2;

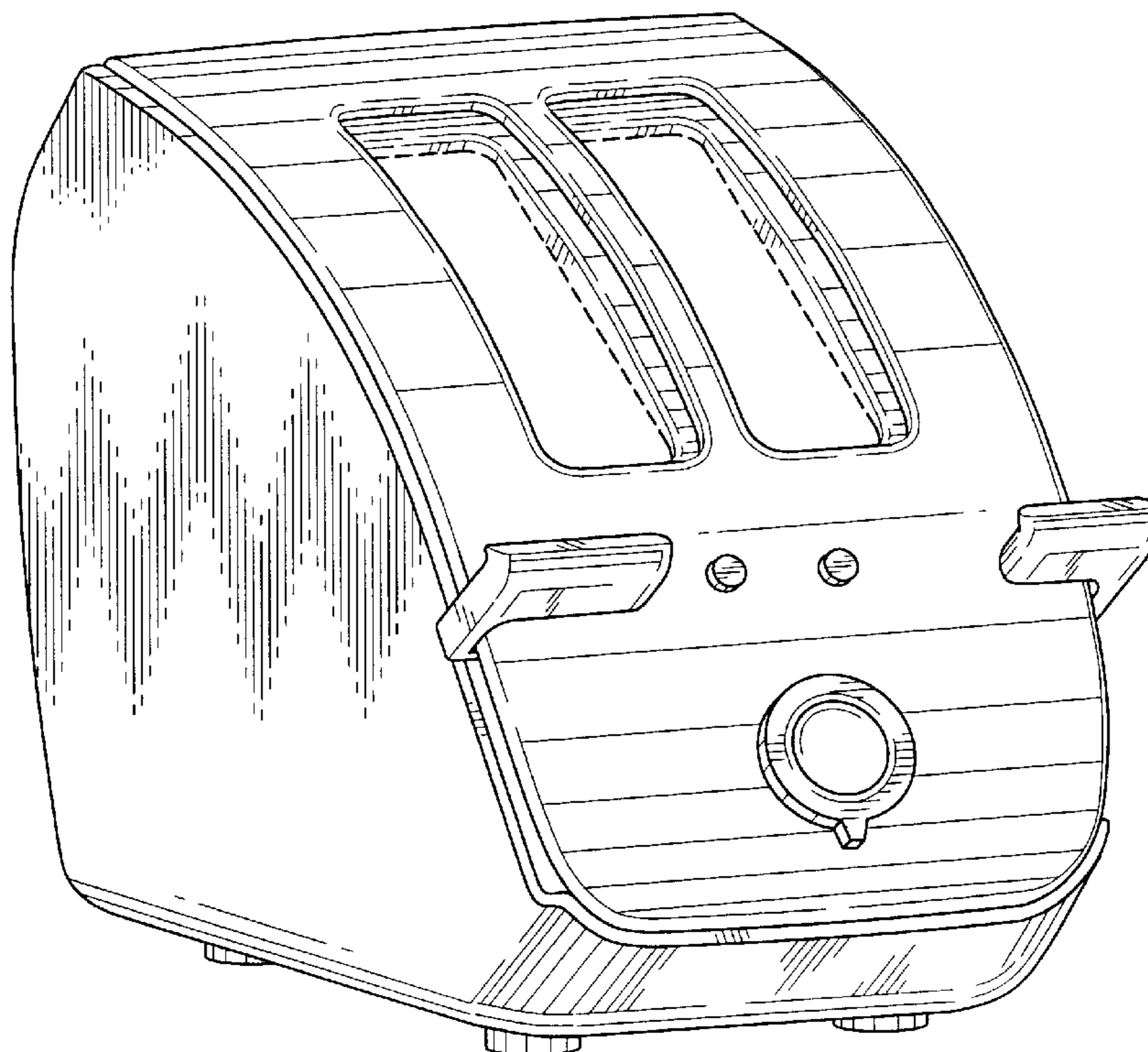
FIG. 4 is a side elevational view thereof from the right of

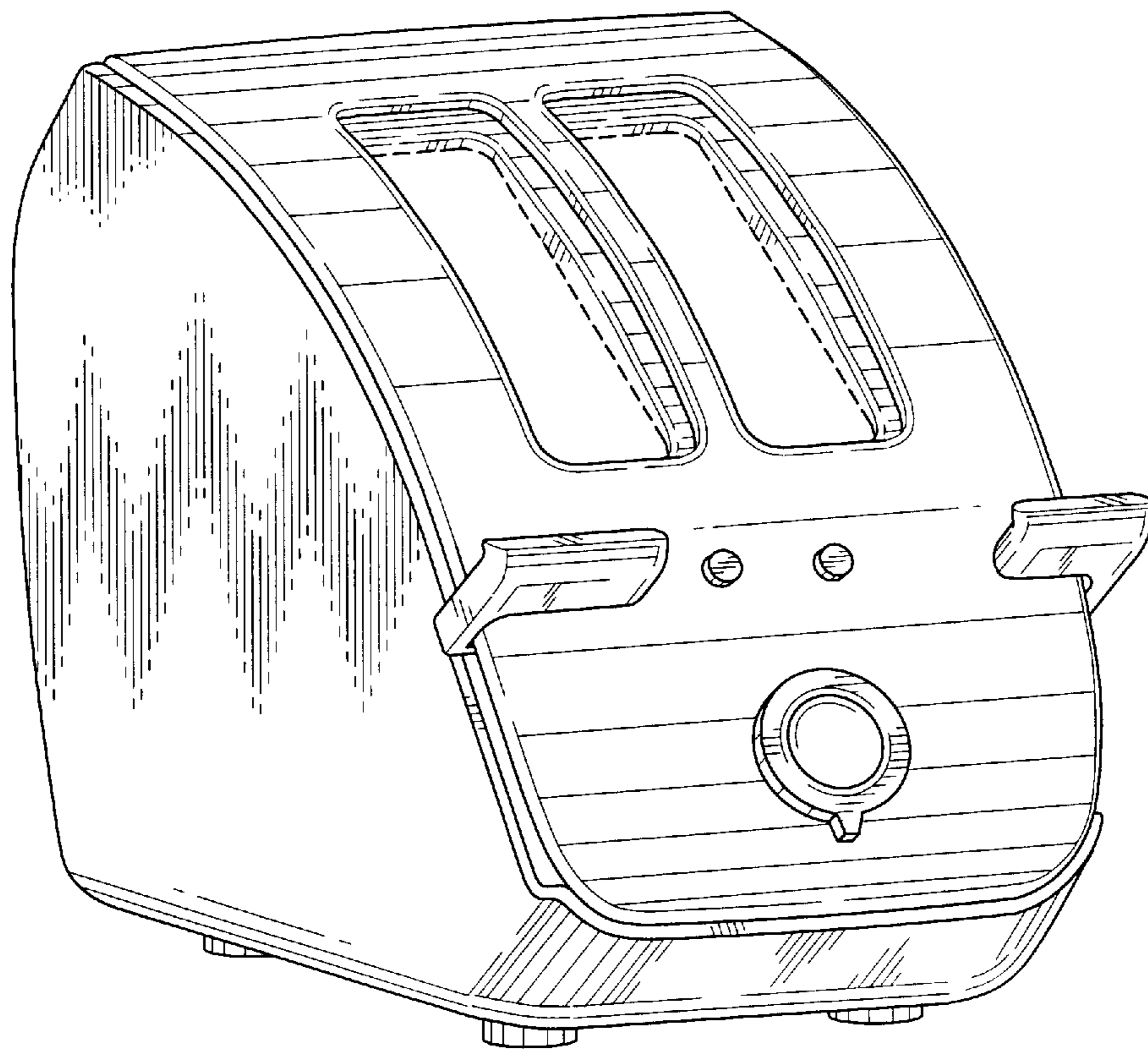

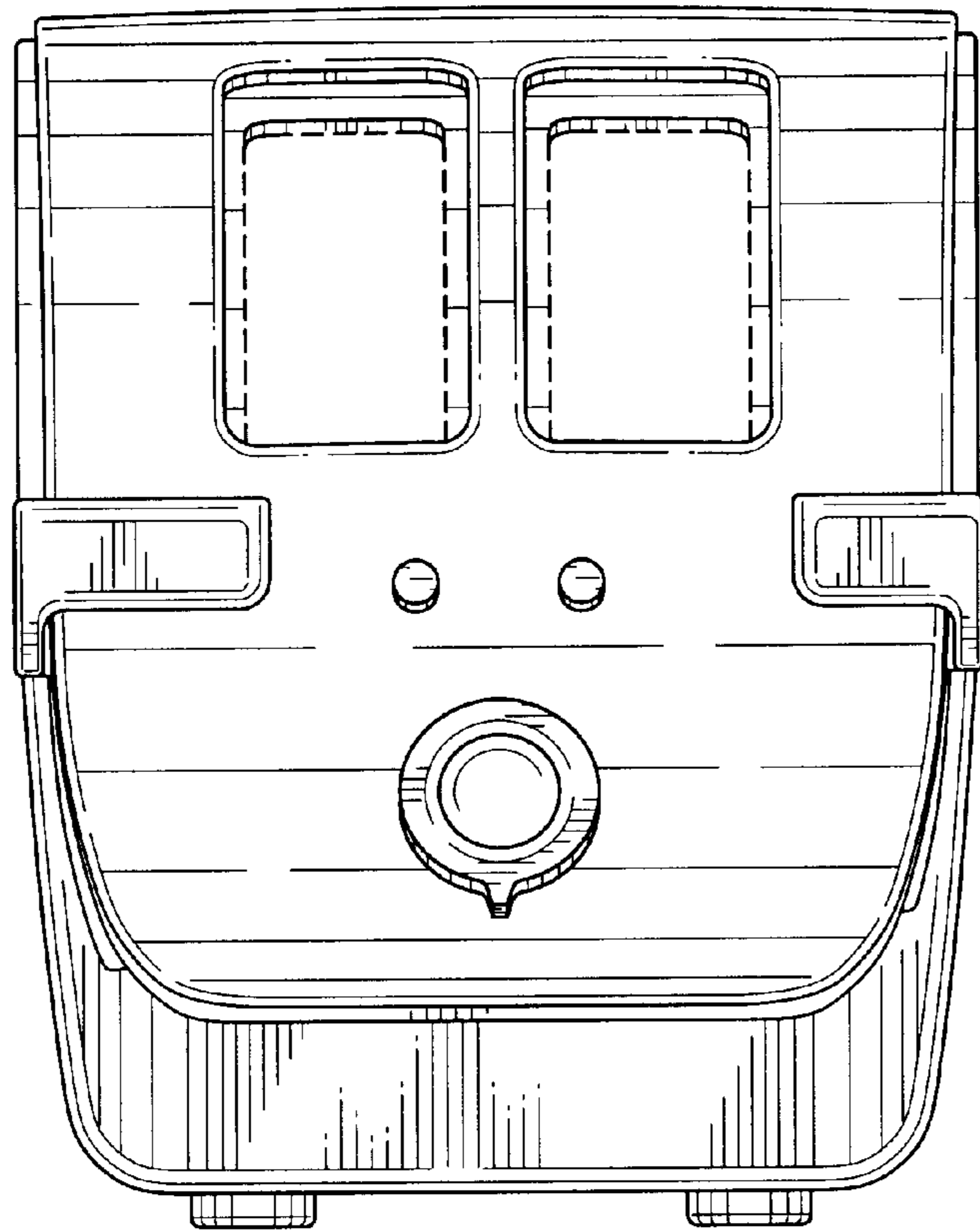

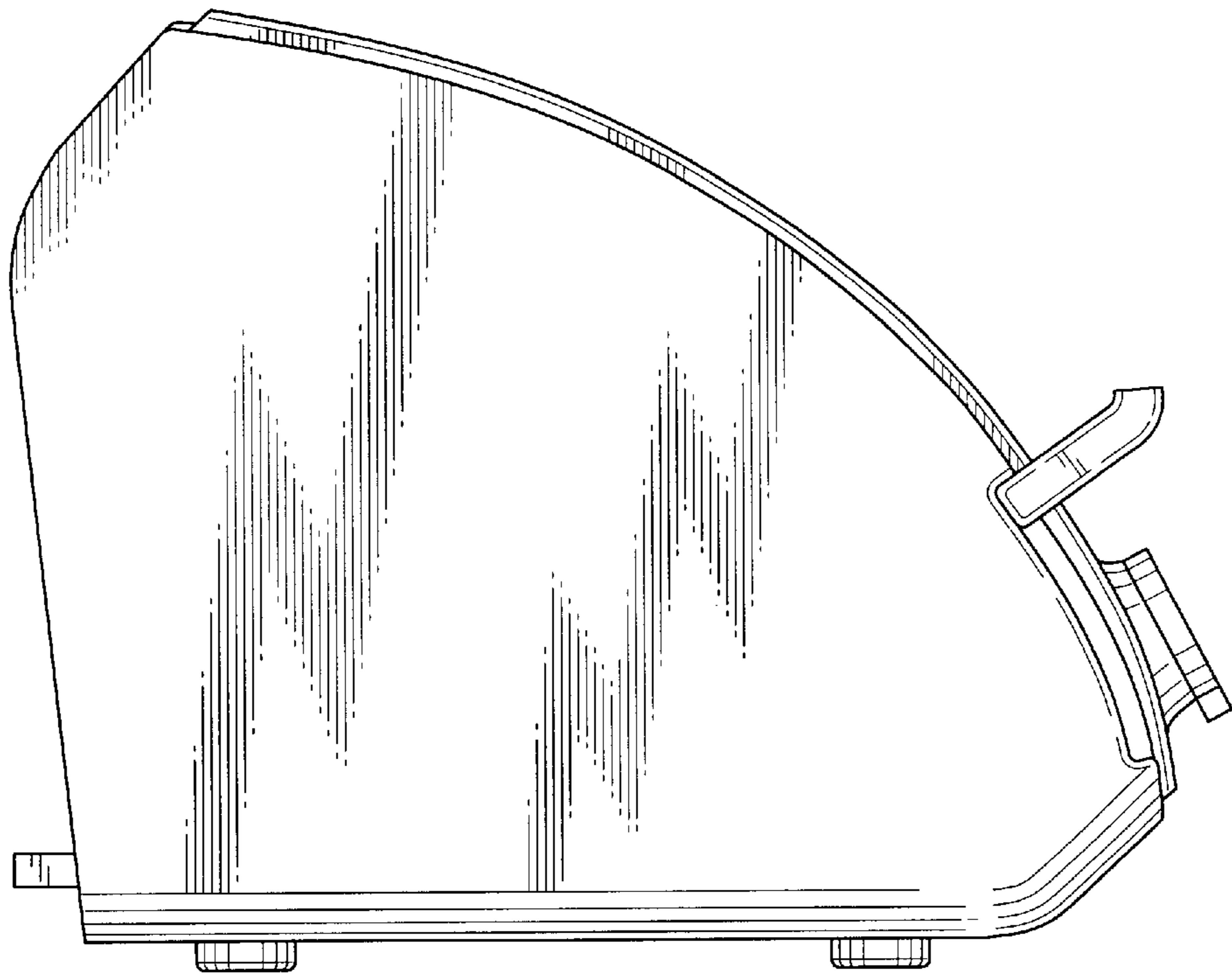

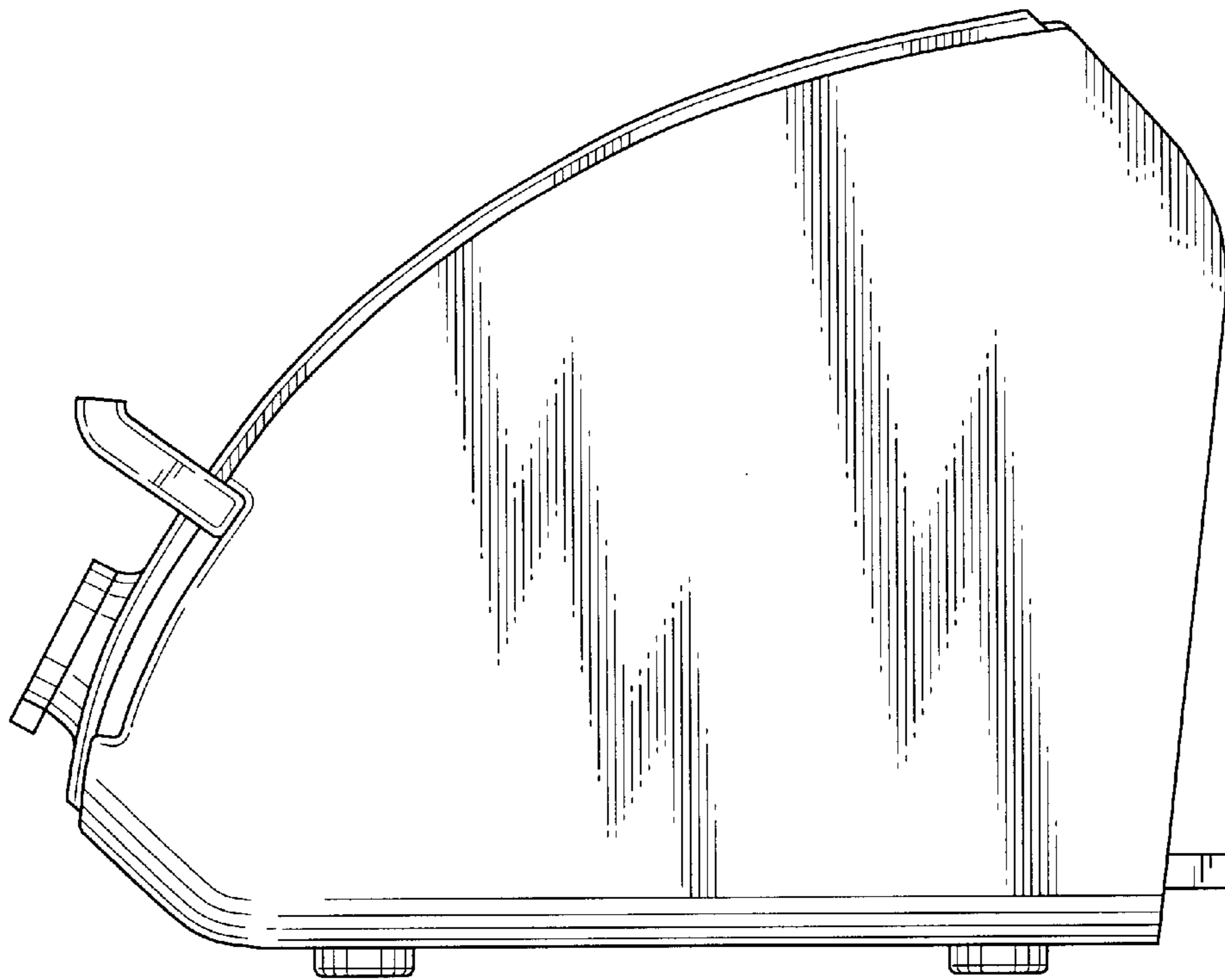

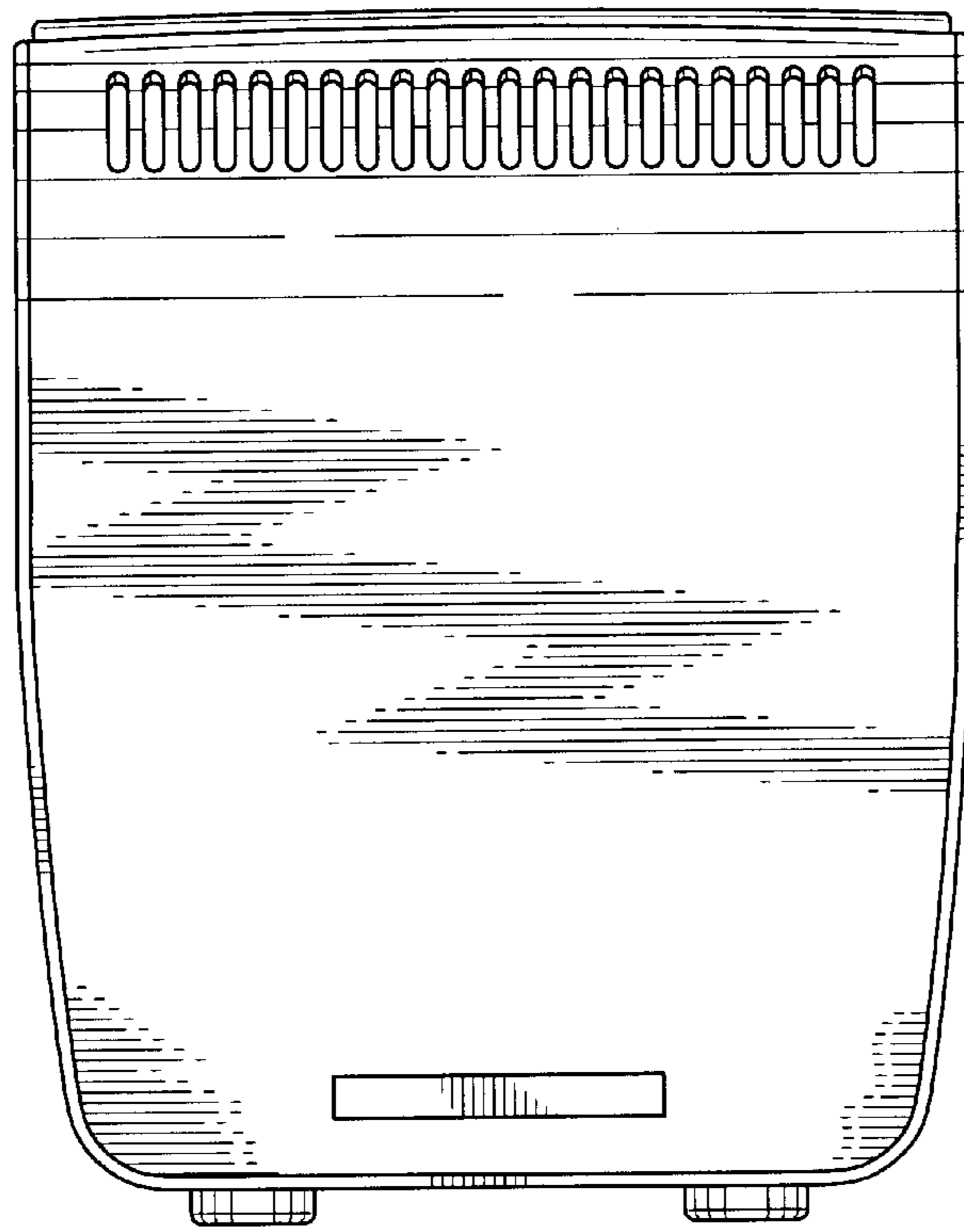

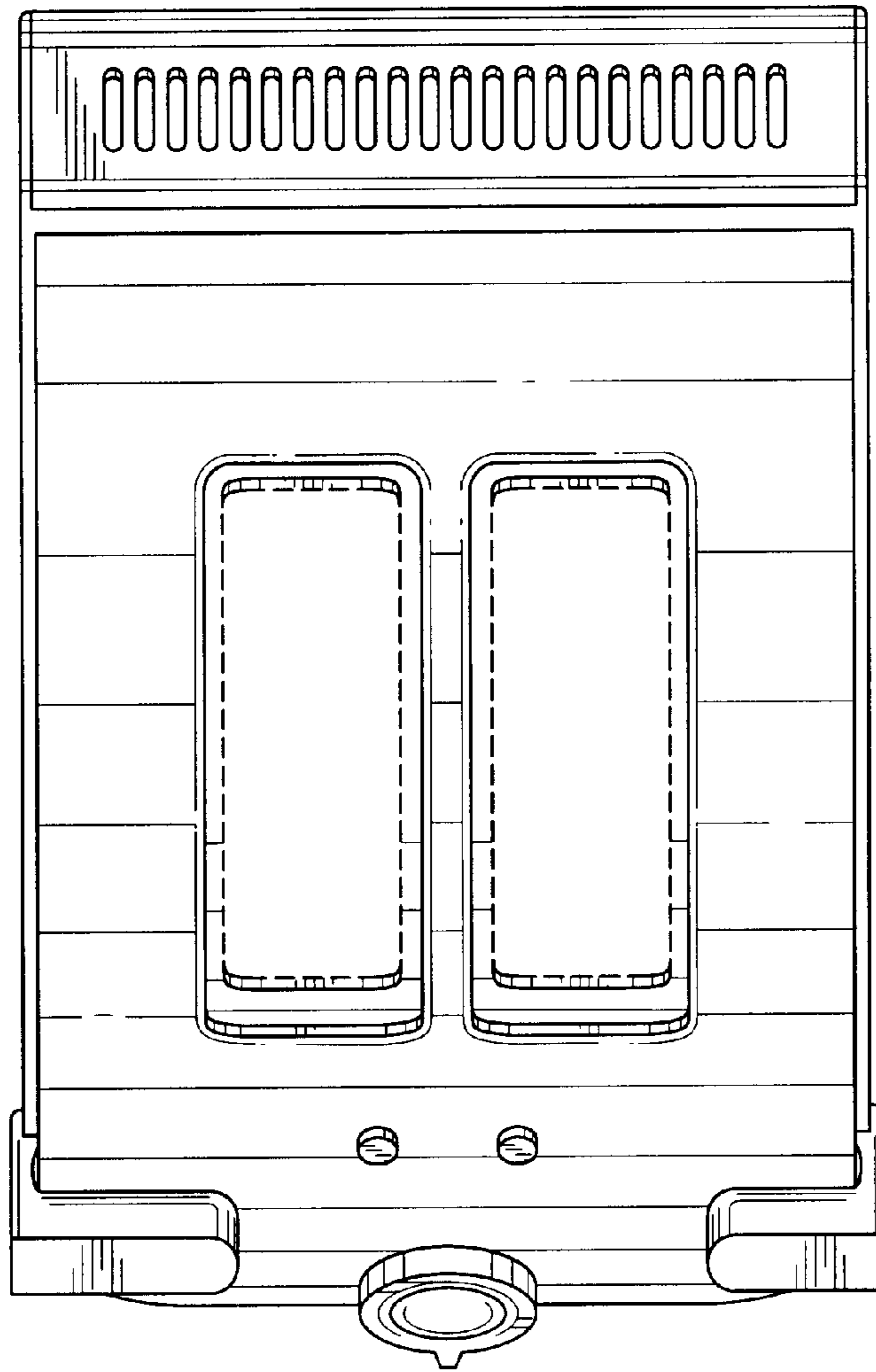

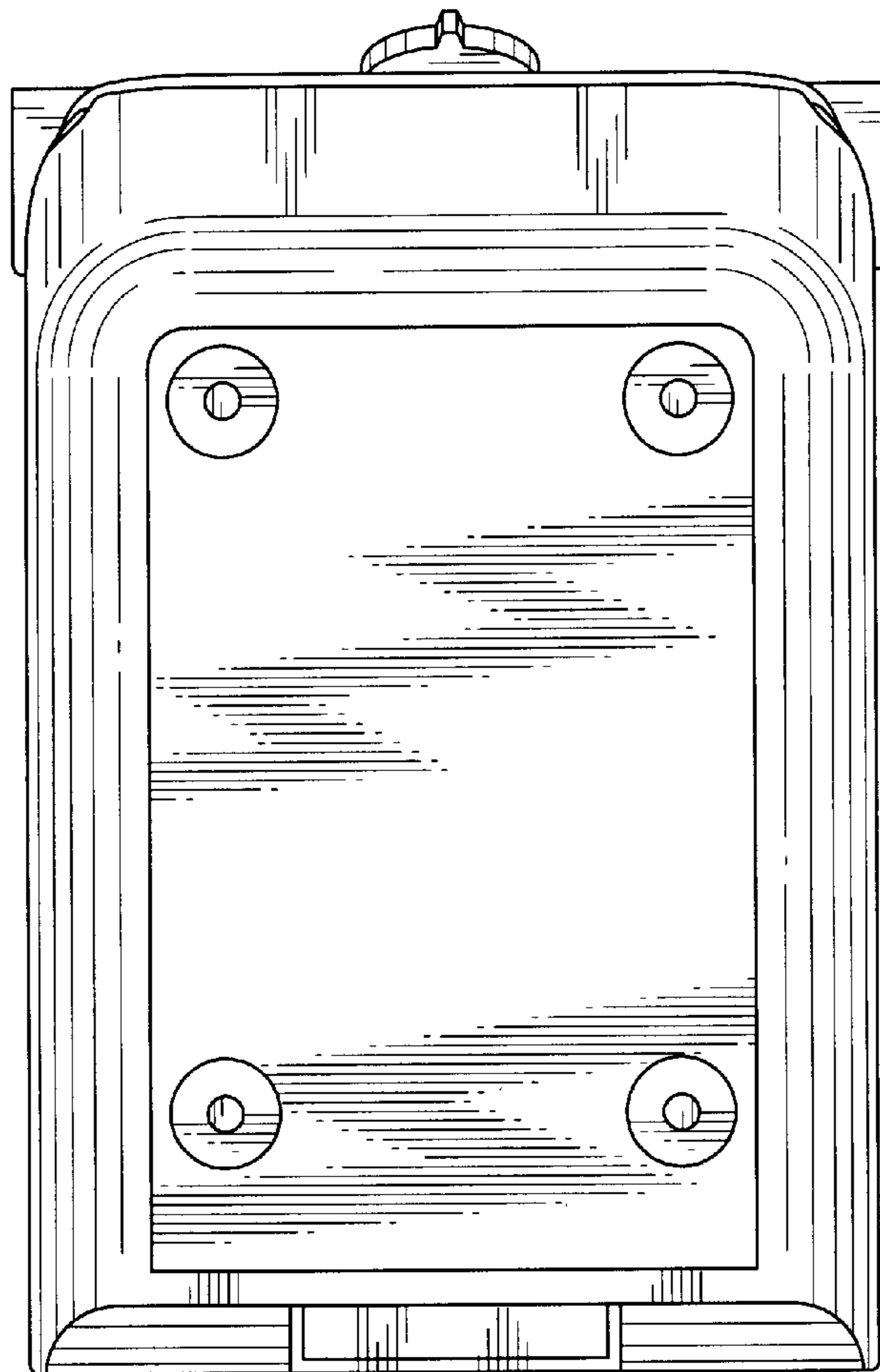
