FIG. 1 is a top plan view of bow embossed insert for baking pan showing my new design;

FIG. 2 is a bottom plan view of the bow embossed insert for baking pan of FIG. 1;

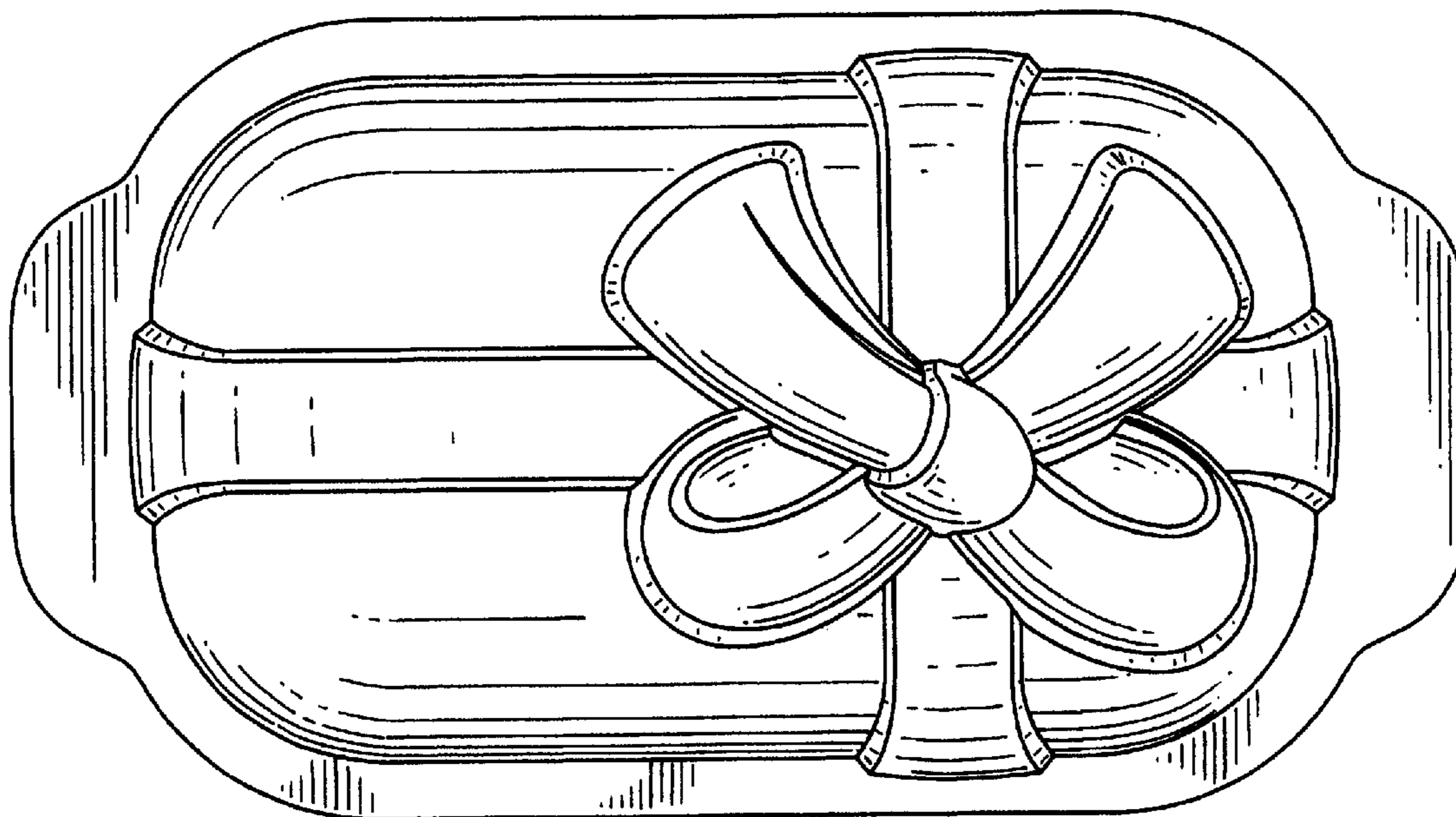
FIG. 3 is a side elevational view of the bow embossed insert for baking pan of FIG. 1;

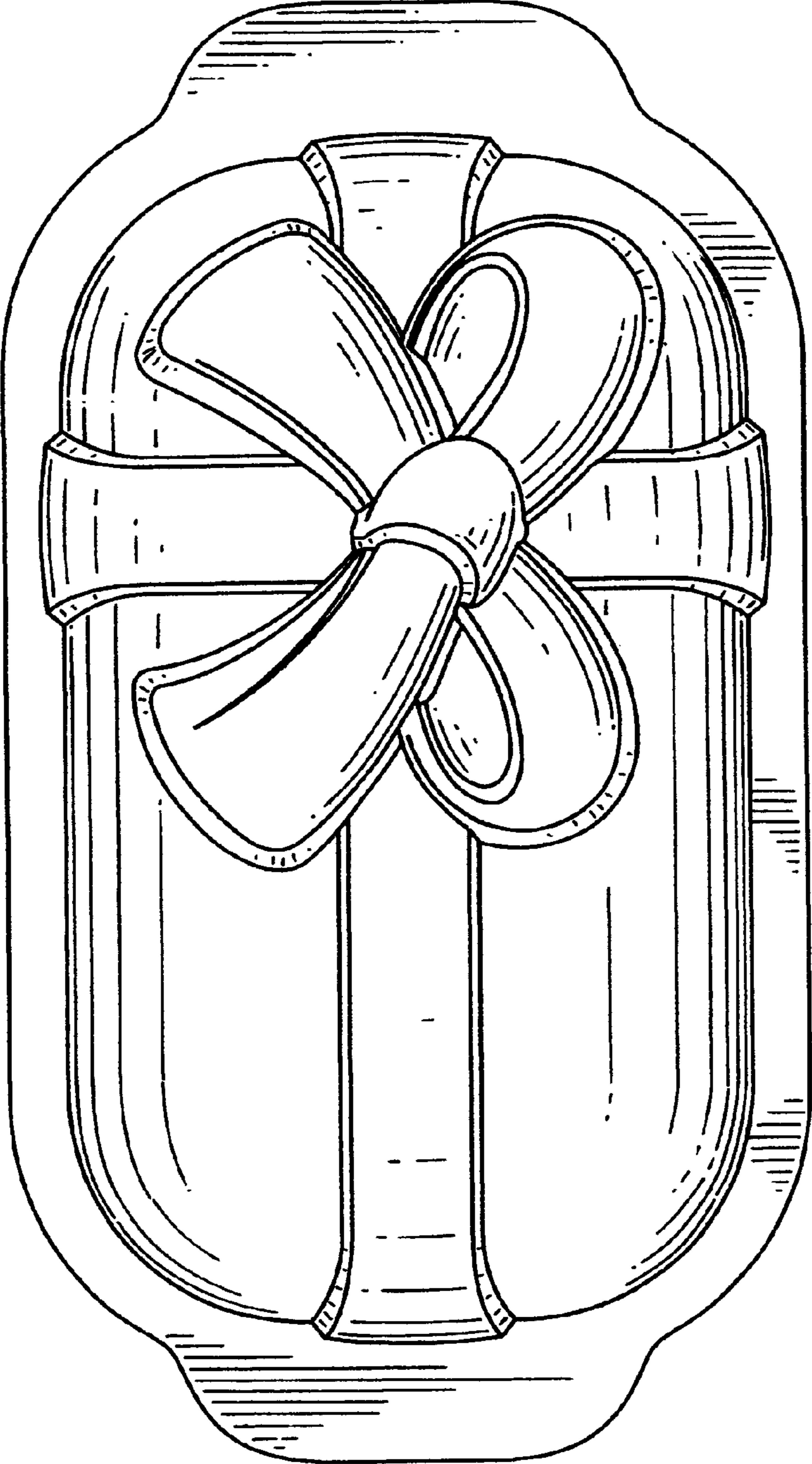

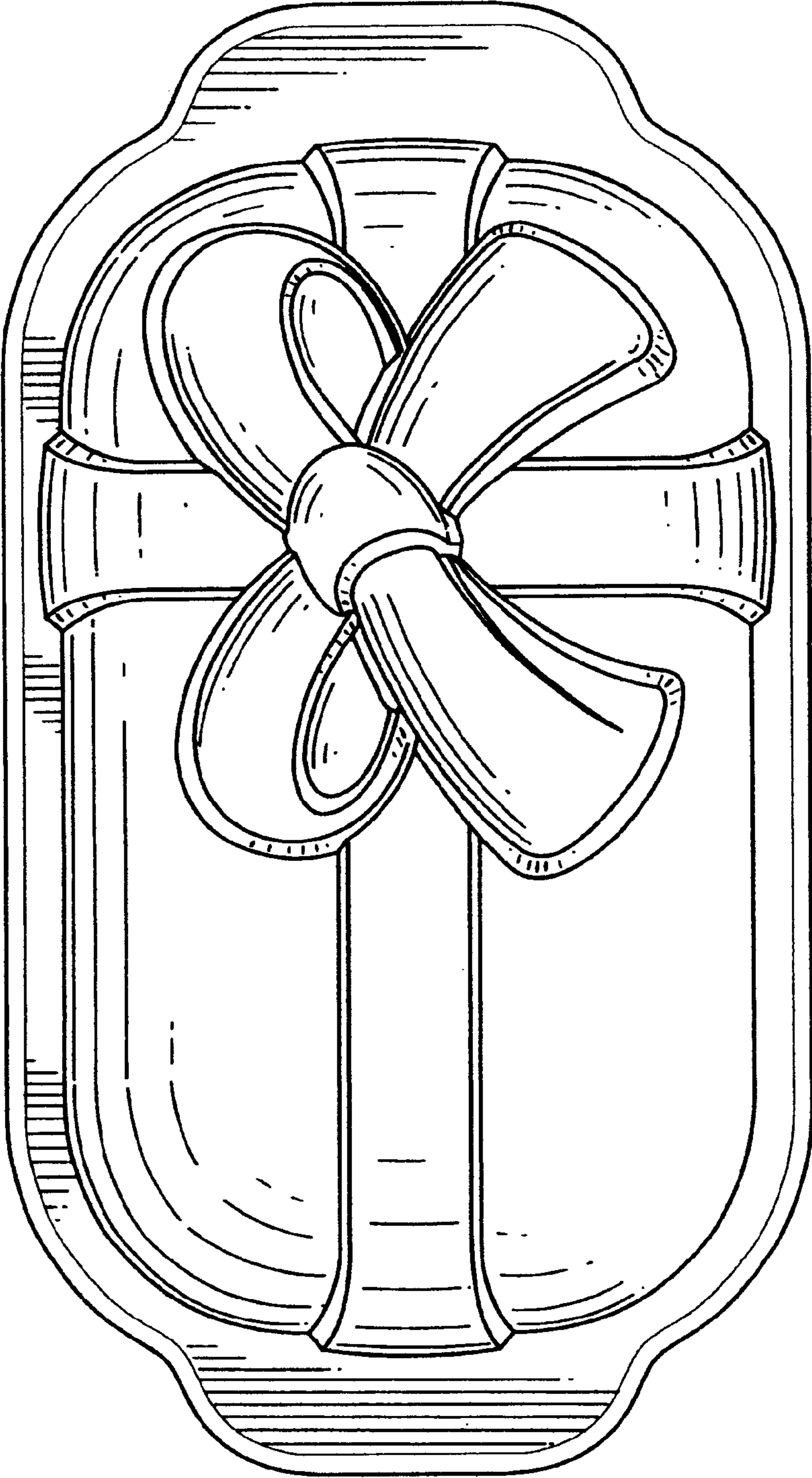

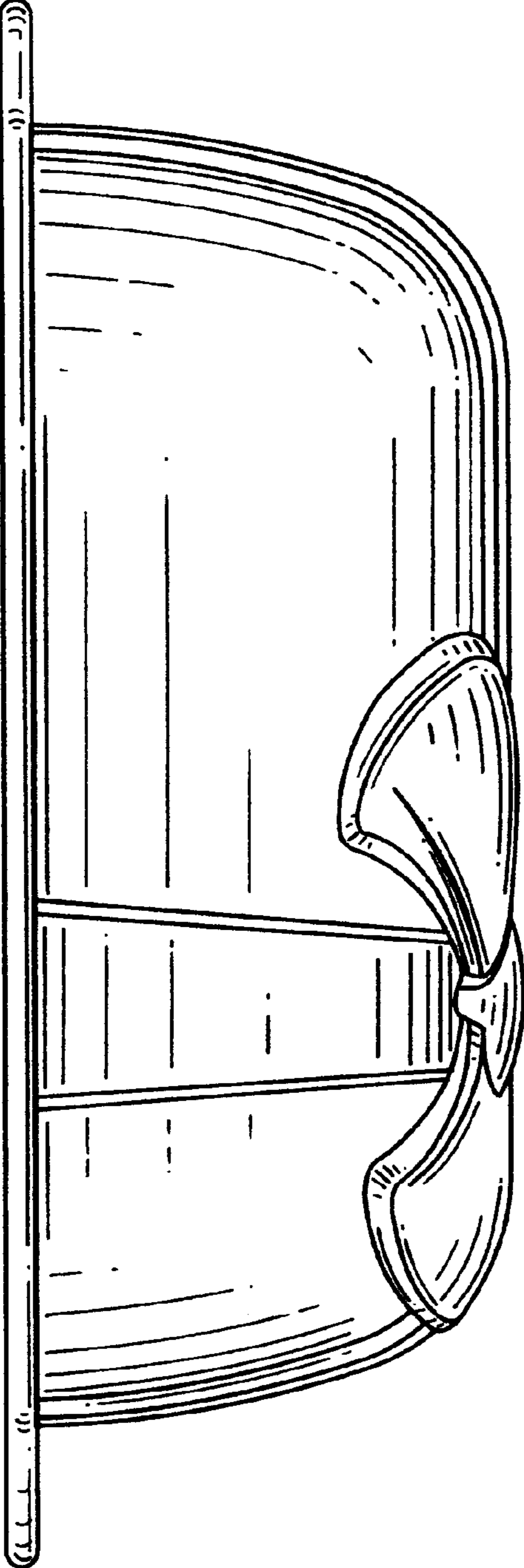

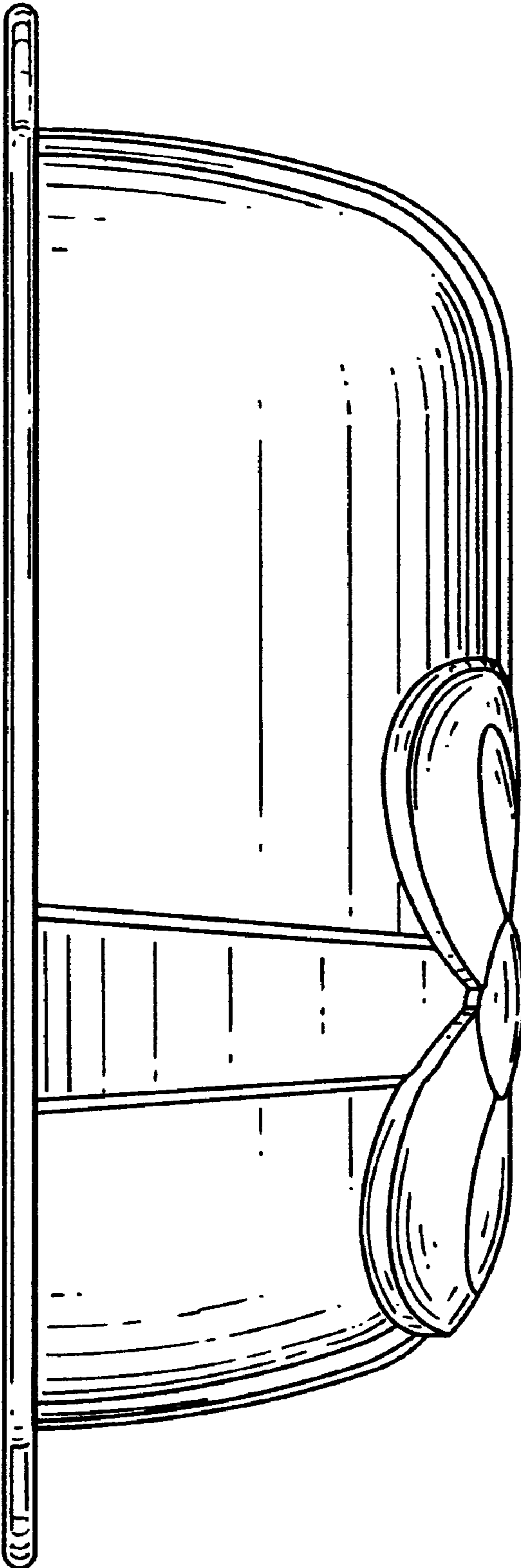

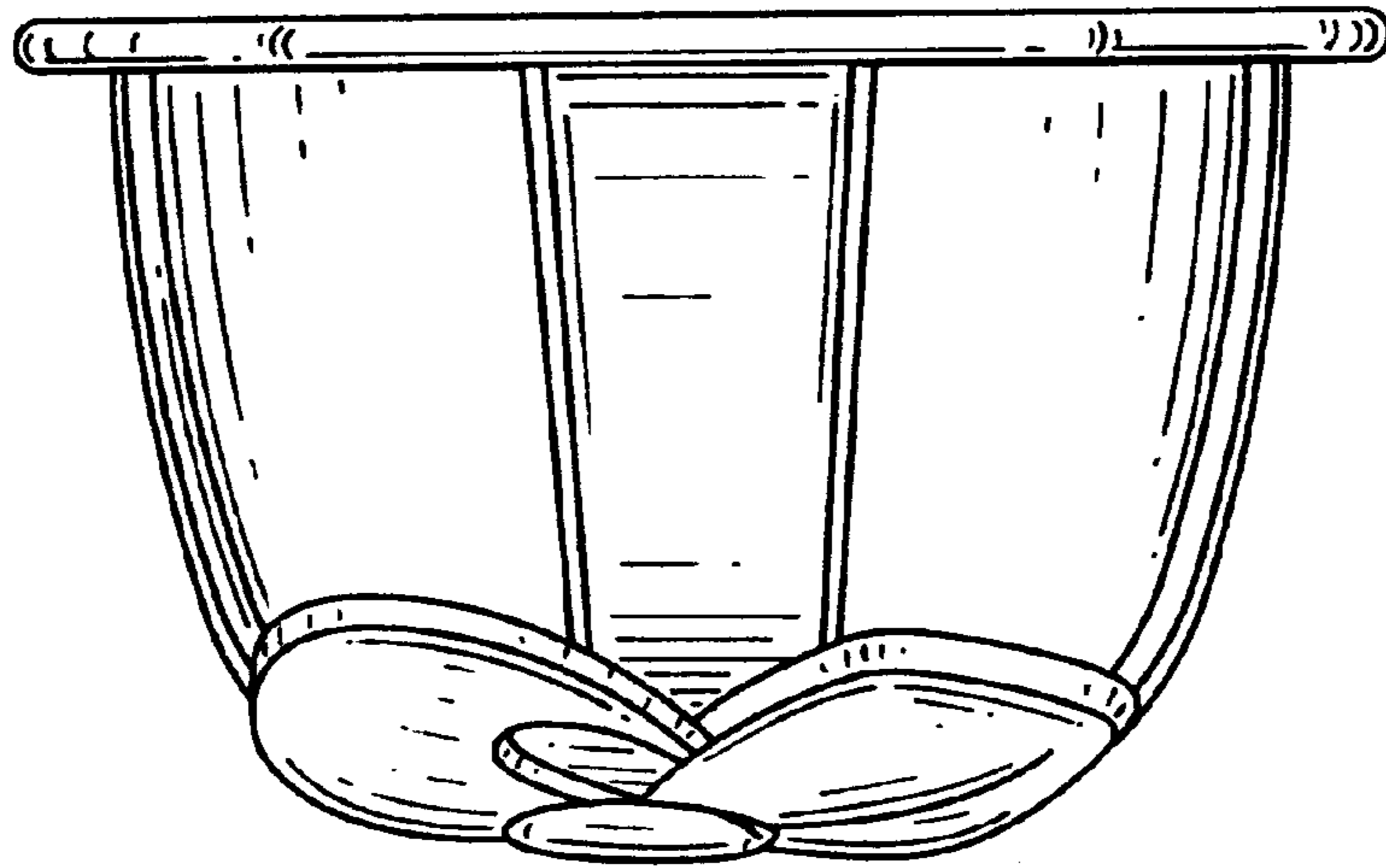

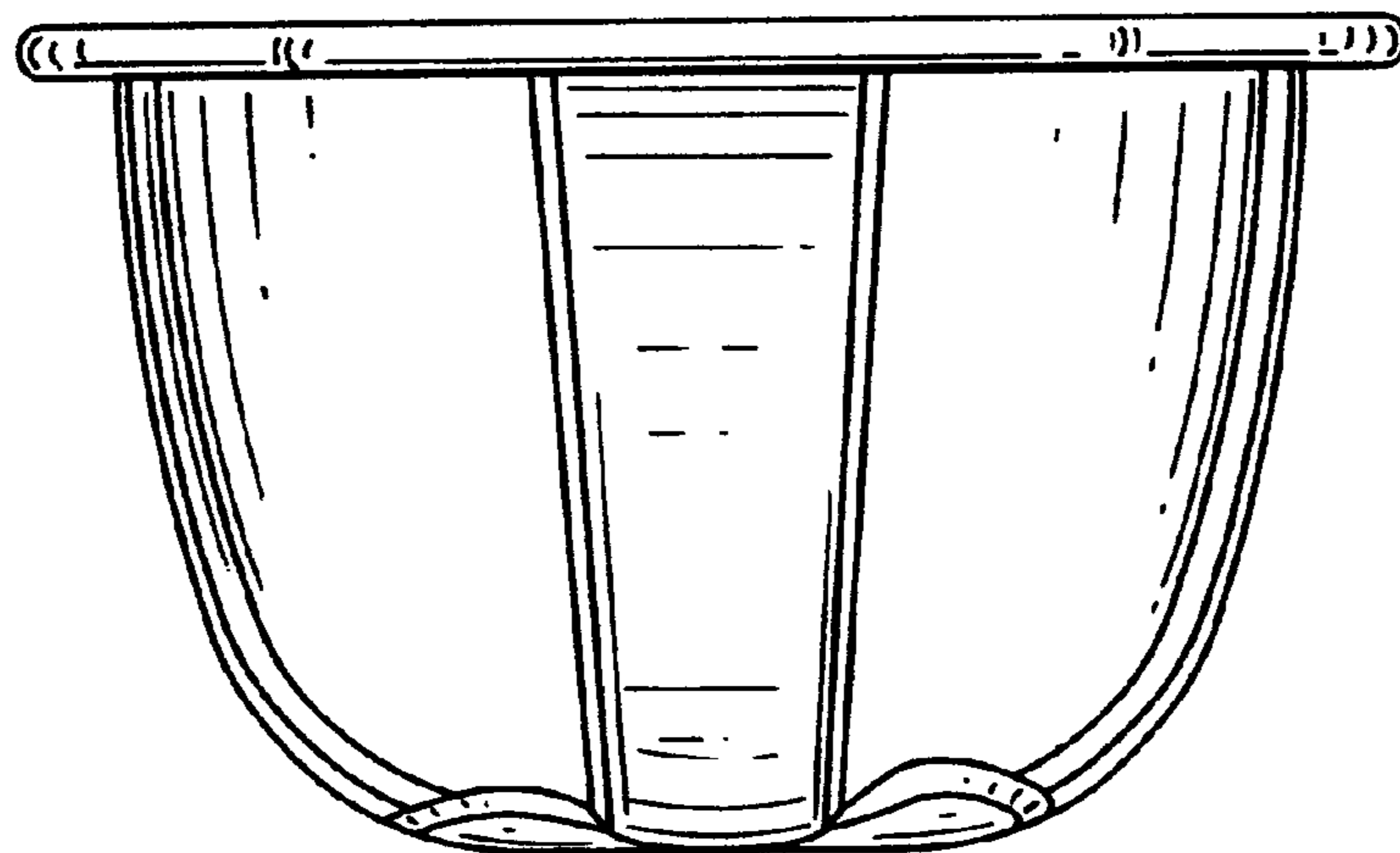
