(57) **CLAIM**

The ornamental design of a box and open end SAE and metric wrench, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the box and open end SAE and metric wrench of my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a side elevational view of the left side thereof;

FIG. 5 is a side elevational view of the right side thereof;

FIG. 6 is an enlarged end elevational view of the left end thereof;

FIG. 7 is an enlarged end elevational view of the right end thereof;

FIG. 8 is an enlarged top plan view of section 8 of FIG. 2;

FIG. 9 is an enlarged top plan view of section 9 of FIG. 2;

FIG. 10 is a perspective view of a modification of the box and open end SAE and metric wrench of FIG. 1;

FIG. 11 is a top plan view of FIG. 10;

FIG. 12 is a bottom plan view of FIG. 10;

FIG. 13 is a side elevational view of the left side of FIG. 10;

FIG. 14 is a side elevational view of the right side of FIG. 10;

FIG. 15 is an enlarged end elevational view of the left end of FIG. 10;

FIG. 16 is an enlarged end elevational view of the right end of FIG. 10;

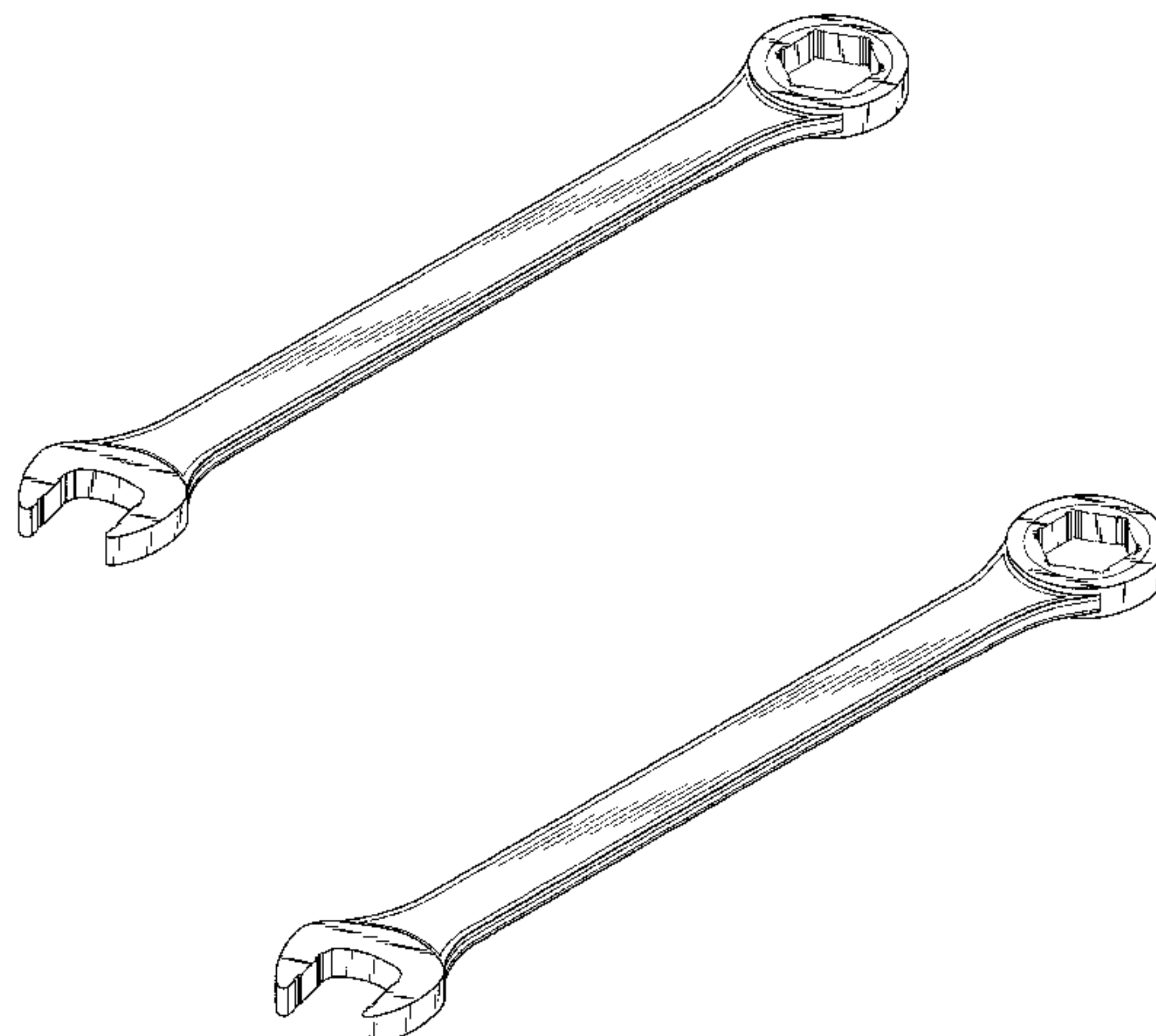
FIG. 17 is an enlarged top plan view of section 17 of FIG. 11; and,

FIG. 18 is an enlarged top plan view of section 18 of FIG. 11.

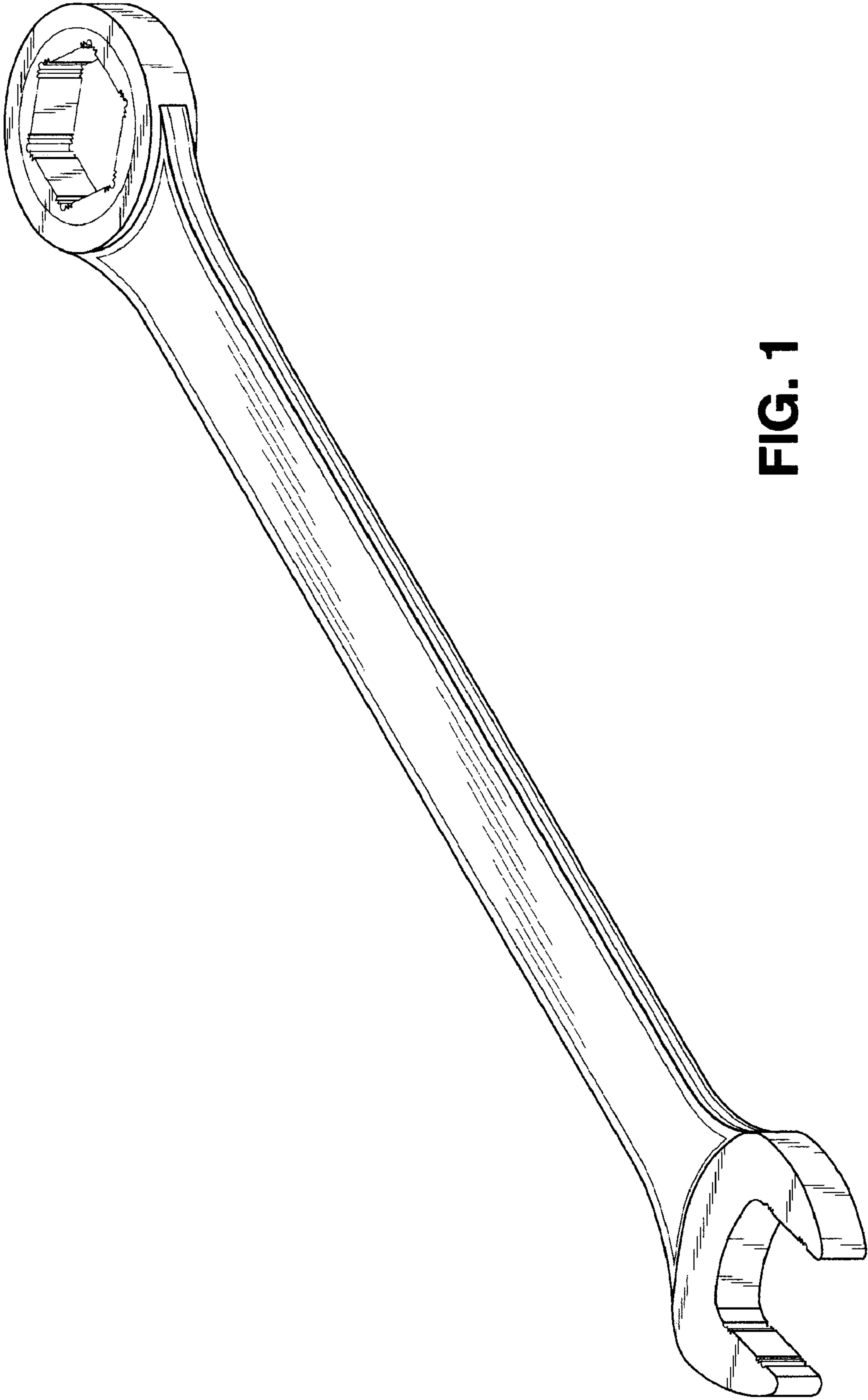

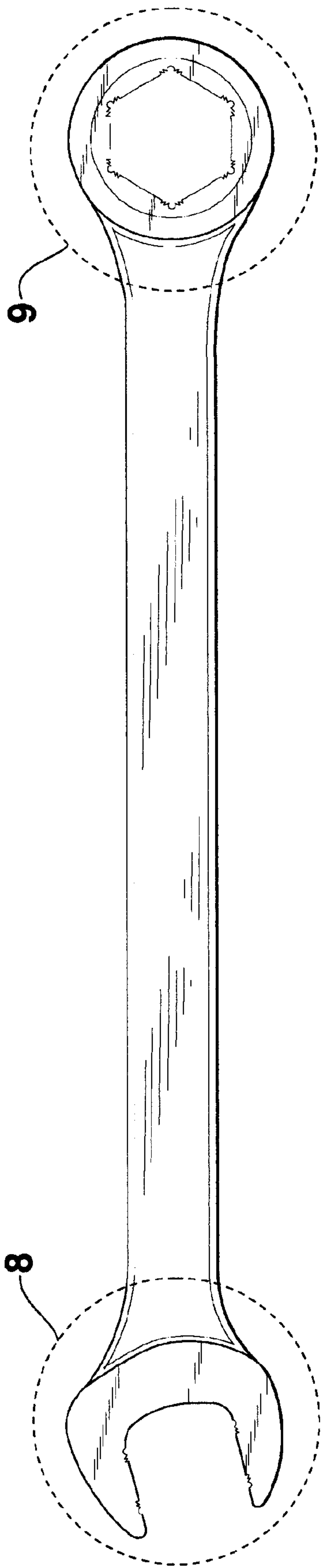

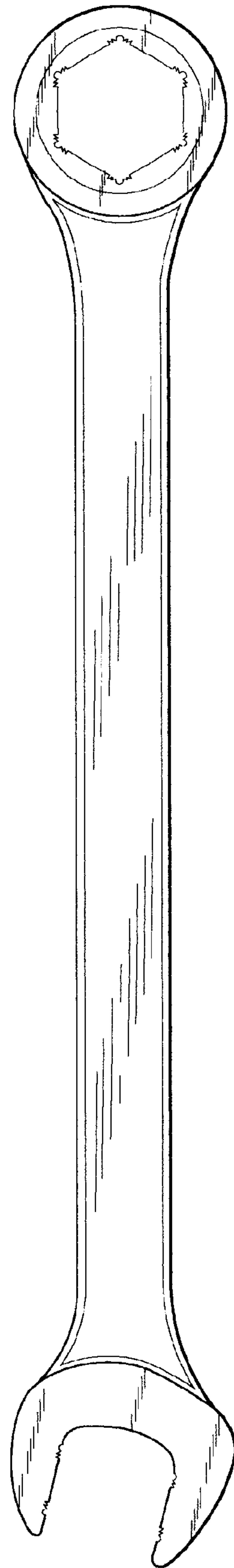

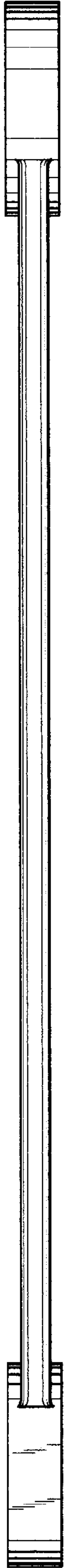

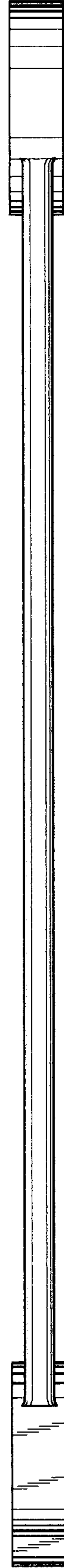

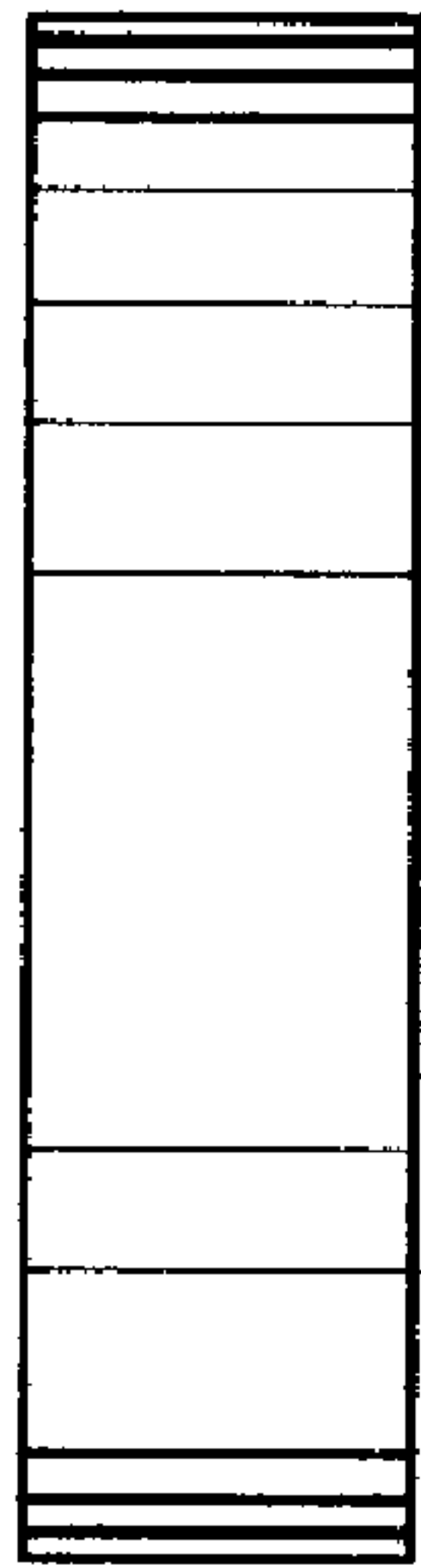

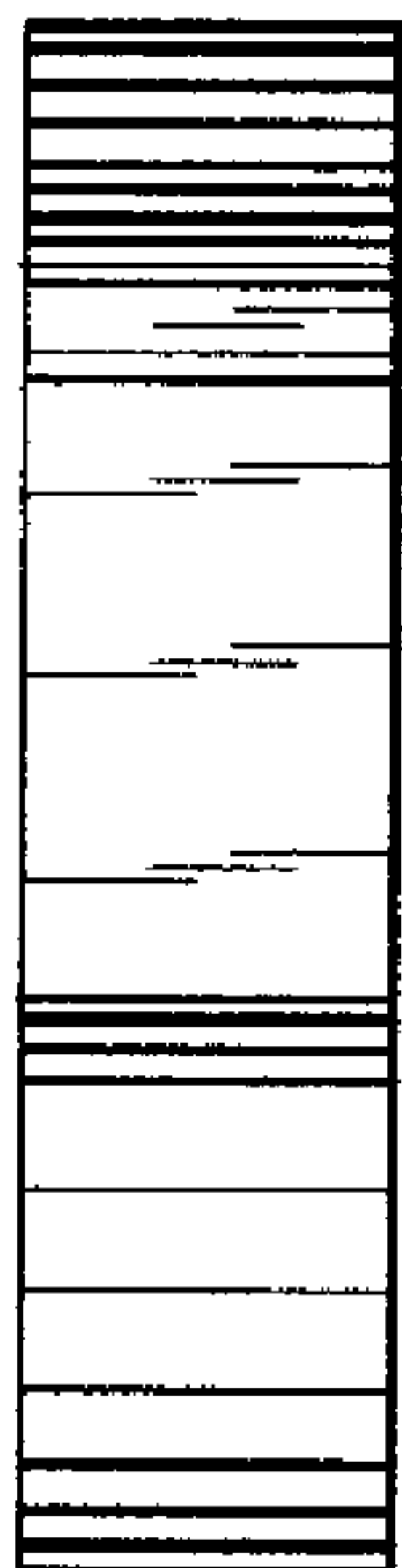

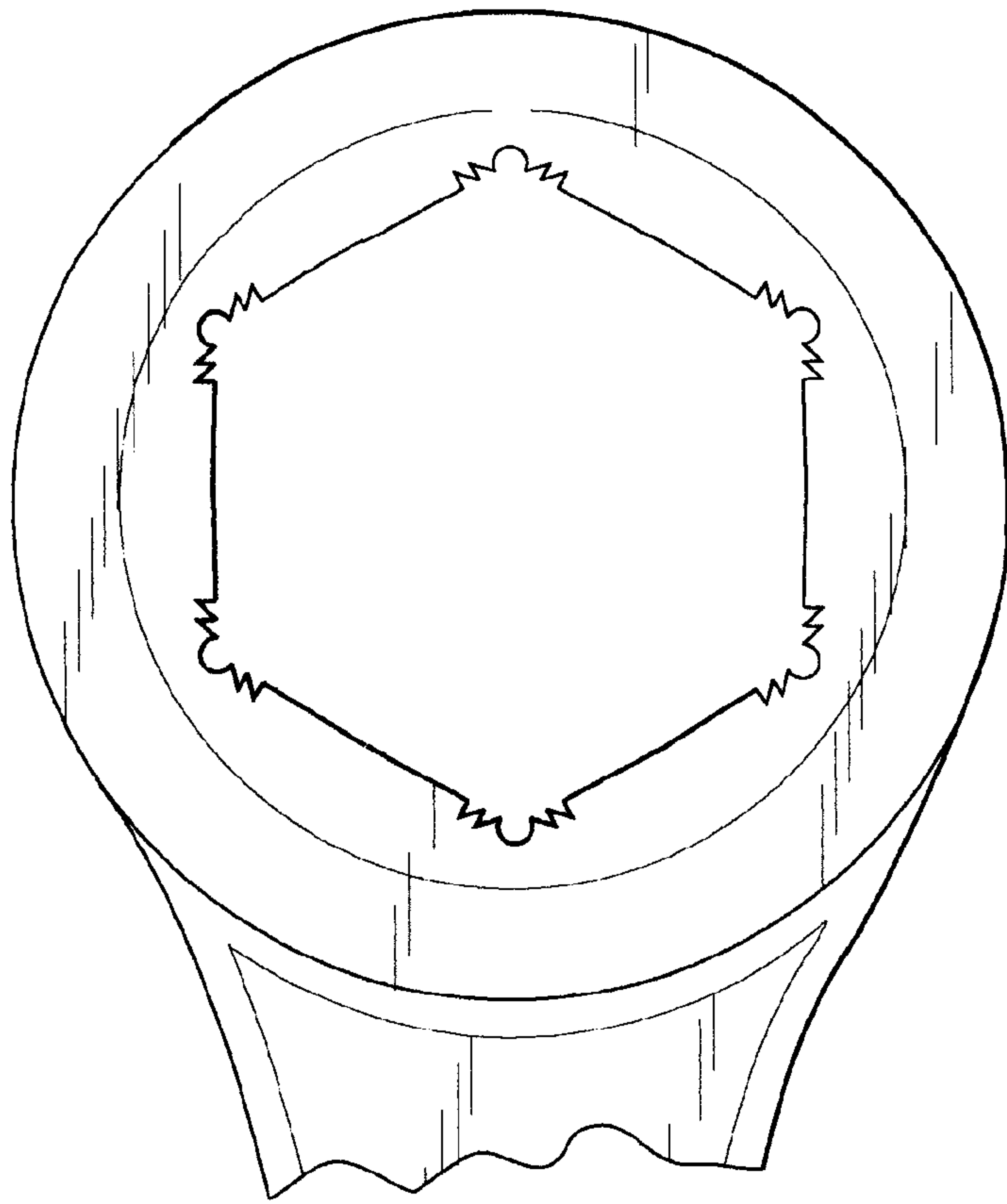

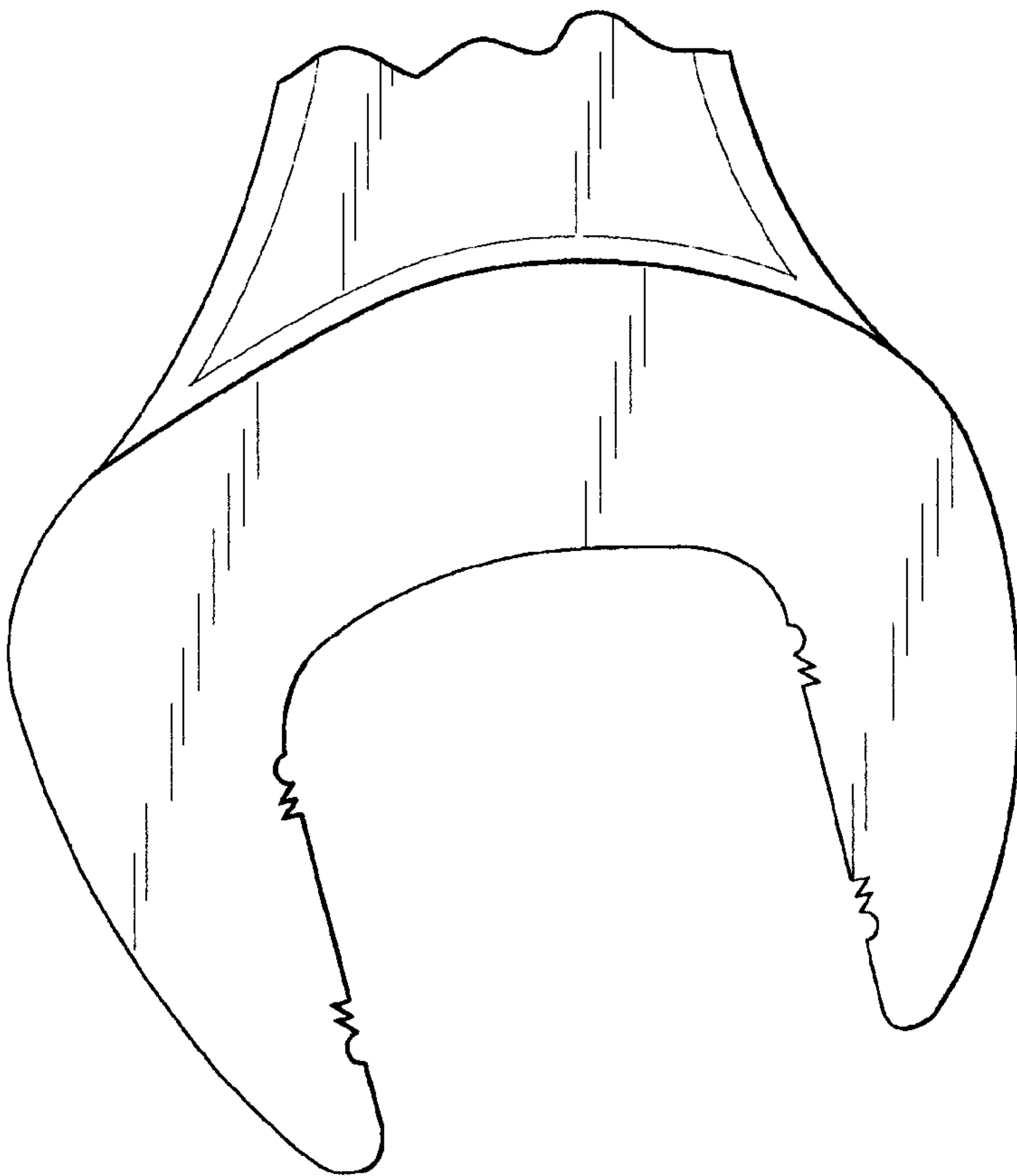

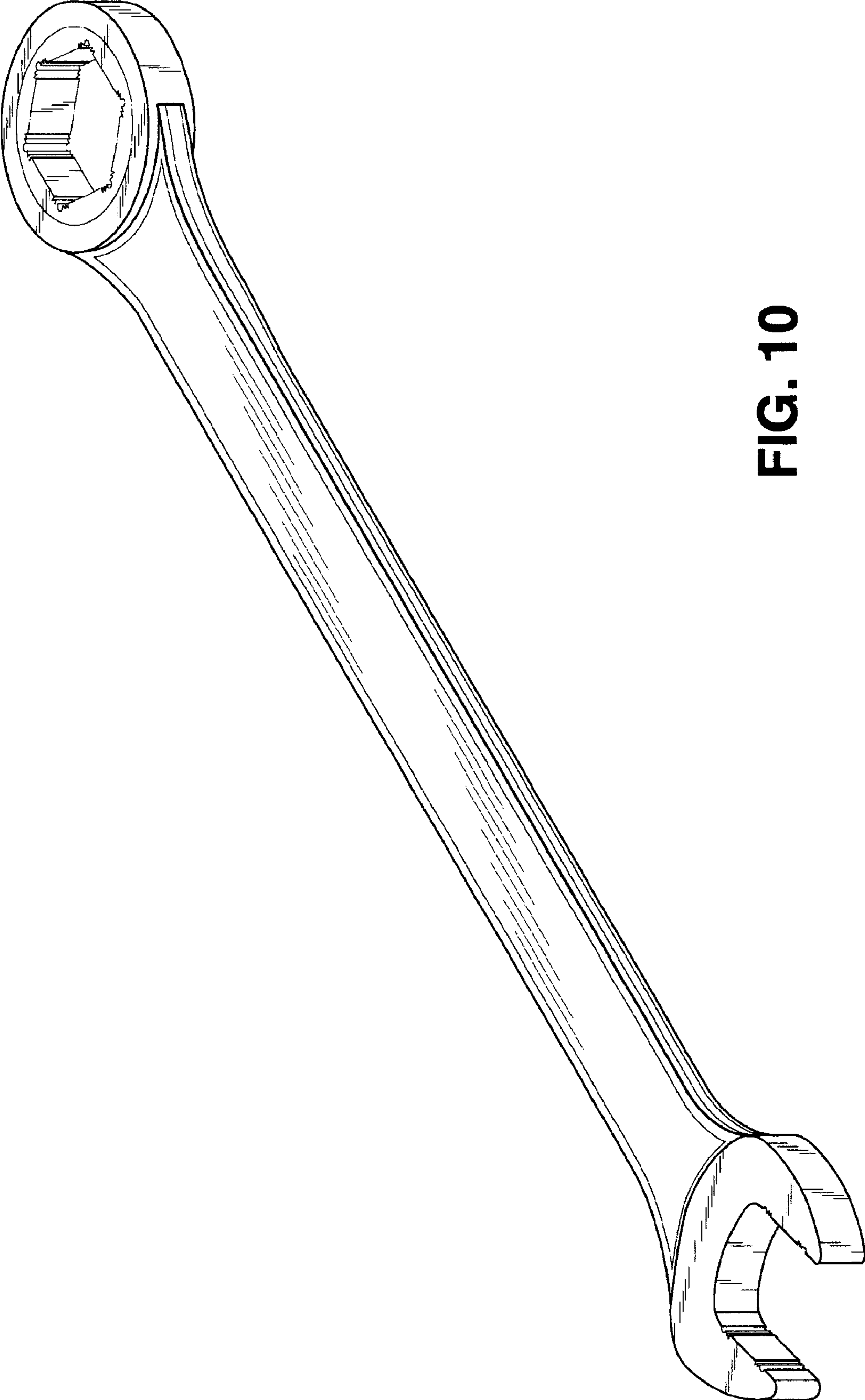

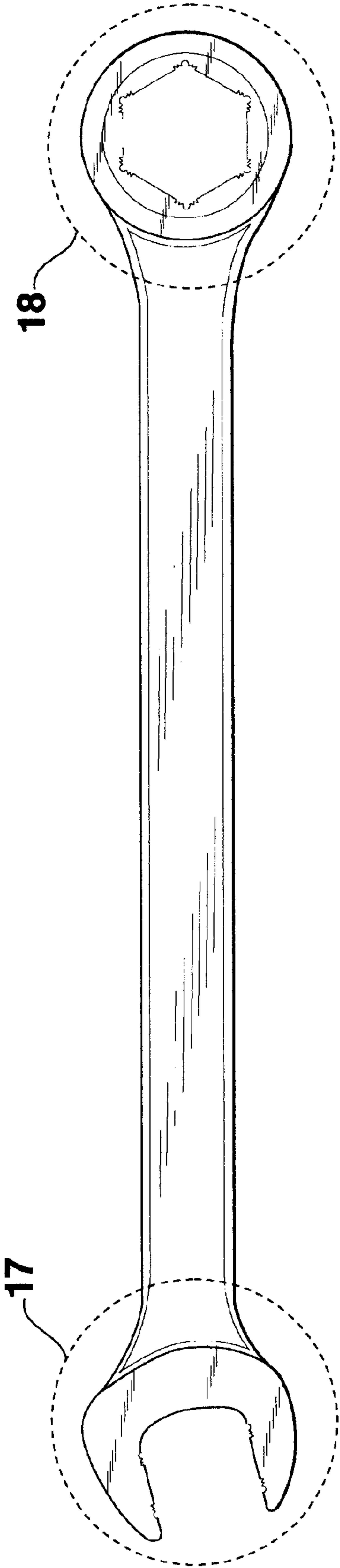

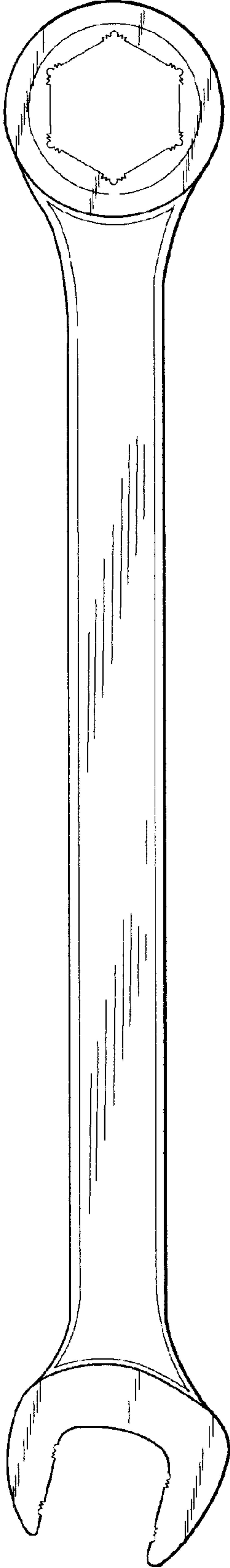

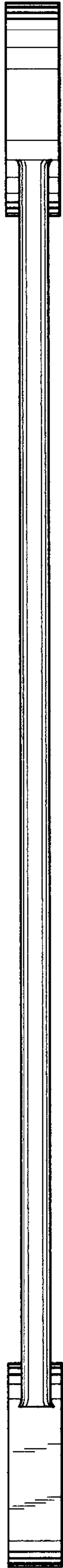

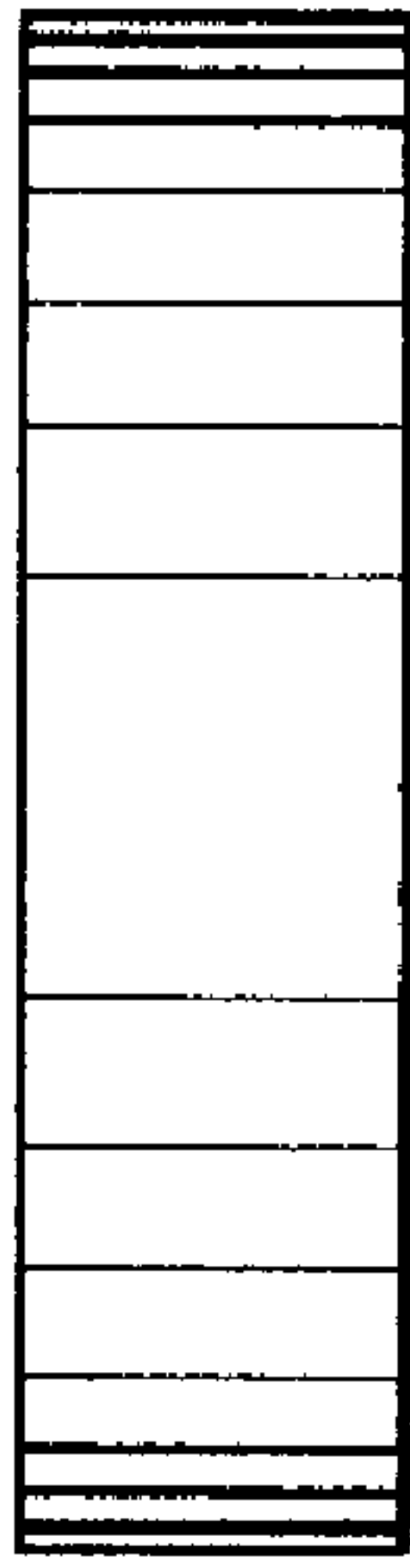

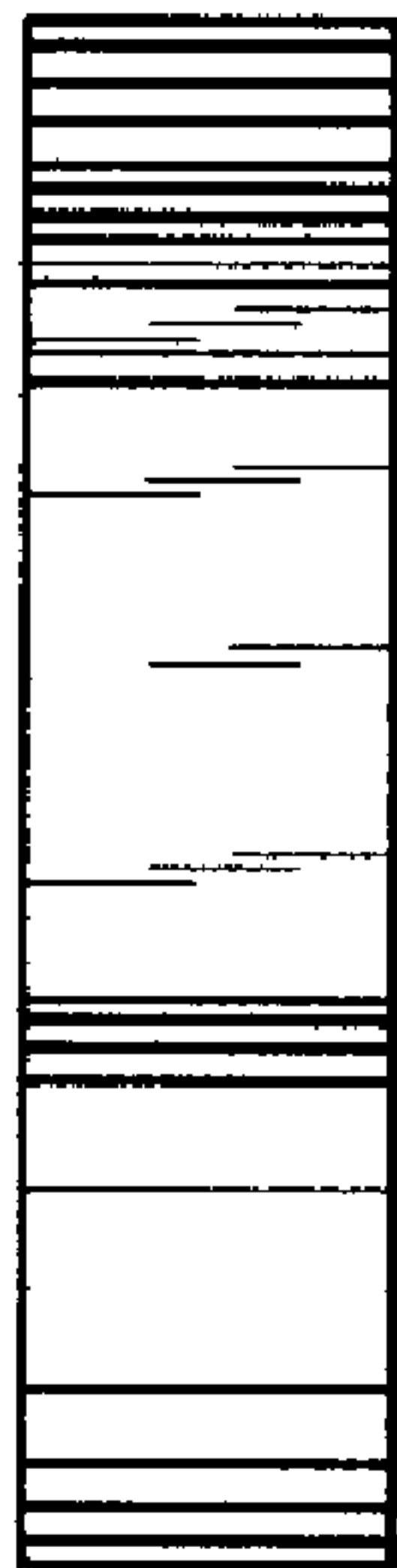

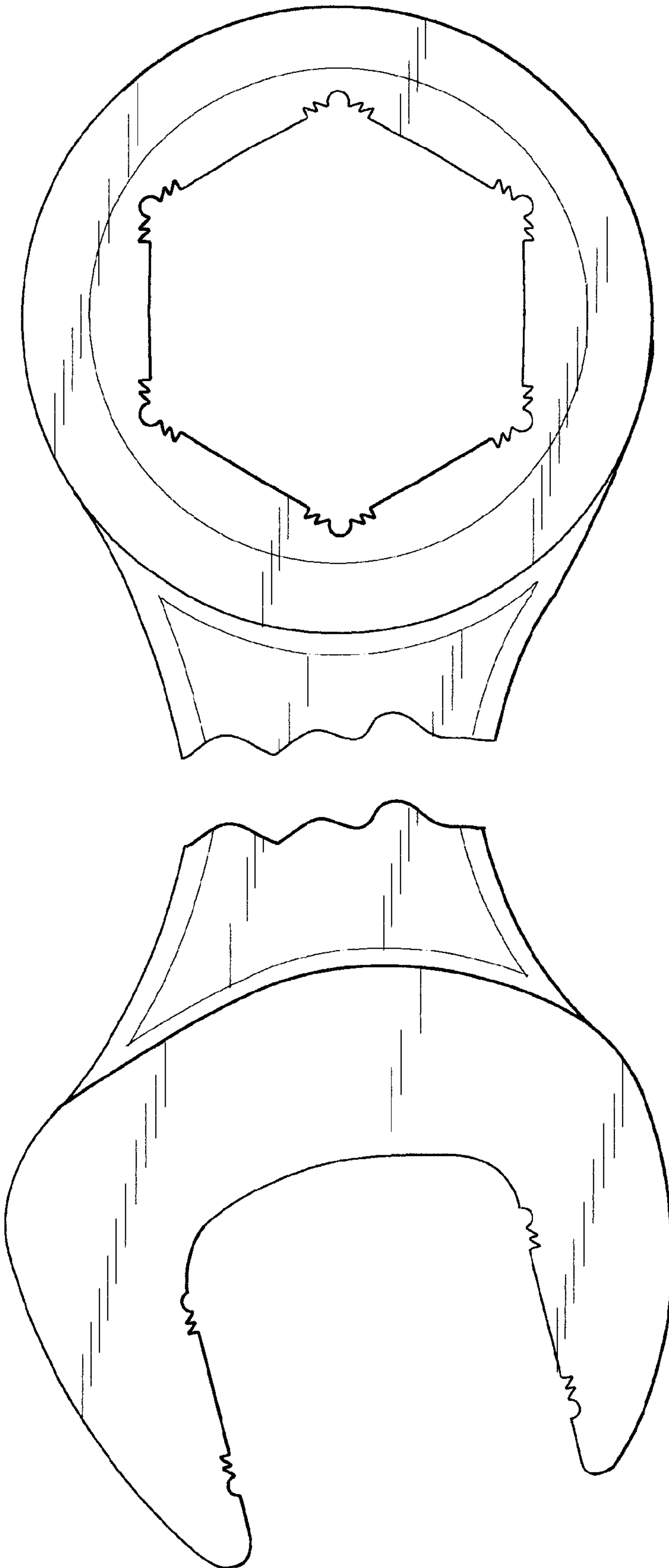
