(57) **CLAIM**

The ornamental design for a container with lid, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a container with lid, showing our new design;

FIG. 2 is a top view of the lid portion removed from the container on a reduced scale;

FIG. 3 is a side view of the container with lid with all other sides being identical thereto;

FIG. 4 is a bottom view thereof on an enlarged scale;

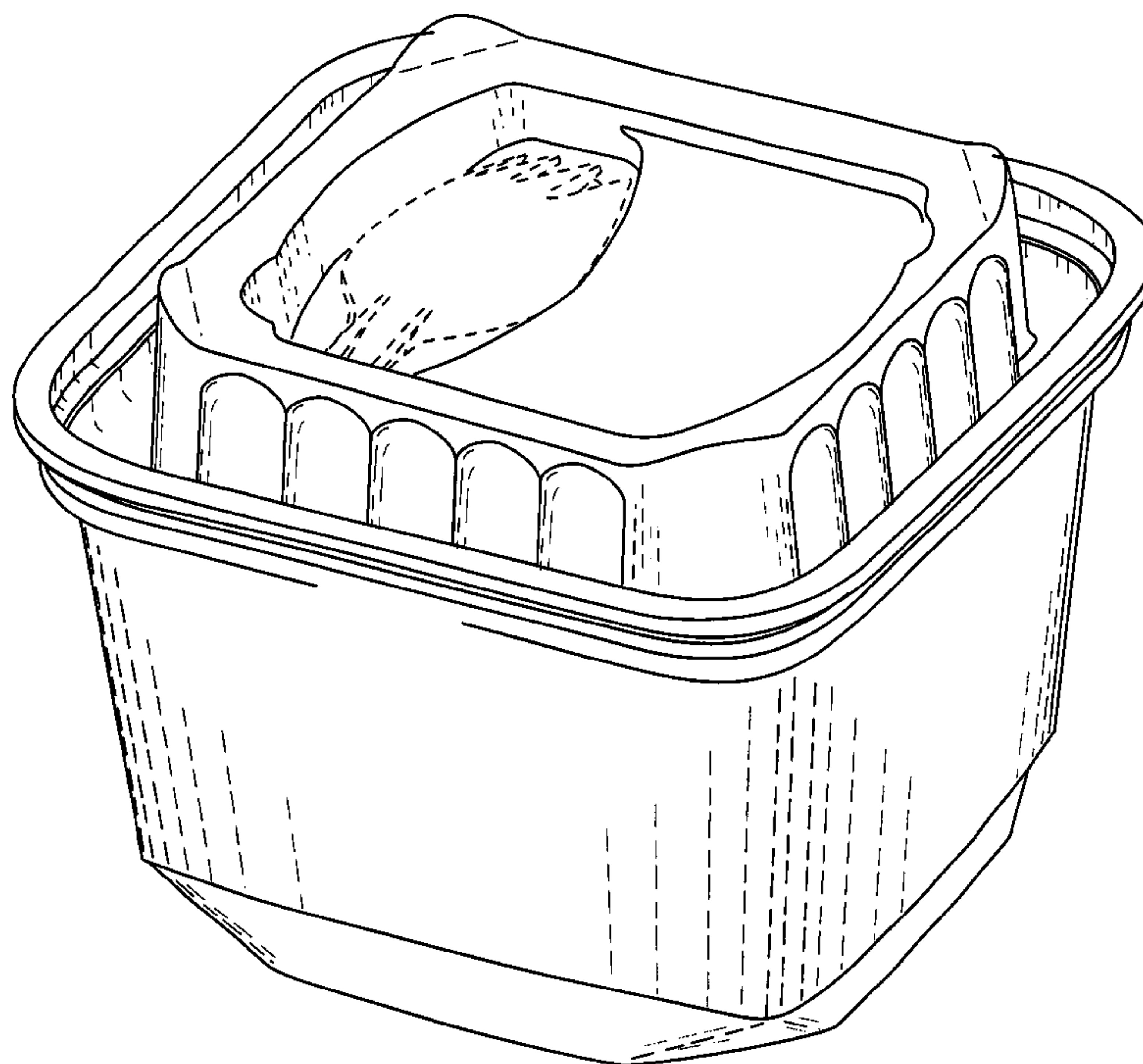
FIG. 5 is a perspective view of the lid on an enlarged scale removed from the container;

FIG. 6 is a side view of the lid in FIG. 5 on an enlarged scale with all other sides being identical thereto; and,

FIG. 7 is a bottom view of the lid in FIG. 5 on an enlarged scale.

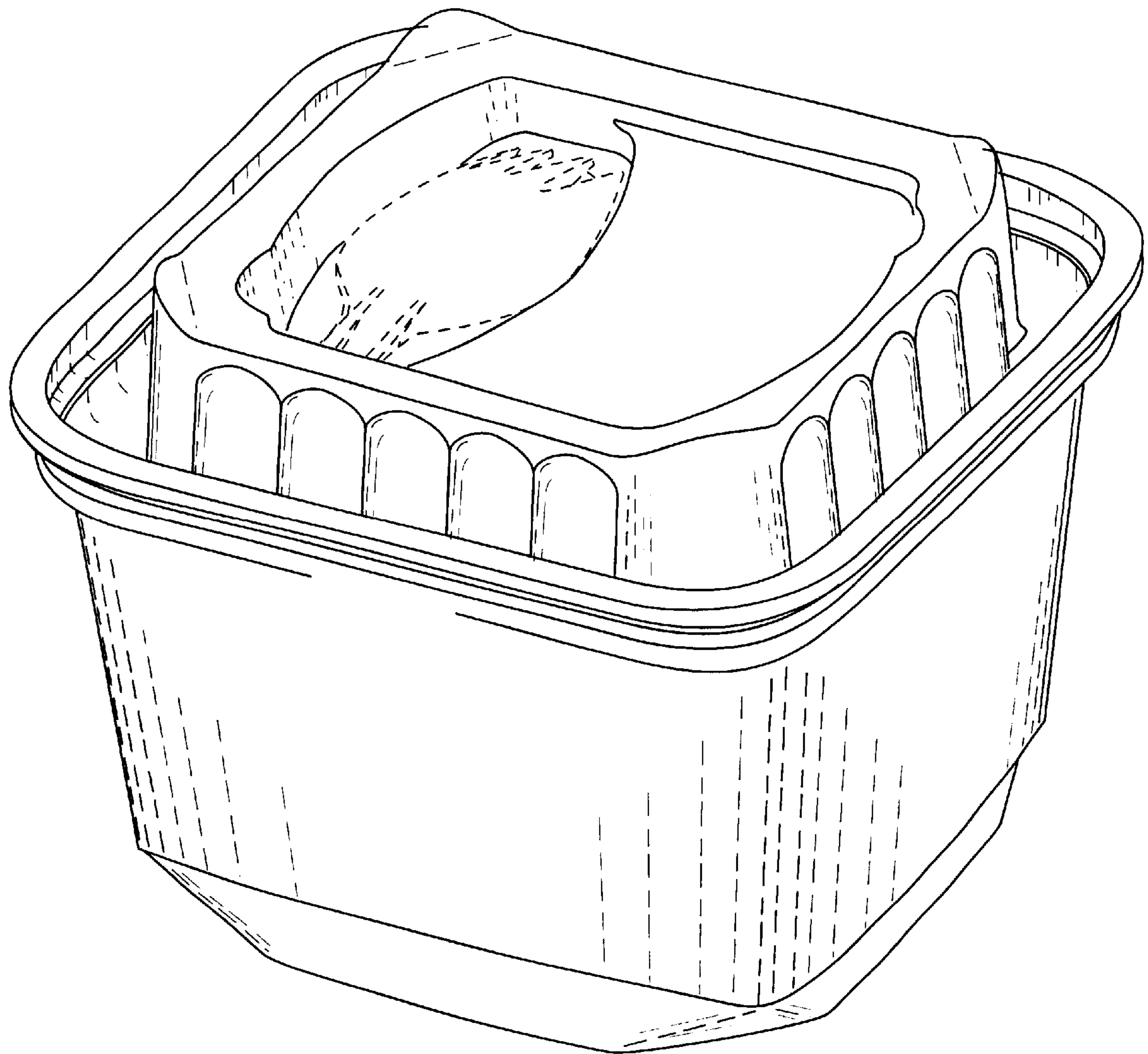

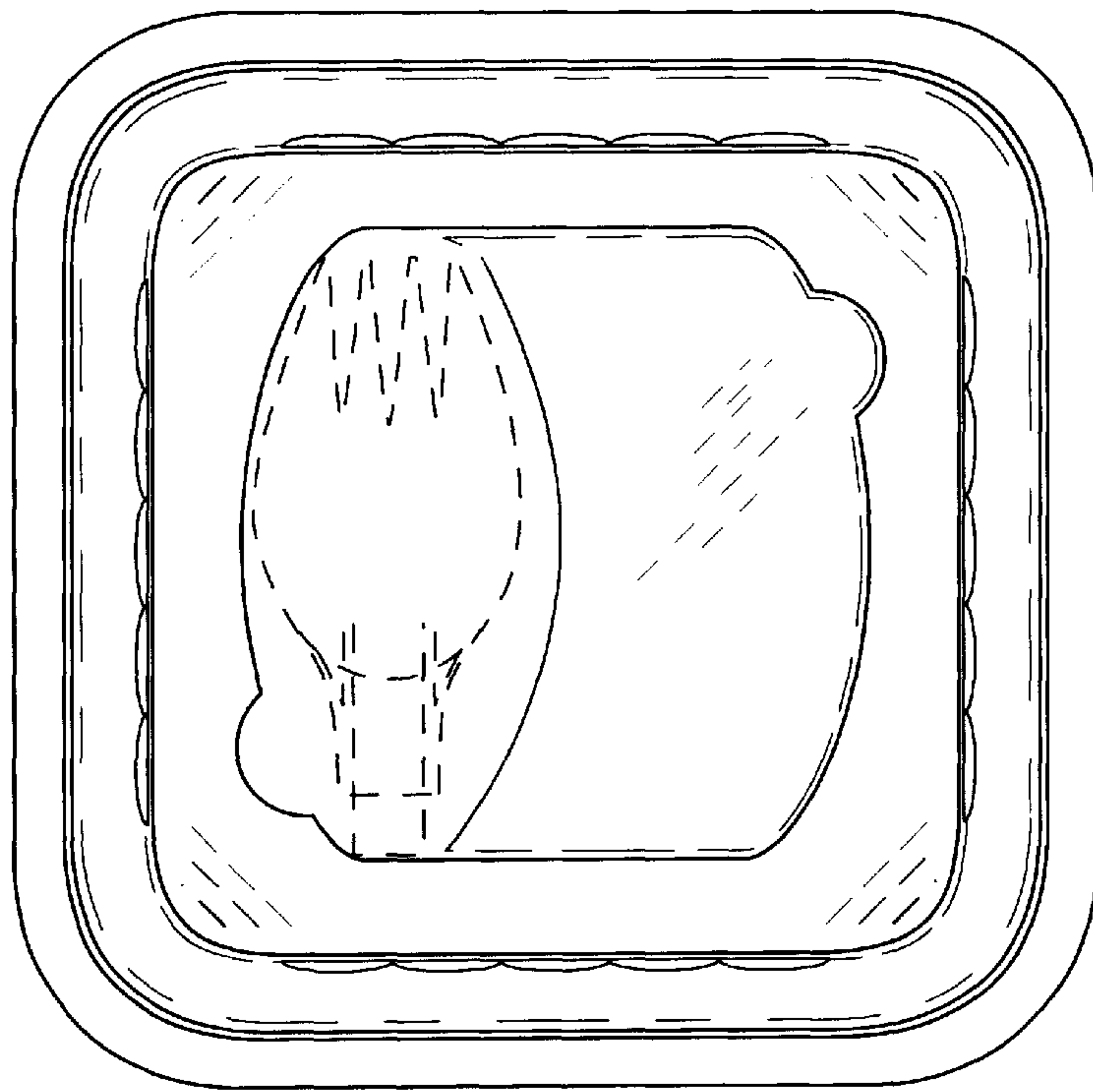

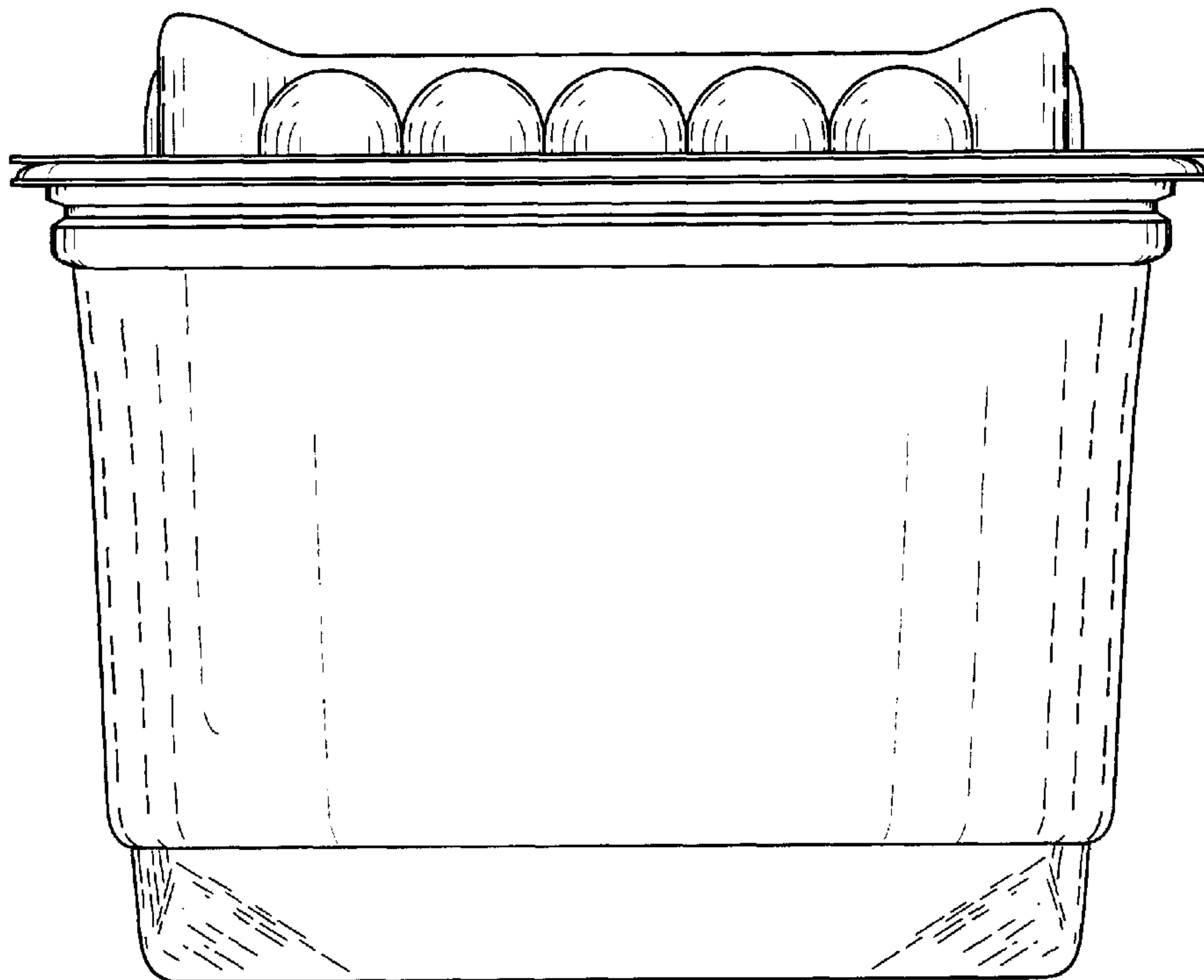

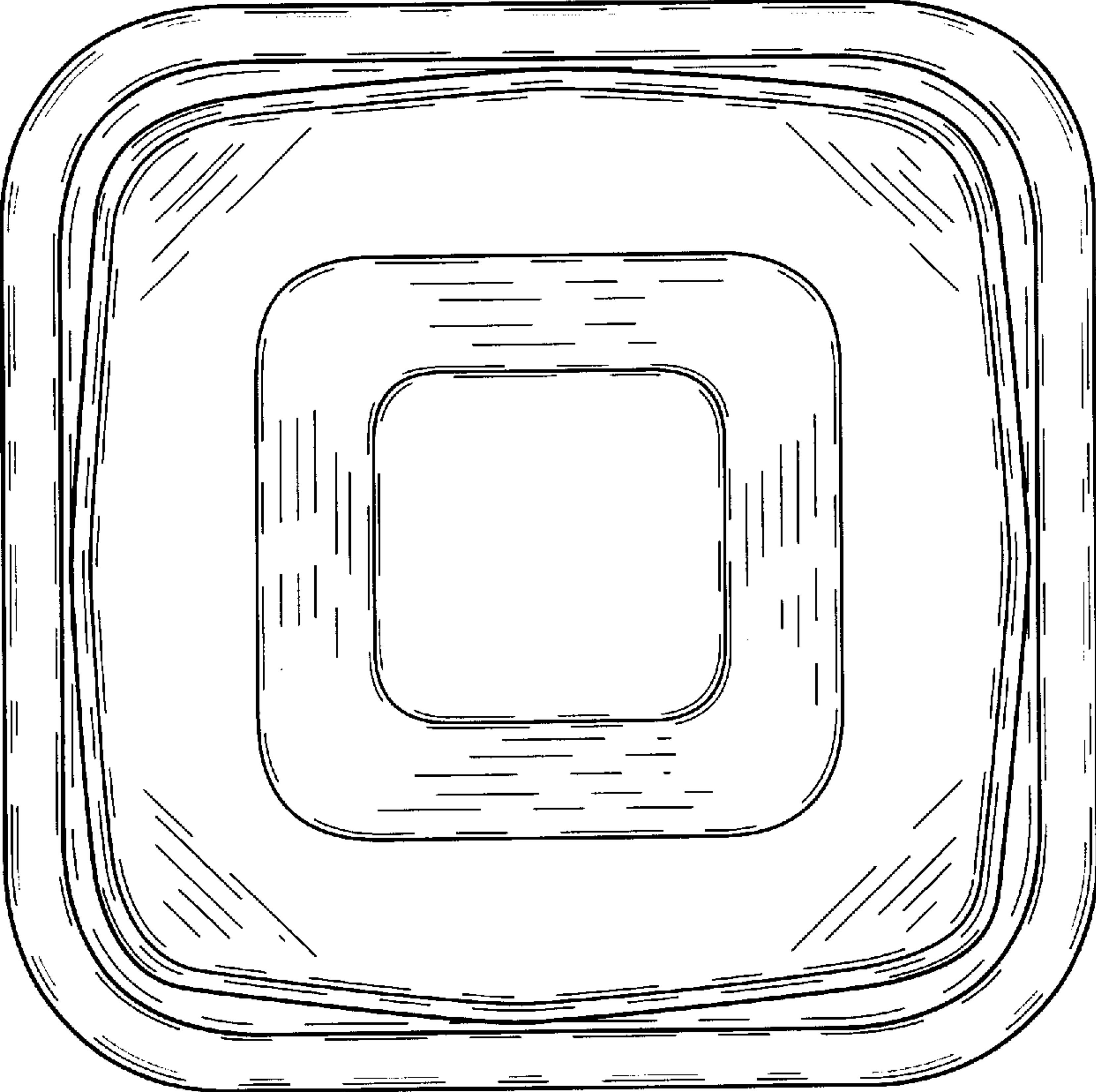

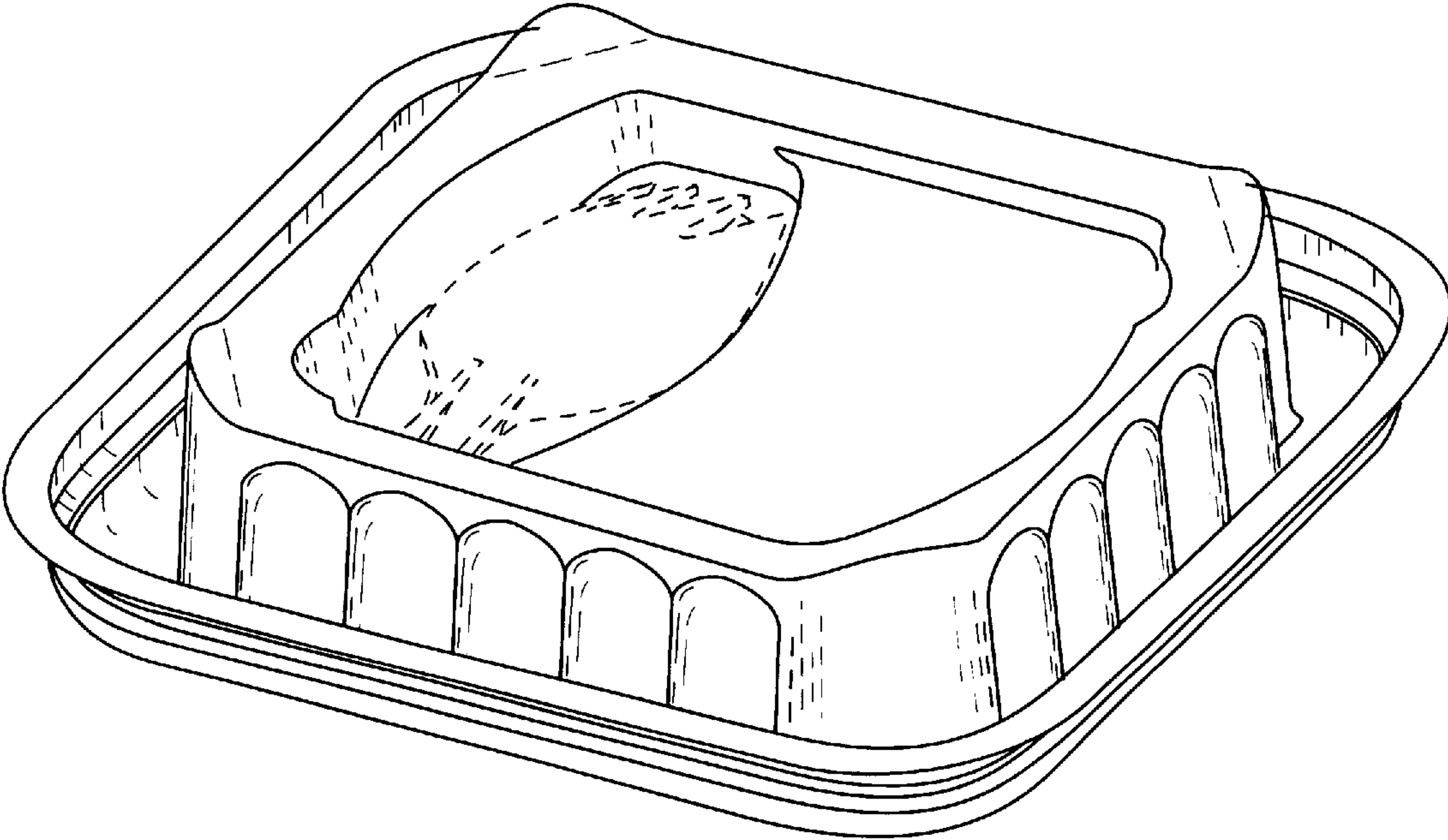

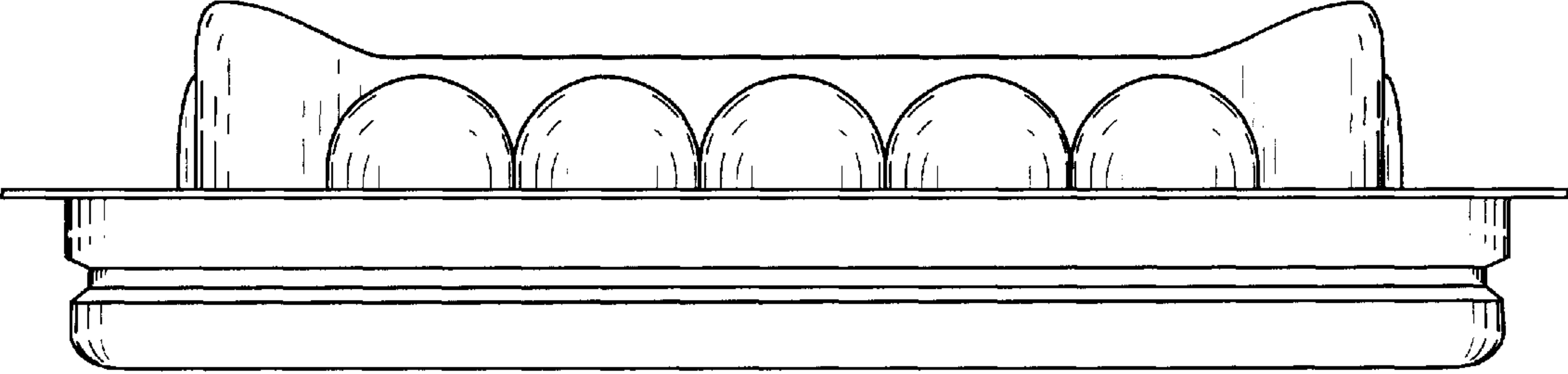

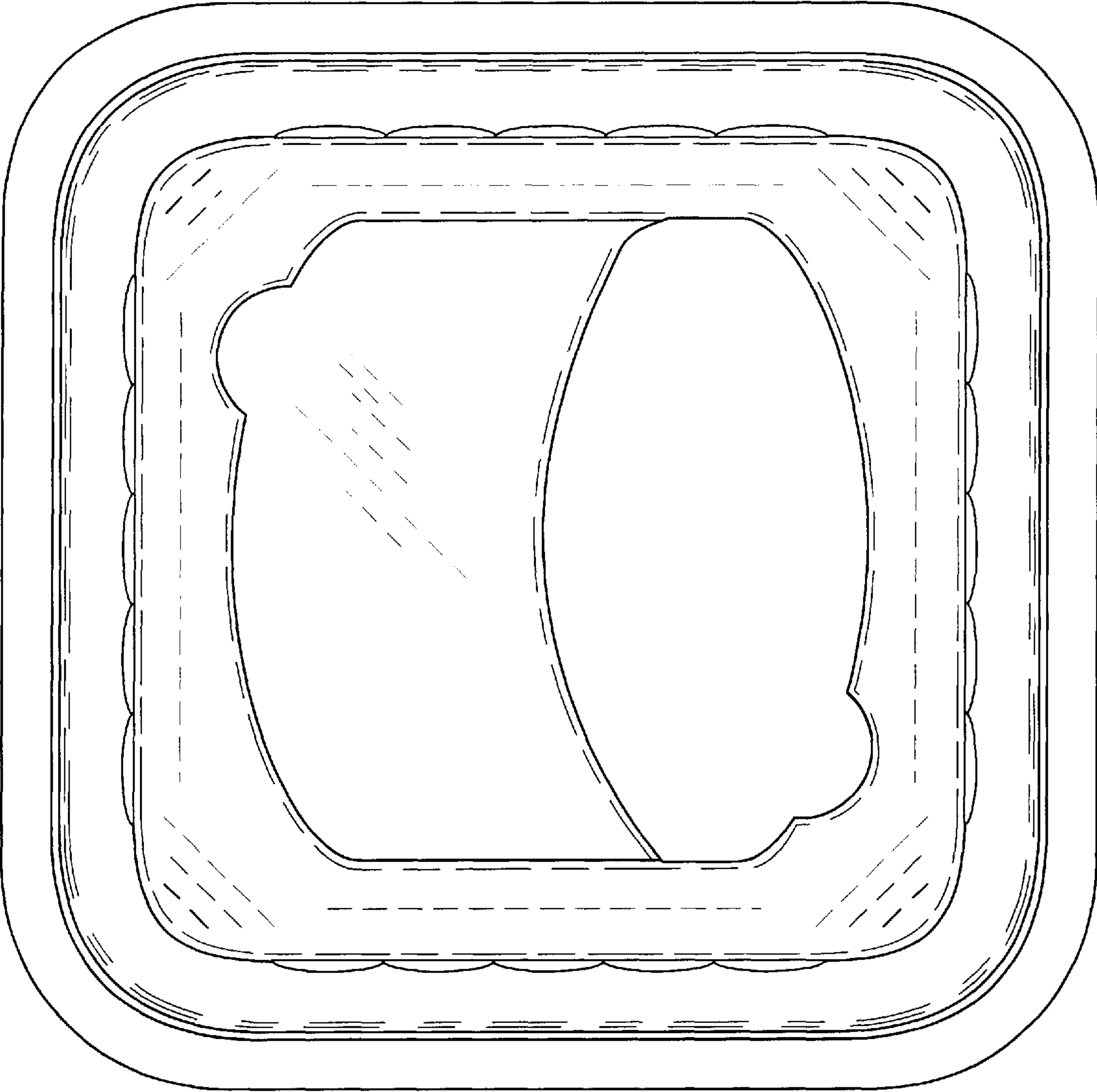
