**DESCRIPTION**

FIG. 1 is a front view of a transparent bottle, the rear view being a mirror image;

FIG. 2 is a side view thereof, the opposite side view being a mirror image;

FIG. 3 is a top view thereof;

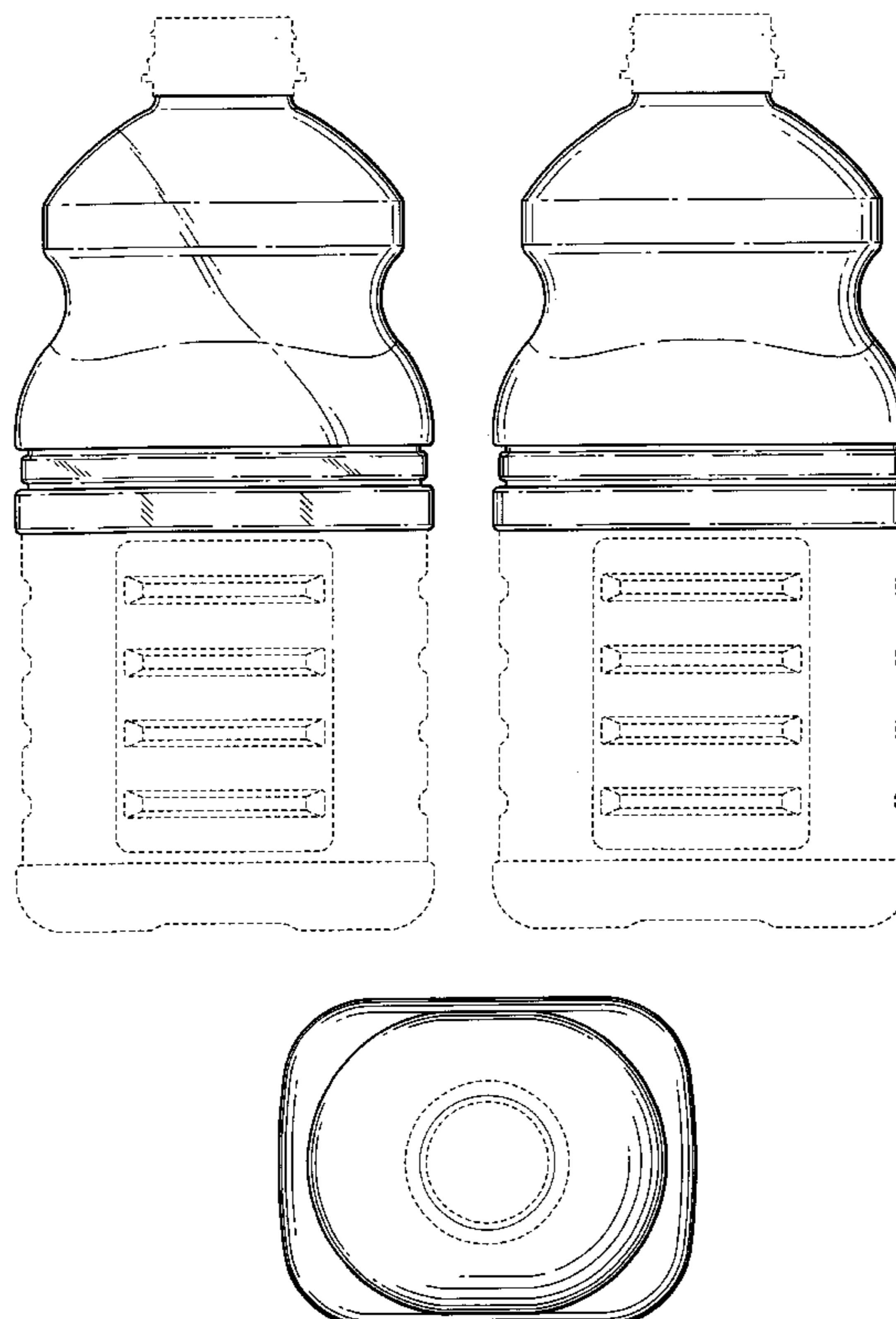
FIG. 4 is a front view of a non-transparent bottle, the rear view being a mirror image;

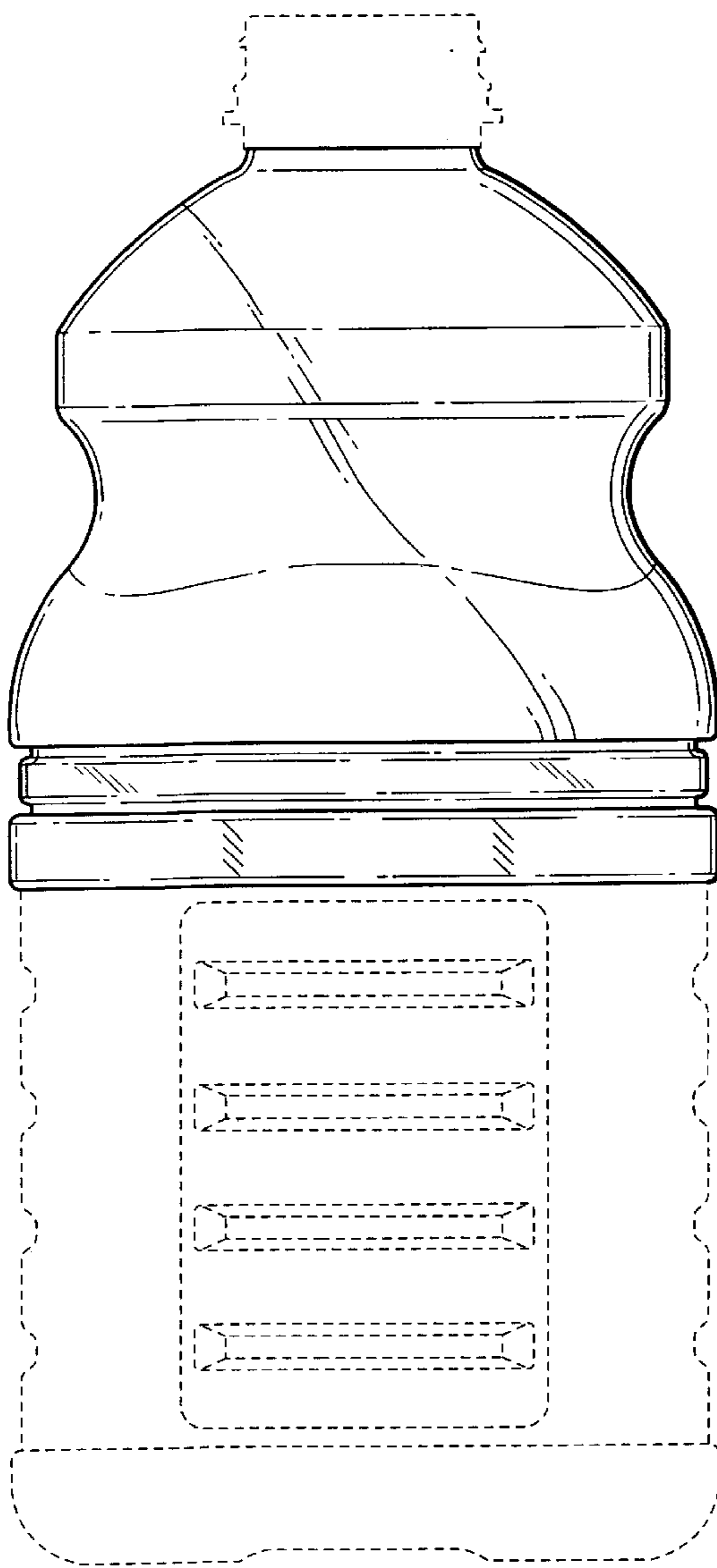

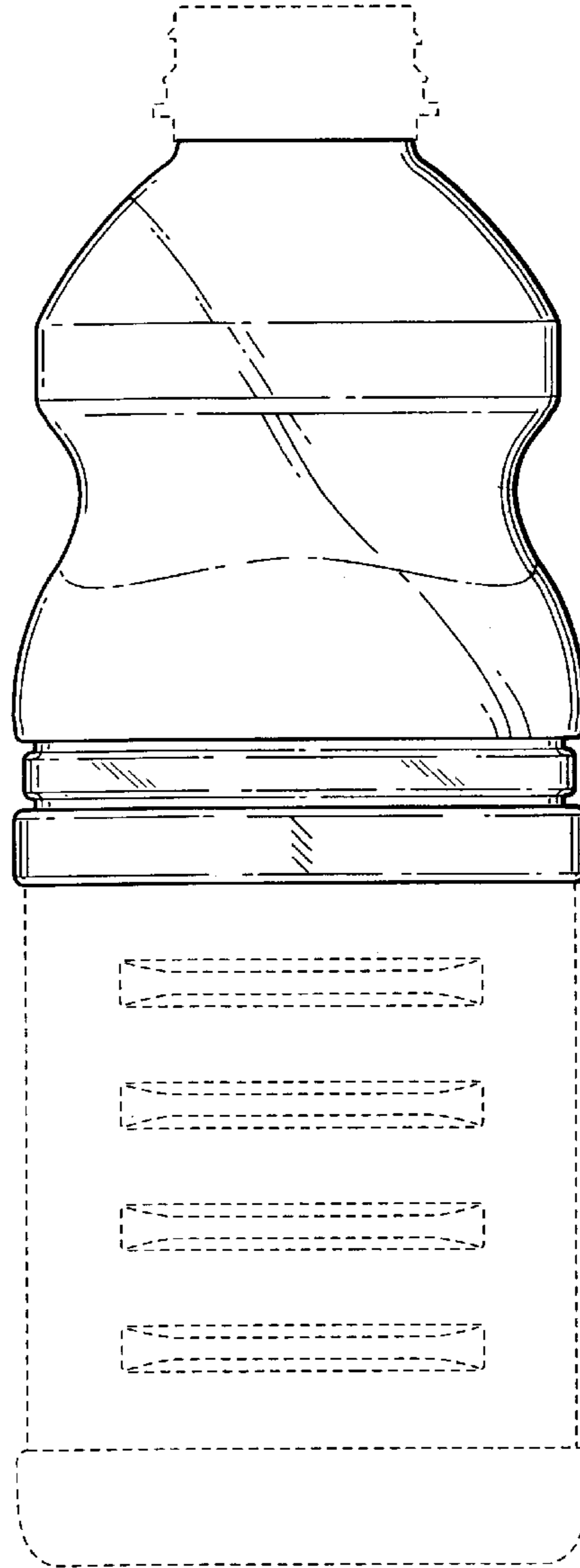

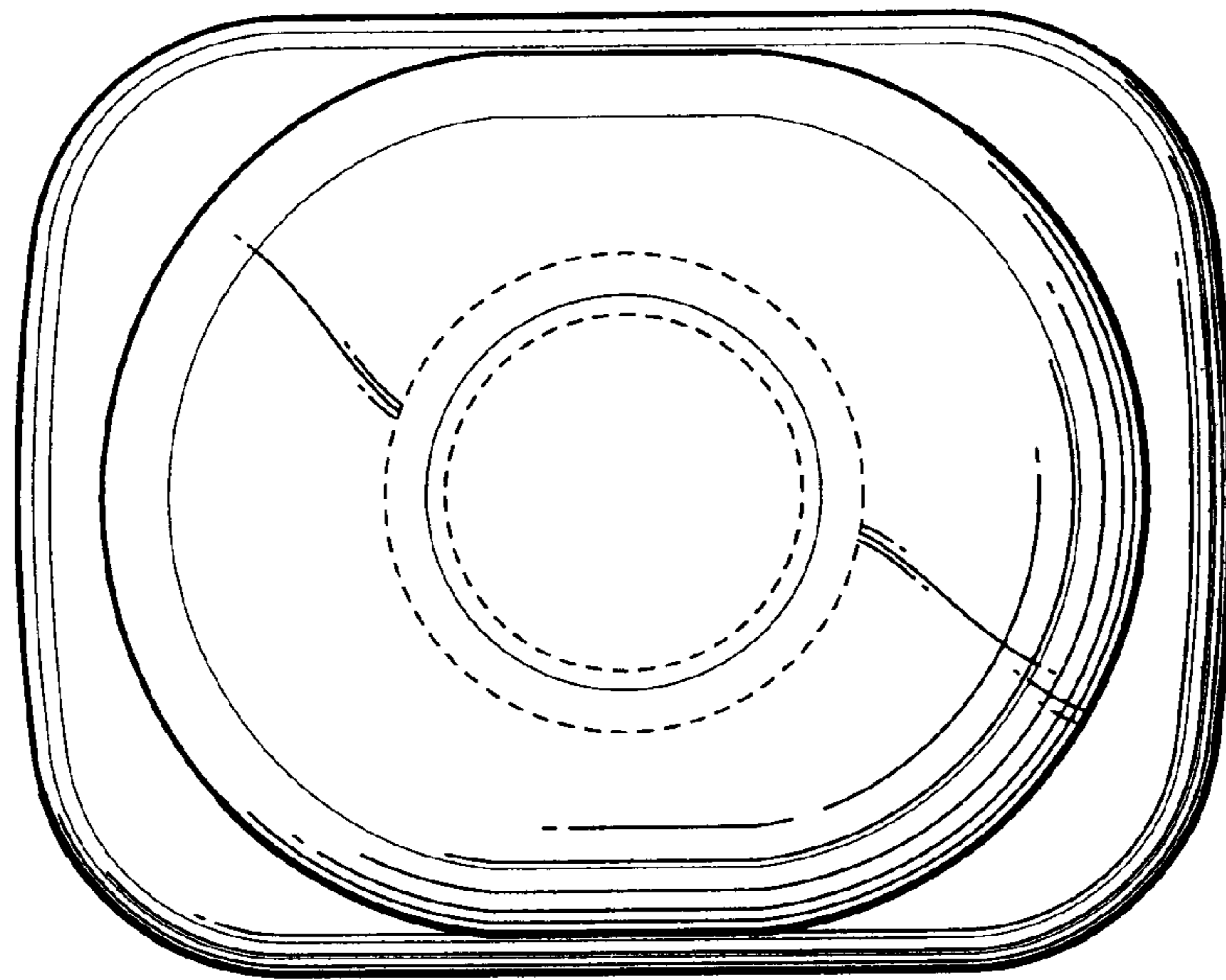

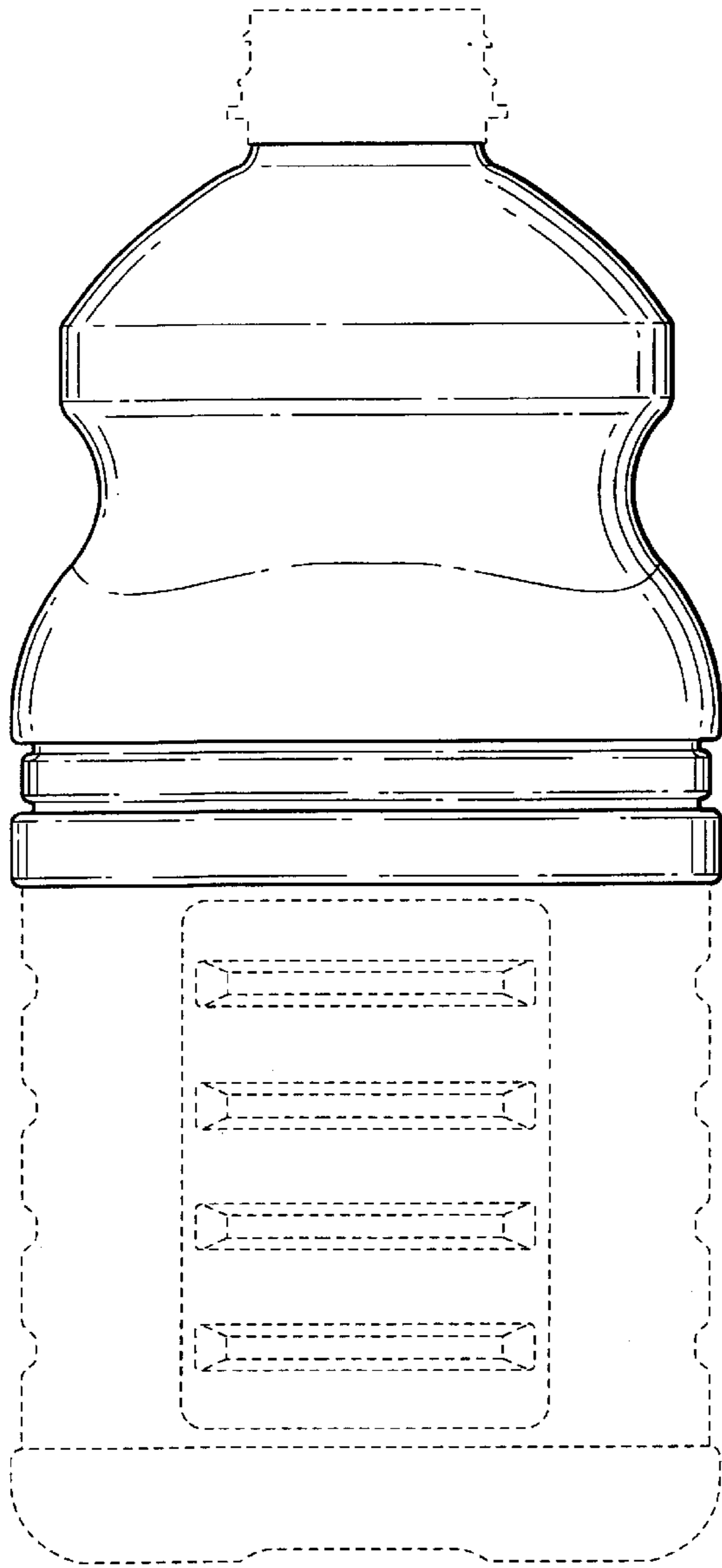

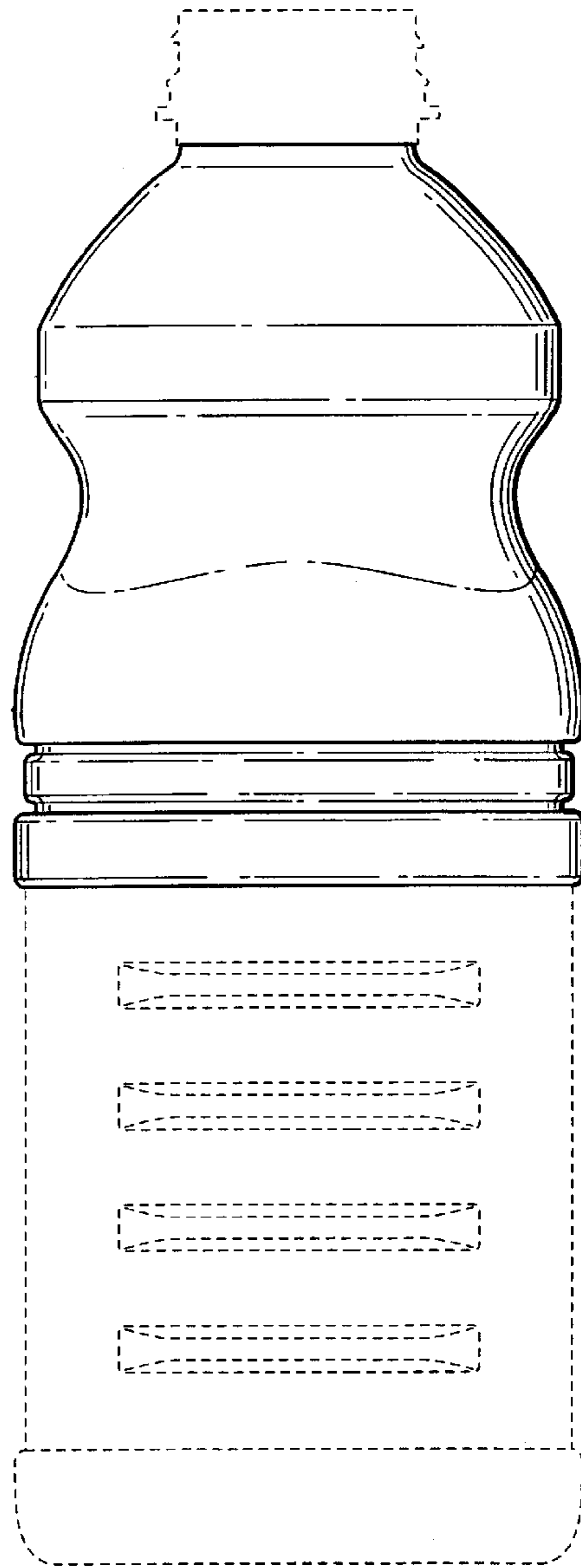

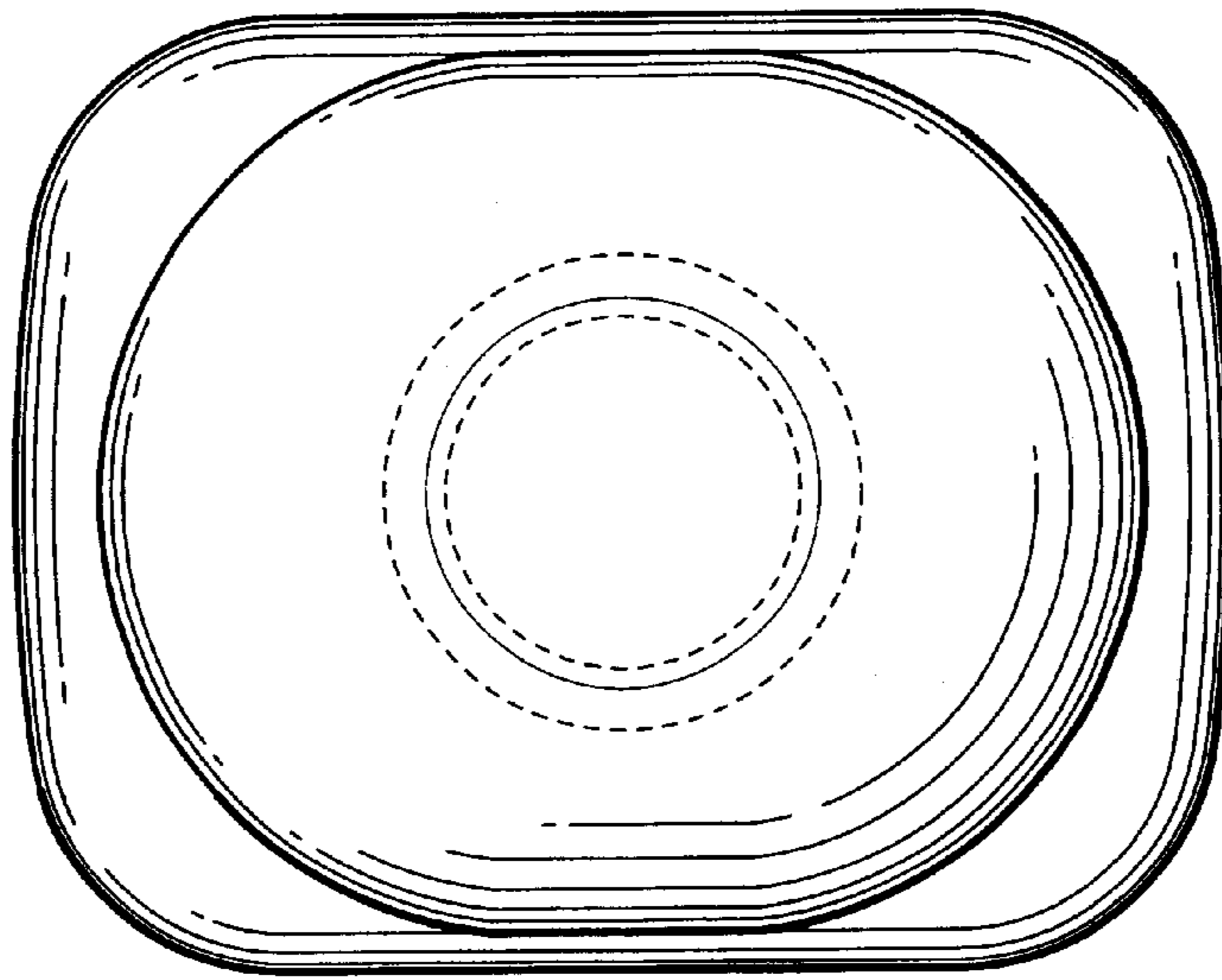
