We claim the ornamental design for a bottle, as shown and described.

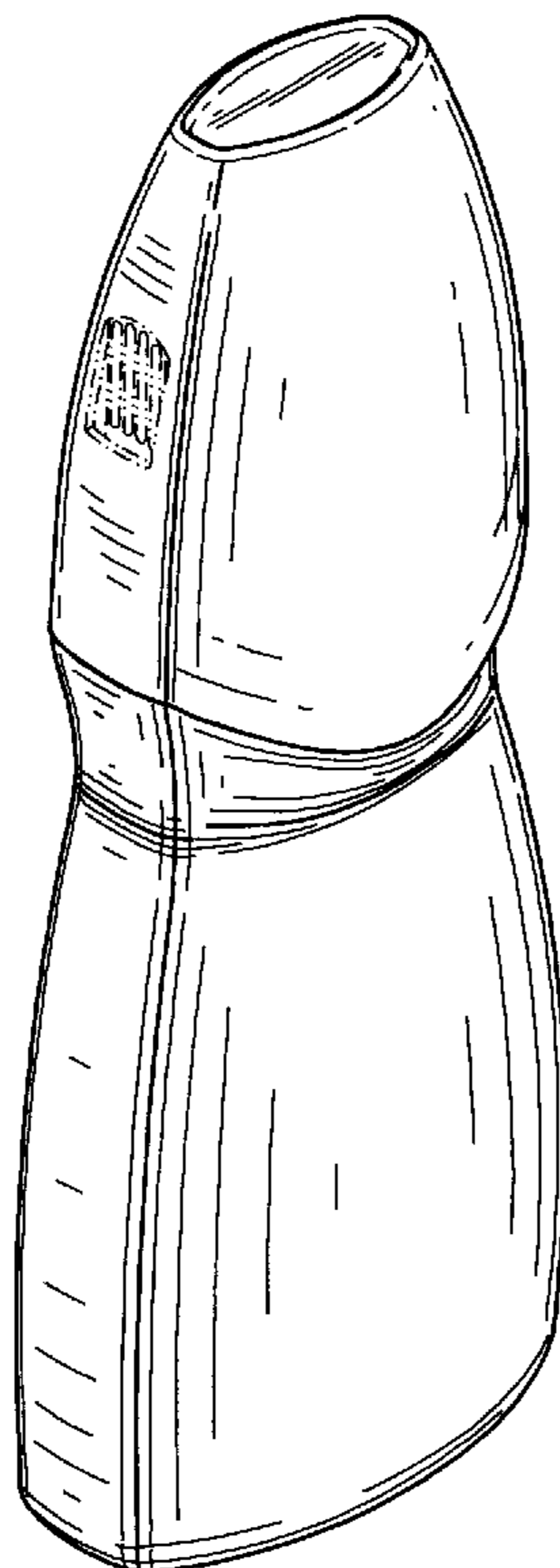
DESCRIPTION

FIG. 1 is a front perspective view of a bottle;
FIG. 2 is a front elevation view thereof, shown at an enlarged scale;
FIG. 3 is a right side elevation view thereof, the left side elevation view being identical;
FIG. 4 is a top plan view thereof; and,
FIG. 5 is a bottom plan view thereof.
The left side of the bottle is symmetrical with the right side shown in FIG. 3.

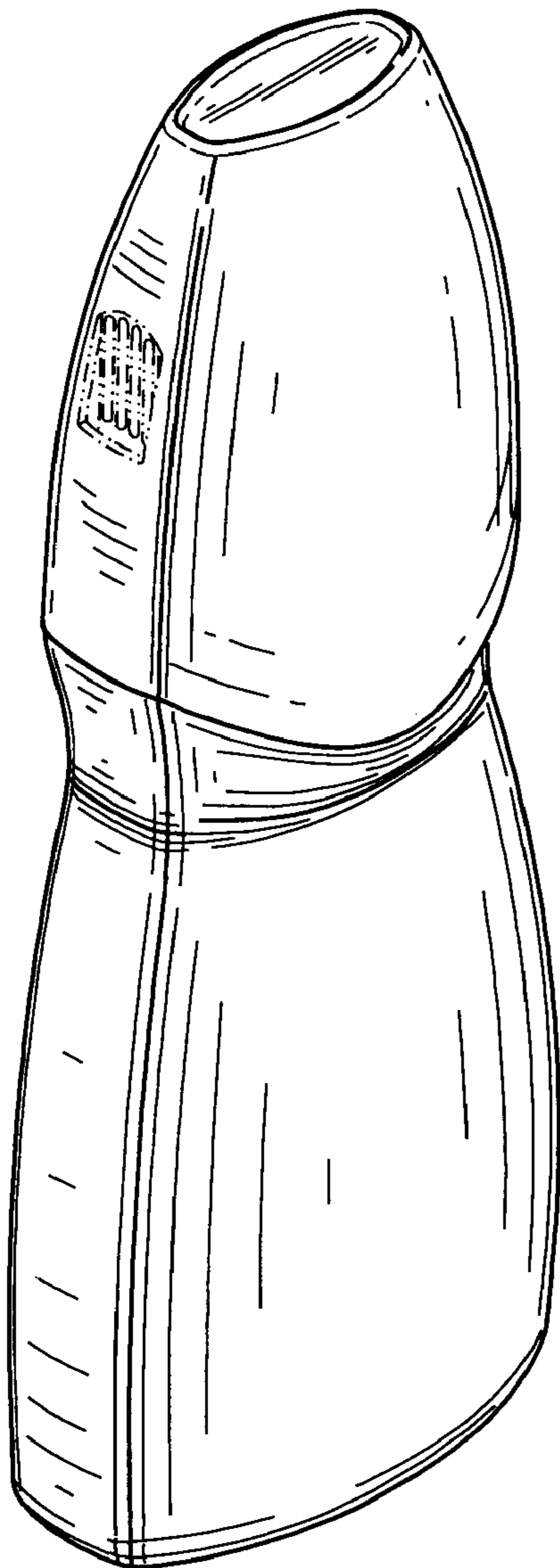

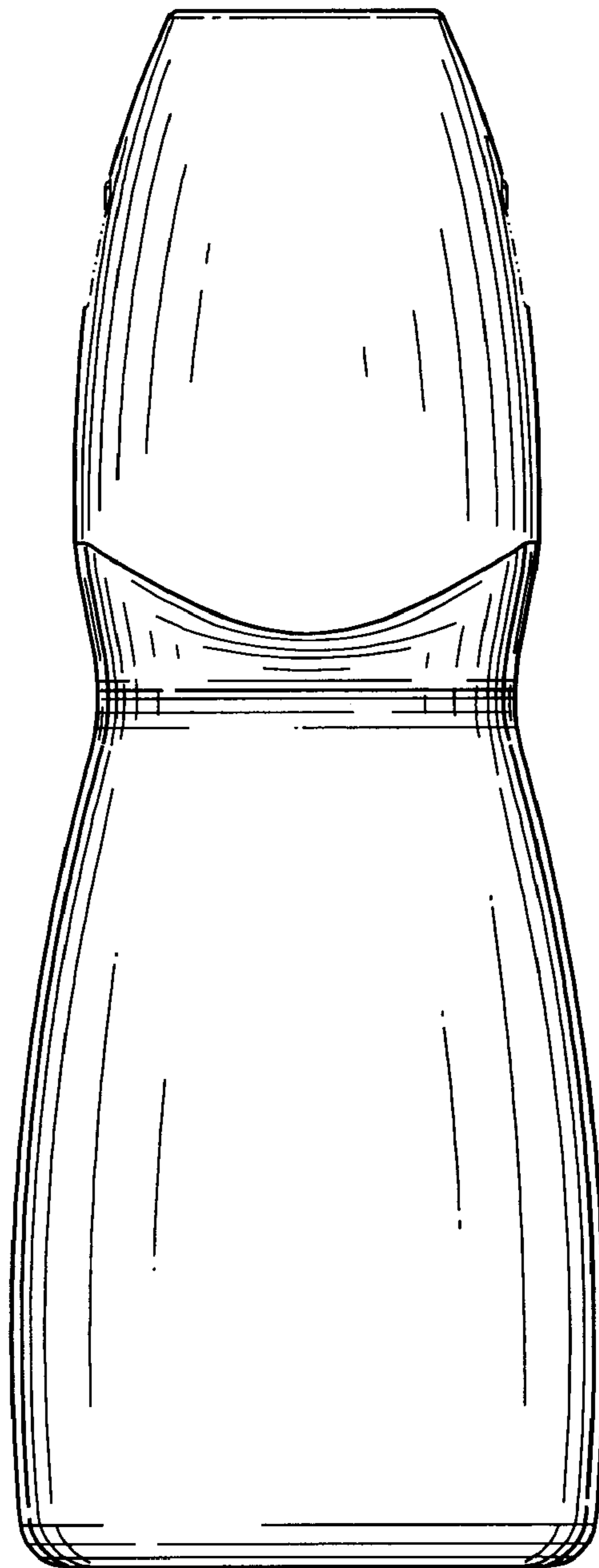

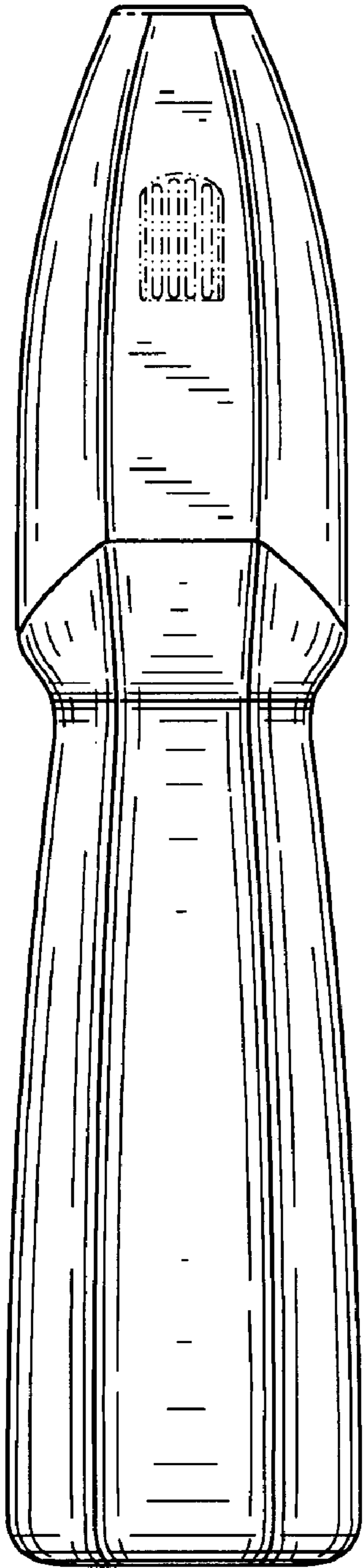

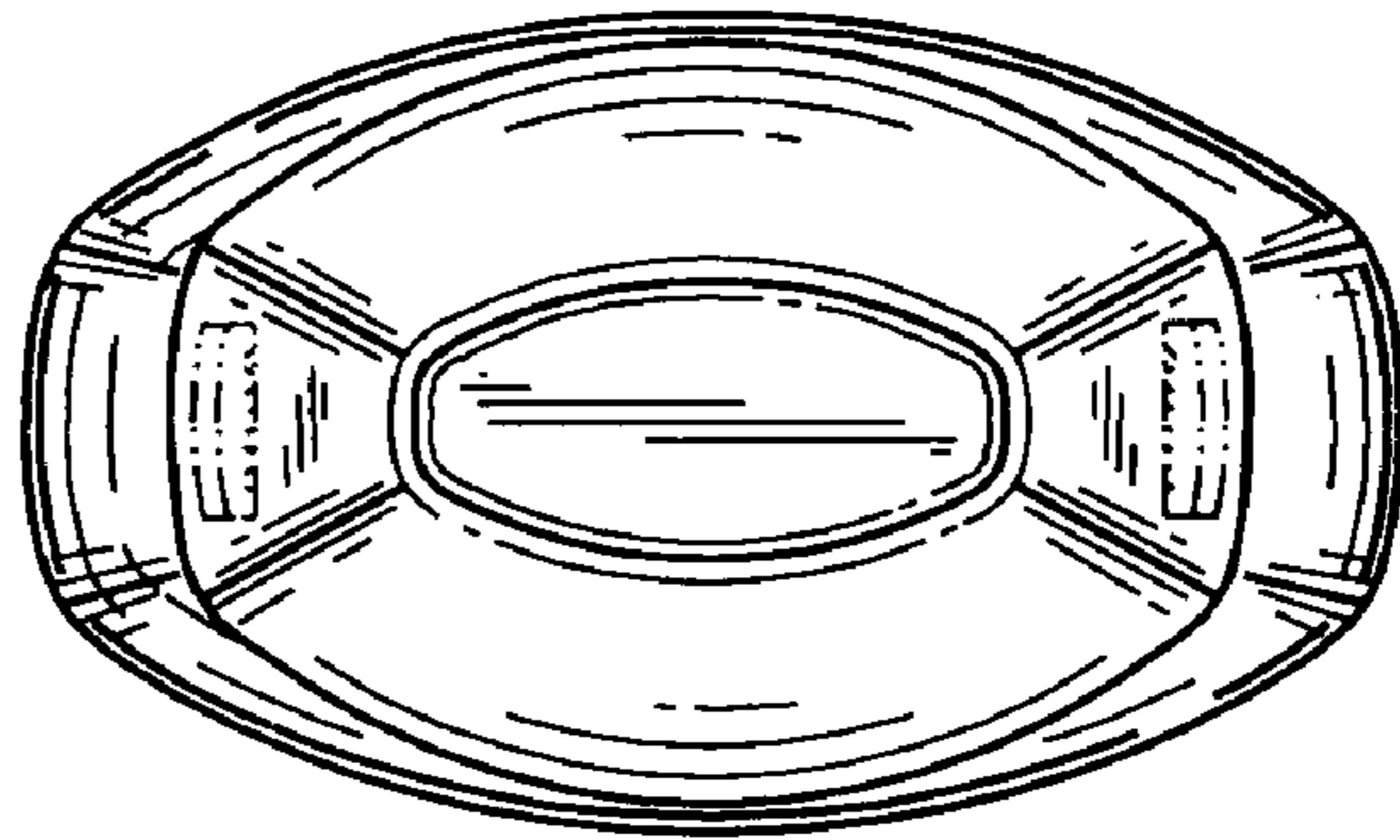

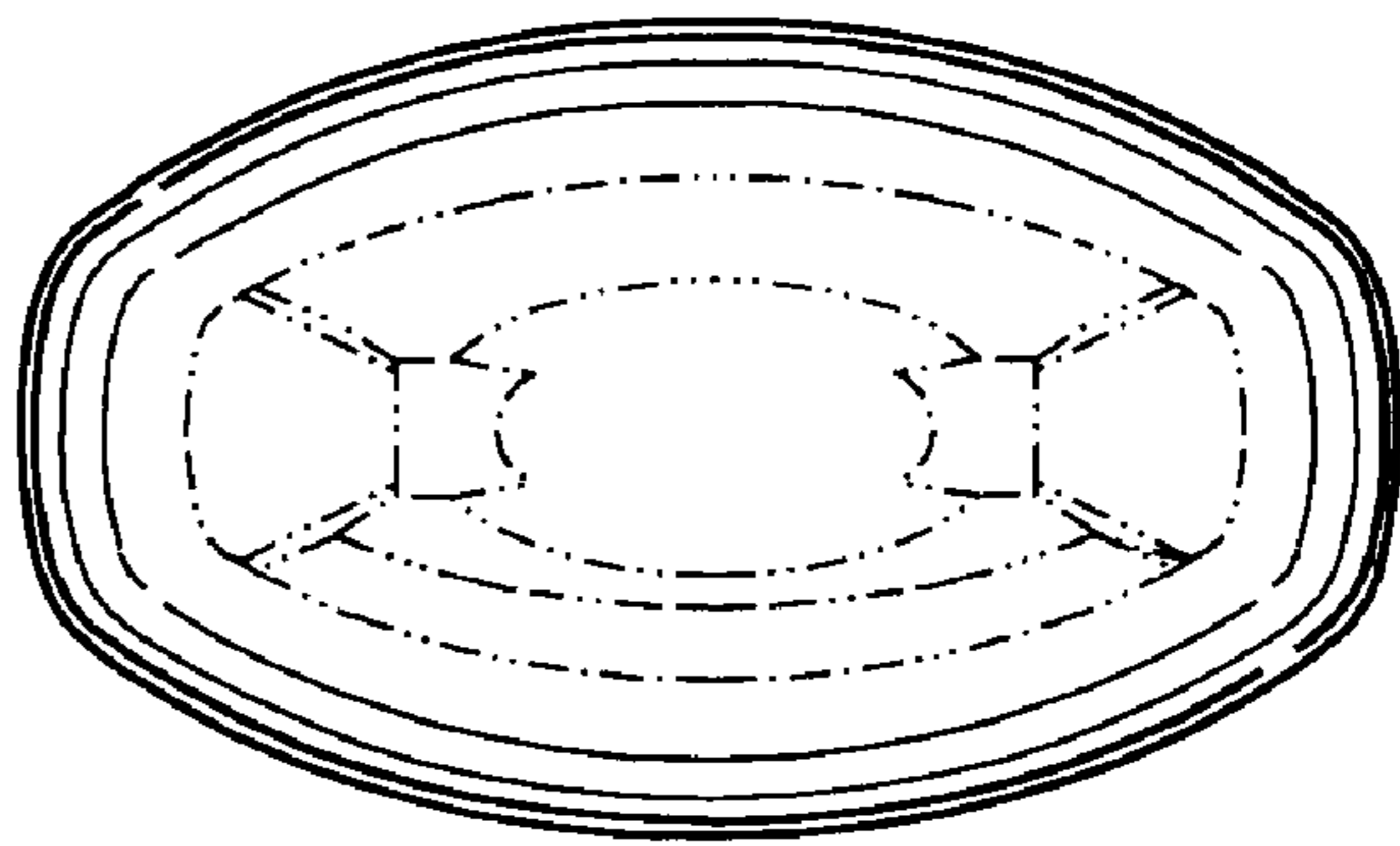
