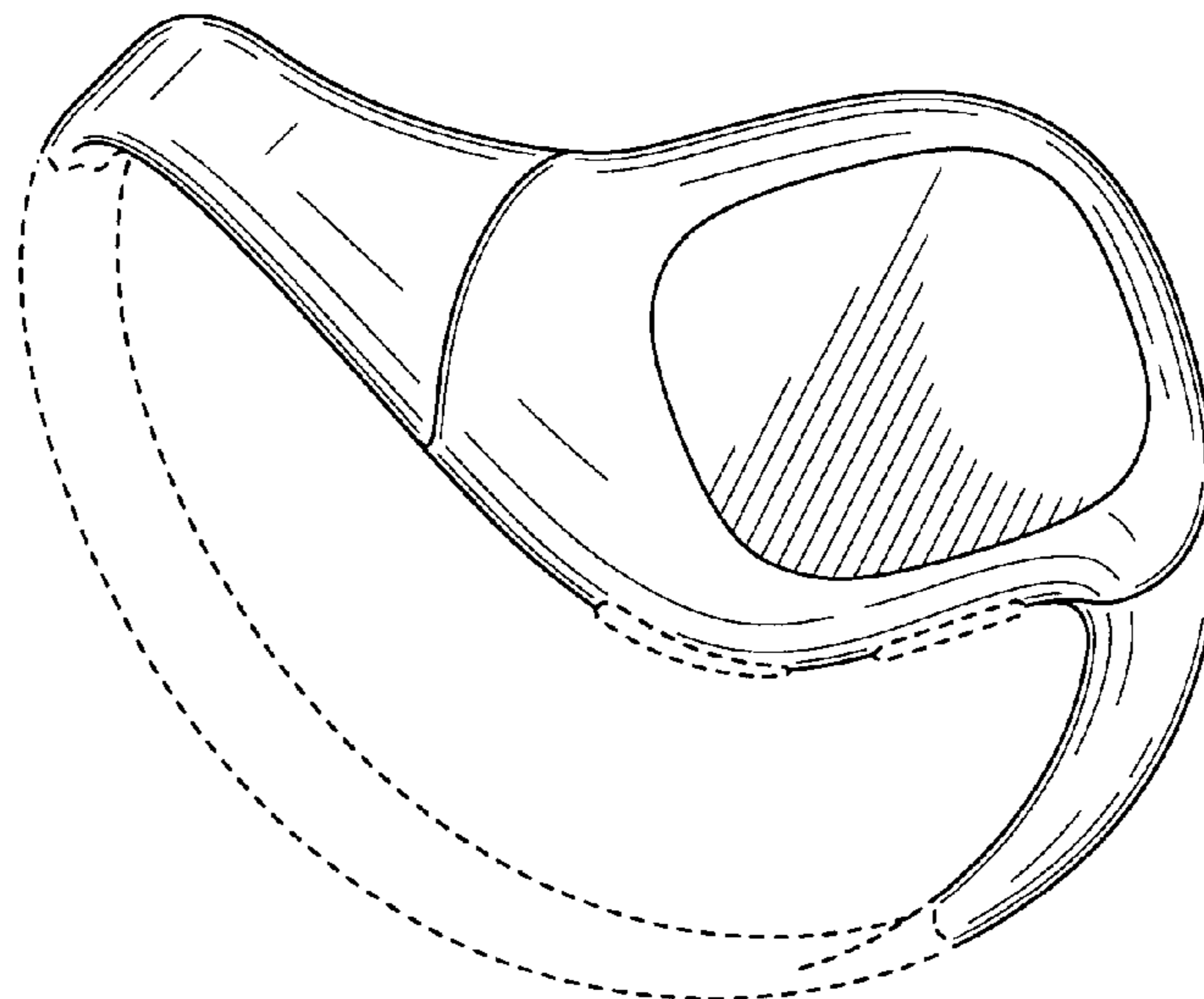
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a portion of a watch showing
my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof with a portion of the disclaimed
band removed for clarity;
FIG. 4 is a right side view thereof;
FIG. 5 is a left side view thereof,
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.
The broken line showing of various regions of the watch and
band is for illustrative purposes only and forms no part of the
claimed design.

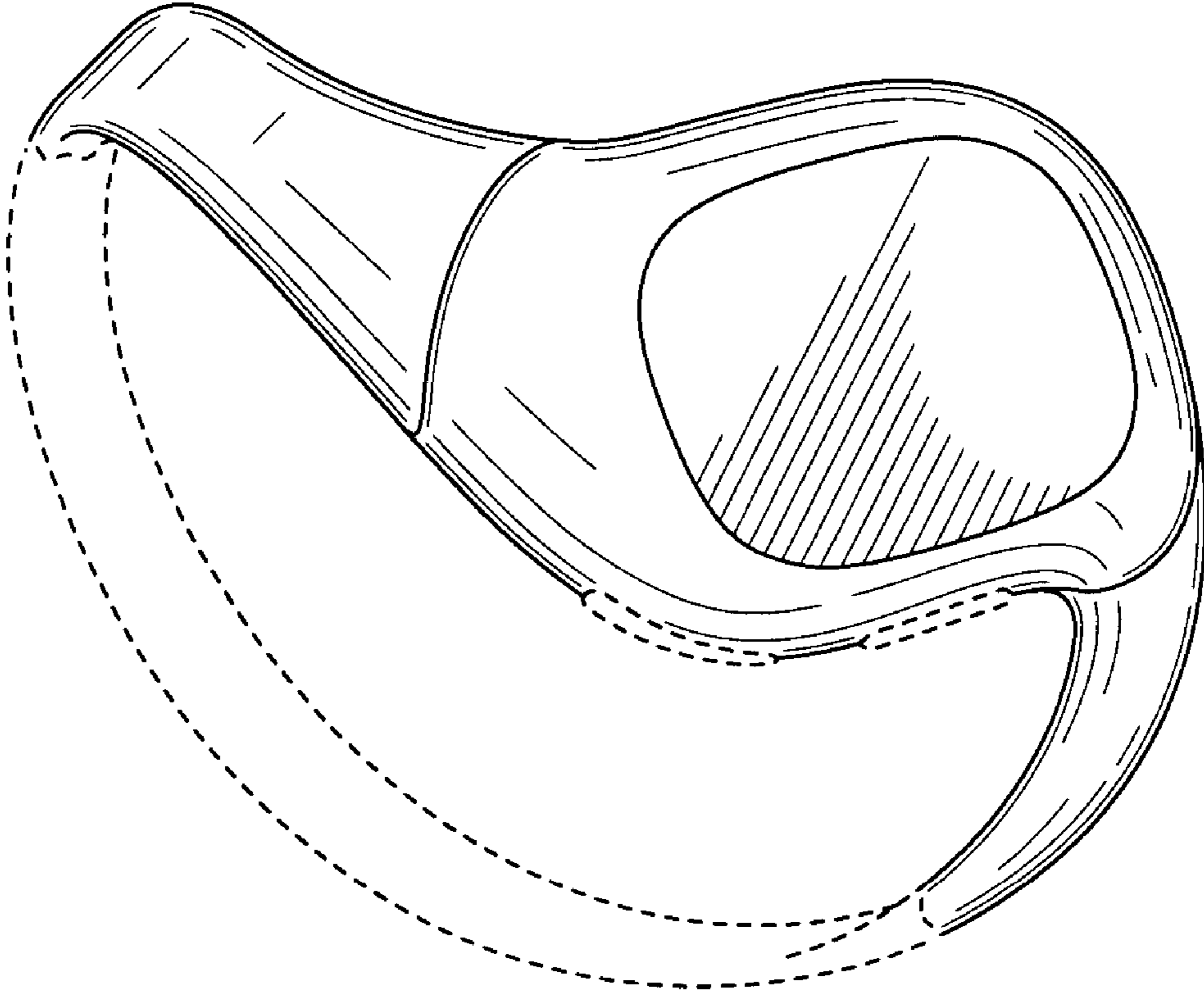

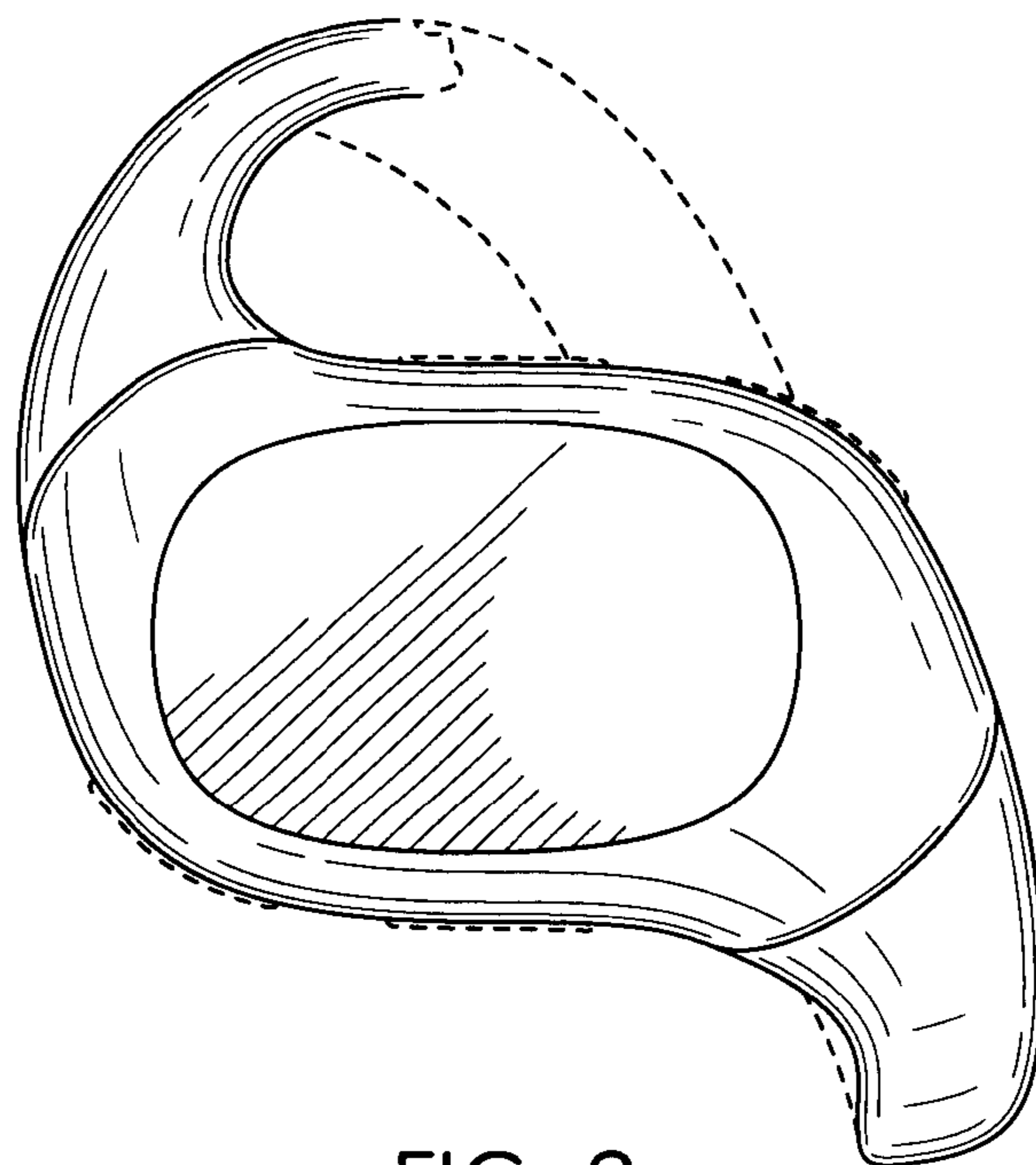

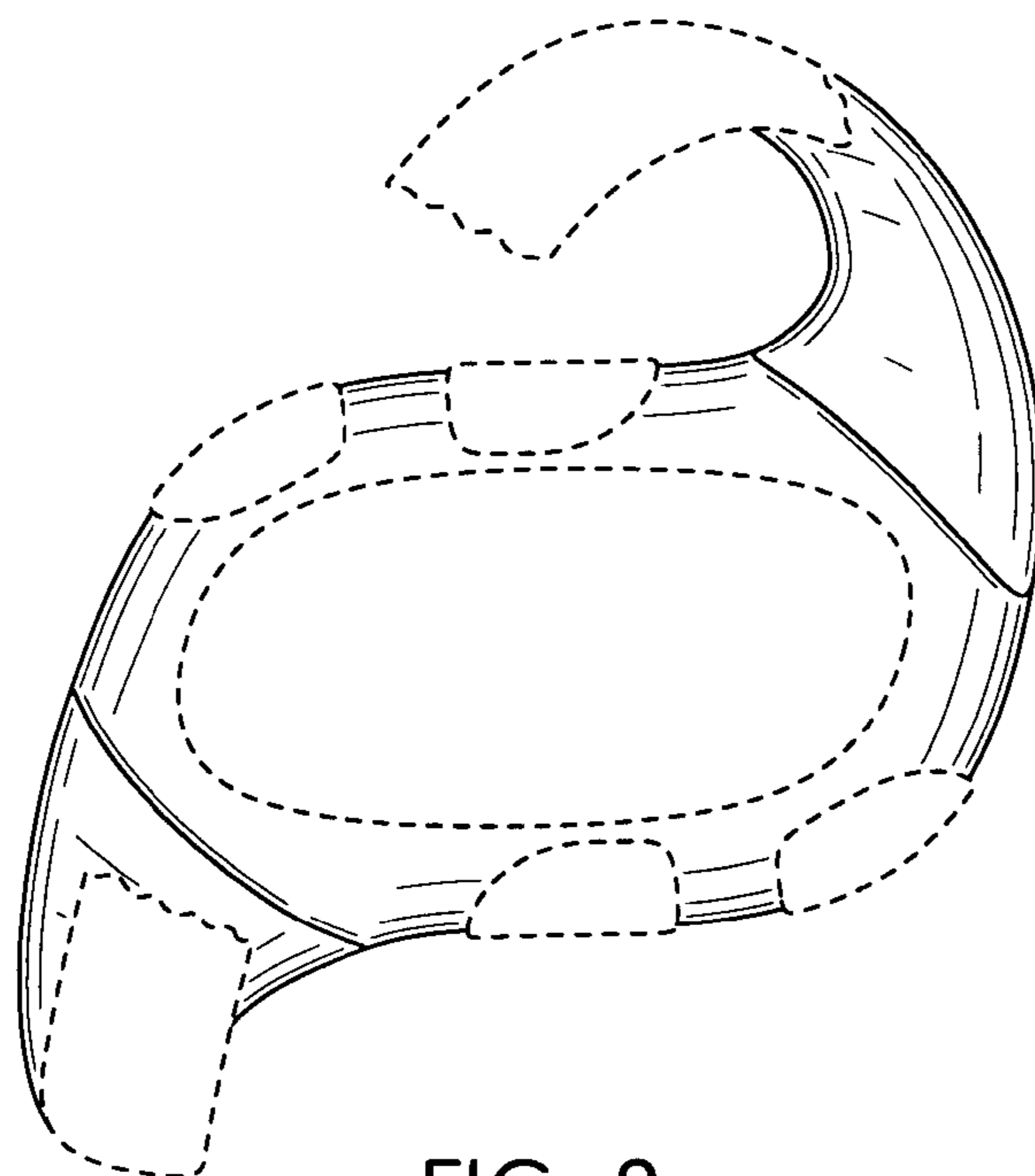

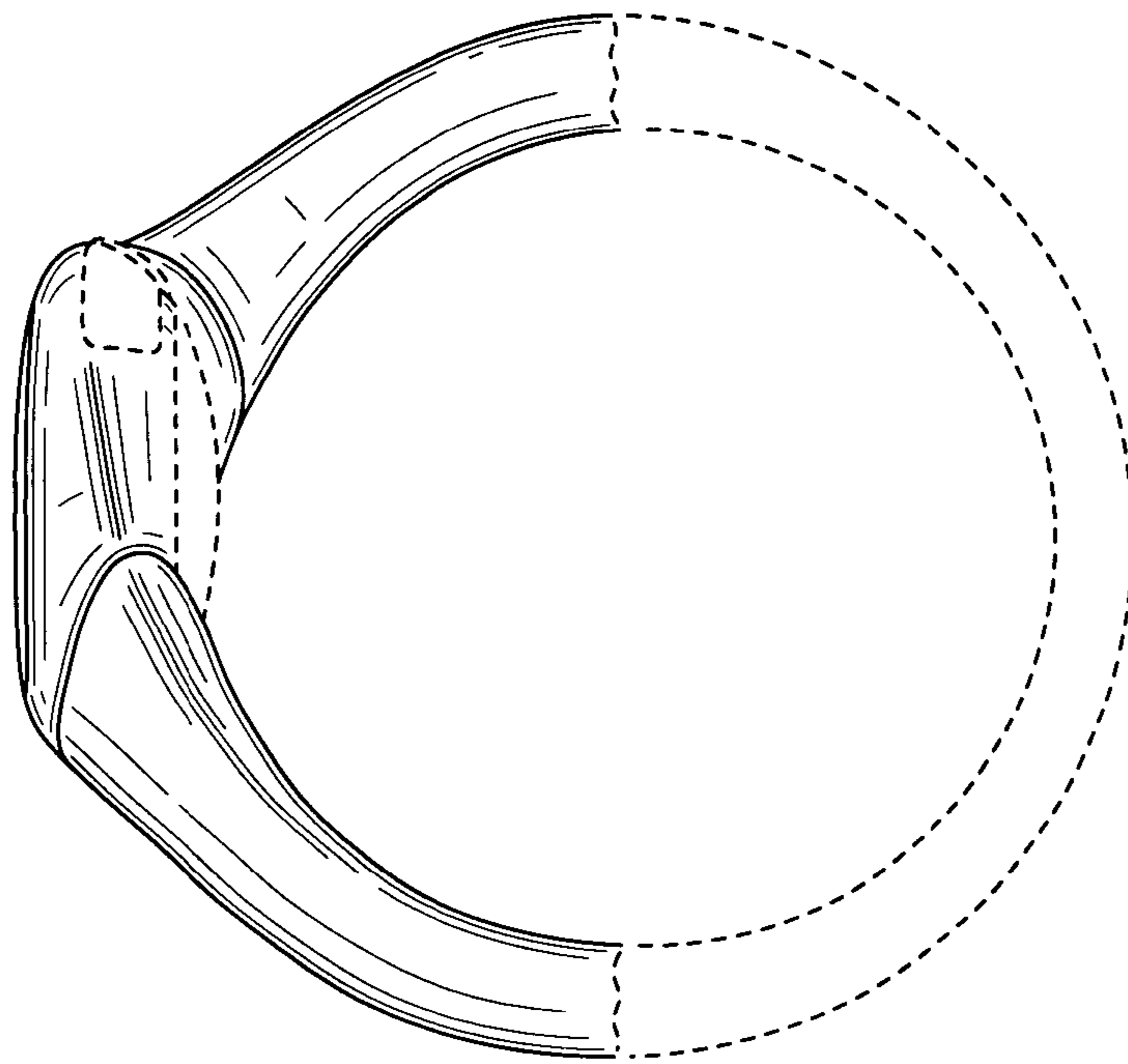

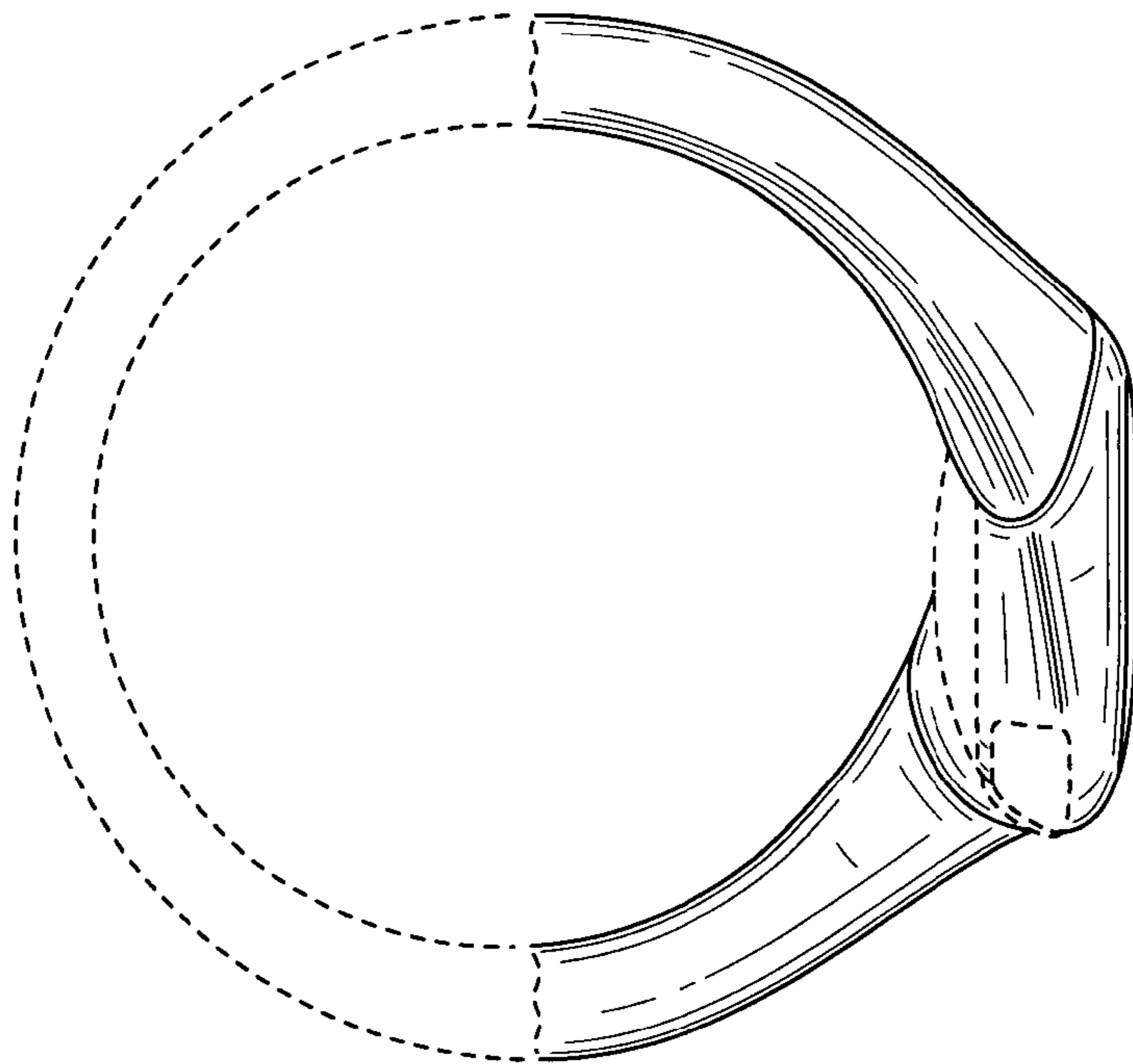

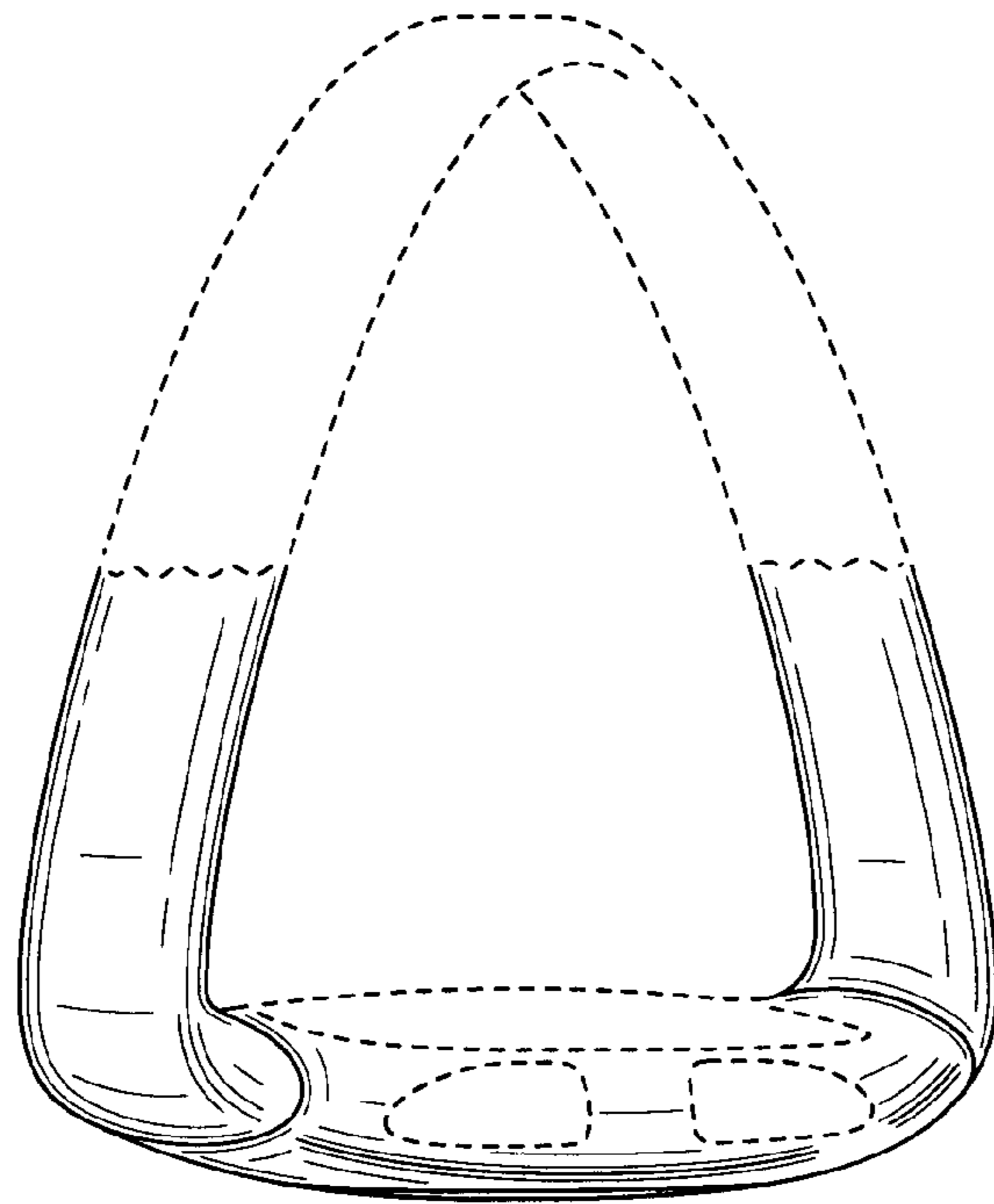

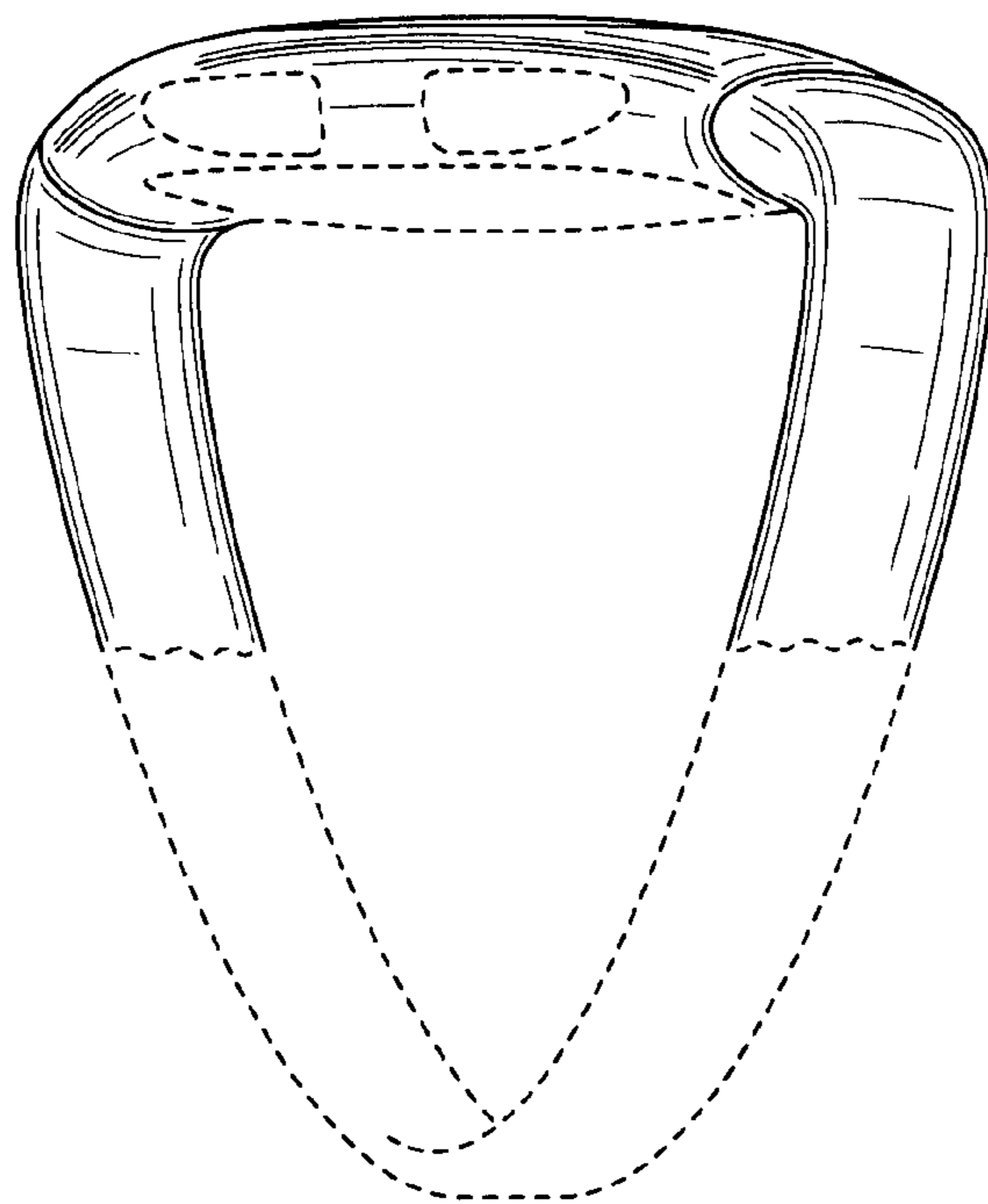
