(57) **CLAIM**

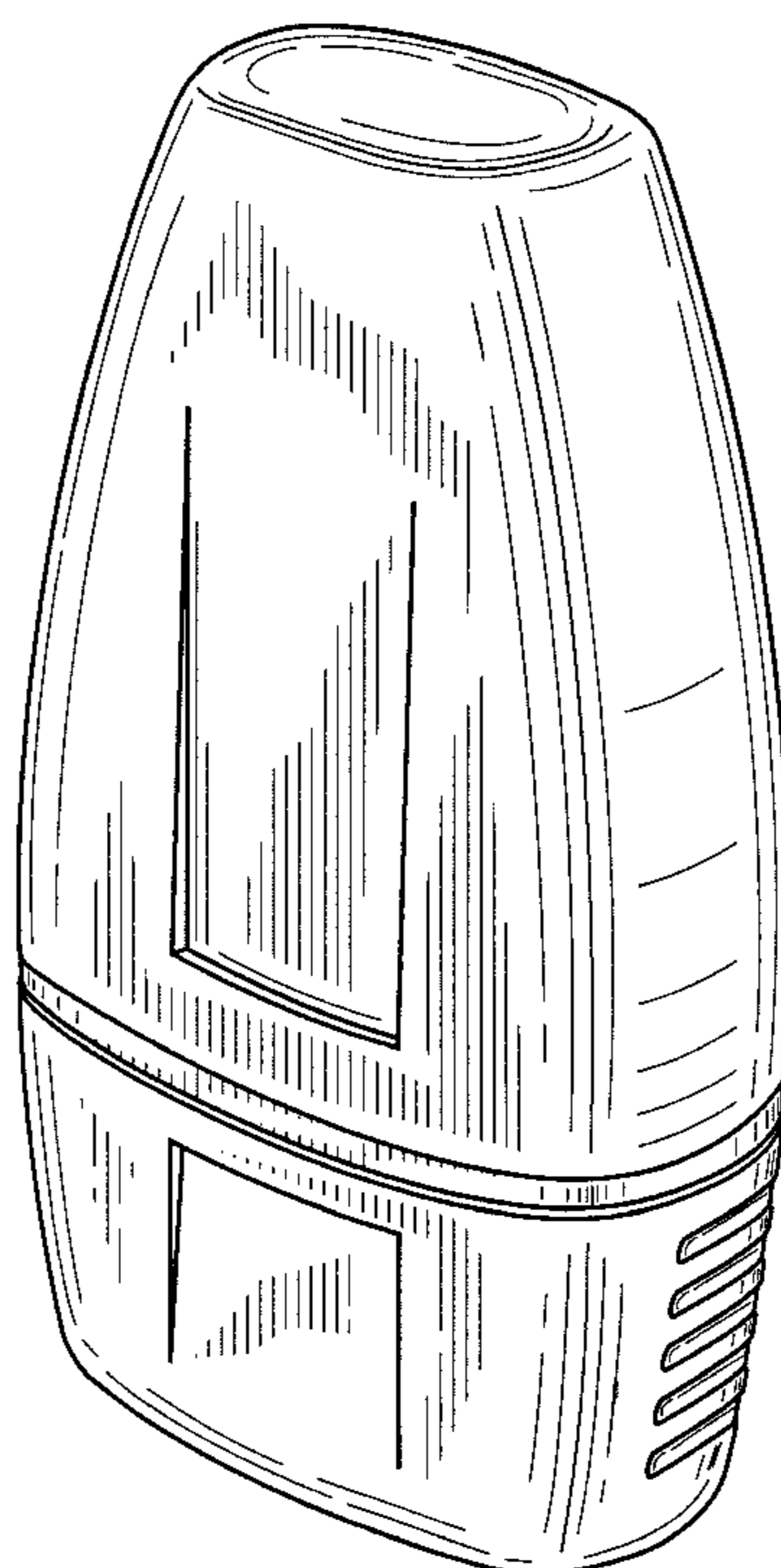
The ornamental design for a powder inhalator, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a powder inhalator showing our new design with a cap in a stored position; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a front elevational view of the powder inhalator of FIG. 1 with the cap removed; FIG. 9 is a perspective view of FIG. 8; FIG. 10 is a front elevational view of FIG. 8; FIG. 11 is a rear elevational view of FIG. 8; FIG. 12 is a right side elevational view of FIG. 8; FIG. 13 is a left side elevational view of FIG. 8; FIG. 14 is a top plan view of FIG. 8; FIG. 15 is a bottom plan view of FIG. 8; and, FIG. 16 is a front elevational view thereof shown in compressed condition.

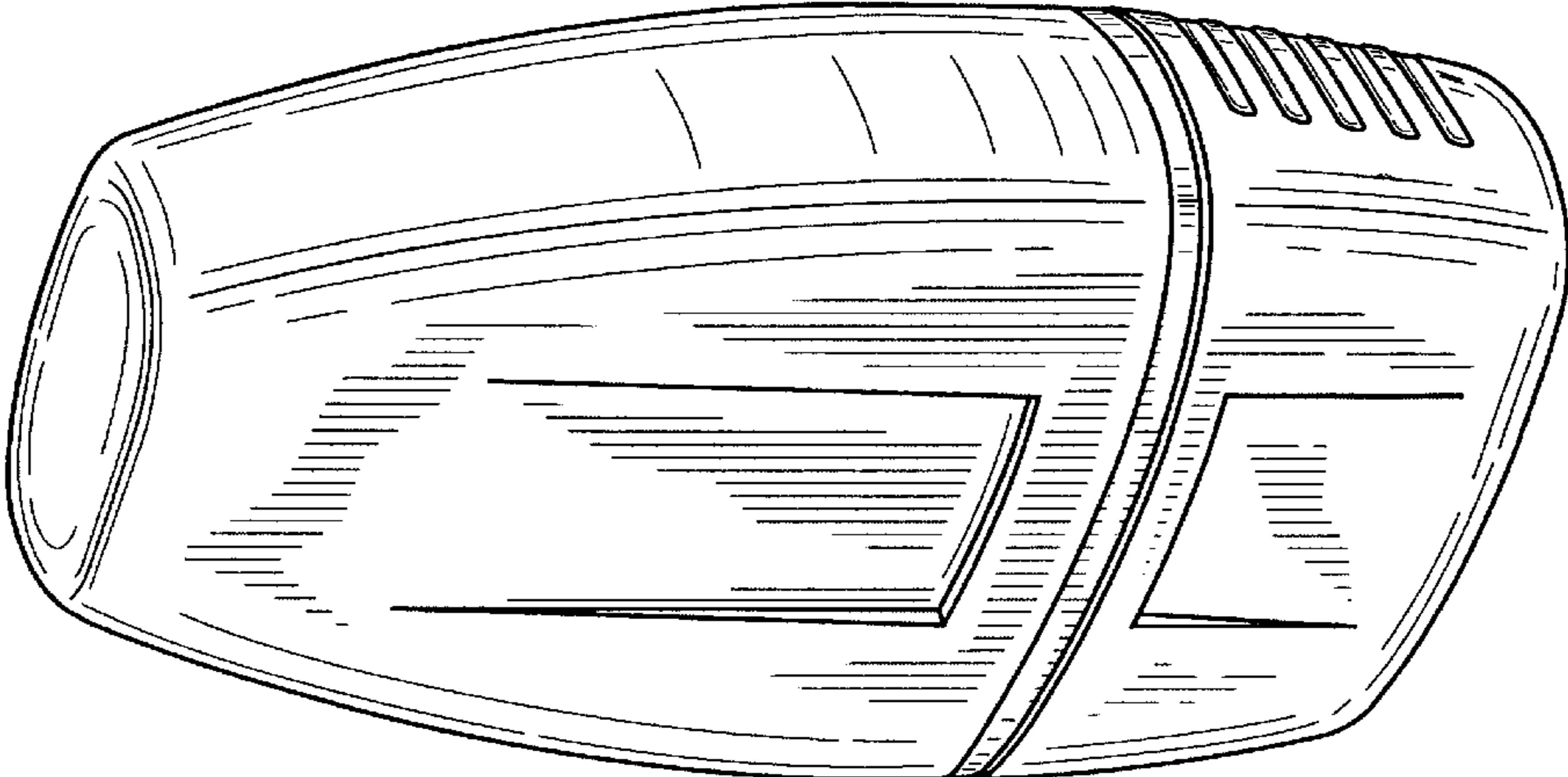

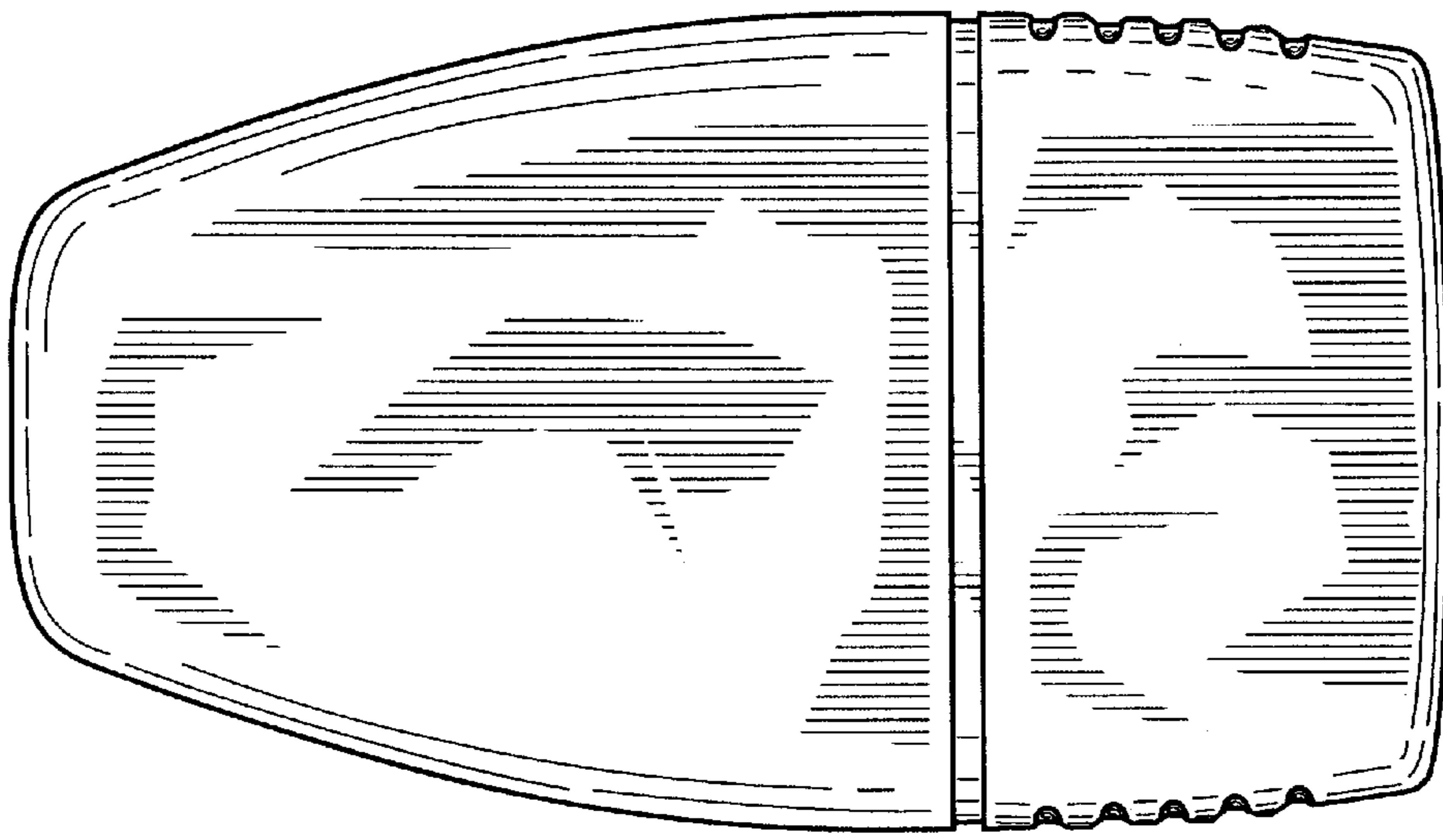

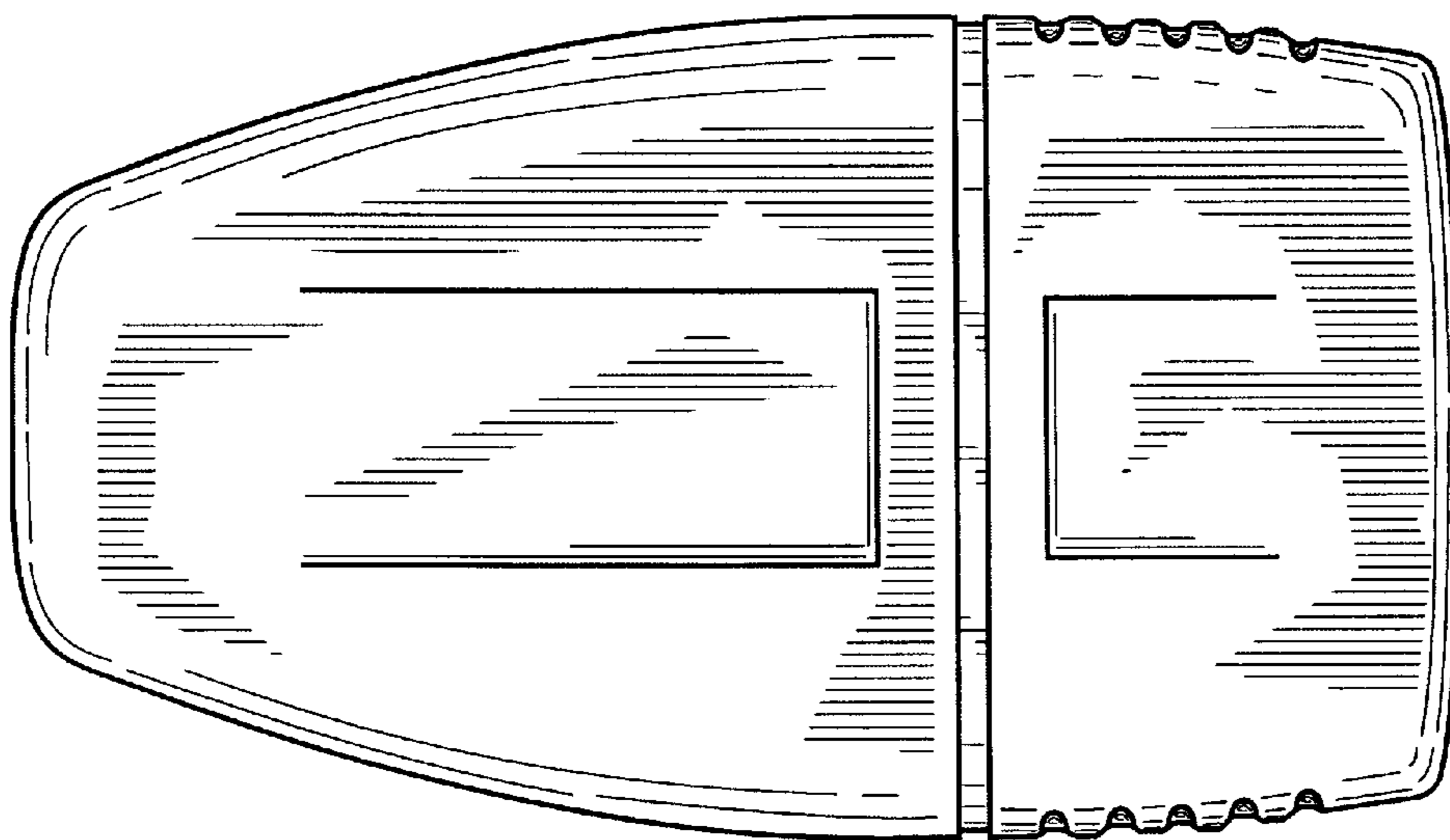

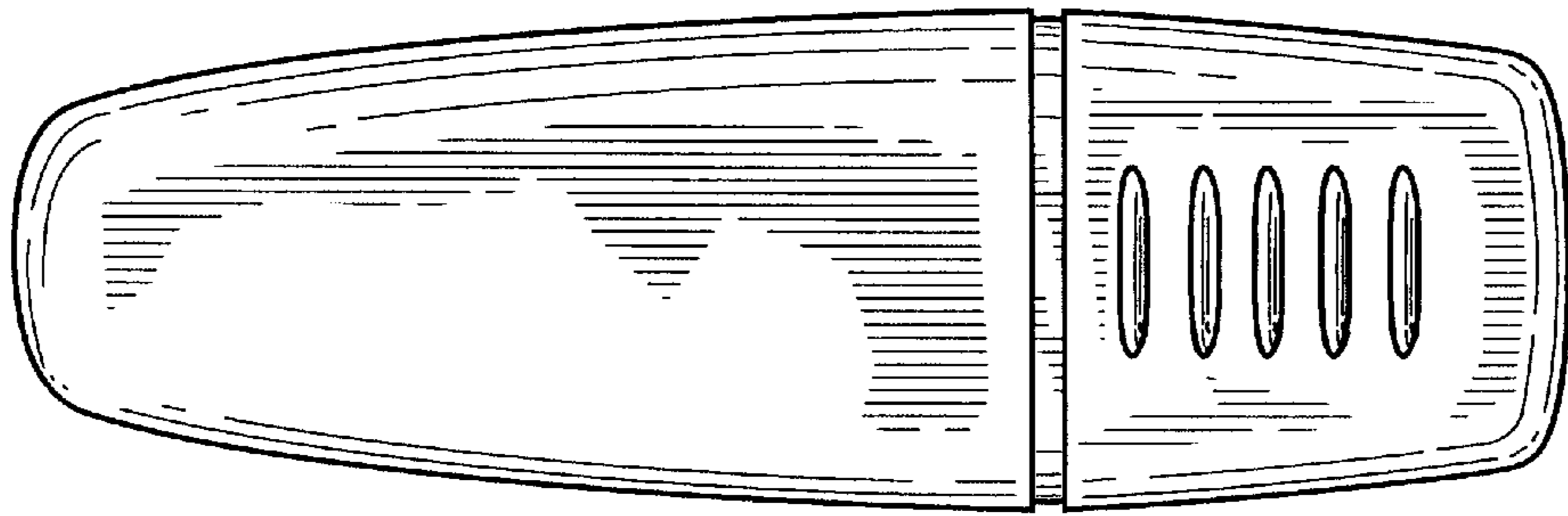

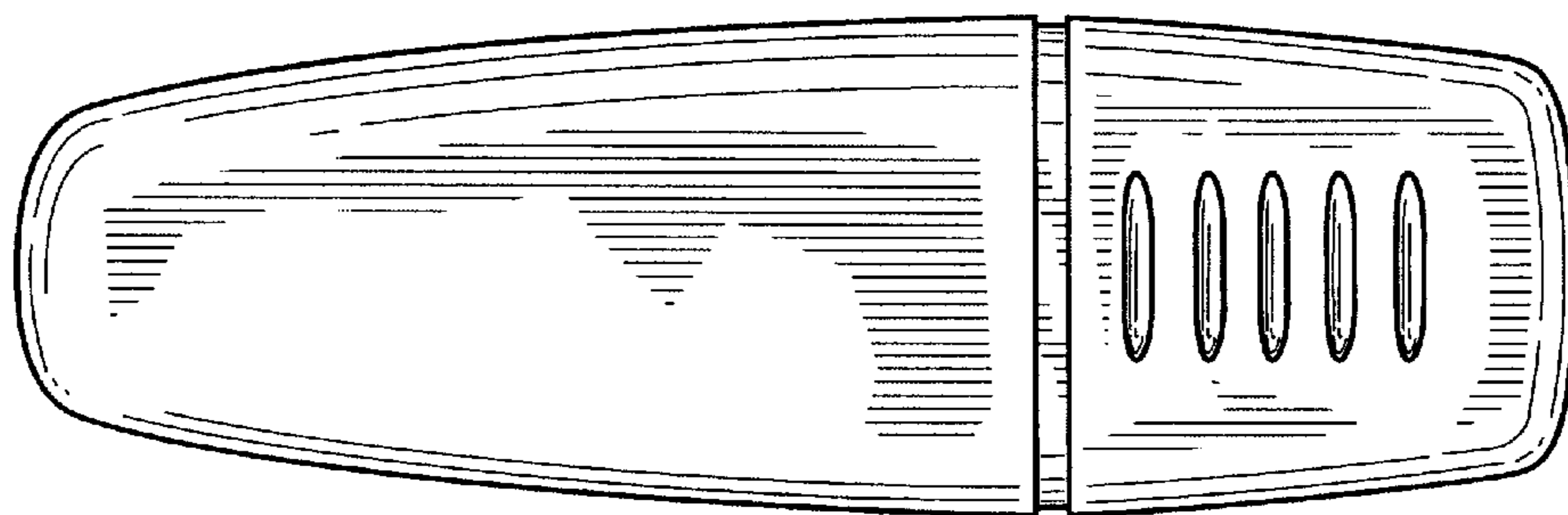

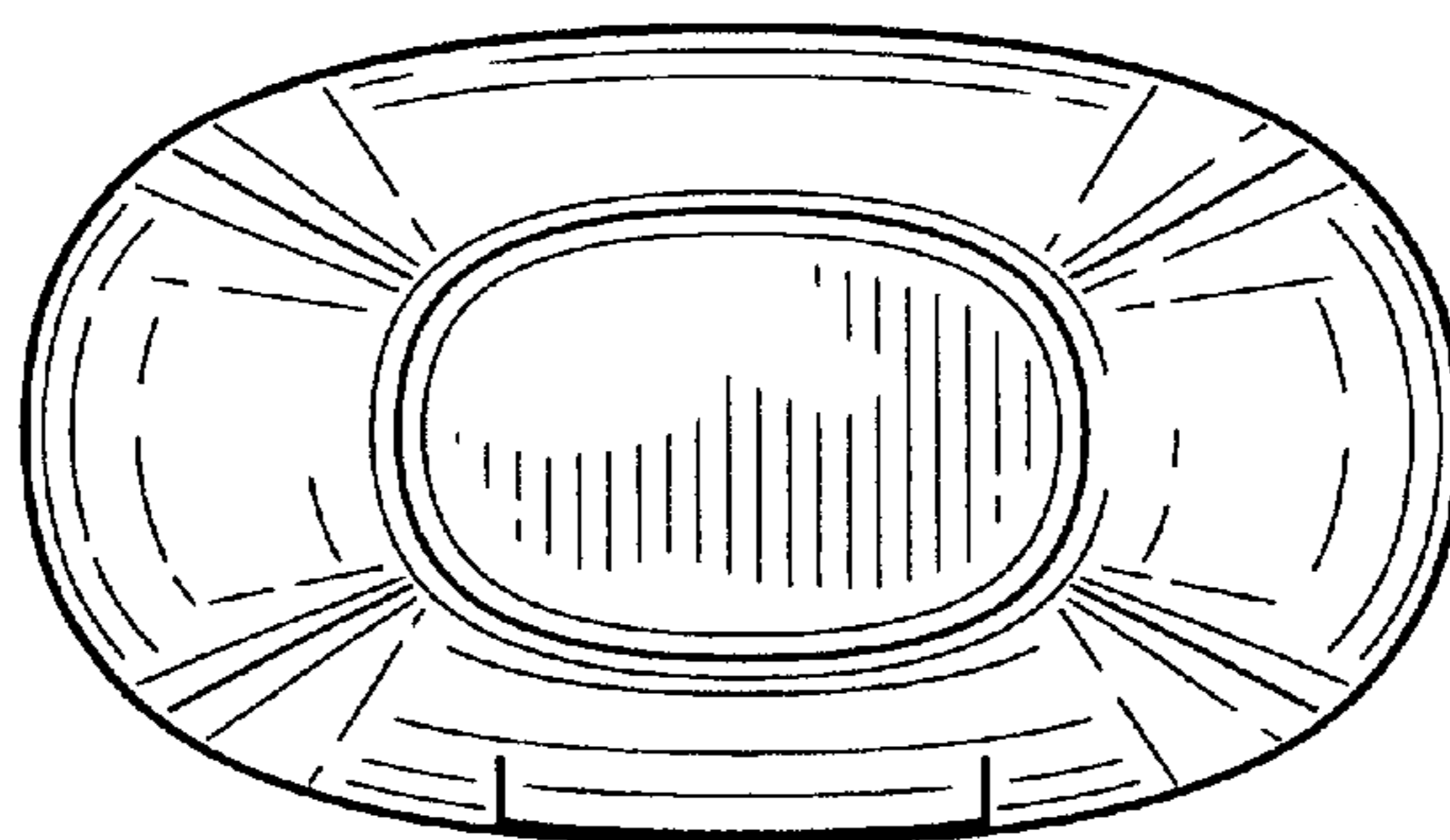

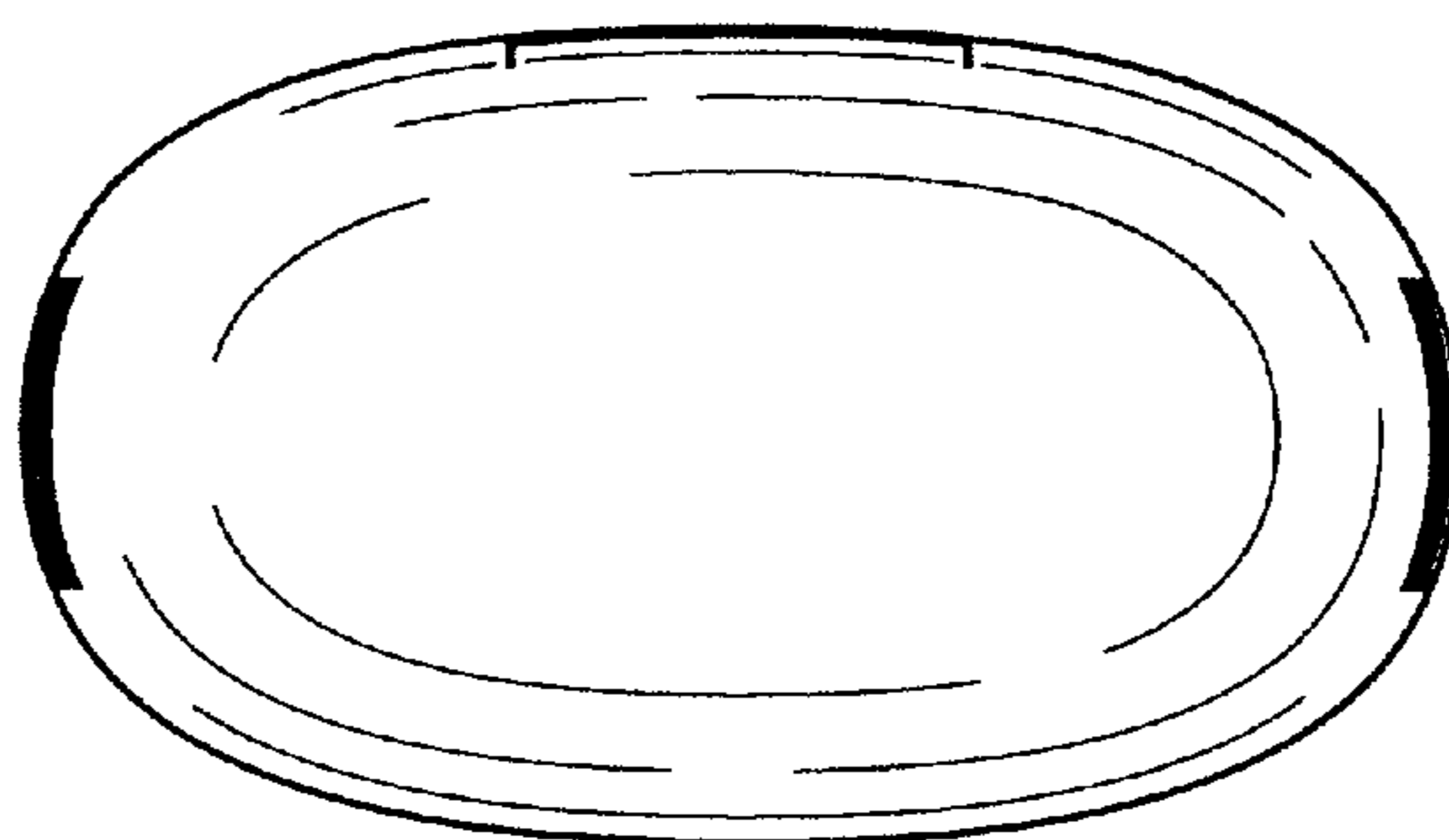

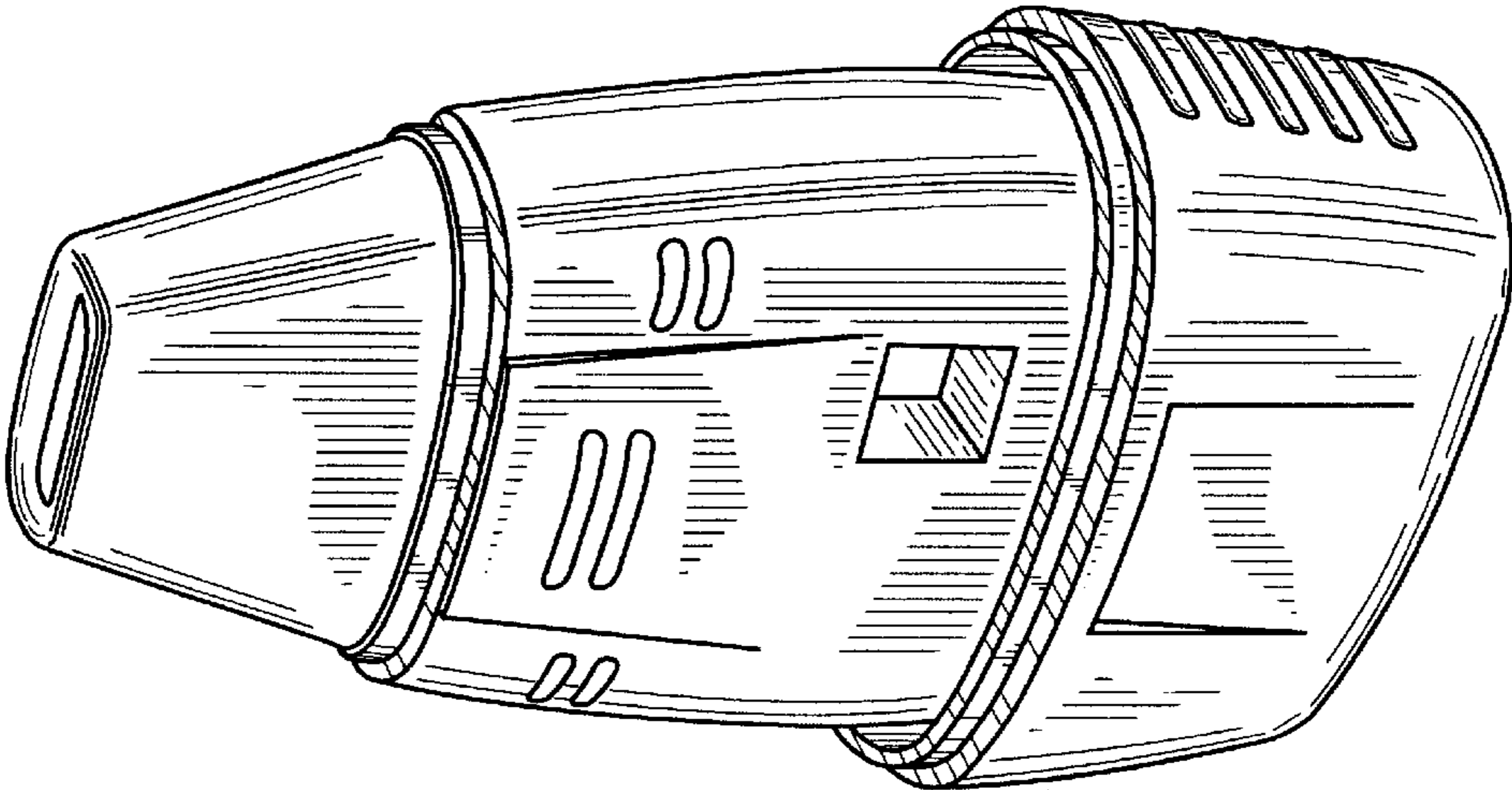

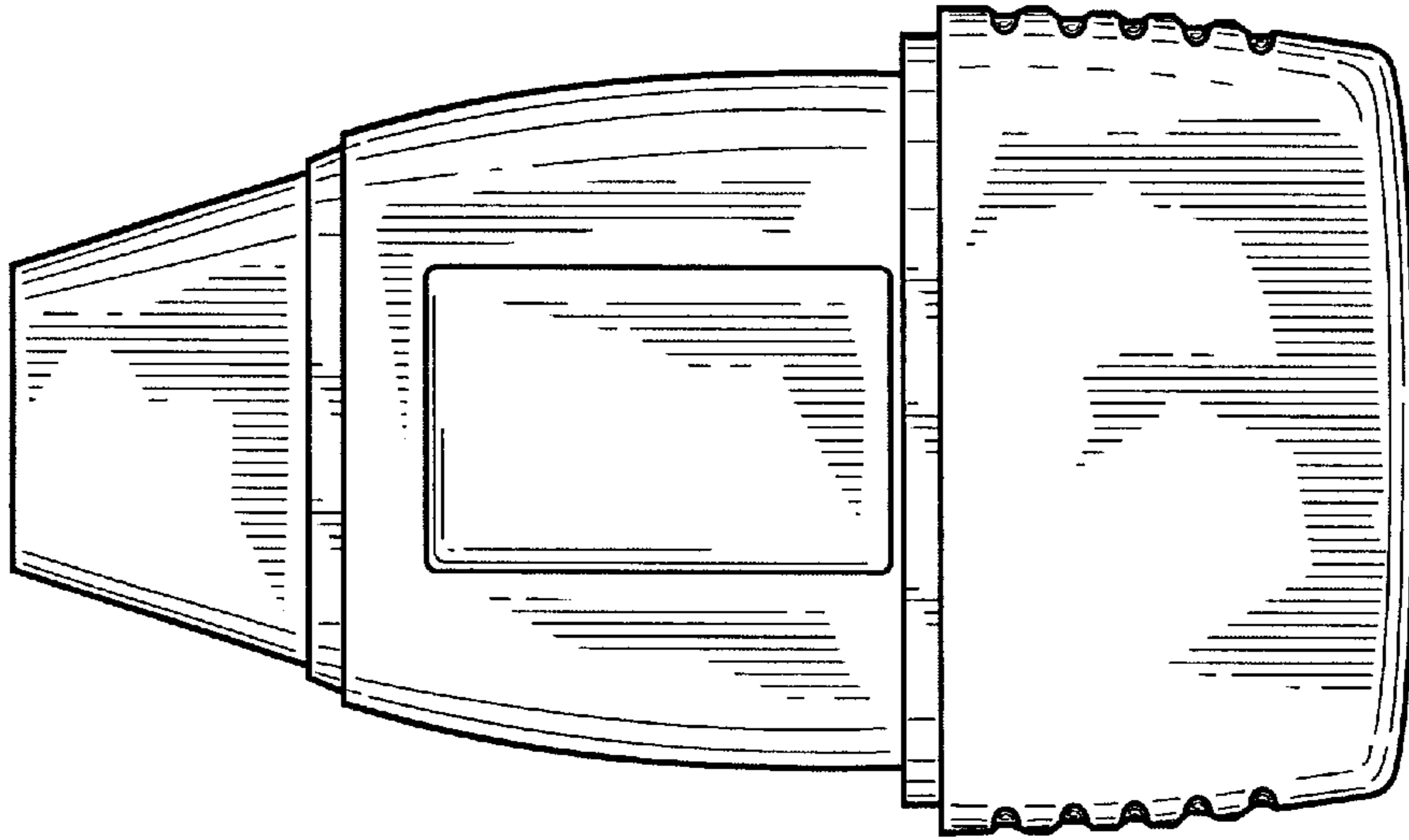

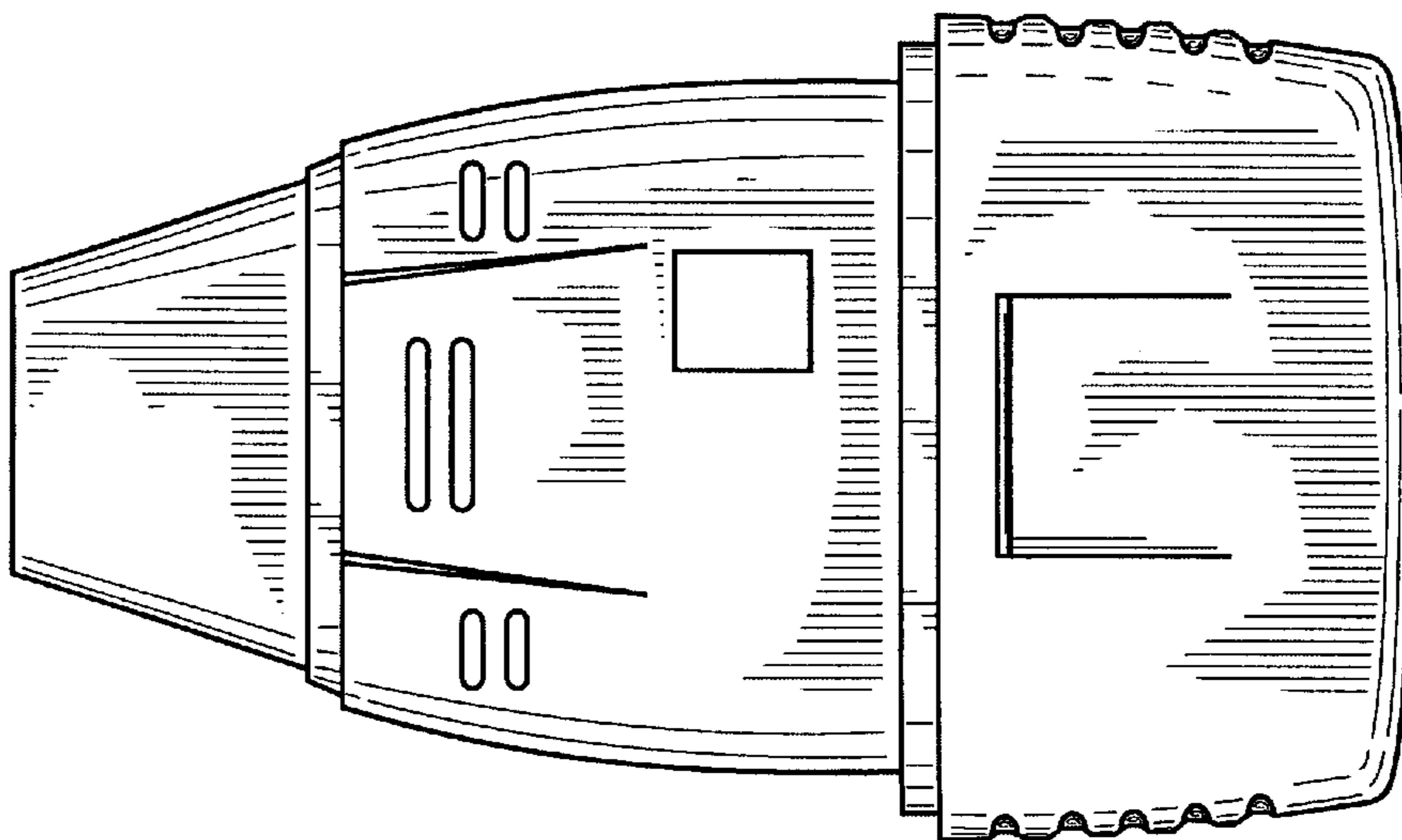

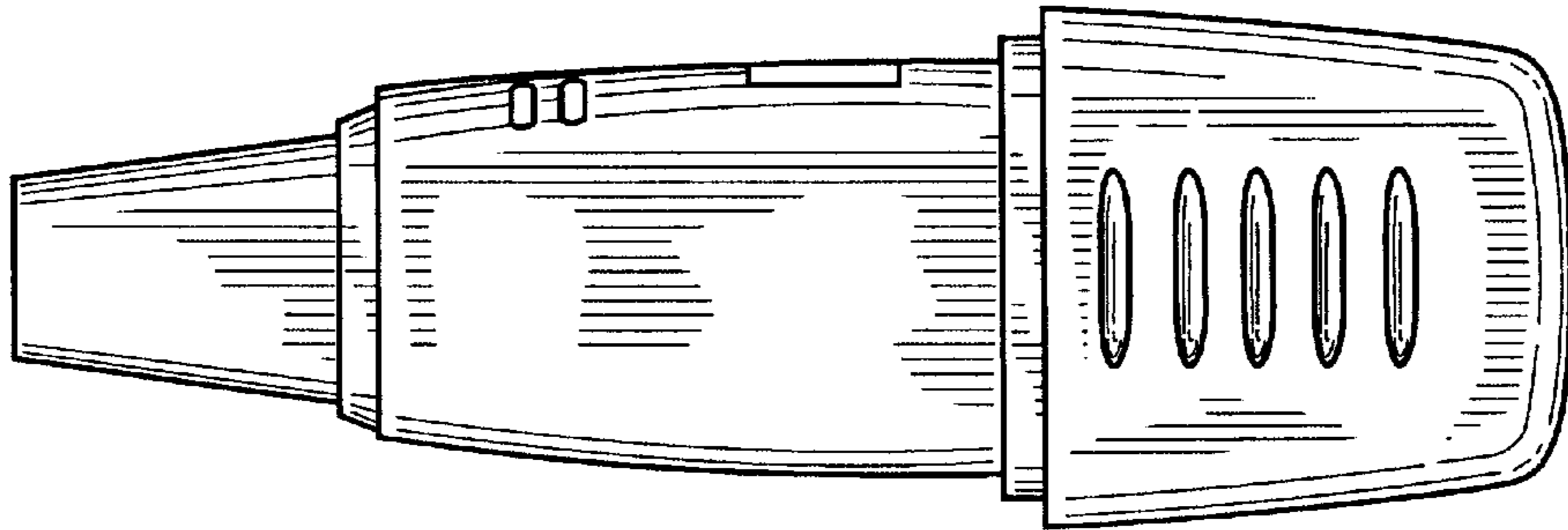

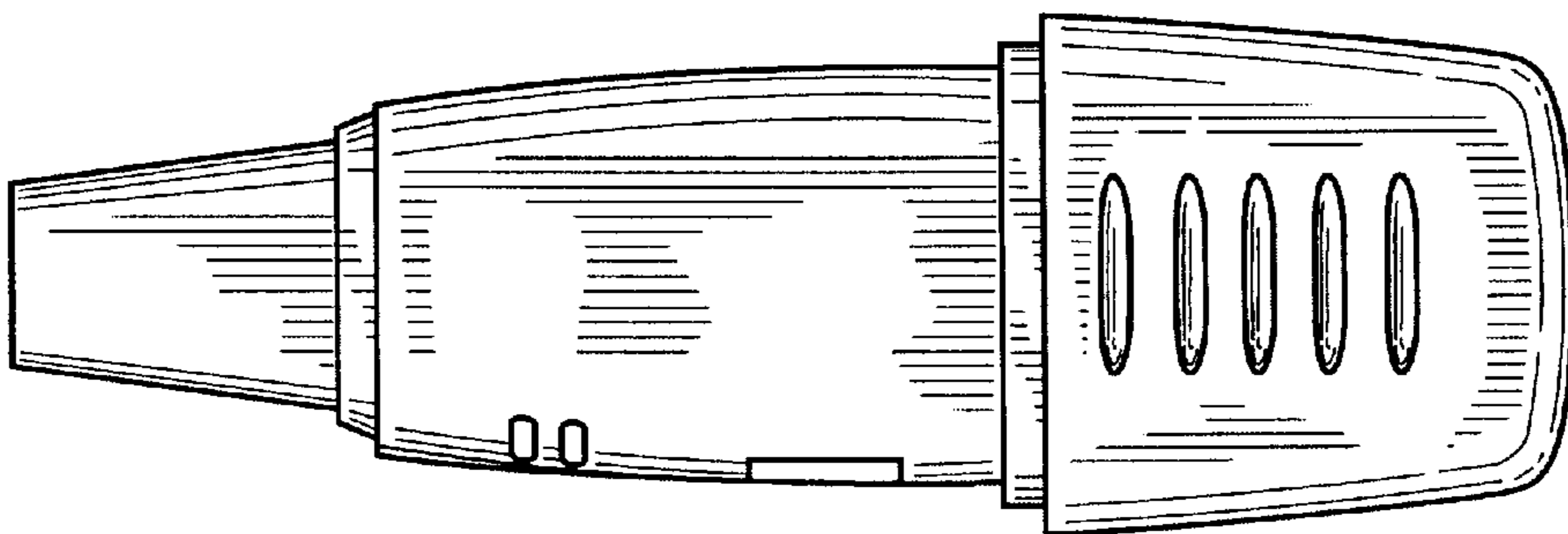

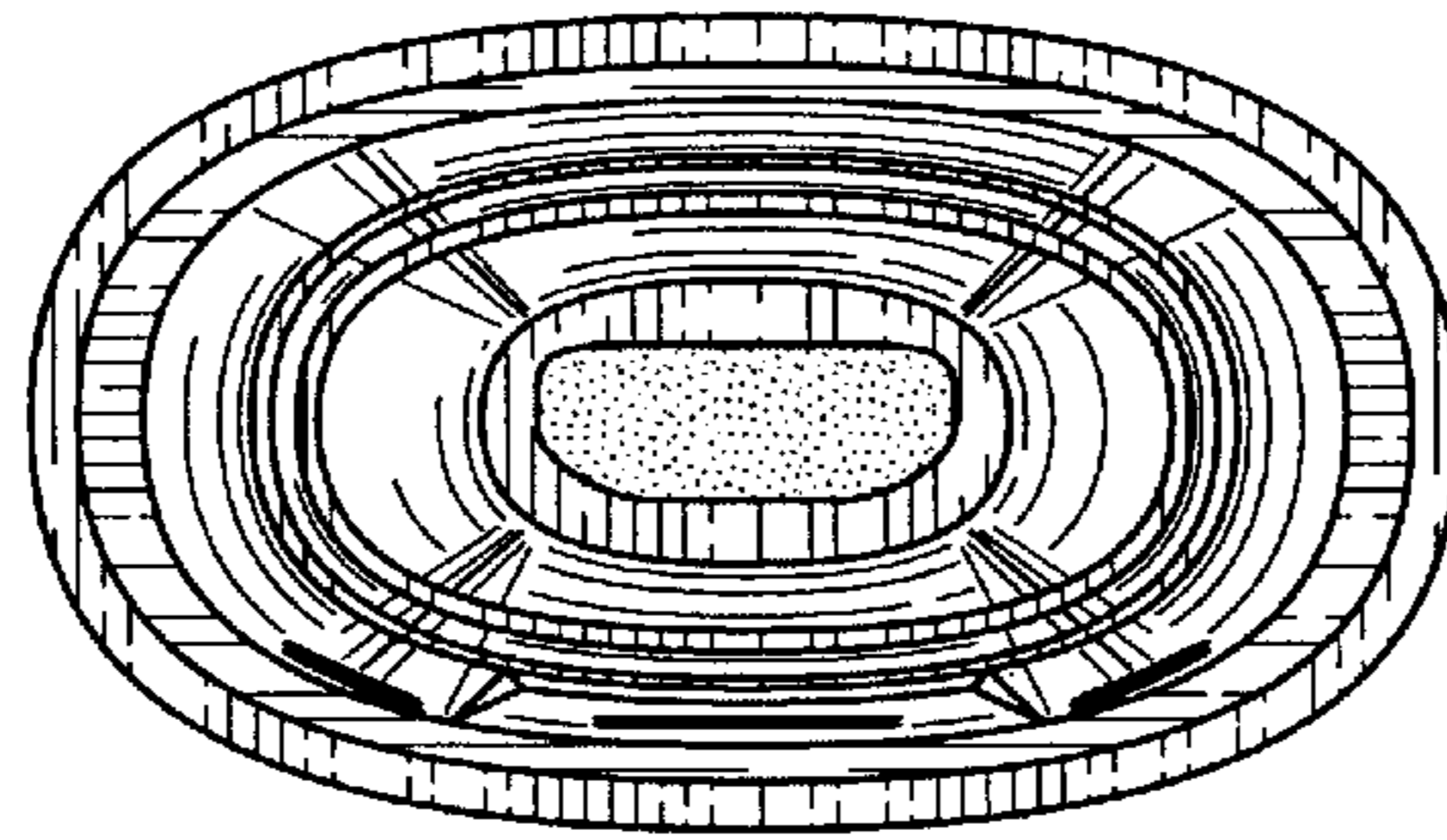

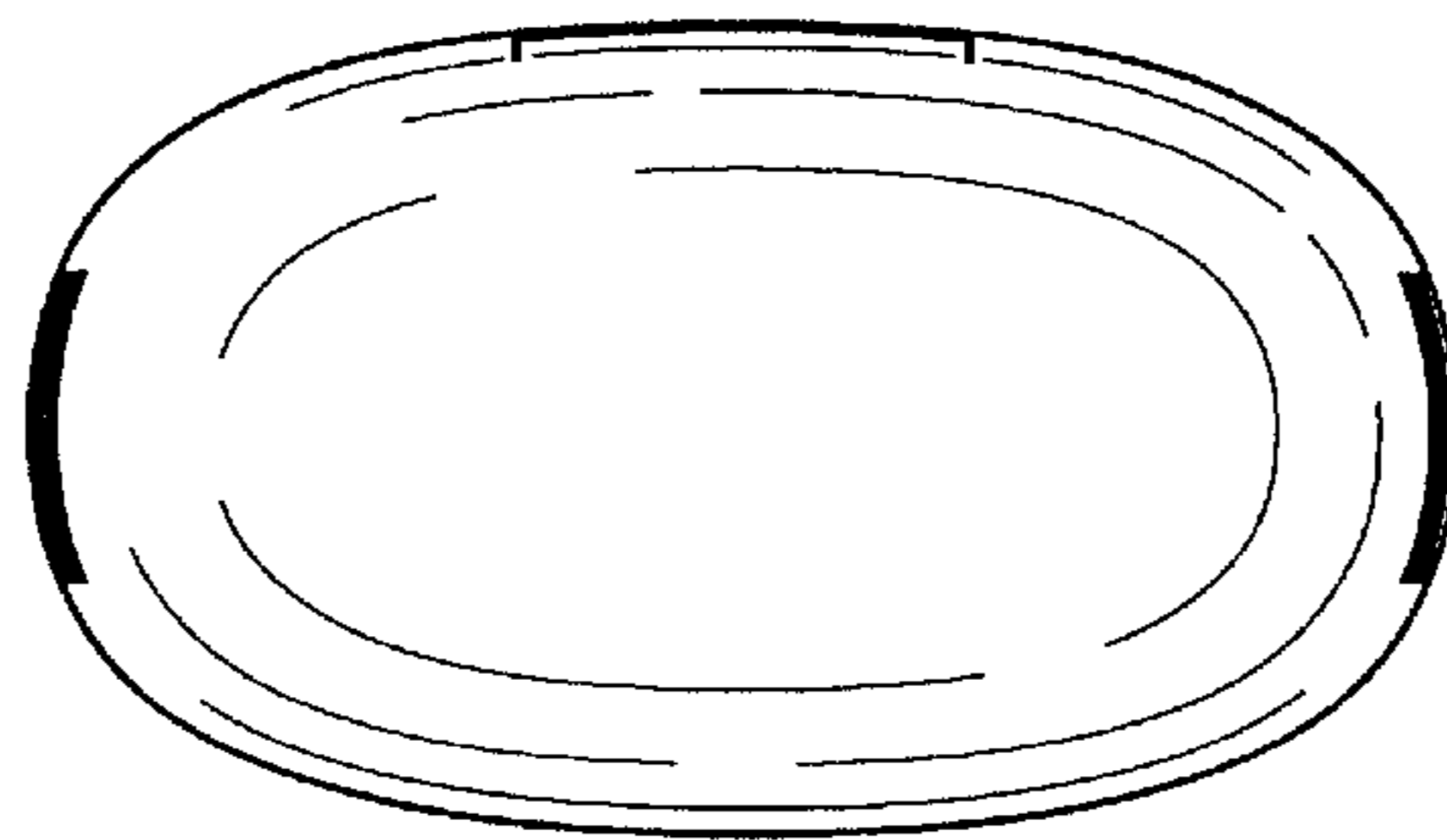

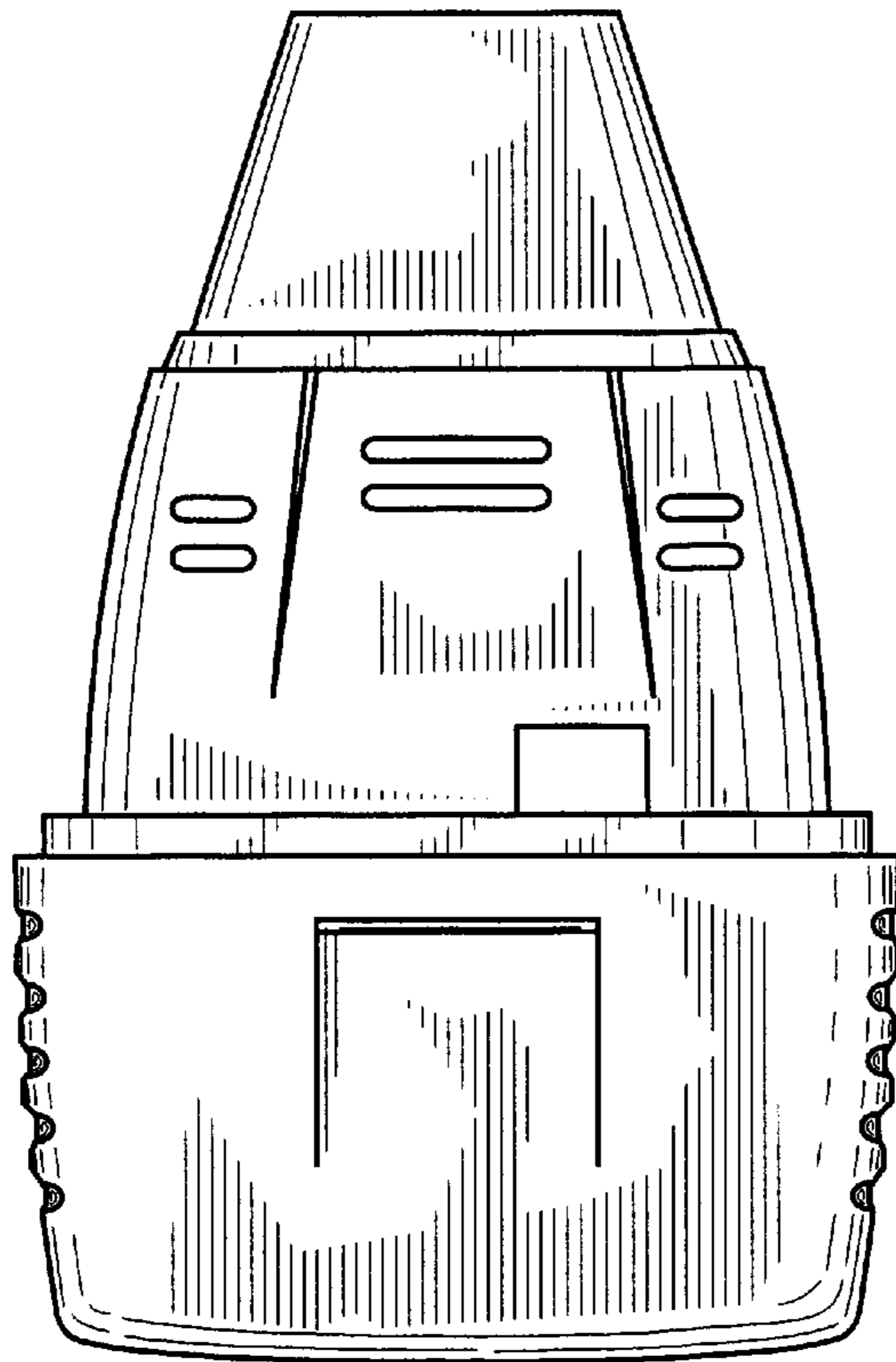
