FIG. 3 is a top plan view of the hair dryer of FIG. 1;

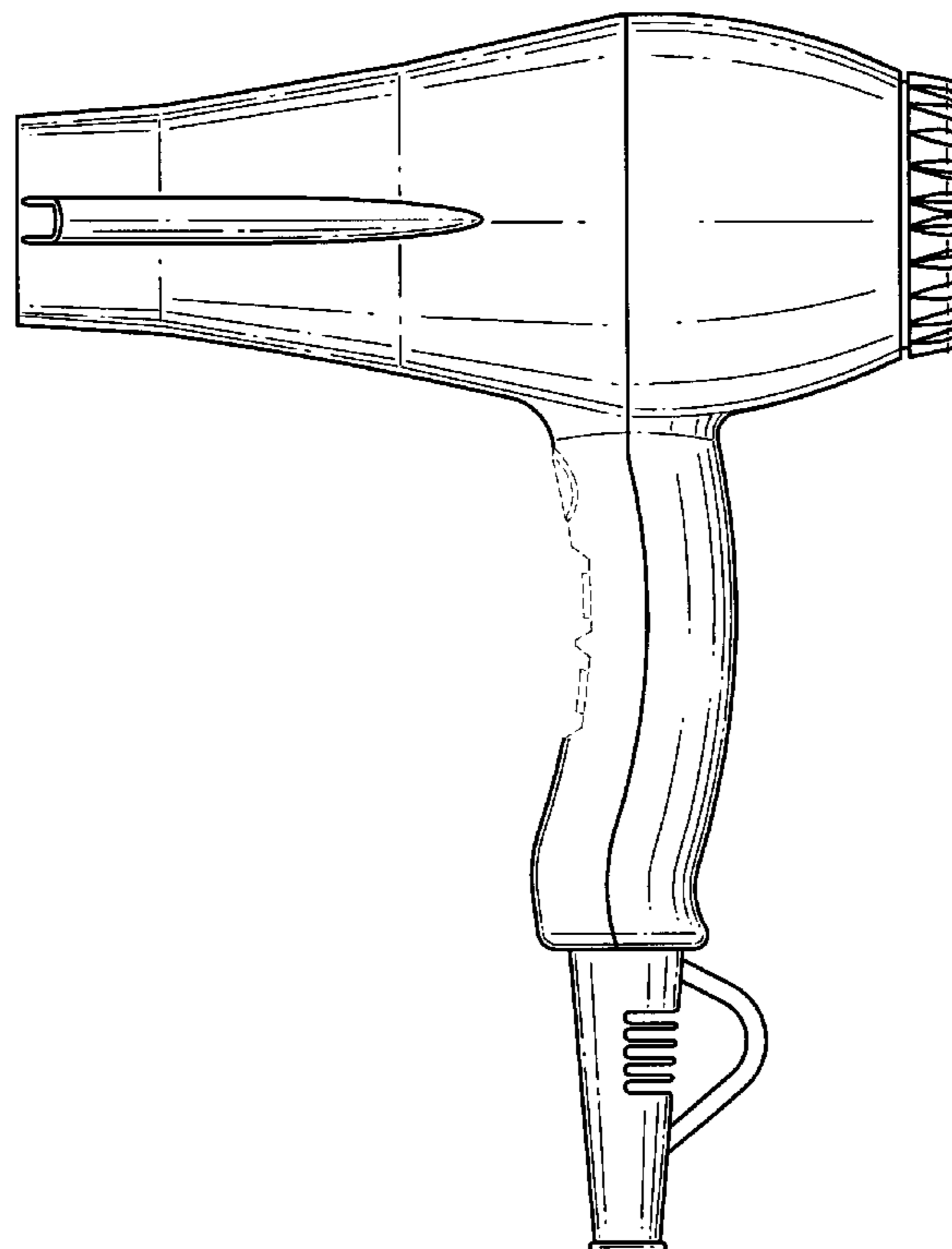
FIG. 4 is a right side elevation of the hair dryer of FIG. 1;

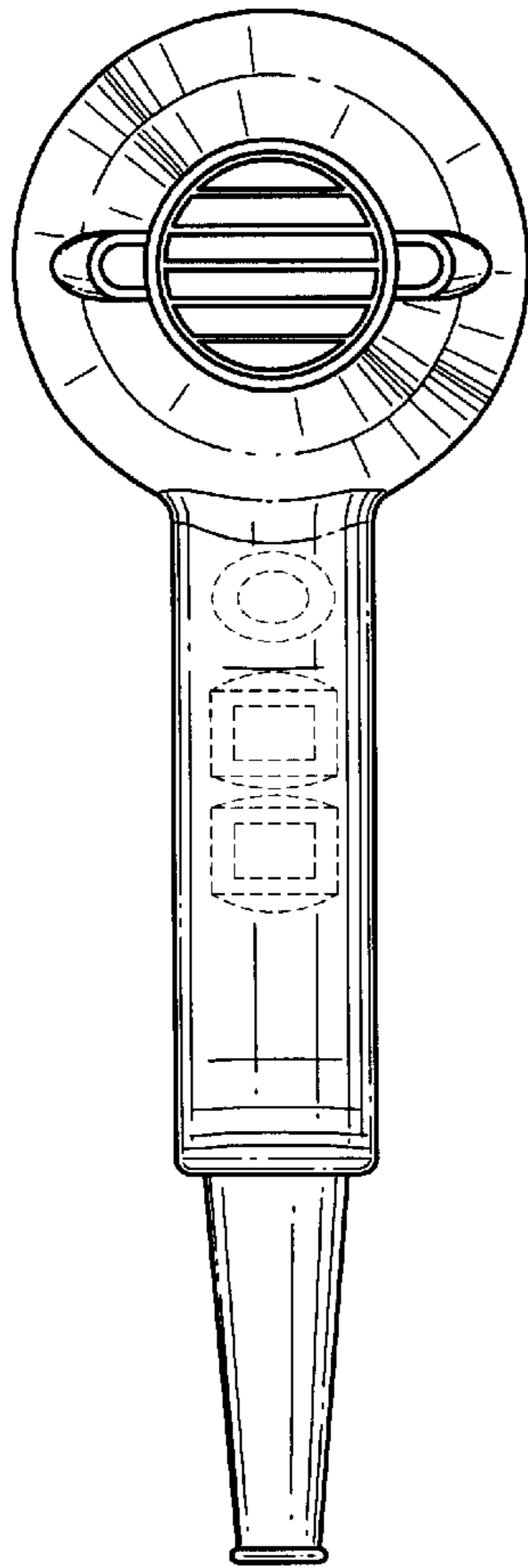
FIG. 5 is a bottom plan view of the hair dryer of FIG. 1; and,

FIG. 6 is a perspective view of the hair dryer of FIG. 1.

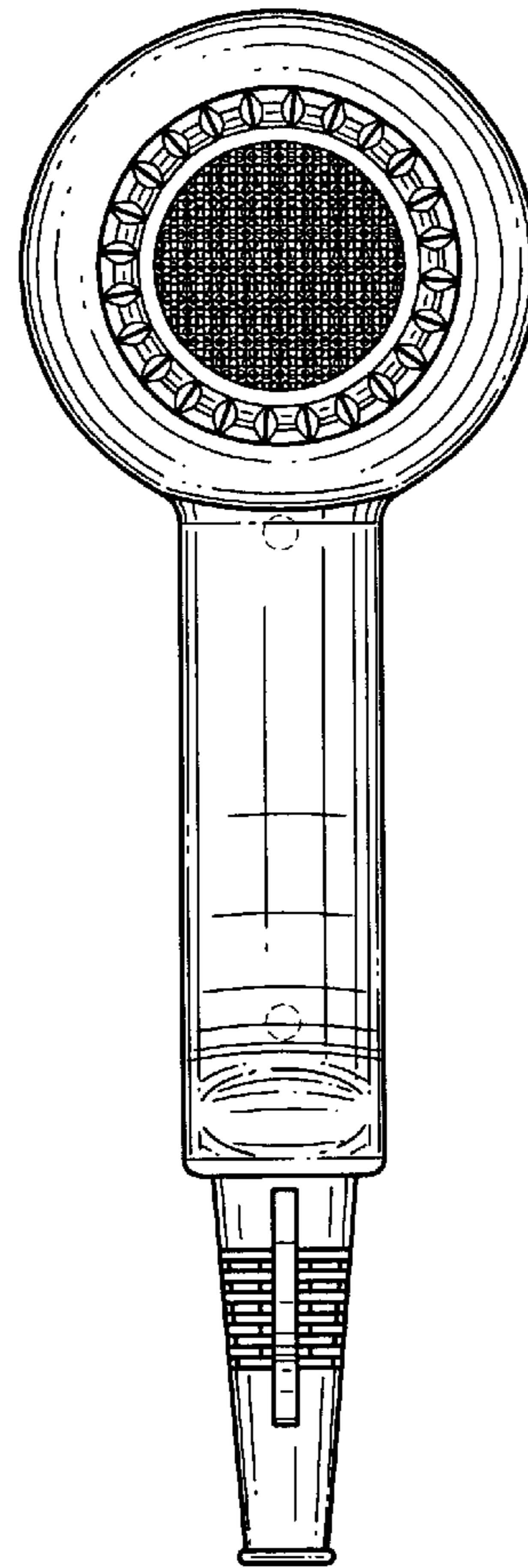

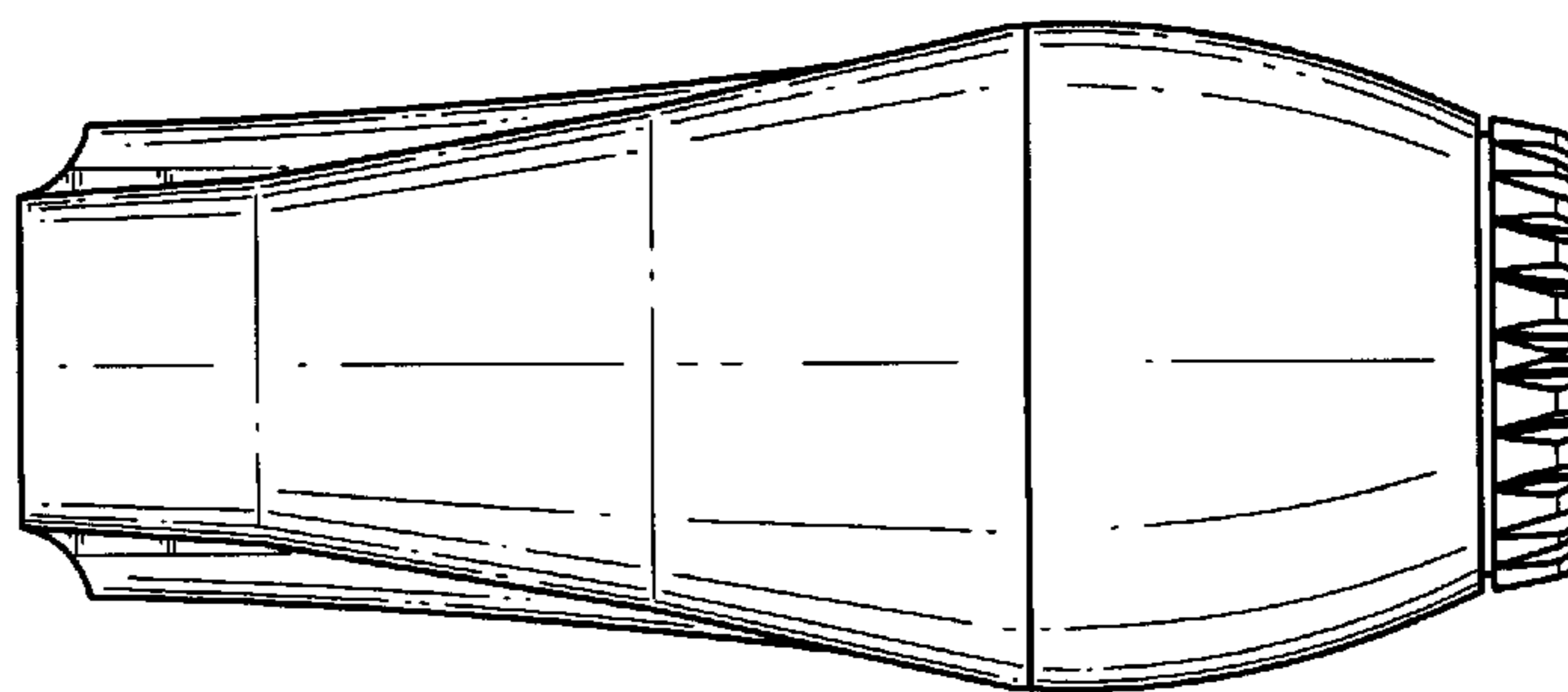




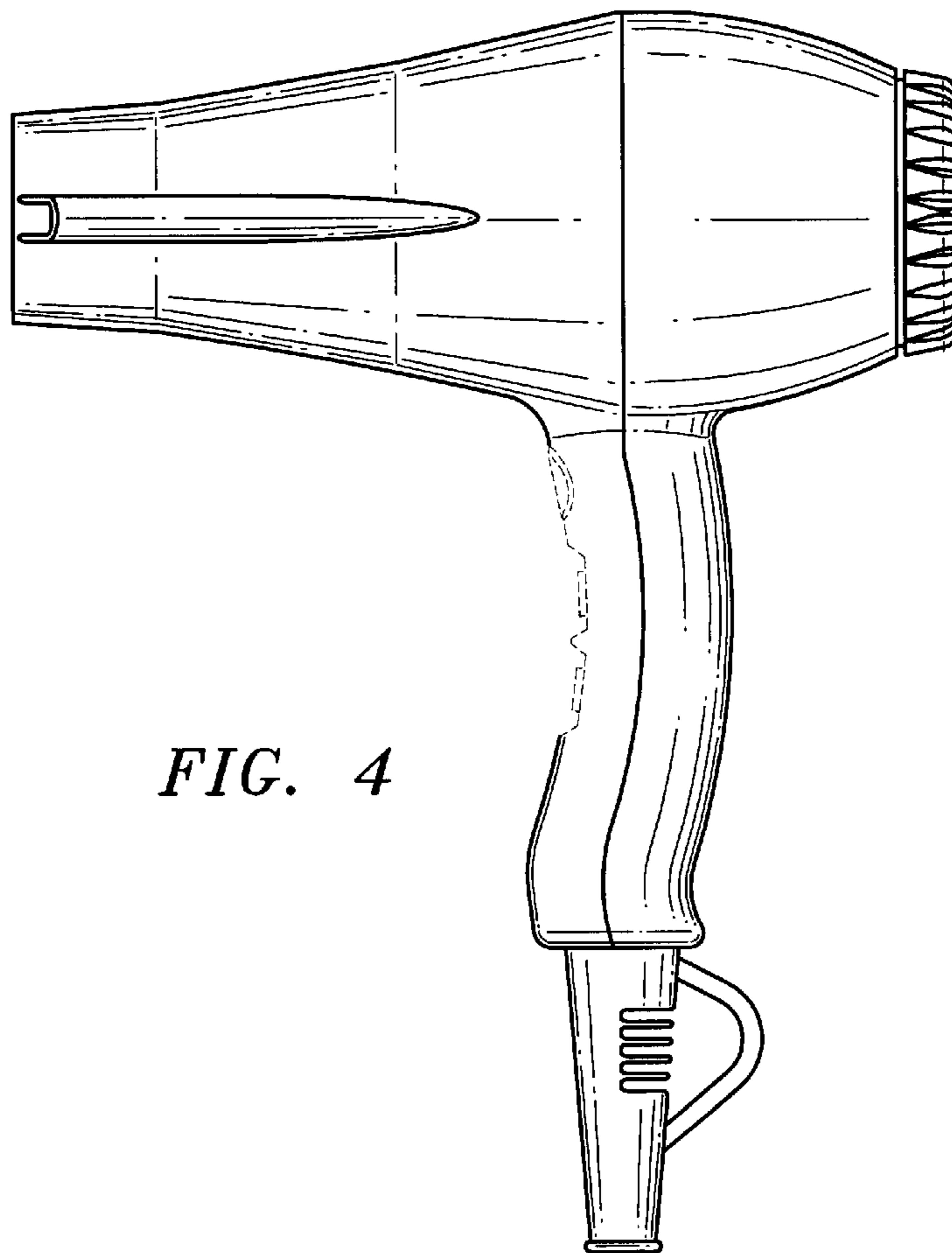

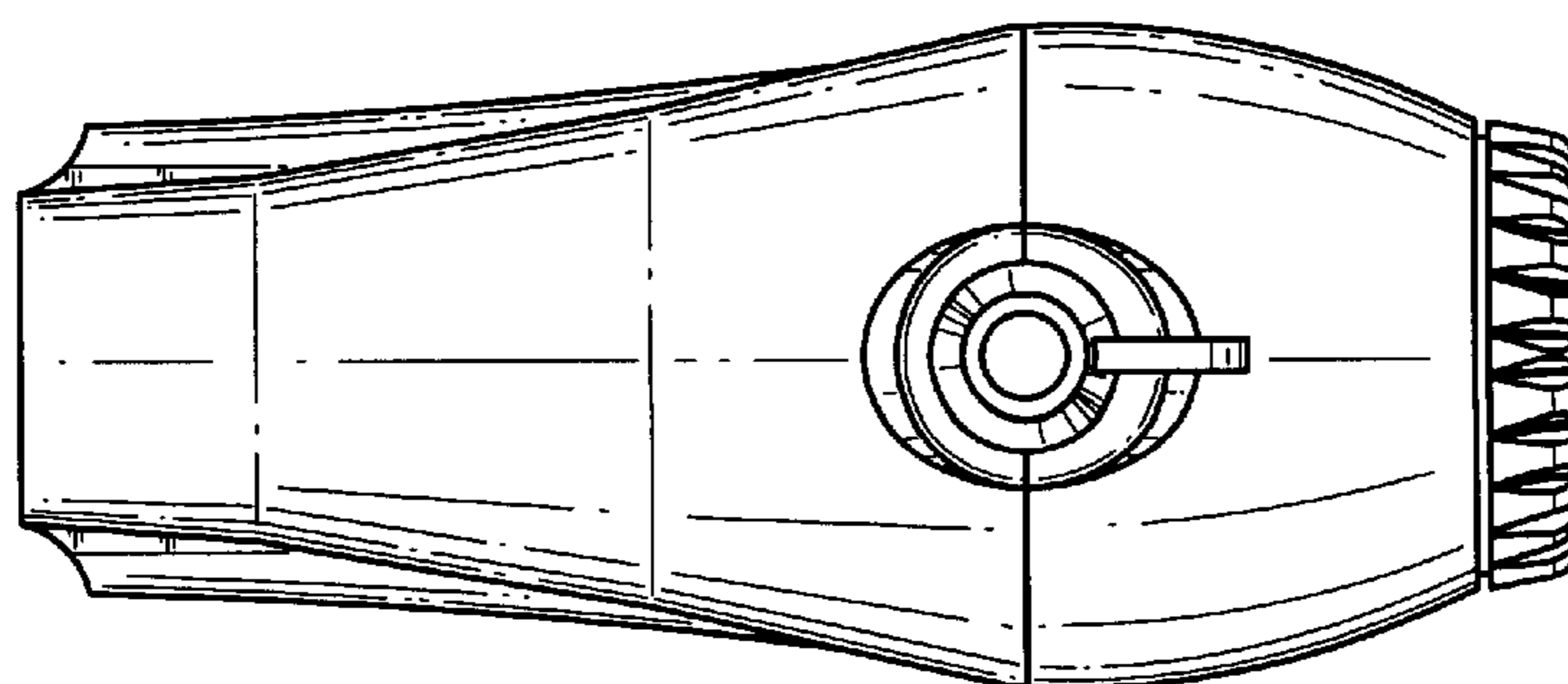

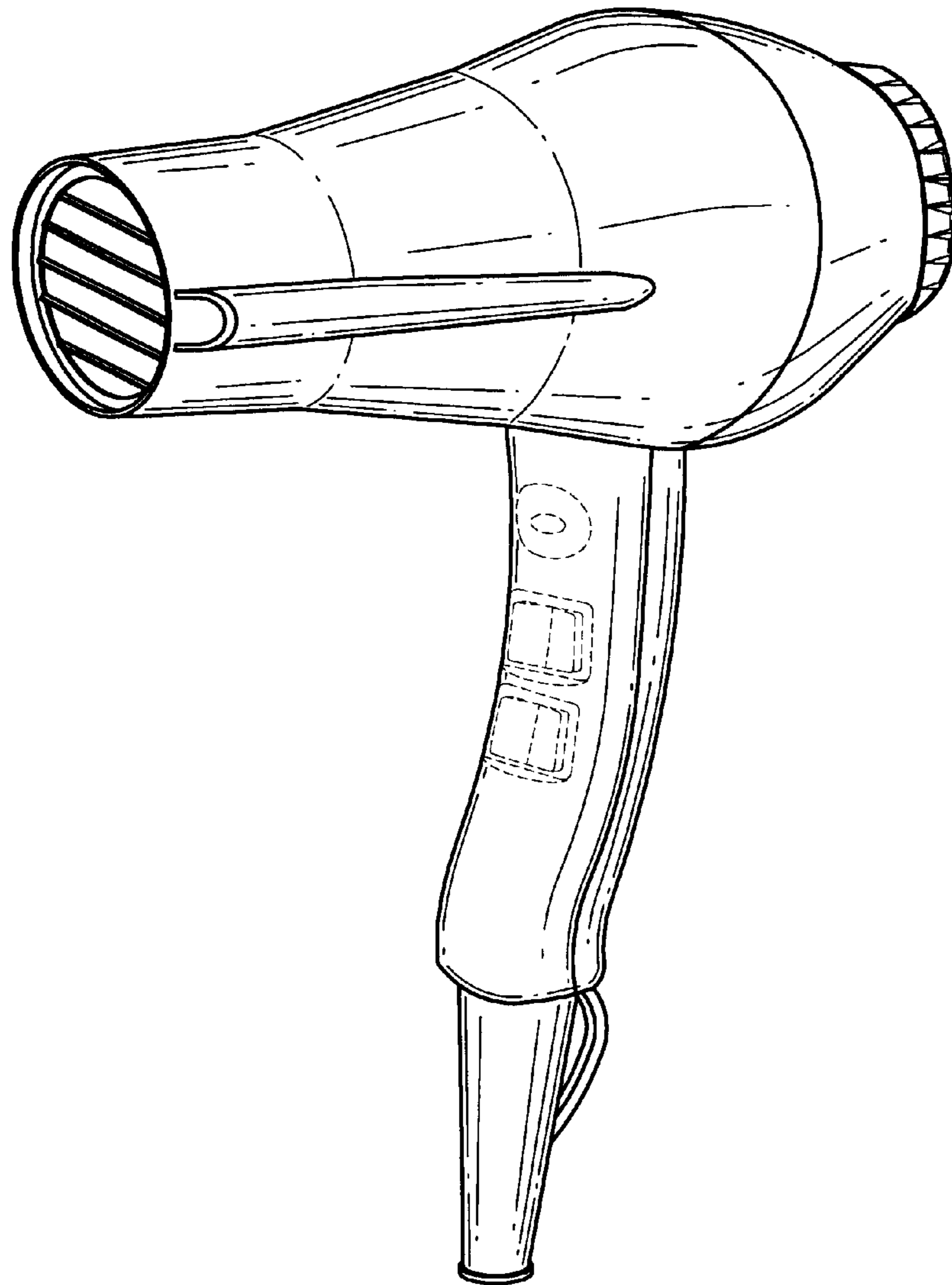
