(57) **CLAIM**

The ornamental design for a multi-purpose glove, as shown
and described.

DESCRIPTION

FIG. 1 is a front view of the multi-purpose glove according
to the claimed design, with broken lines forming a boundary
around a first printable area containing indicia, wherein the
first printable area and indicia inside the broken lines form
no part of the claimed design;

FIG. 2 is a rear view of the multi-purpose glove shown in
FIG. 1, with broken lines forming a boundary around a
second printable area containing indicia, wherein the second
printable area and indicia inside the broken lines form no
part of the claimed design;

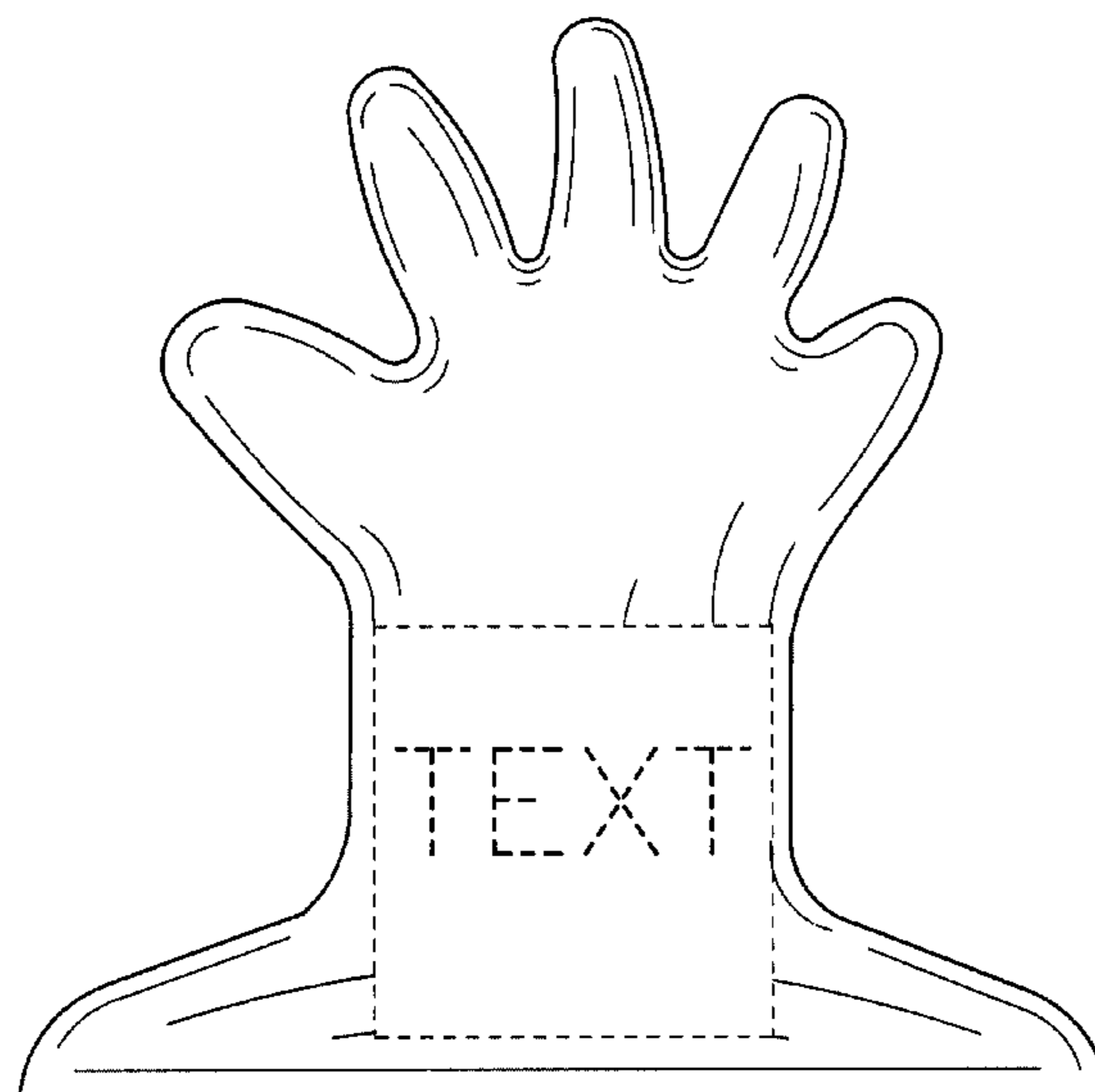
FIG. 3 is a bottom view of the multi-purpose glove shown
in FIG. 1;

FIG. 4 is a top view of the multi-purpose glove shown in
FIG. 1;

FIG. 5 is a right side elevational view of the multi-purpose
glove shown in FIG. 1; and,

FIG. 6 is a left side elevational view of the multi-purpose
glove shown in FIG. 1.

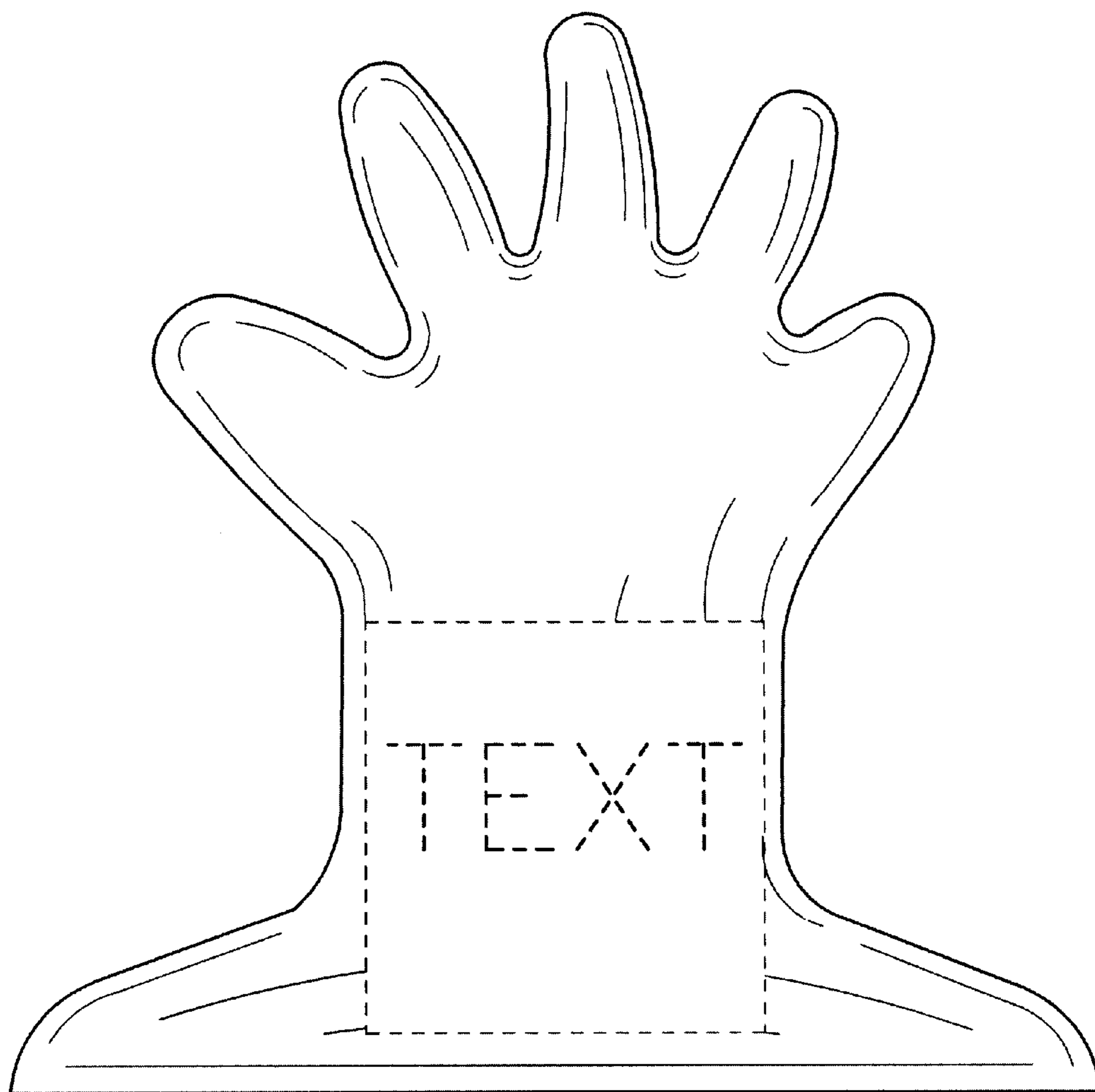

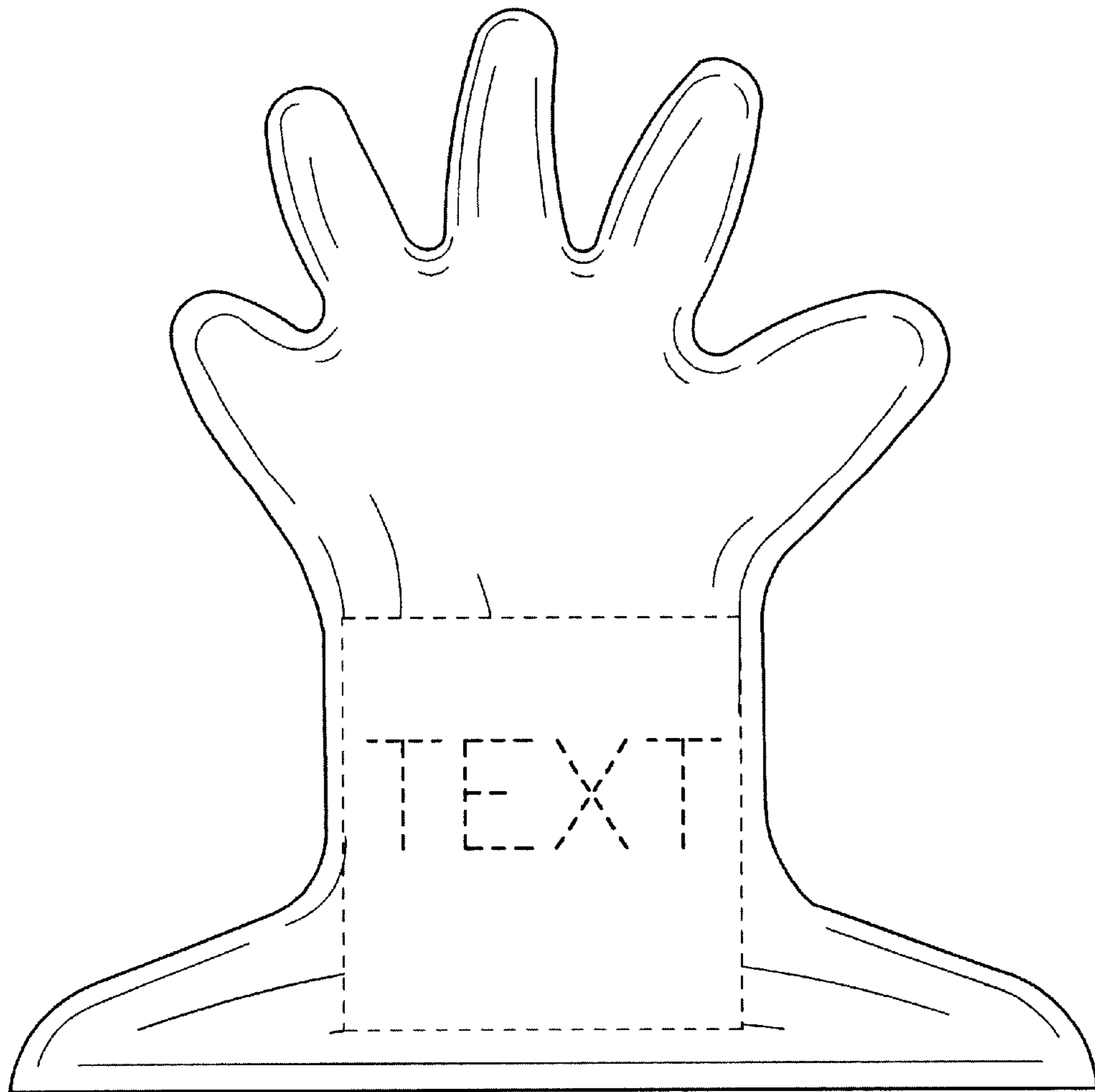

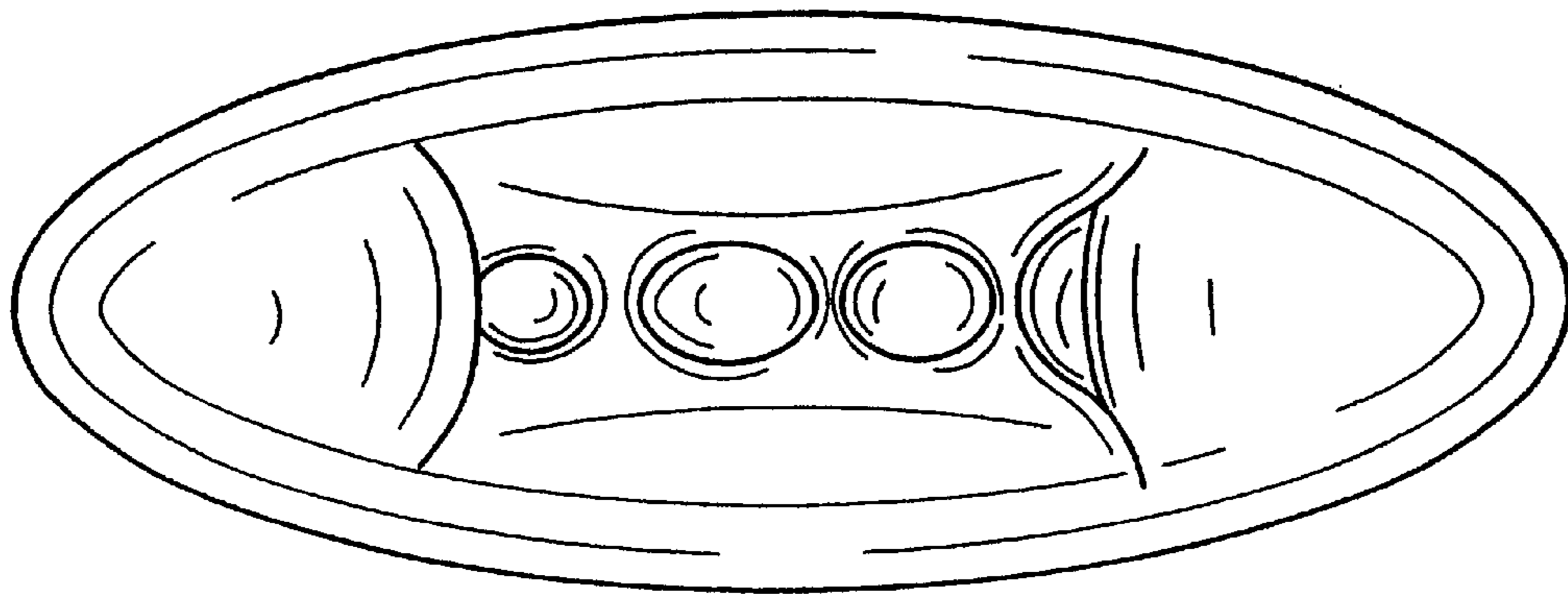

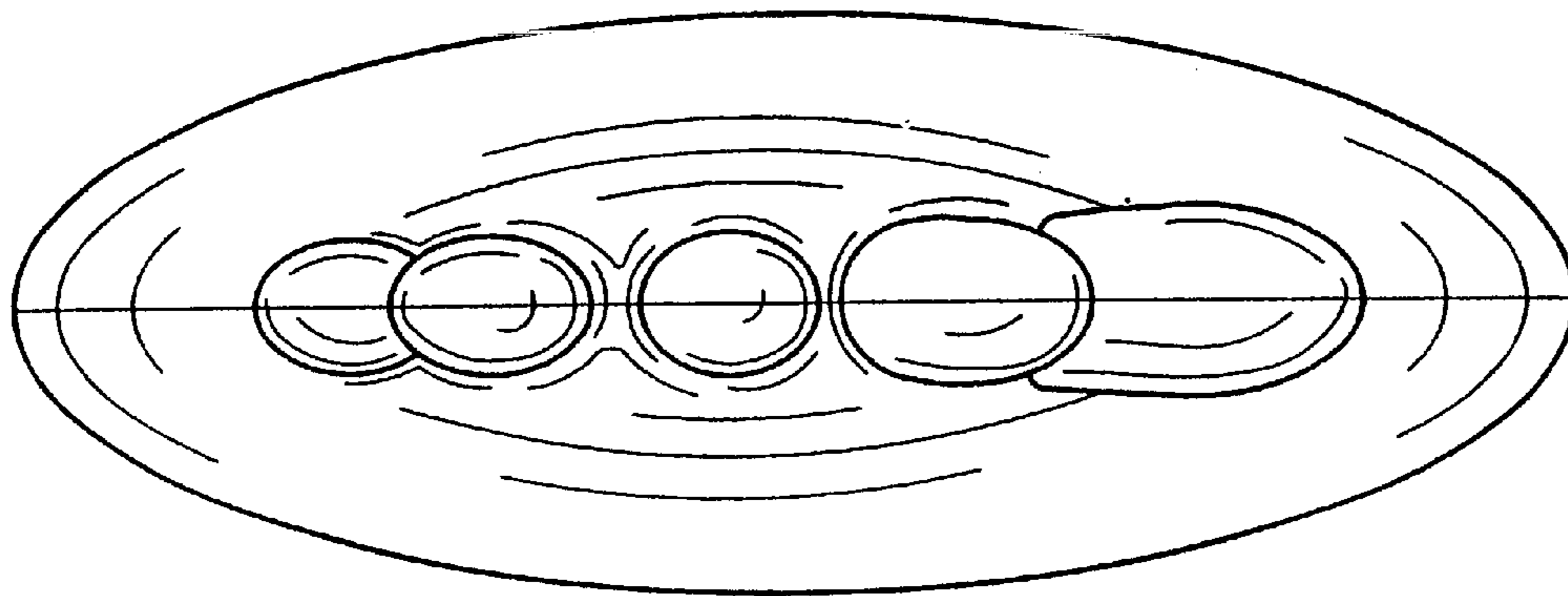

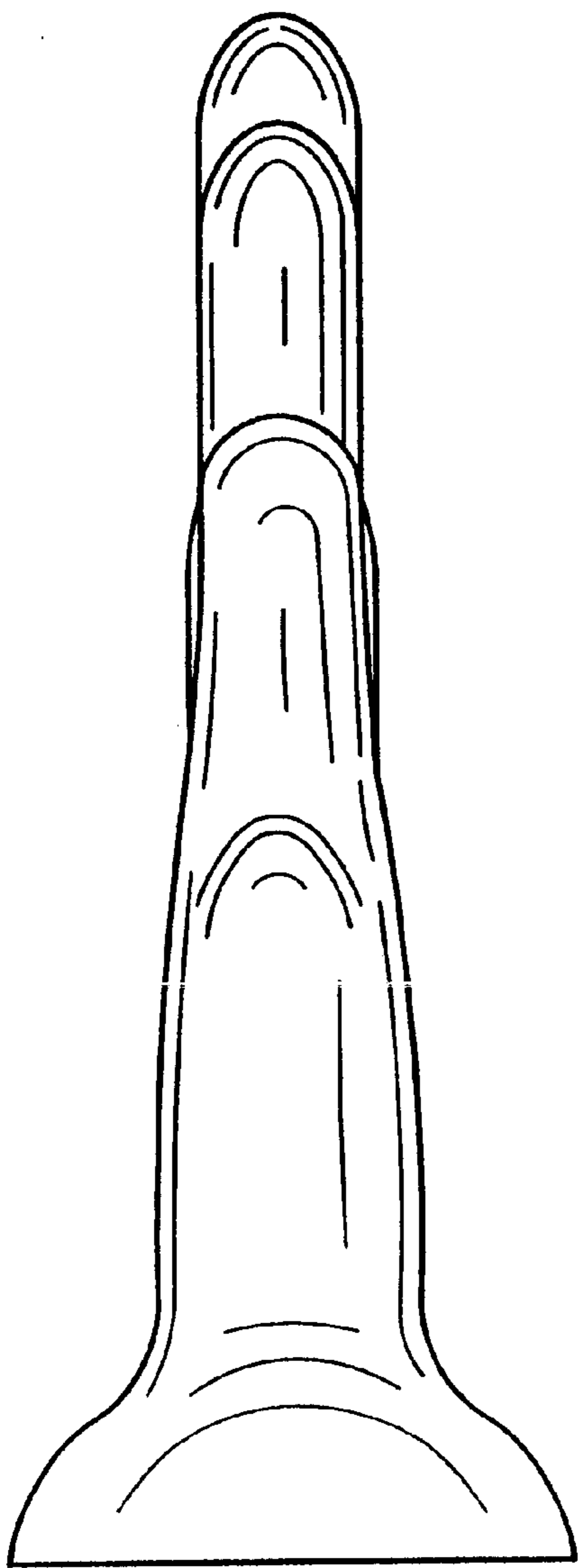

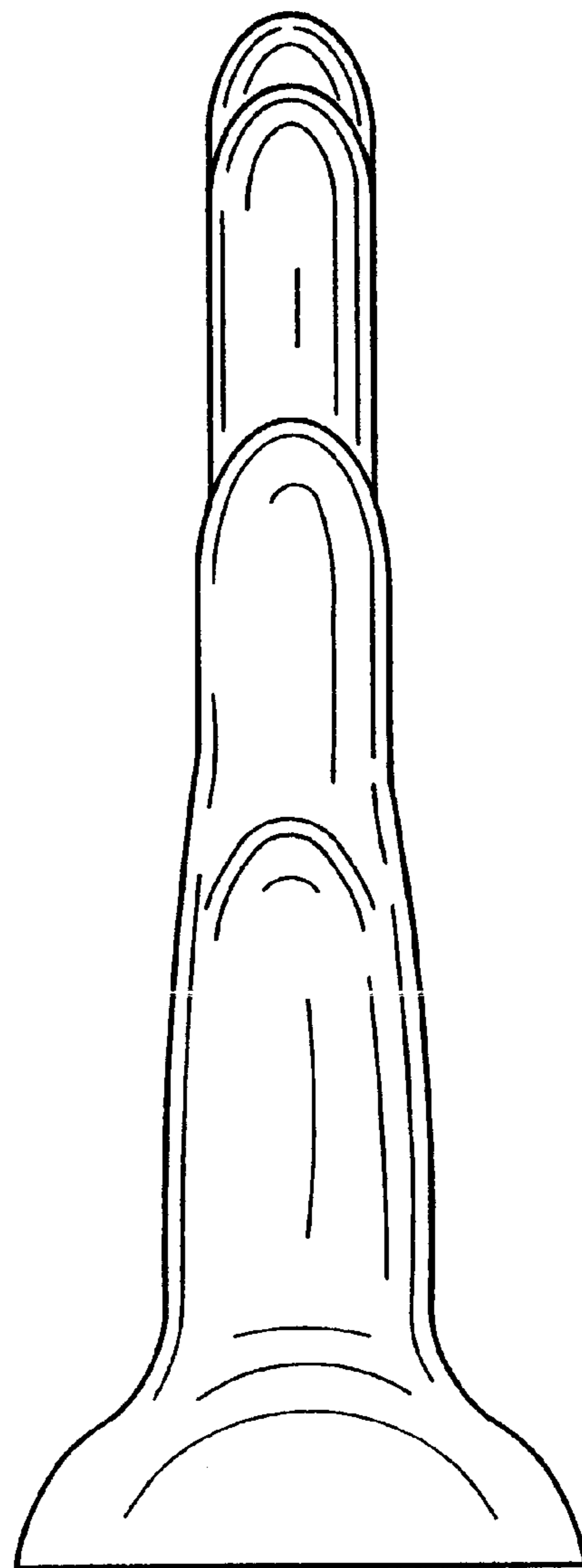
