**DESCRIPTION**

FIG. 1 is a perspective view of the frog support of the subject invention.

FIG. 2 is a front plan view of the frog support of the subject invention.

FIG. 3 is a rear plan view of the frog support of FIG. 1.

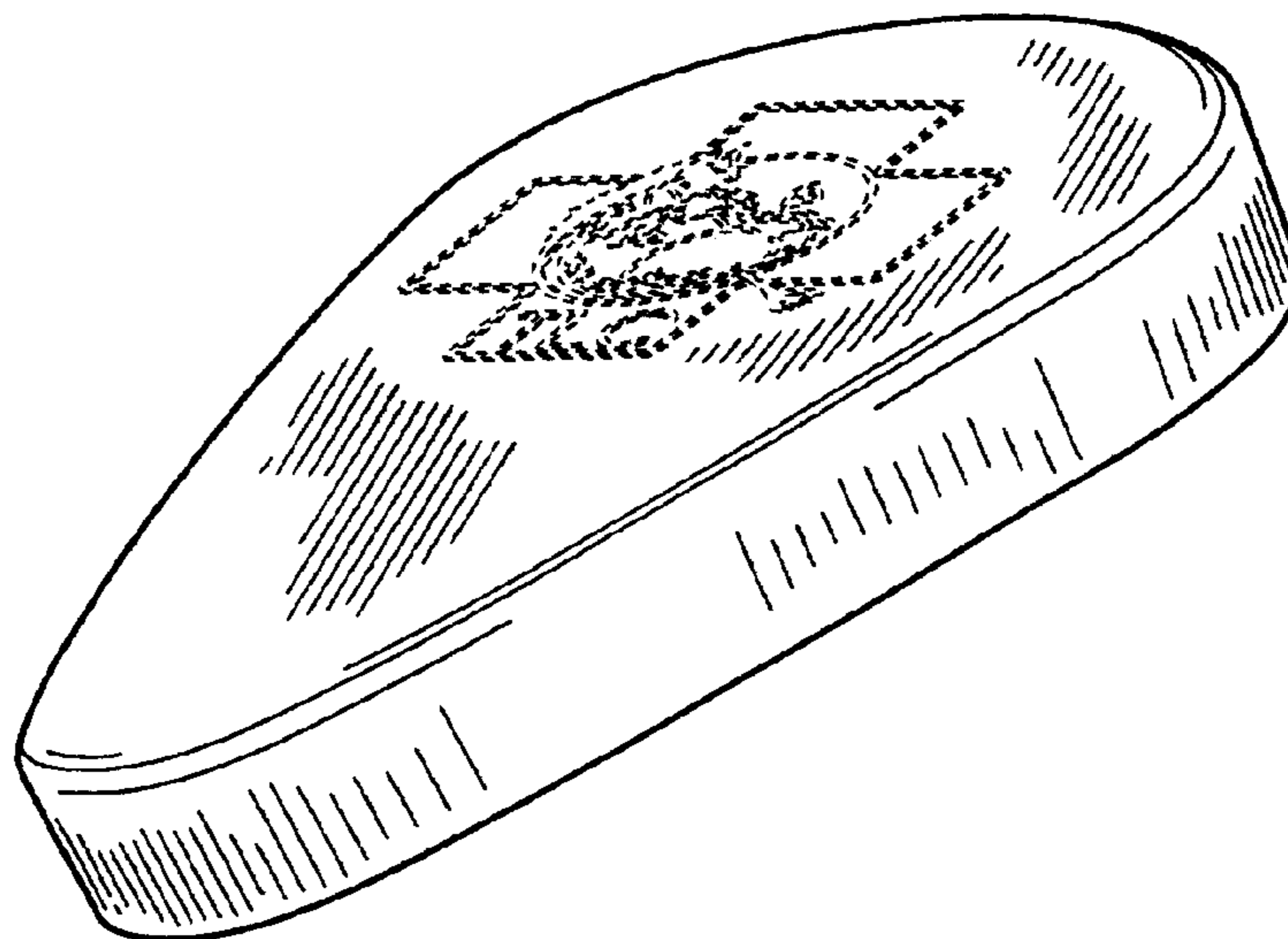
FIG. 4 is a right side view of the frog support of FIG. 1.

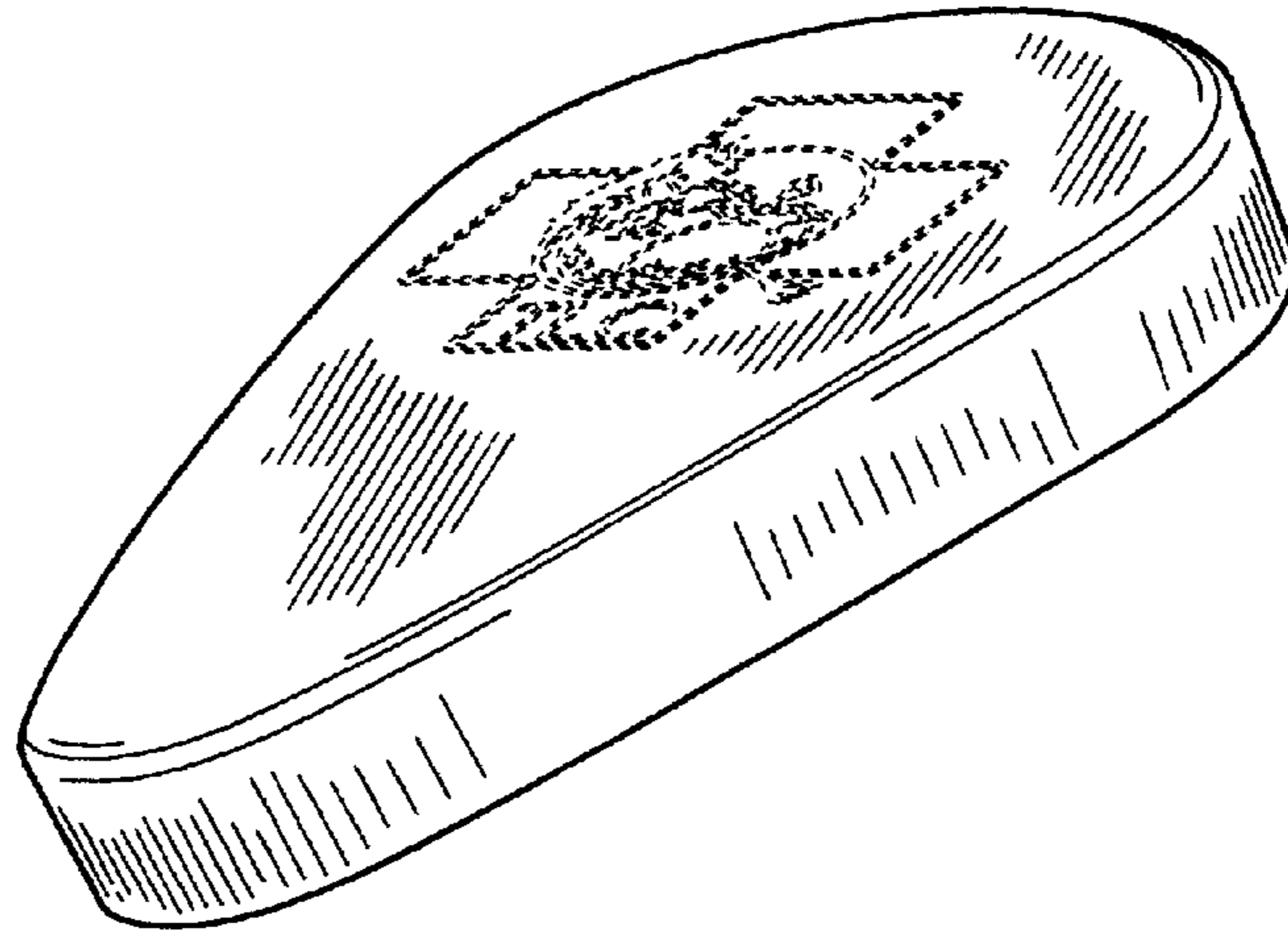

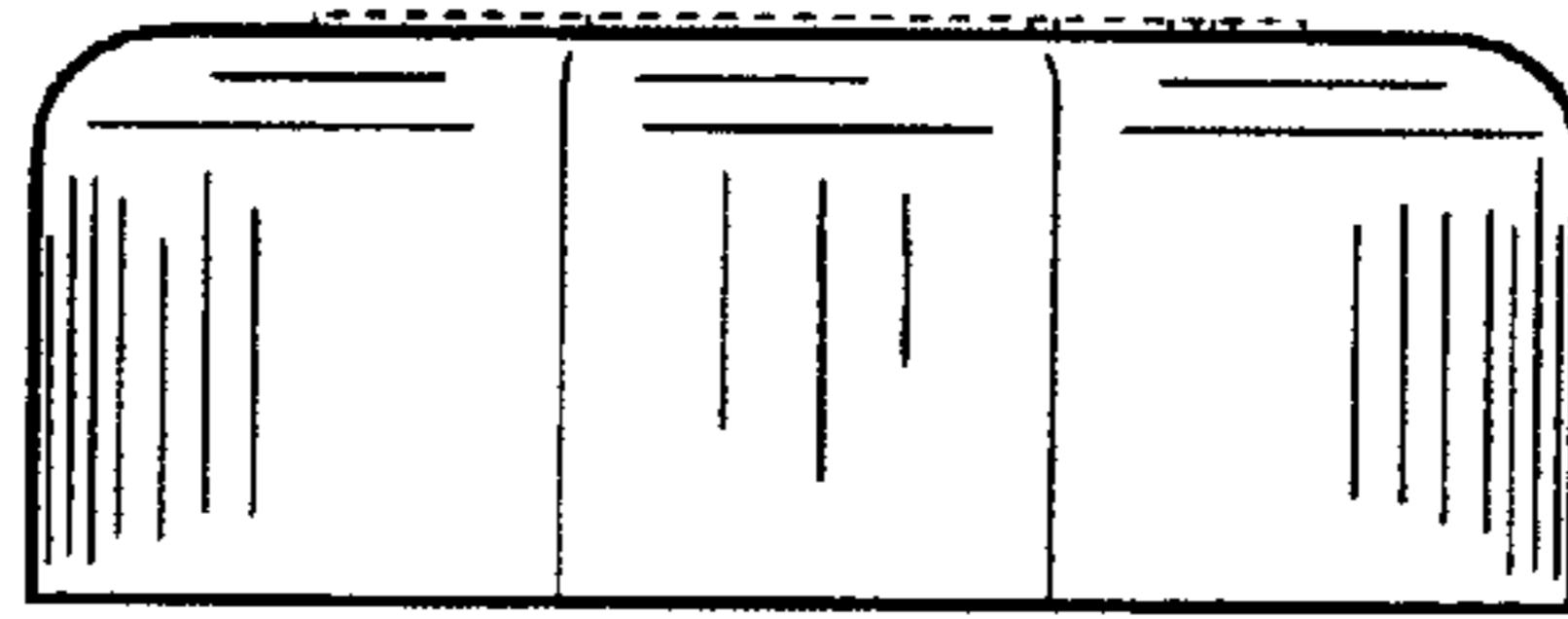

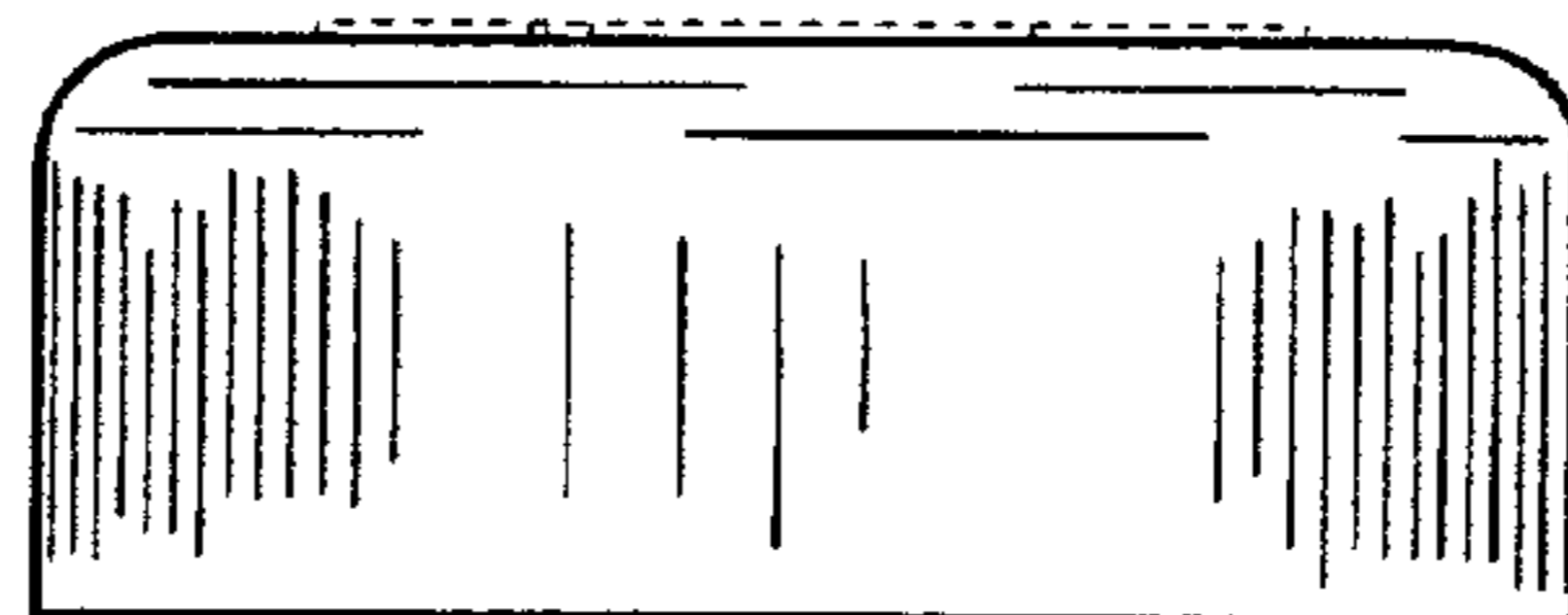

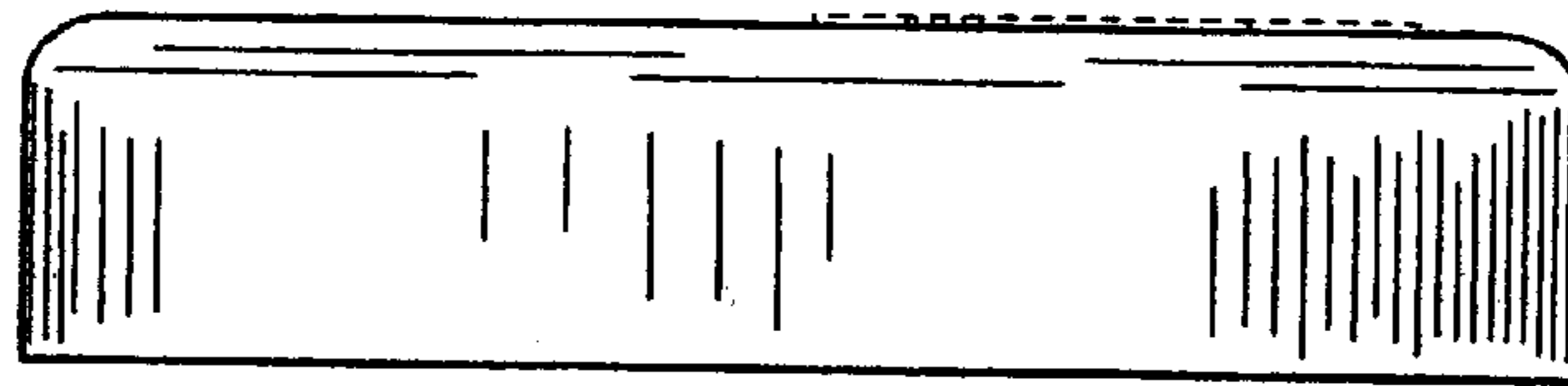

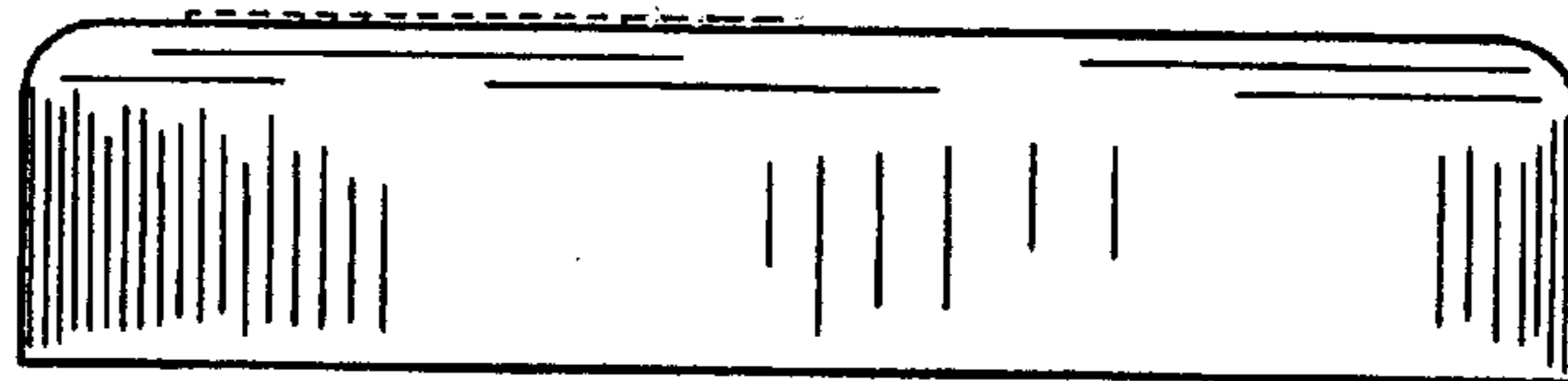

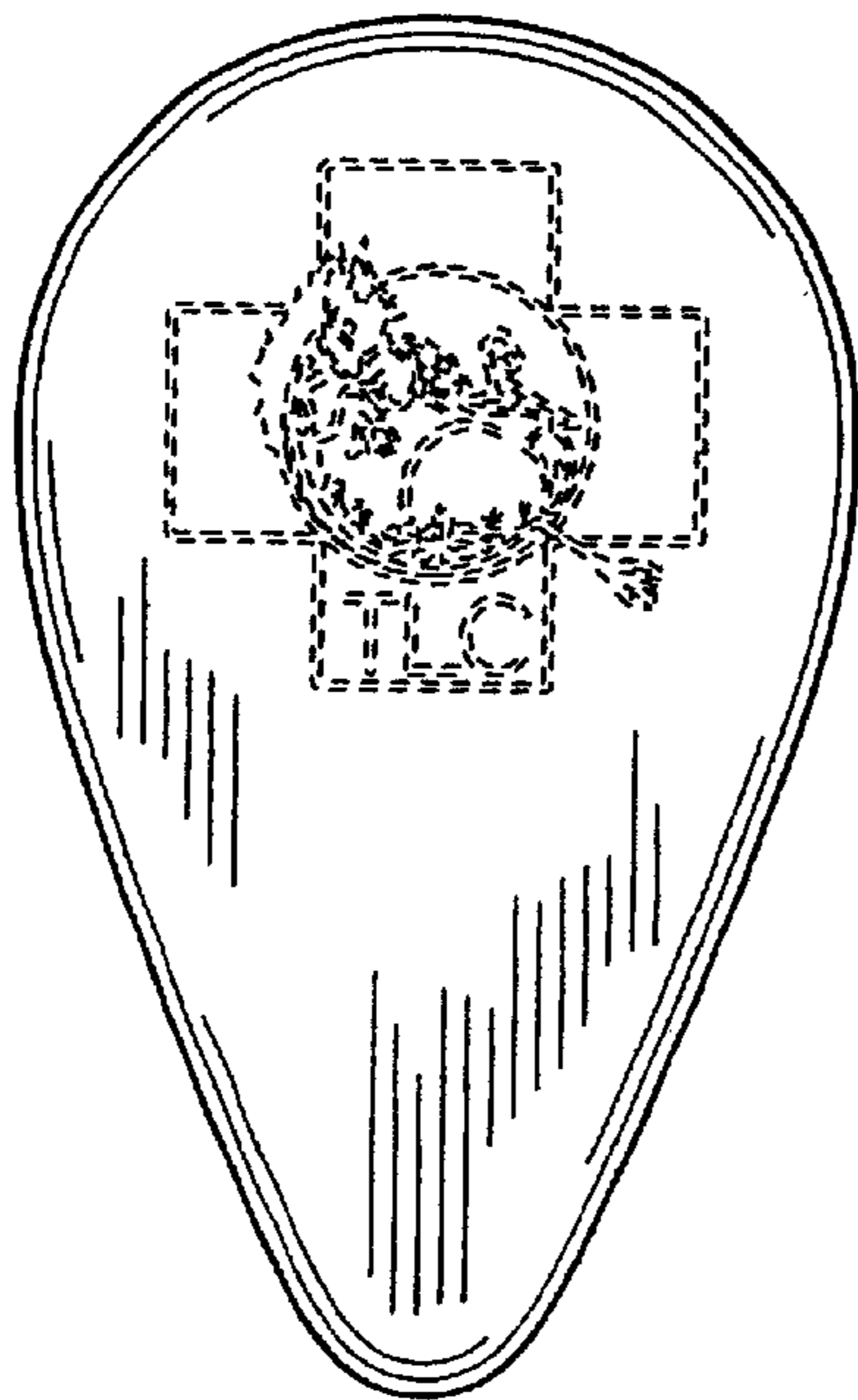

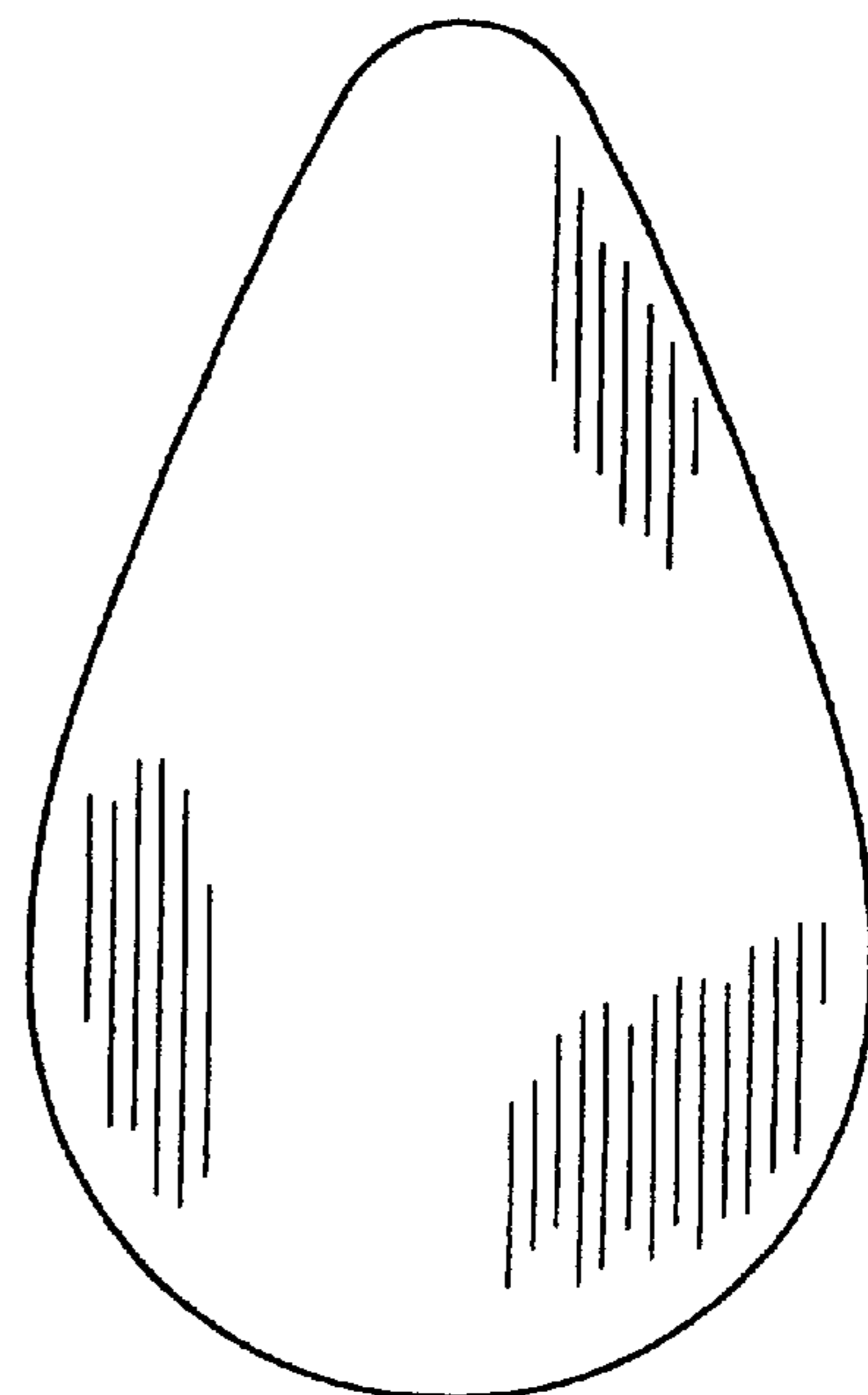
