**DESCRIPTION**

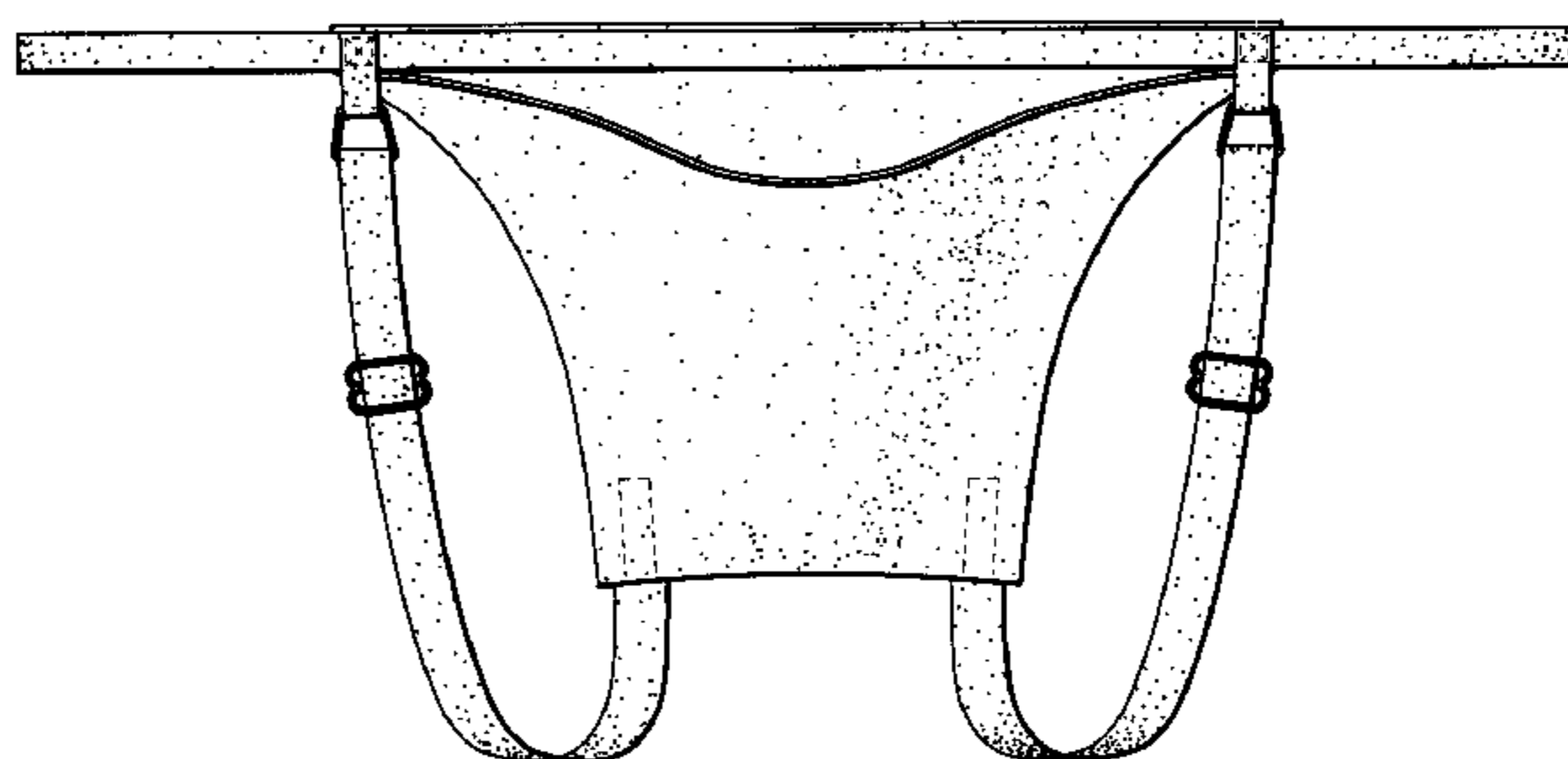
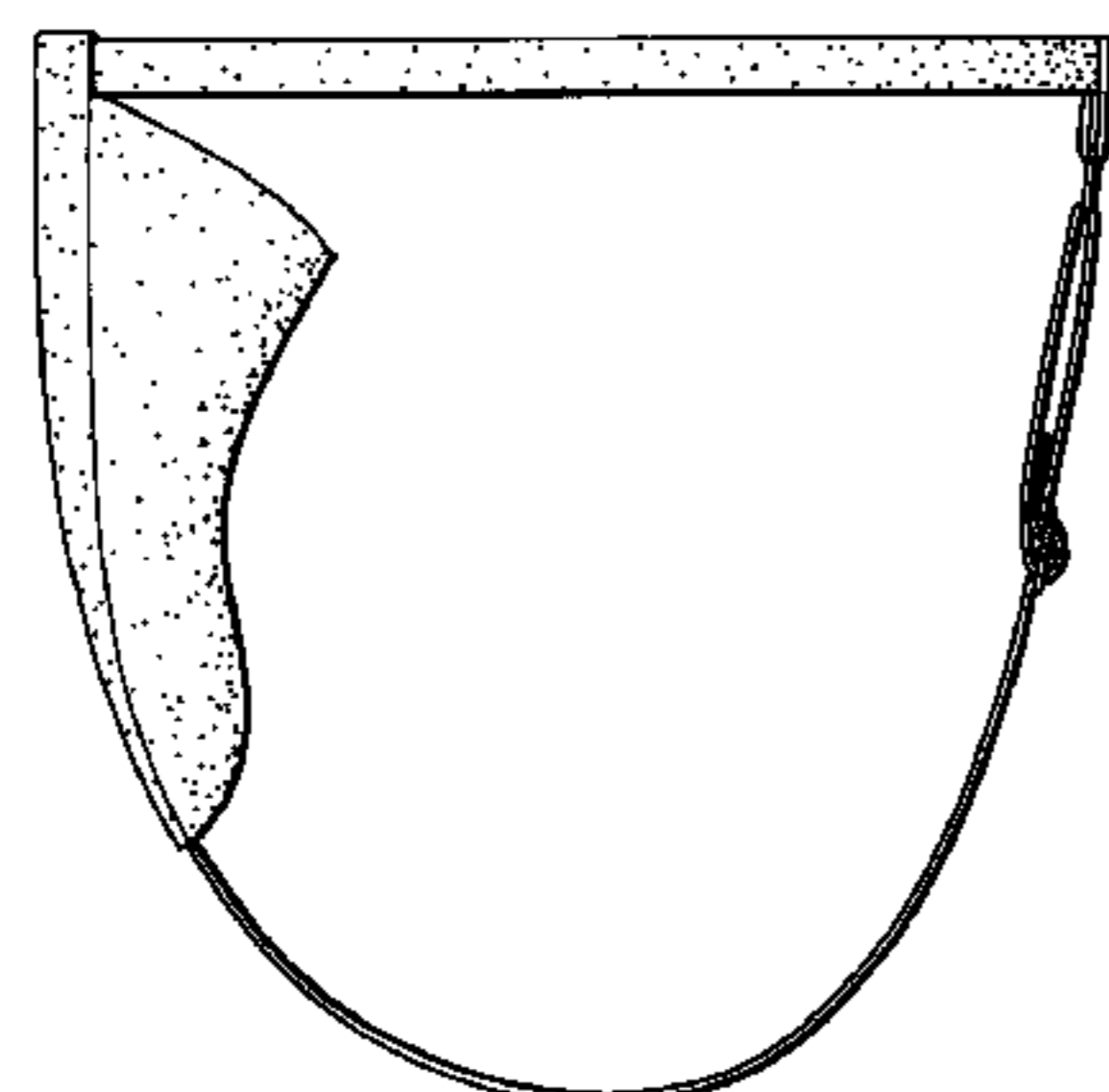
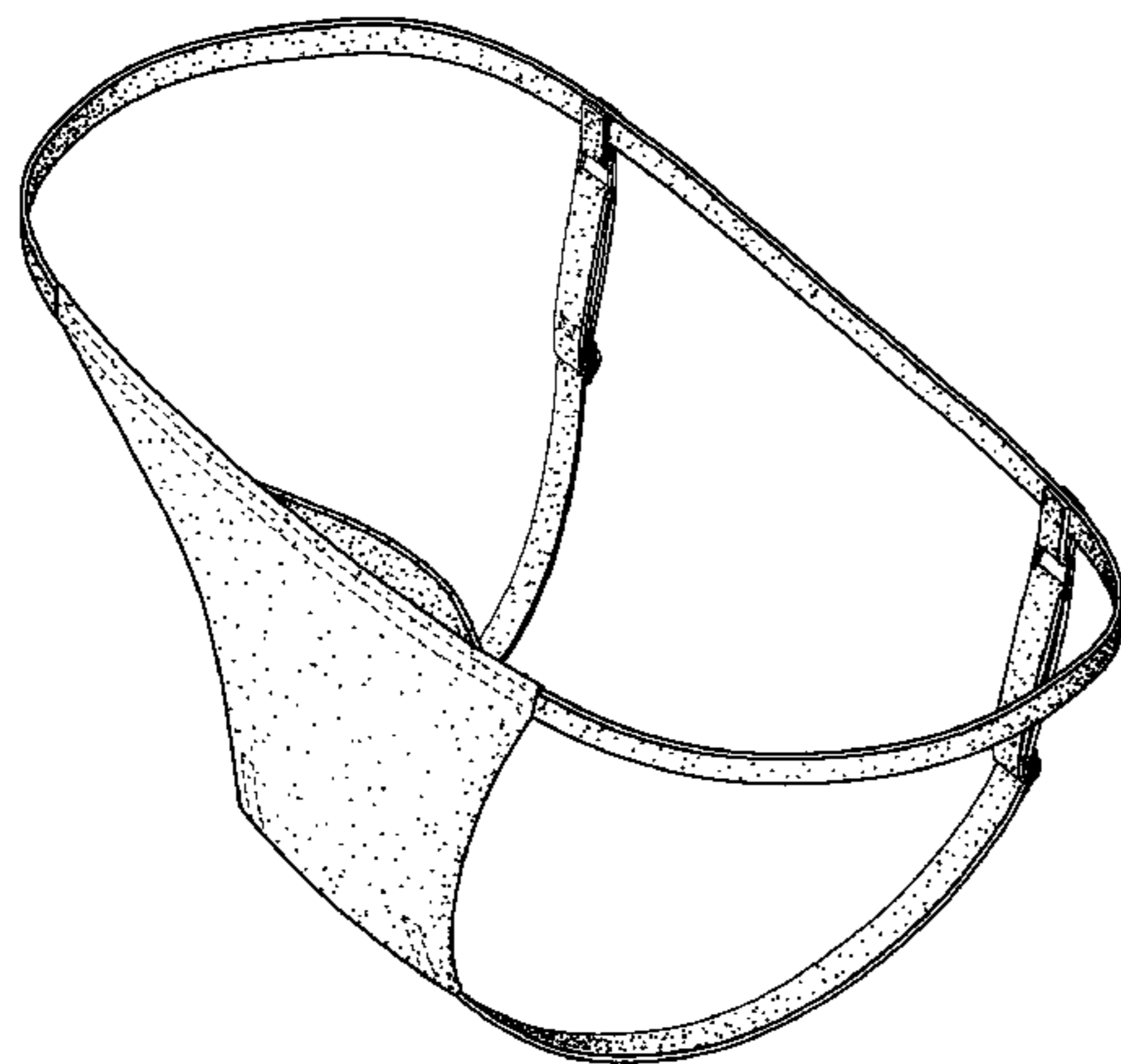
FIG. 1 is a front perspective view of a pouch panty showing my new design;

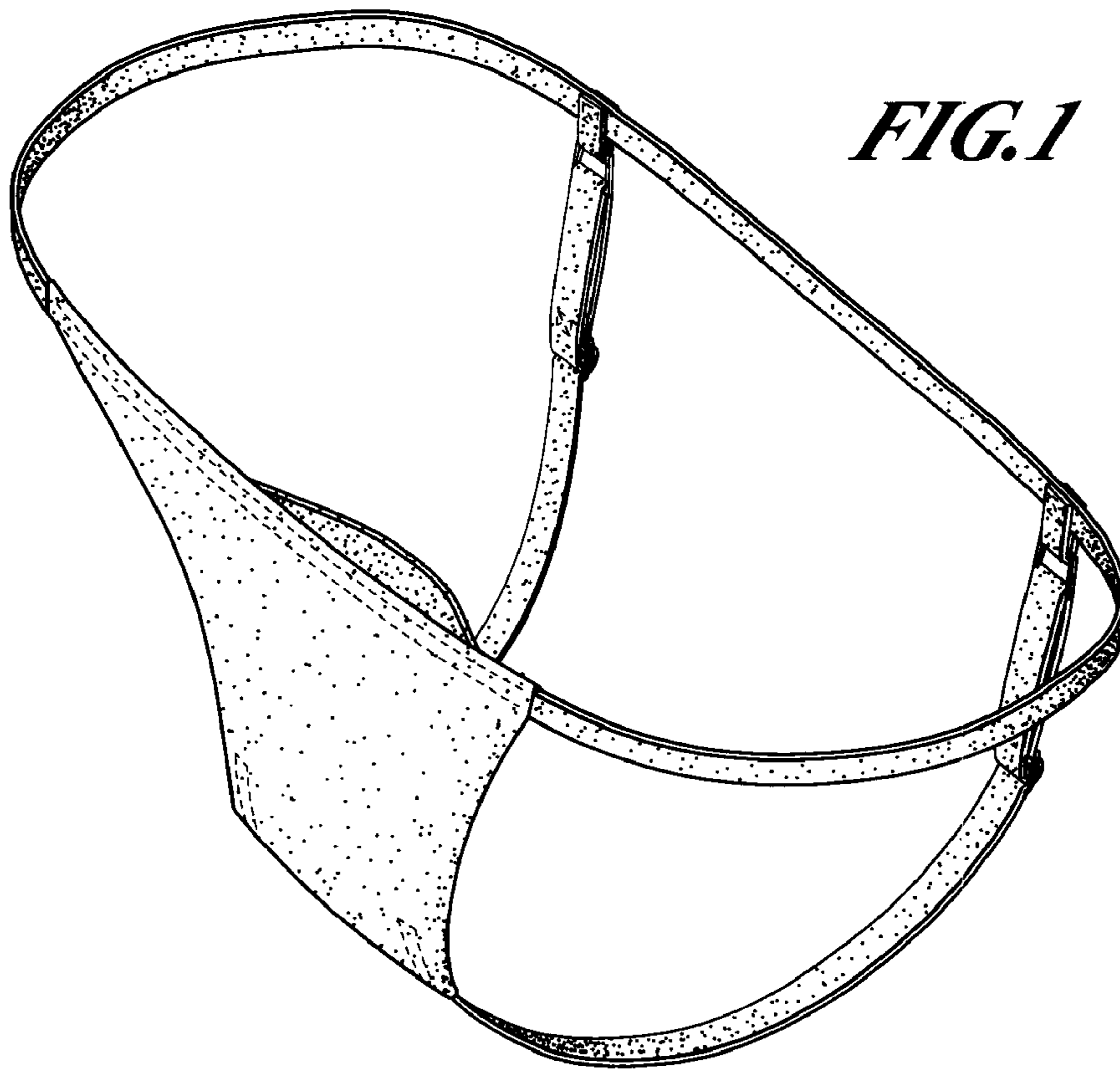
FIG. 2 is a left side elevational view thereof, the right side being a mirror image; and,

FIG. 3 is a rear elevational view thereof.

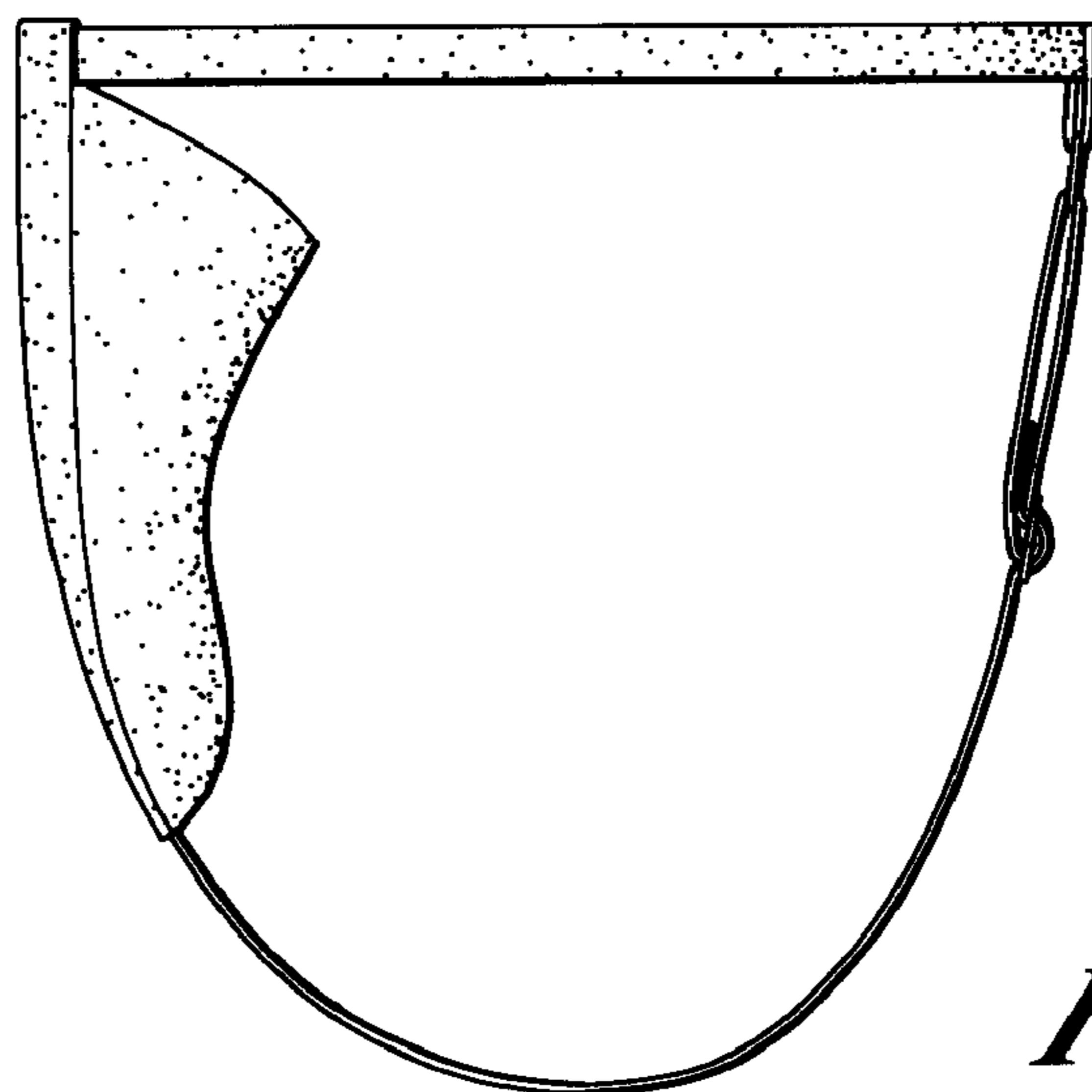
The broken line shown in FIGS. 1 and 3 represents stitching.

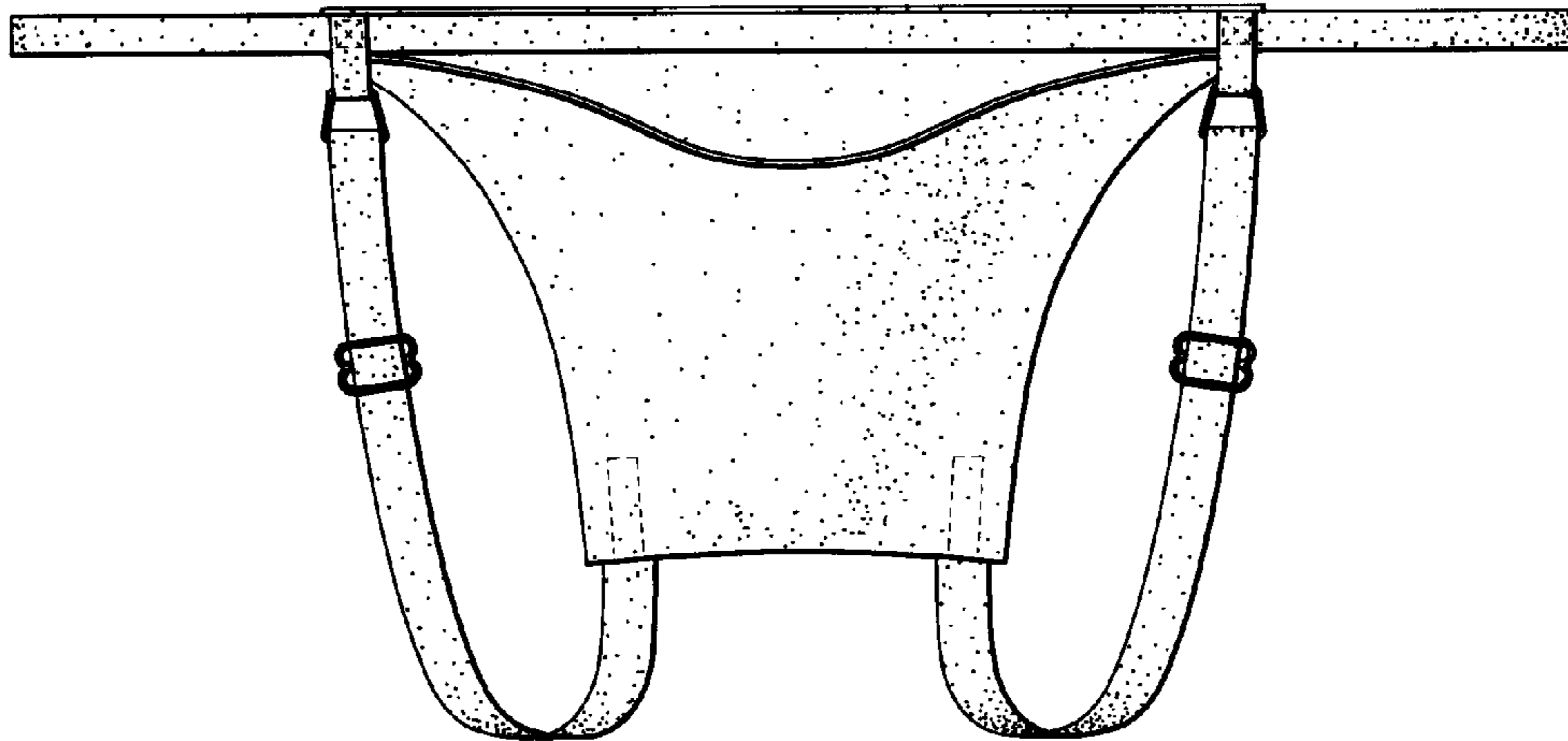
