(57) **CLAIM**

I claim the ornamental design for a head buster hat, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the head buster hat, showing my new design;

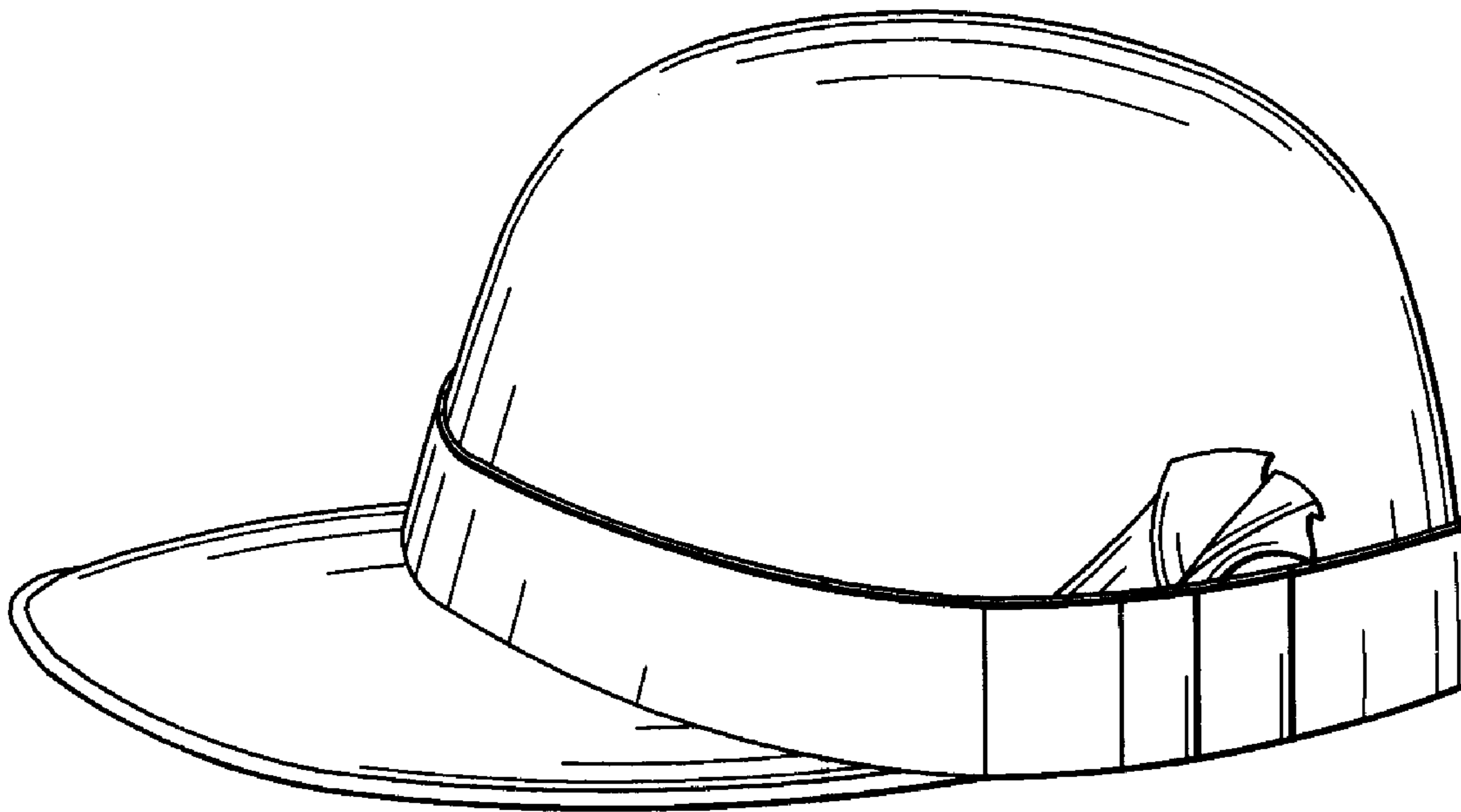
FIG. 2 is a perspective view, viewed from a point slightly elevated, of the head buster hat illustrated in FIG. 1;

FIG. 3 is a rear perspective view of the head buster hat illustrated in FIG. 1, viewed from the right rear;

FIG. 4 is a bottom view of the head buster hat illustrated in FIG. 1; and,

FIG. 5 is an exploded perspective view of the head buster hat illustrated in FIG. 1 on slightly reduced scale shown without the feather for convenience of illustration.

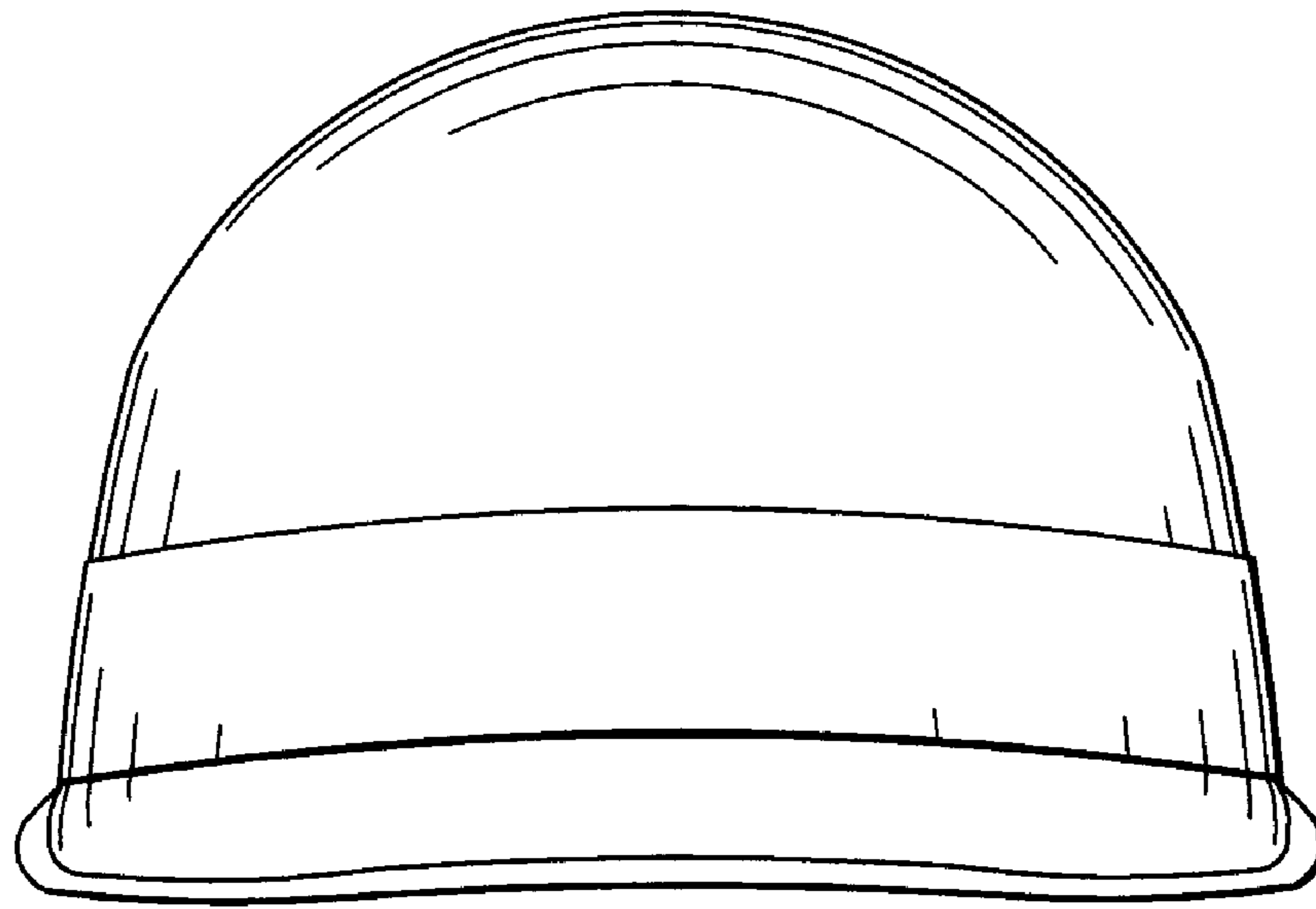

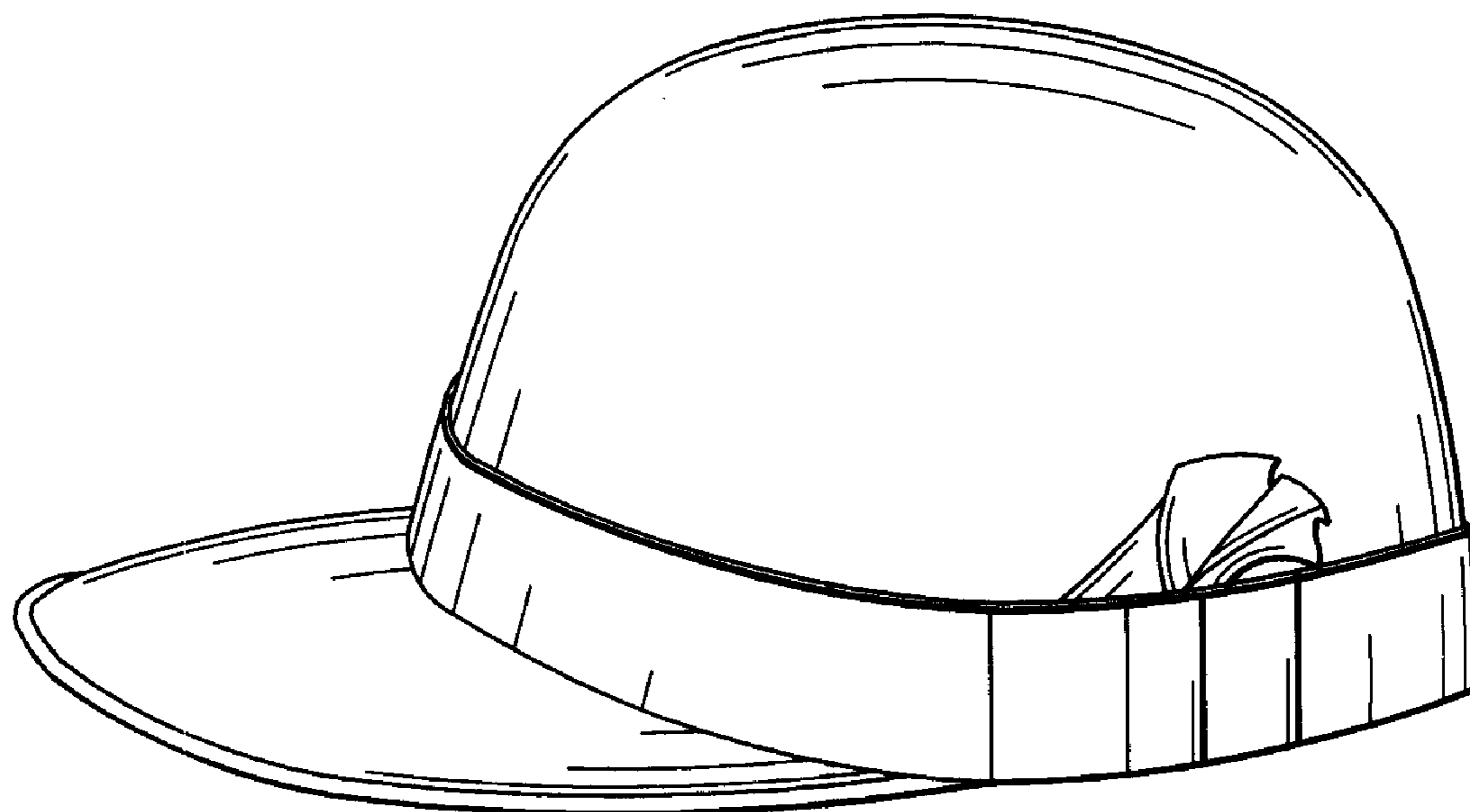

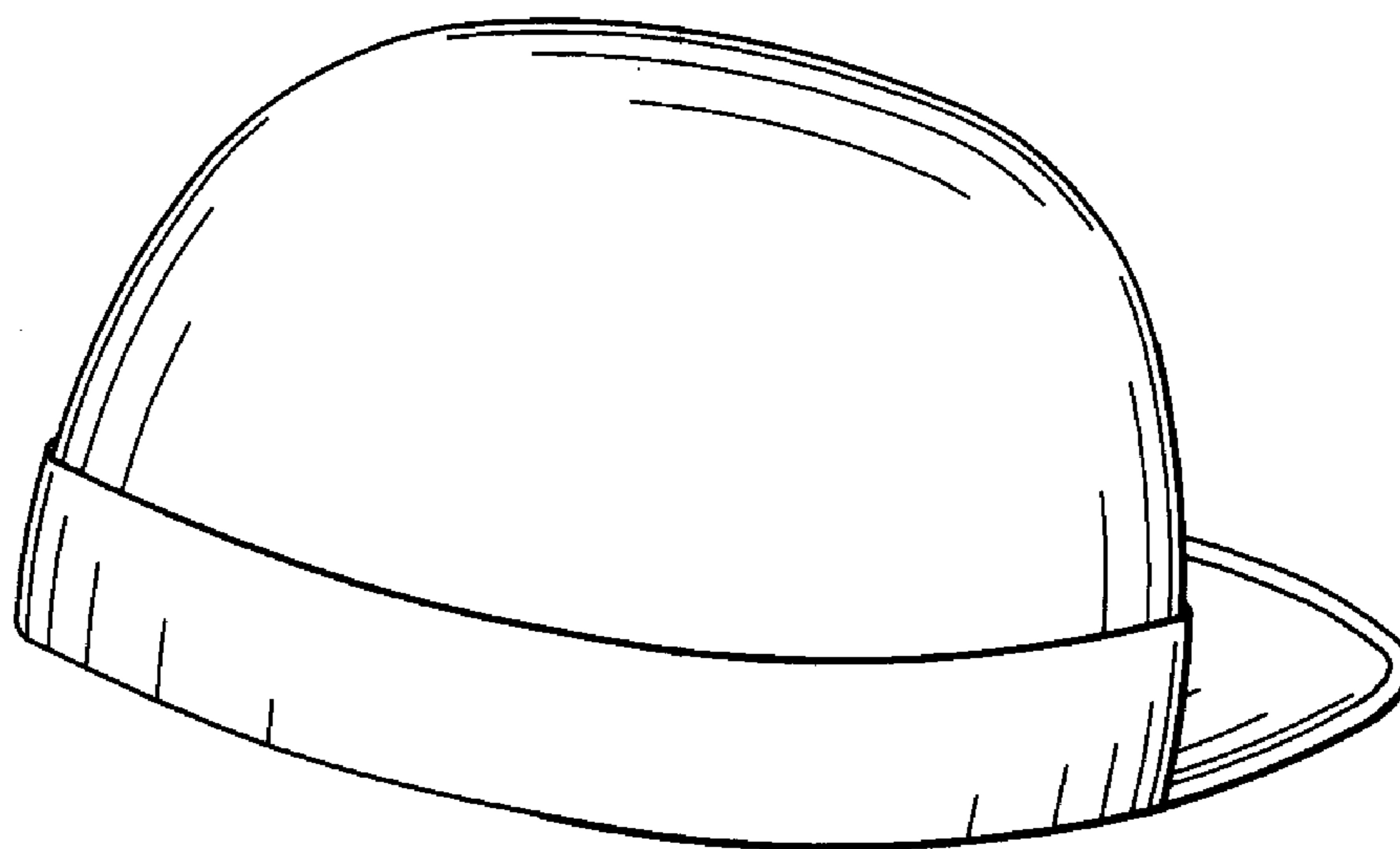

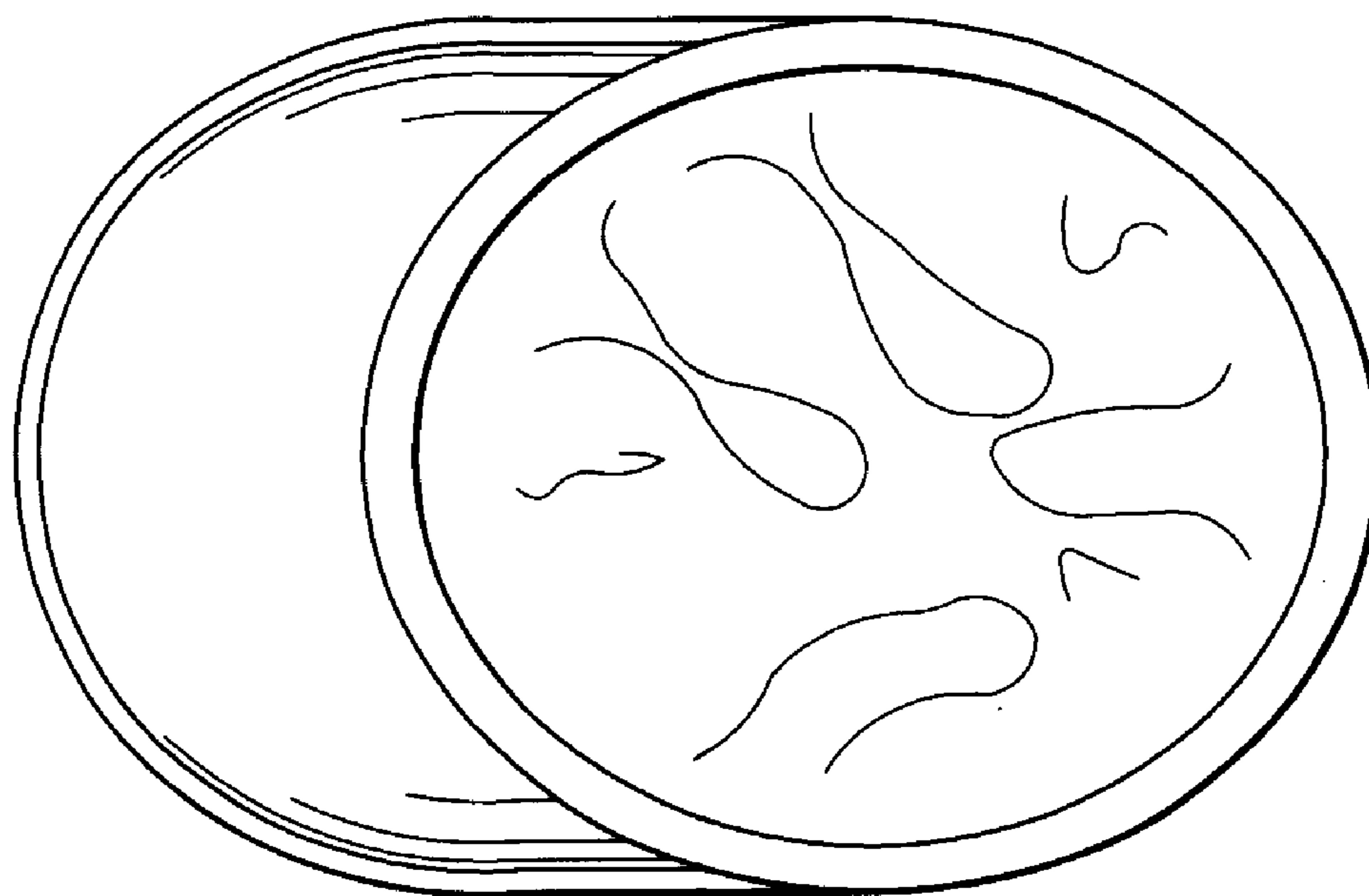

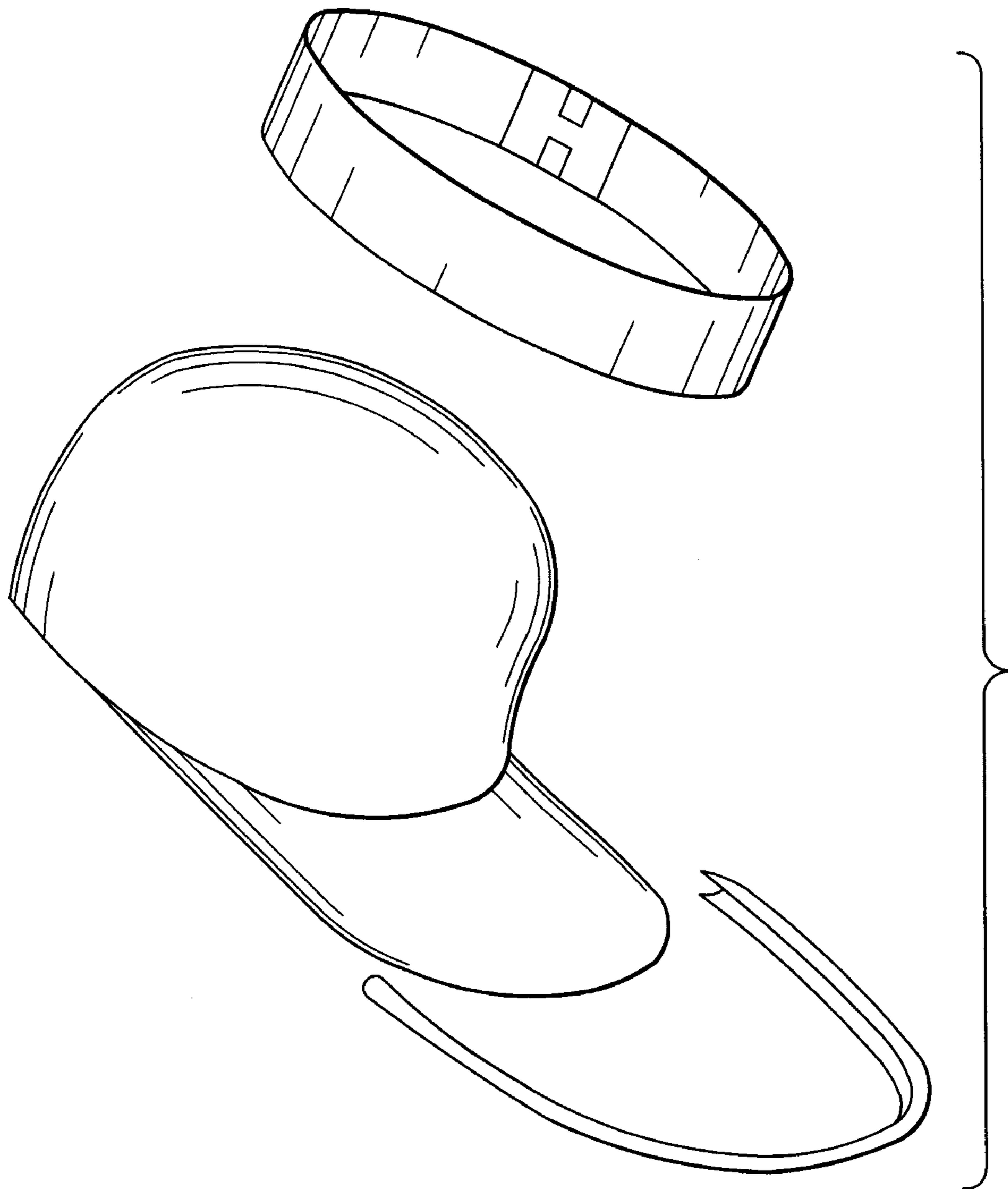
