I claim the ornamental design for a footwear tread, as shown and described.

DESCRIPTION

FIG. 2 is a front perspective view thereof;

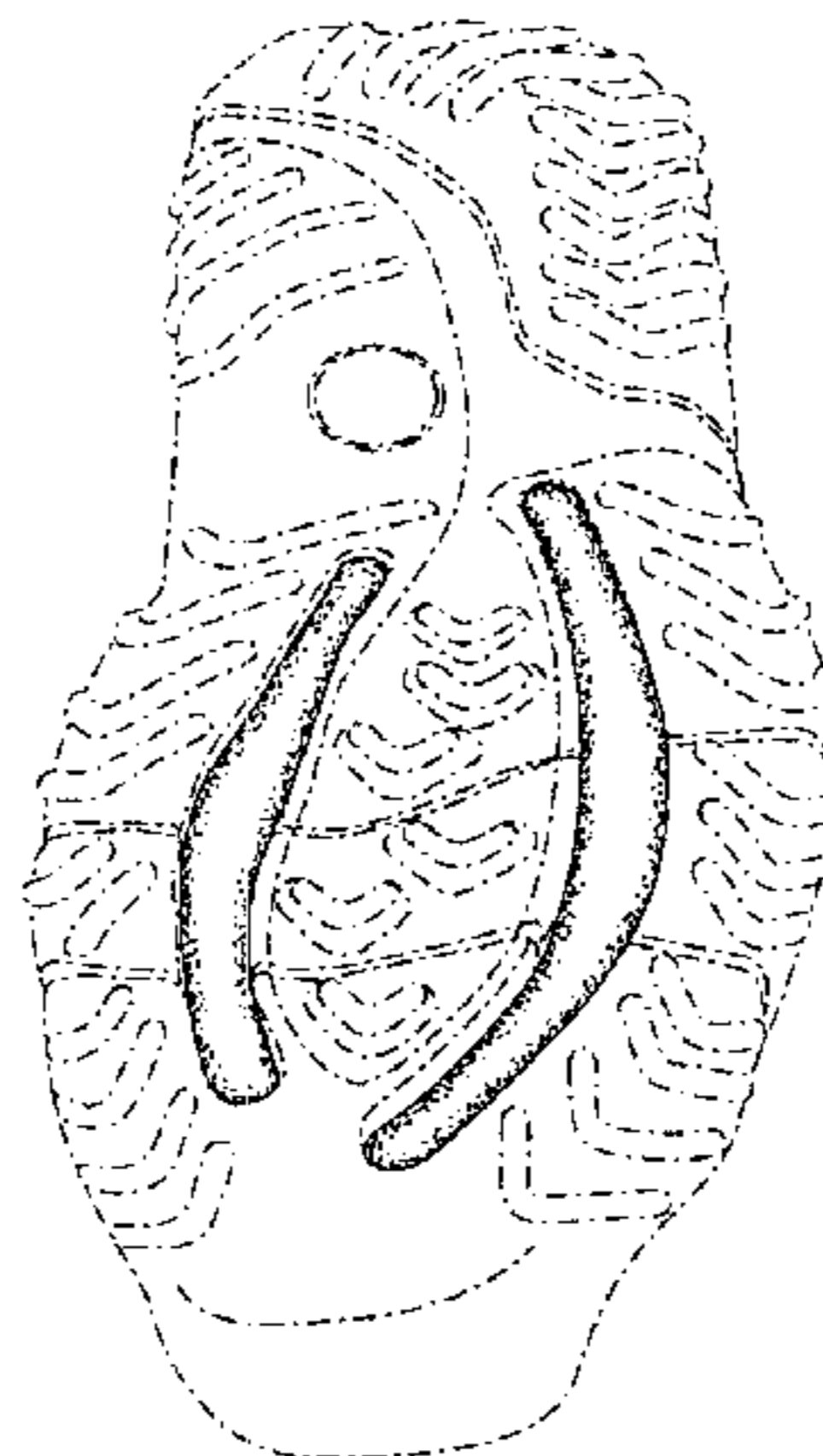
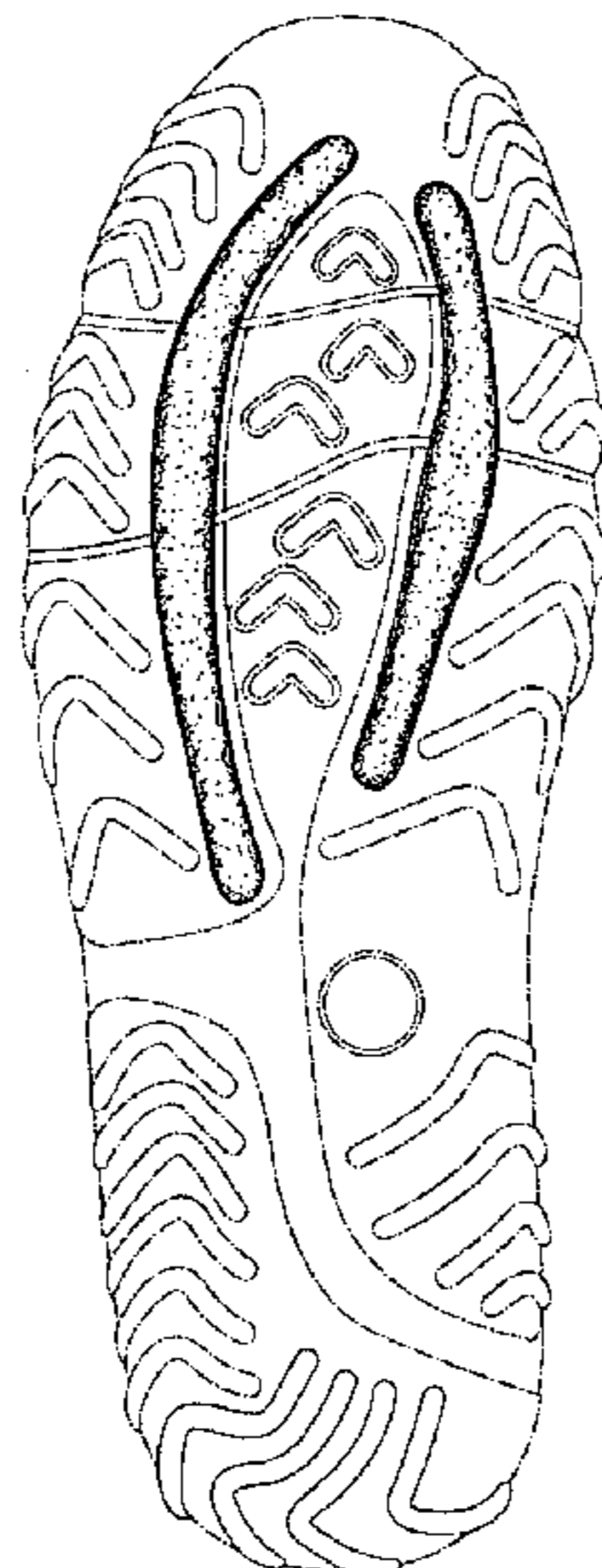
FIG. 3 is a rear perspective view thereof;

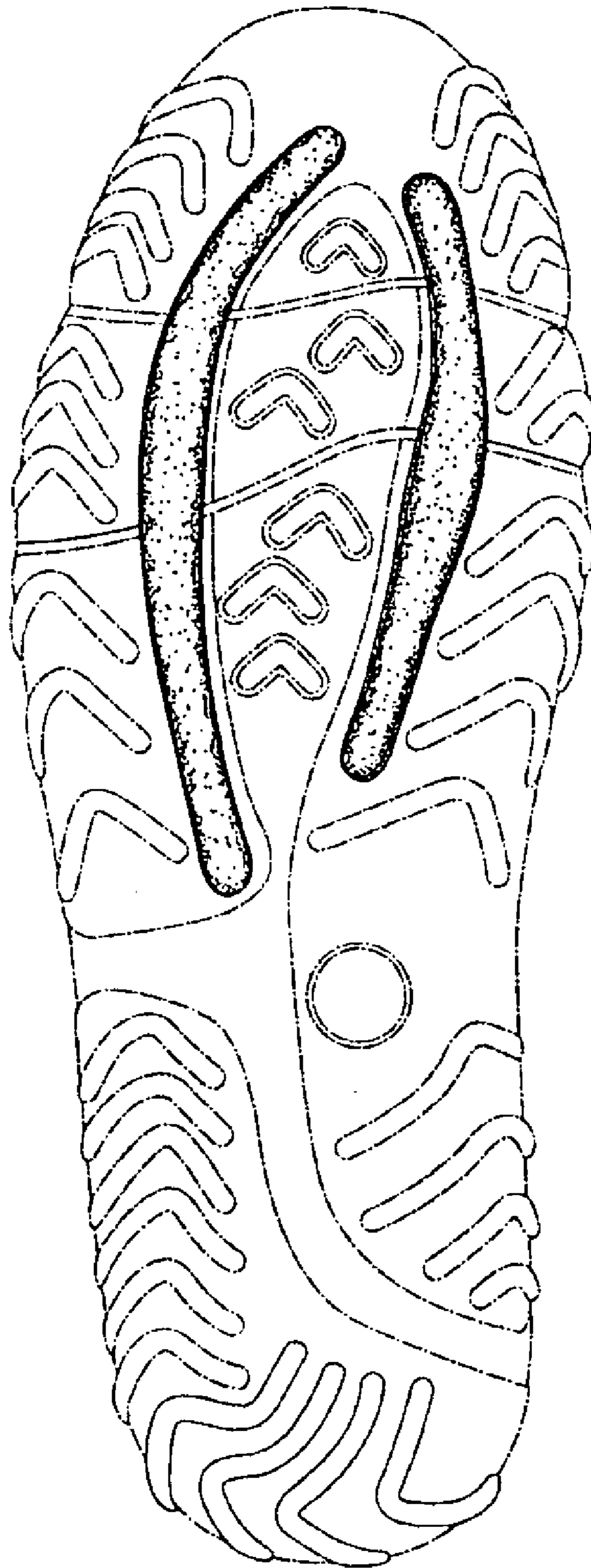

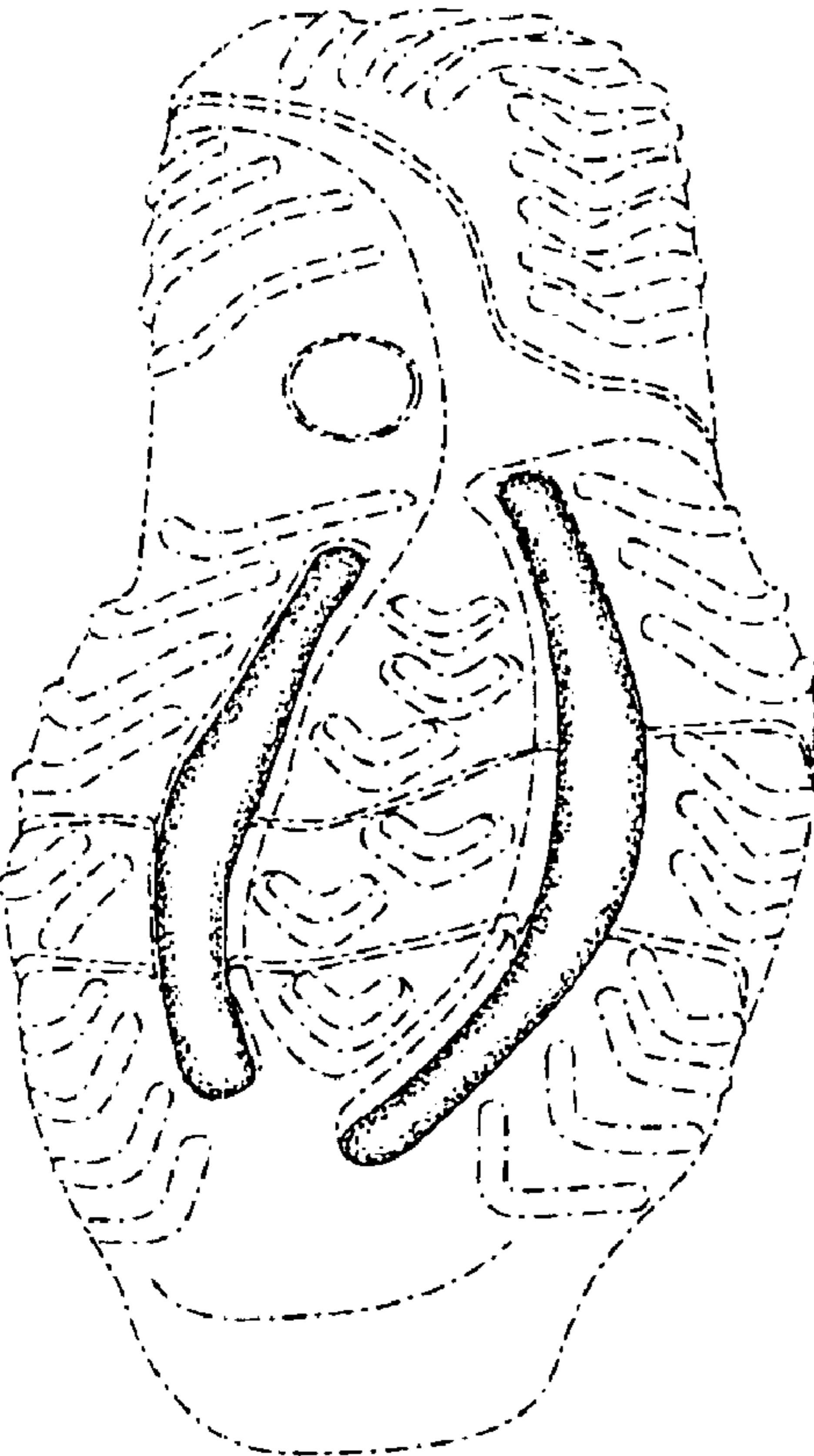

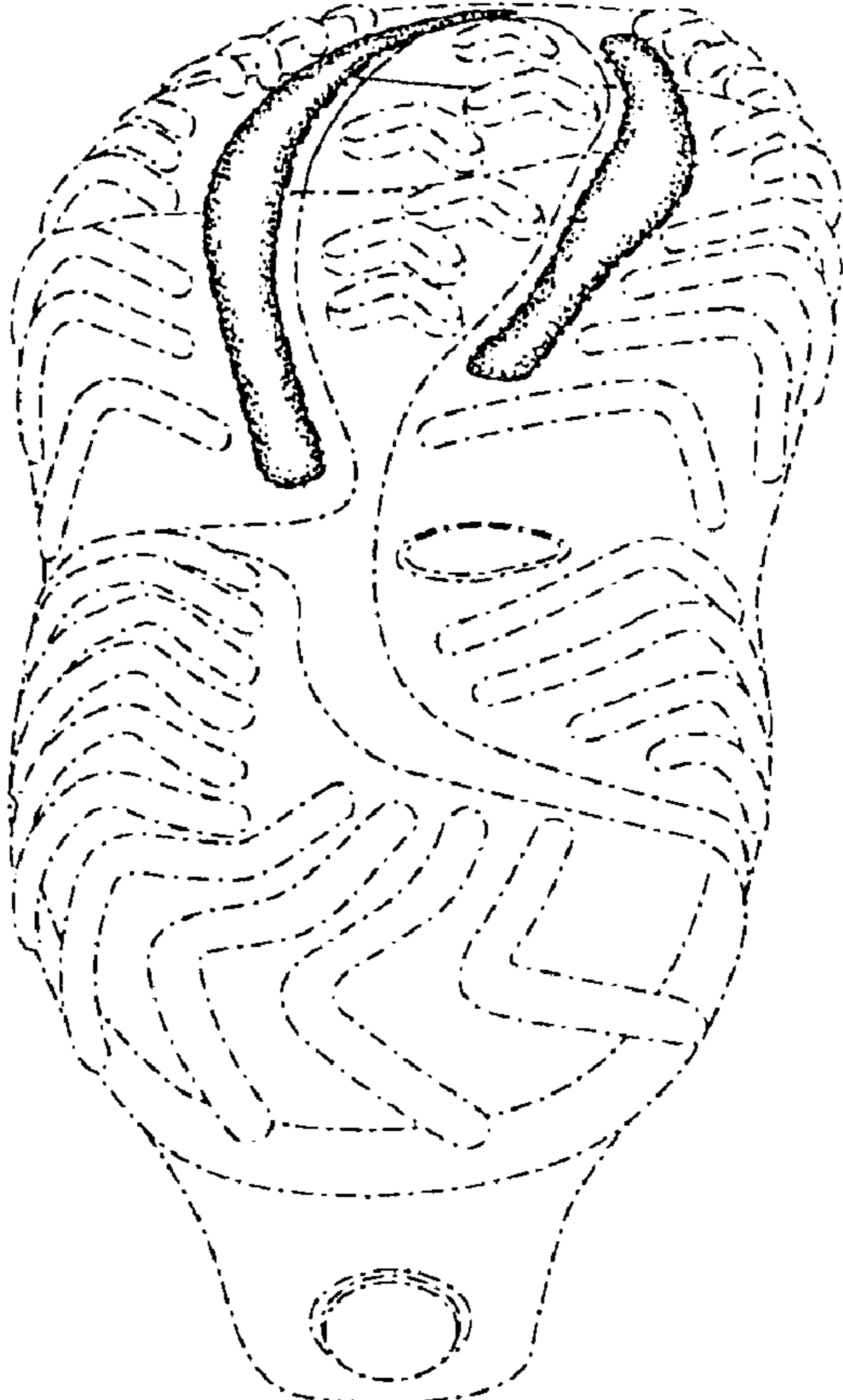

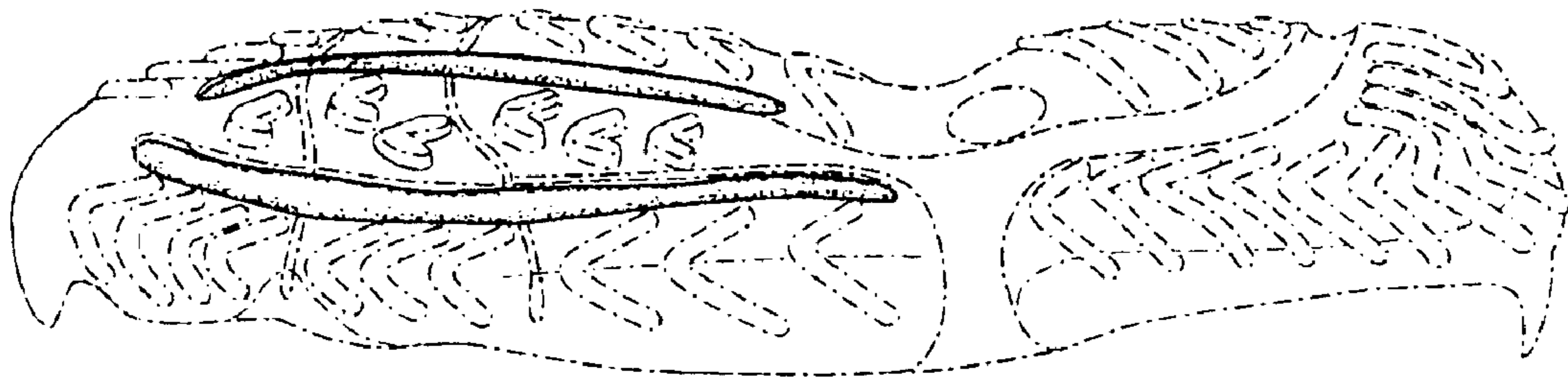

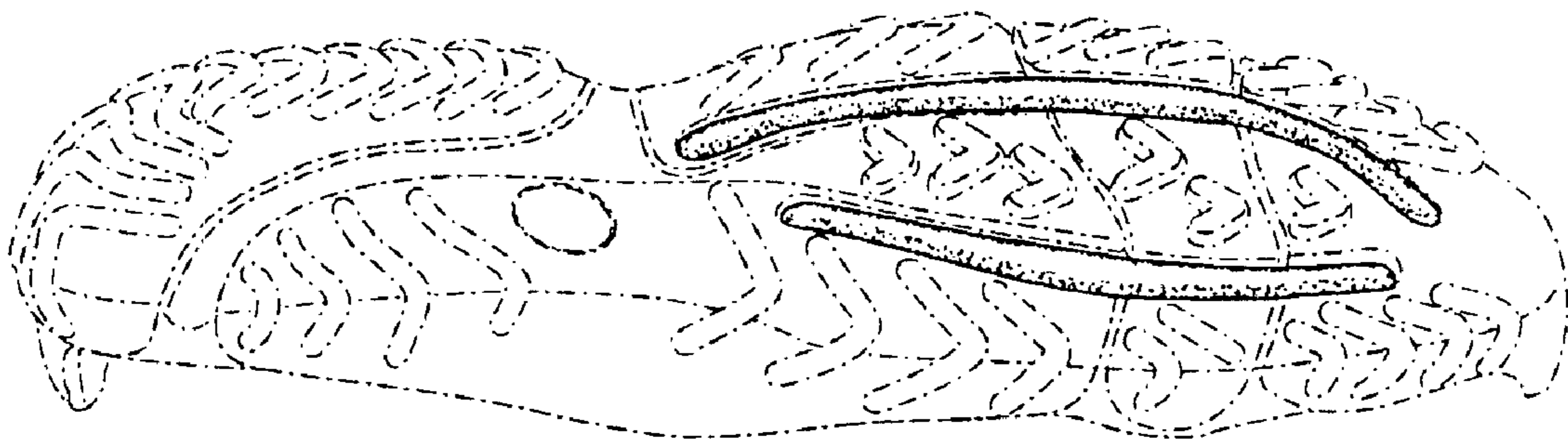
