DESCRIPTION

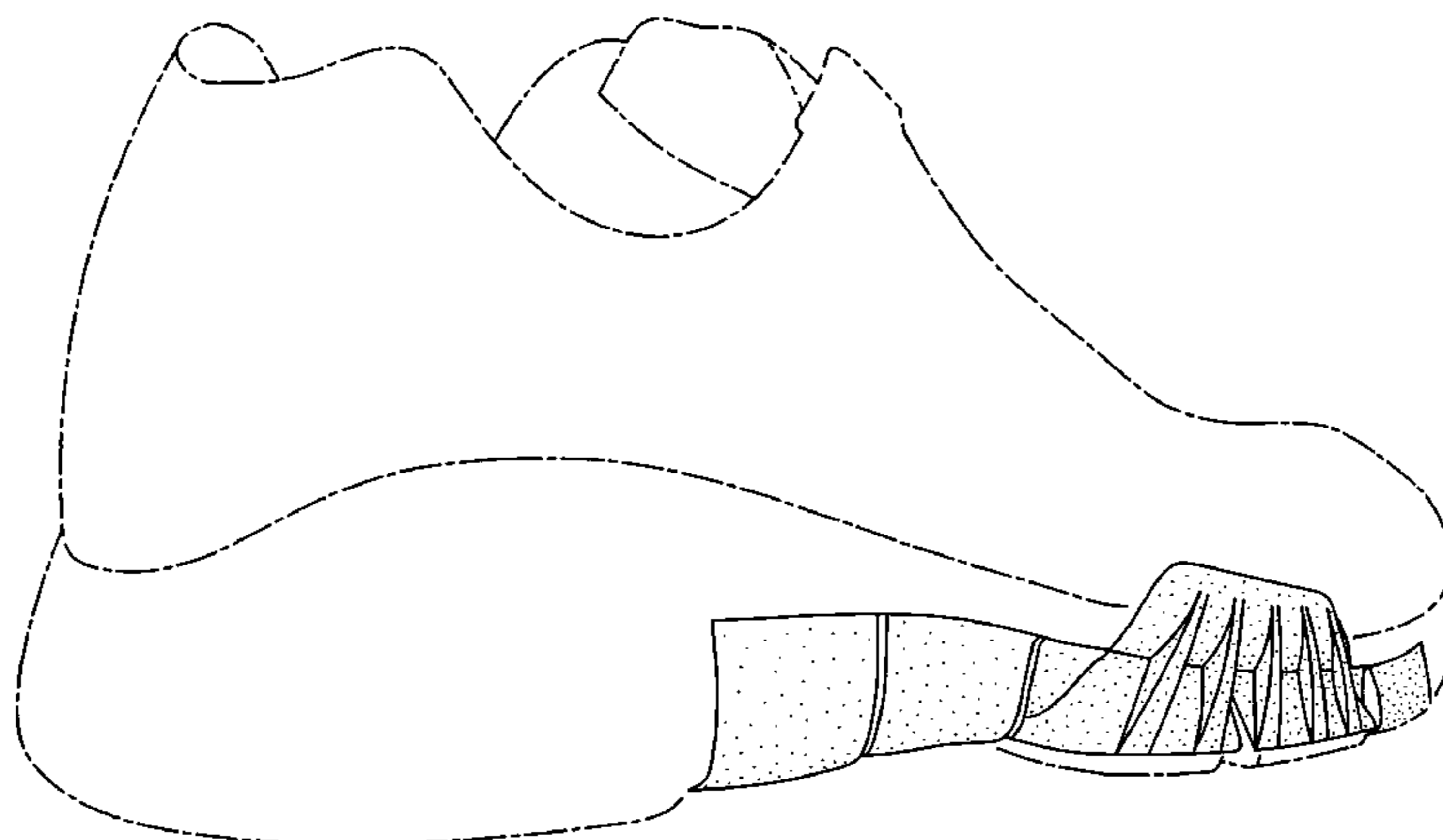
FIG. 1 is a front perspective view of a portion of a shoe midsole showing my new design;

FIG. 2 is a side view thereof; and,

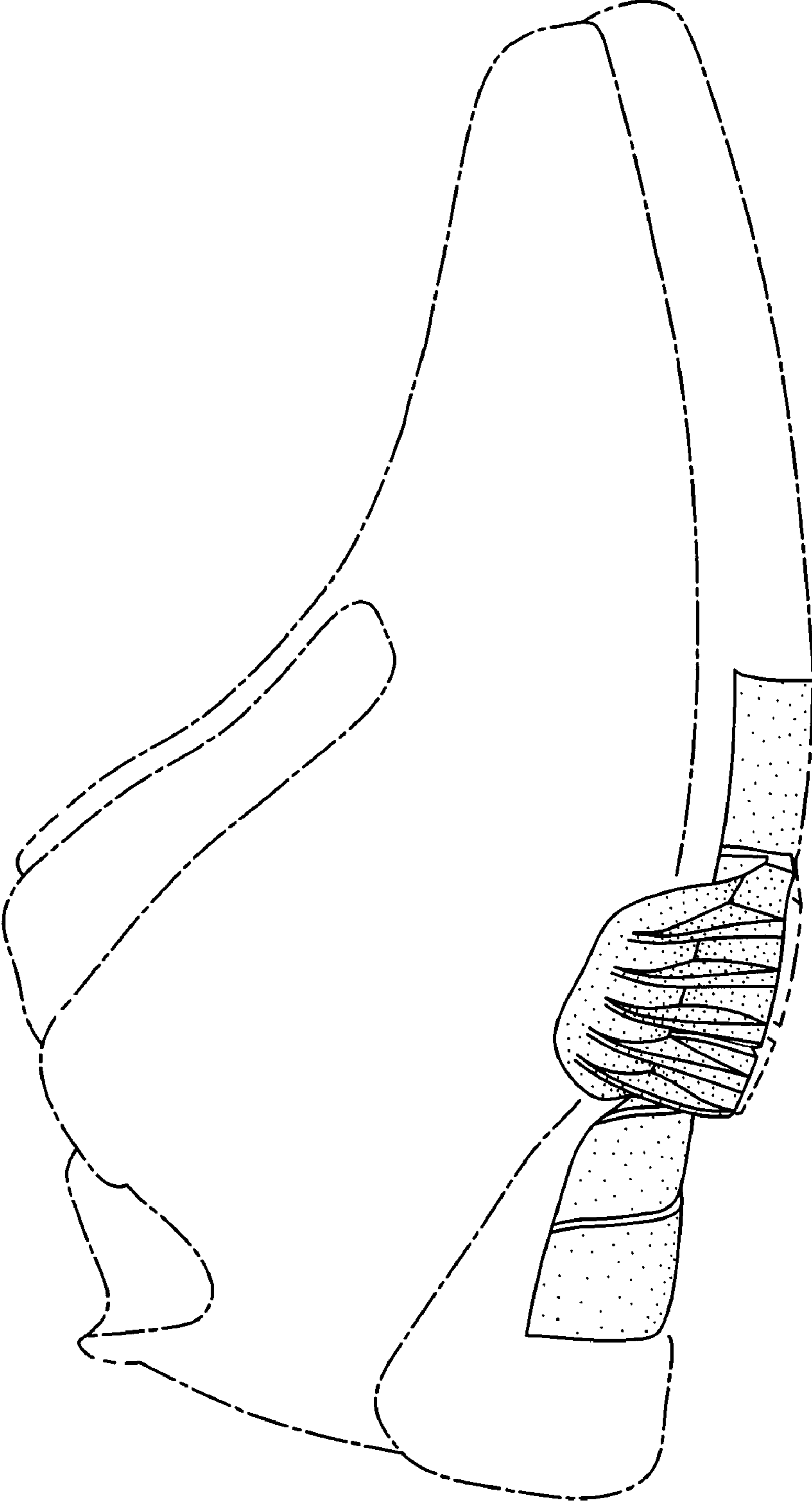

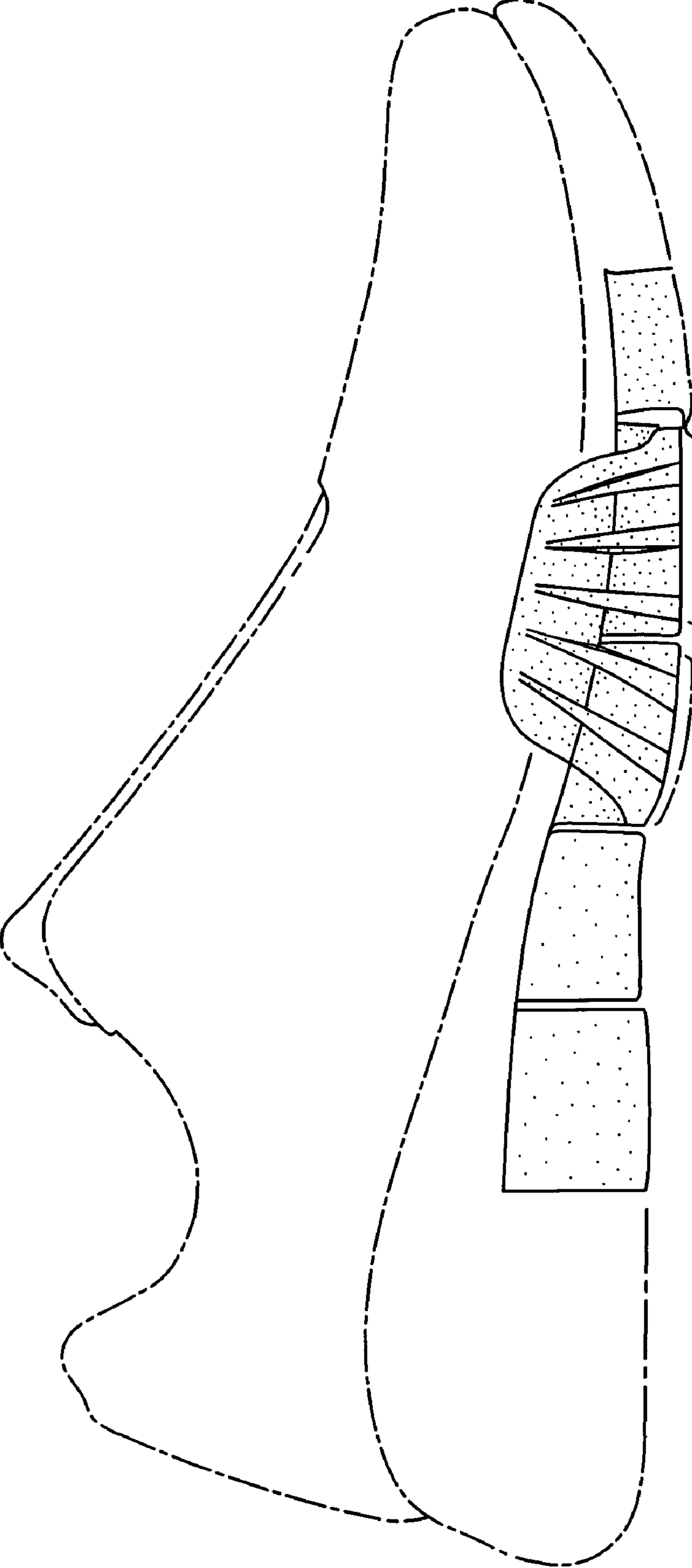
