**DESCRIPTION**

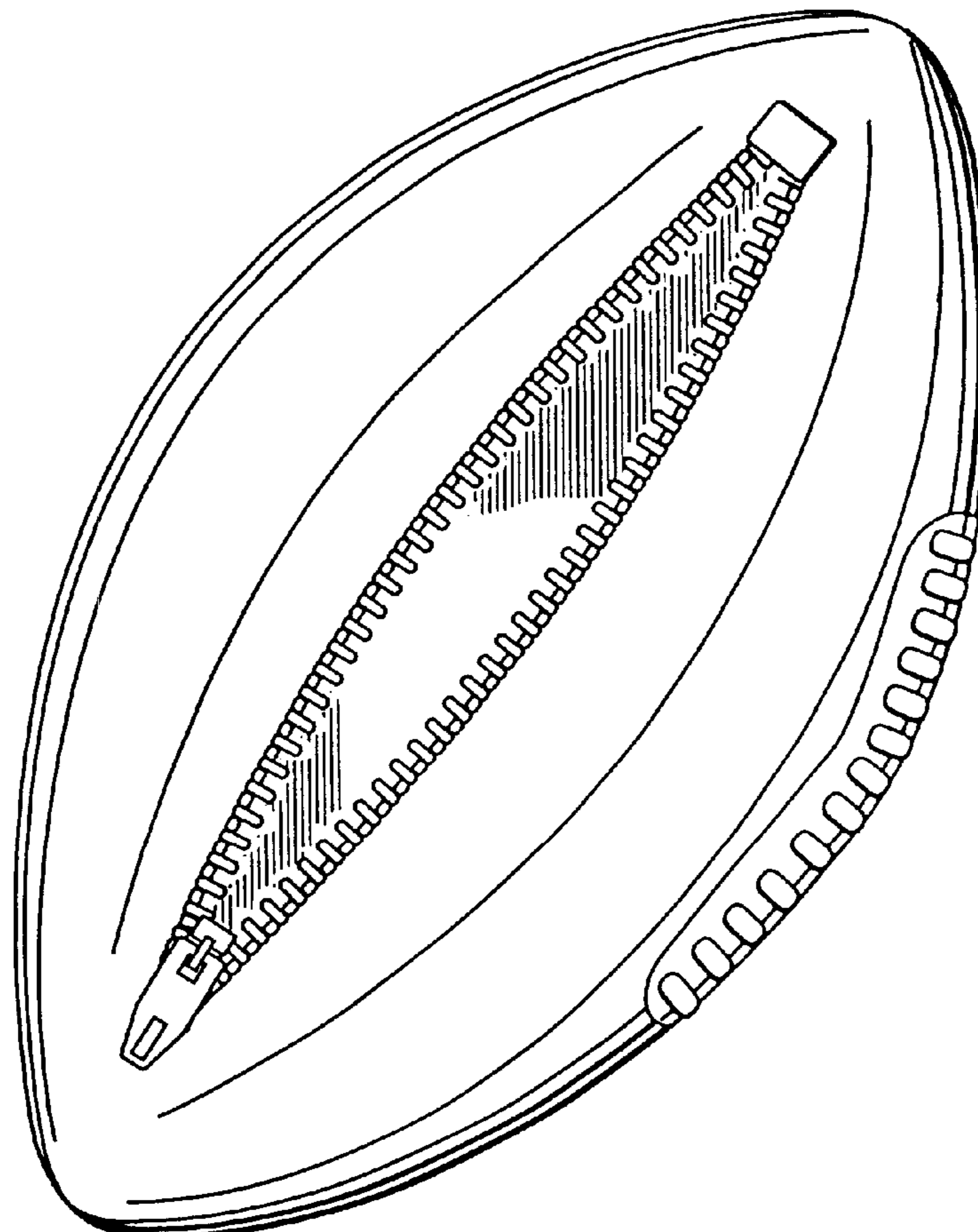
FIG. 1 is a top plan view of a bag showing my new design,

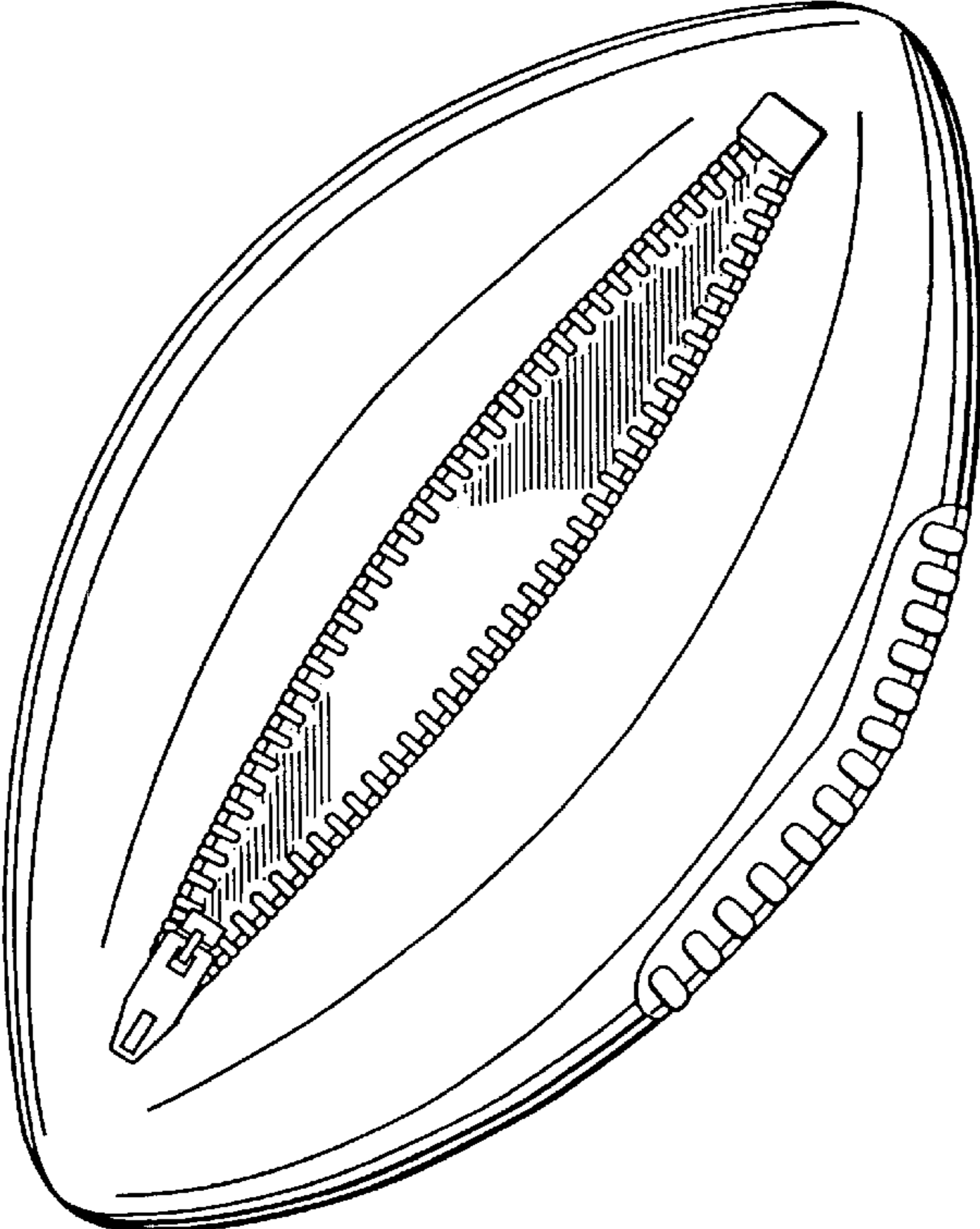

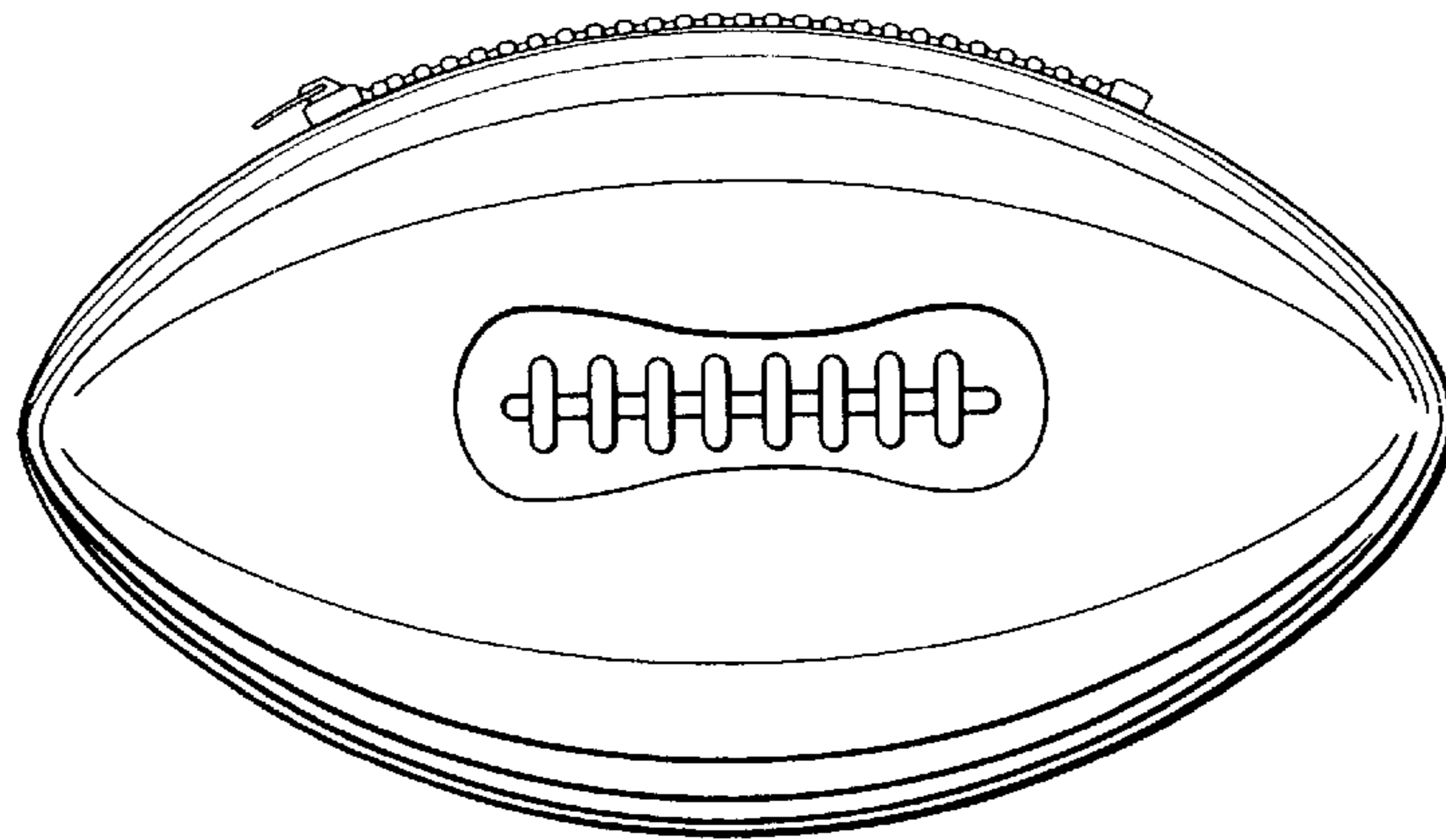

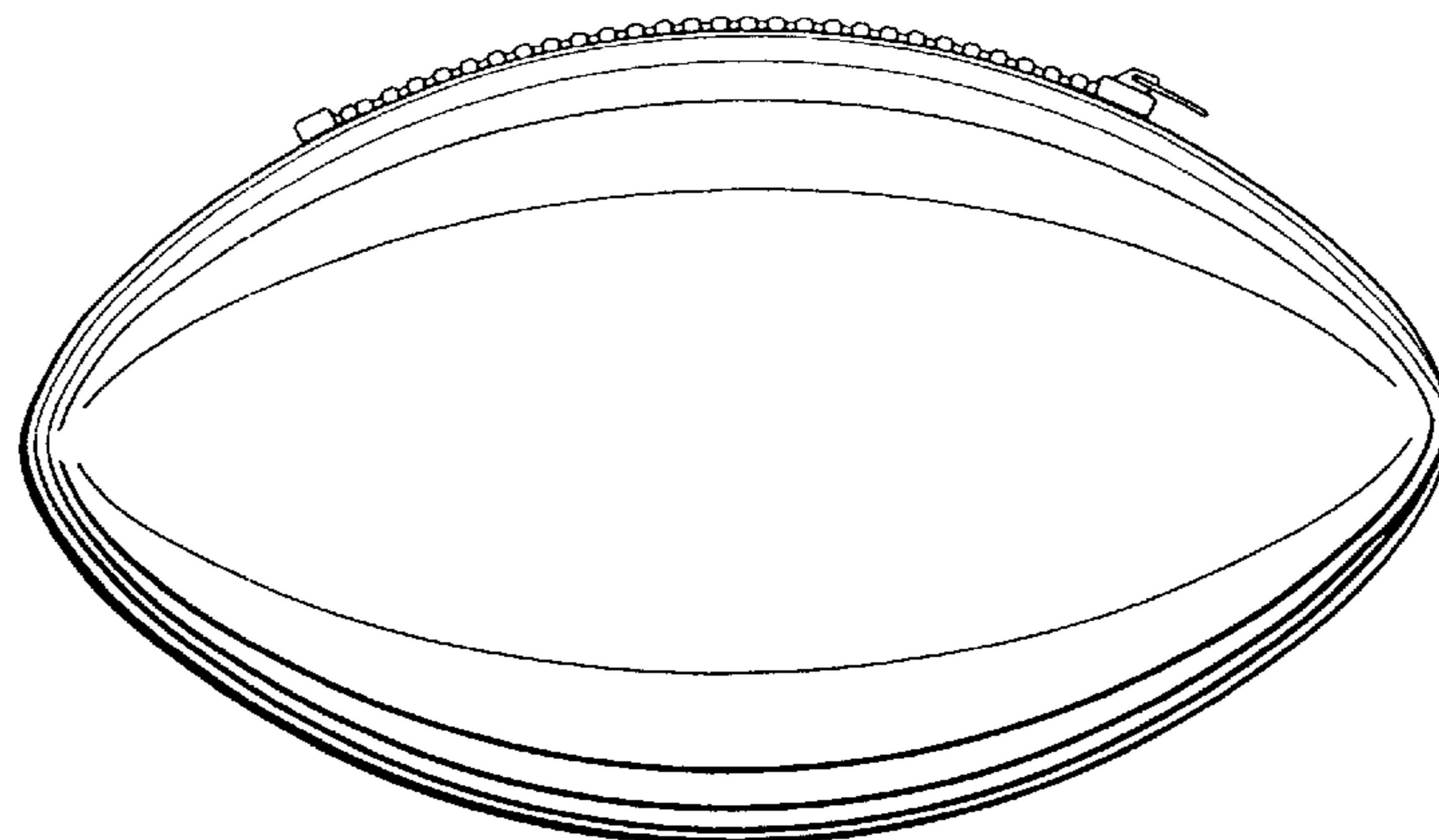

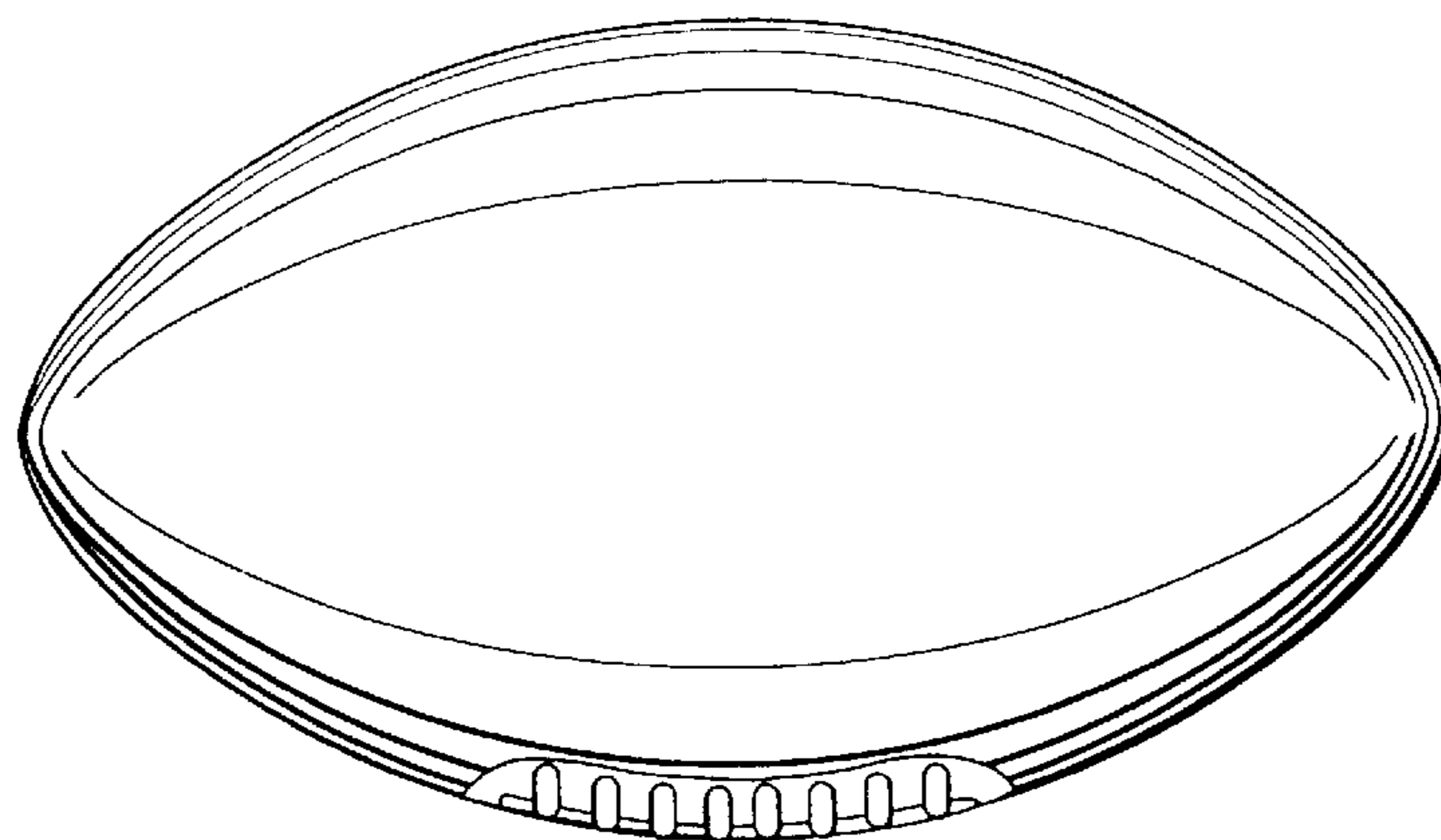
