(57) **CLAIM**

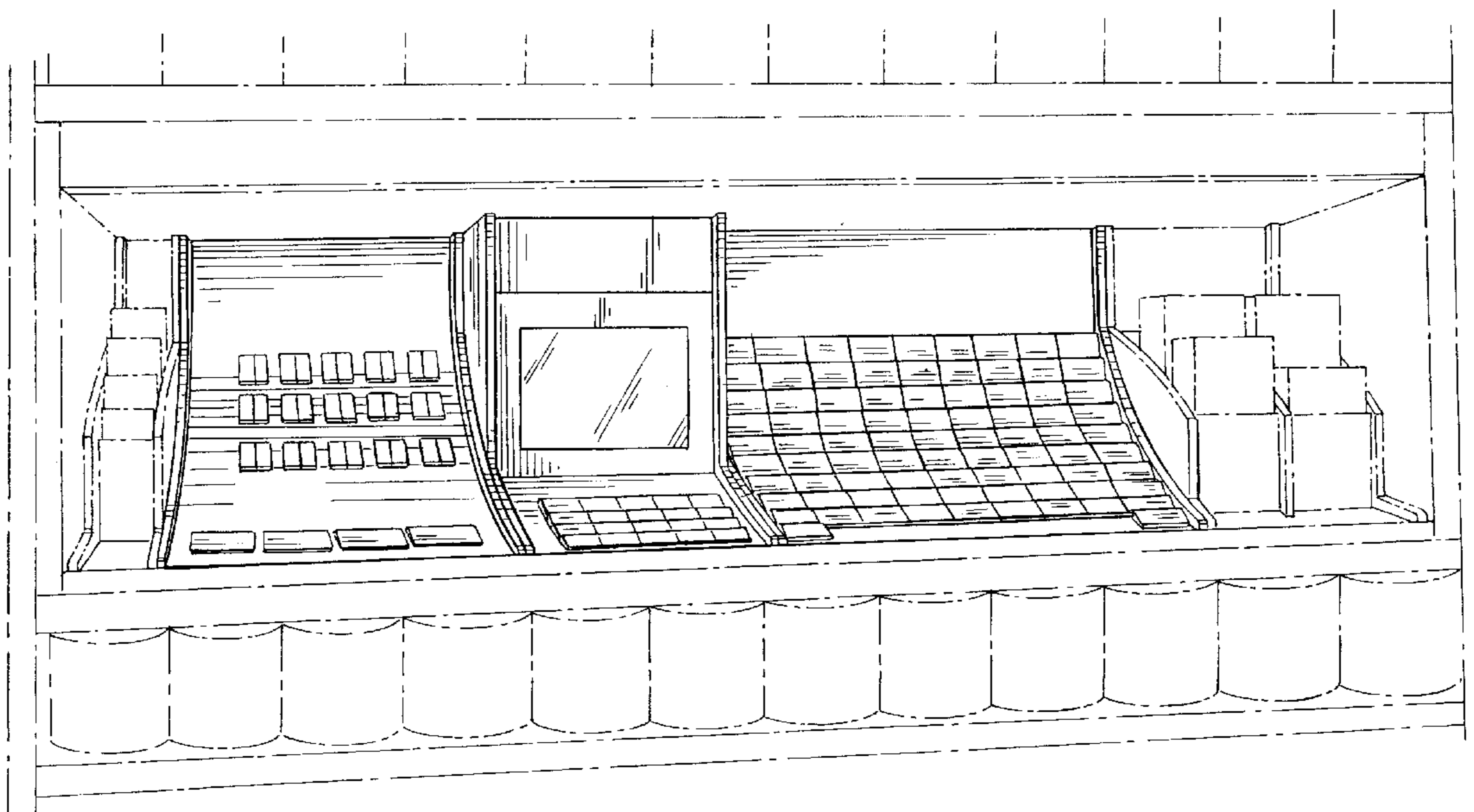
We claim the ornamental design for a wood treatment center display, as shown and described.

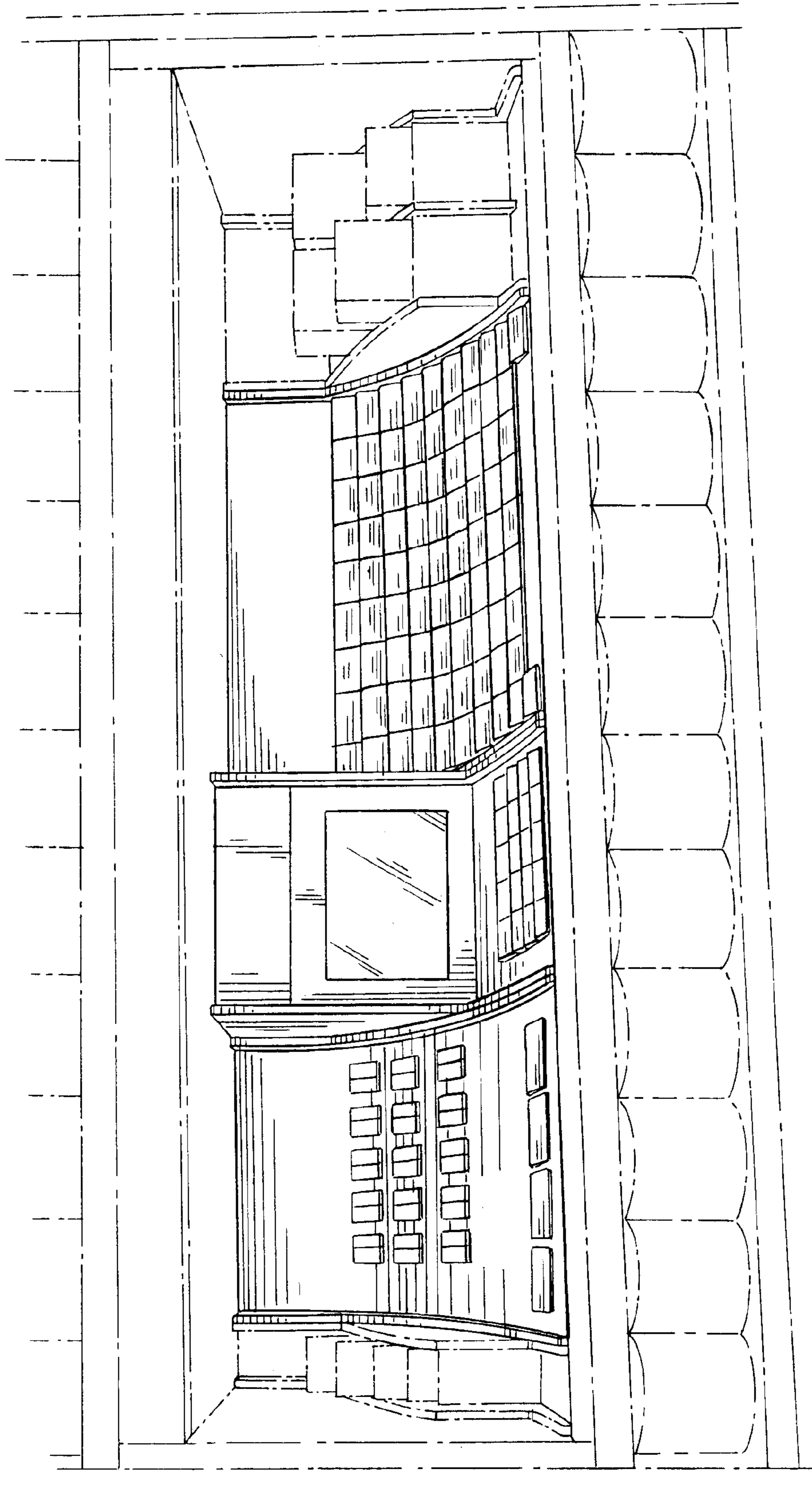

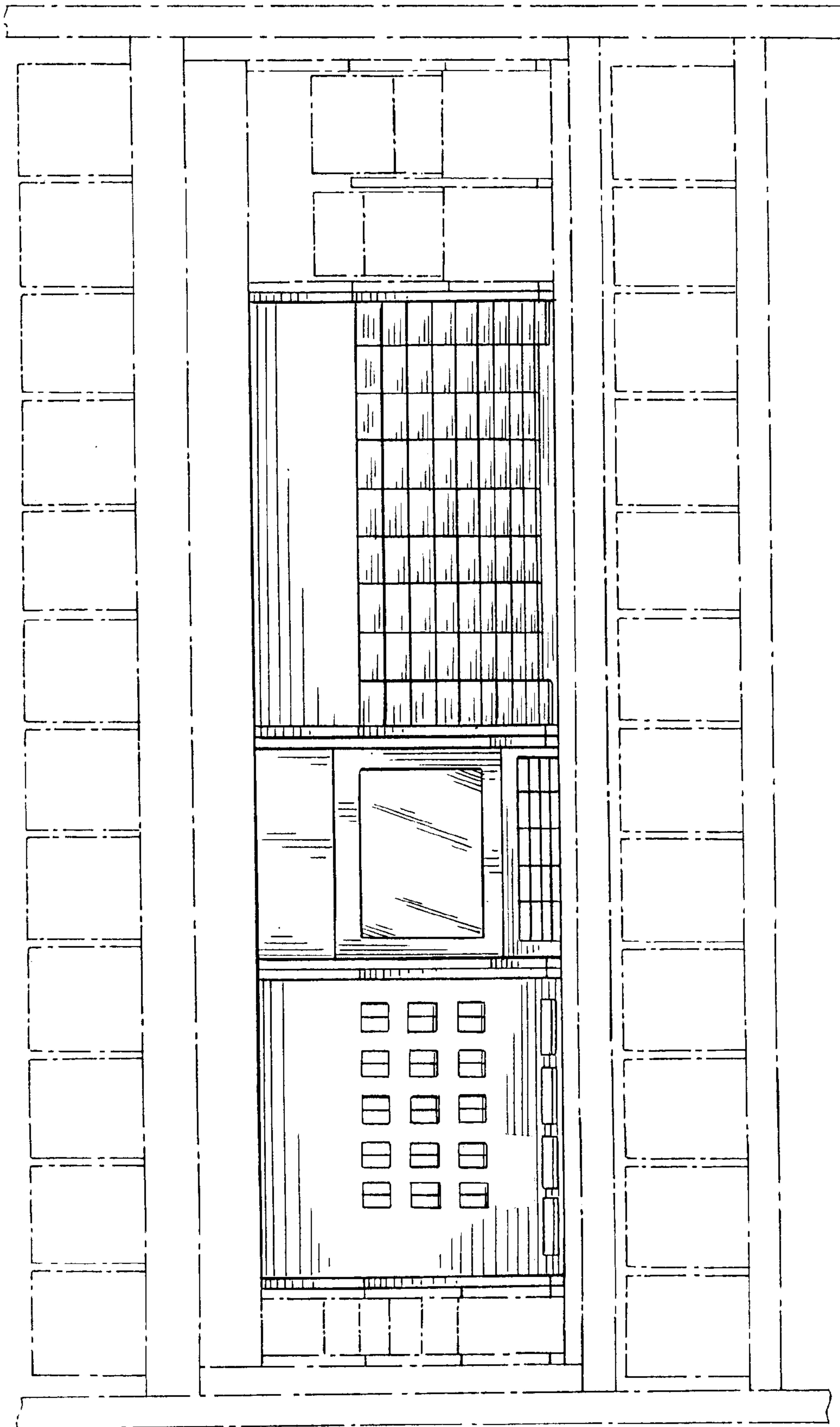
