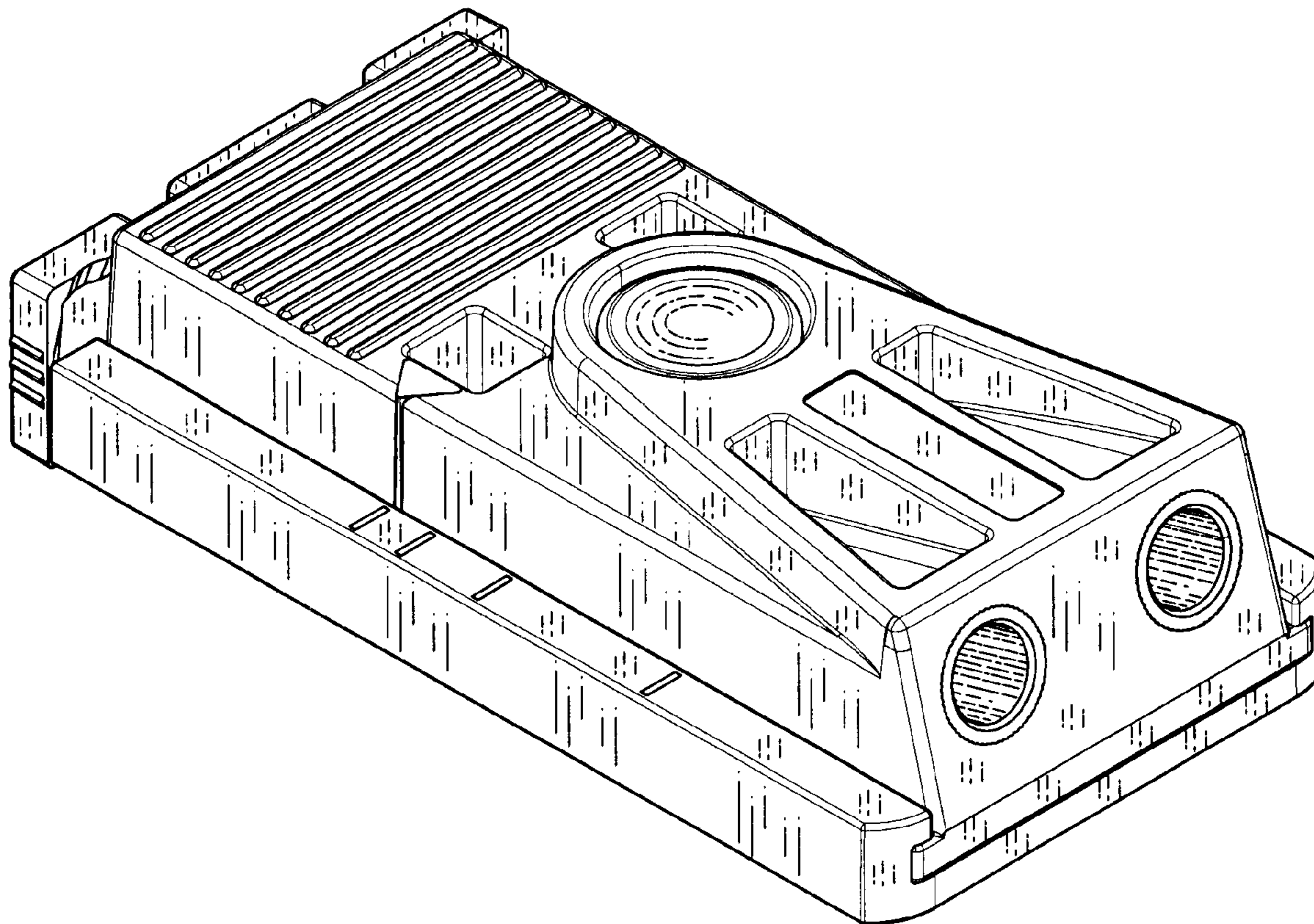
(57) **CLAIM**

The ornamental design for a pocket jig, as shown and described.

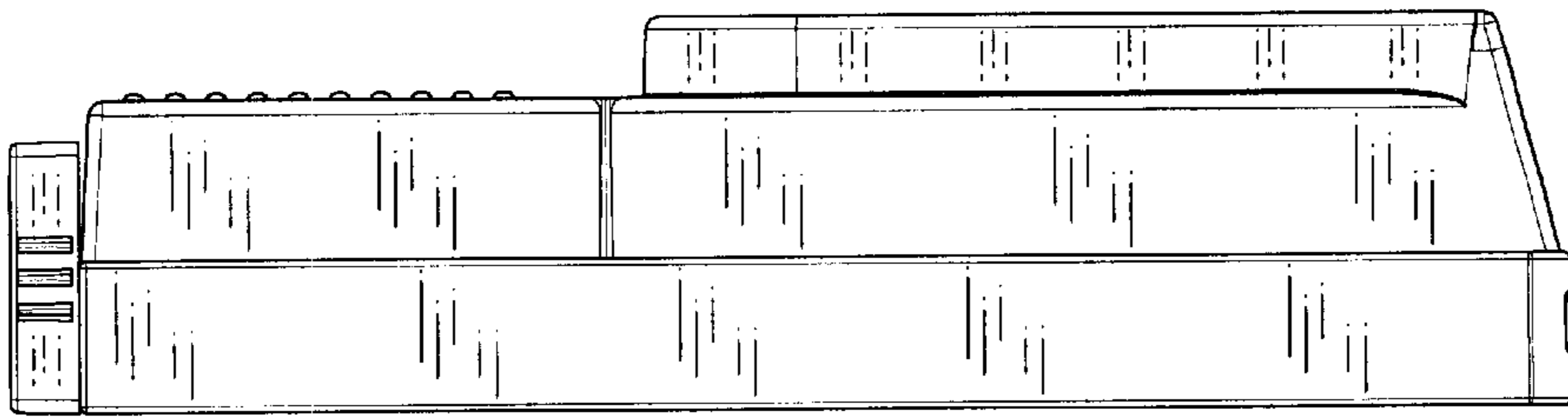
**DESCRIPTION**

FIG. 1 is a front view of a pocket jig of the claimed design. FIG. 2 is a left side view of the pocket jig of FIG. 1. FIG. 3 is a back side view of the pocket jig of FIG. 1. FIG. 4 is a right side view of the pocket jig of FIG. 1. FIG. 5 is a top view of the pocket jig of FIG. 1. 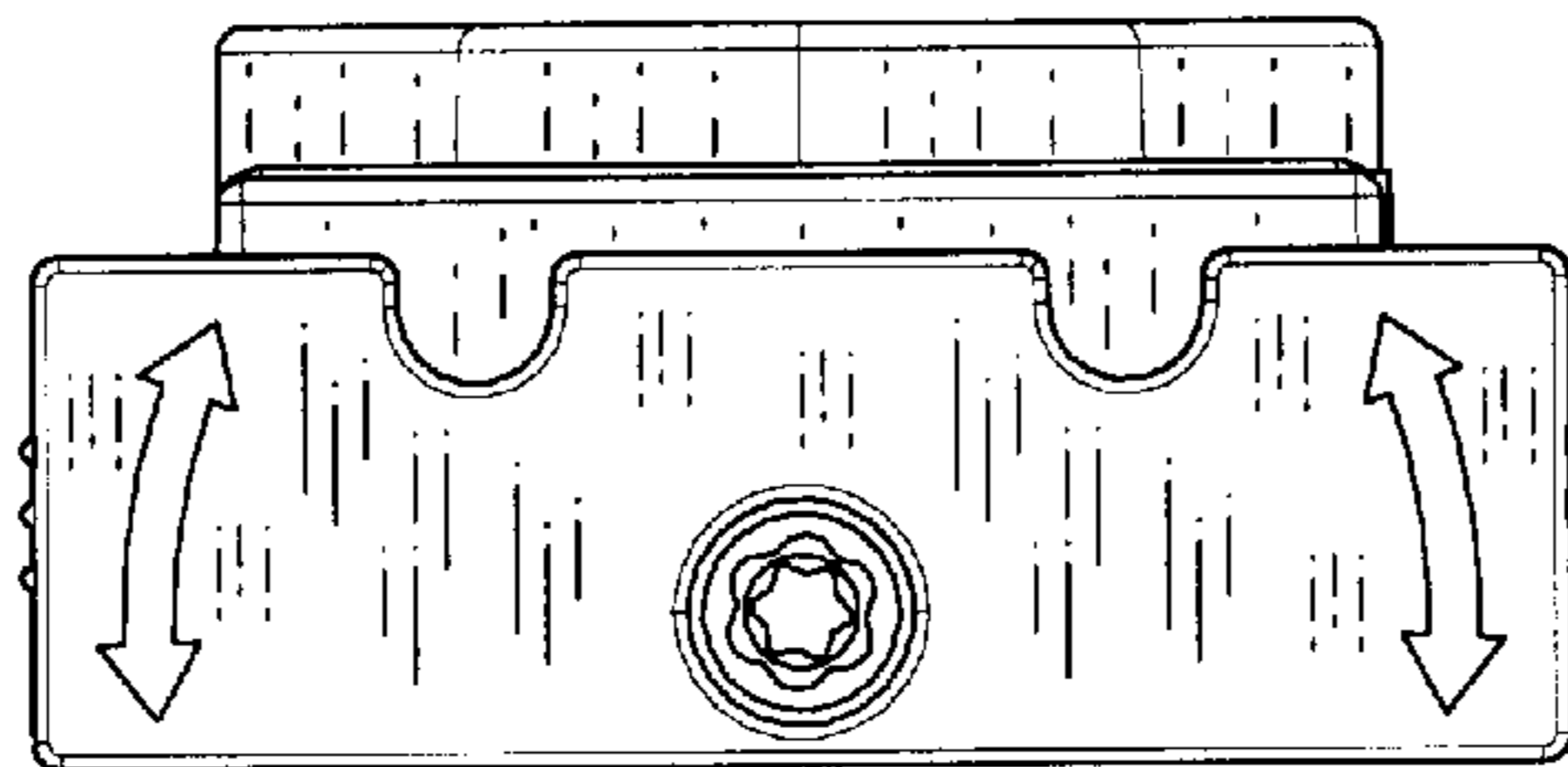

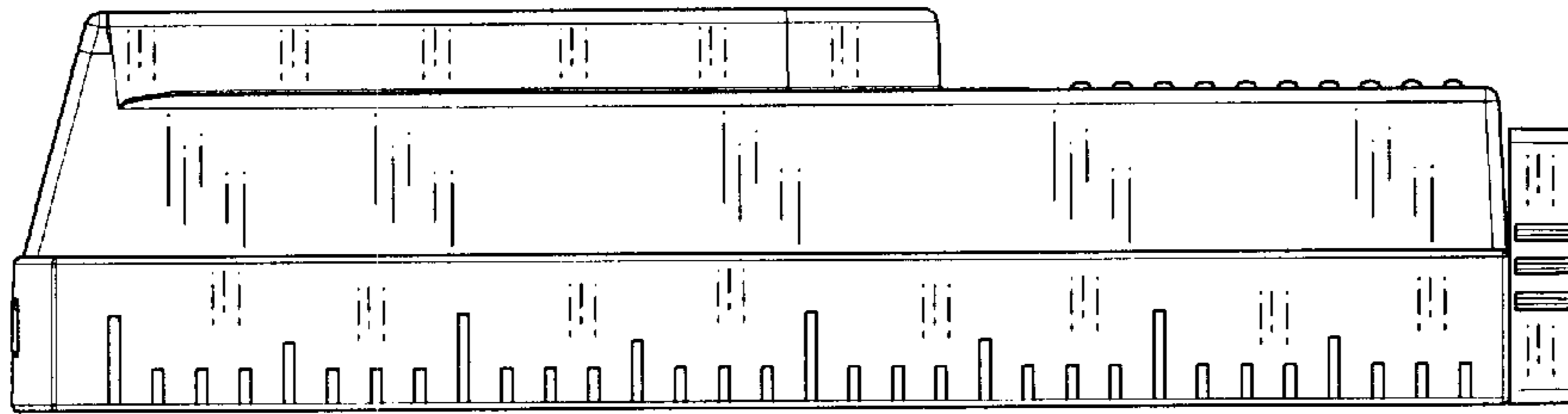

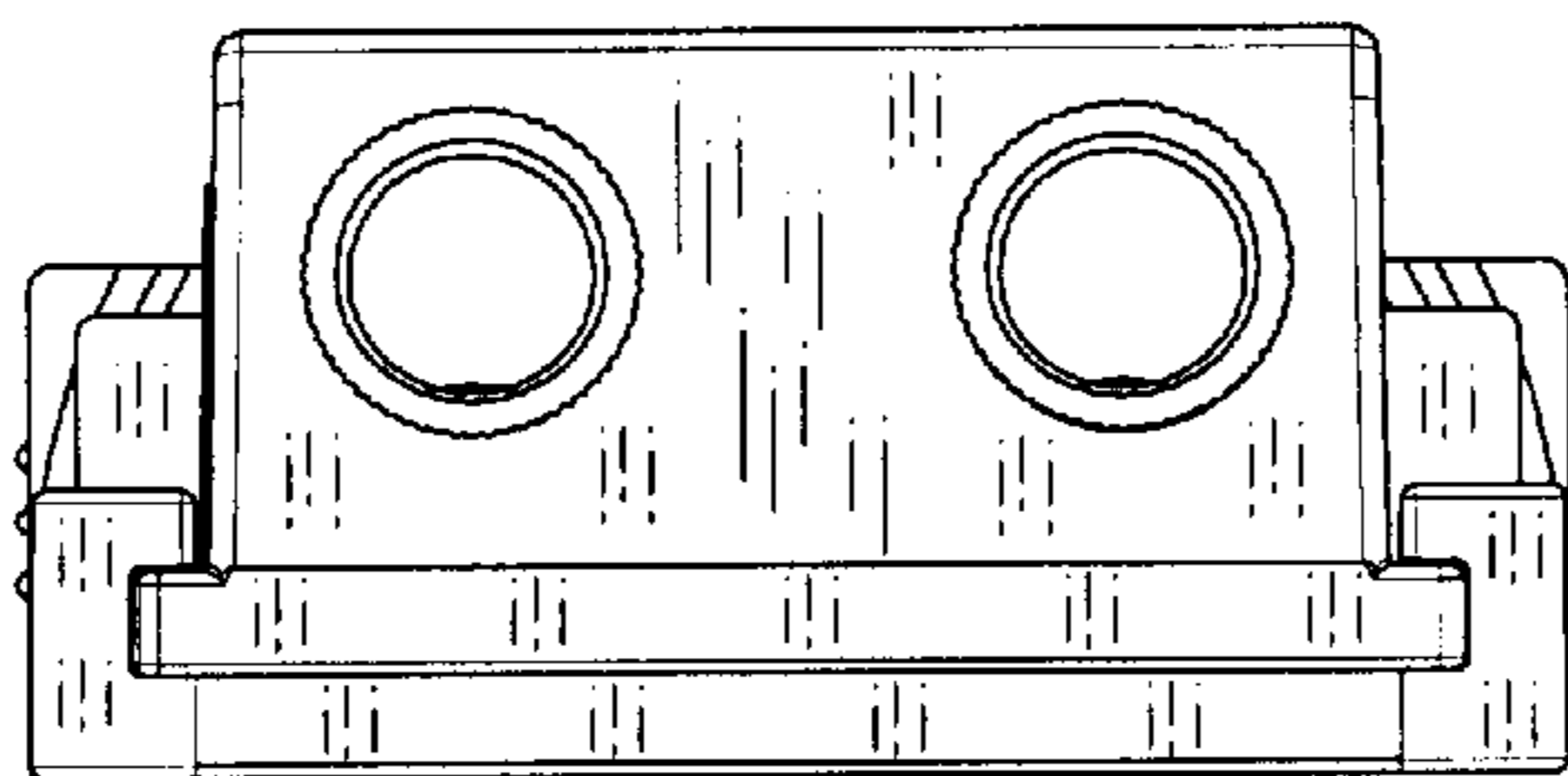

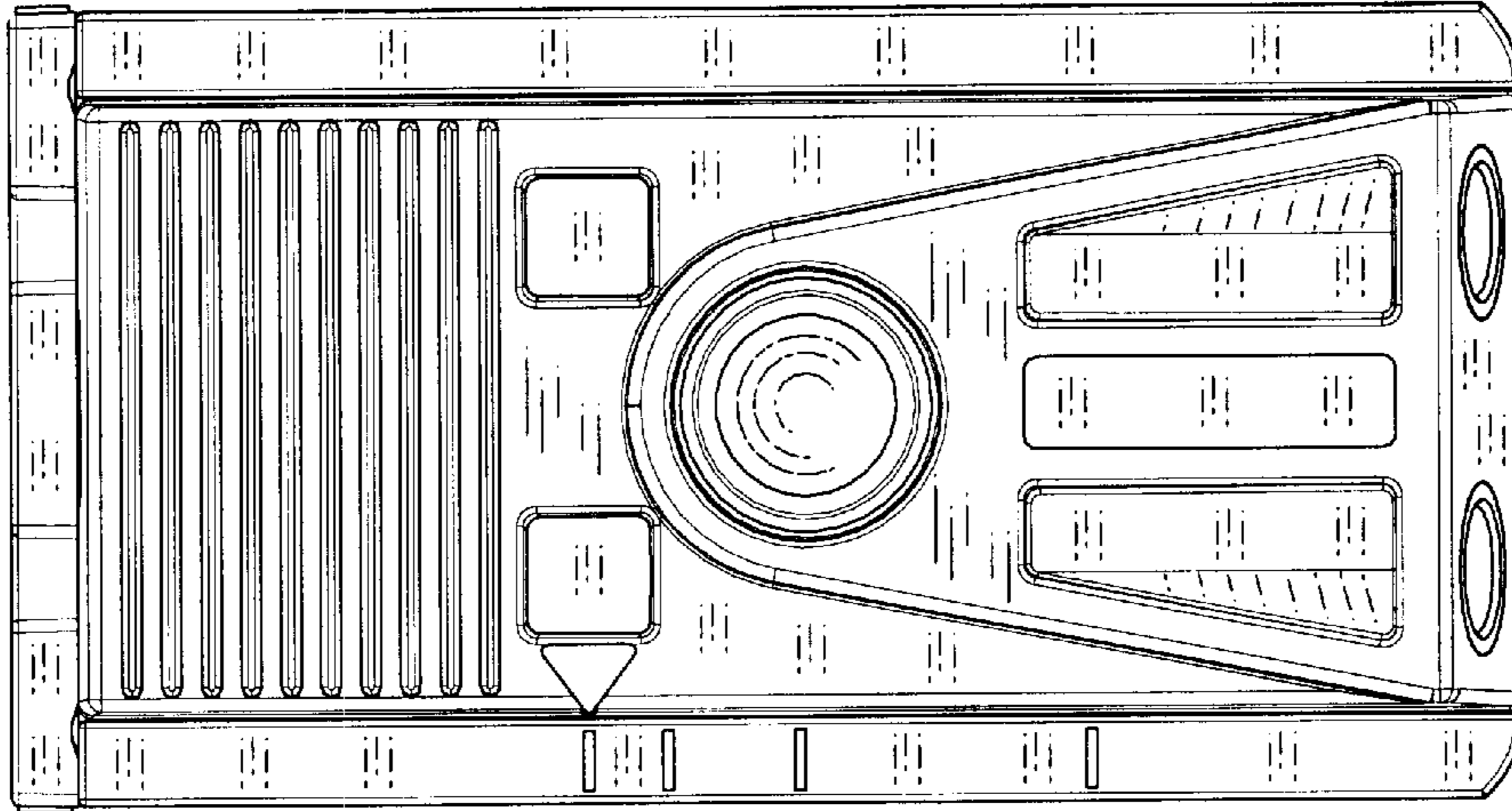

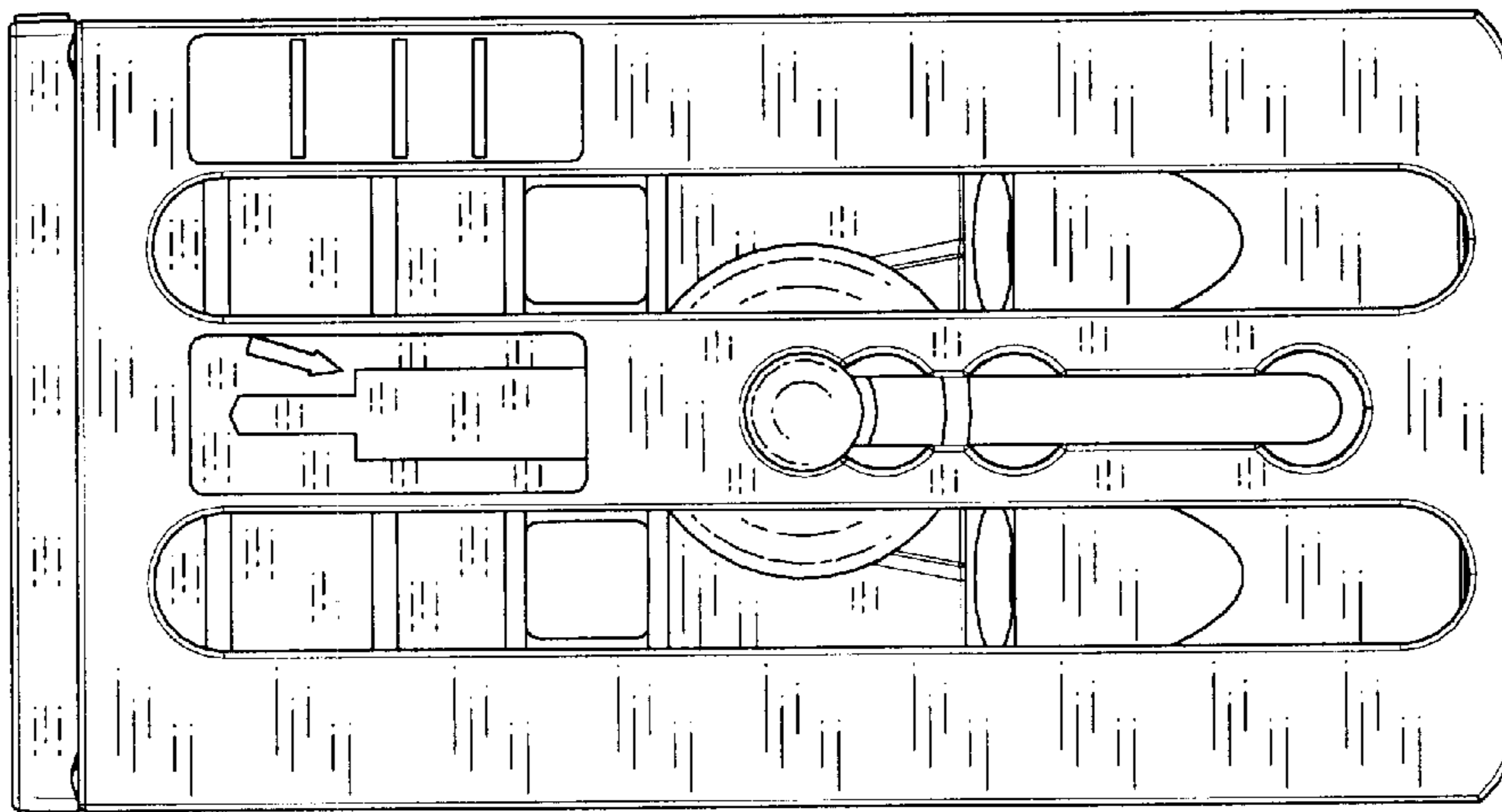
