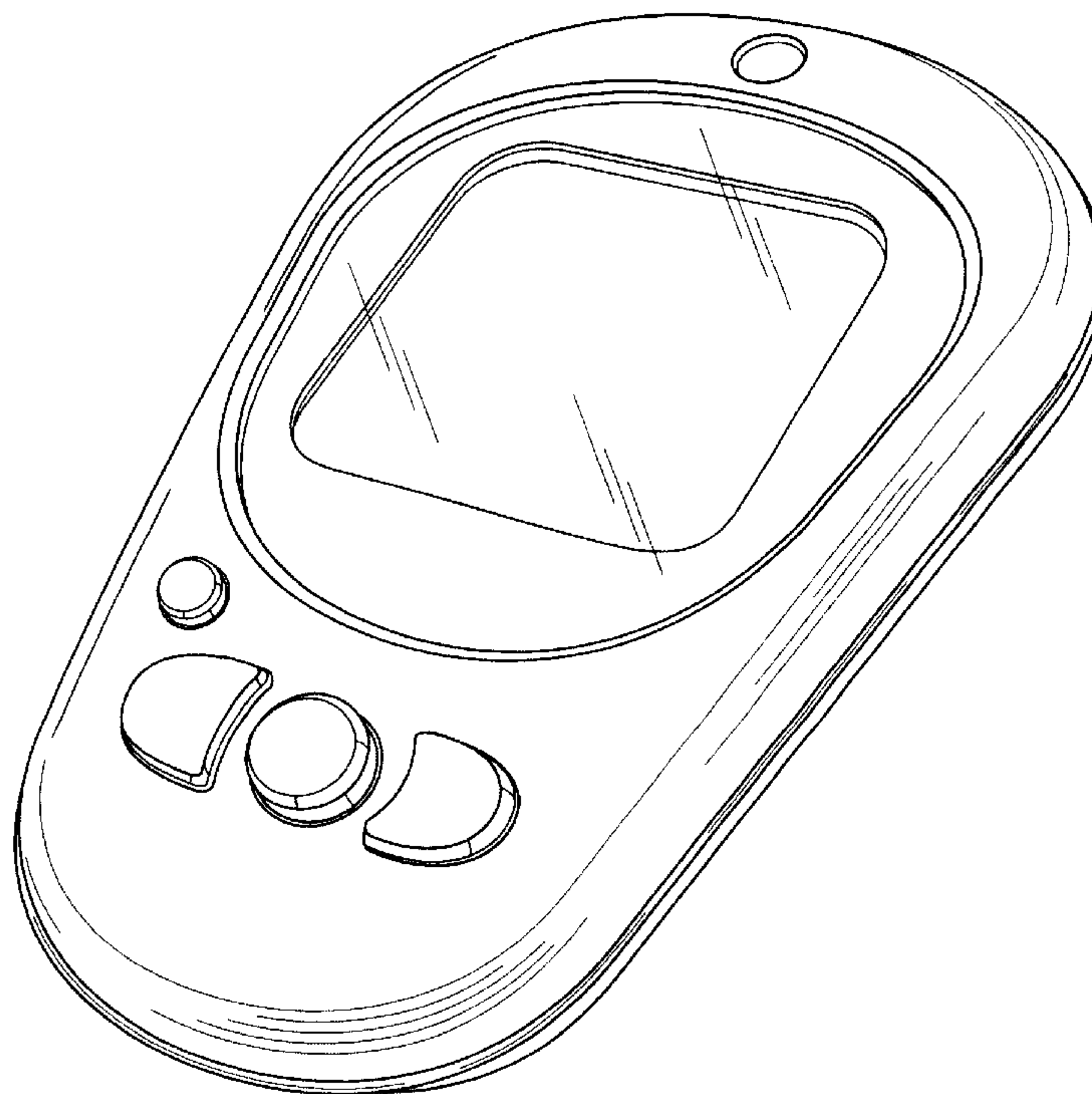
(57) **CLAIM**

The ornamental design for a UV meter, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the UV meter;  
FIG. 2 is a bottom elevation view of the UV meter of FIG. 1;  
FIG. 3 is a top elevation view of the UV meter of FIG. 1;  
FIG. 4 is a right side elevation view of the UV meter of FIG. 1;  
FIG. 5 is a left side elevation view of the UV meter of FIG. 1;  
FIG. 6 is a front plan view of the UV meter of FIG. 1; and,  
FIG. 7 is a rear plan view of the UV meter of FIG. 1, wherein the broken lines show environmental context for illustrative purposes only and form no part of the claimed design or a specified embodiment thereof.

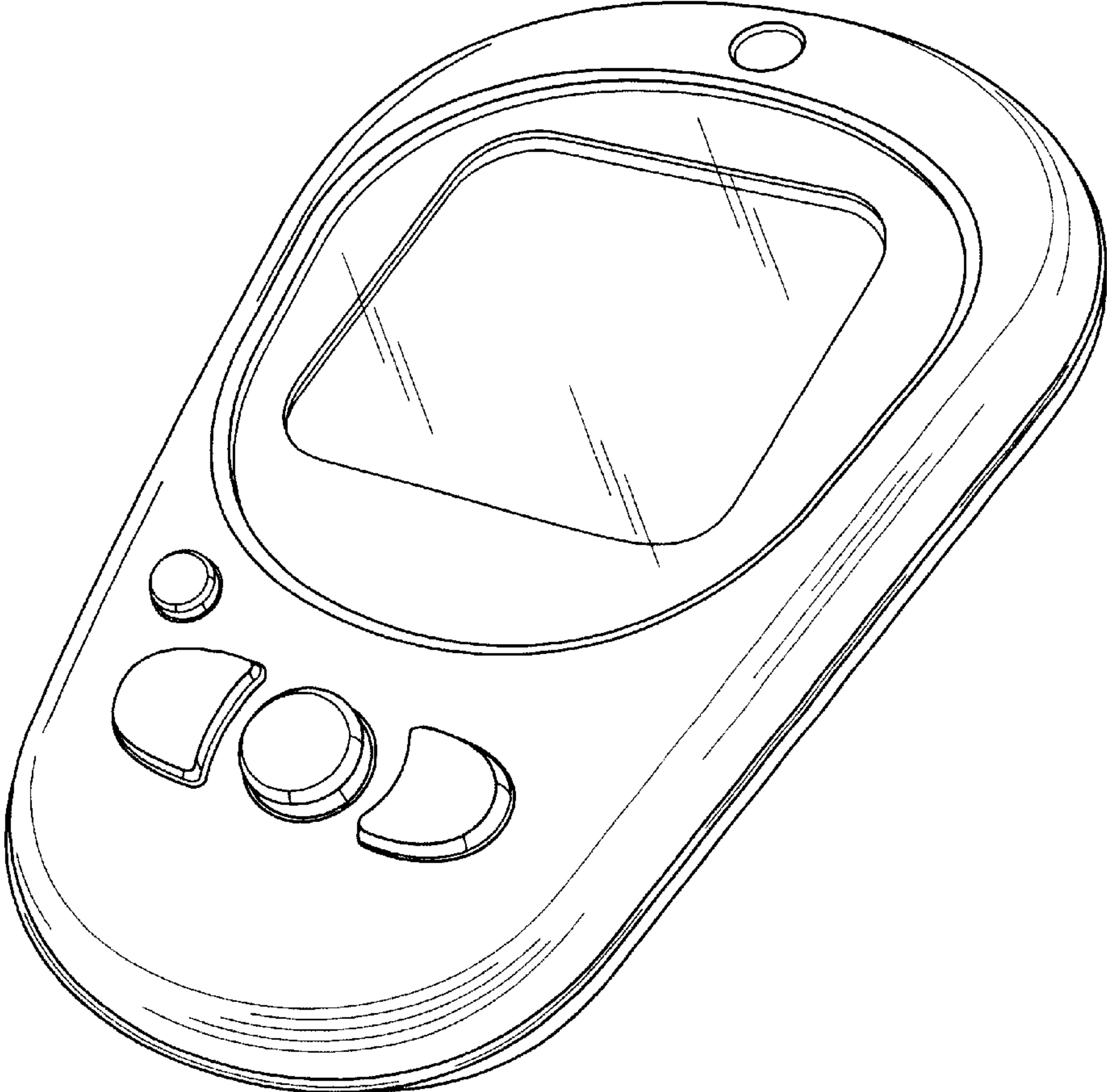

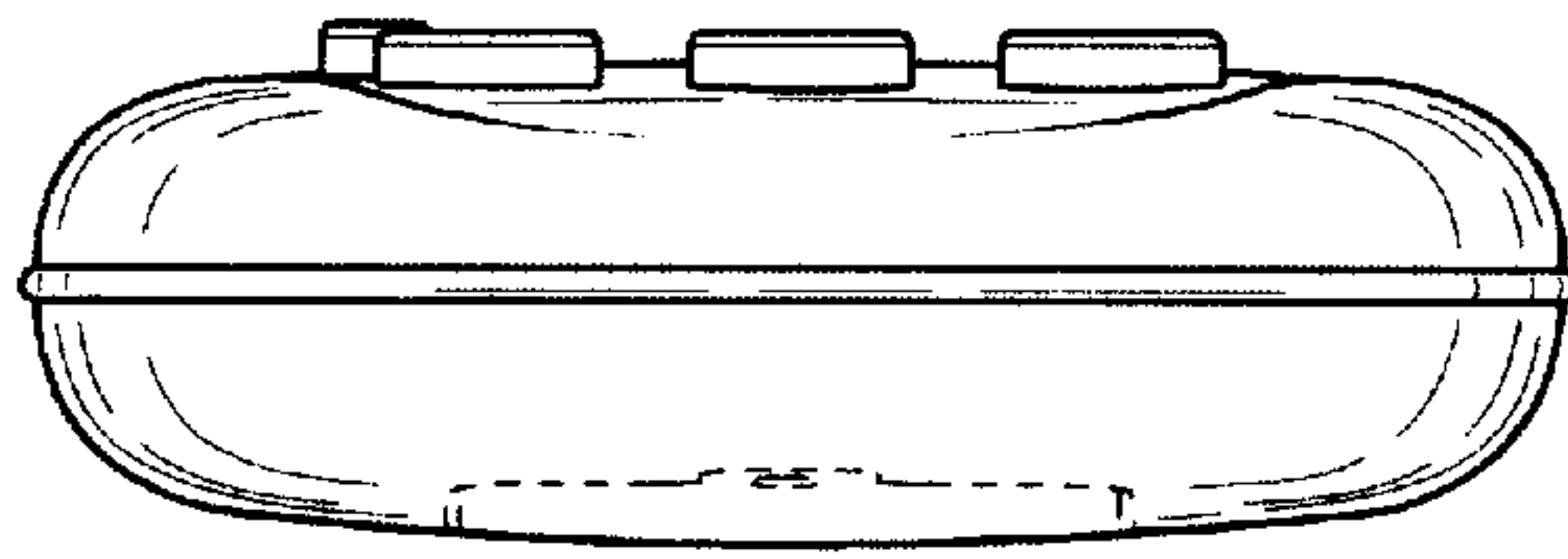

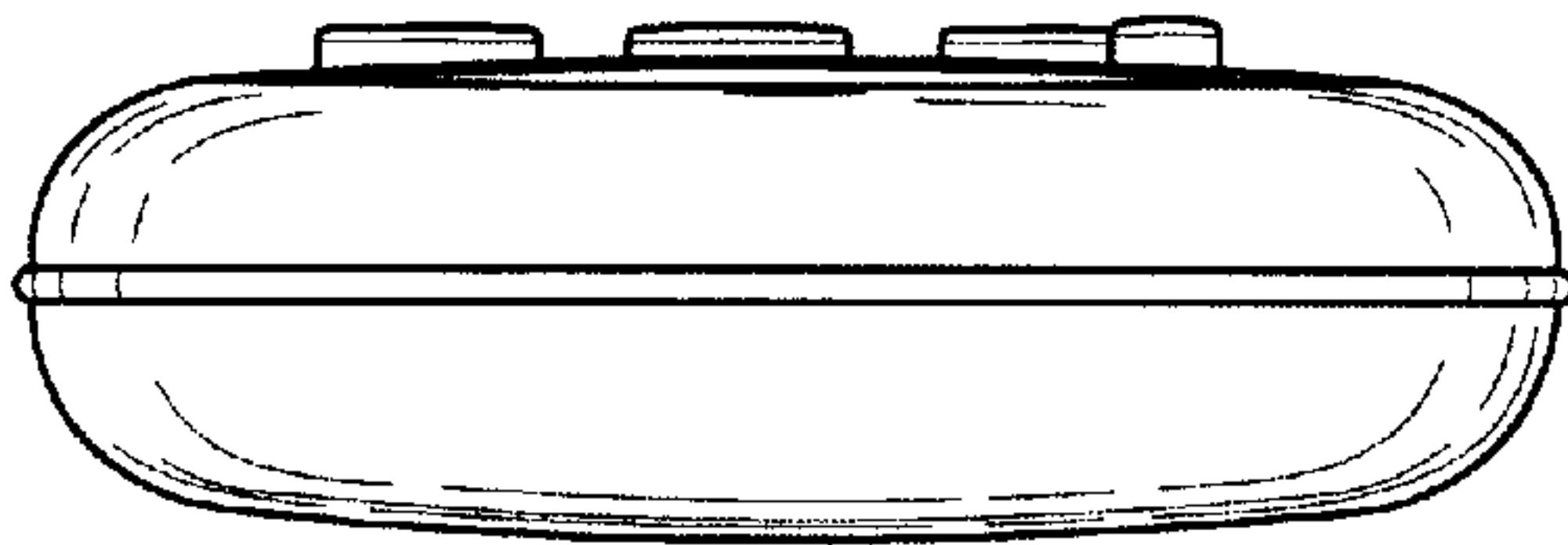

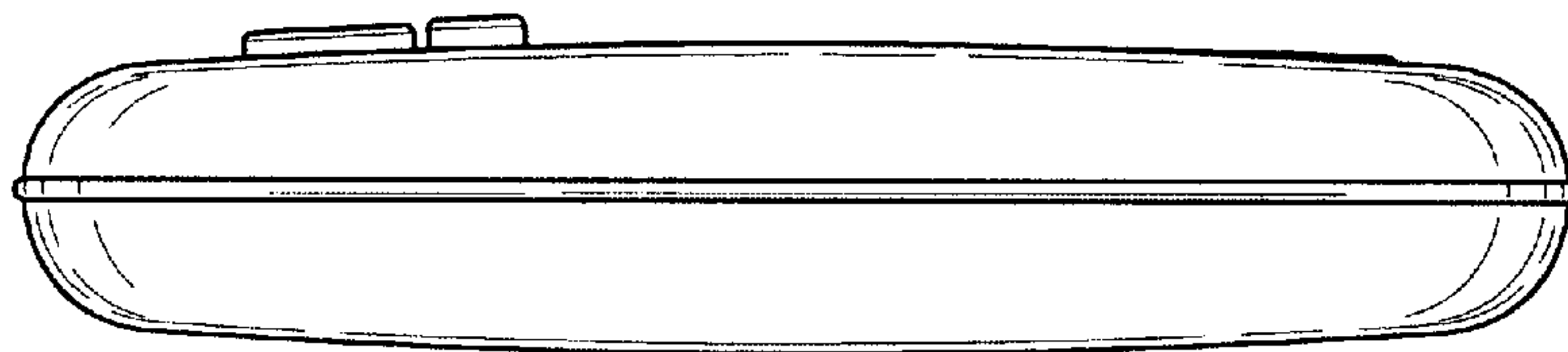

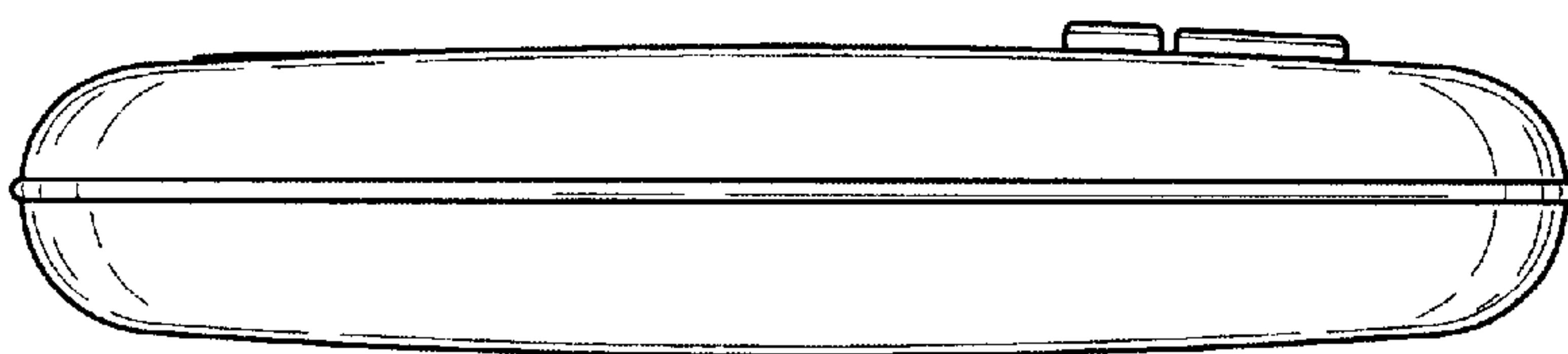

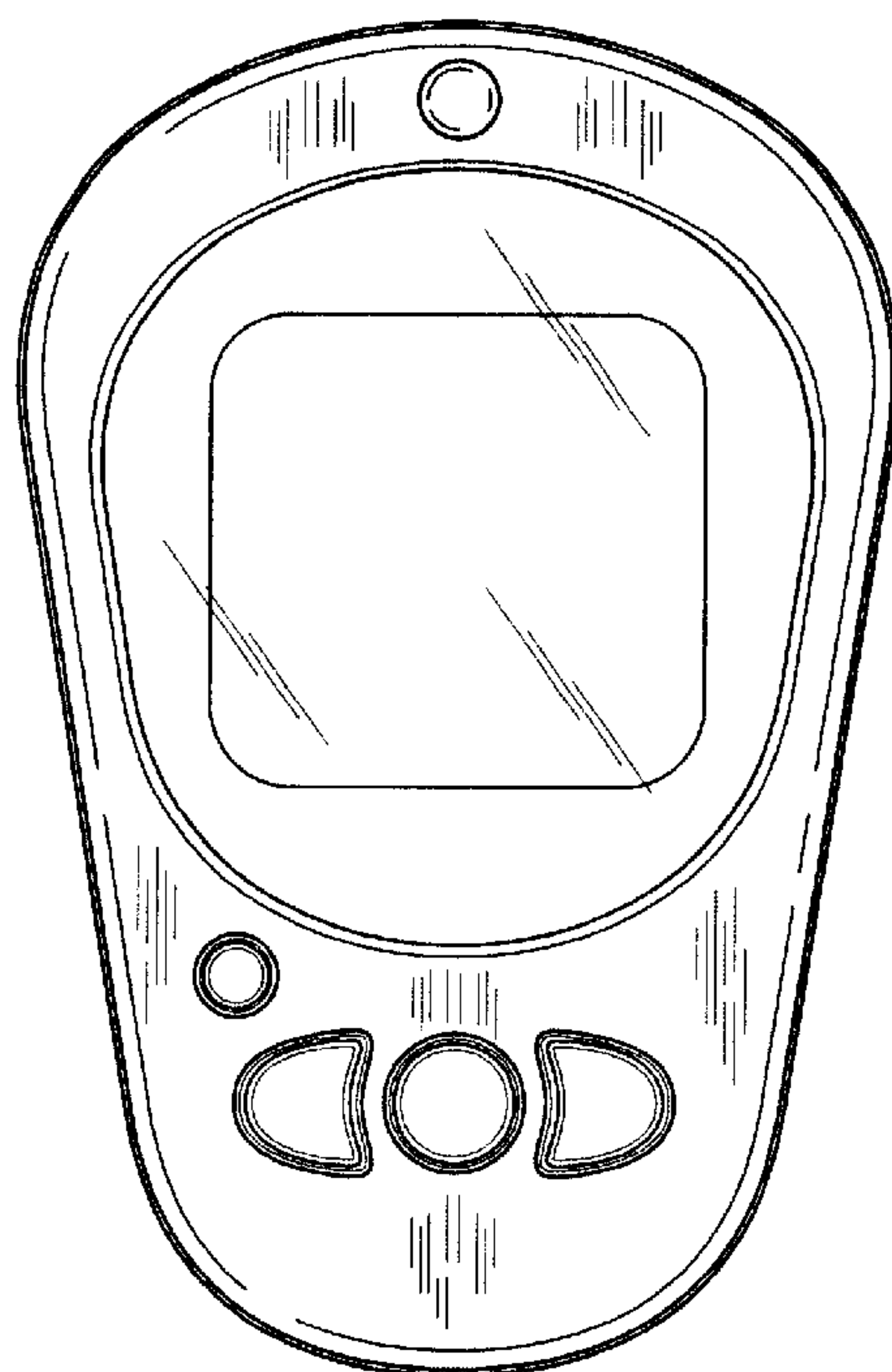

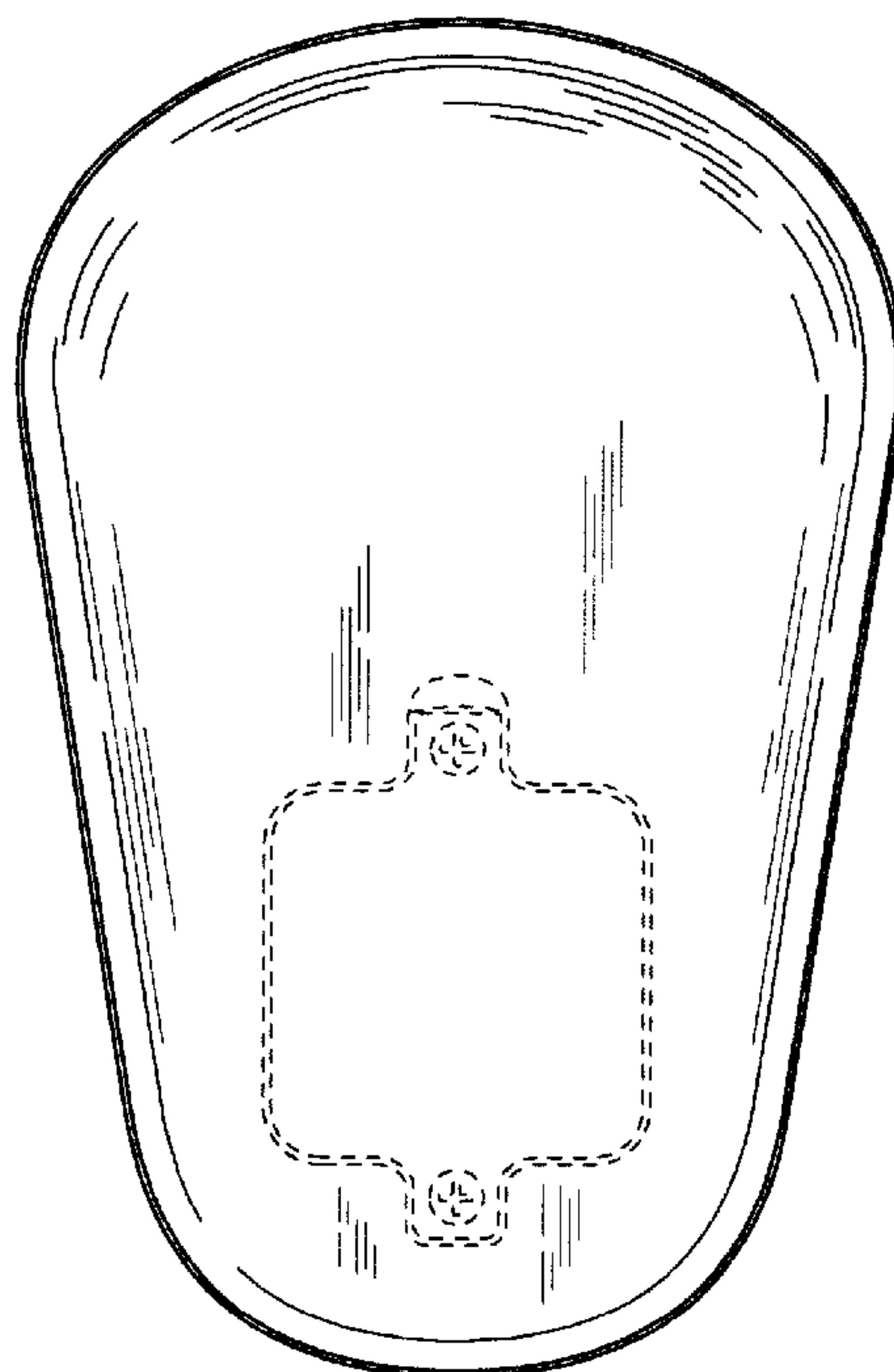
