FIG. 4 is a left side view thereof, when closed;

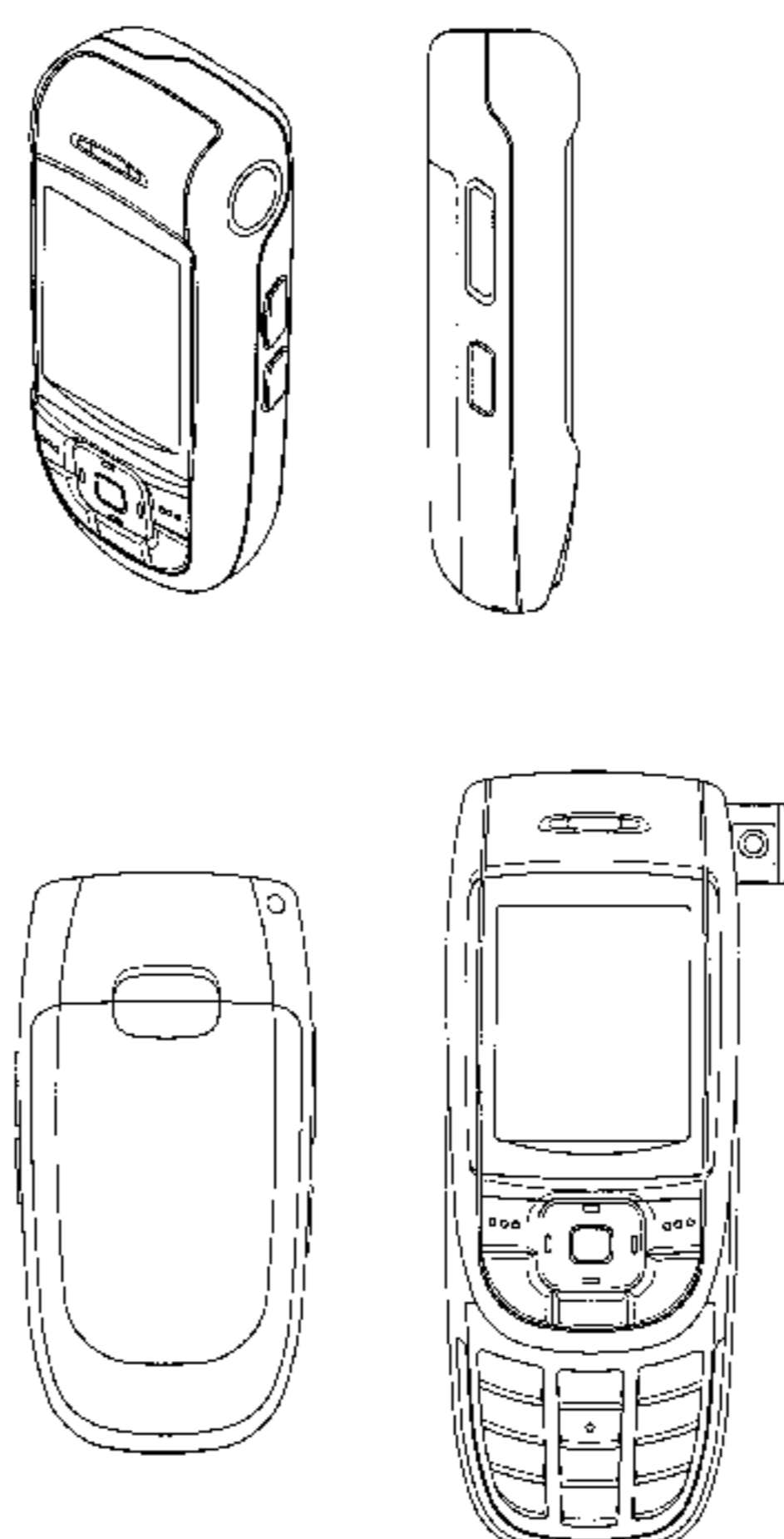
FIG. 5 is a right side view thereof, when closed;

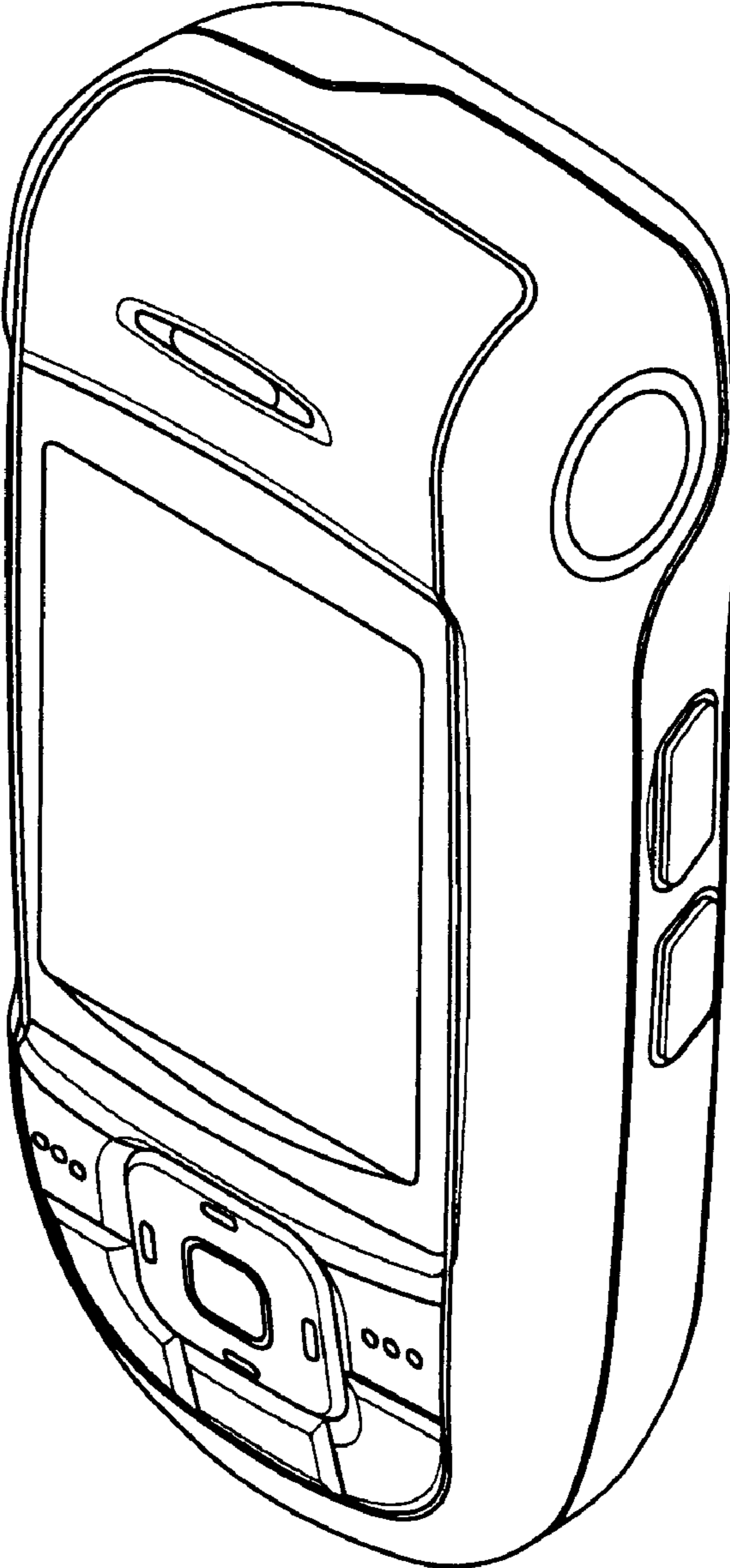

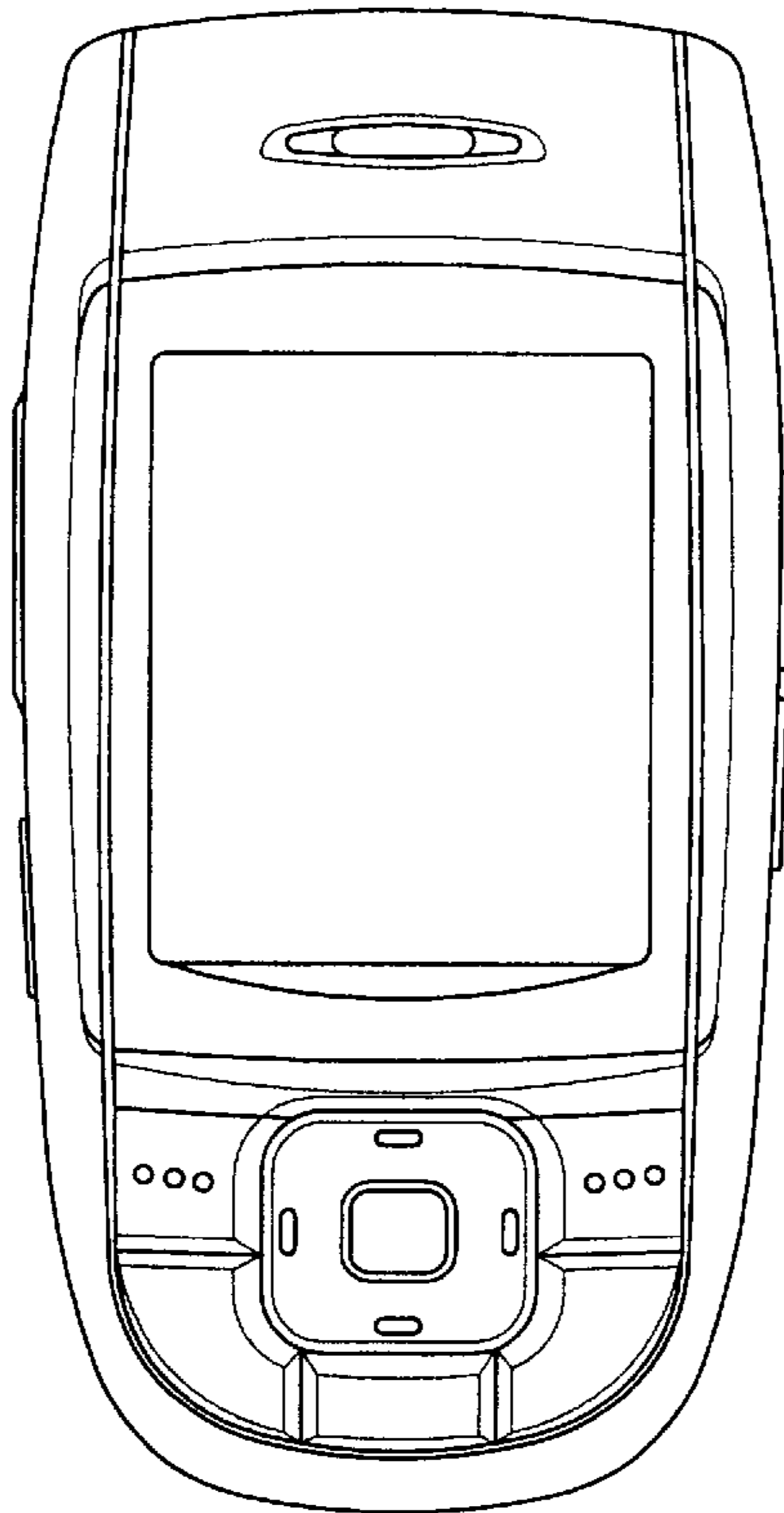

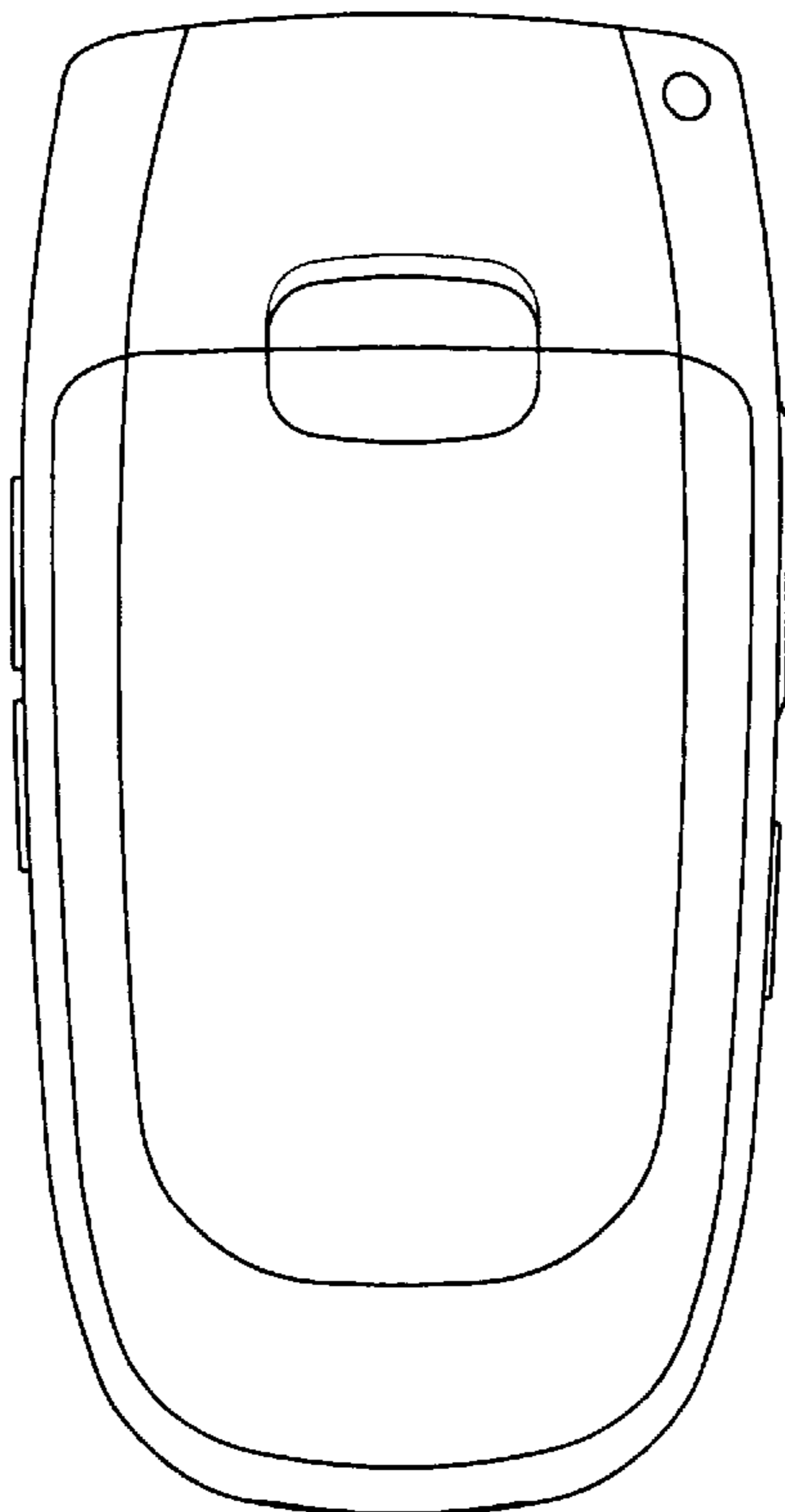

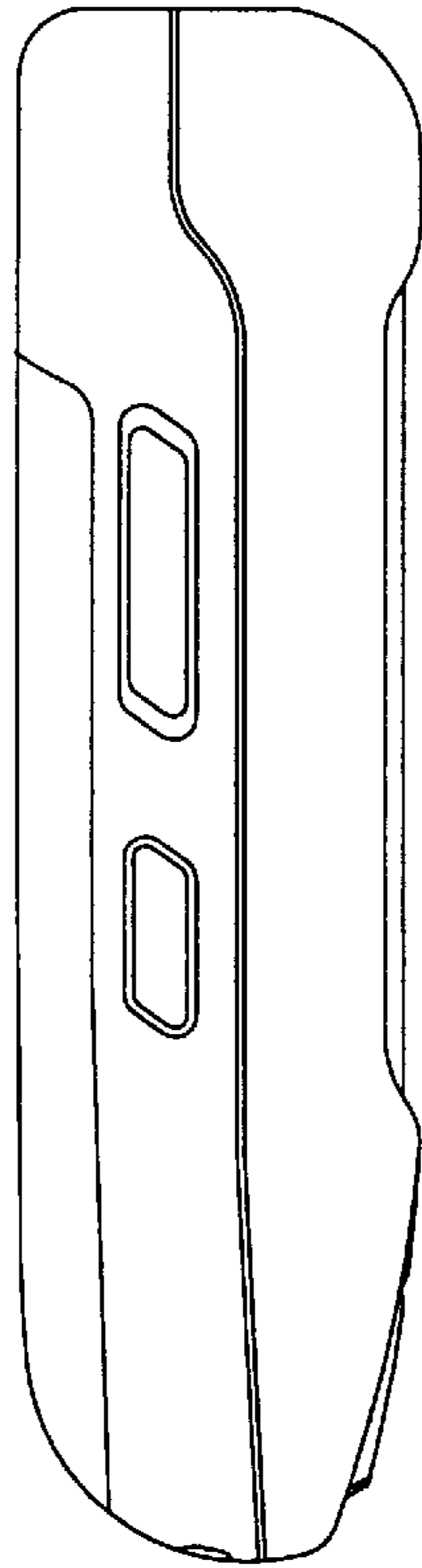

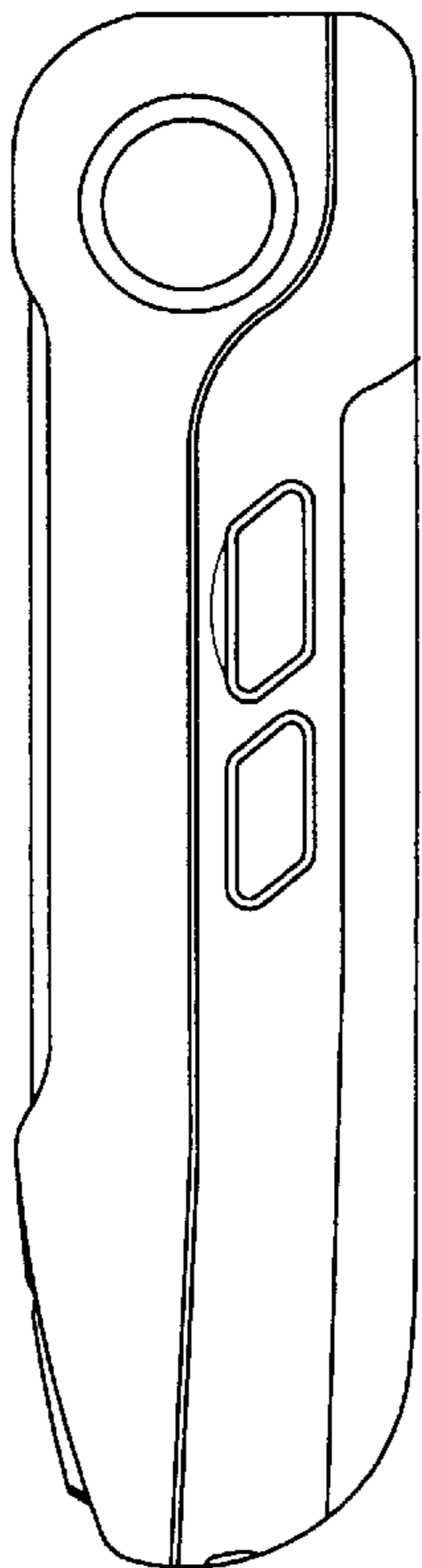

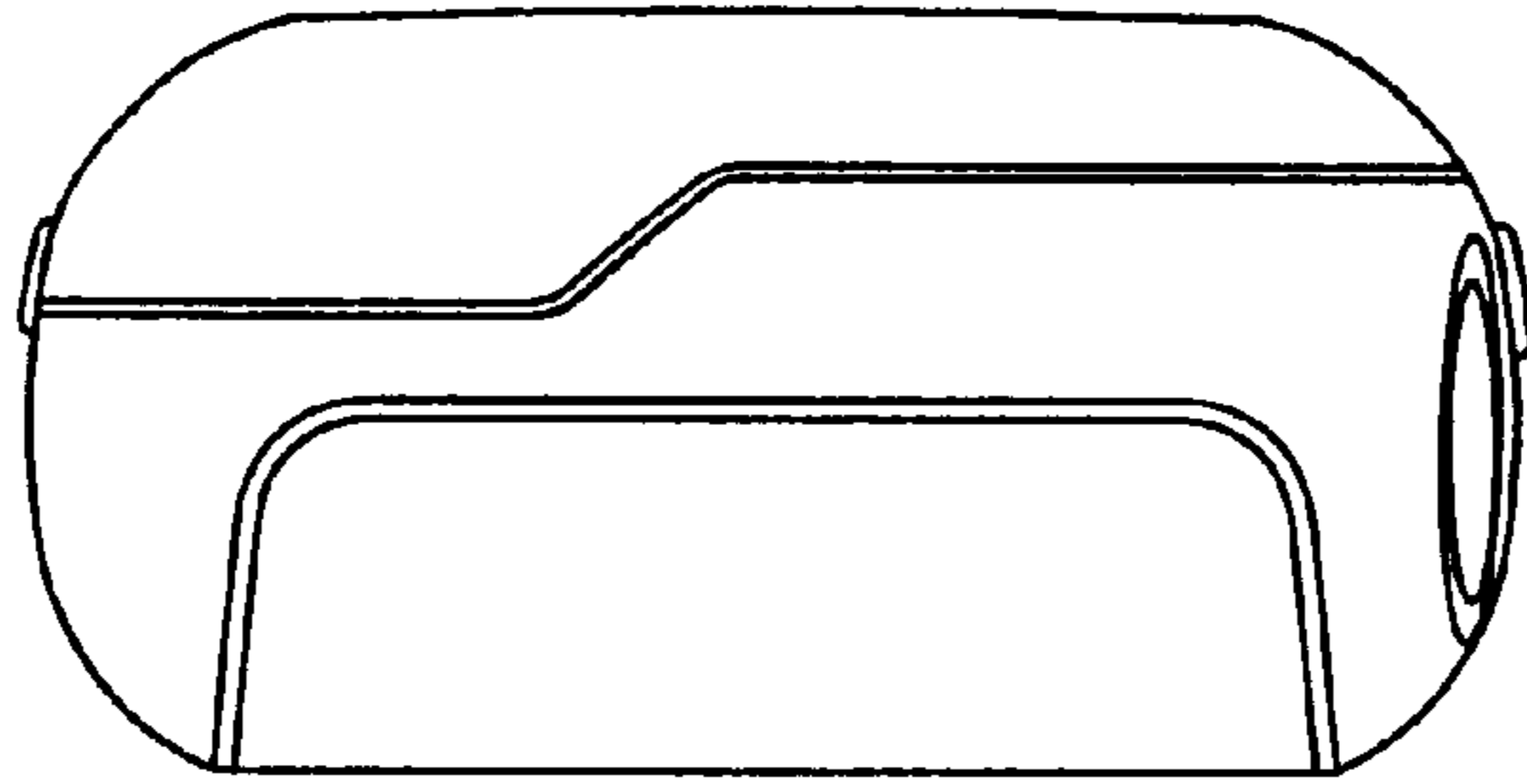

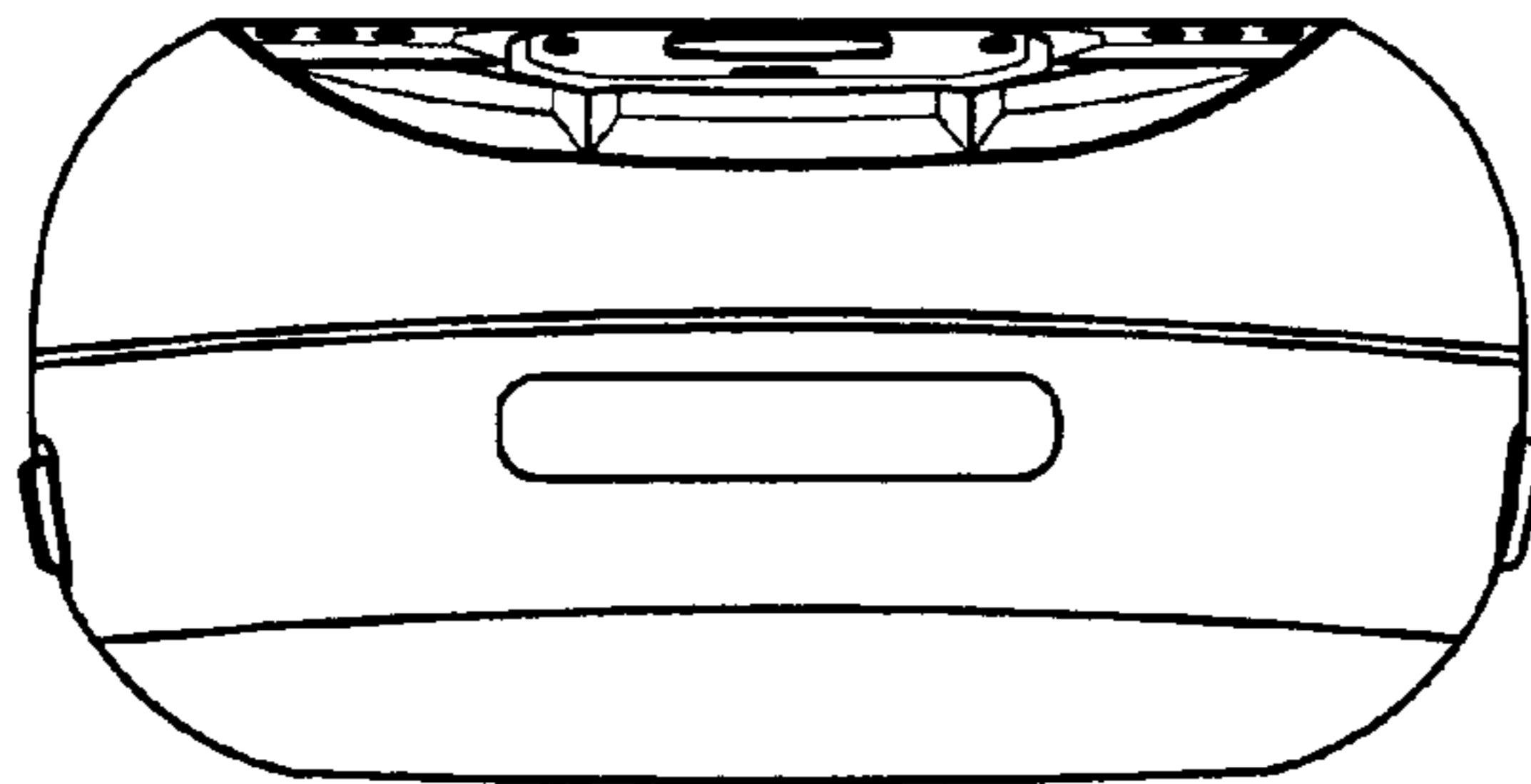
