I claim the ornamental design for a key button arrangement for a handset as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a keybutton arrangement for a handset showing my new design in an environment of disclaimed a disclaimed handset;

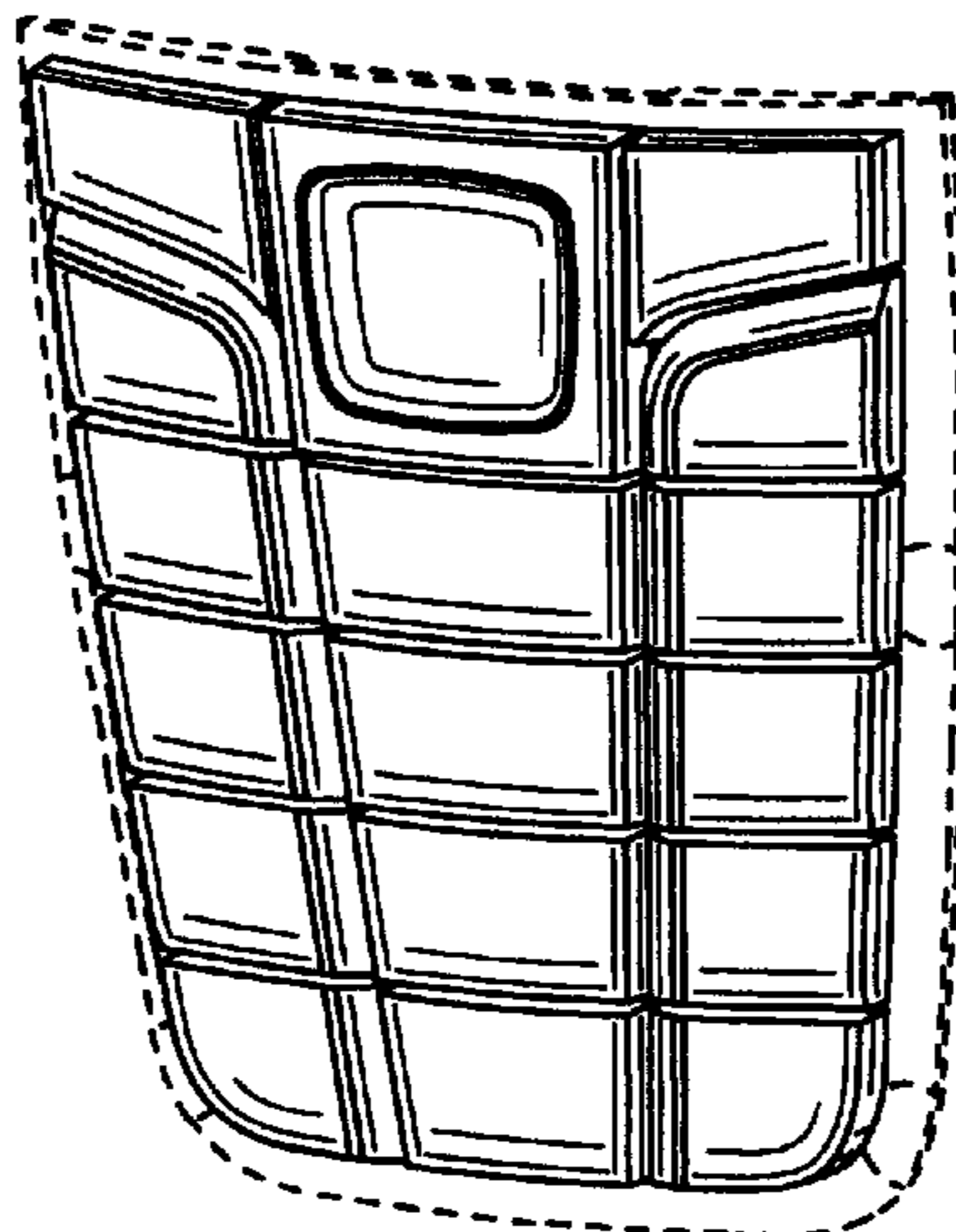
FIG. 2 is a front perspective view thereof;

FIG. 3 is a front view of a second embodiment of a key button arrangement for a handset showing my new design in an environment of a disclaimed key mat; and

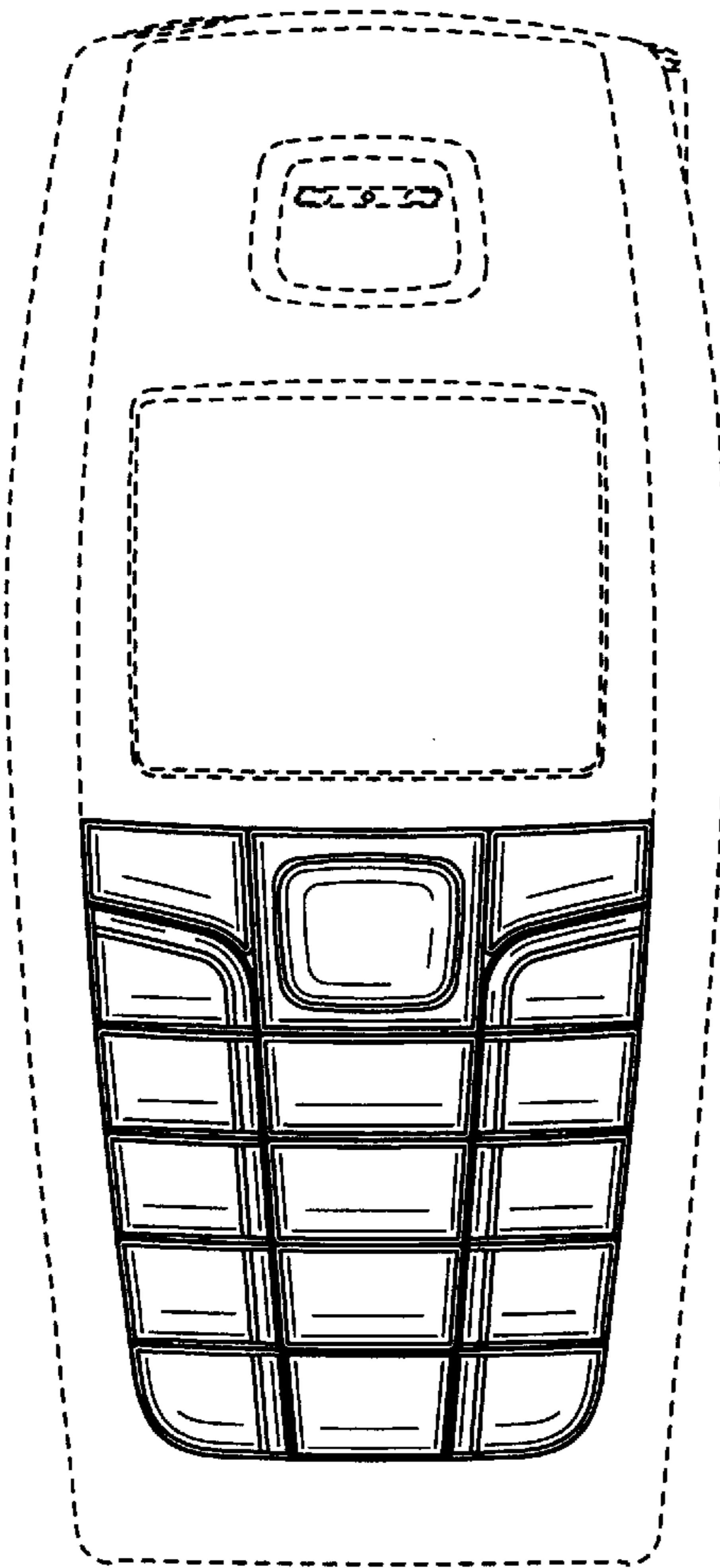

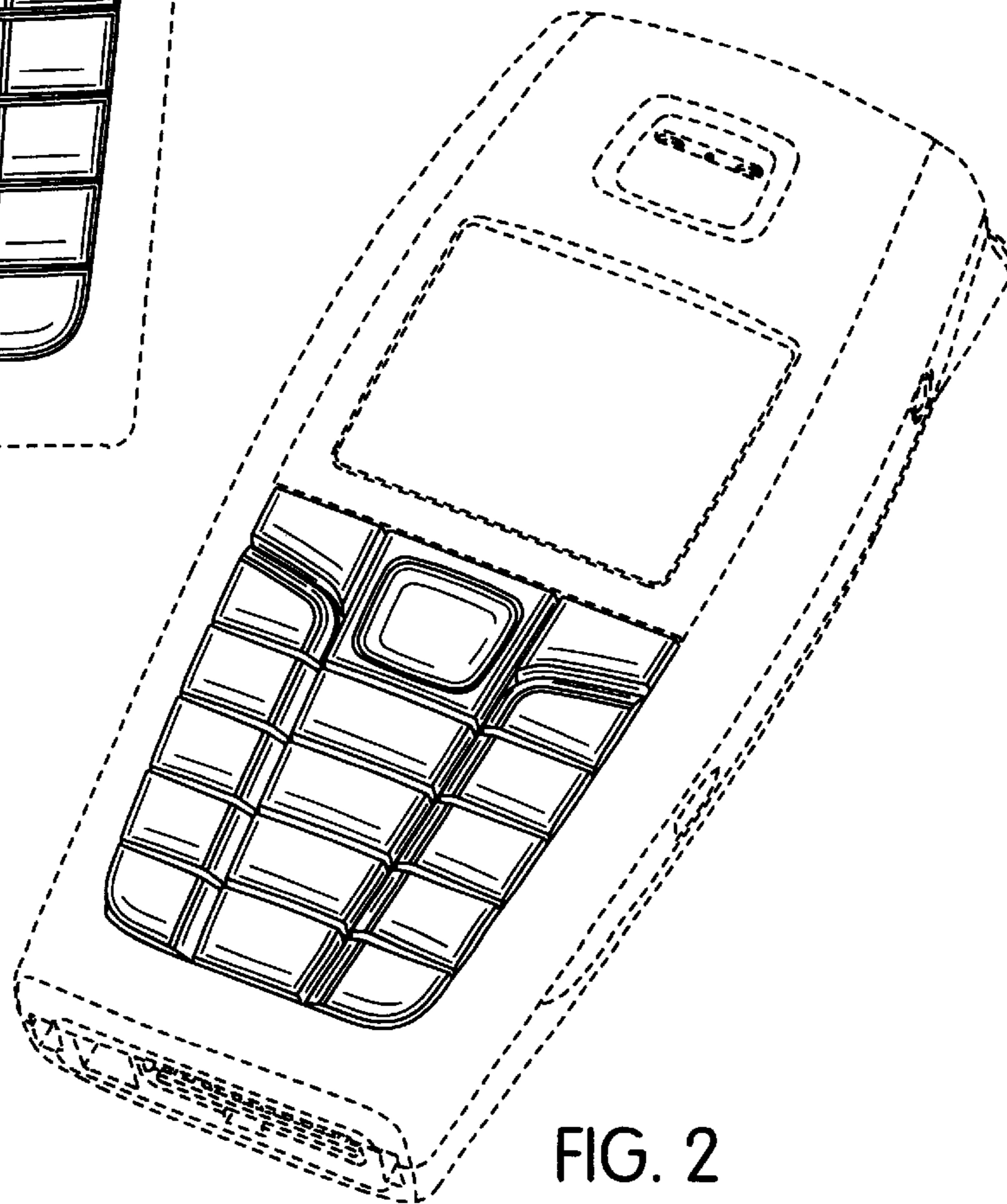

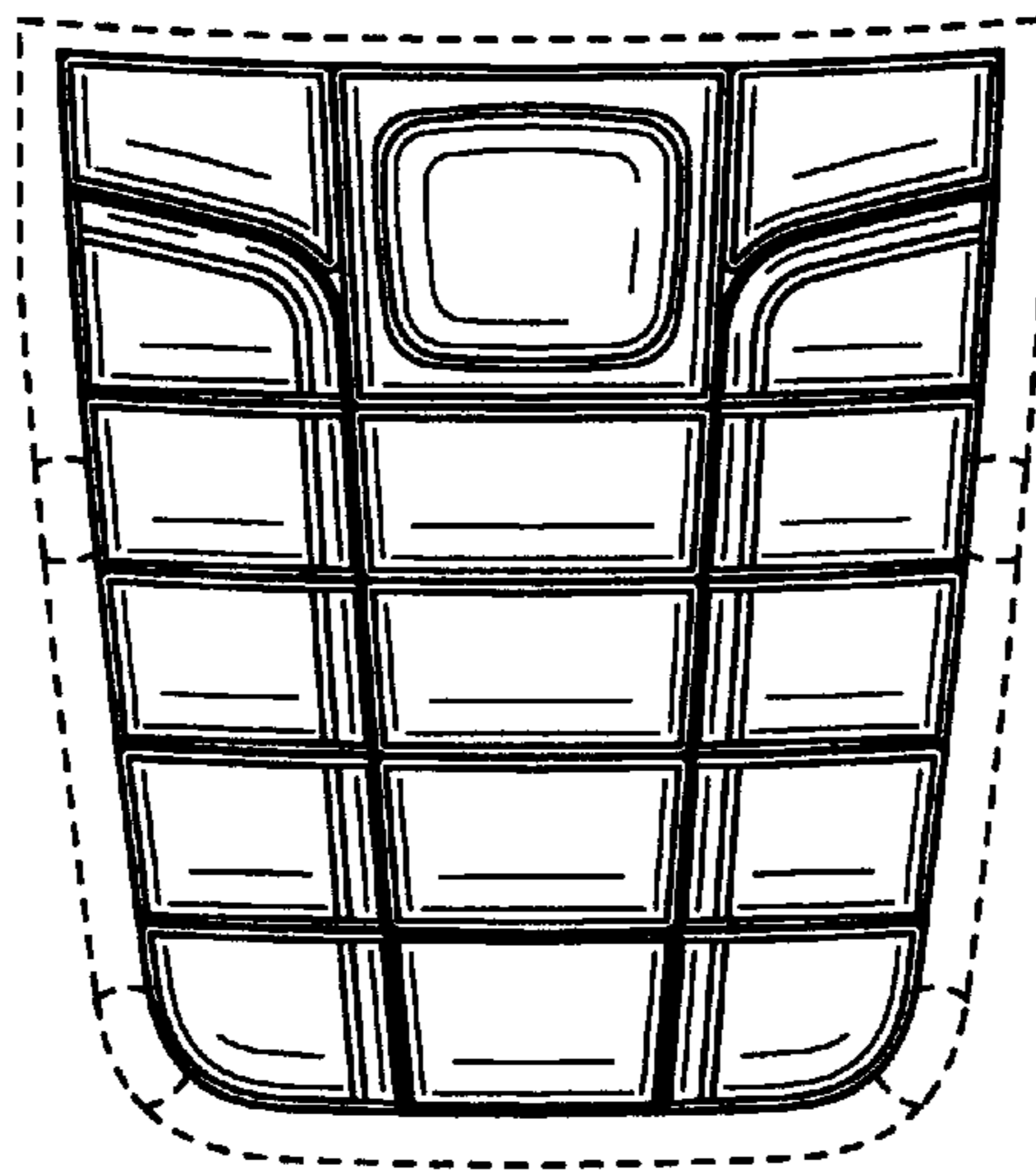

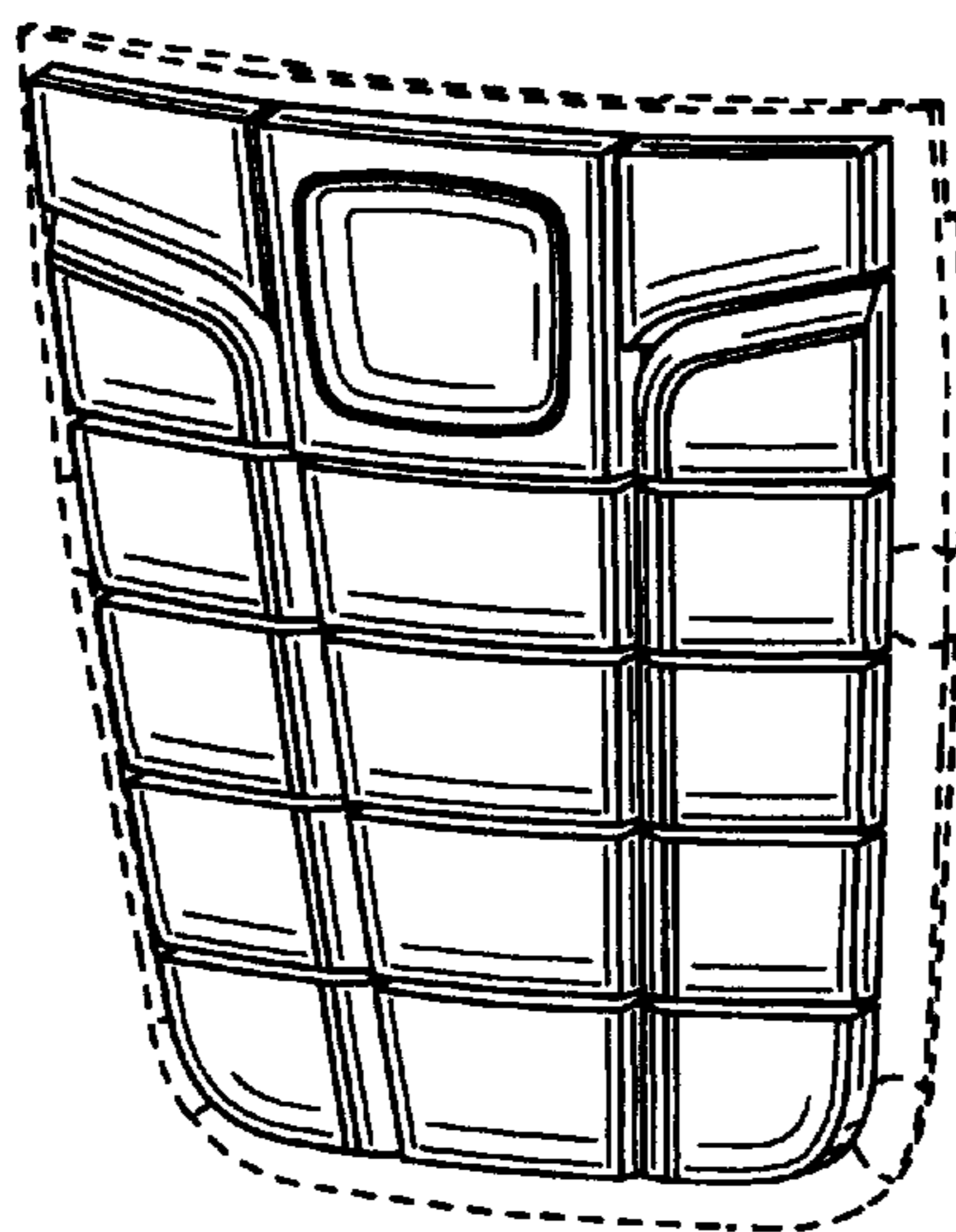
