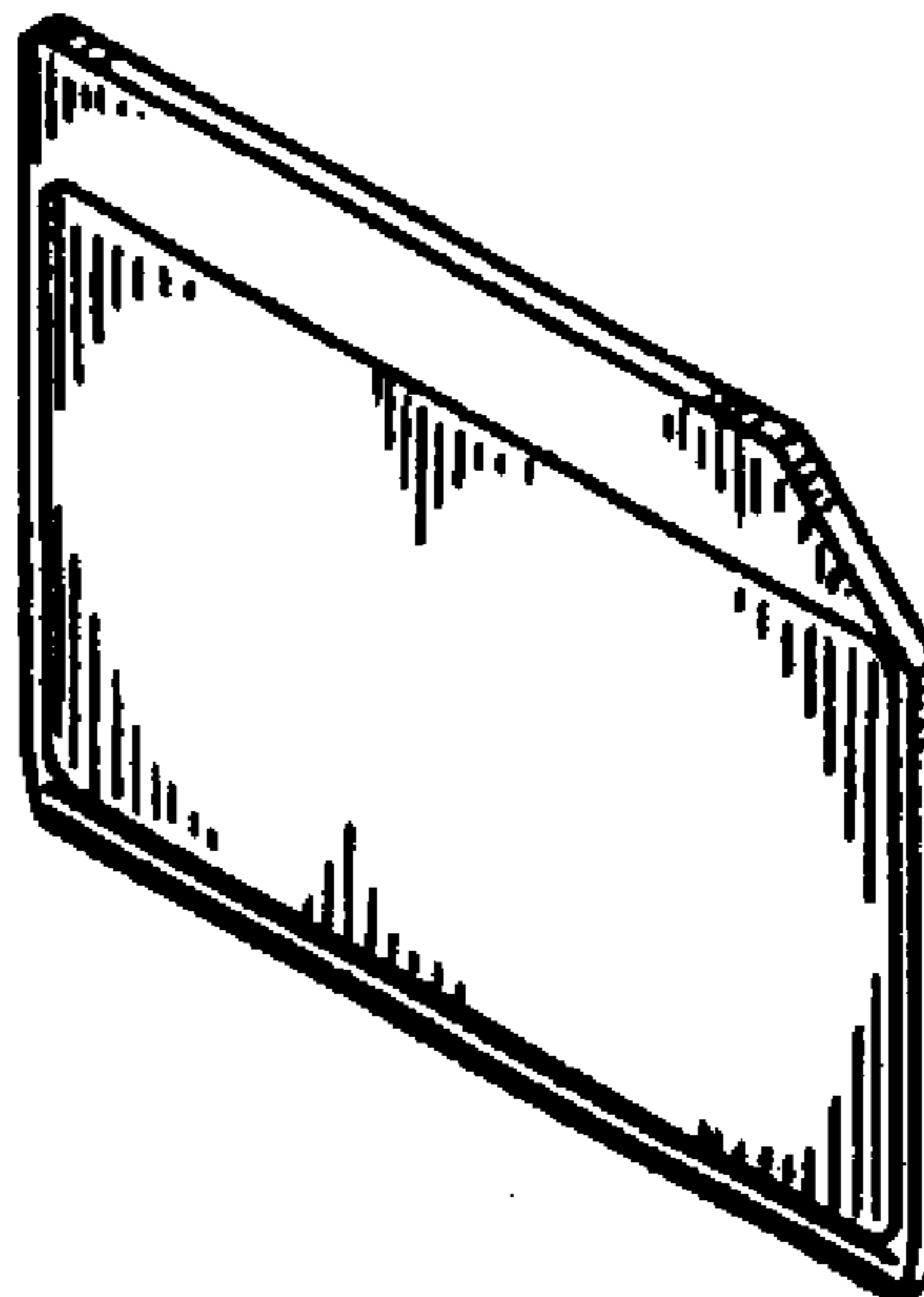
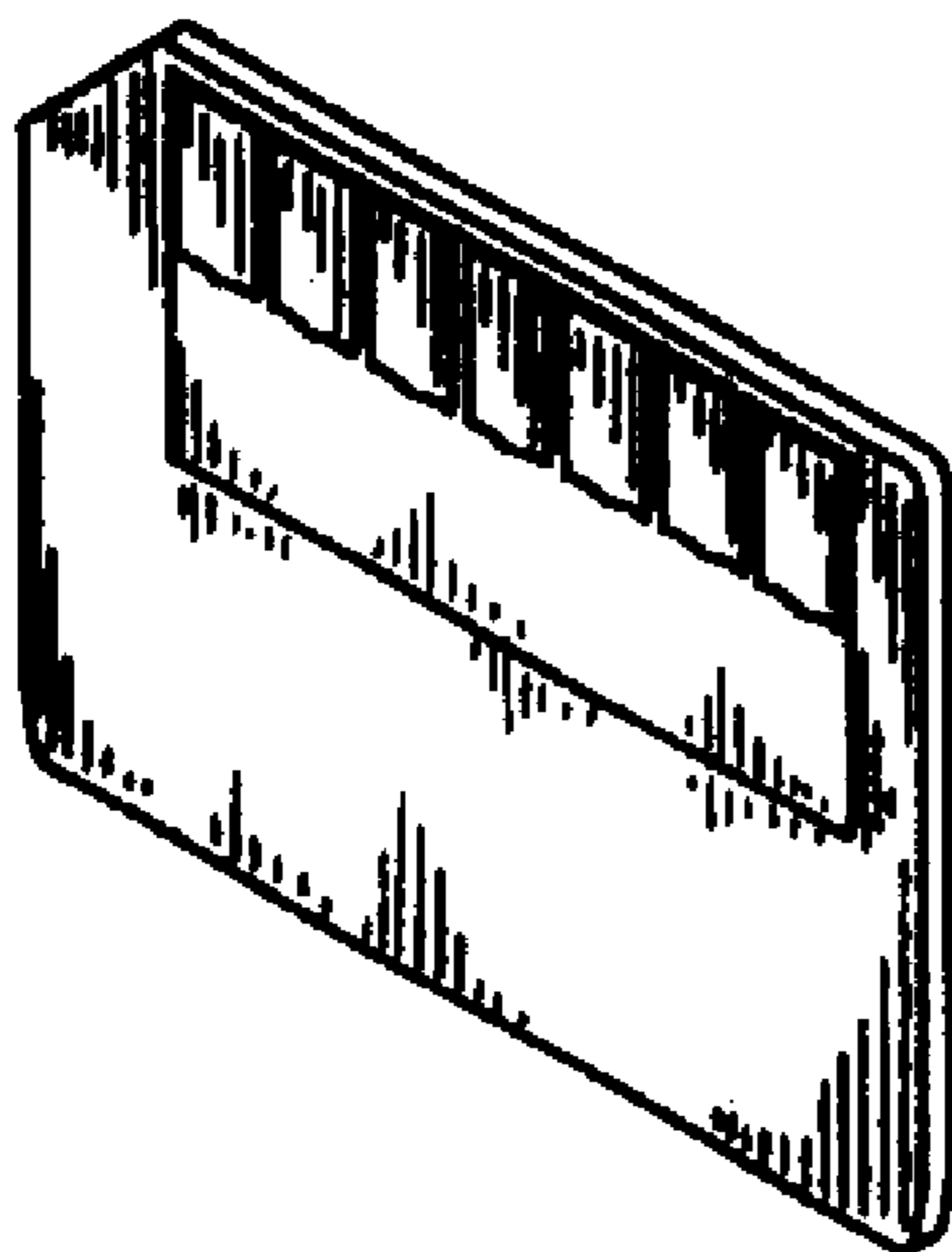
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front elevation view of the IC card type circuit module showing our new design;

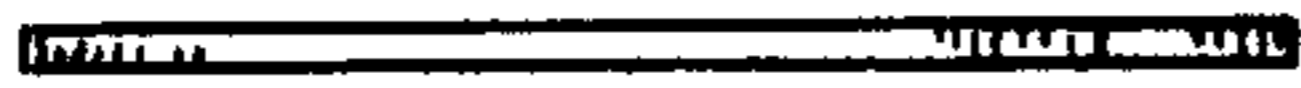

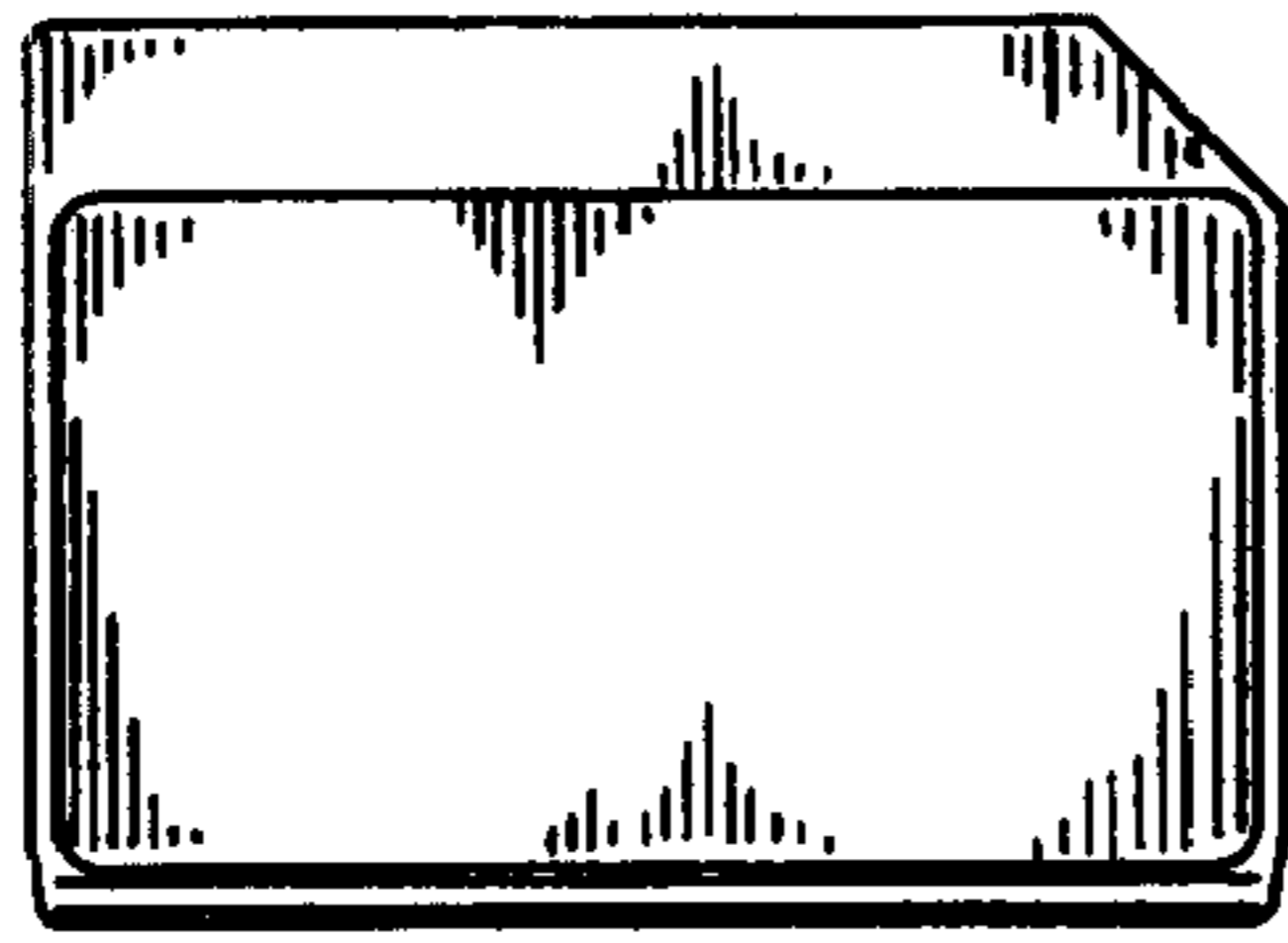

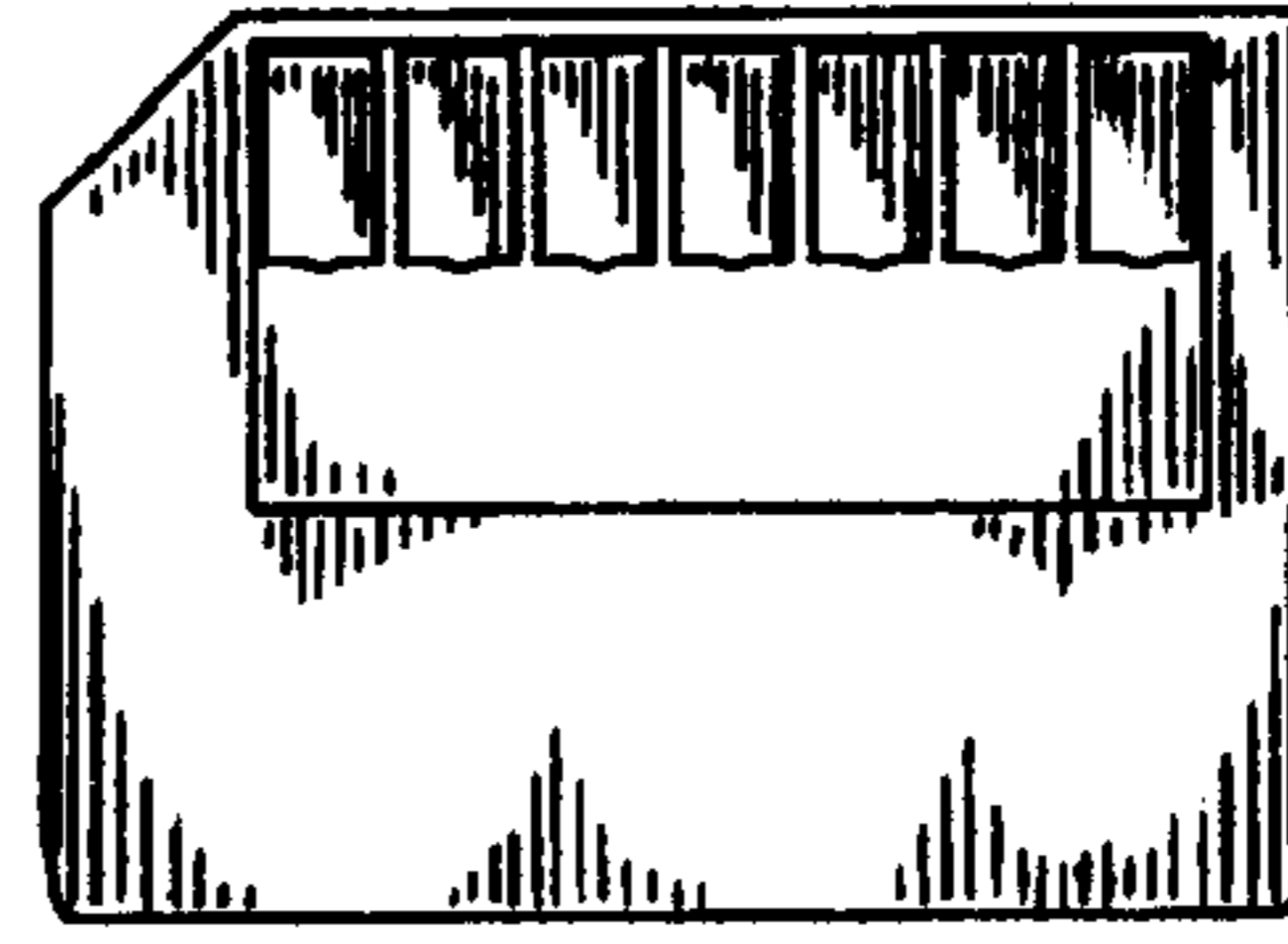

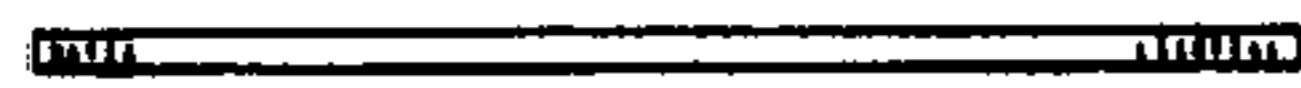

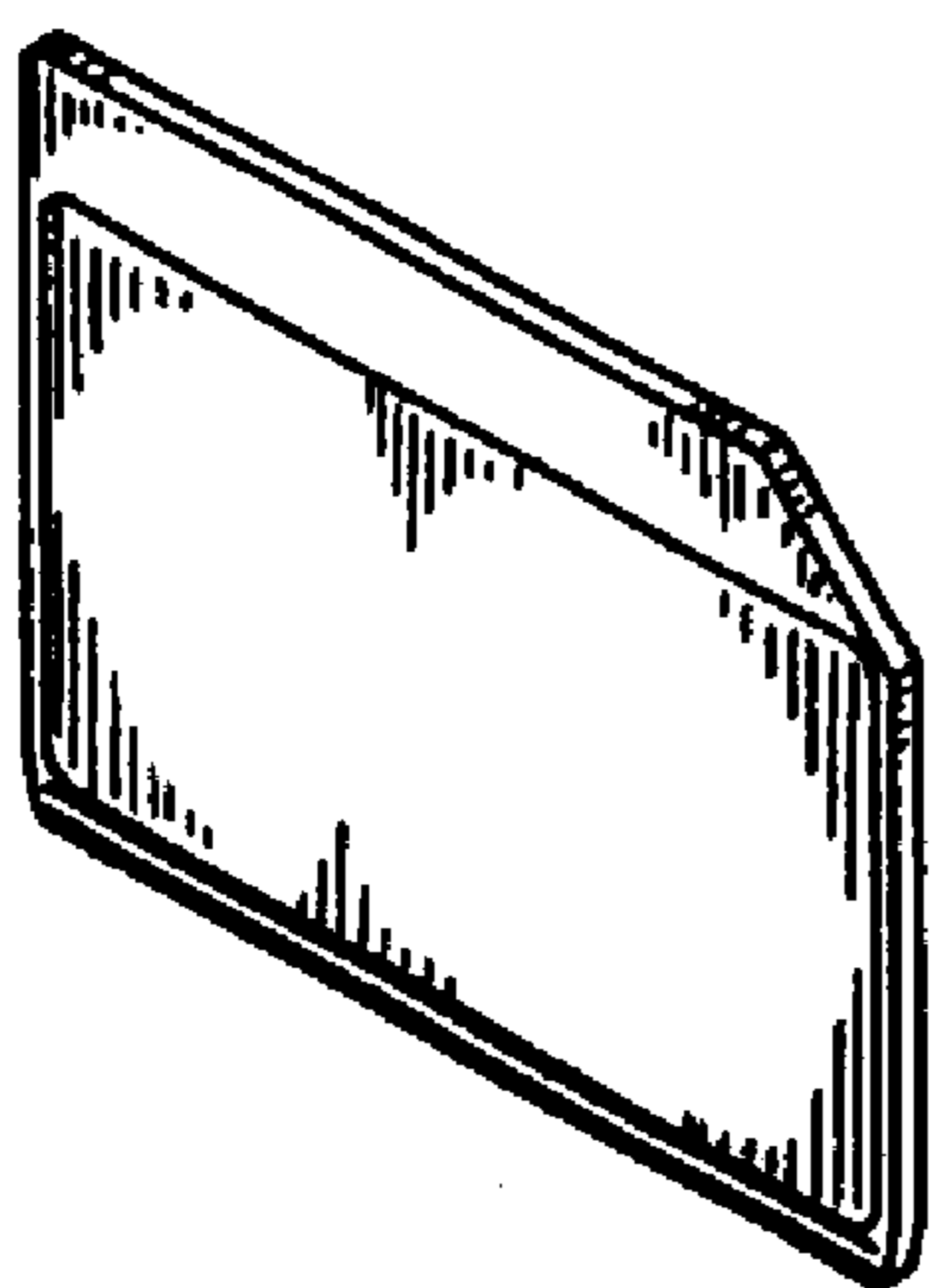

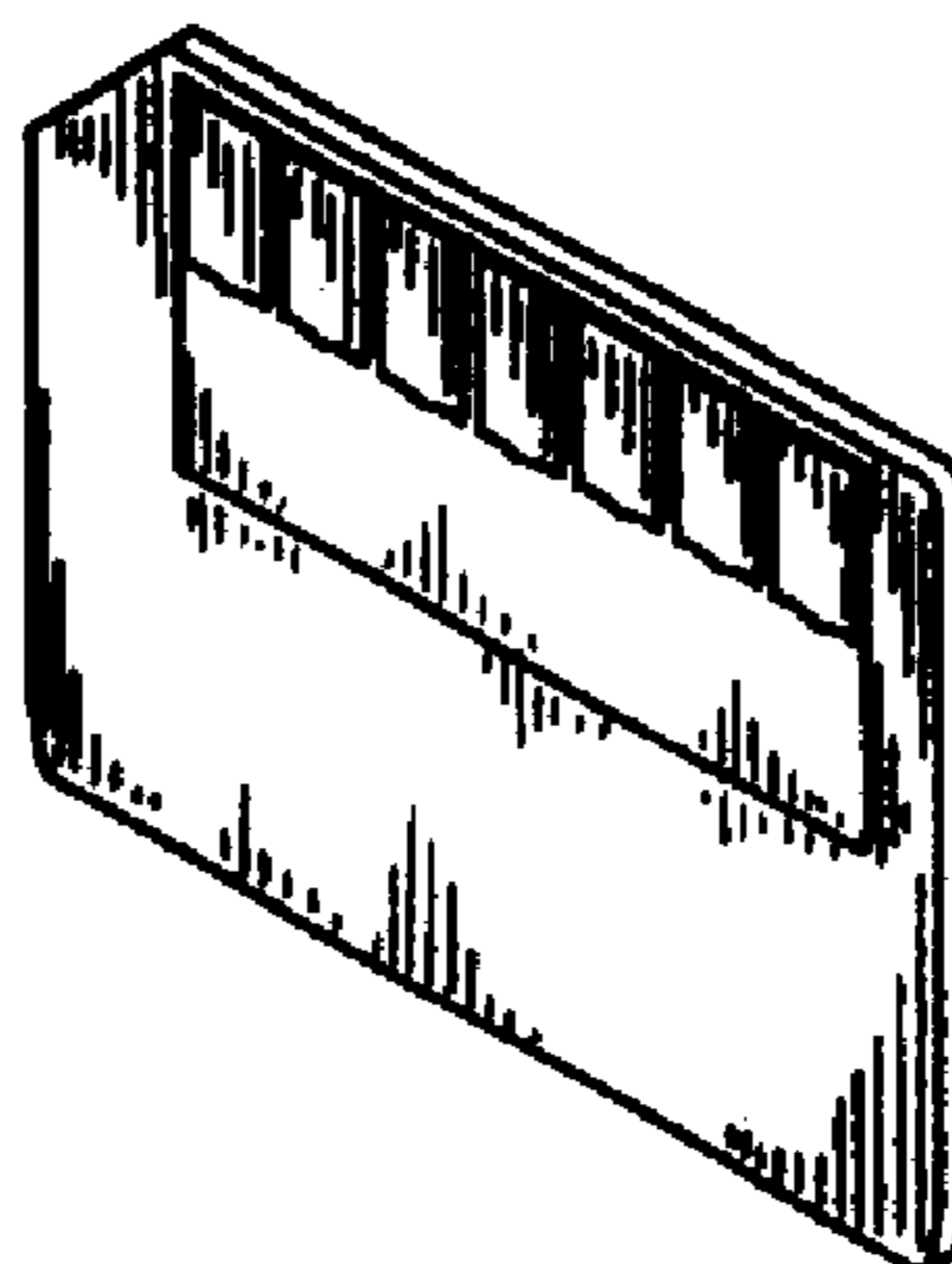
