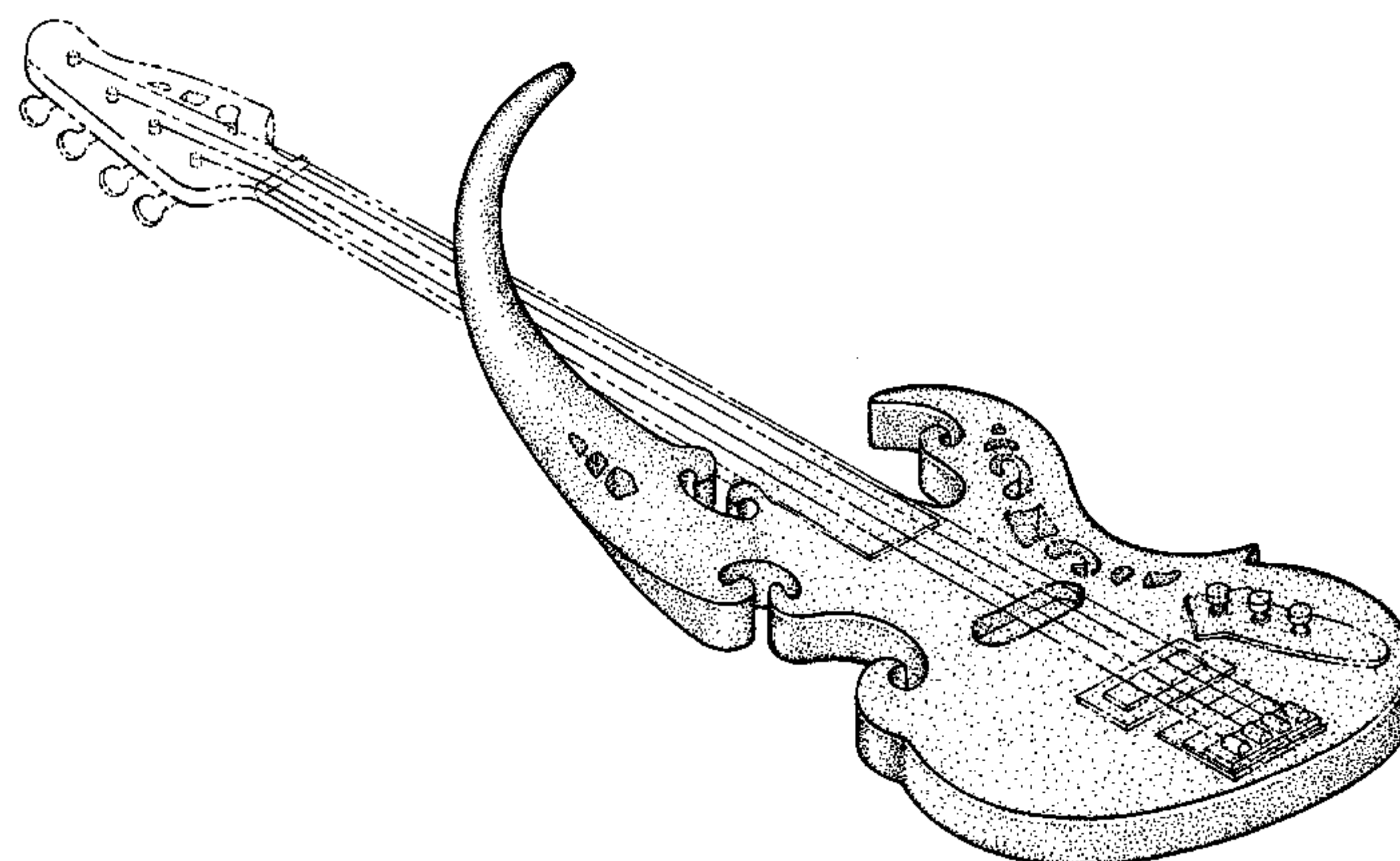
(57) **CLAIM**

The ornamental design for a guitar body, as shown and described.

DESCRIPTION

FIG. 1 is a front isometric view of a guitar body showing my invention;
FIG. 2 is front elevational view of the guitar body of FIG. 1;
FIG. 3 is a left side elevational view of the guitar body of FIG. 2;
FIG. 4 is a right side elevational view of the guitar body of FIG. 2;
FIG. 5 is rear elevational view of the guitar body of FIG. 1;
FIG. 6 is a bottom plan view of the guitar body of FIG. 2;
and,
FIG. 7 is a top plan view of the guitar body of FIG. 2.
The broken line showing of a neck or fingerboard and strings is for illustrative purposes only and forms no part of the claimed design.

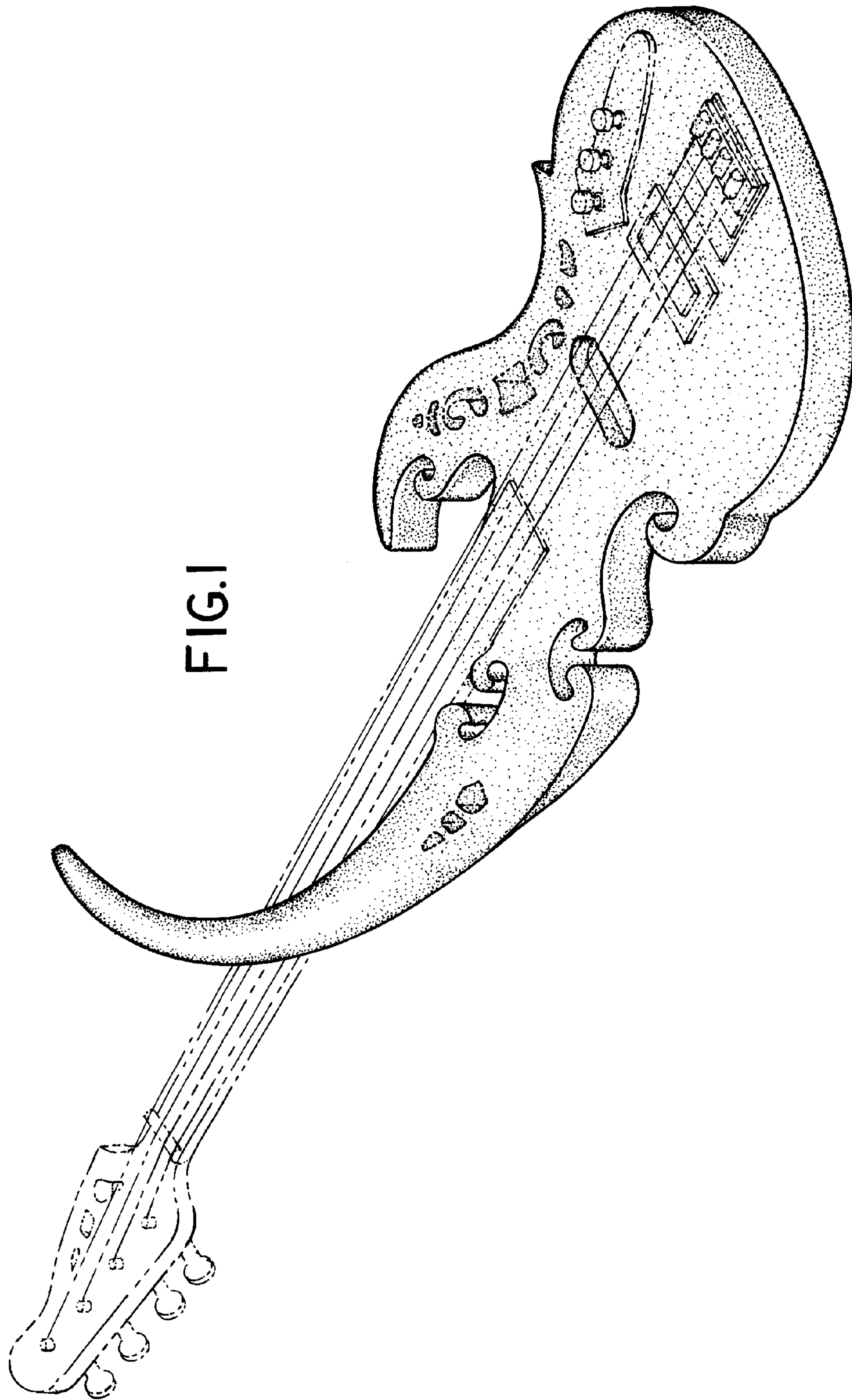
