**DESCRIPTION**

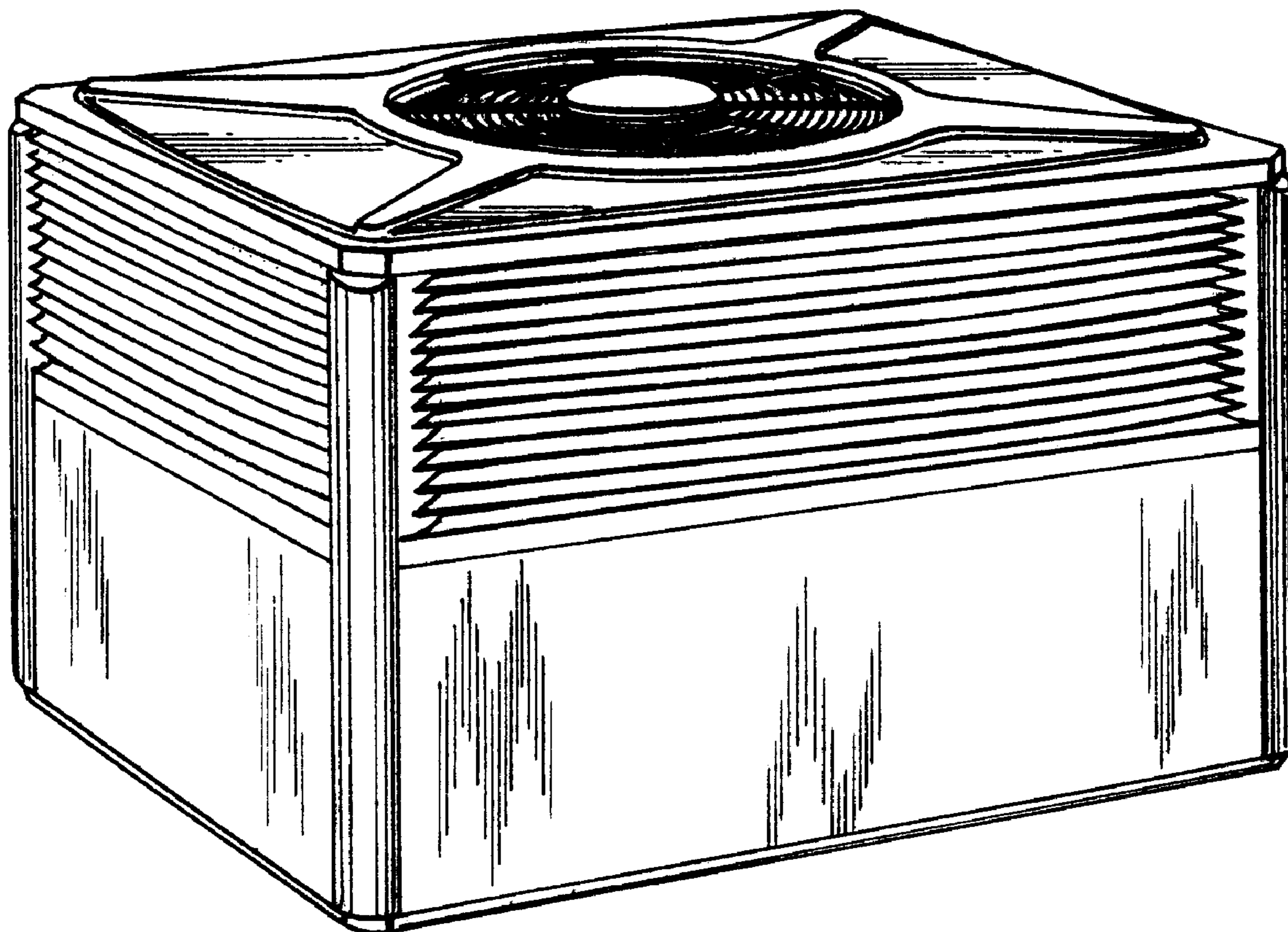
FIG. 1 is a perspective view of the packaged air conditioning unit showing our new design.

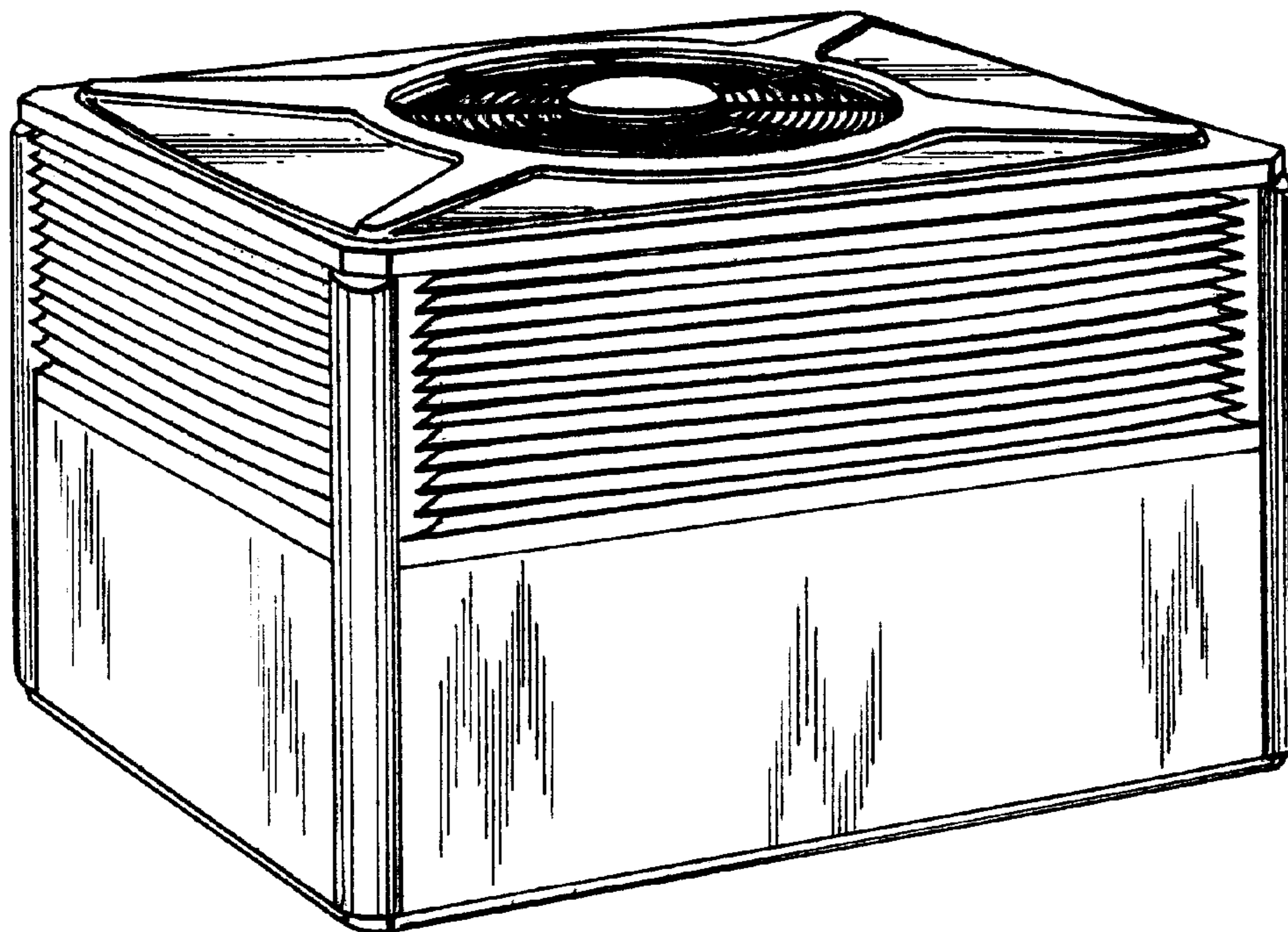

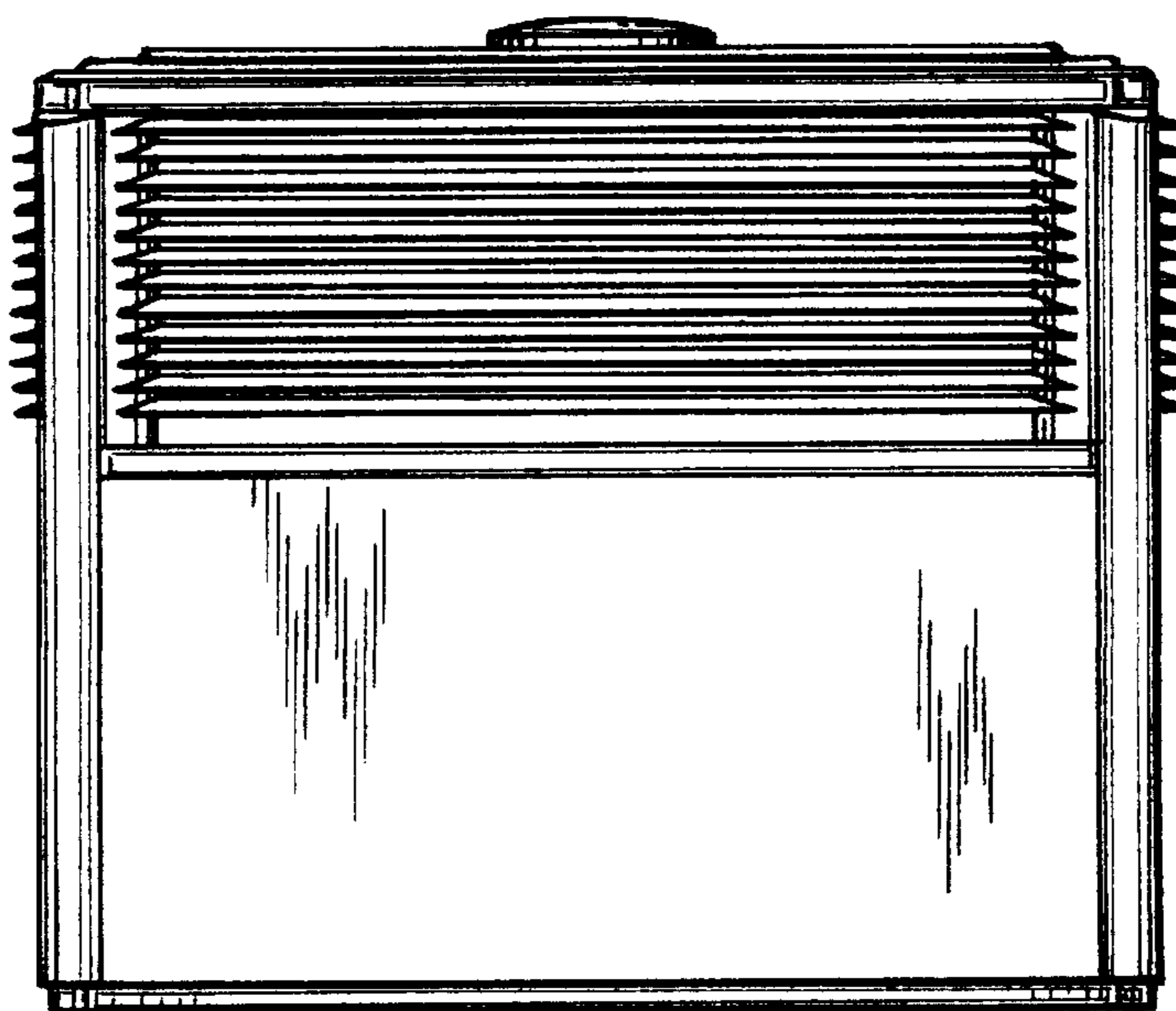

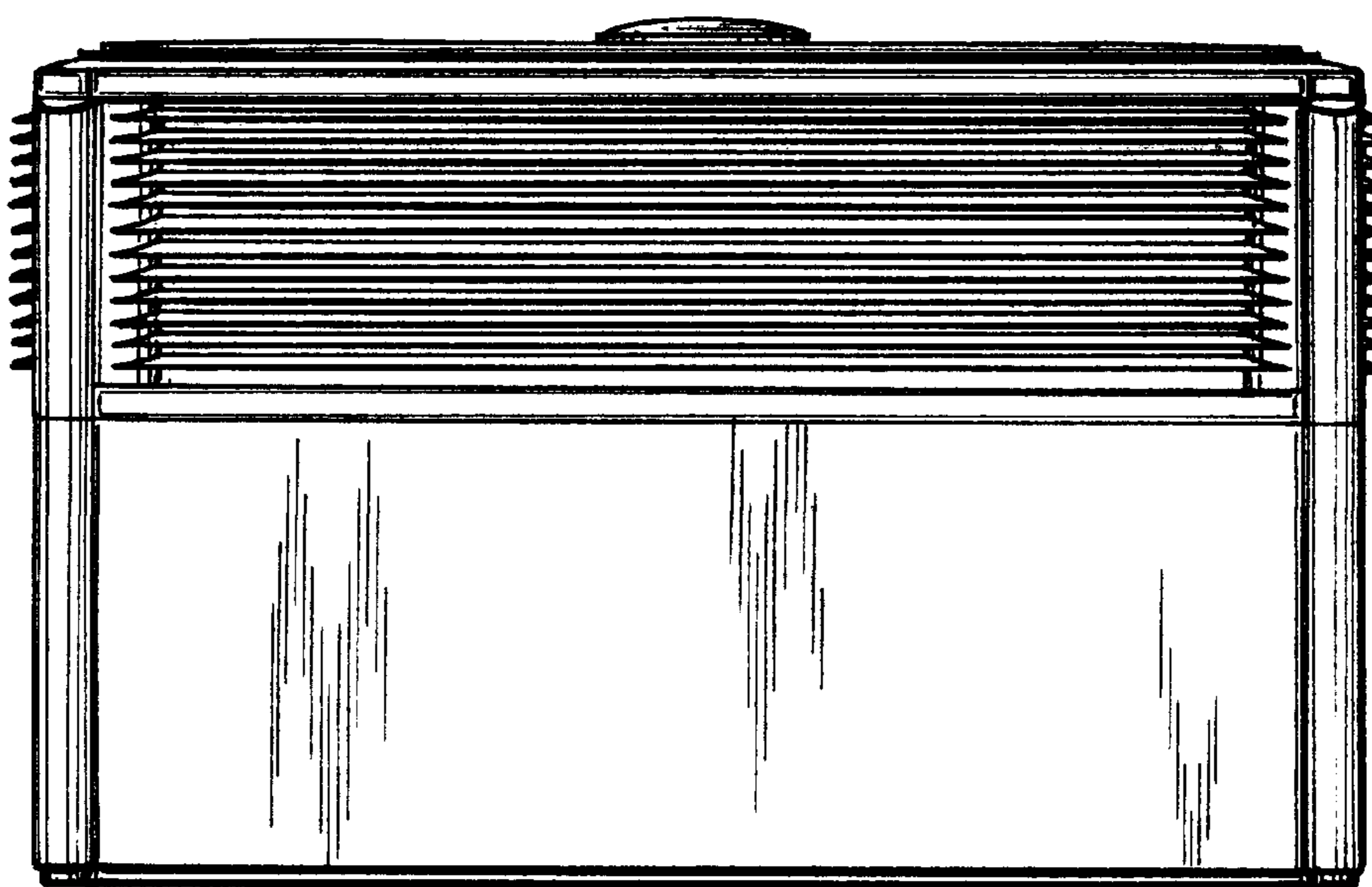
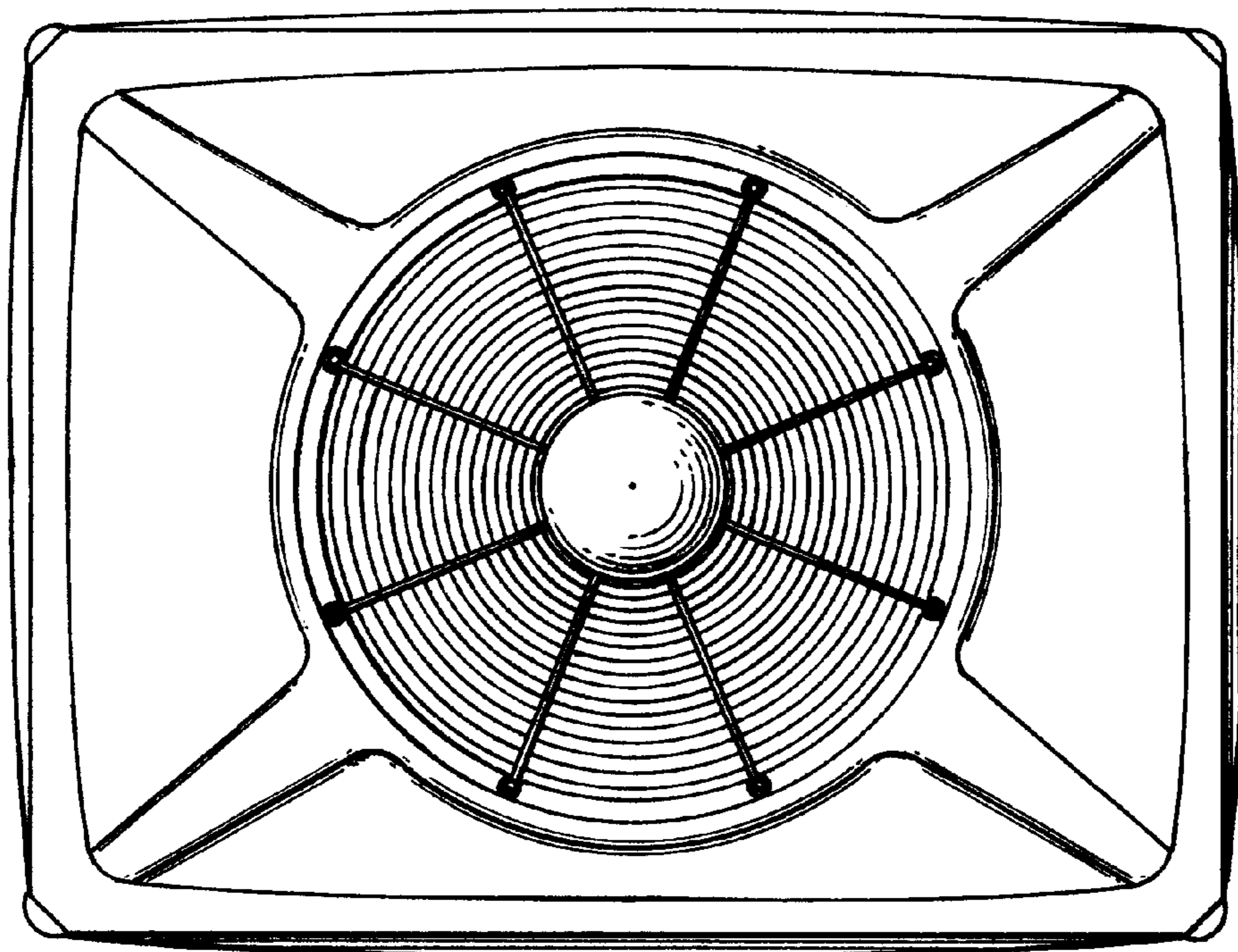
