FIG. 5 is a rear view of the removable wall base with grooves as shown in FIG. 1;

FIG. 6 is a side view of the removable wall base with grooves as shown in FIG. 1, shown from the opposite side of that shown in FIG. 4; and,

FIG. 7 is a bottom view of the removable wall base with grooves as shown in FIG. 1.

The claimed design has been broken in the center to indicate indefinite length.
