design;

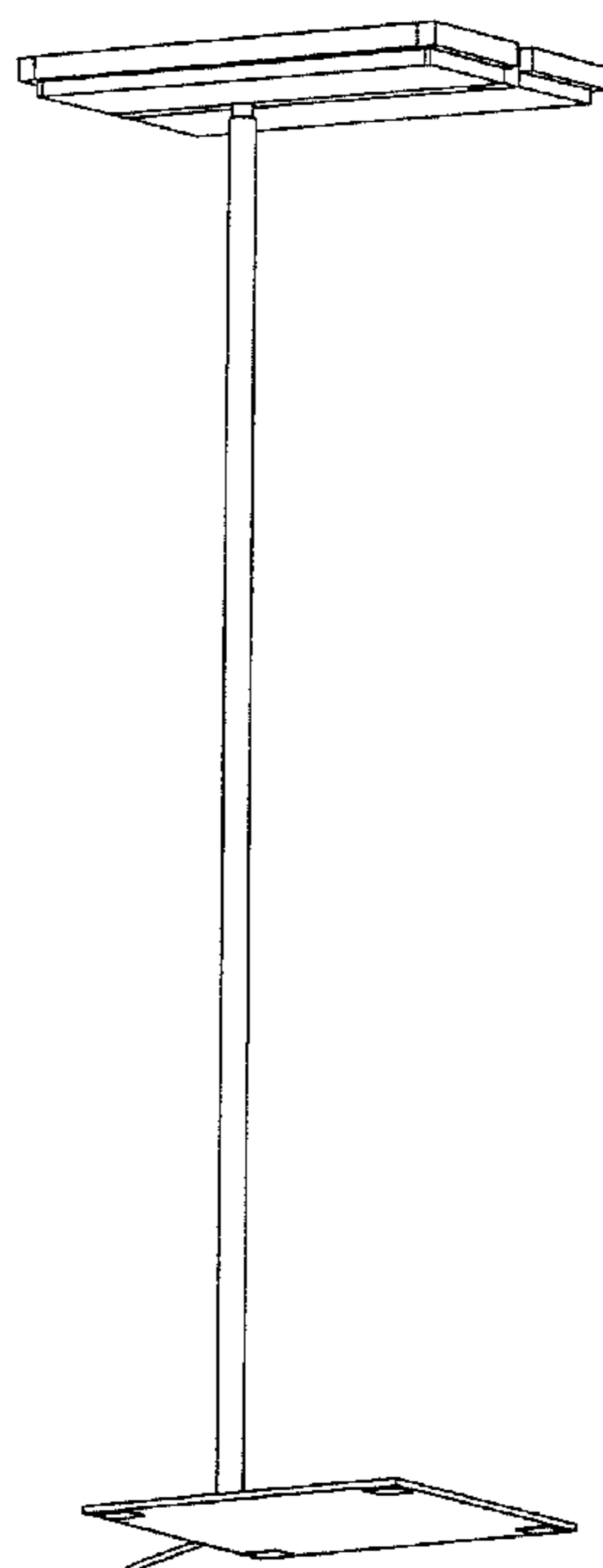
FIG. 4 is a side view from the left of an embodiment of the

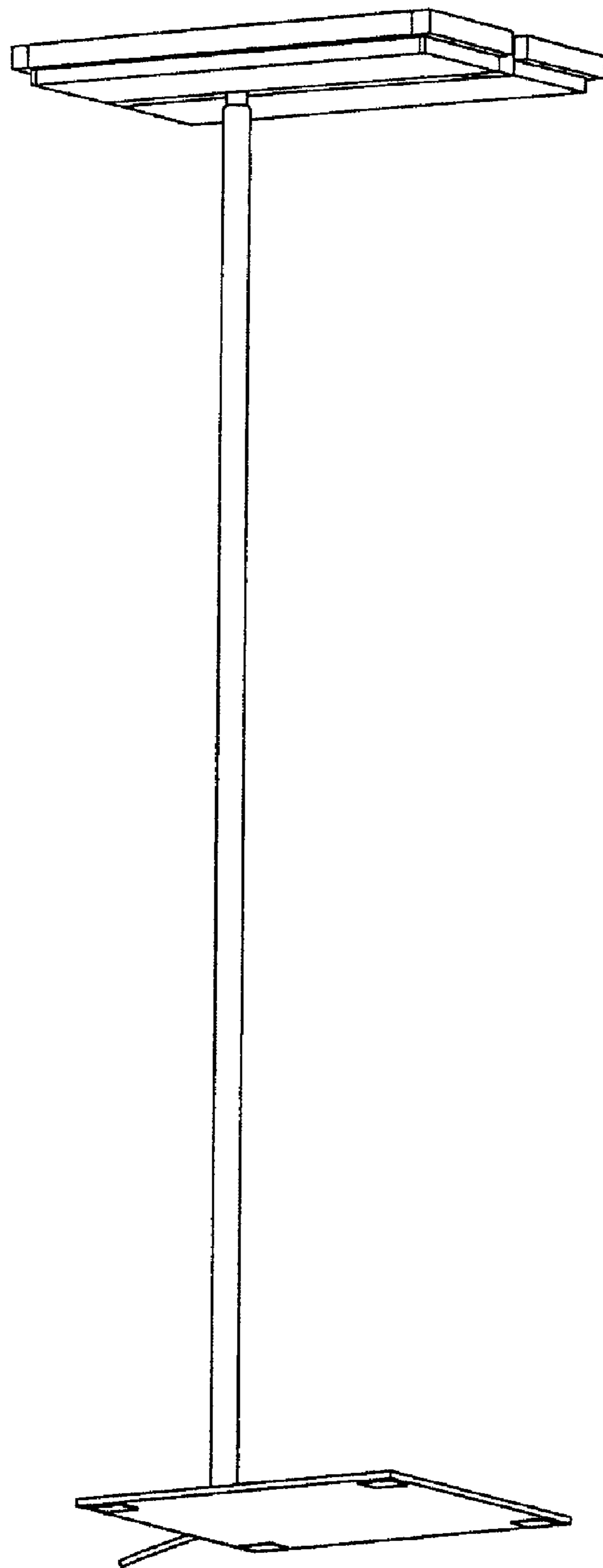

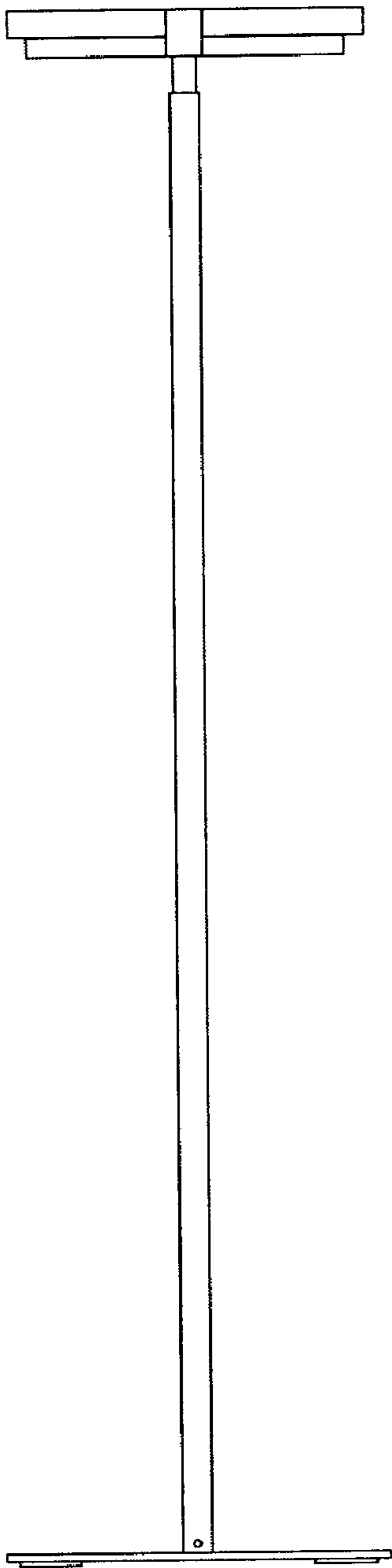

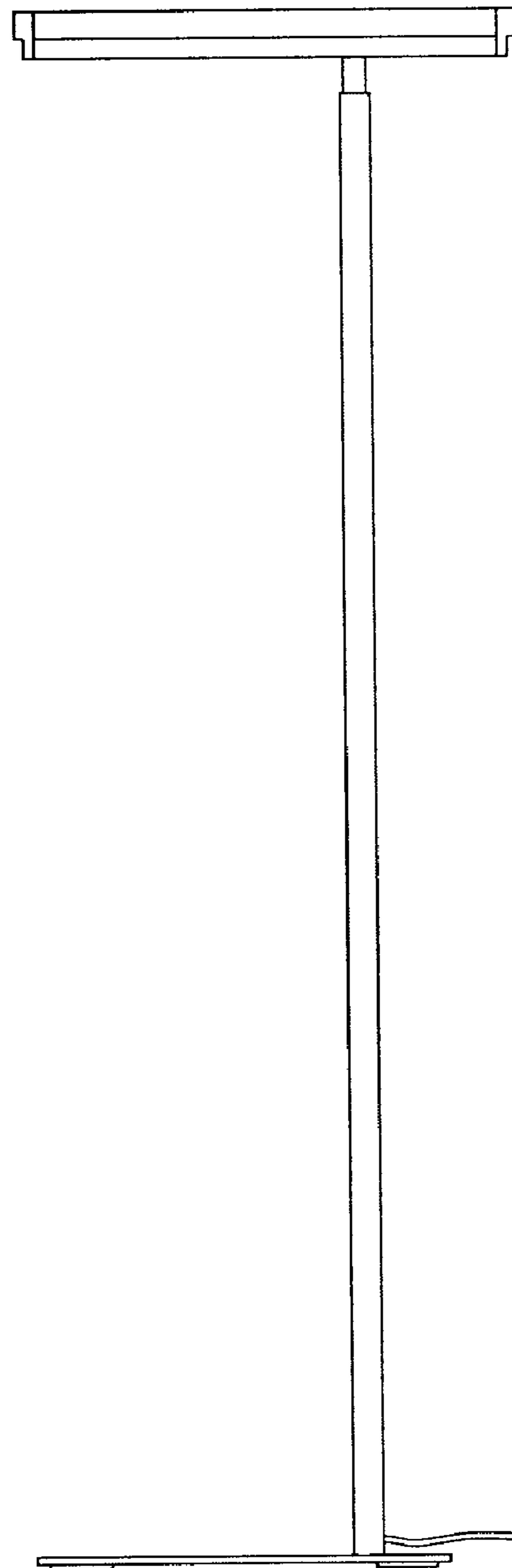

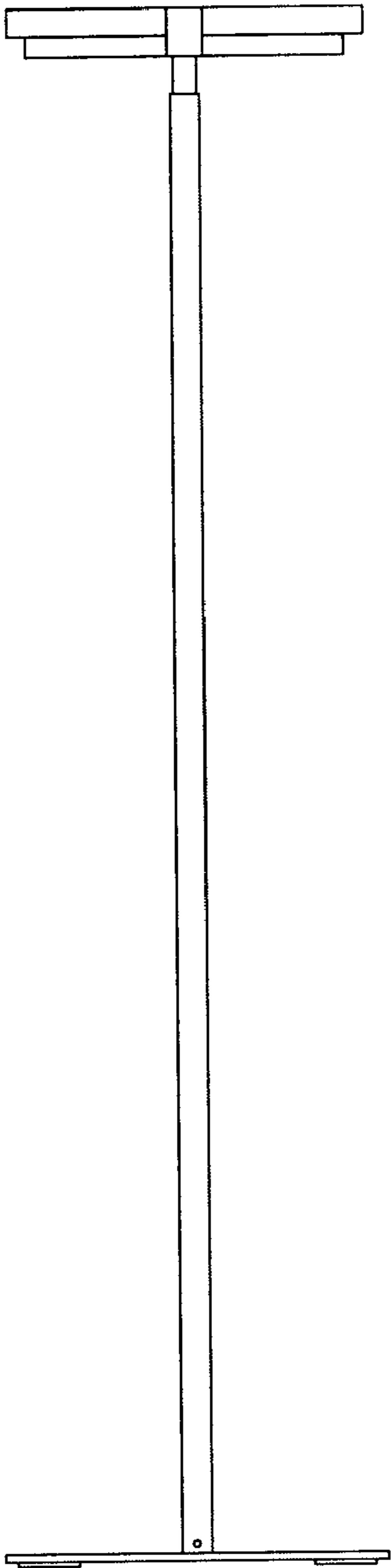

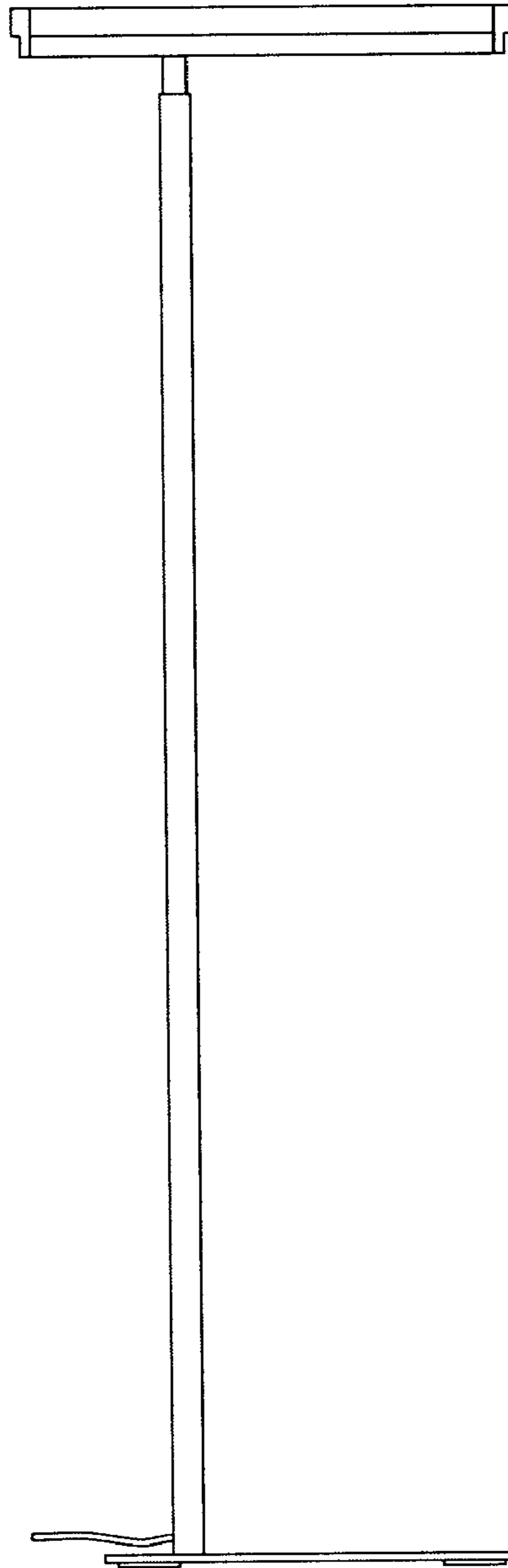

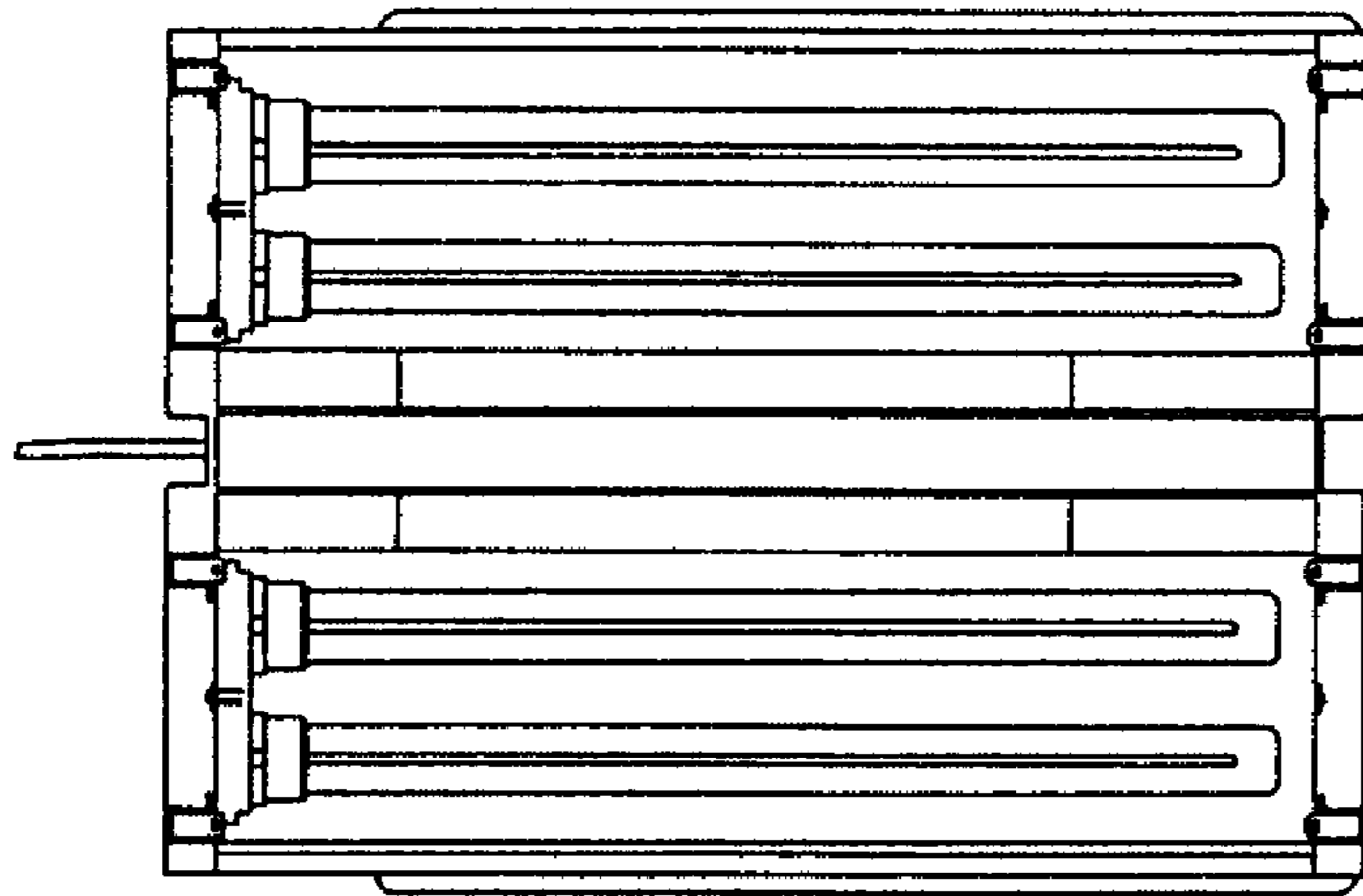

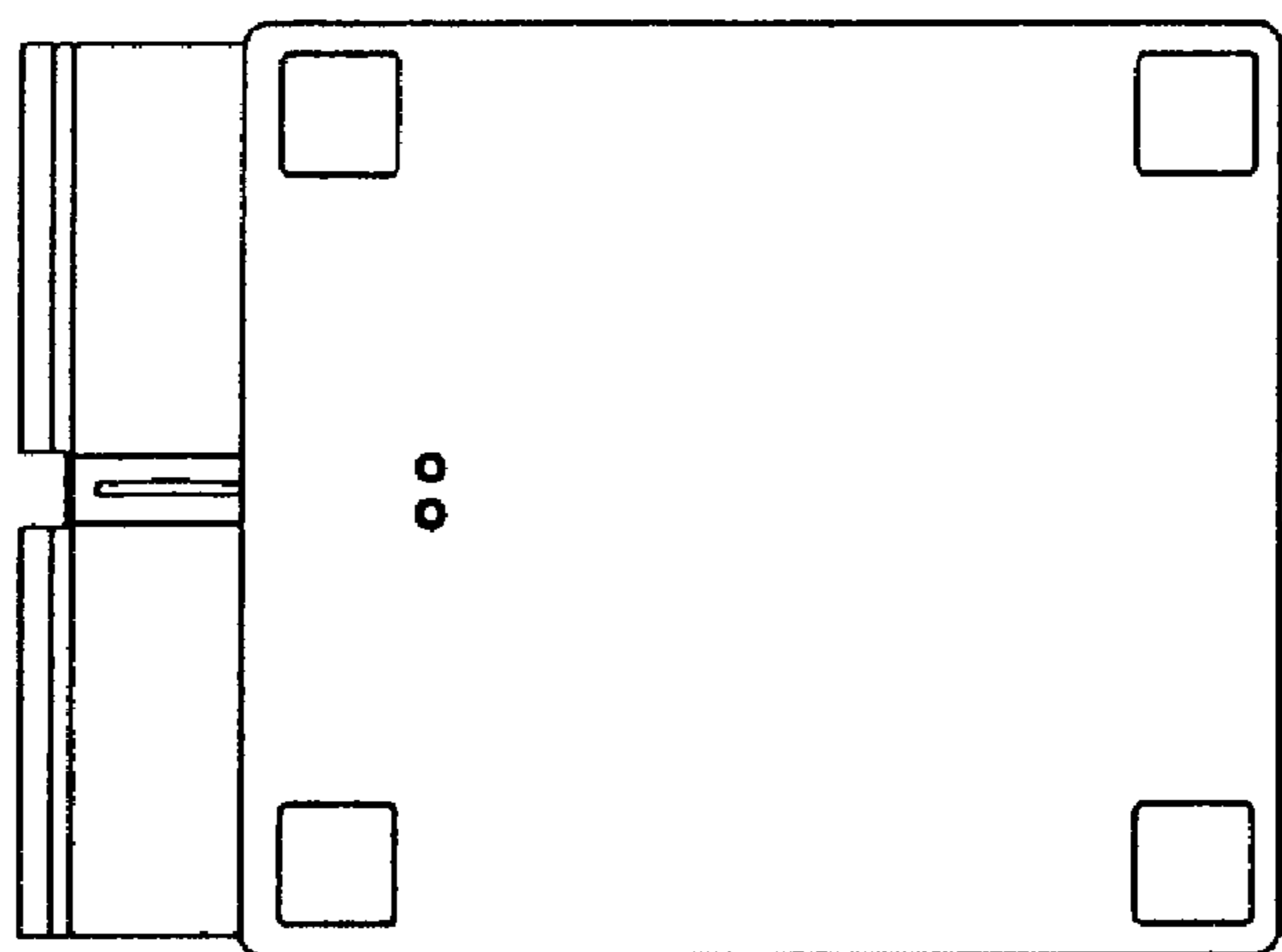

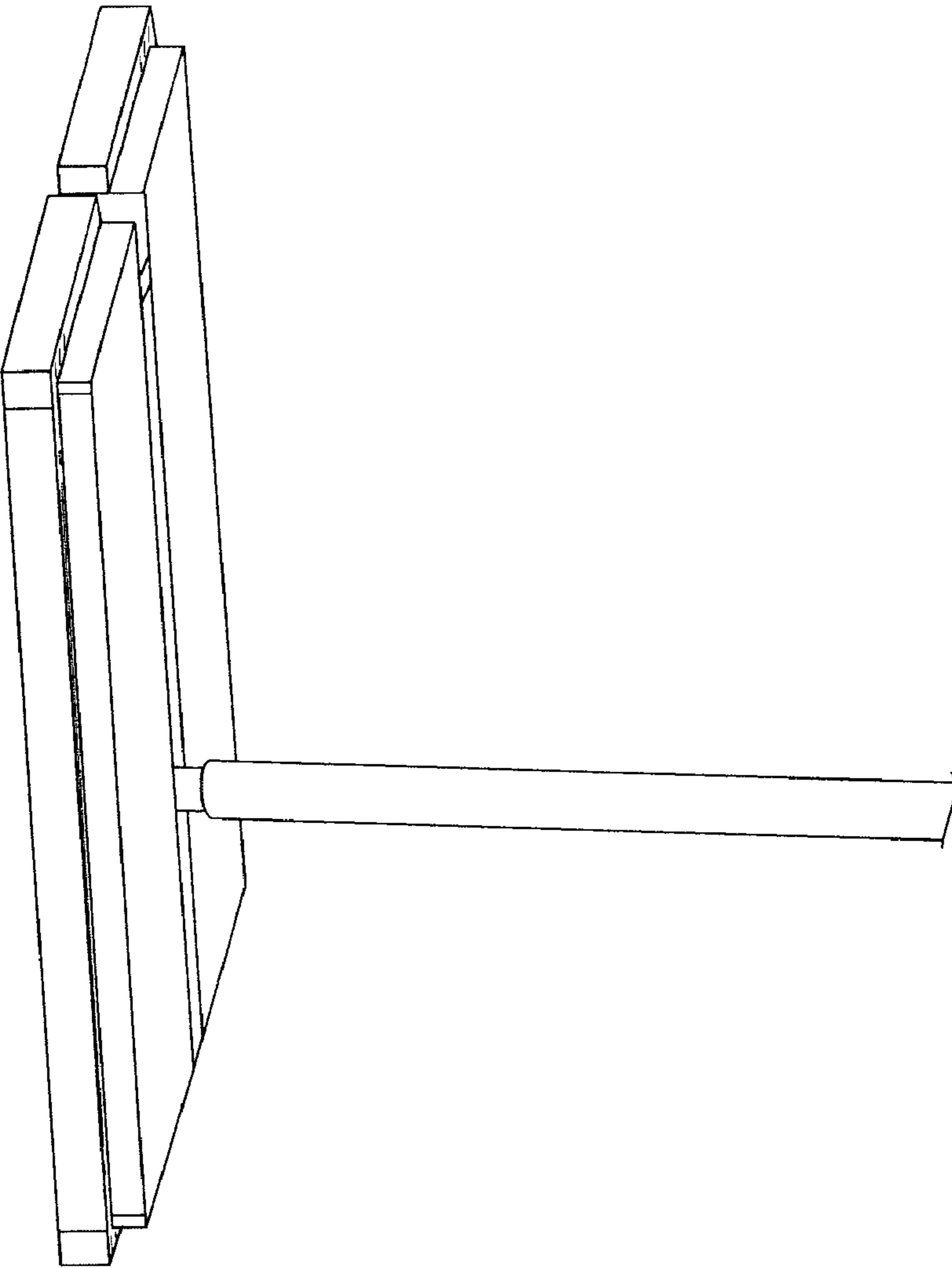
