(57) **CLAIM**

The ornamental design for a portion of a drawer of a service cart, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a portion of a drawer of a service cart showing my new design;

FIG. 2 is a cross-section of the right side elevation view of the portion of a drawer of FIG. 1;

FIG. 3 is a front elevation view of the portion of a drawer of FIG. 1;

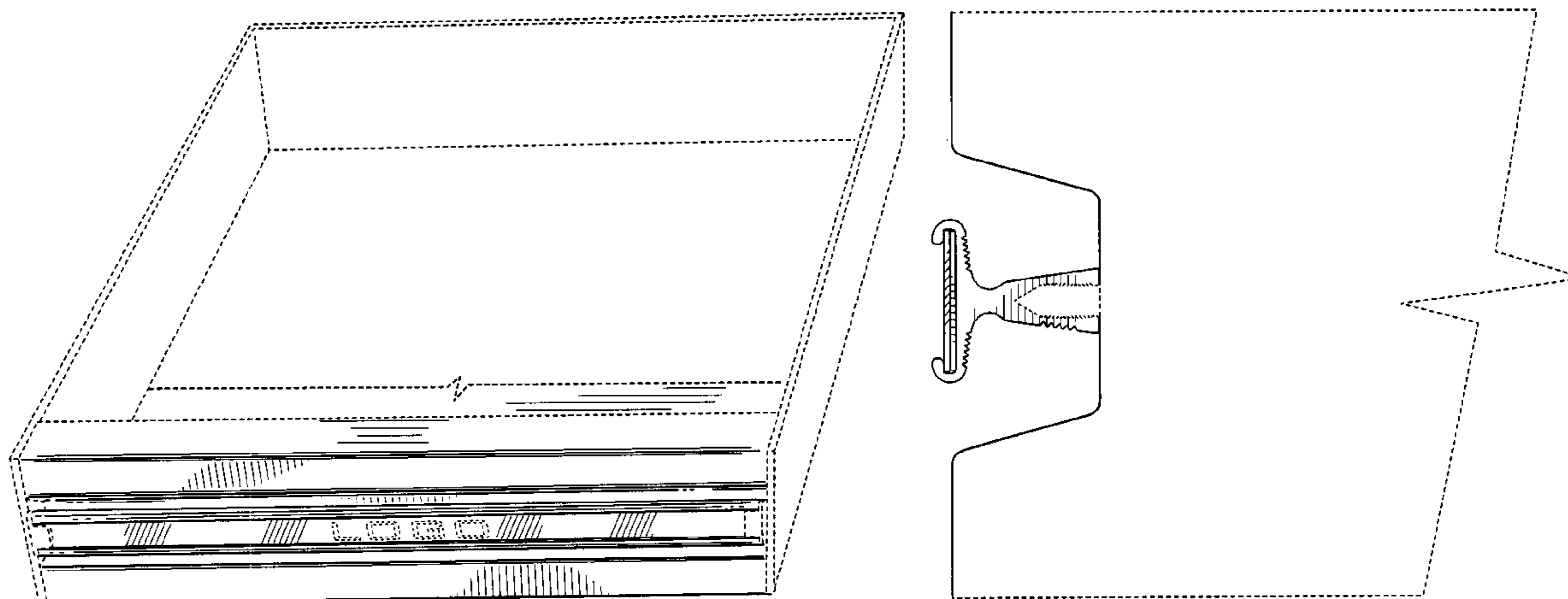
FIG. 4 is a top plan view of the portion of a drawer of FIG. 1;

FIG. 5 is a right side elevation view of the portion of a drawer of FIG. 1, the left side elevation view being a mirror image thereof; and,

FIG. 6 is a bottom plan view of the portion of a drawer of FIG. 1; the rear elevation view of the portion of a drawer of FIG. 1 is unornamented and forms no part of the claimed design of the portion of a drawer shown in FIG. 1.

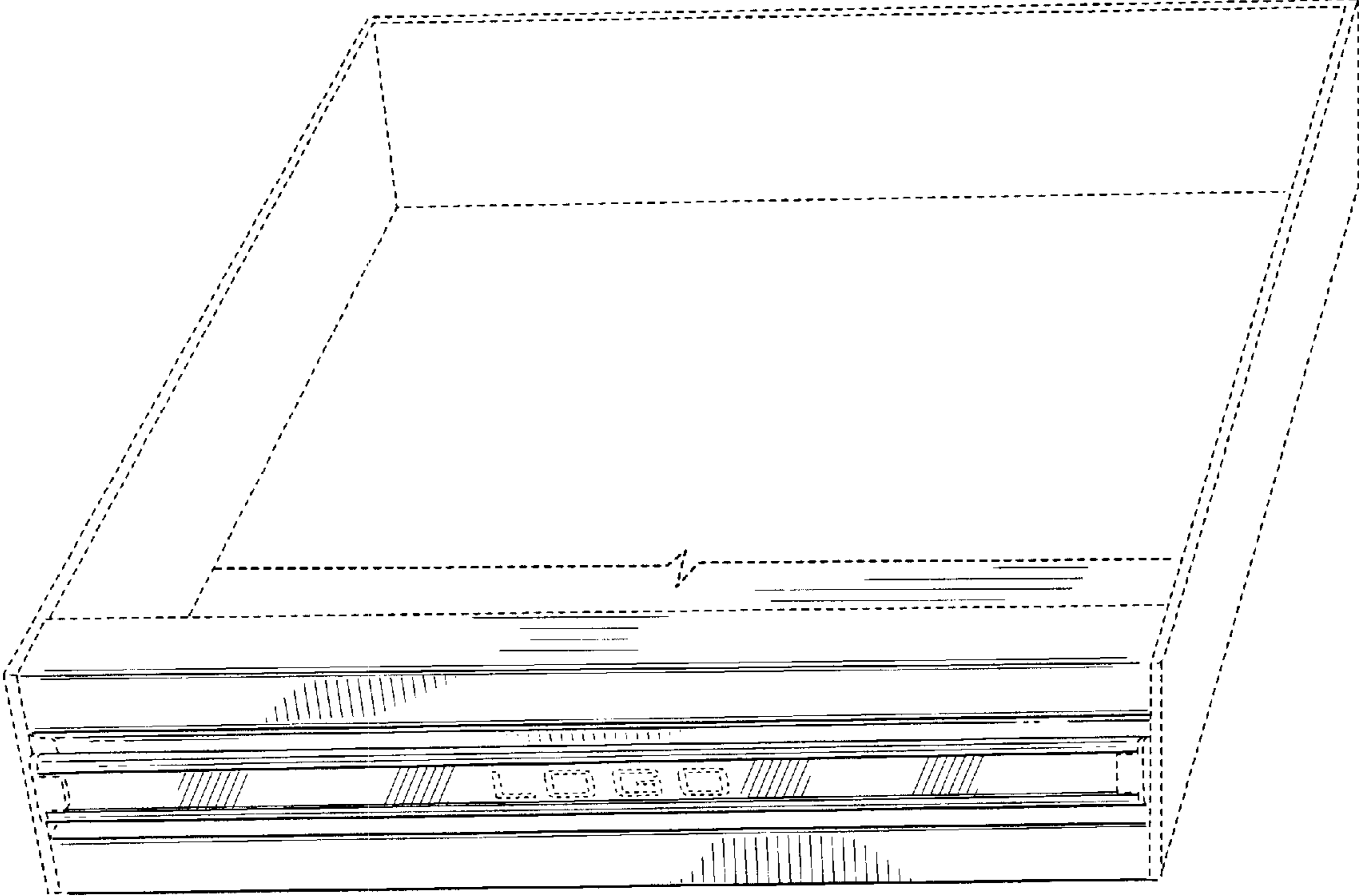

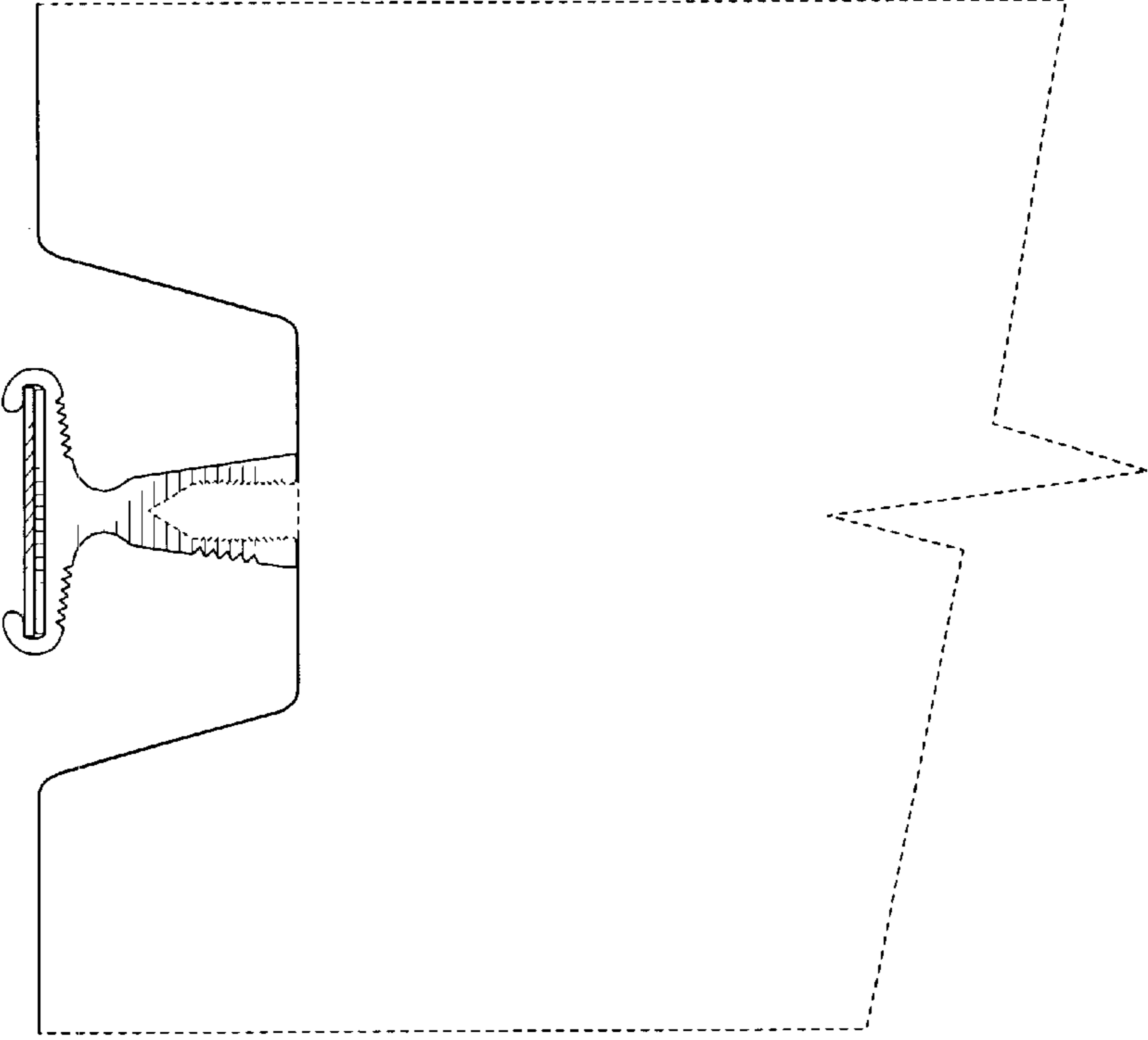

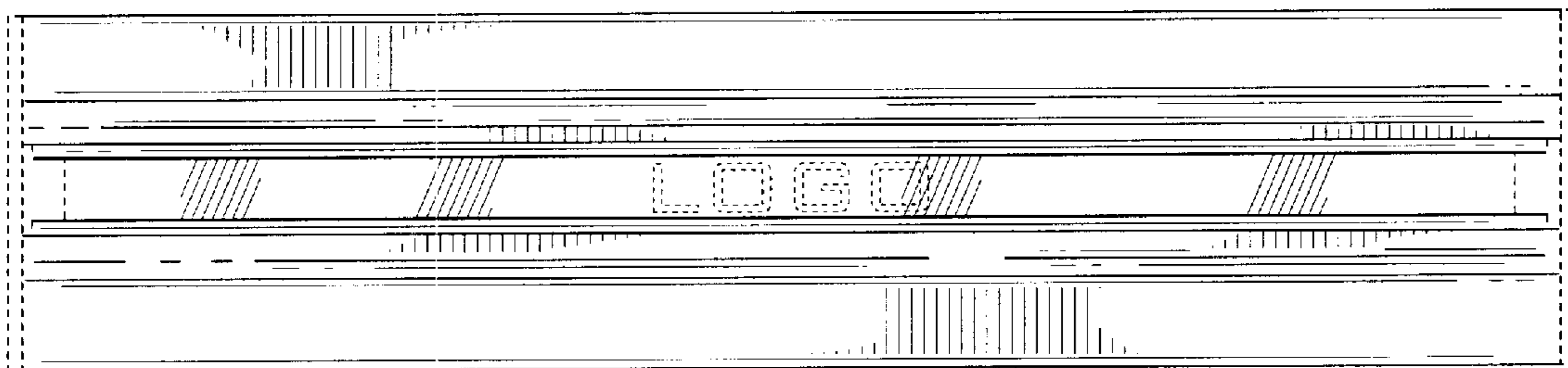

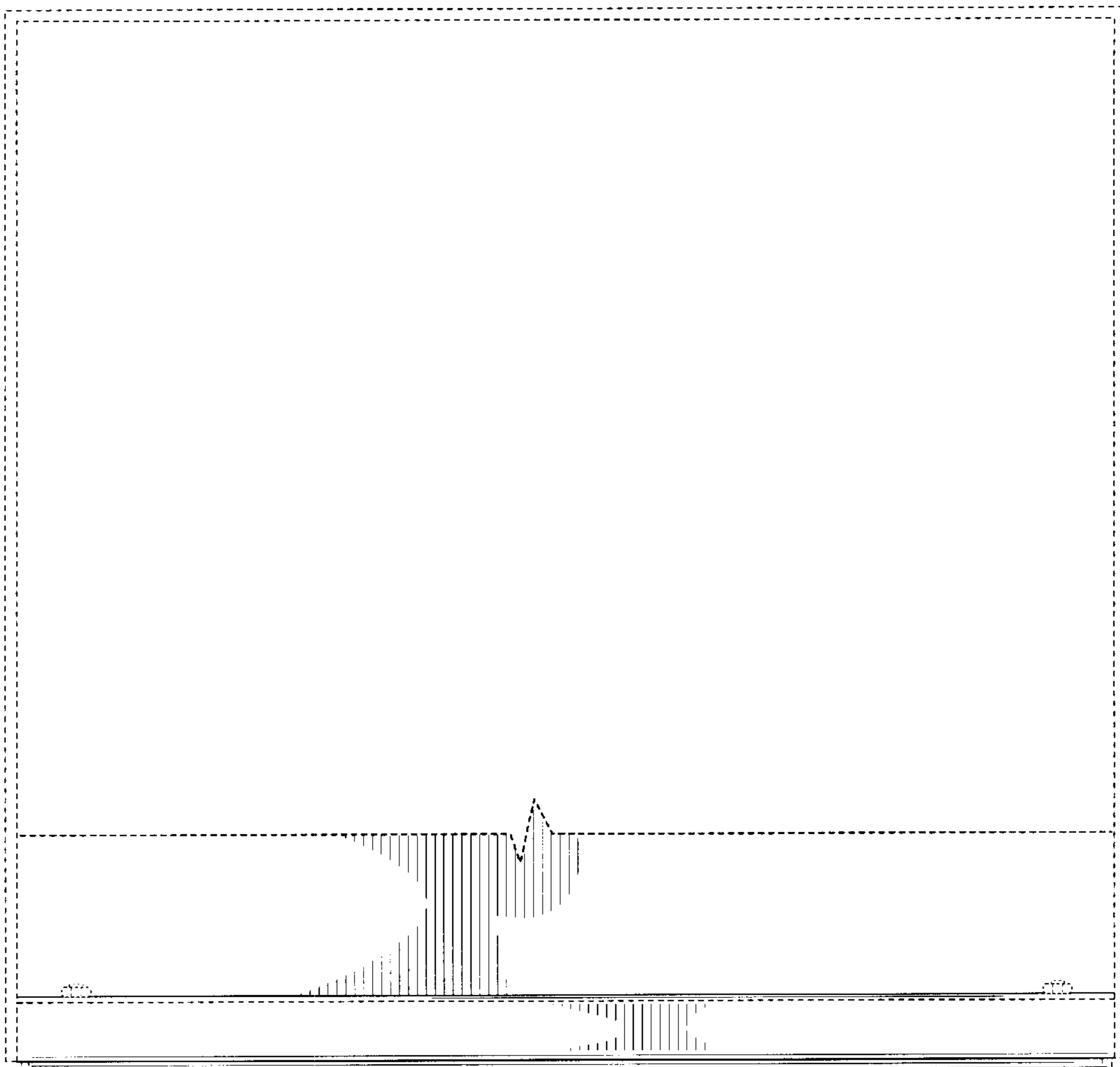

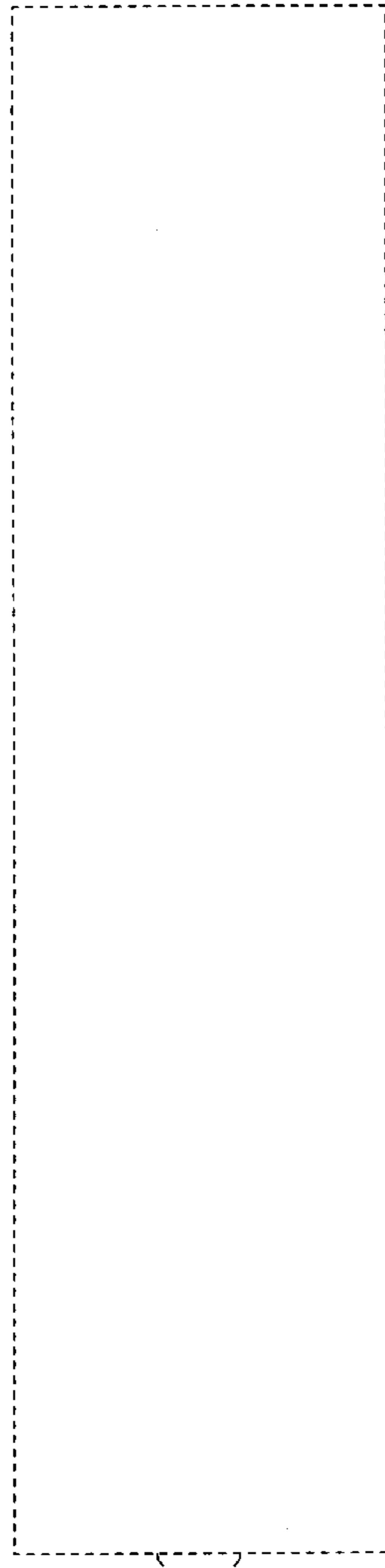

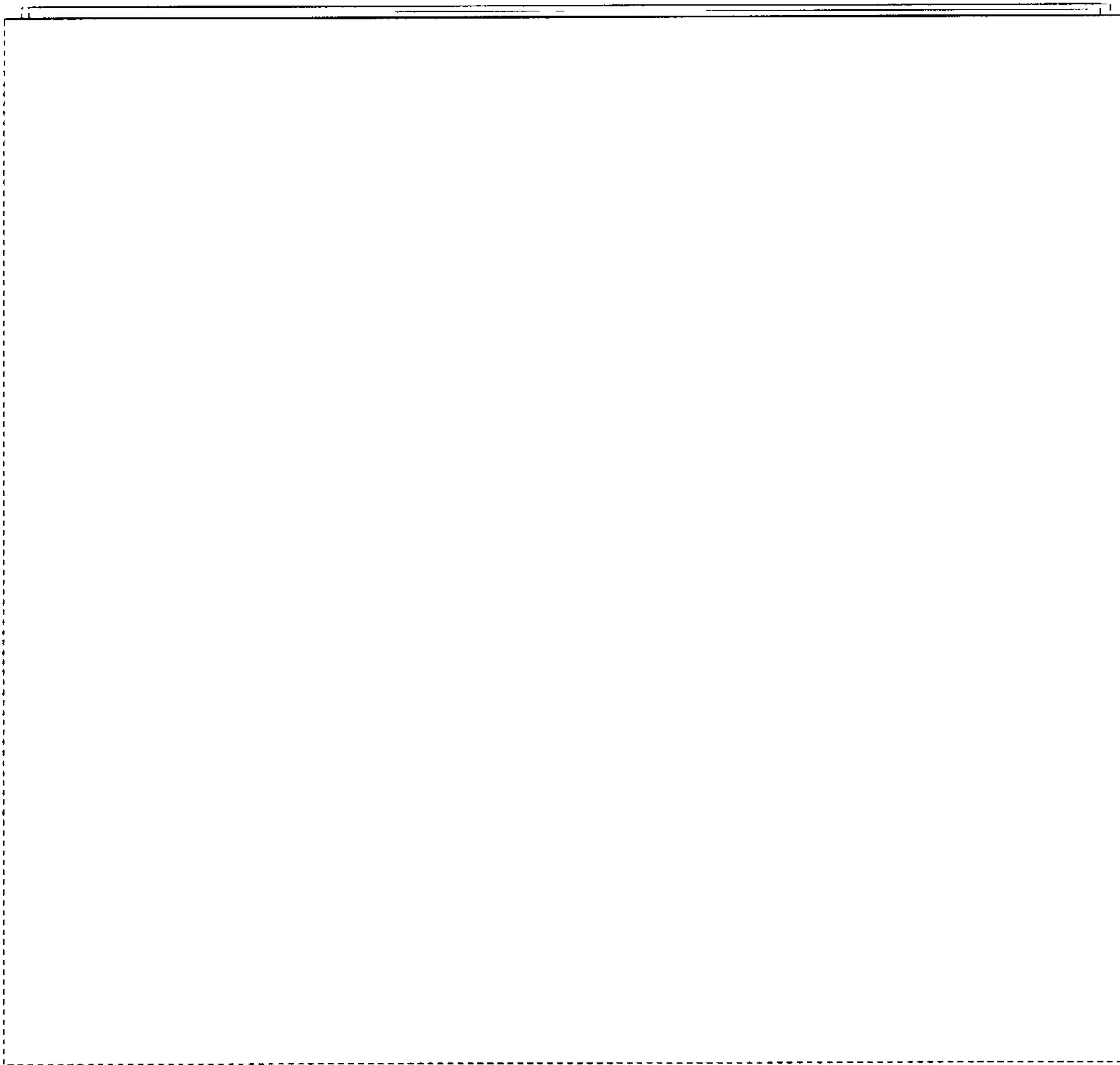
