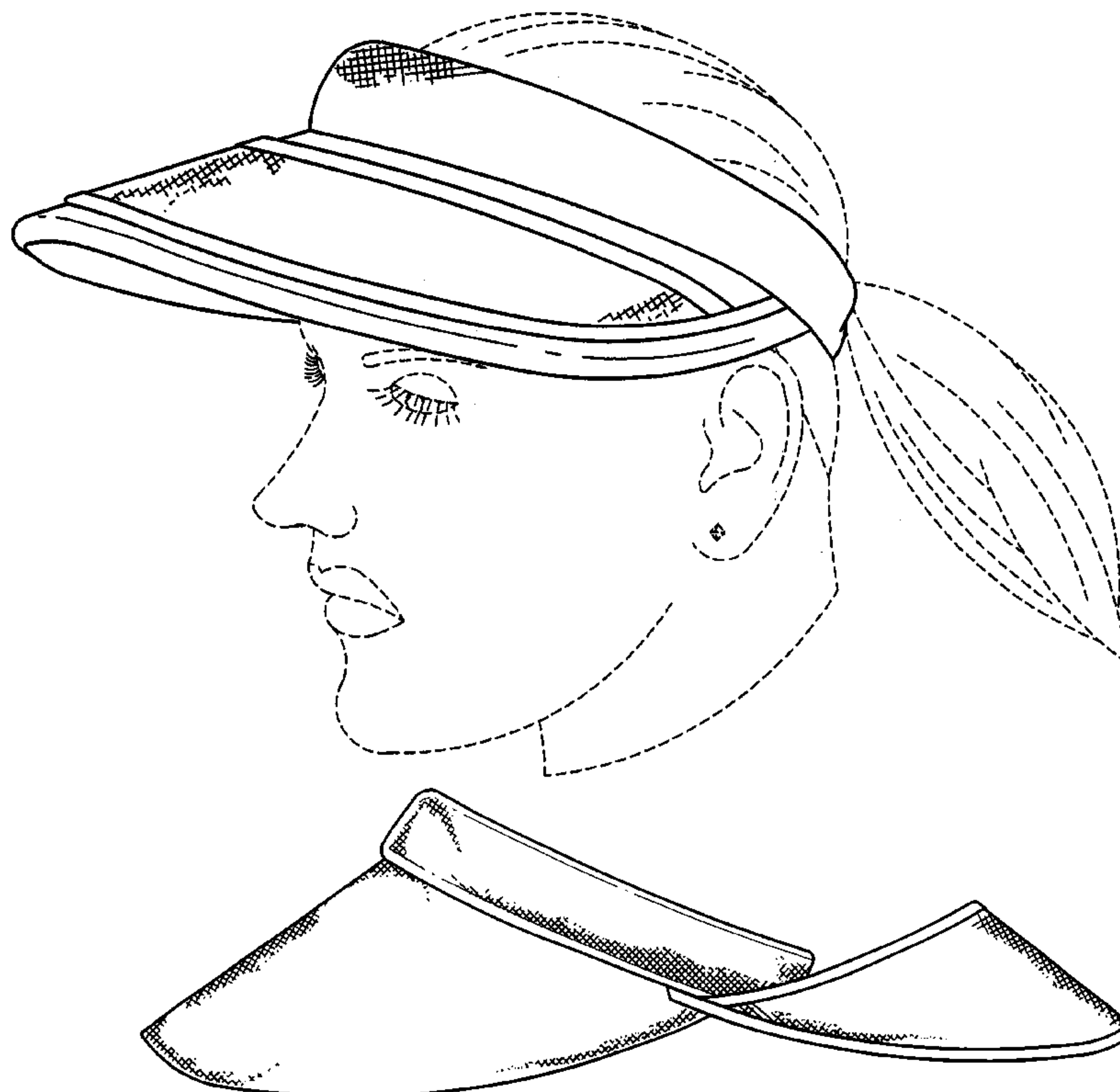
(57) **CLAIM**

I claim the ornamental design for an visor cap, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of my visor cap;
FIG. 2 is a right front top perspective view thereof;
FIG. 3 is a left side elevational view thereof with the right side elevational view being a mirror image thereof;
FIG. 4 is a top view thereof;
FIG. 5 is a bottom view thereof;
FIG. 6 is a front view thereof;
FIG. 7 is a rear view thereof; and,
FIG. 8 is a right side elevational view showing the top visor element of the previous figures in the rearward position.
The portions shown in broken lines are for illustrative purposes only, and form no part of the claimed design.

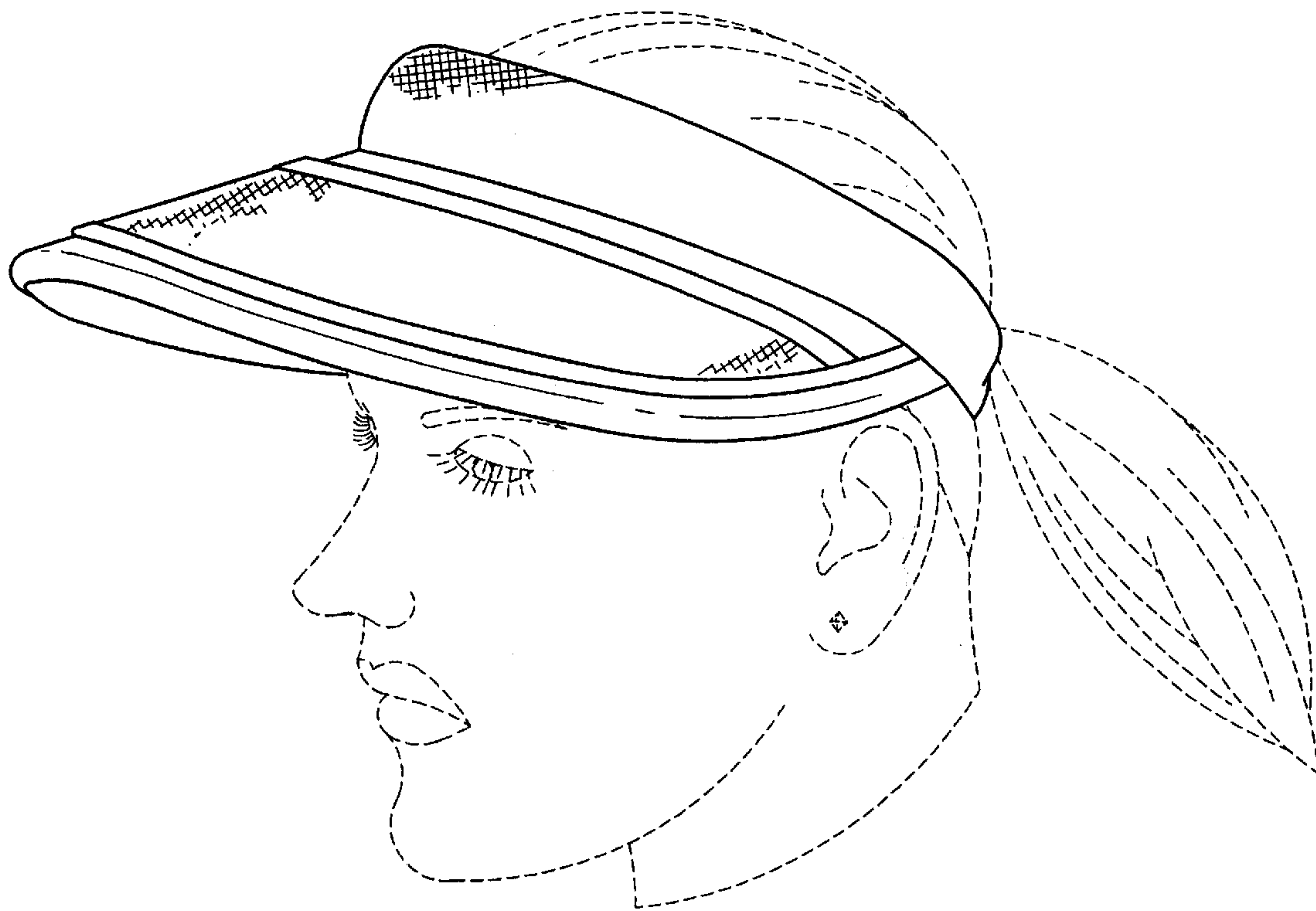

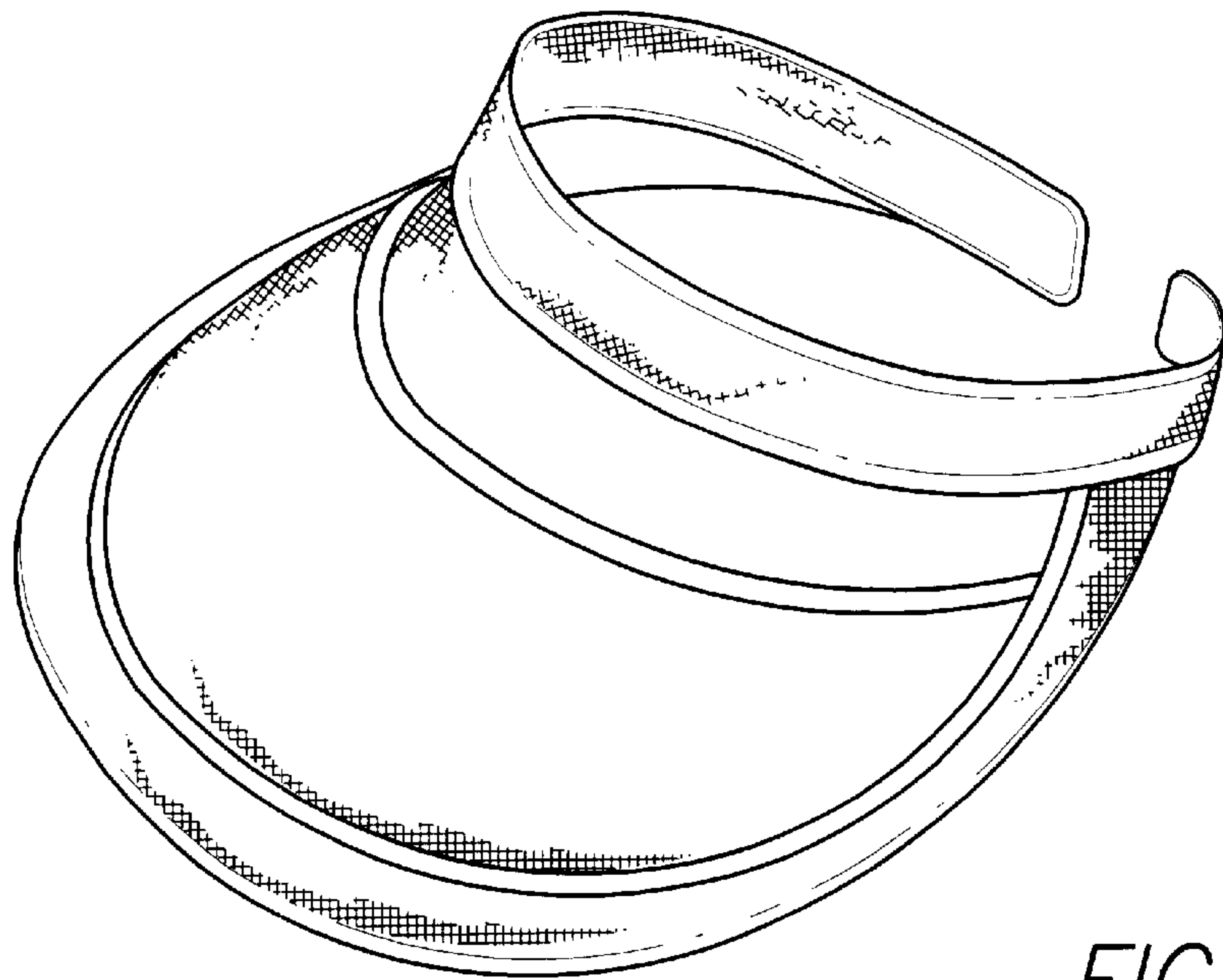

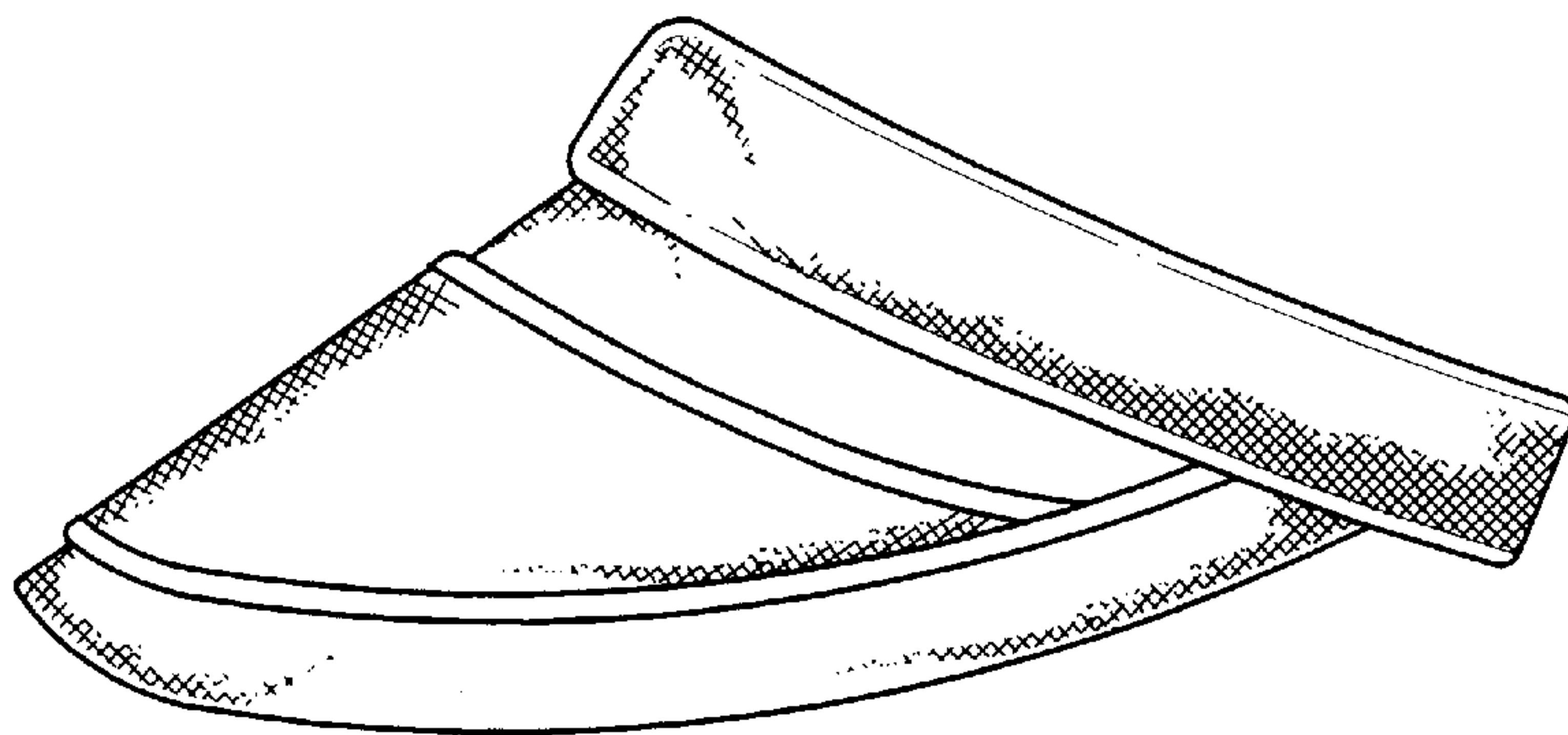

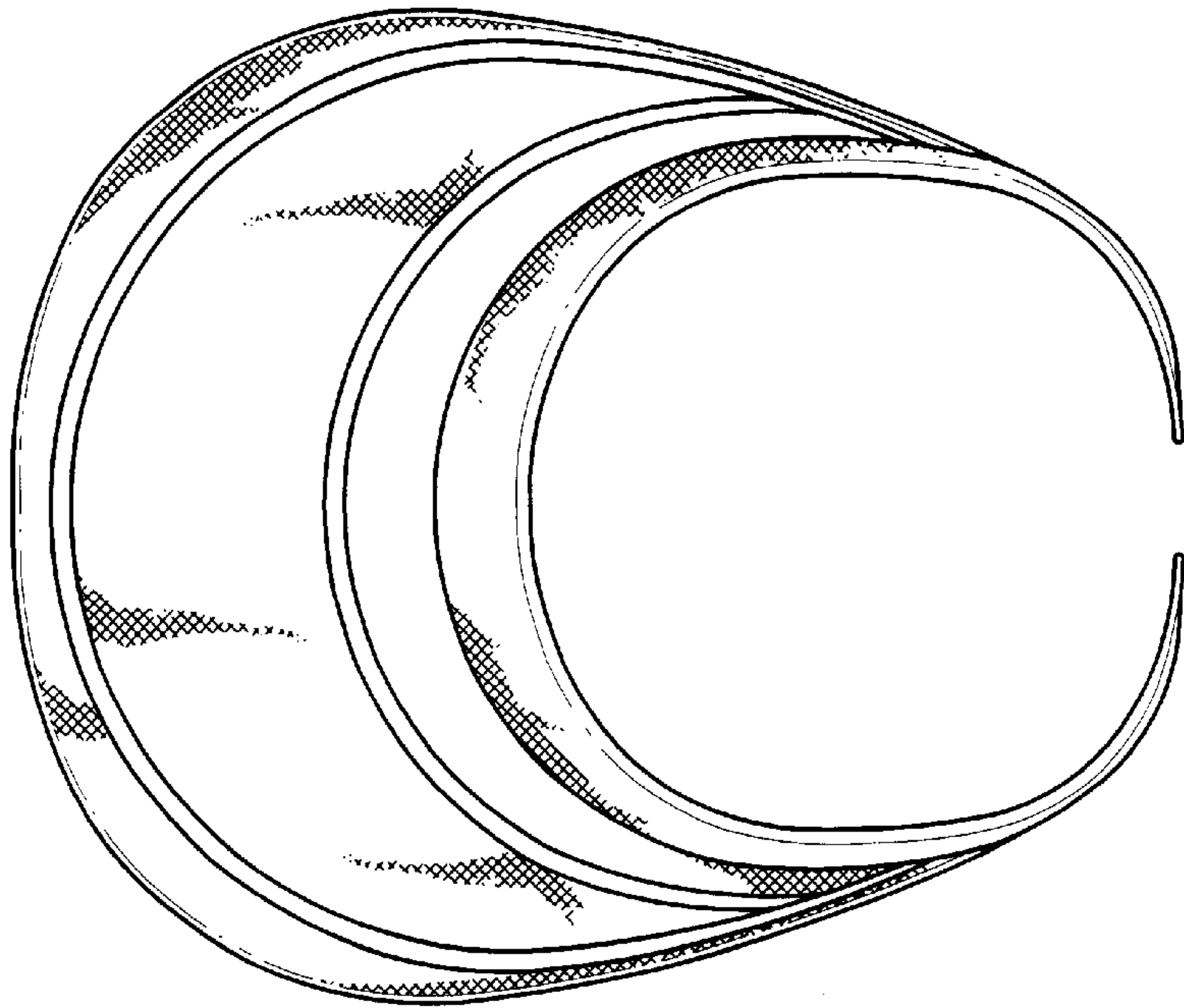

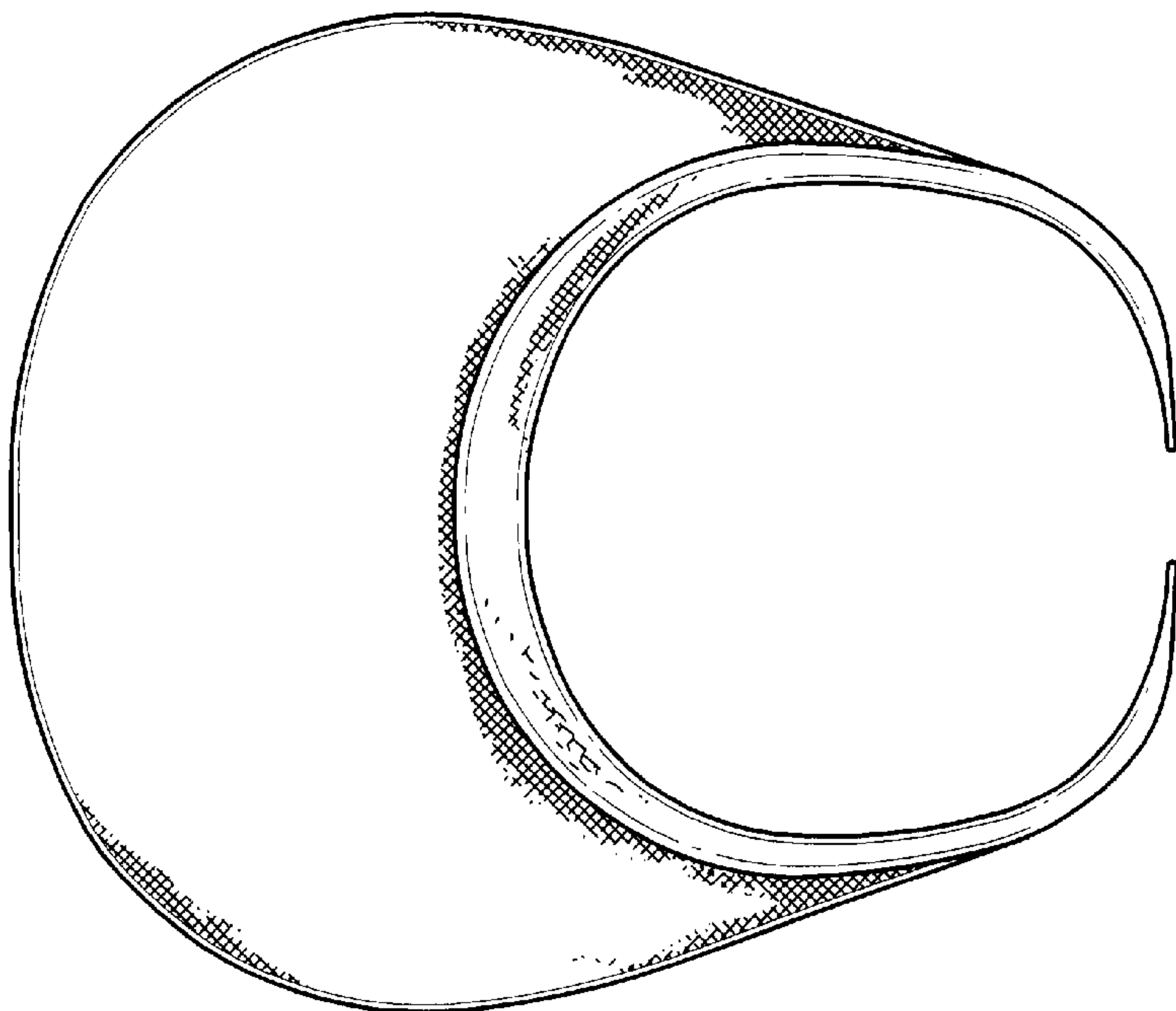

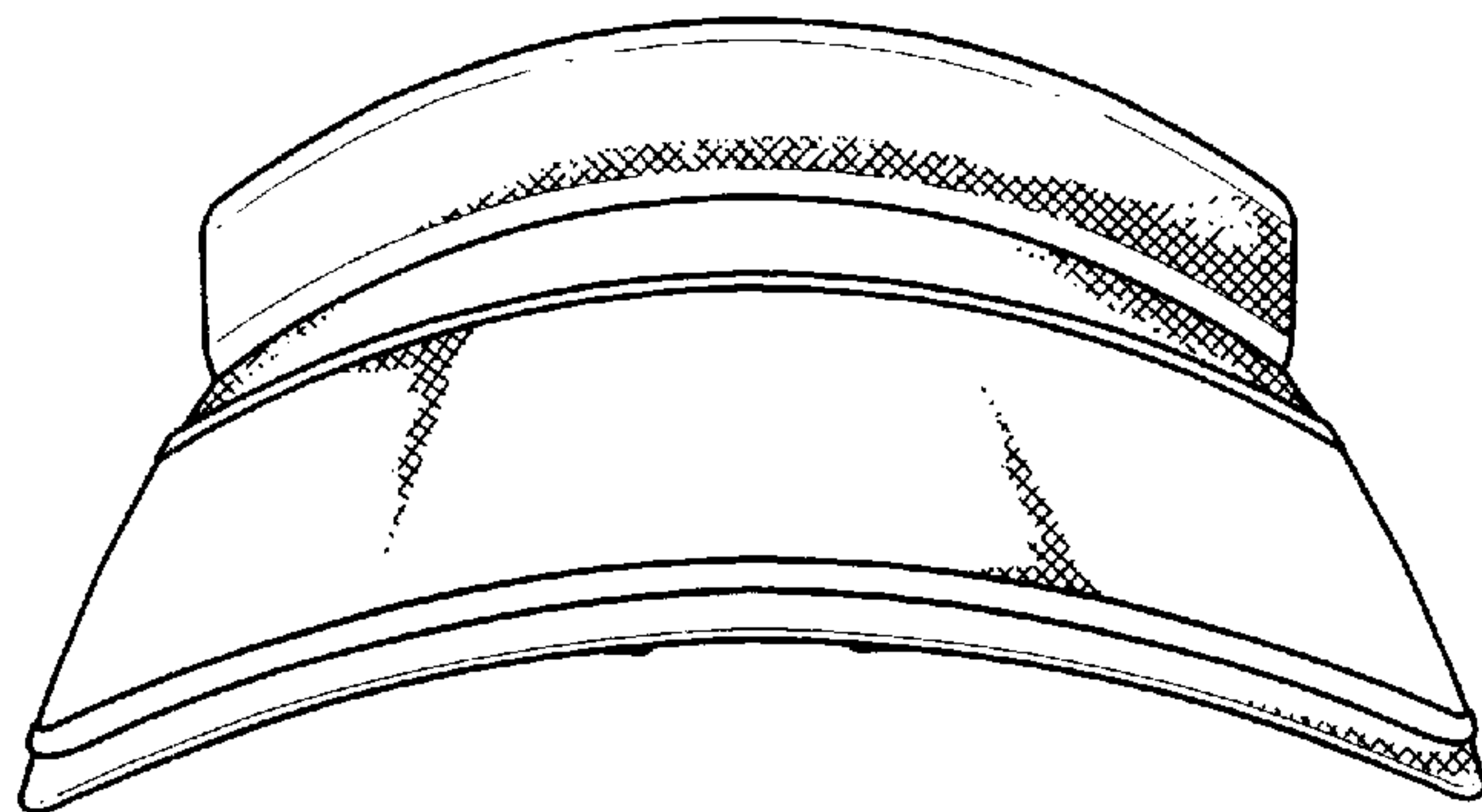

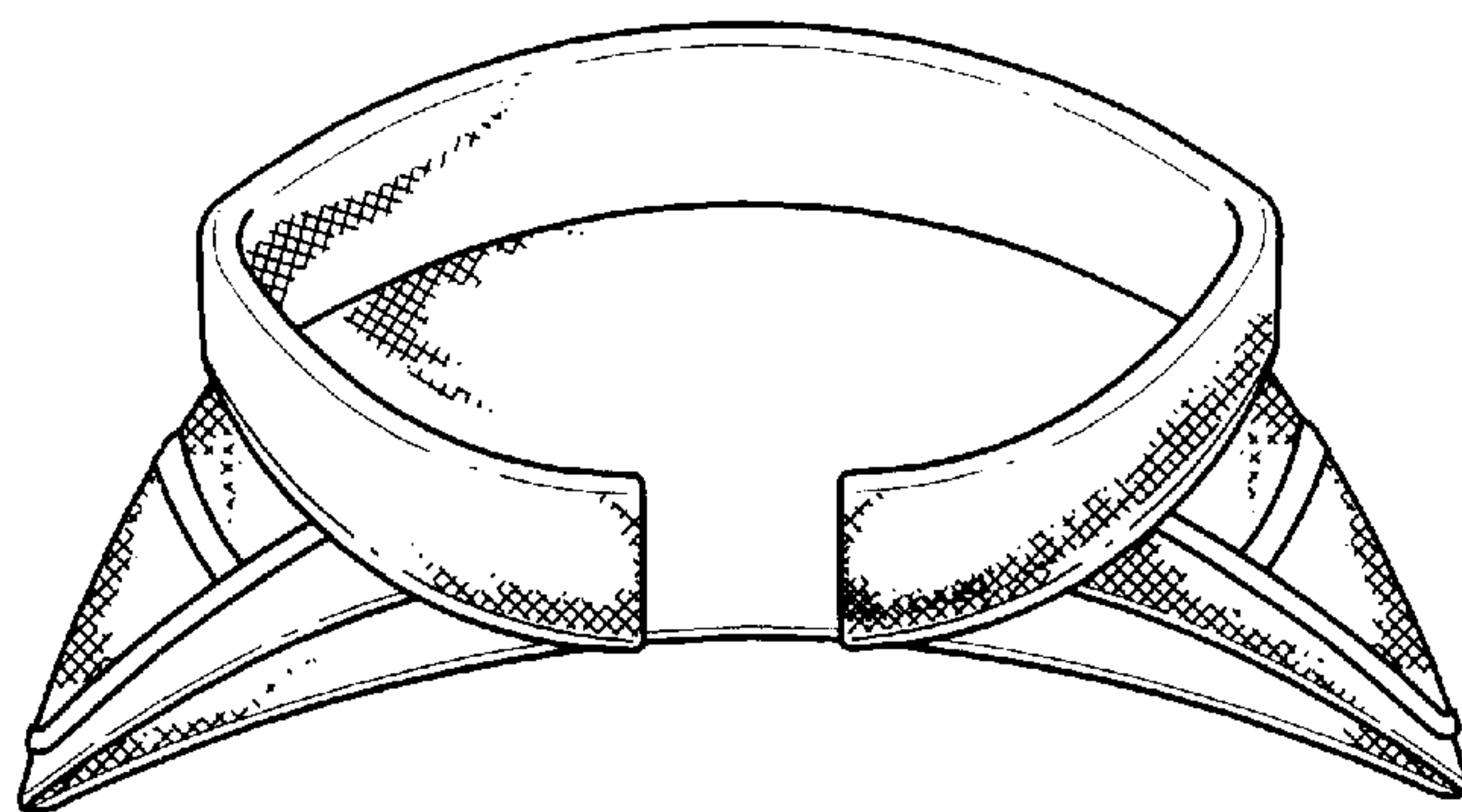

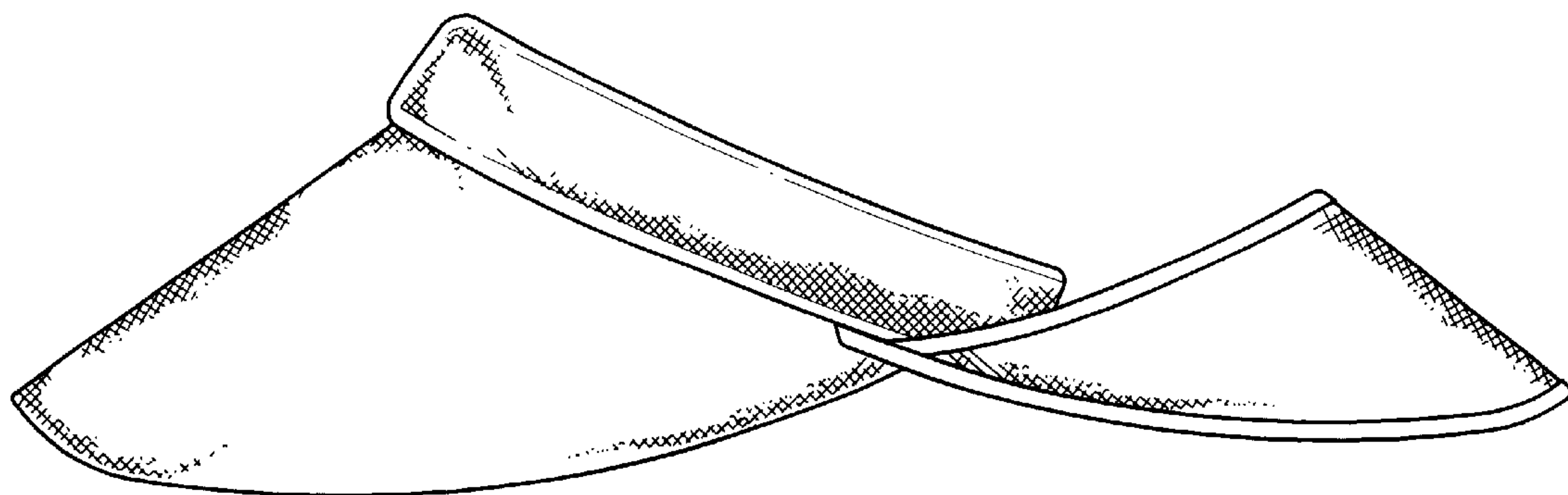
