(57) **CLAIM**

The ornamental design for a storage bag for three reels, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a storage bag for three reels, according to the present invention;

FIG. 2 is a side view of the storage bag for three reels, according to the present invention;

FIG. 3 is a second side view of the storage bag for three reels, according to the present invention;

FIG. 4 is an end view of the storage bag for three reels, according to the present invention;

FIG. 5 is a second end view of the three piece bag for storage of reels, according to the present invention;

FIG. 6 is a top view of the storage bag for three reels, according to the present invention;

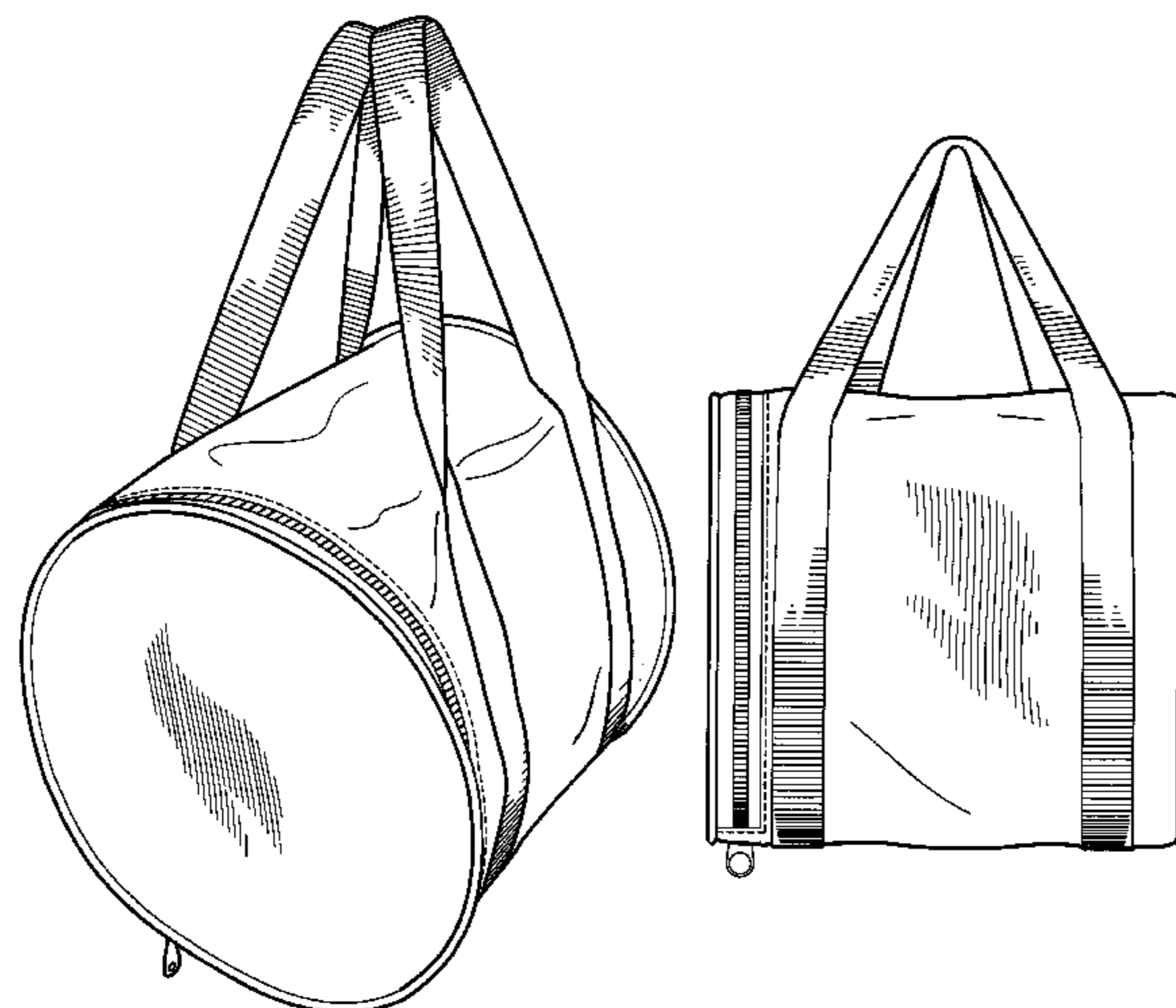
FIG. 7 is a bottom view of the storage bag for three reels, according to the present invention;

FIG. 8 is a partial cutaway view of the storage bag for three reels, according to the present invention, illustrating the placement of the storage bag for three reels within the package;

FIG. 9 is a partial cutaway side view of the storage bag for three reels, according to the present invention, illustrating the placement of the storage reels within the bag; and,

FIG. 10 is a partial cutaway end view of the storage bag for three reels, according to the present invention, illustrating the placement of the storage reels within the bag.

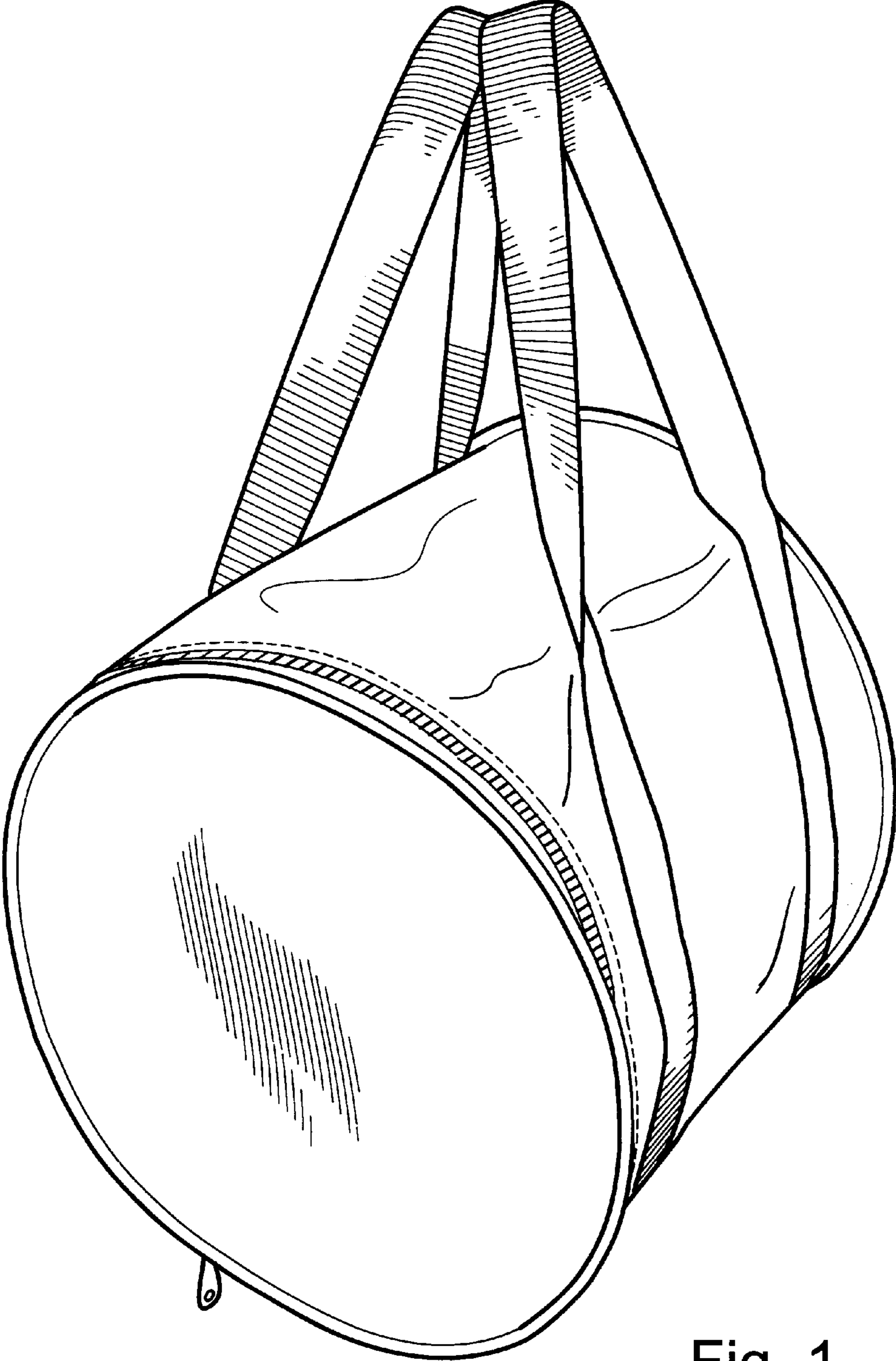

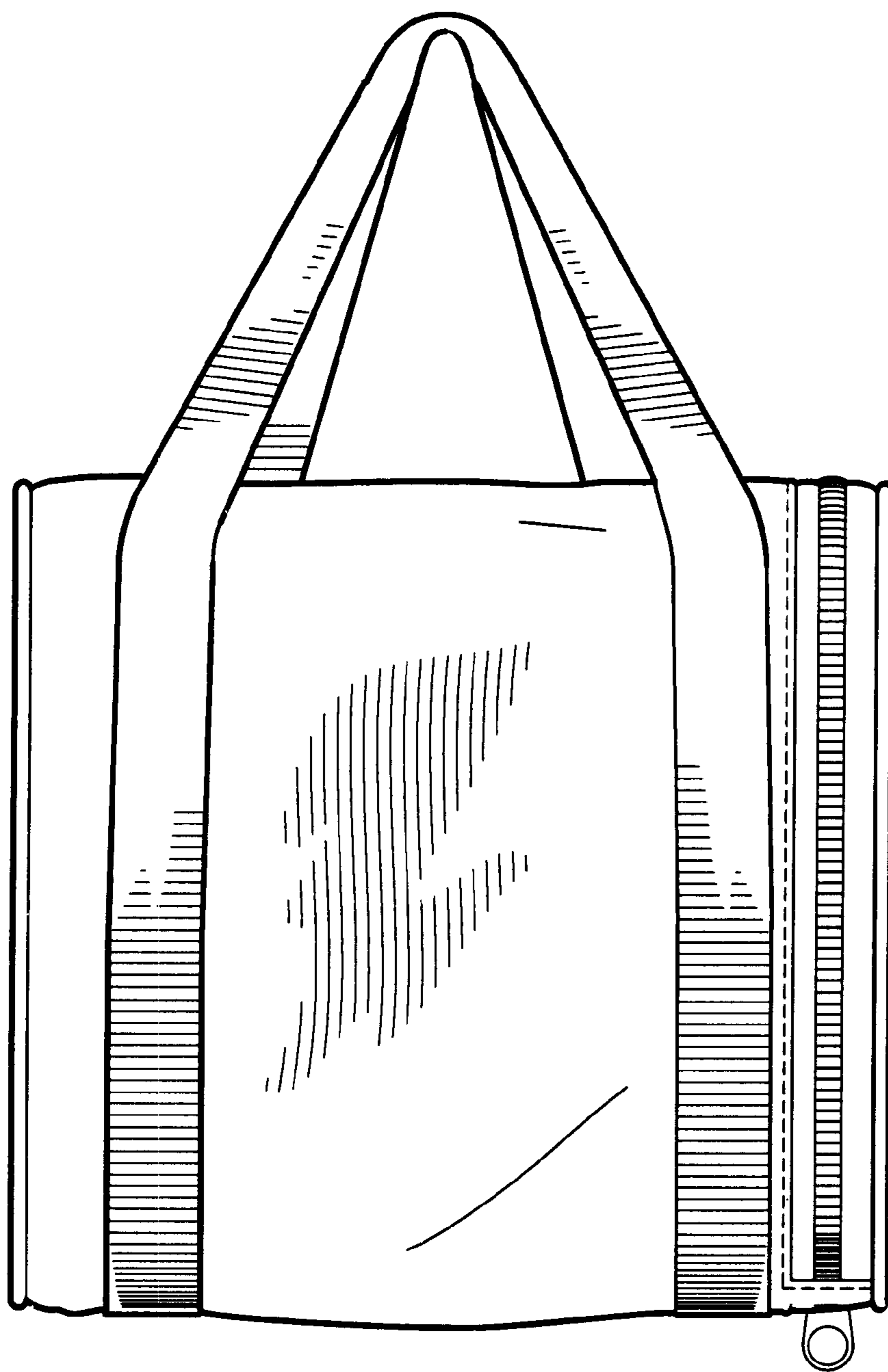

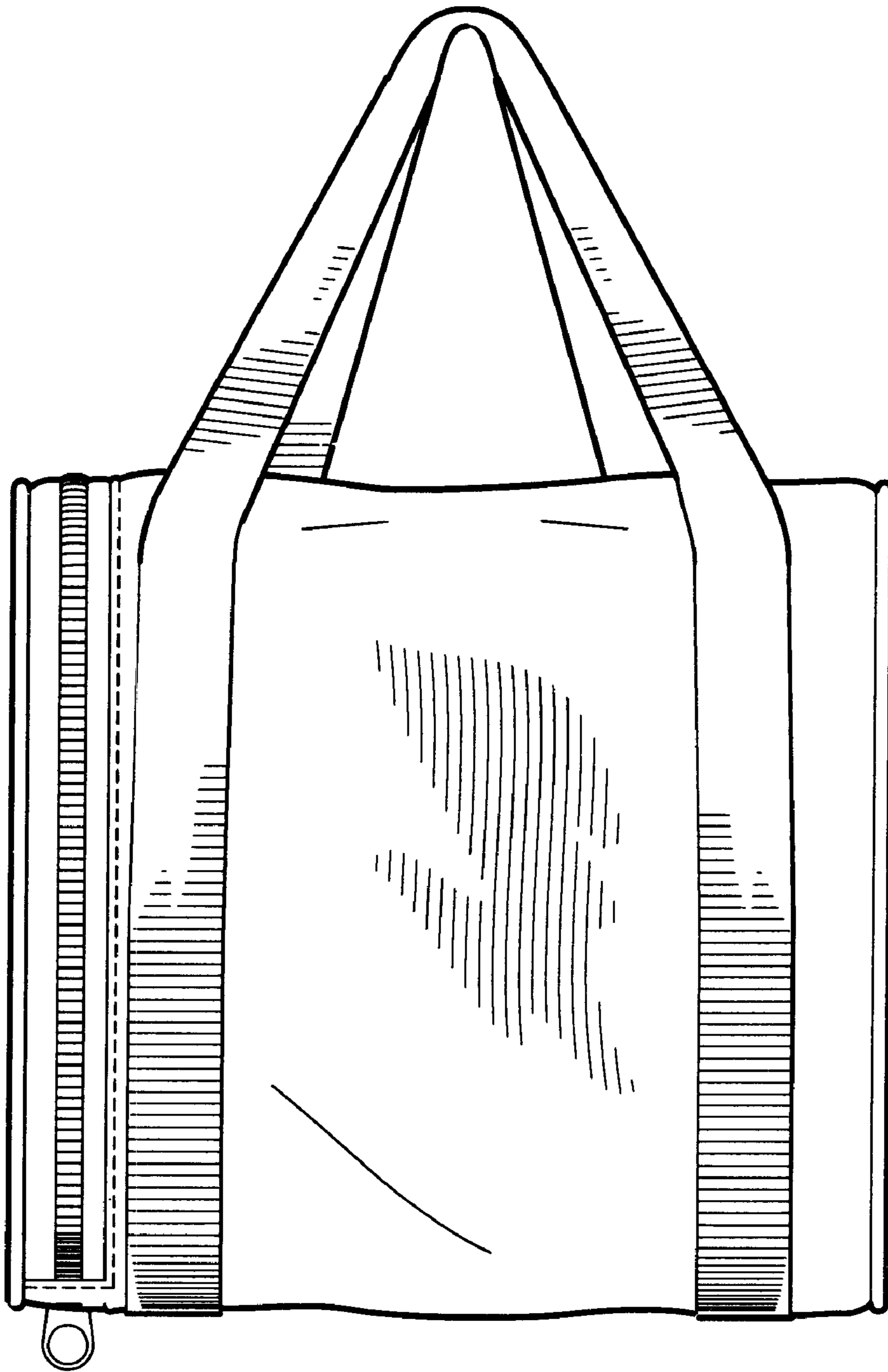

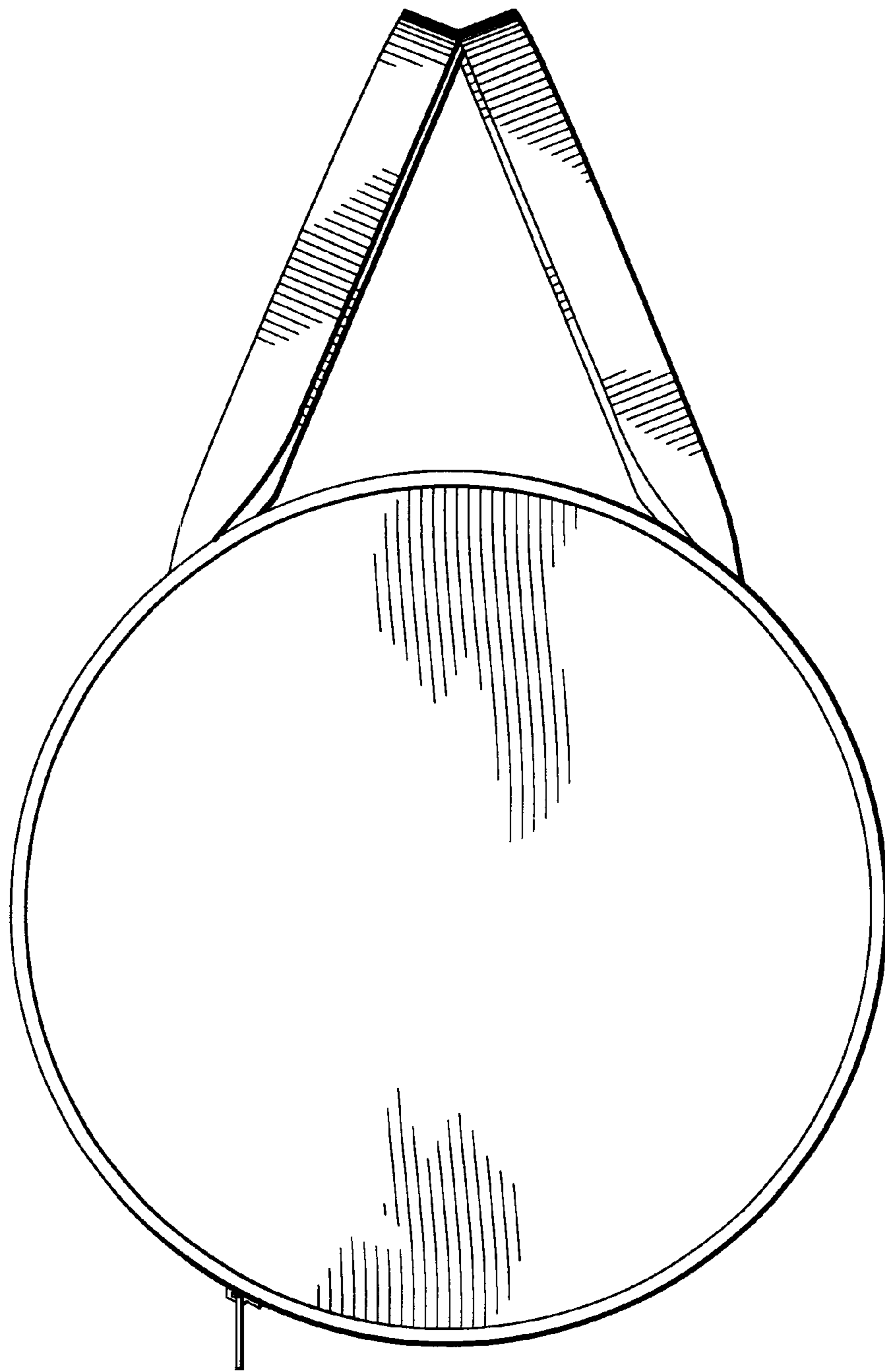

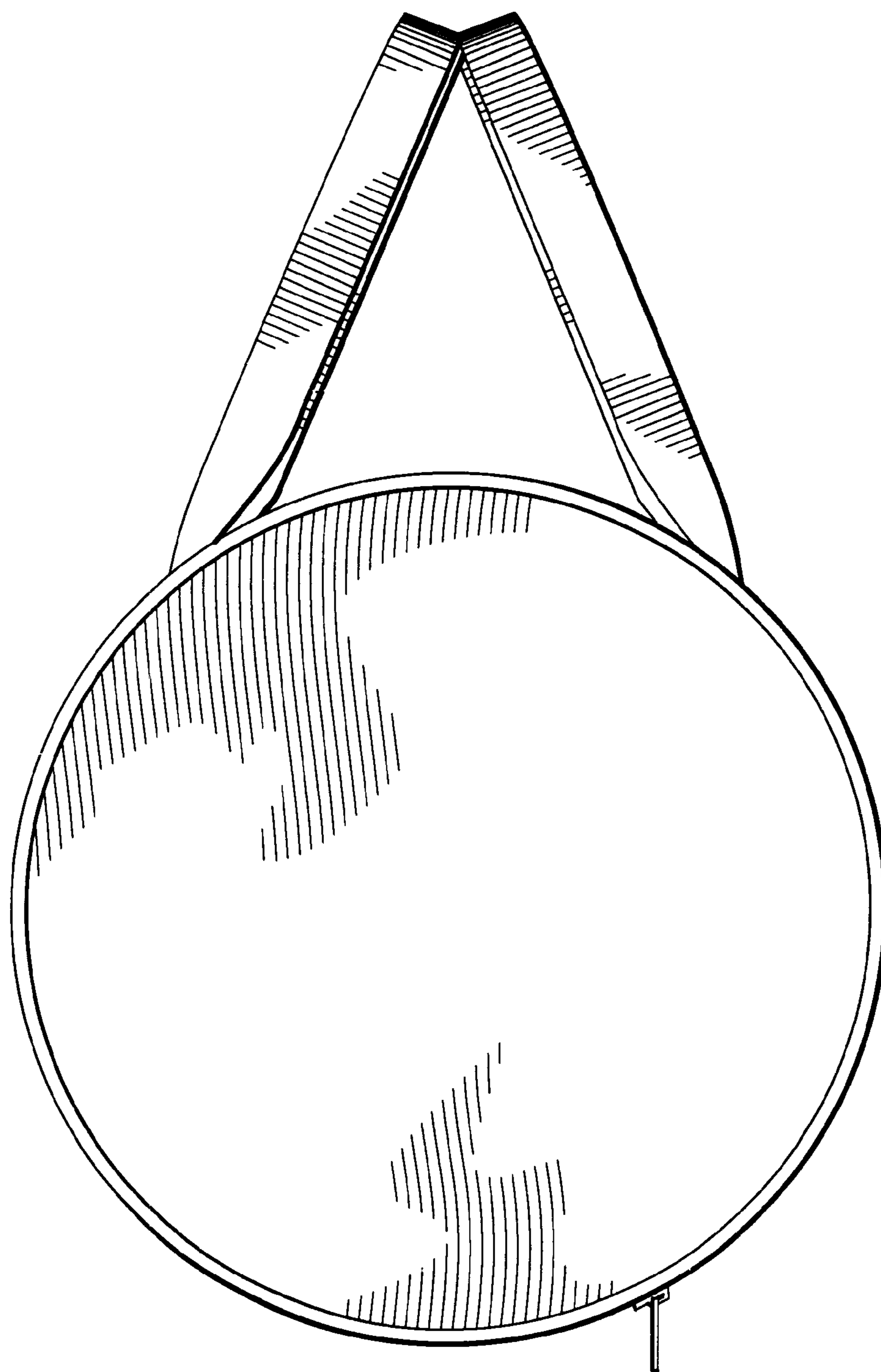

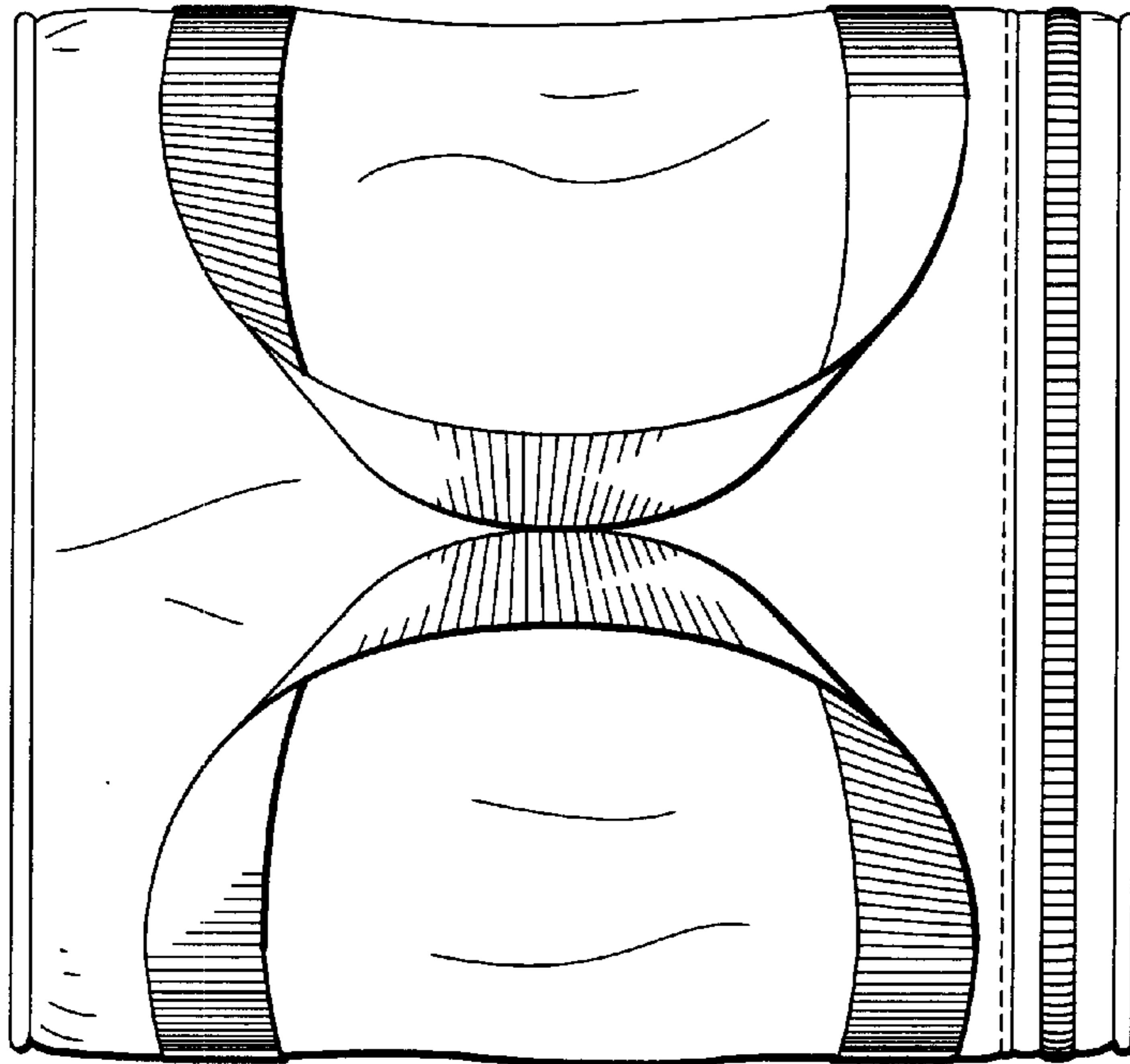

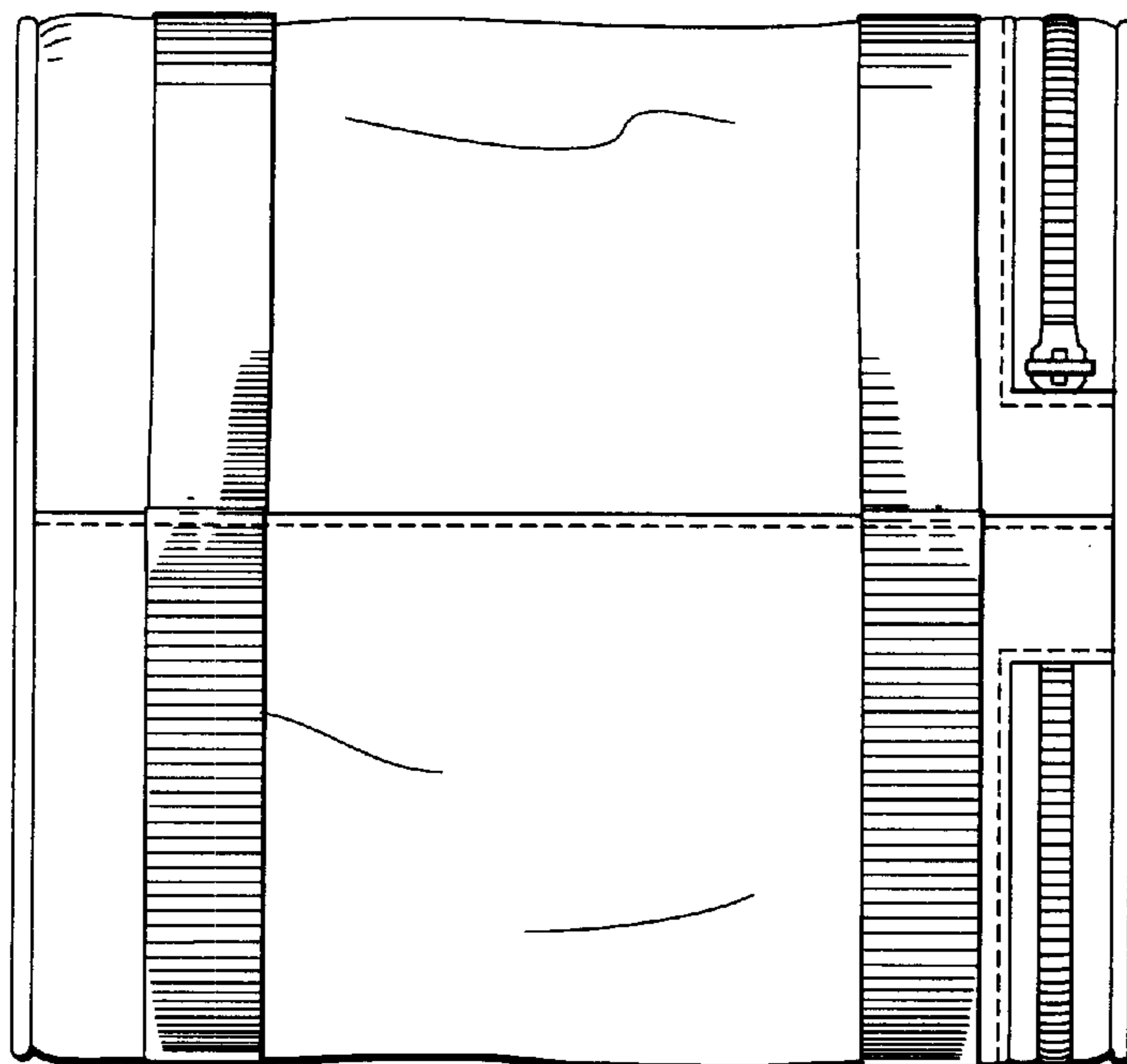

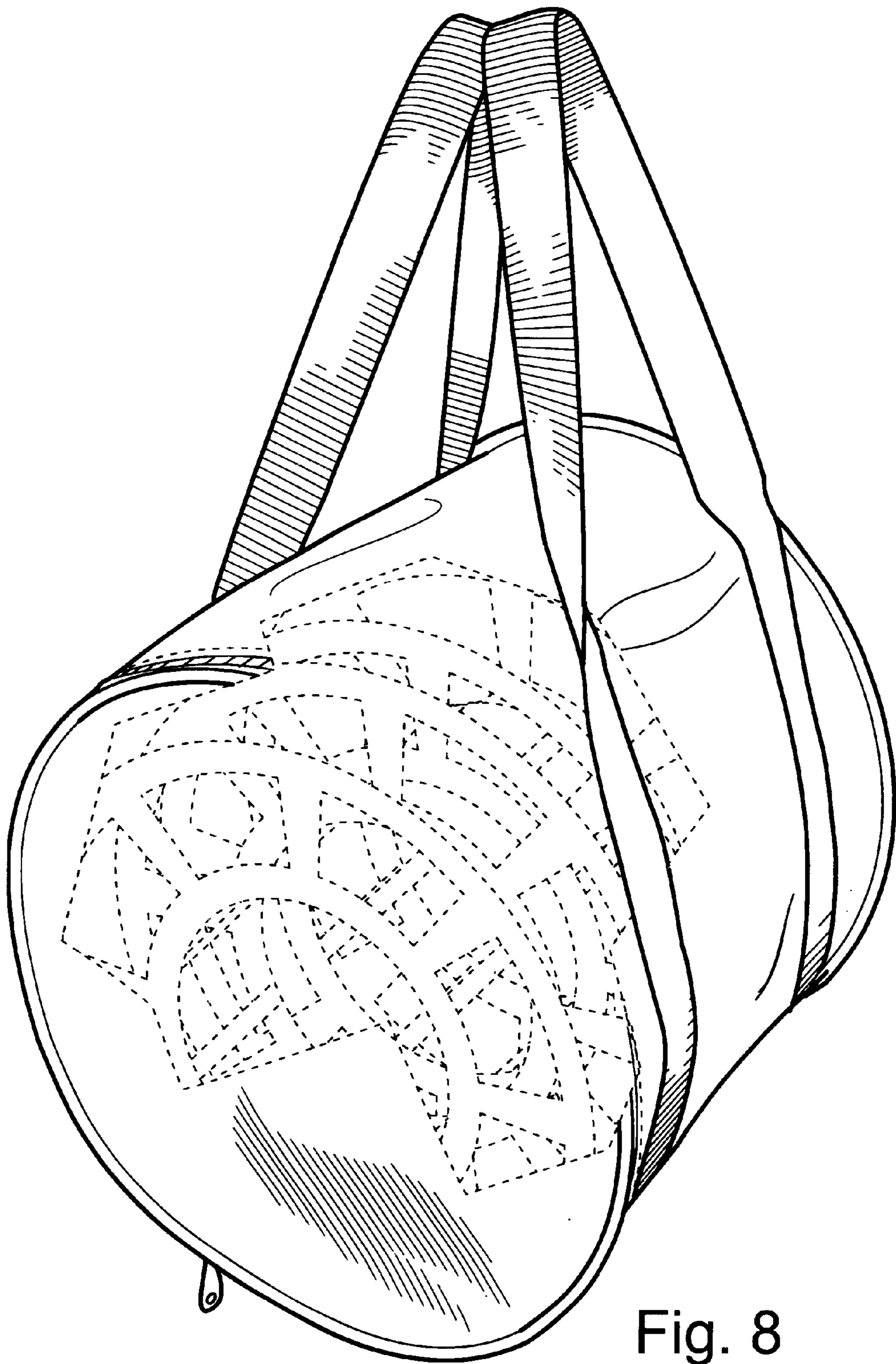

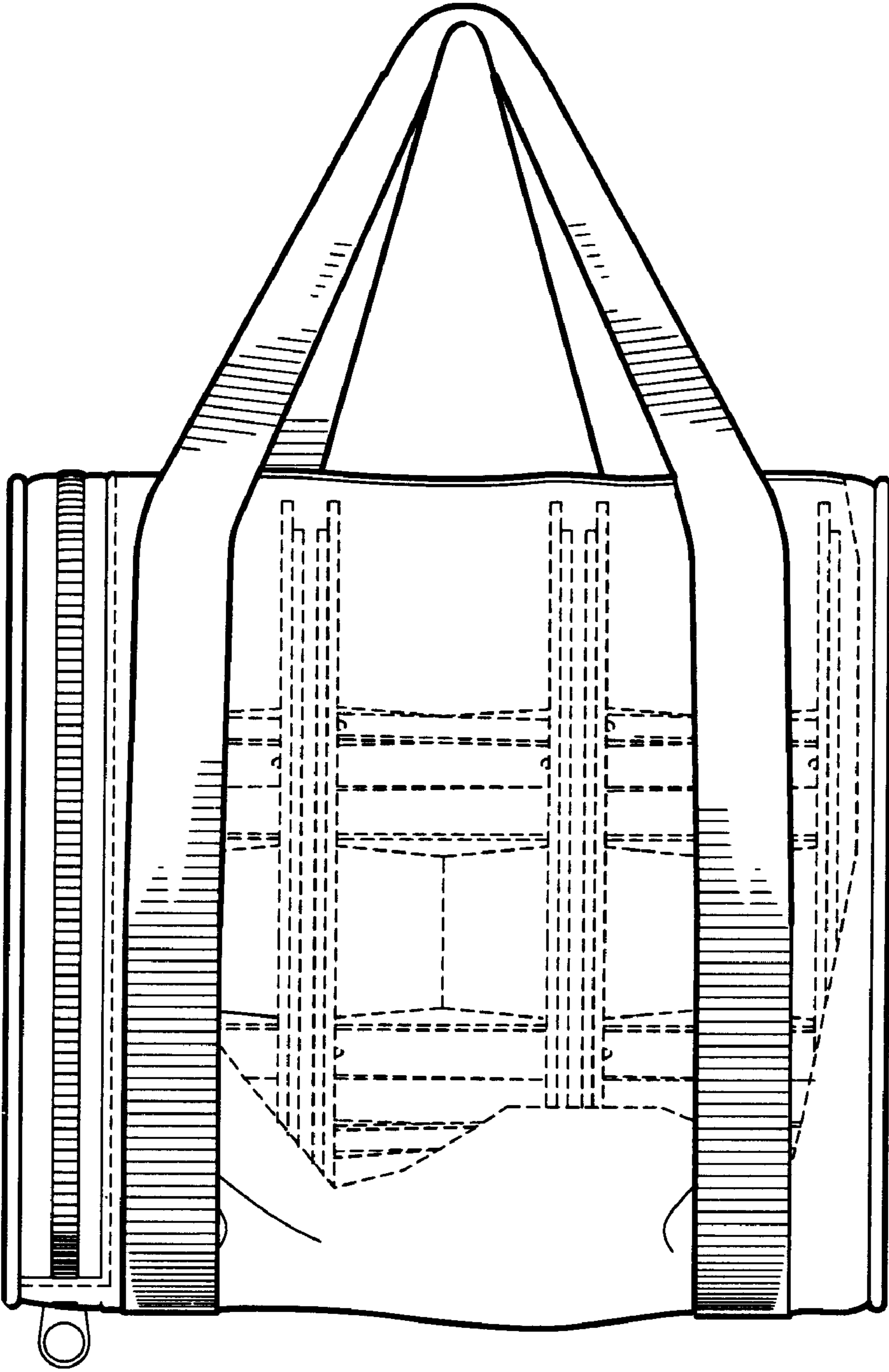

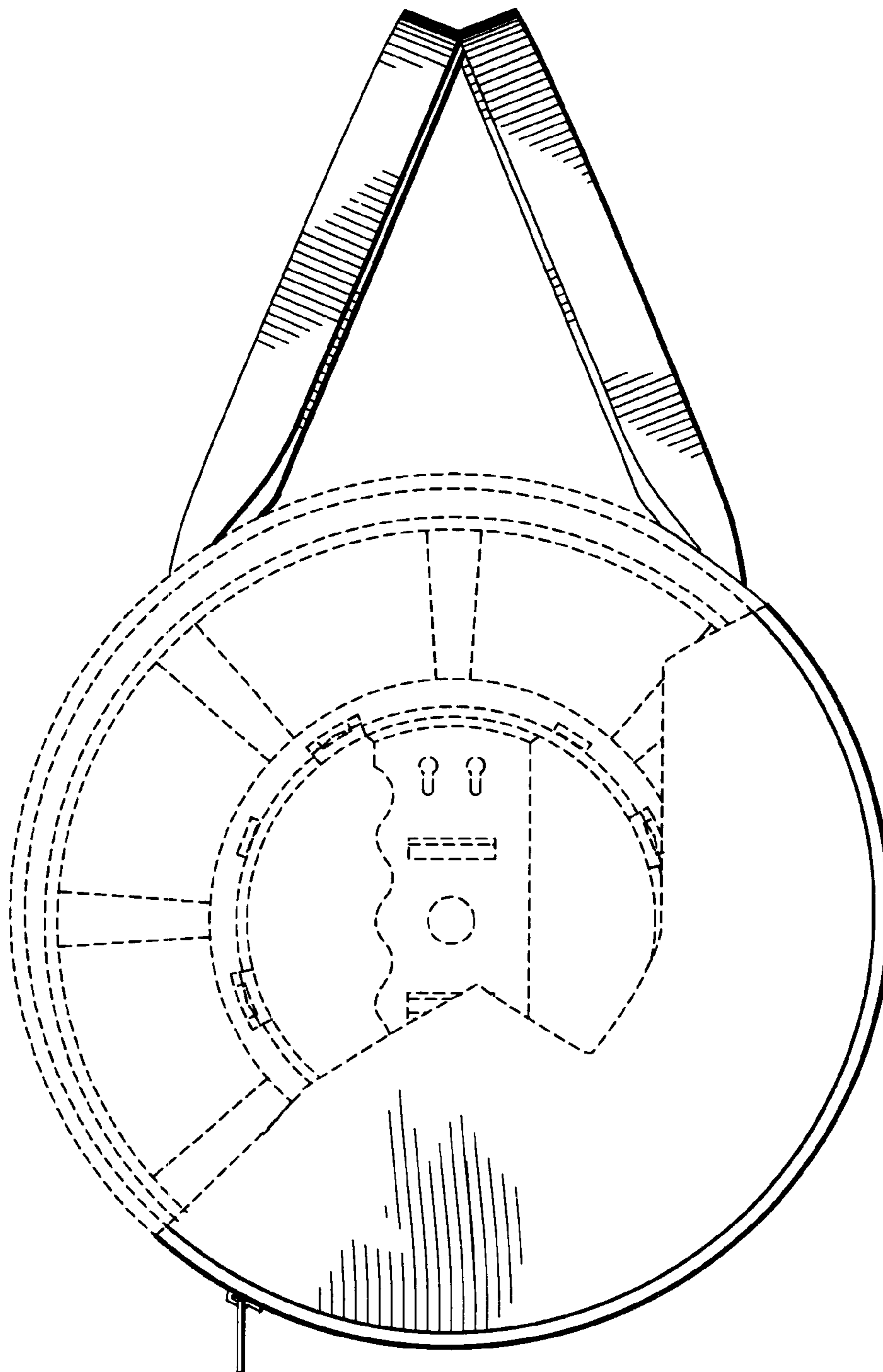
