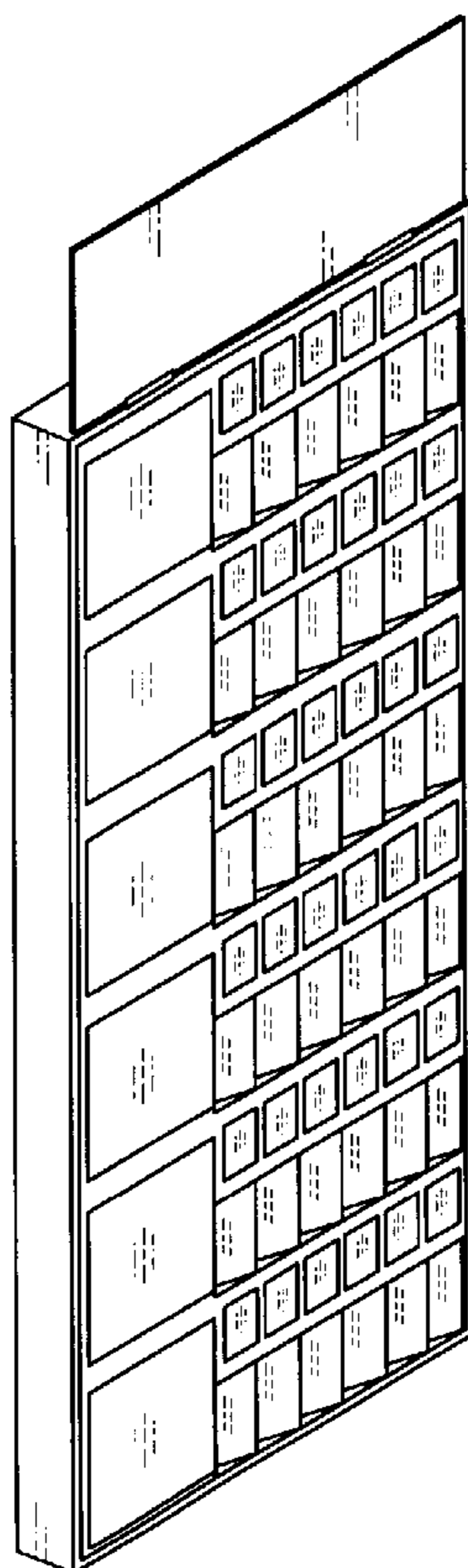

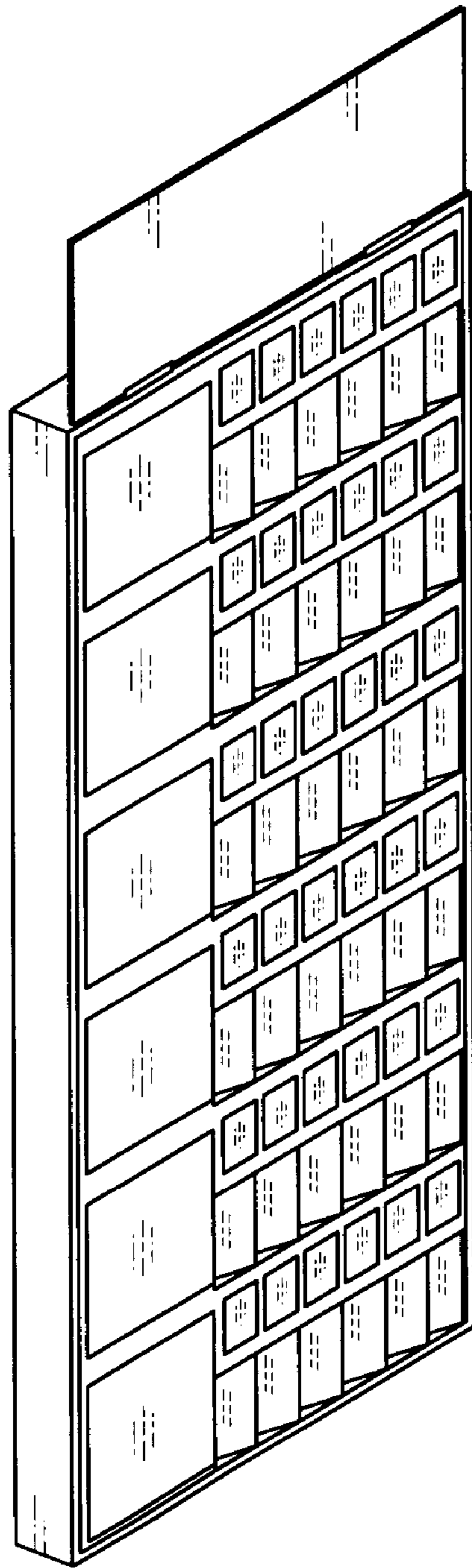
The ornamental design for the wallpaper display panel, as shown in the drawings and described above.

**DESCRIPTION**

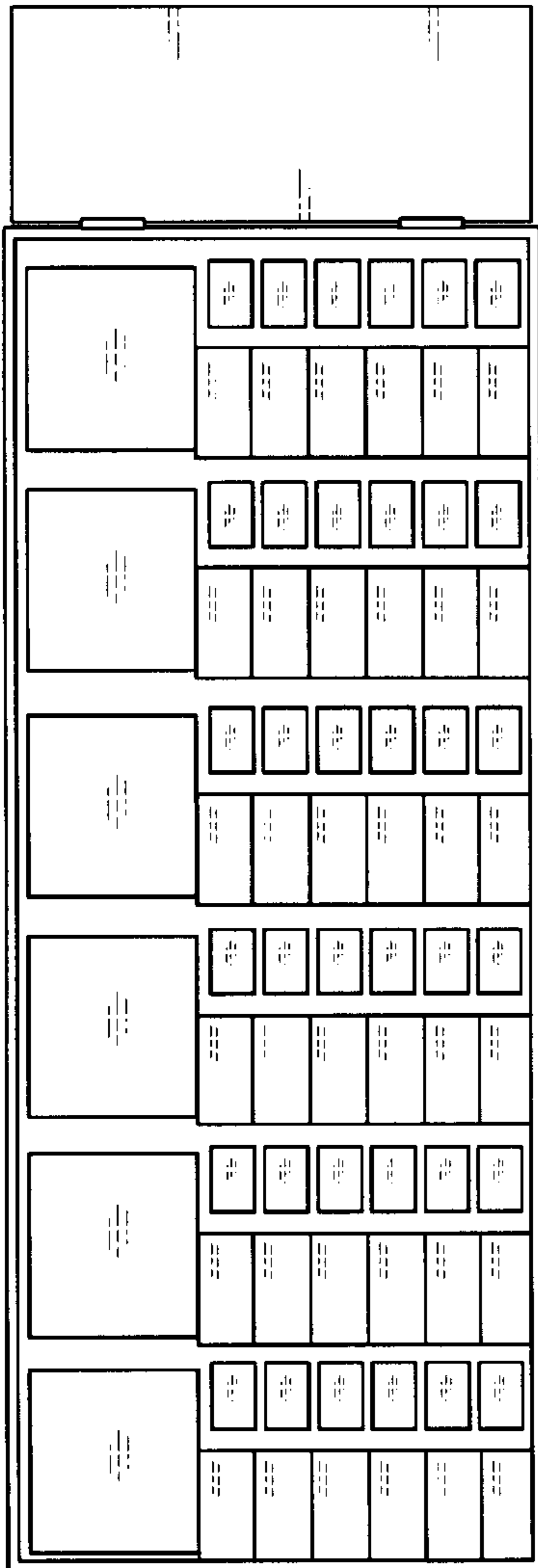
FIG. 1 is a side perspective view of the wallpaper display panel of the present invention.

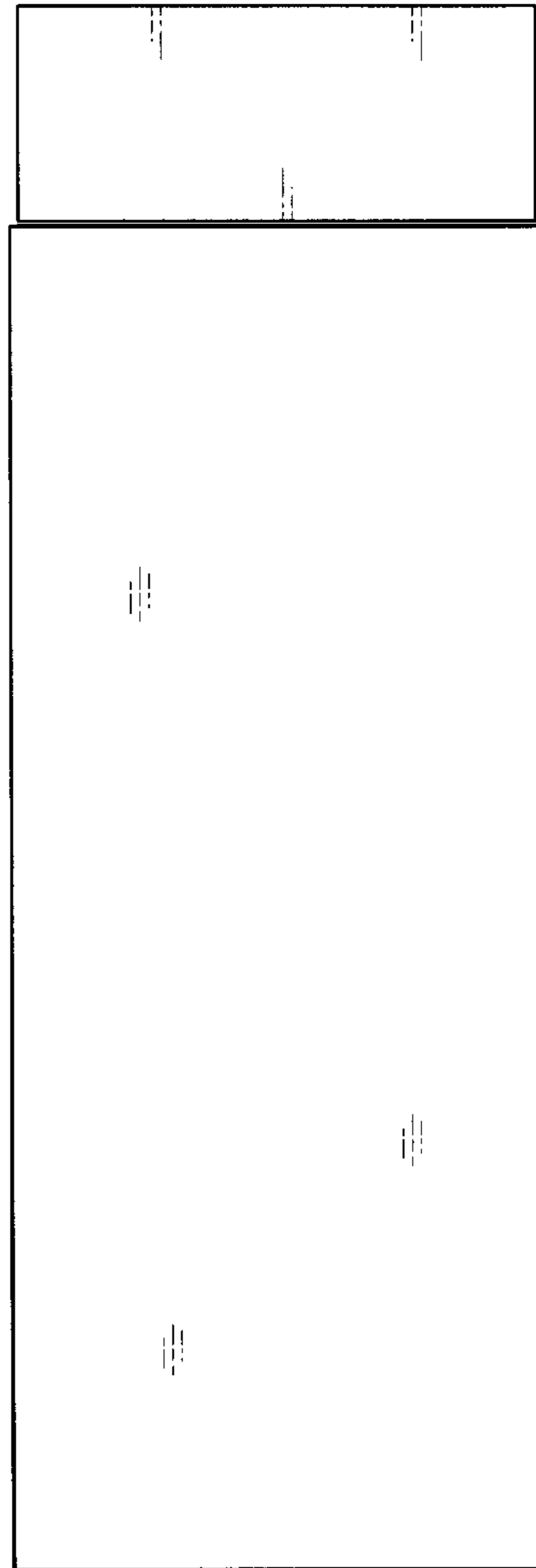




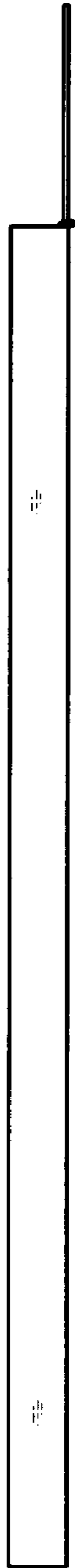
