(57) **CLAIM**

The ornamental design for a liquid dispenser assembly and
dispenser body portion, as shown and described.

DESCRIPTION

the liquid dispenser assembly.

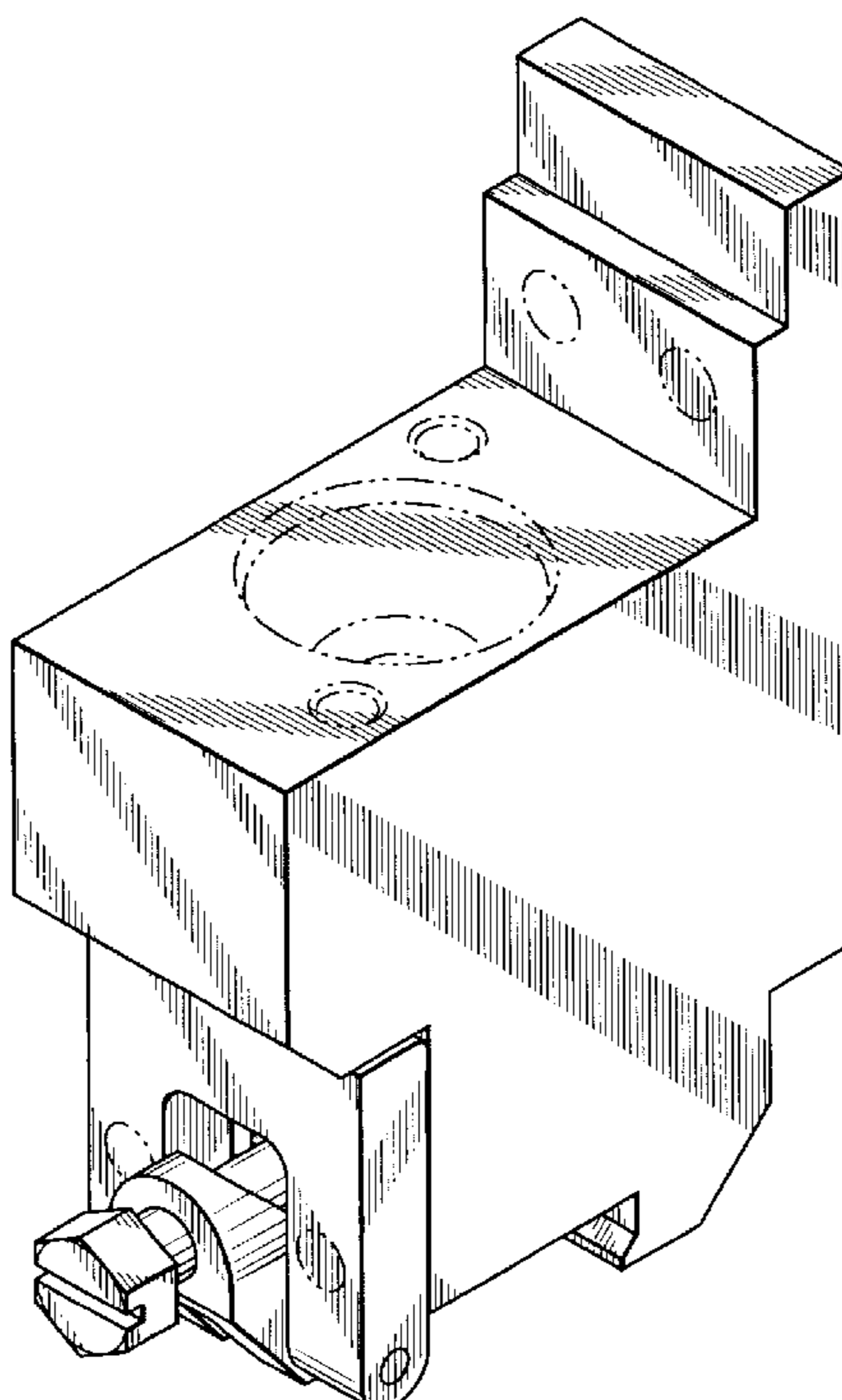
FIG. 12 is a left side view of the dispenser body portion of

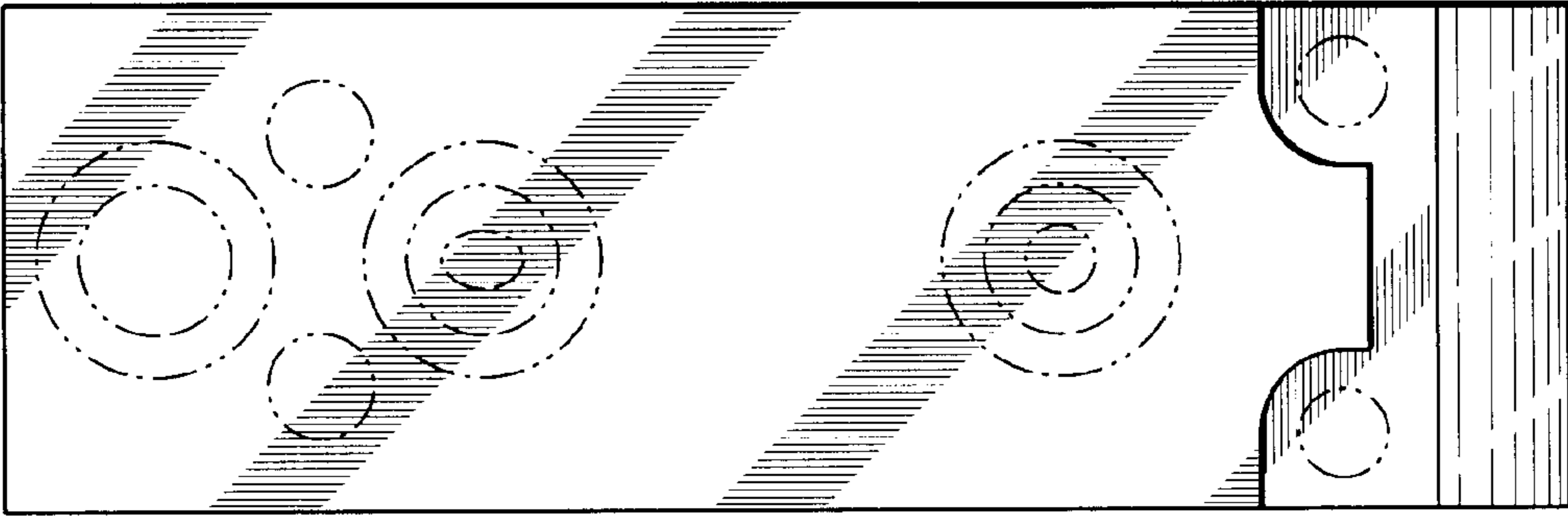

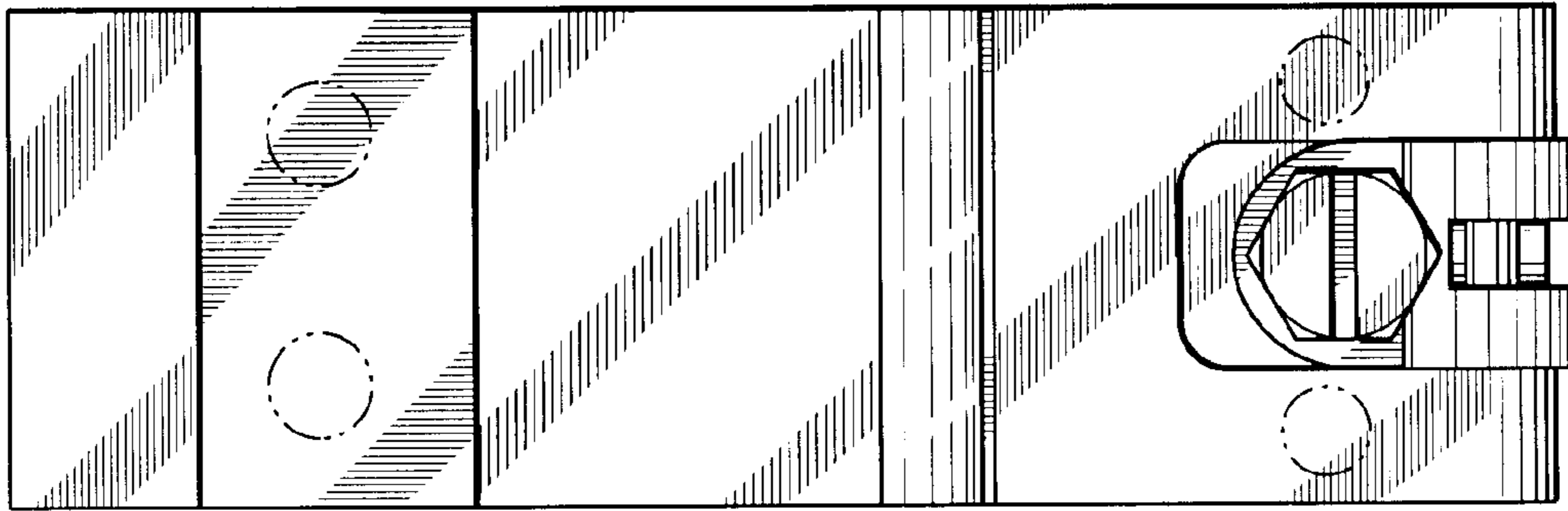

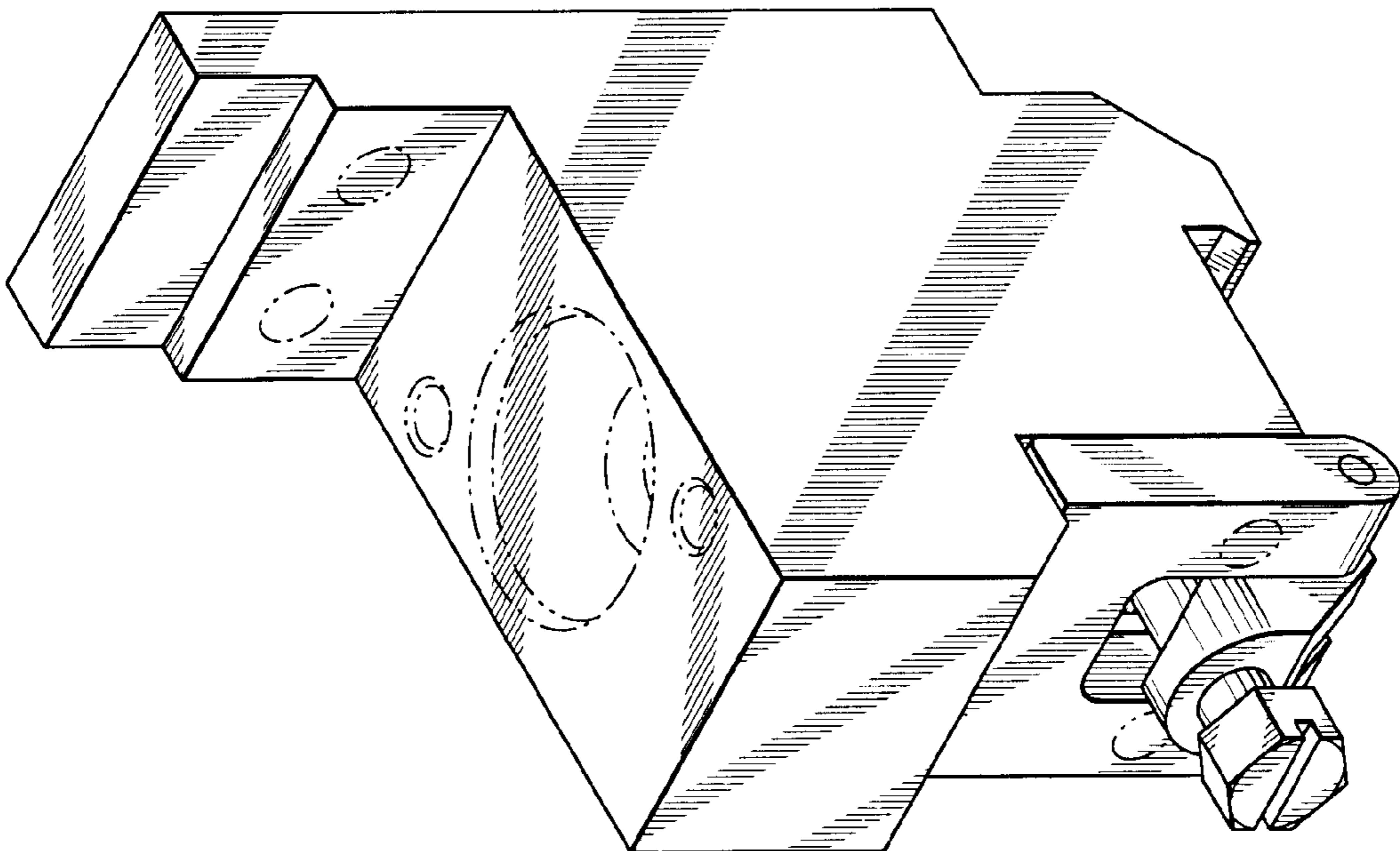

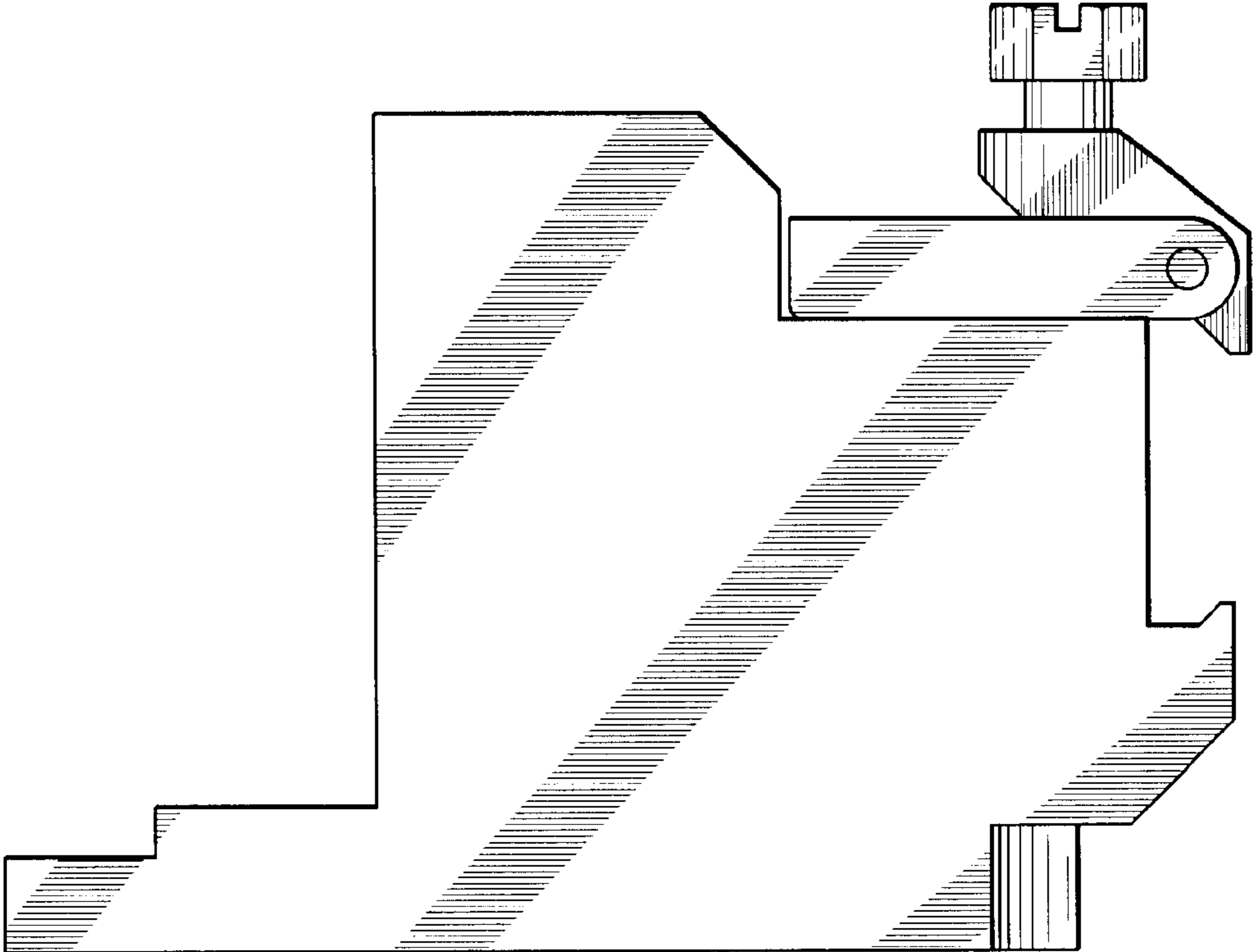

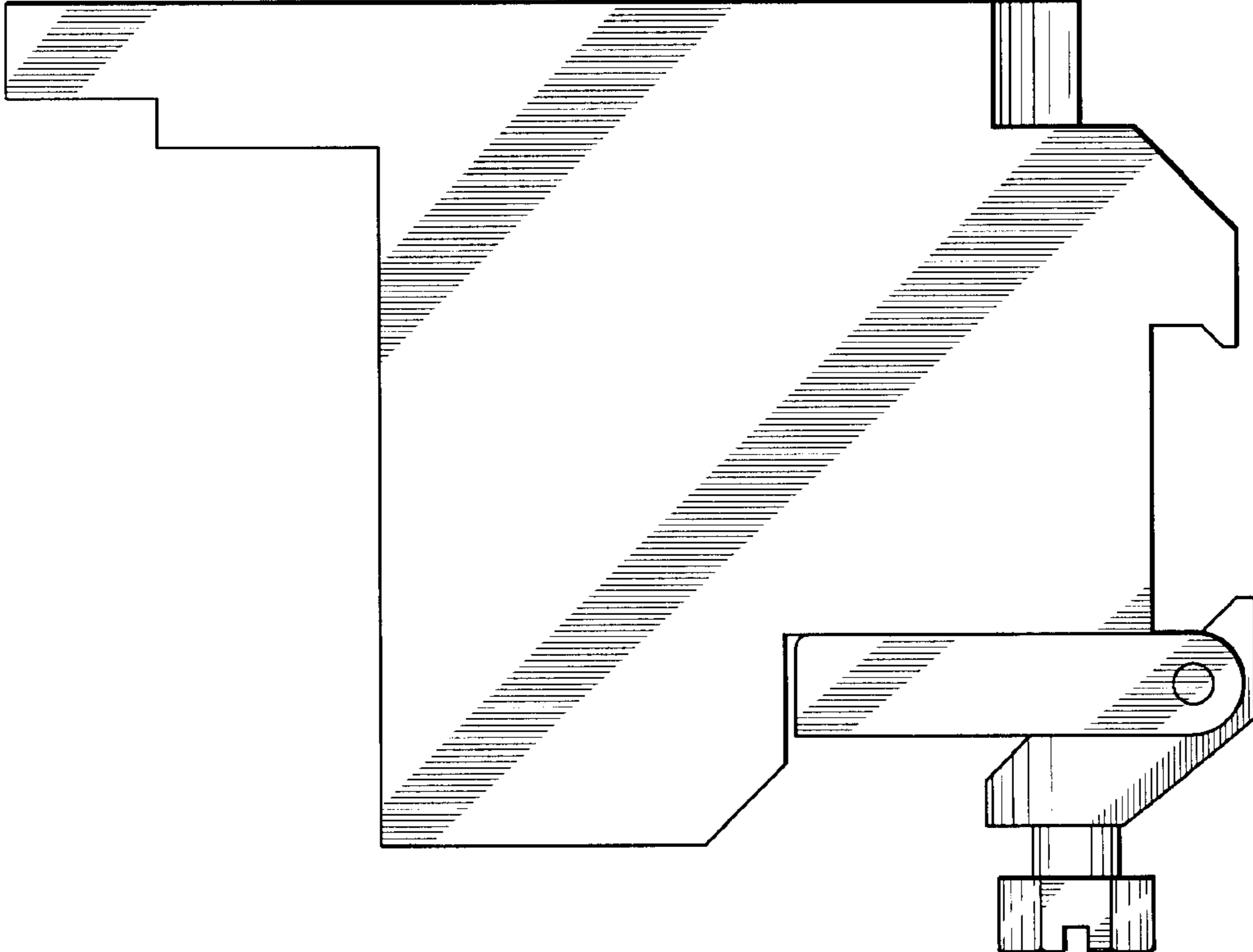

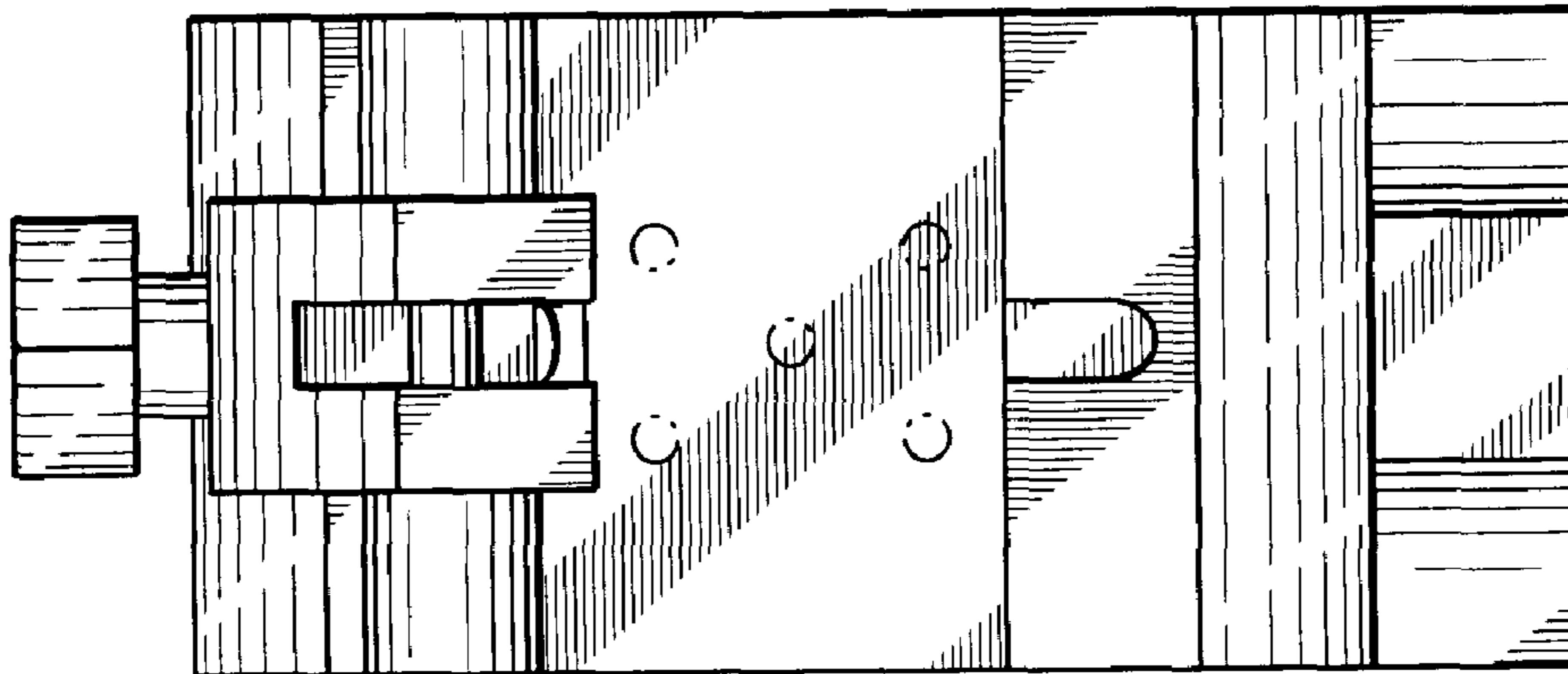

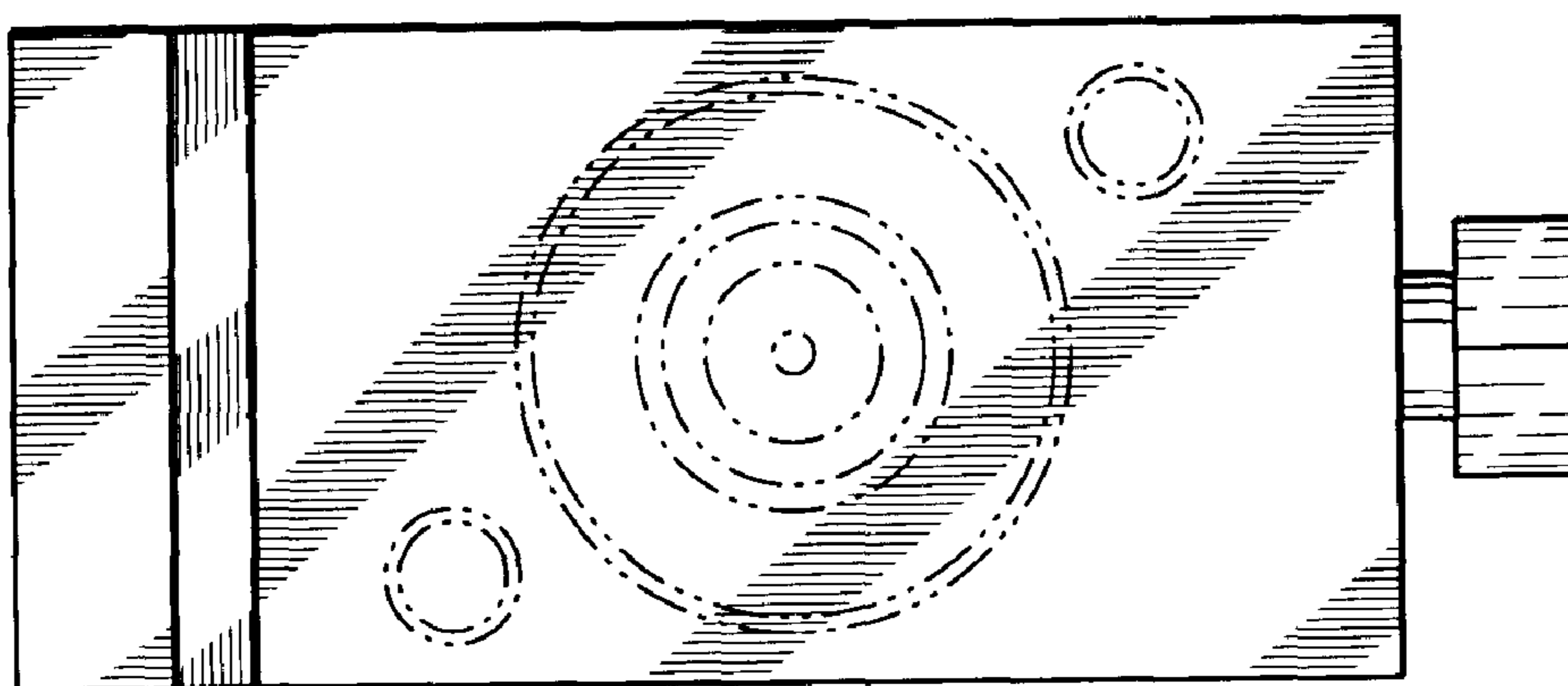

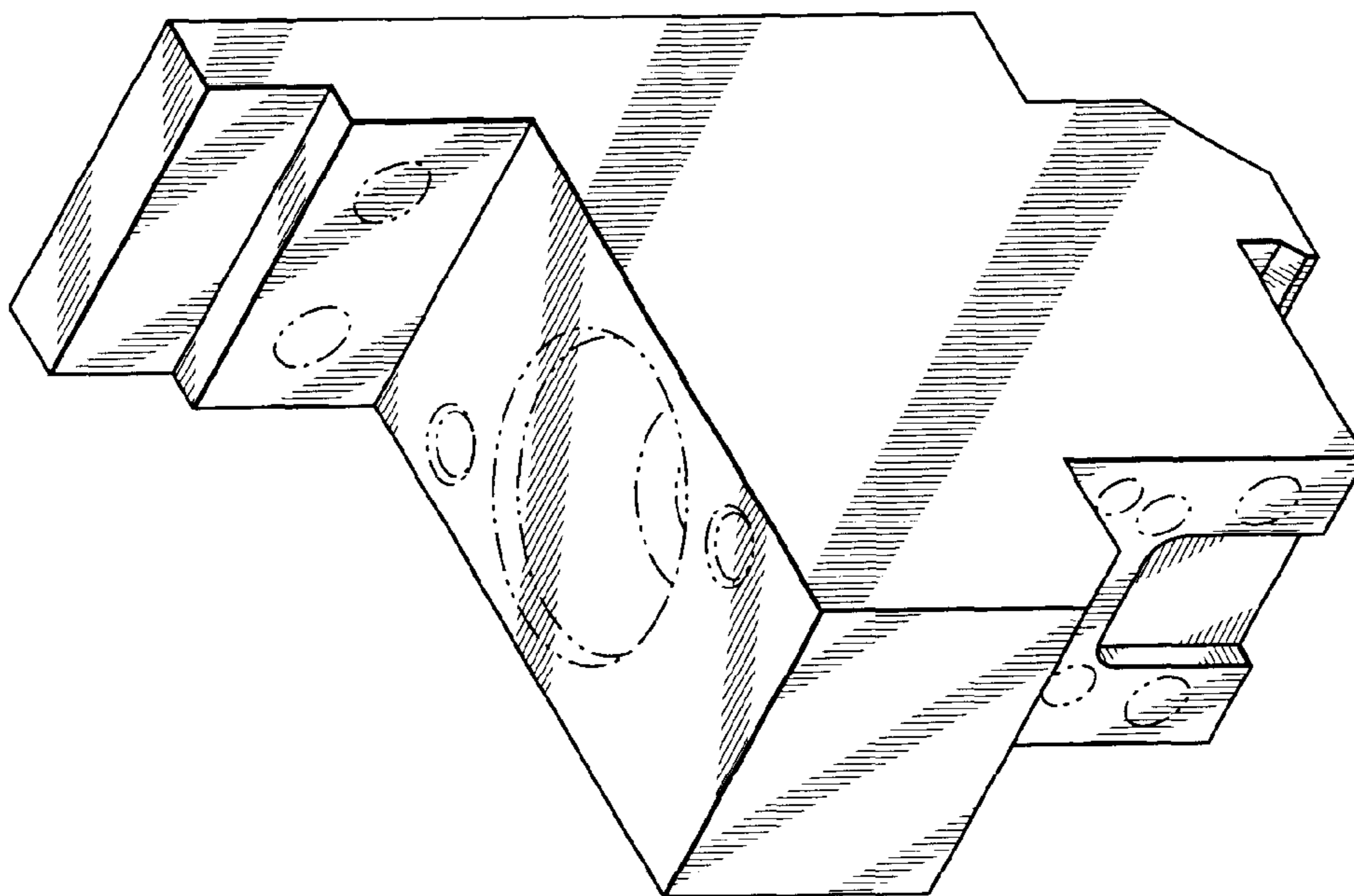

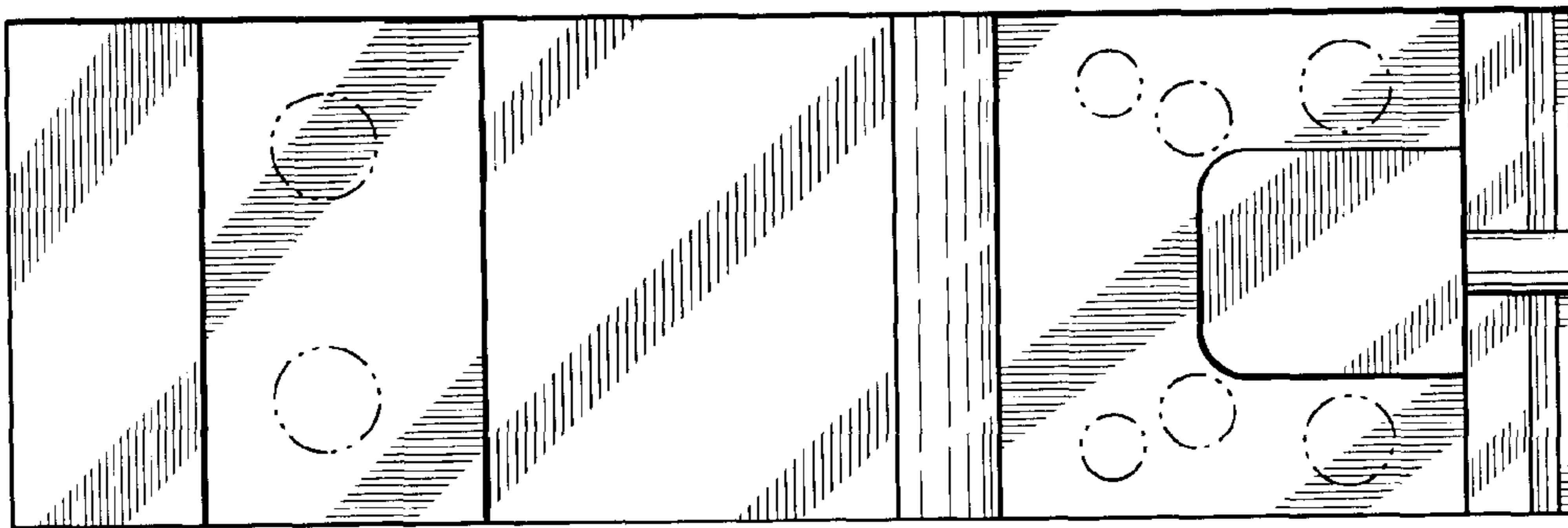

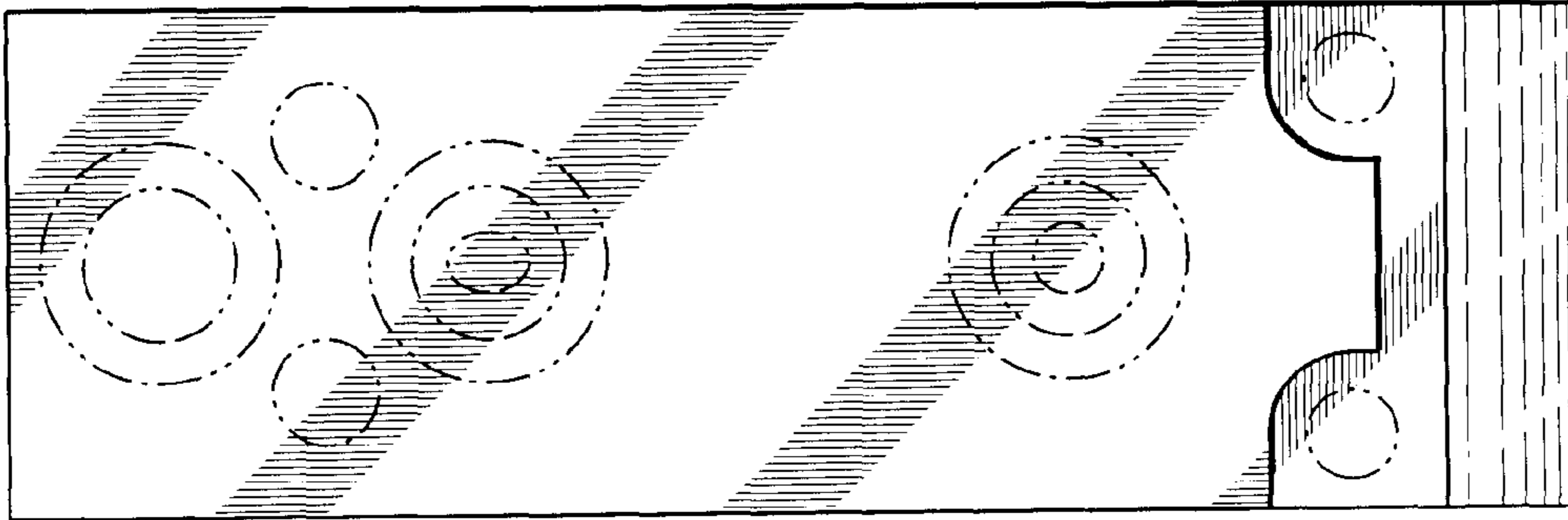

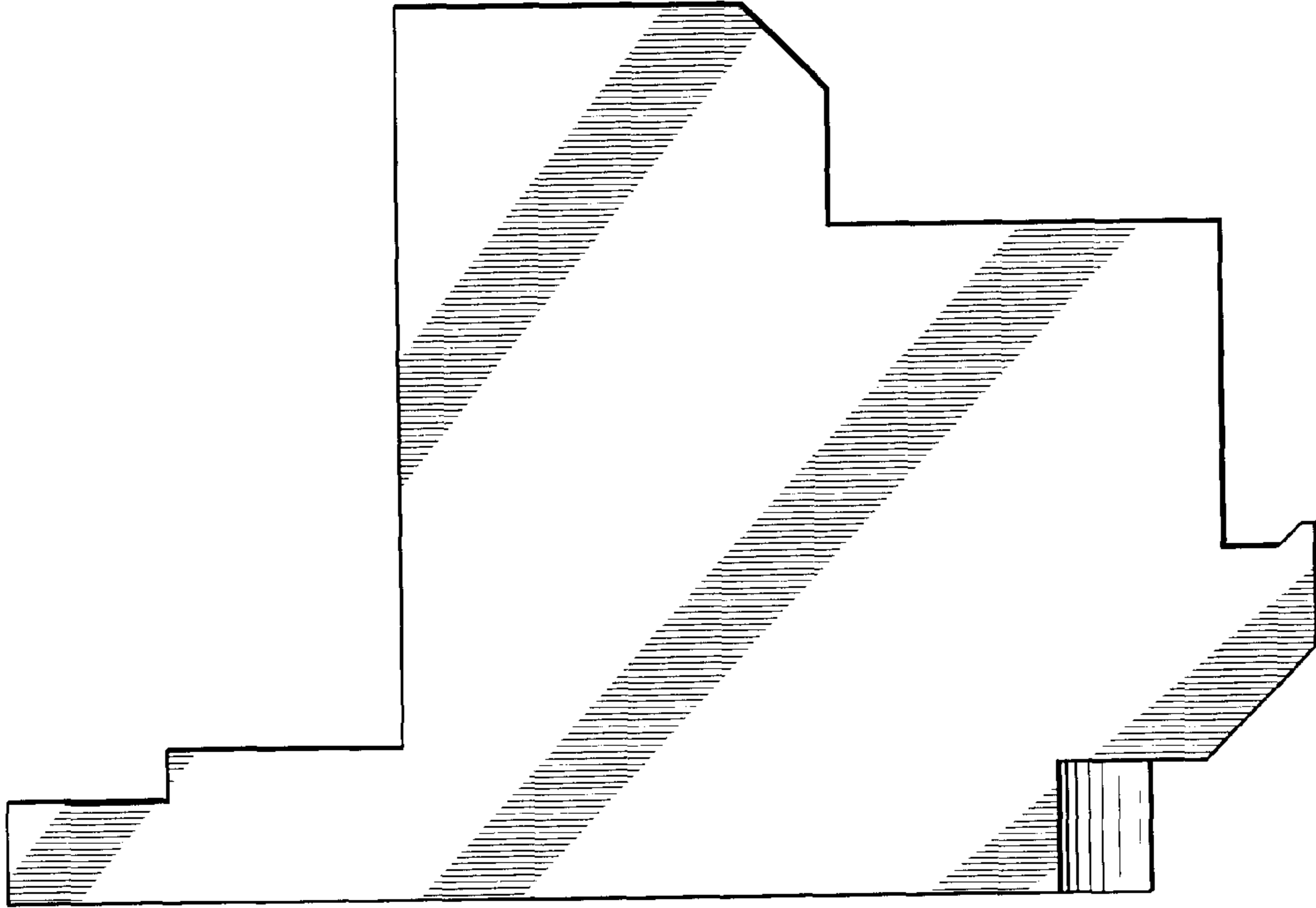

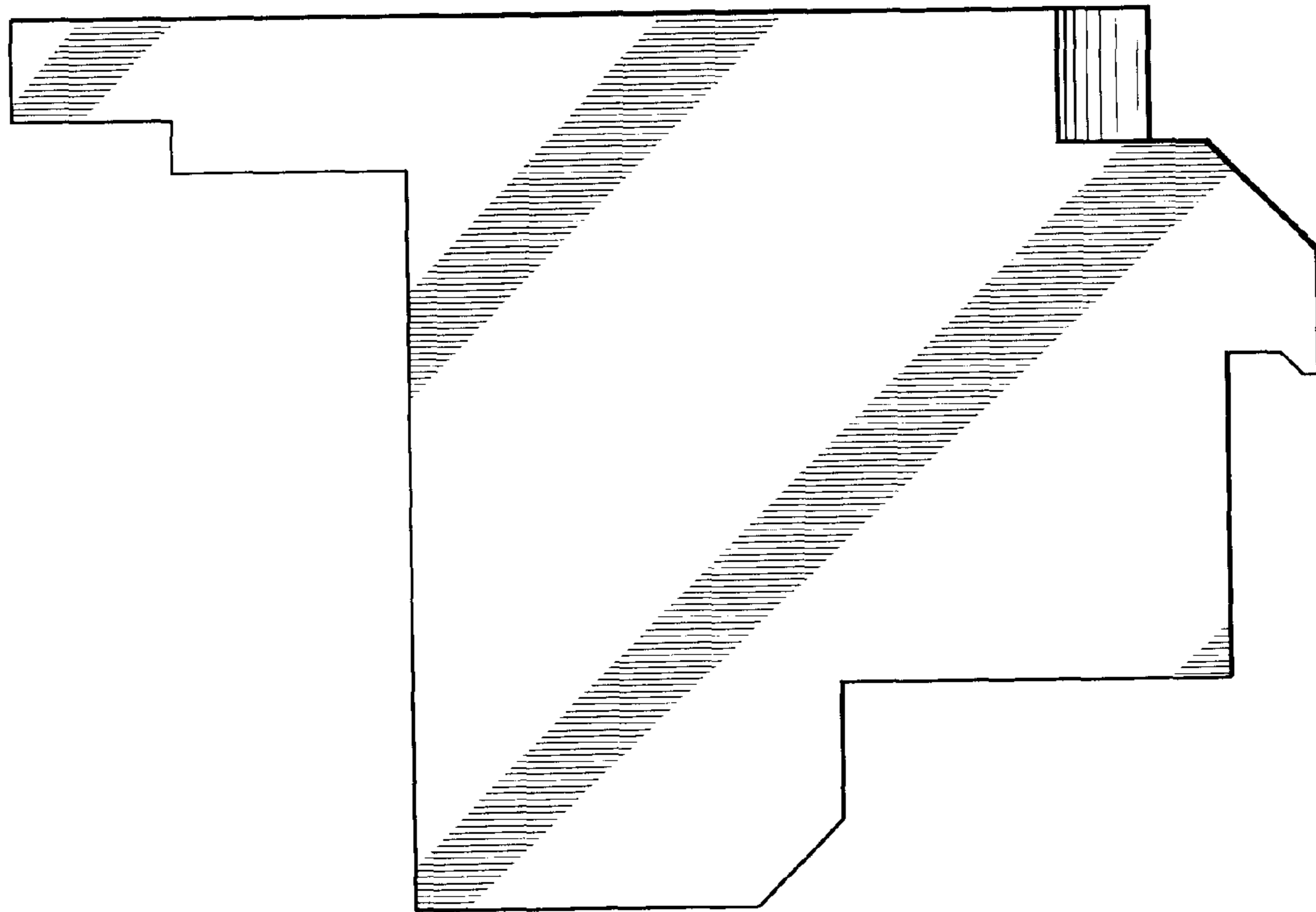

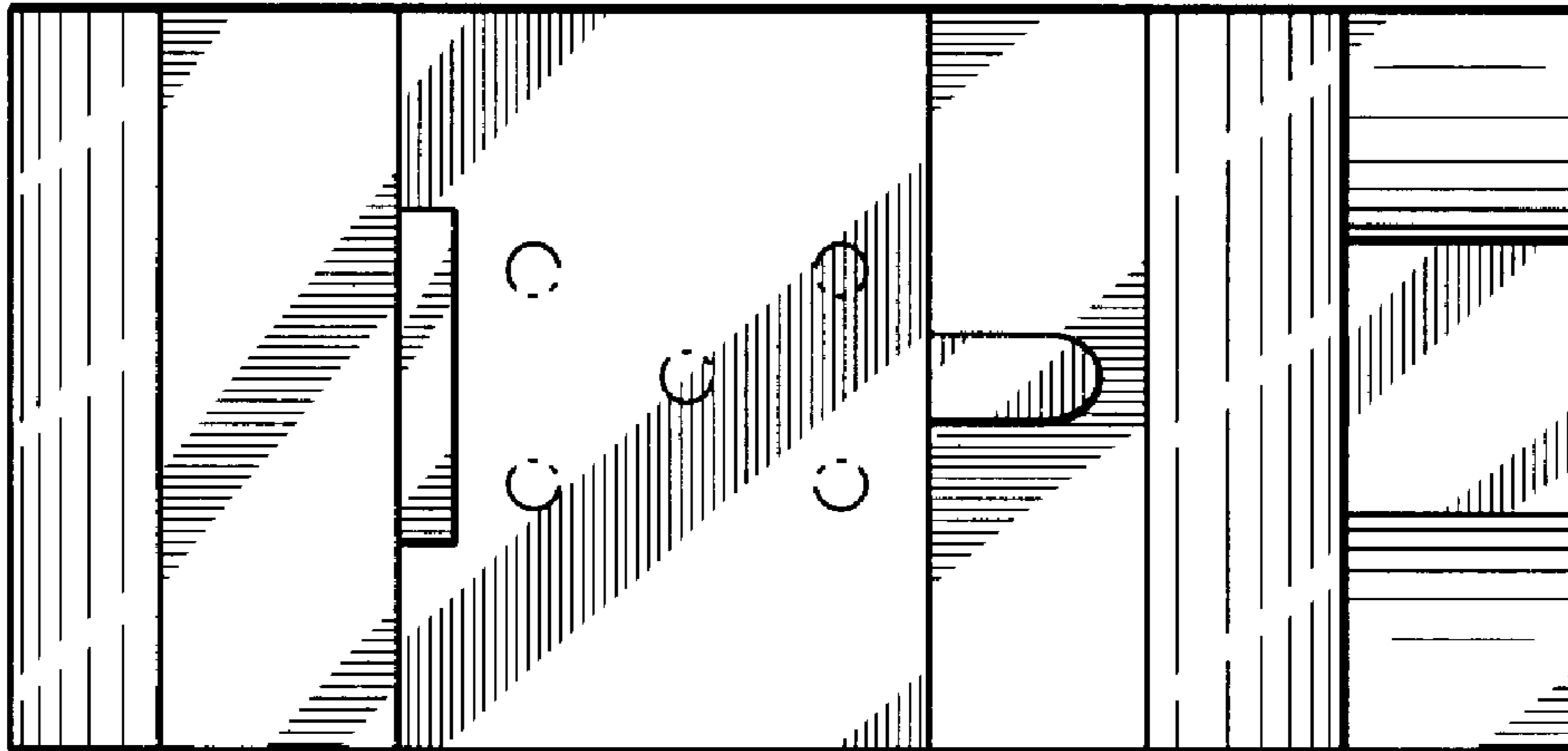

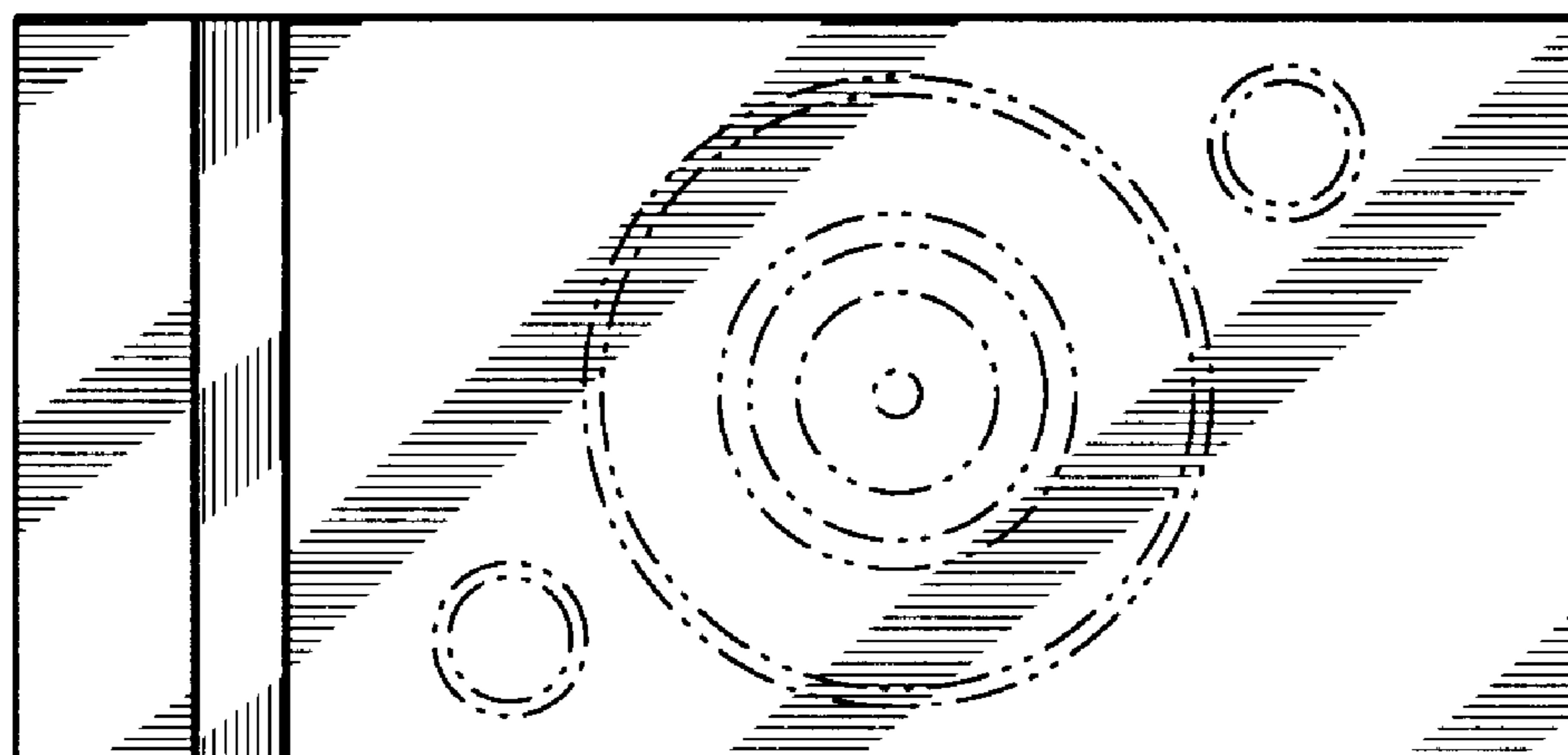
