(57) **CLAIM**

The ornamental design for a bathroom accessory wall mounting backplate, as shown and described.

DESCRIPTION

FIG. 1 is a front isometric view of the bathroom accessory wall mounting backplate of the present invention for mounting the exemplary toilet paper holder shown in dashed outline, the toilet paper holder forming no part of the present invention, it being understood that other bathroom accessories may be mounted by the inventive backplate without departing from the inventive concepts.

FIG. 2 is a front isometric view of the bathroom accessory wall mounting backplate of the present invention;

FIG. 3 is a front view of the bathroom accessory wall mounting backplate of the present invention;

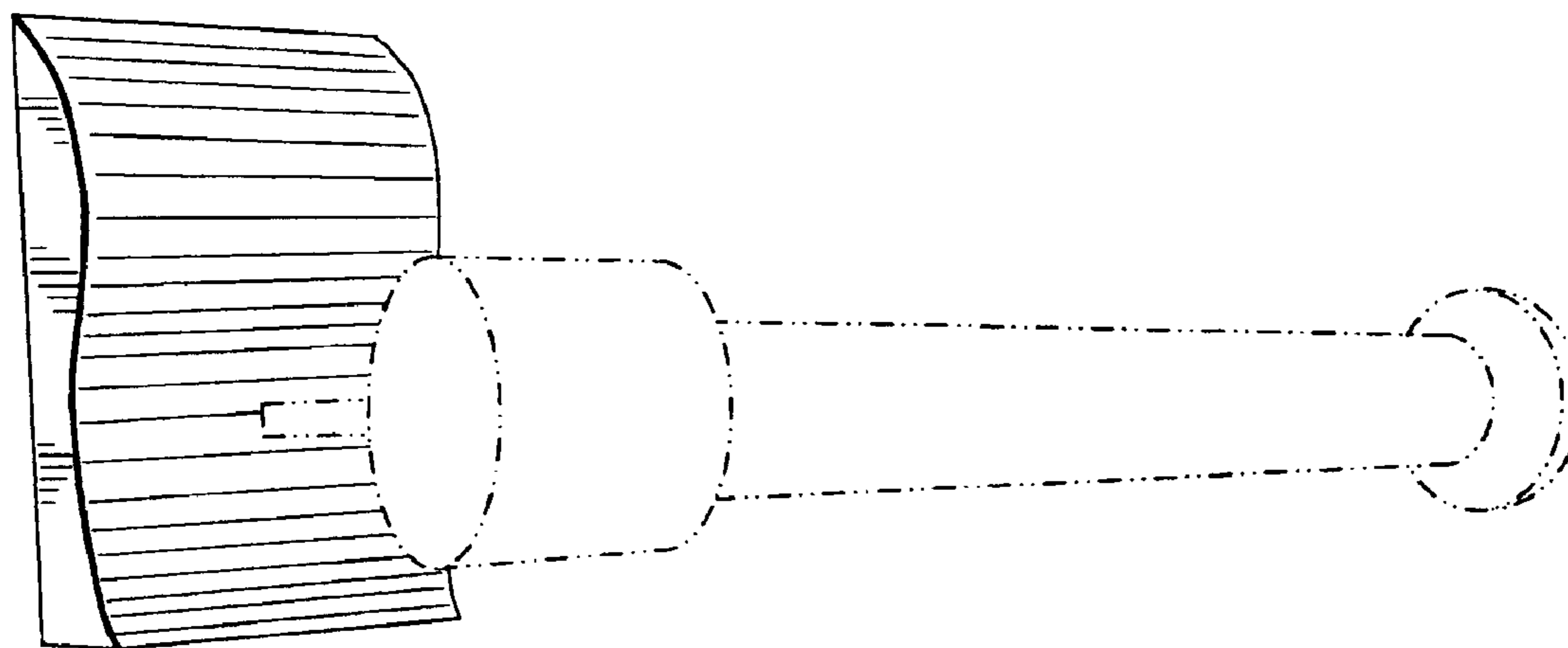
FIG. 4 is a left side view of the novel bathroom accessory wall mounting backplate of the present invention, the right side of which is its mirror image;

FIG. 5 is a top view of the bathroom accessory wall mounting backplate of the present invention;

FIG. 6 is a bottom view of the bathroom accessory wall mounting backplate of the present invention; and,

FIG. 7 is a view of the back of the bathroom accessory wall mounting backplate of the present invention.

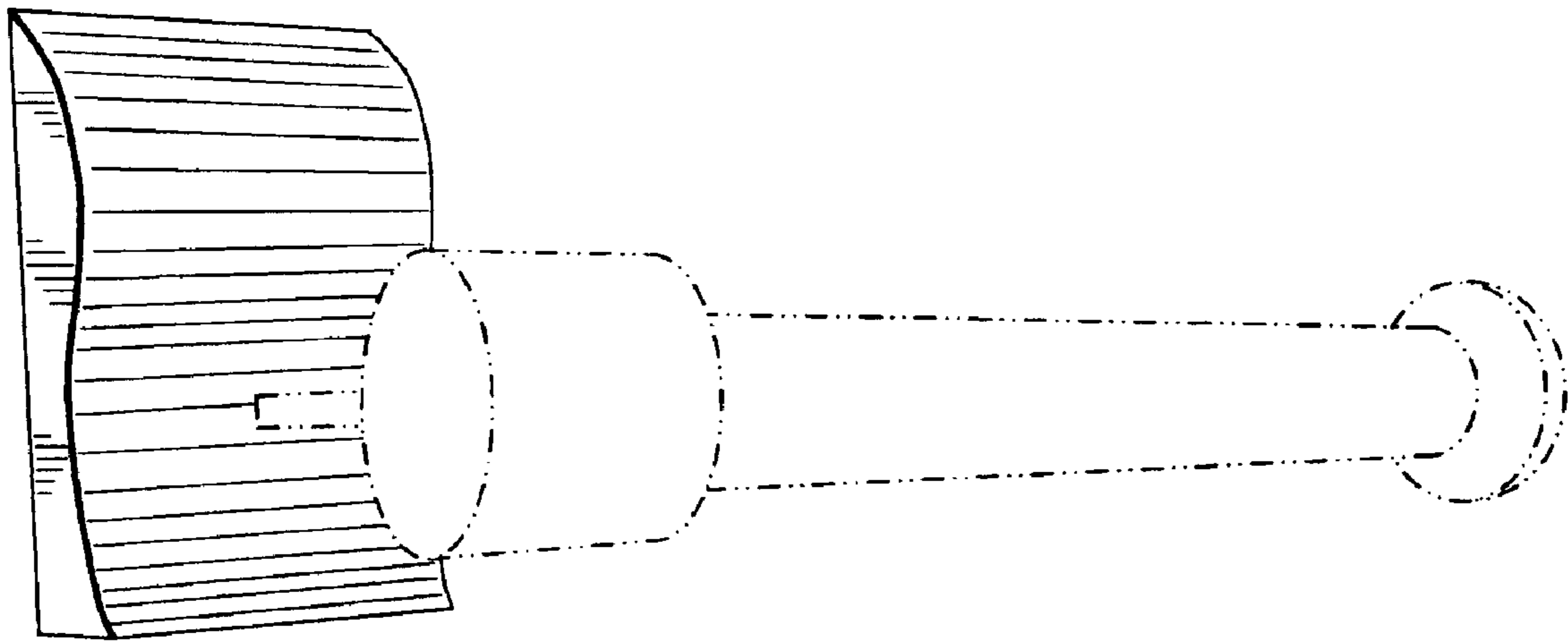

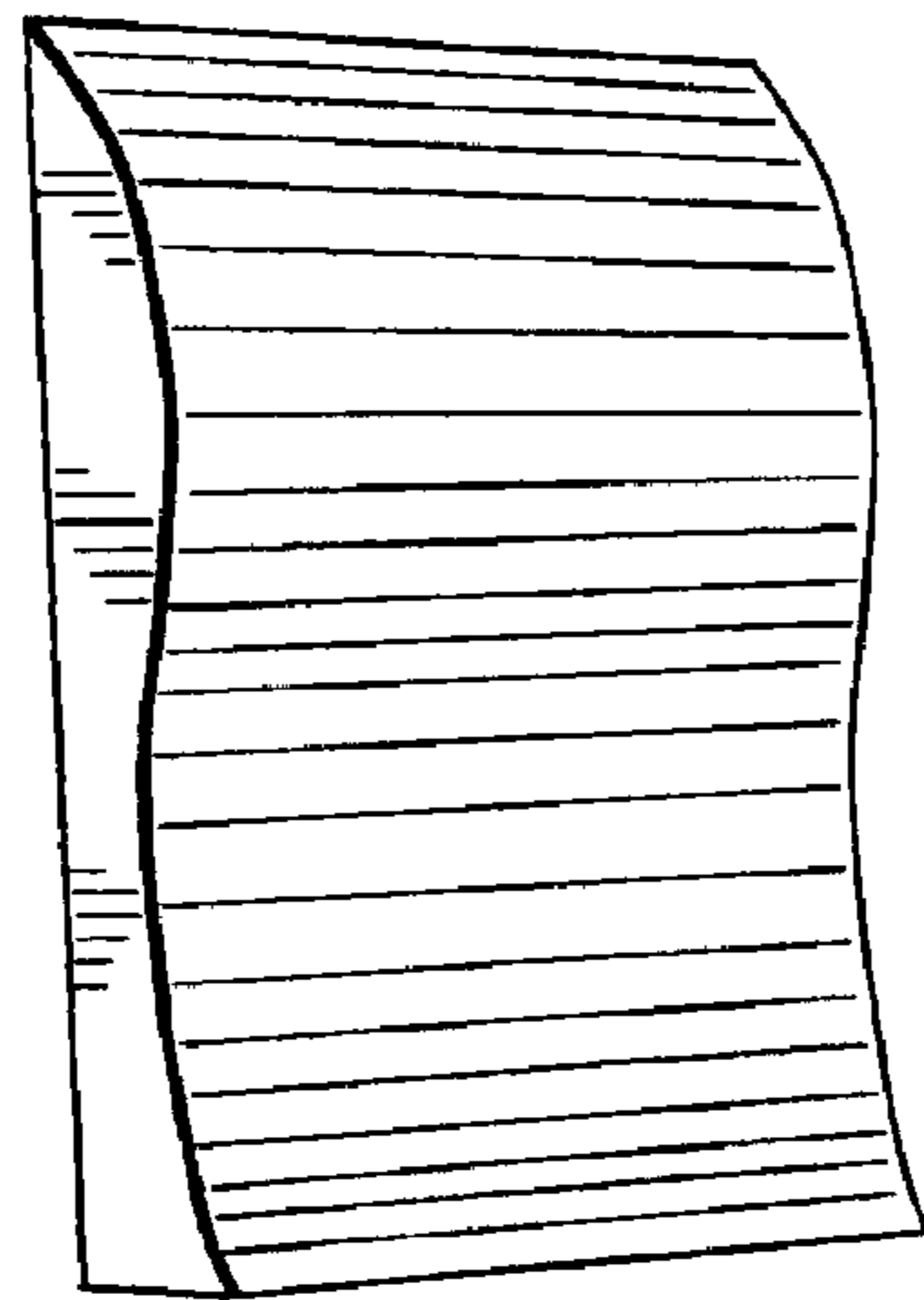

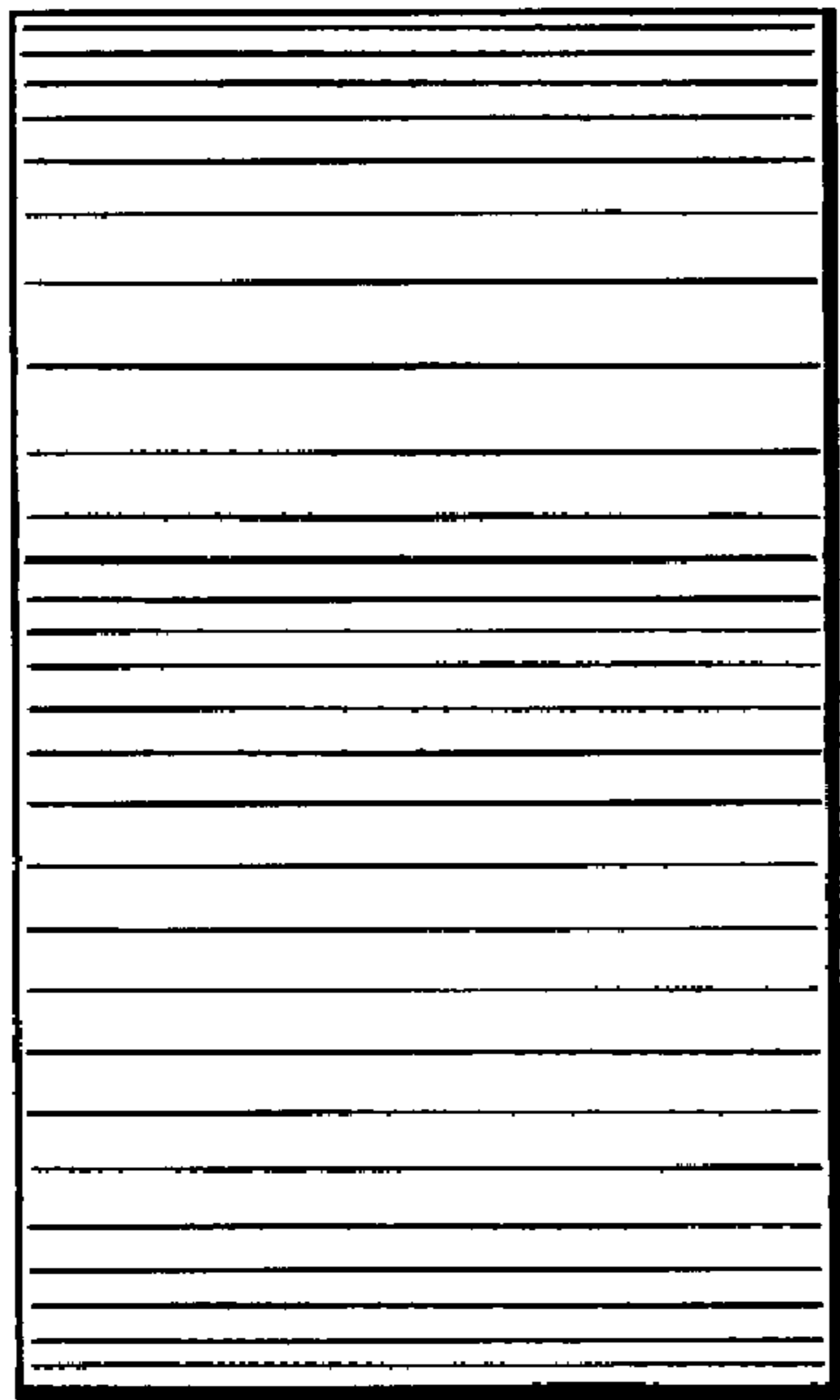

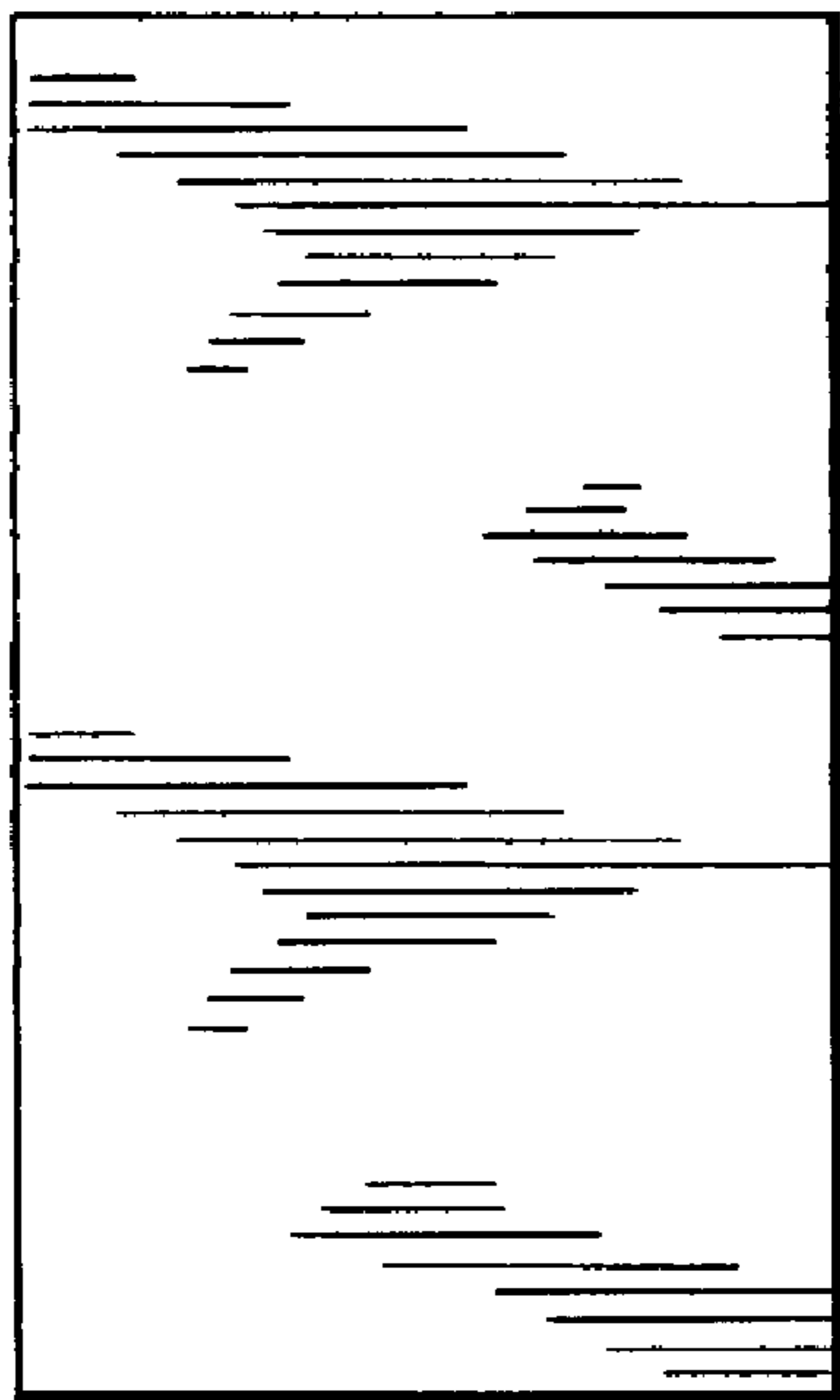

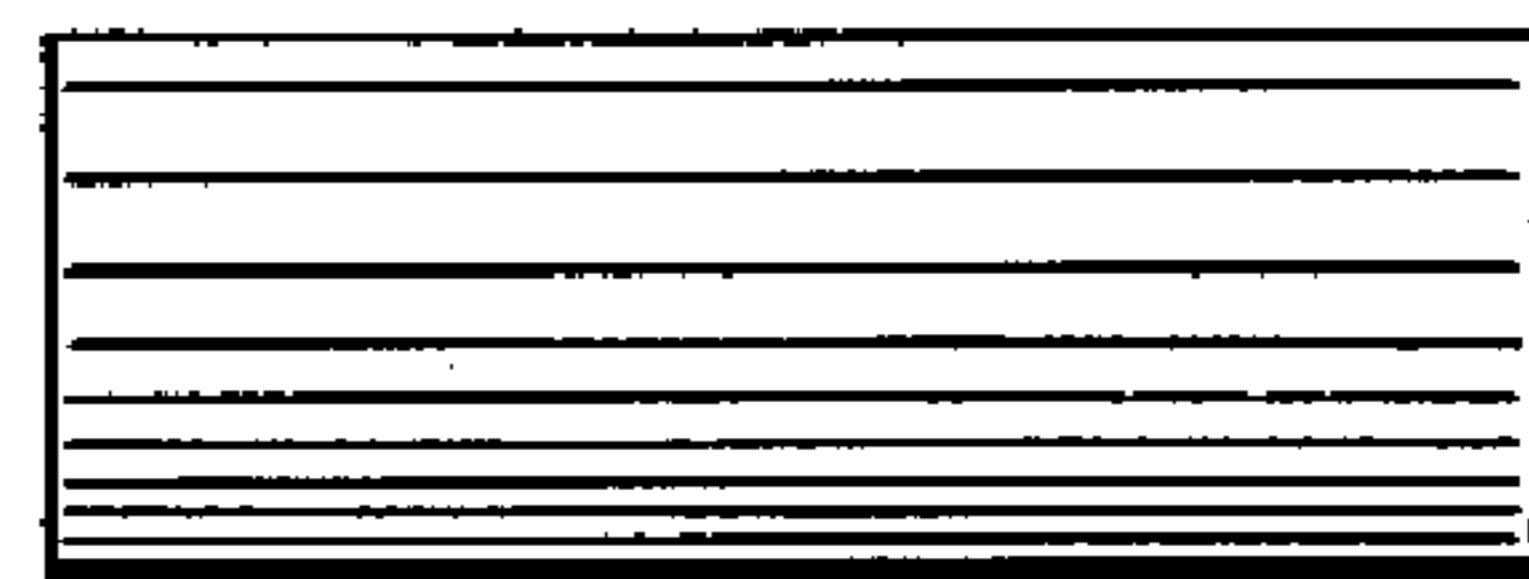

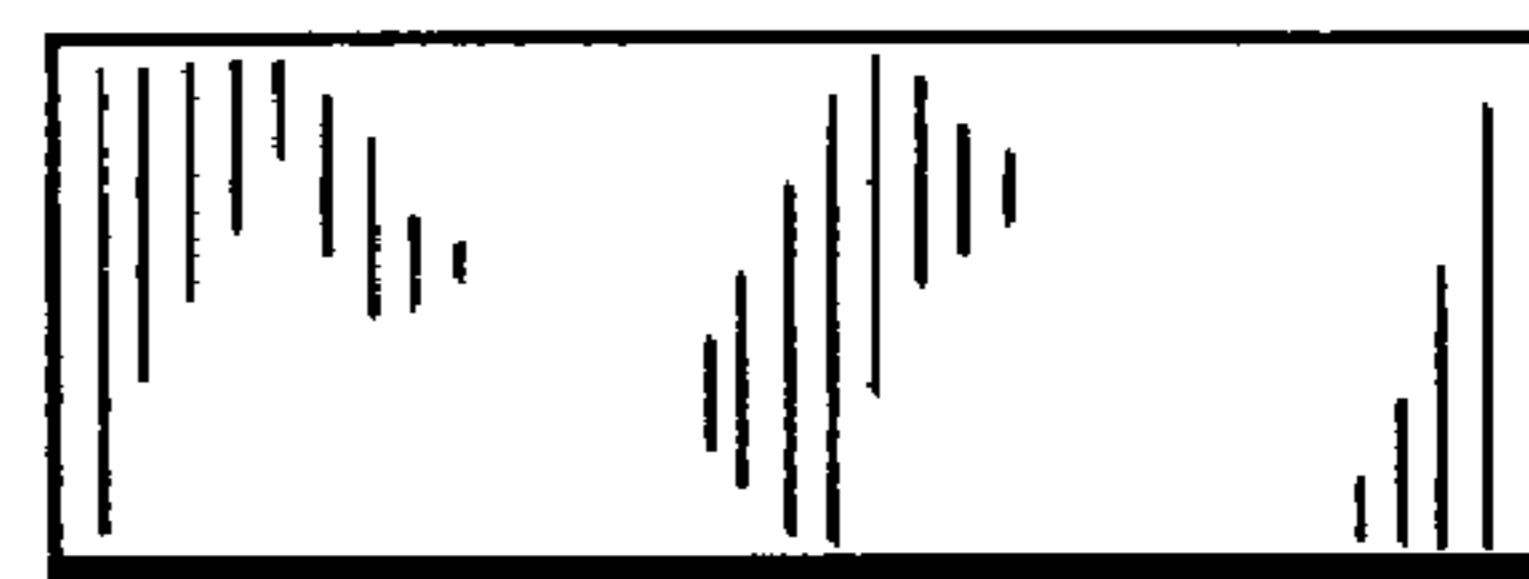
