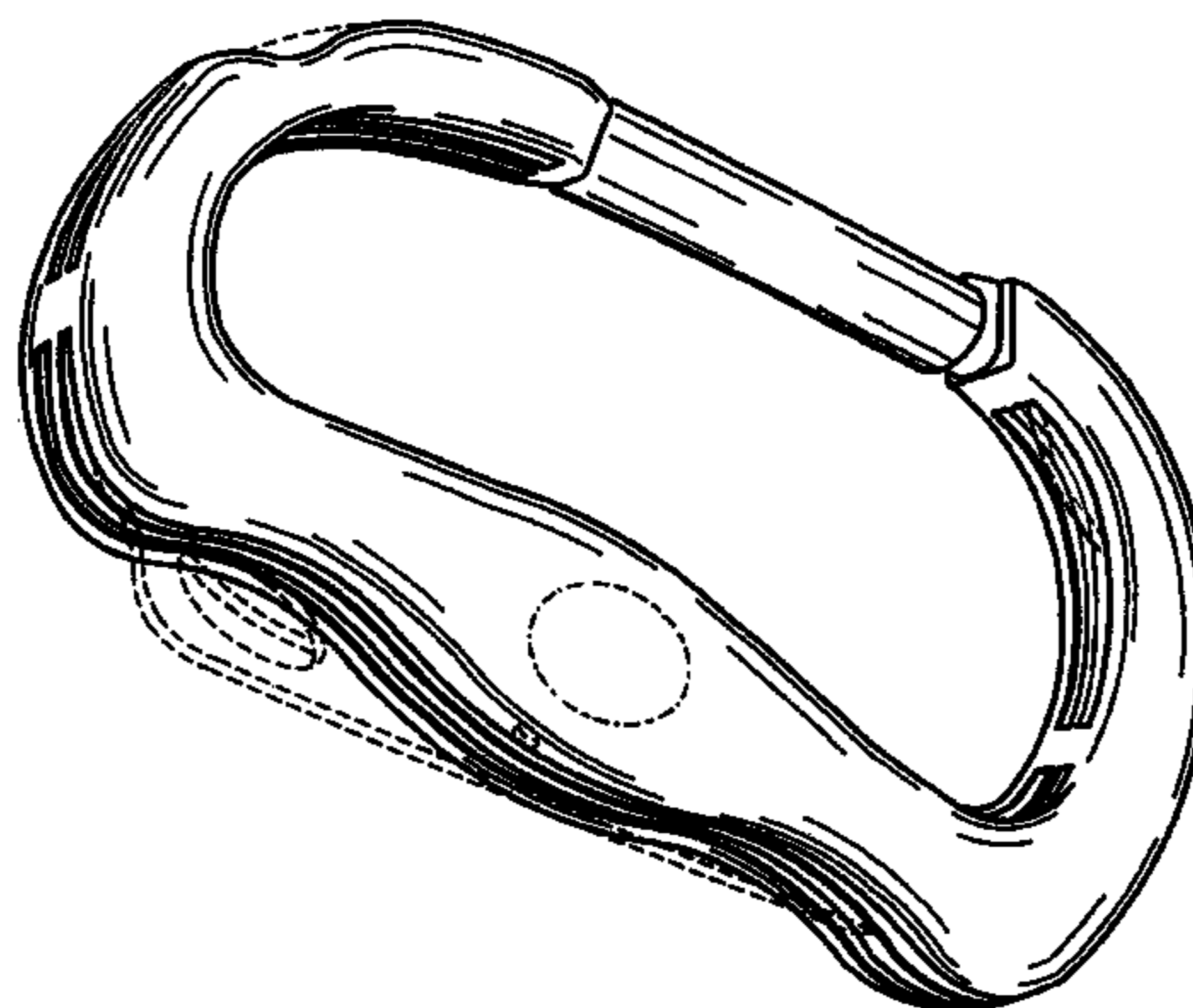
(57) **CLAIM**

We claim the ornamental design for a combination carabiner and tool device, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom left rear perspective view of a combination carabiner and tool device.  
 FIG. 2 is a left side plan view thereof.  
 FIG. 3 is right side plan view thereof.  
 FIG. 4 is a top elevational view thereof.  
 FIG. 5 is a bottom elevational view thereof.  
 FIG. 6 is a front elevational view thereof; and,  
 FIG. 7 is a rear elevational view thereof.  
 The broken line(s) shown in the drawings are for illustrative purposes only and form no part of the claimed design.  
 The shading lines shown in the drawings represent the approximate three-dimensional contour of the design, and are not intended to indicate surface decoration.  
 Portions of the combination carabiner and tool device that are not shown in the drawing(s) form no part of the claimed design.

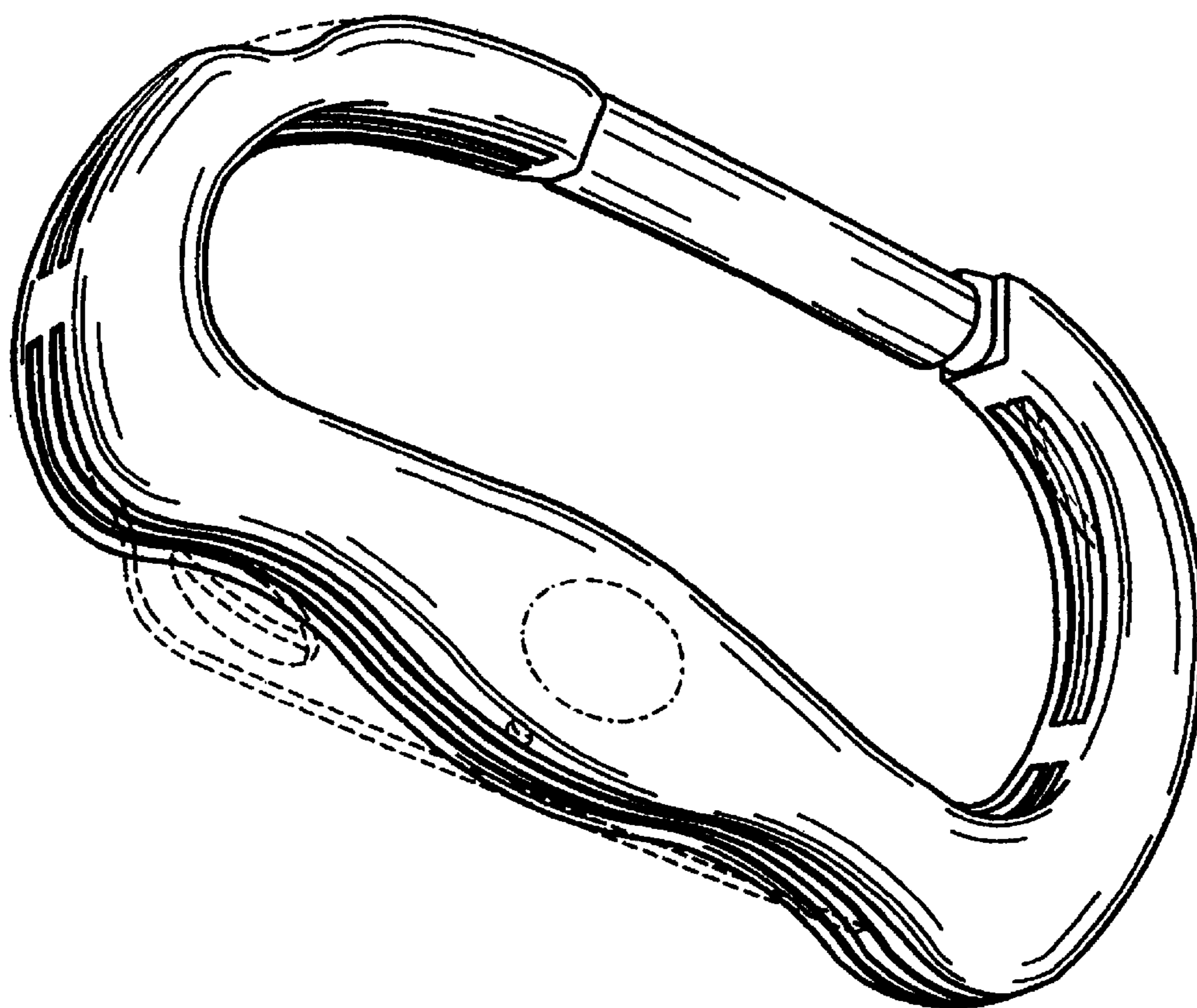

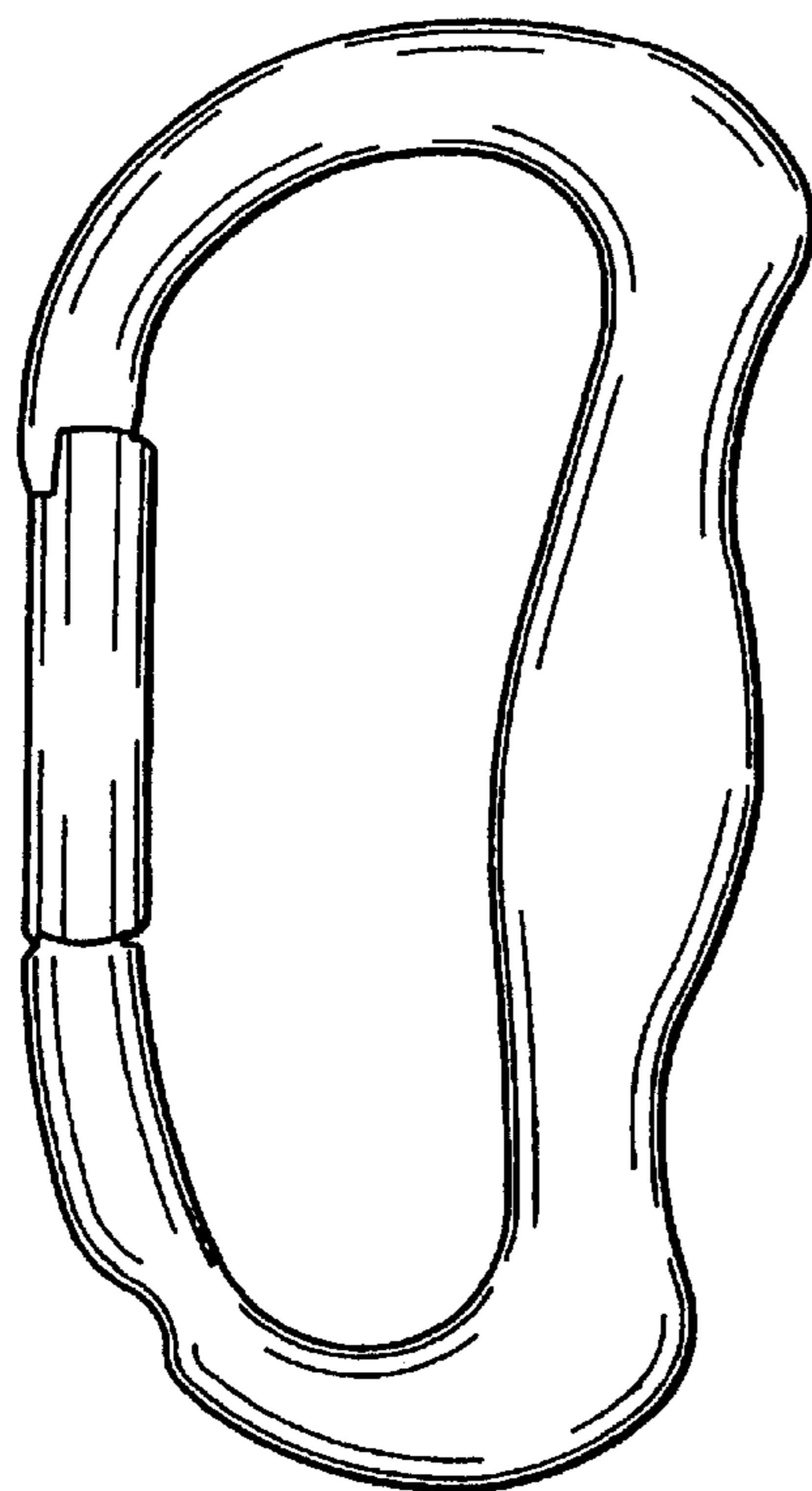

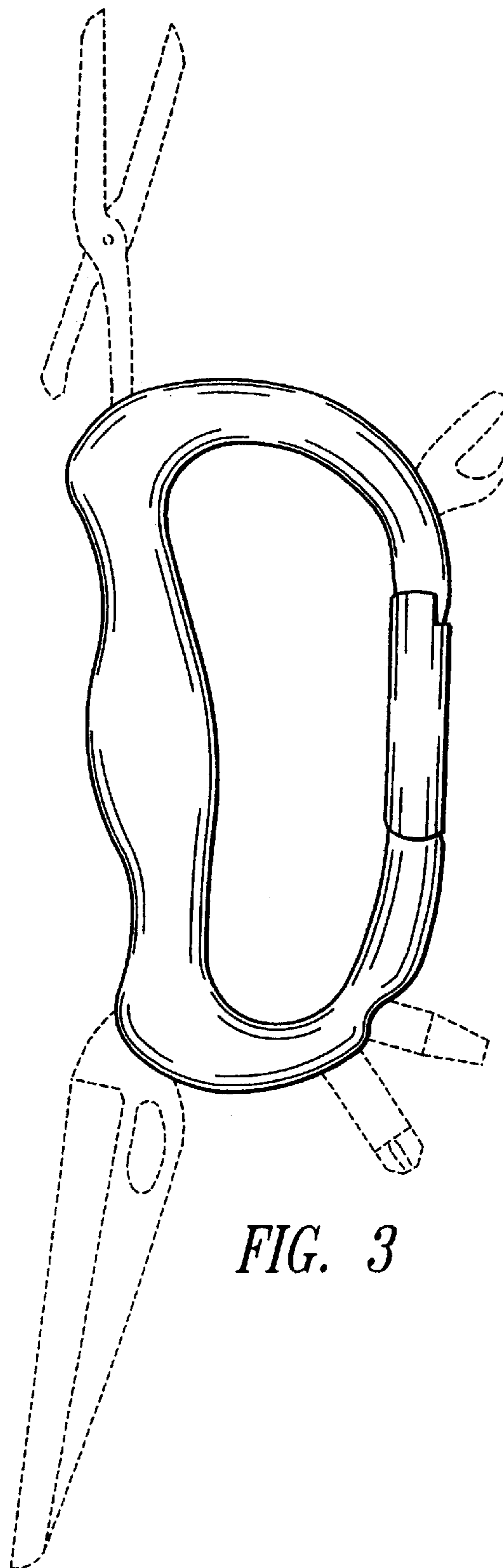

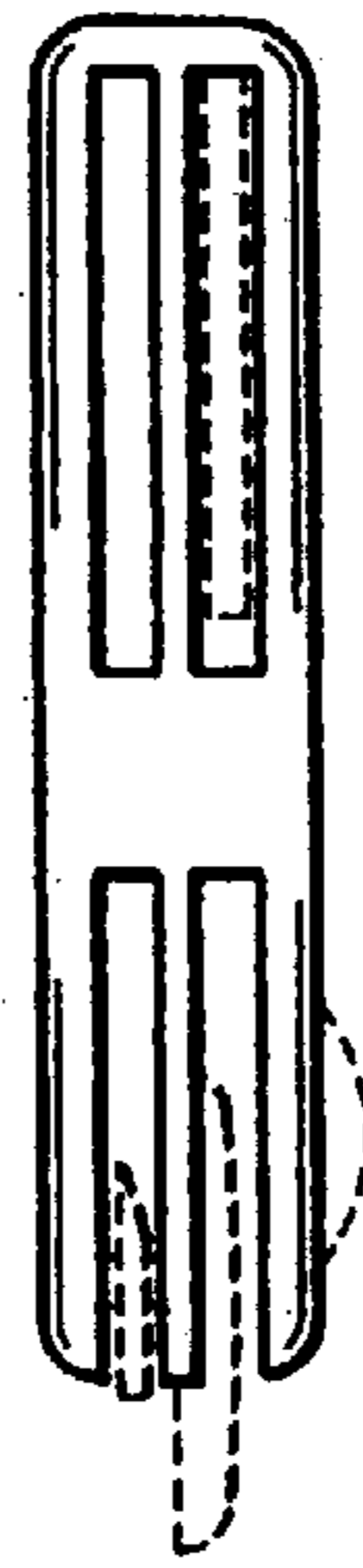
