We claim the ornamental design for a door latch handle, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the door latch handle of the present invention.

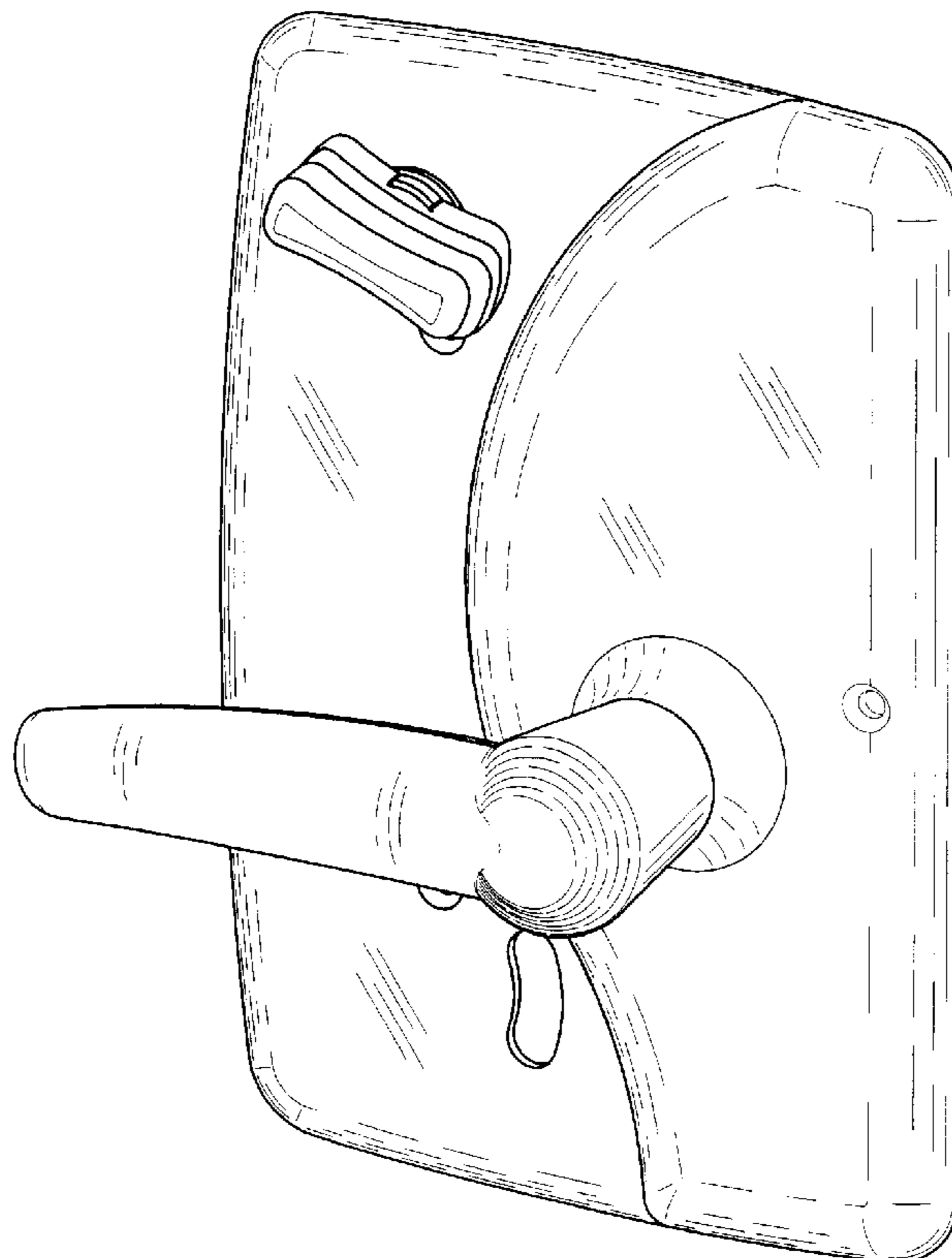
FIG. 2 is a top plan view of the door latch handle, the undisclosed bottom view is not part of the claimed design;

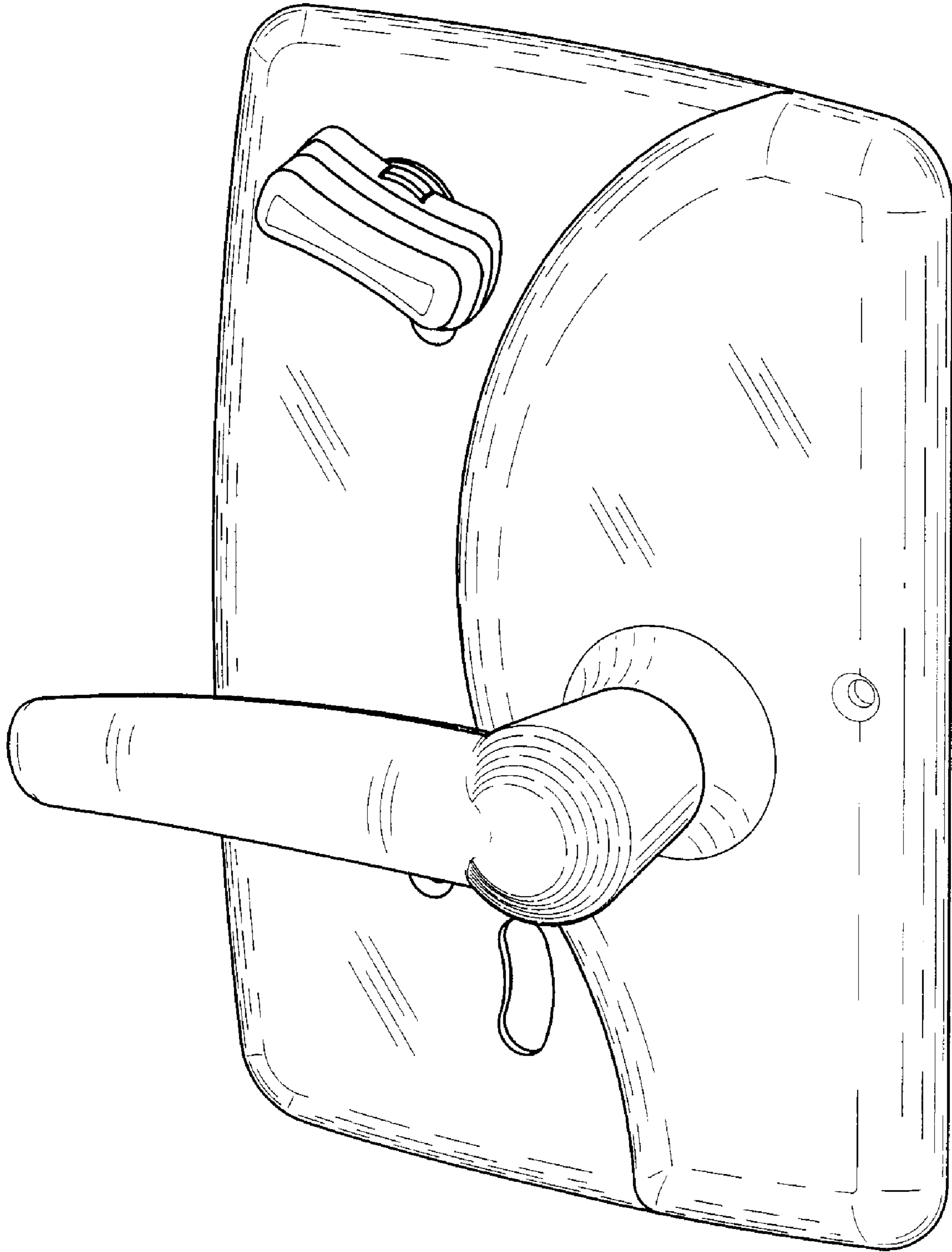
FIG. 3 is an elevation view from the top edge of the handle. FIG. 4 is an elevation view from the bottom edge of the handle.

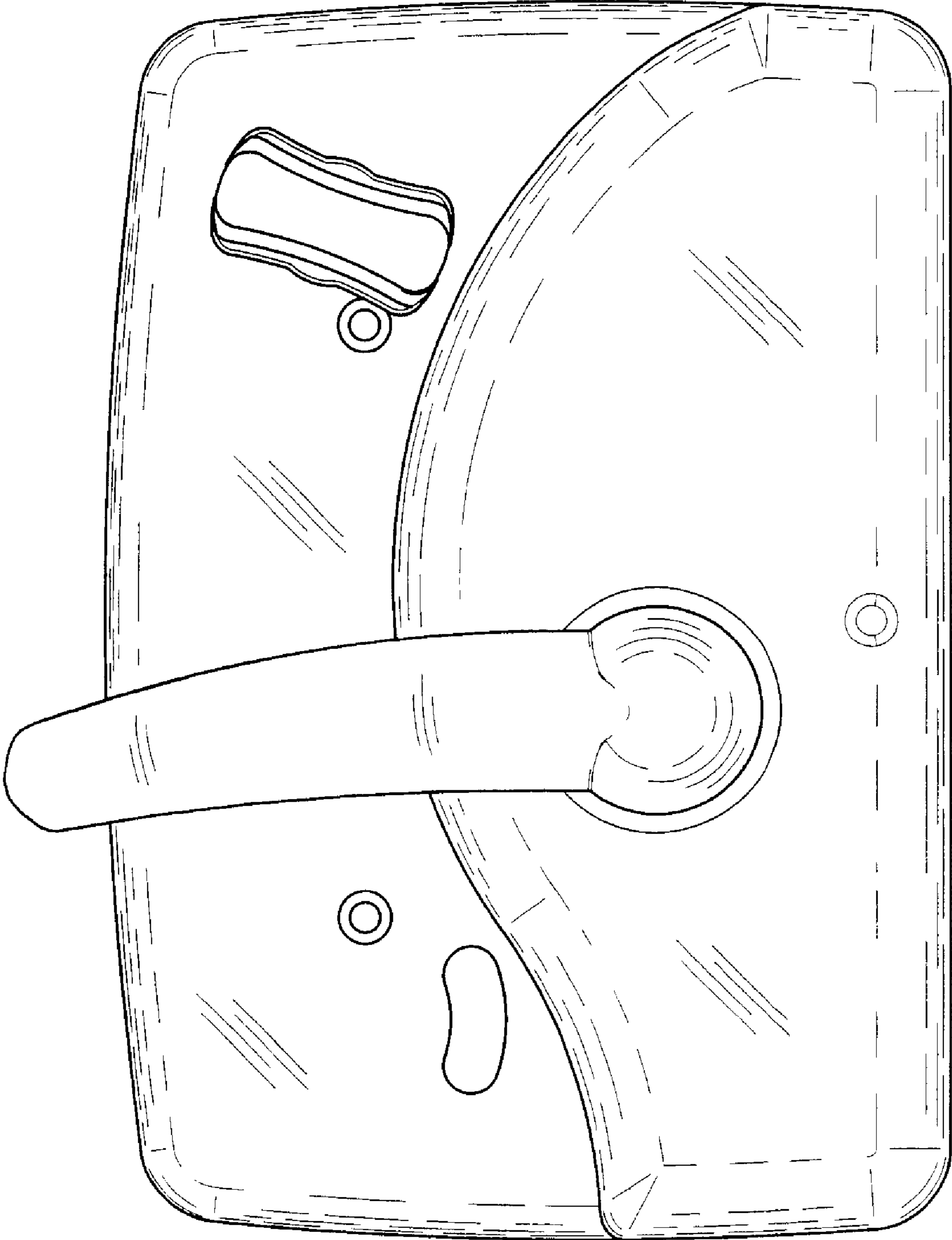
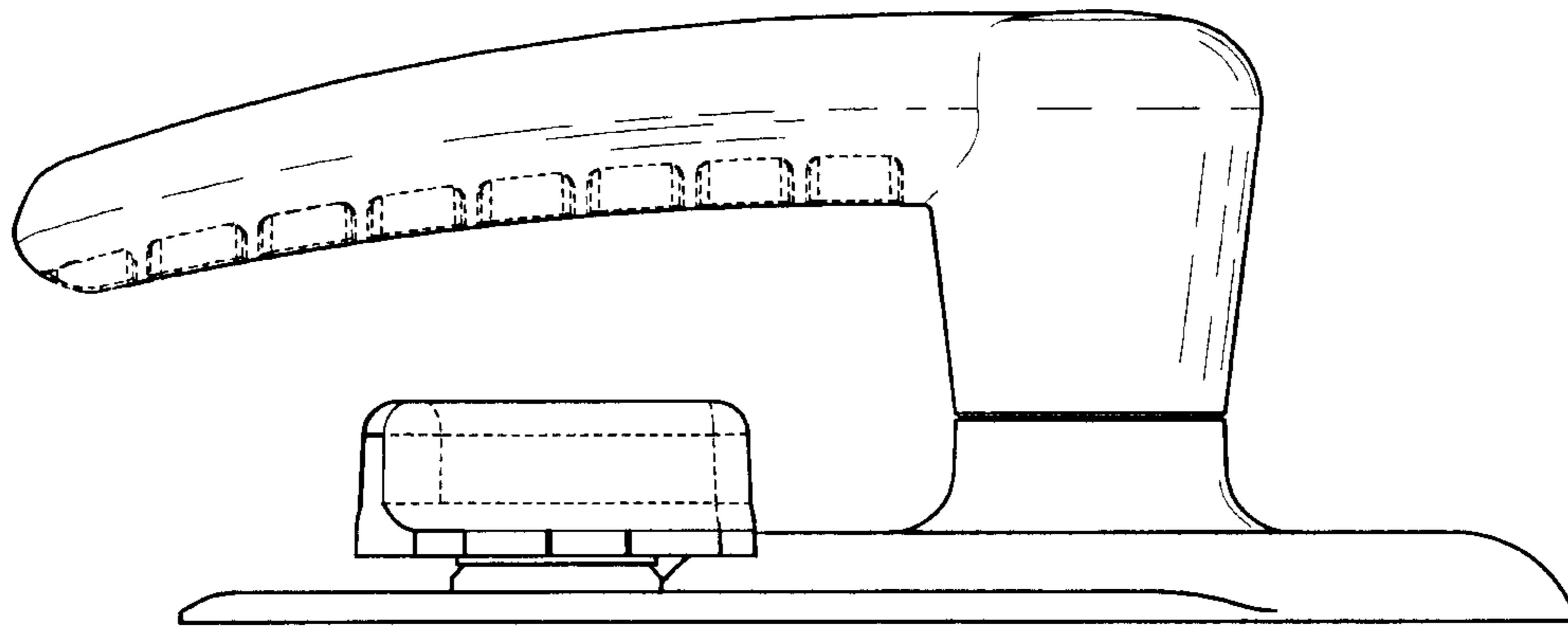
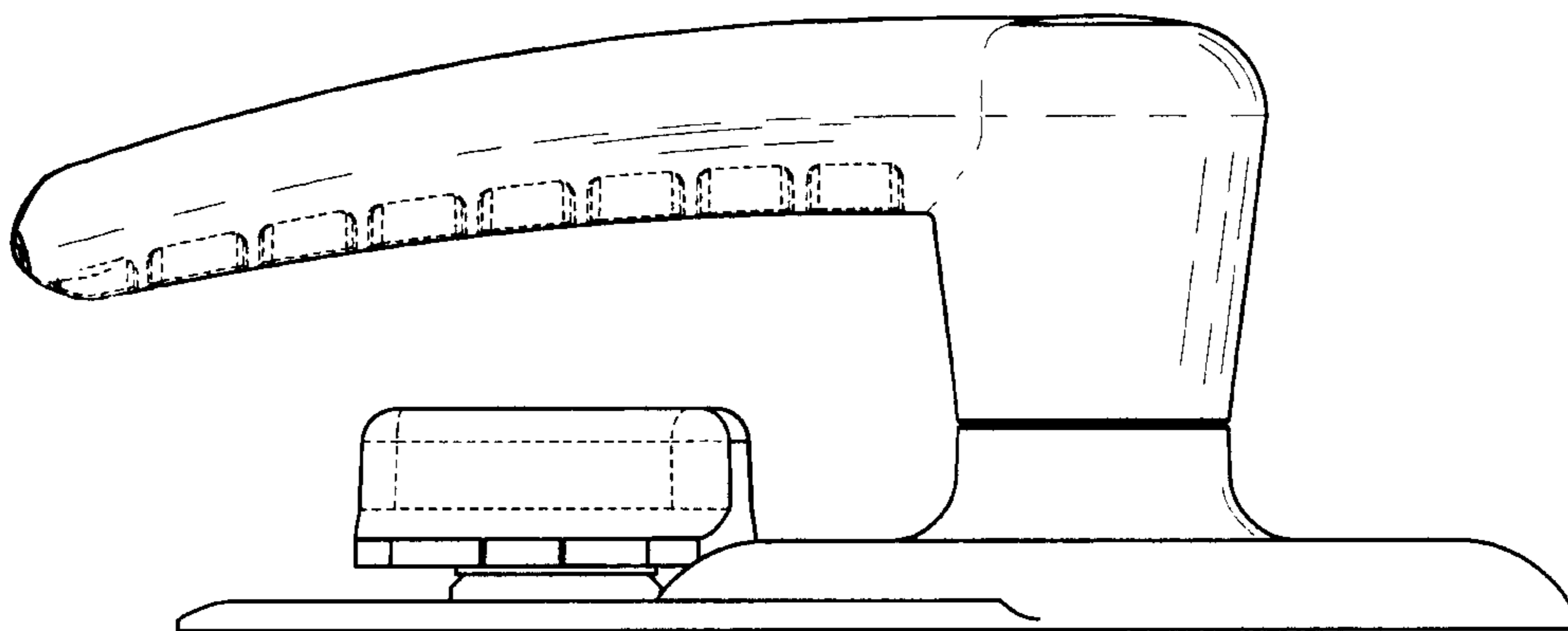


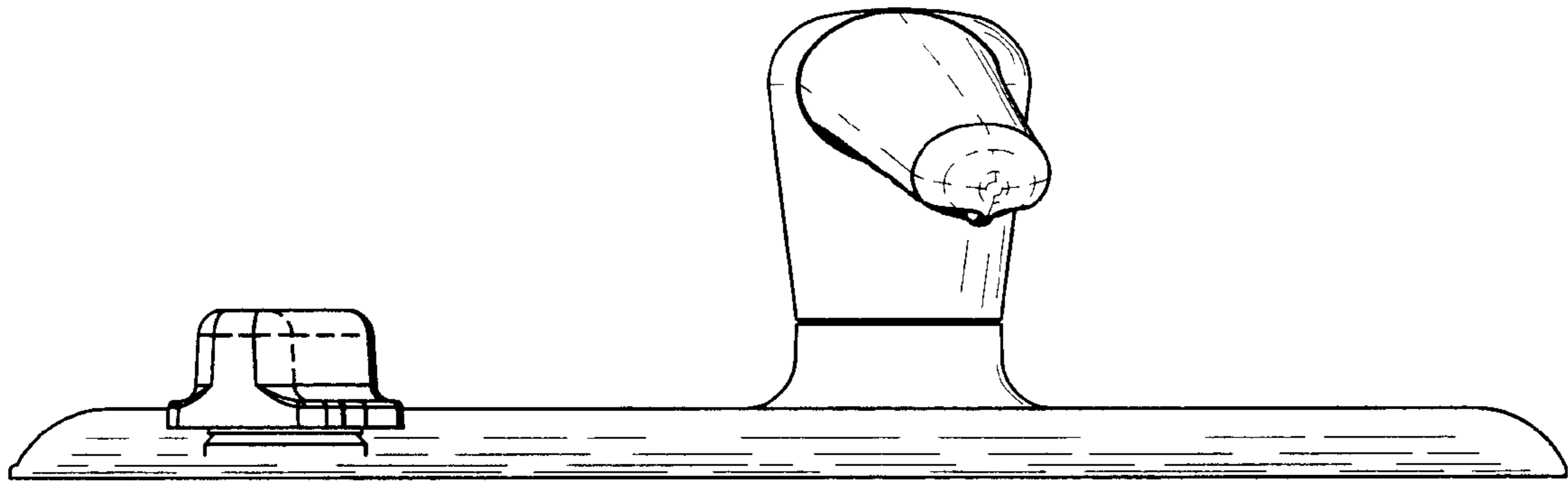

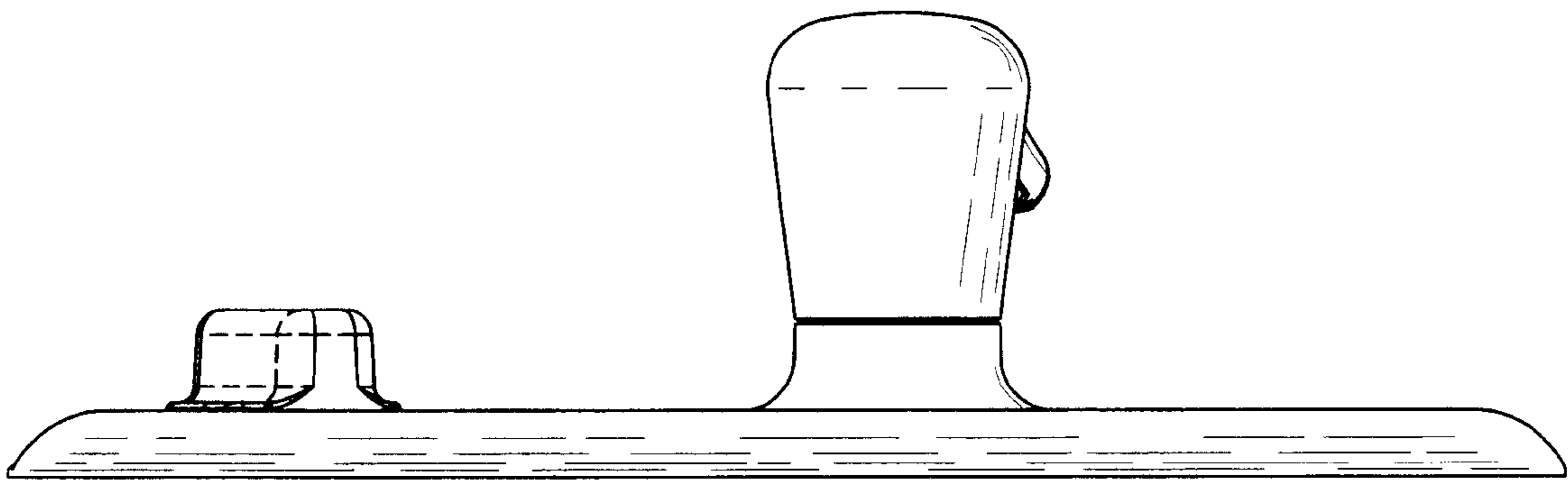
