(57) **CLAIM**

The ornamental design for a bottle containing a liquid detergent containing suspended beads, as shown and described.

DESCRIPTION

FIG. 1 is a right view of bottle containing a liquid detergent containing suspended beads, embodying the new design; FIG. 2 is a front view thereof; FIG. 3 is a left view thereof; FIG. 4 is a back view thereof; FIG. 5 is a top view thereof; and, FIG. 6 is a bottom view.

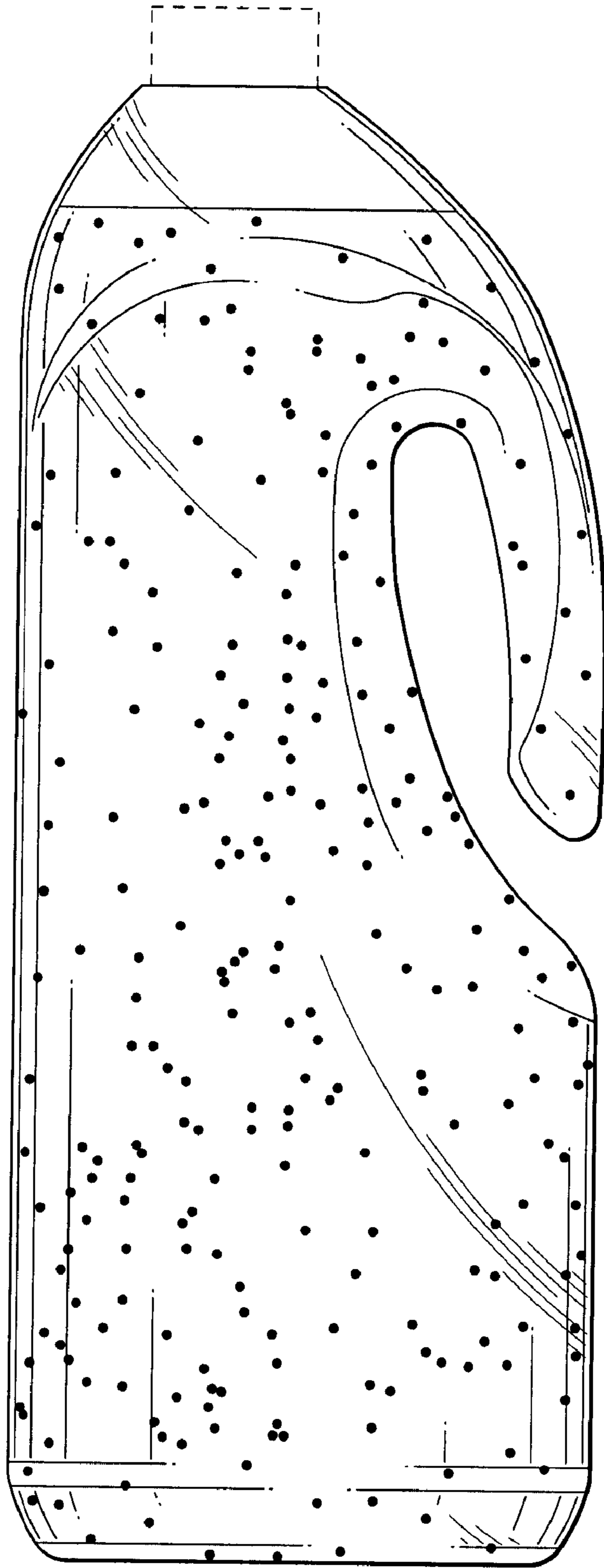

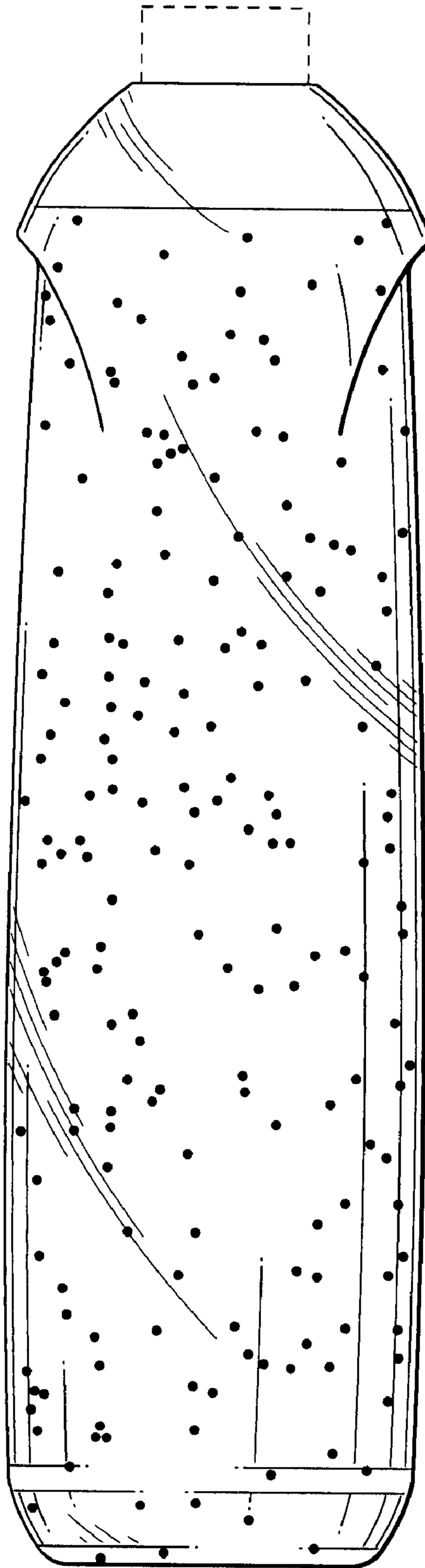

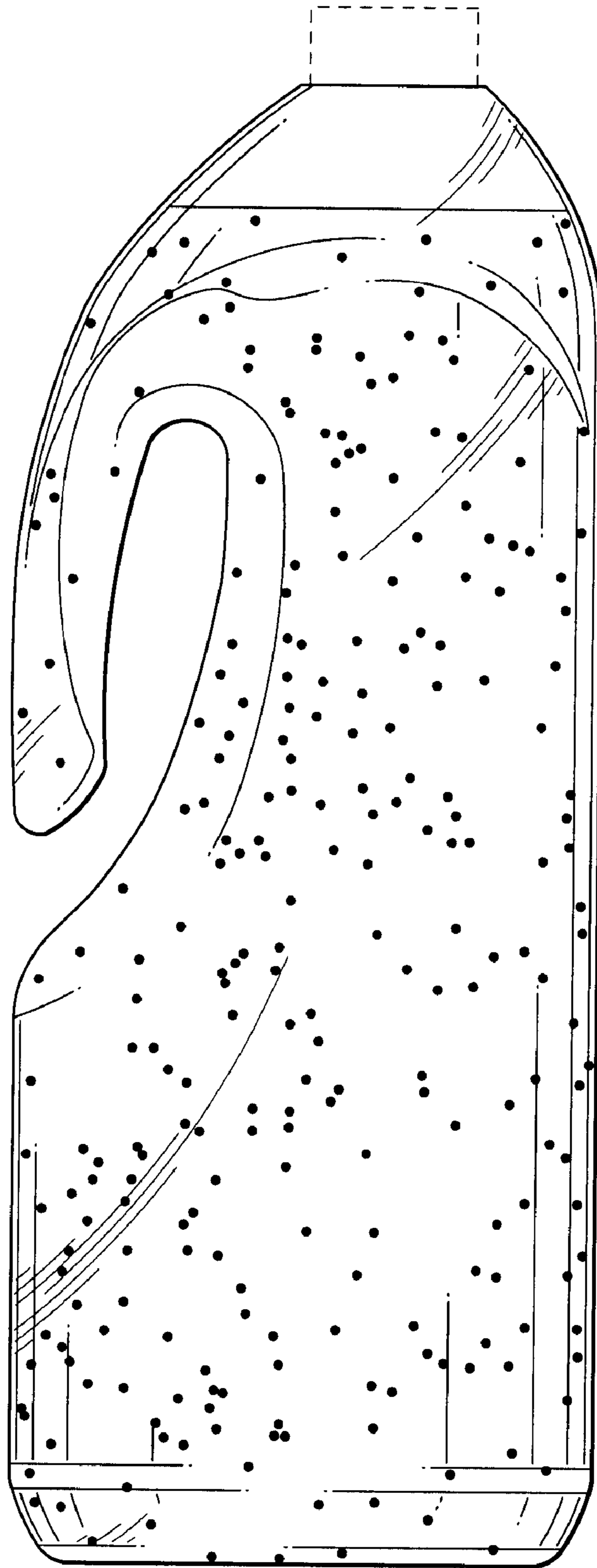

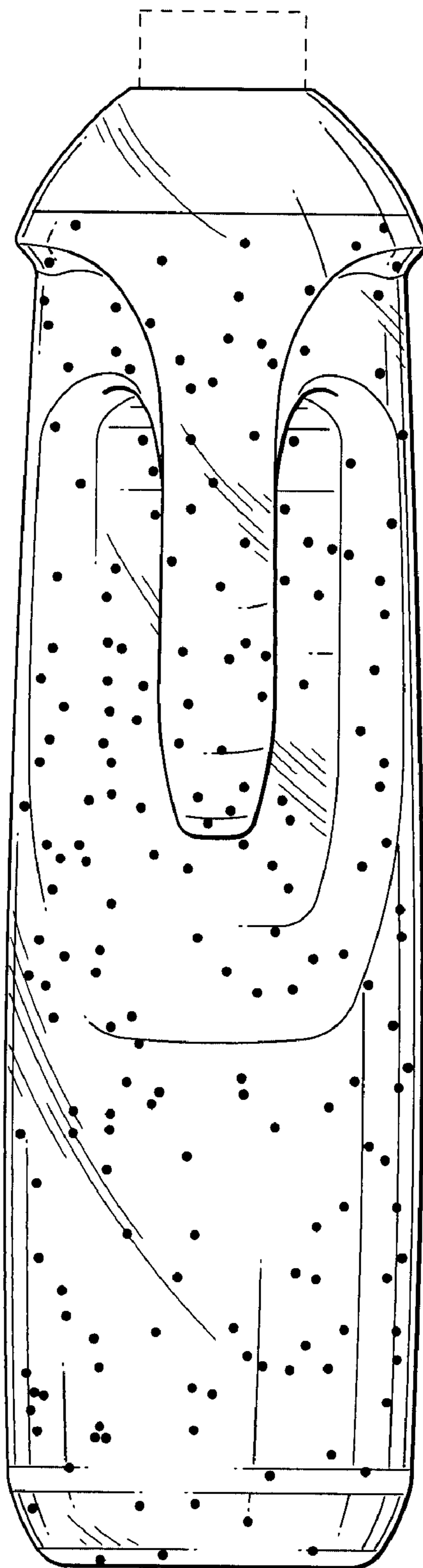

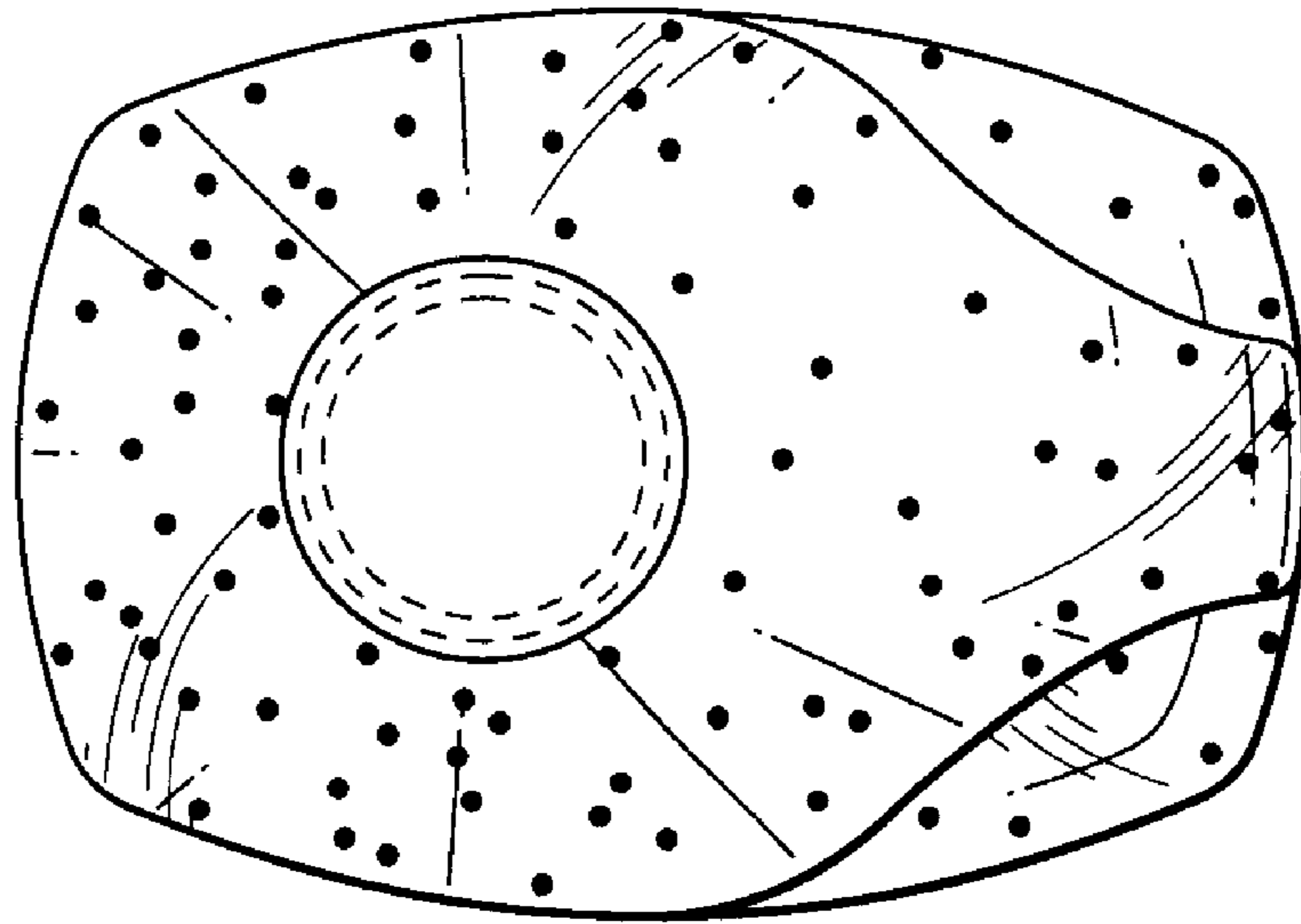

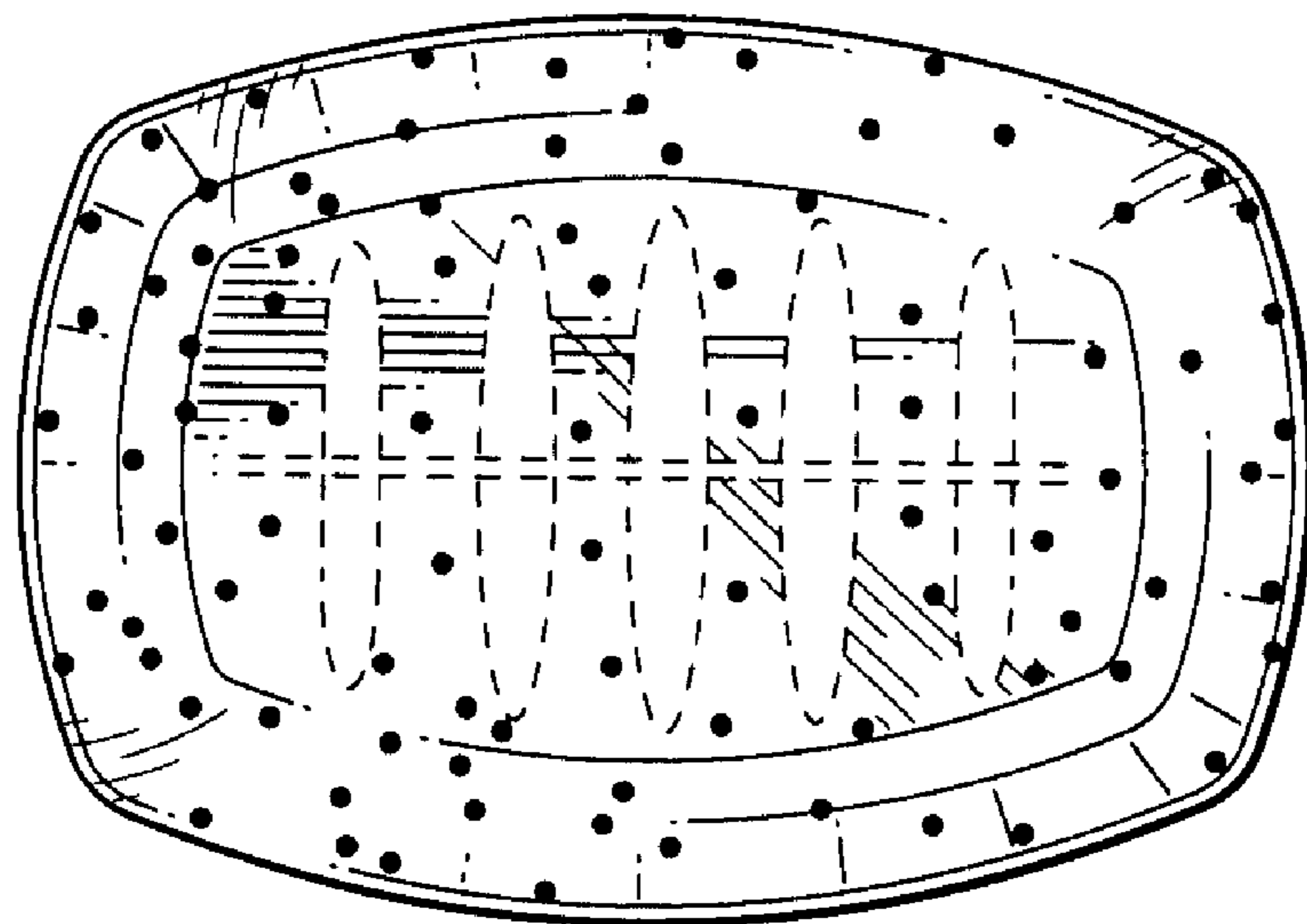
