(57) **CLAIM**

The ornamental design for an automobile upper grille, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the automobile upper grille thereof;

FIG. 2 is a front view thereof;

FIG. 3 is a top plan view thereof; and

FIG. 4 is a right side elevational view, the left side elevational view being a mirror image thereof.

FIG. 5 is a perspective view of a second embodiment of the present invention;

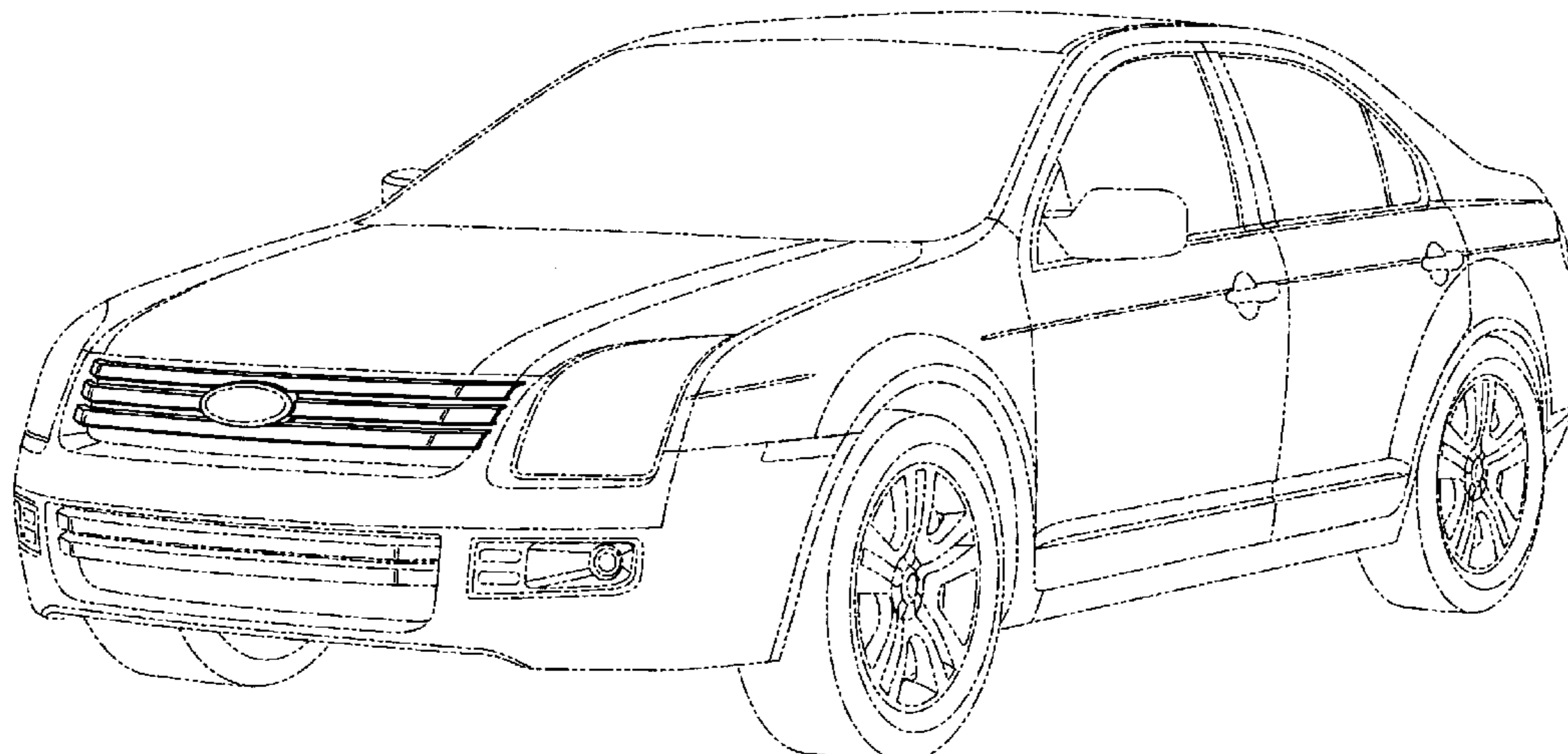
FIG. 6 is a front view of the second embodiment shown in FIG. 5;

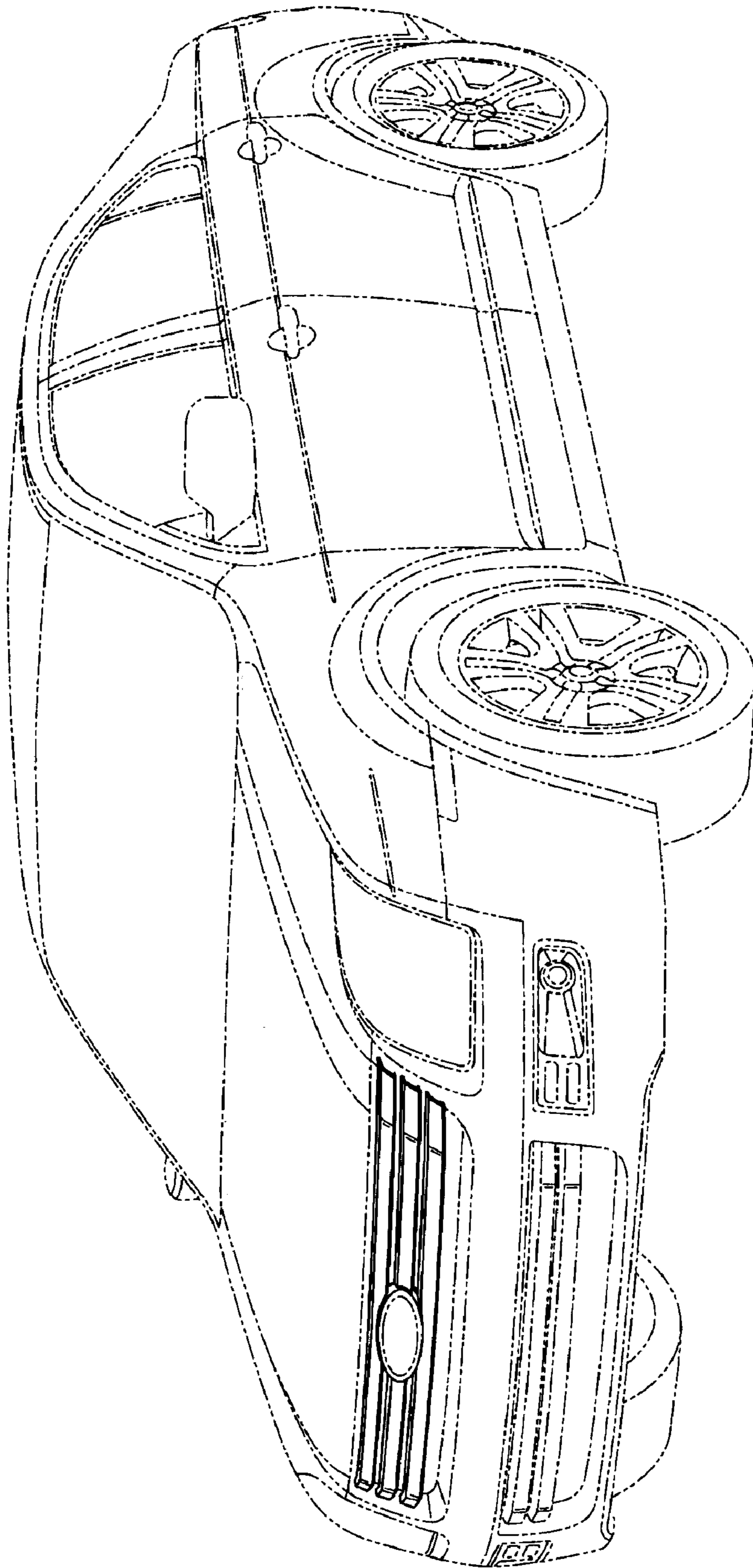
FIG. 7 is a top plan view of the second embodiment shown in FIG. 5; and,

FIG. 8 is a right side elevational view of the second embodiment shown in FIG. 5, the left side elevational view being a mirror image thereof.

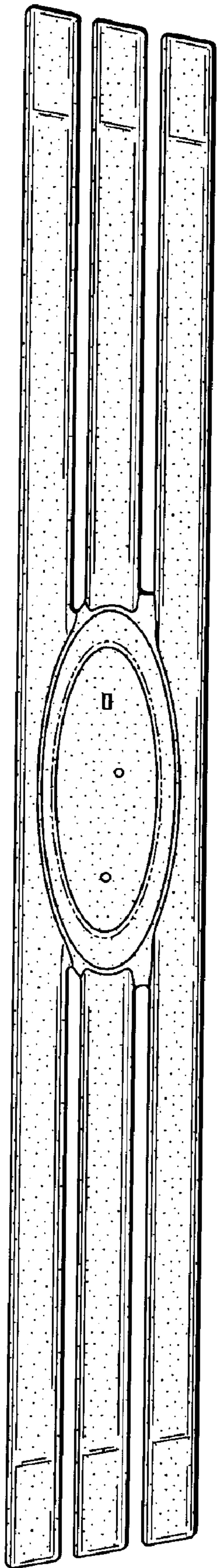

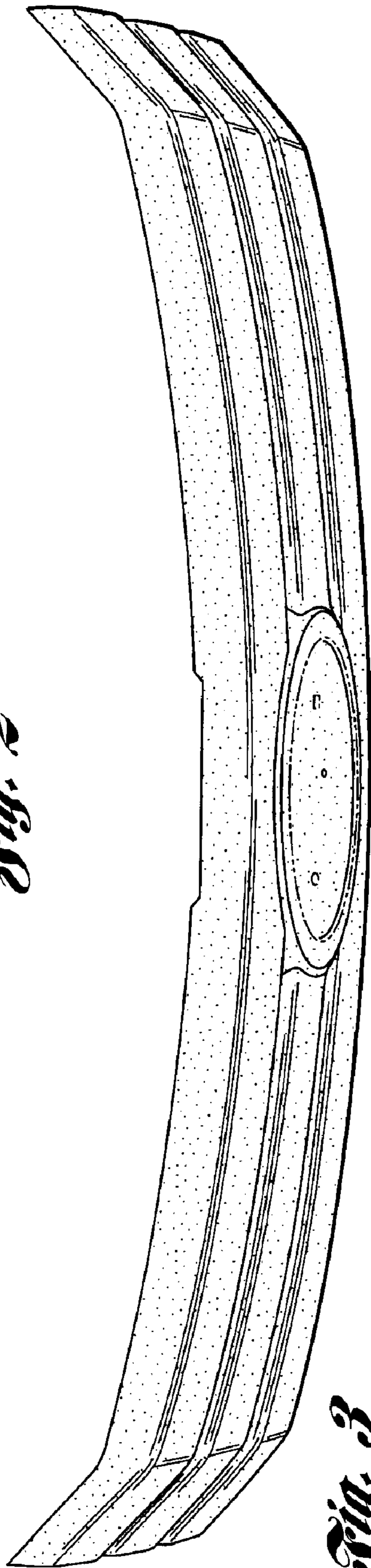




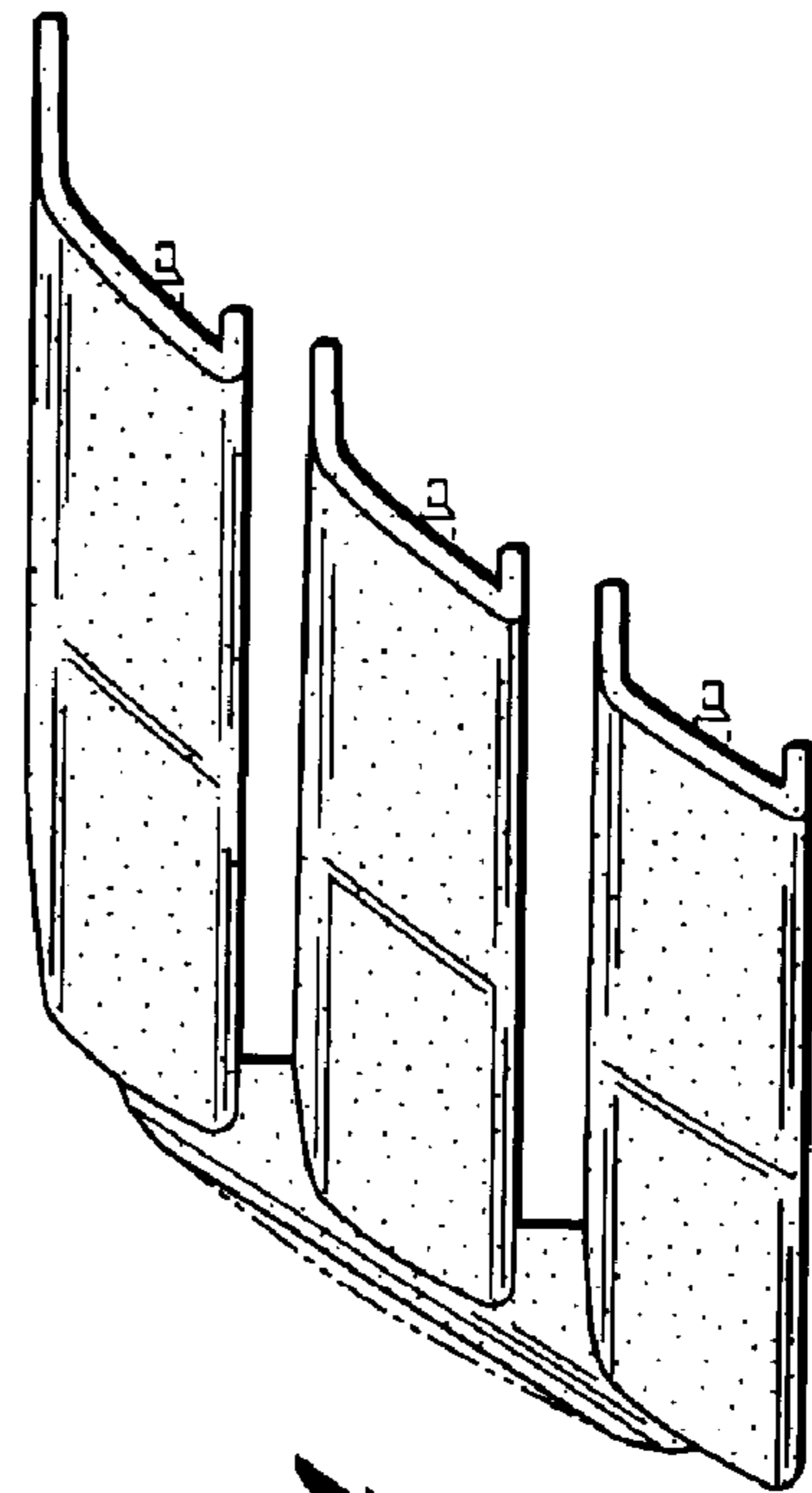

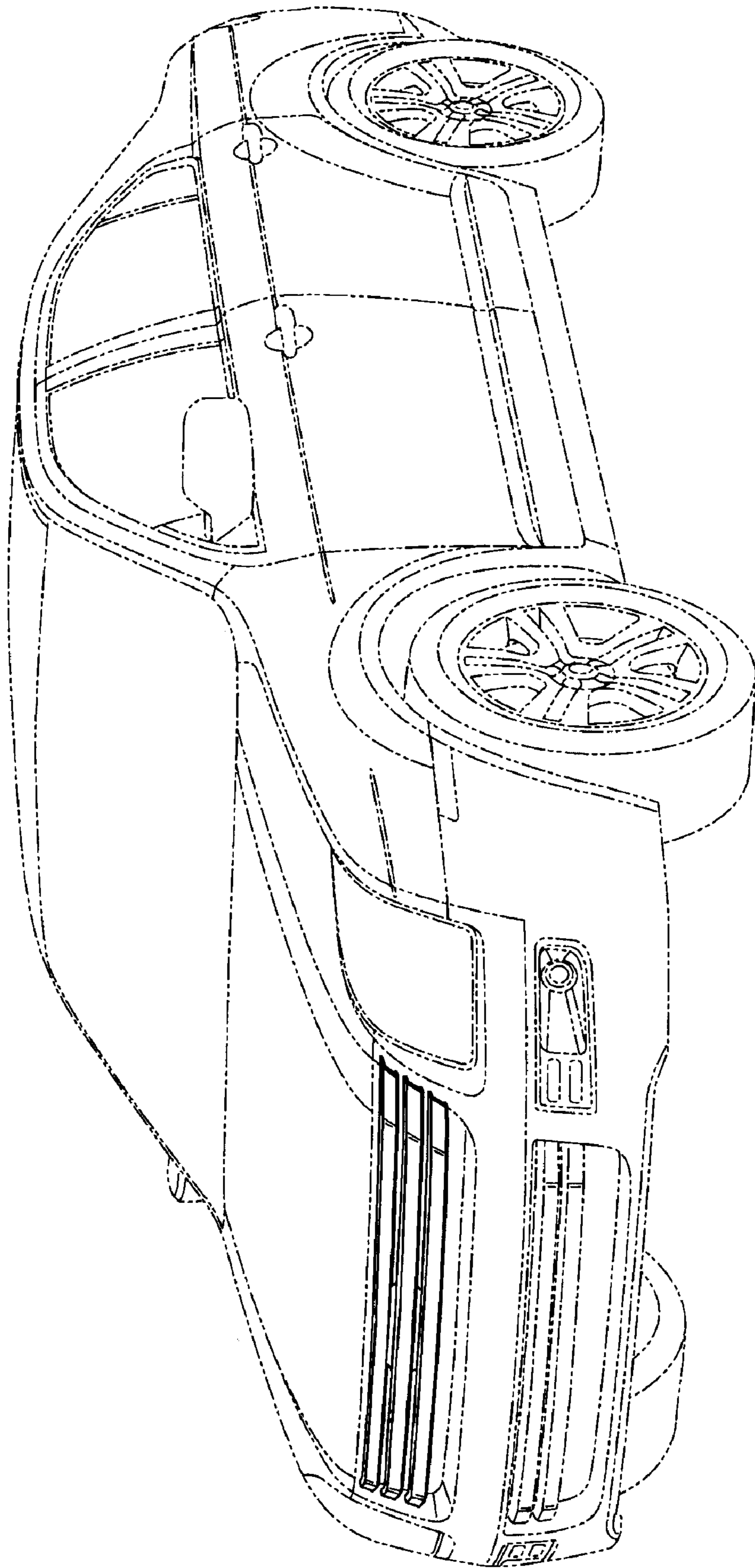

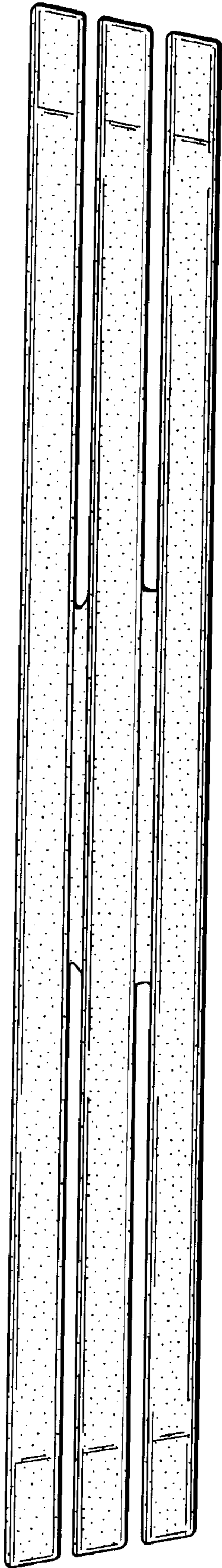

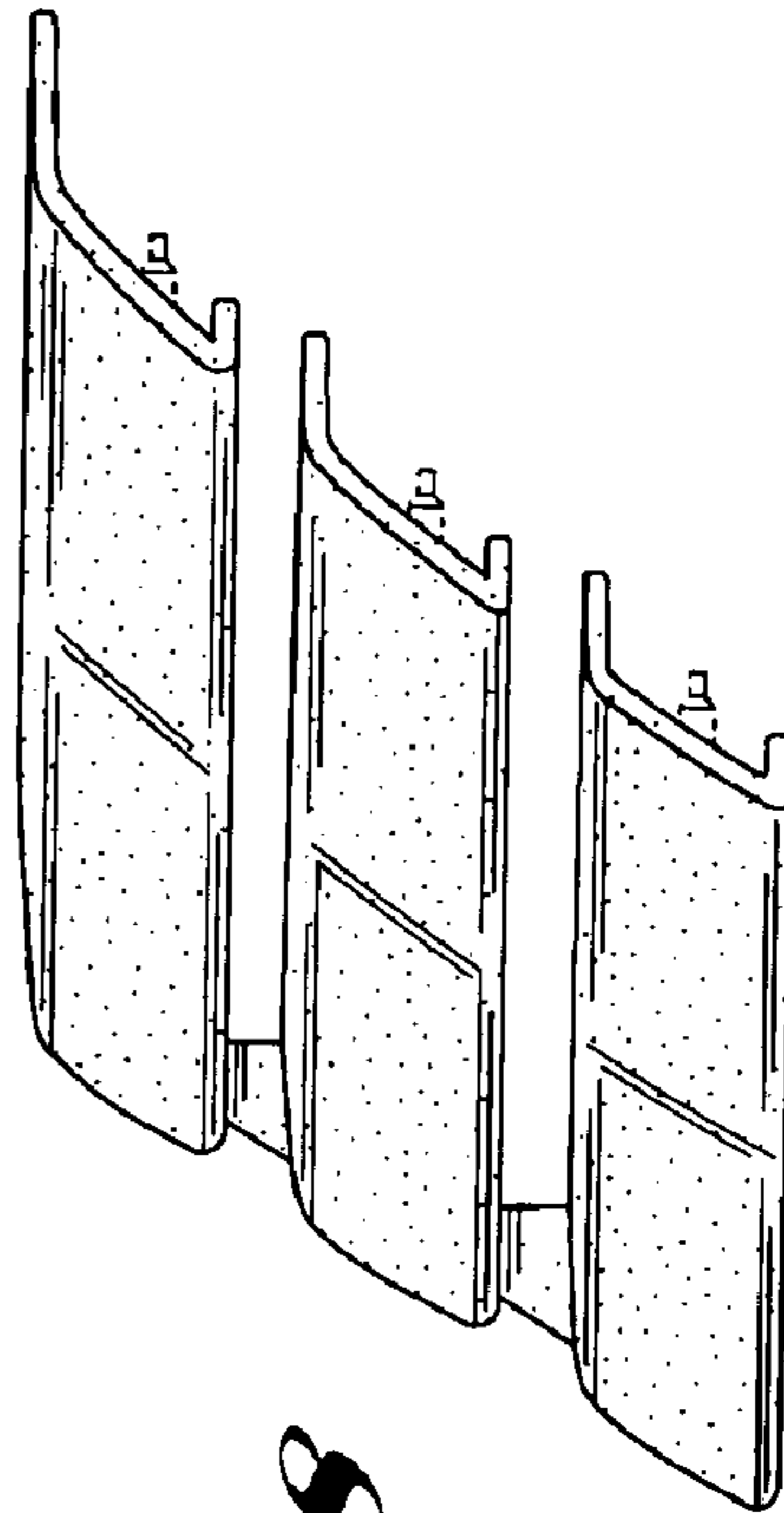
