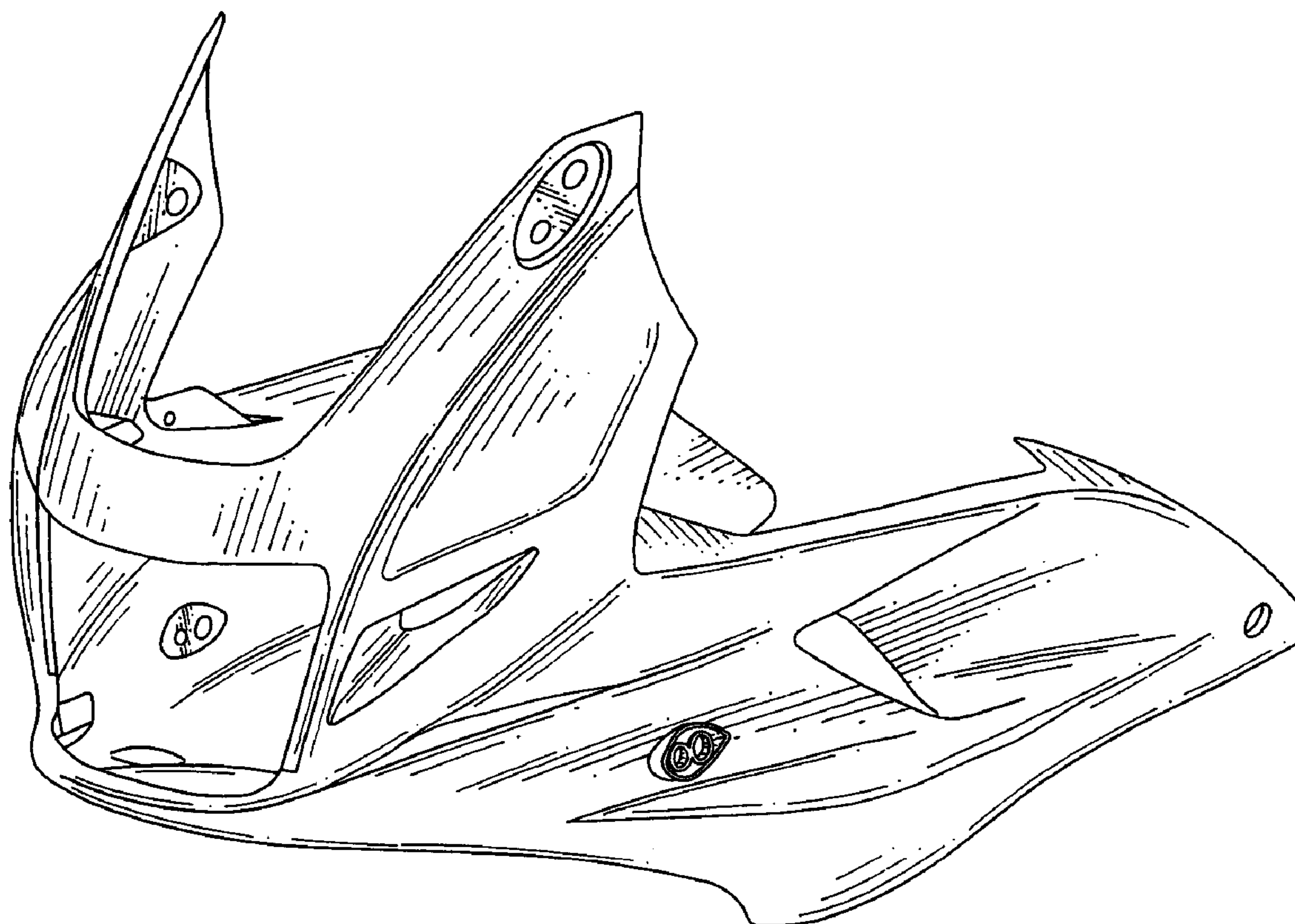
(57) **CLAIM**

The ornamental design for, a front fairing for a motorcycle, as shown and described.

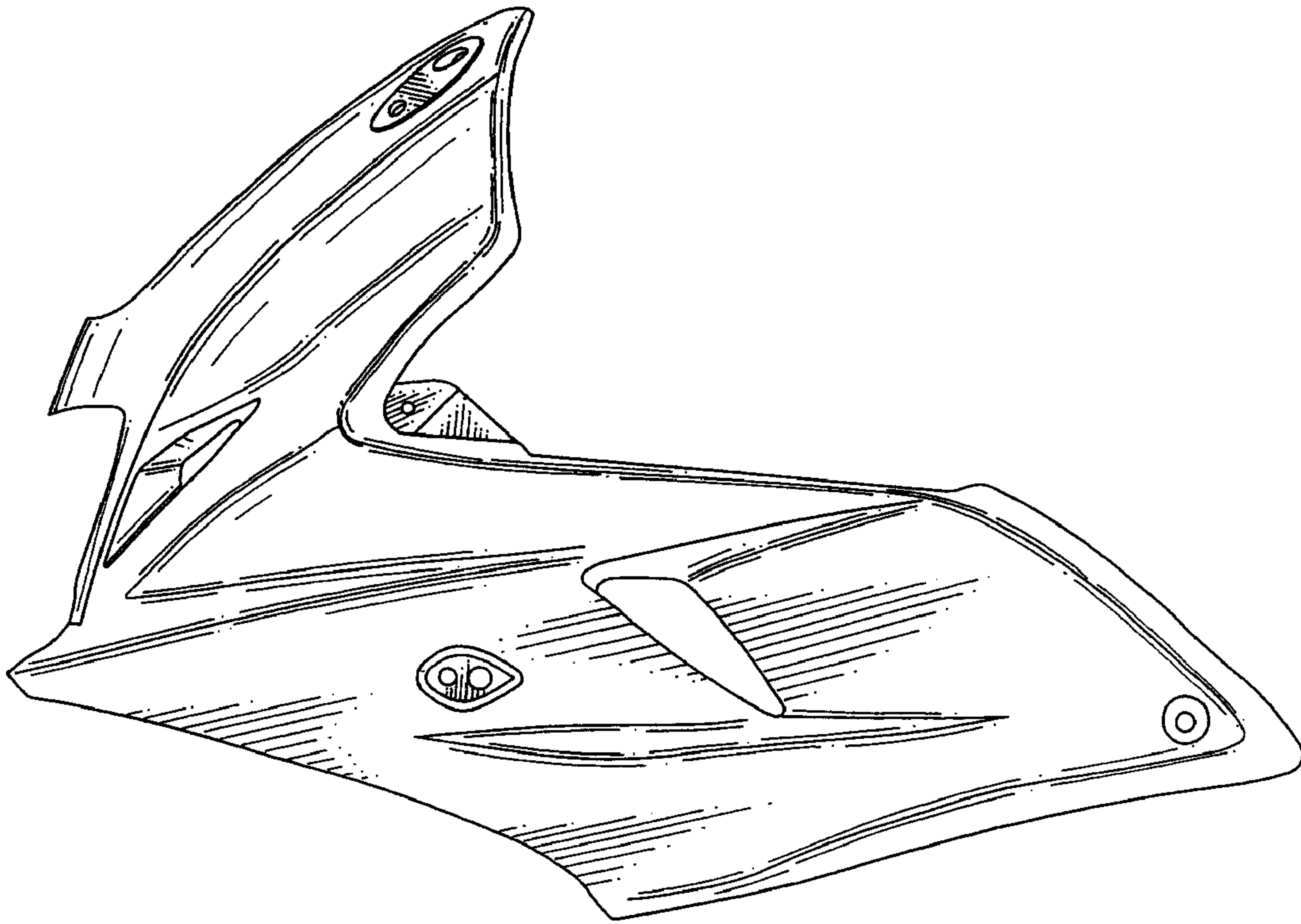
DESCRIPTION

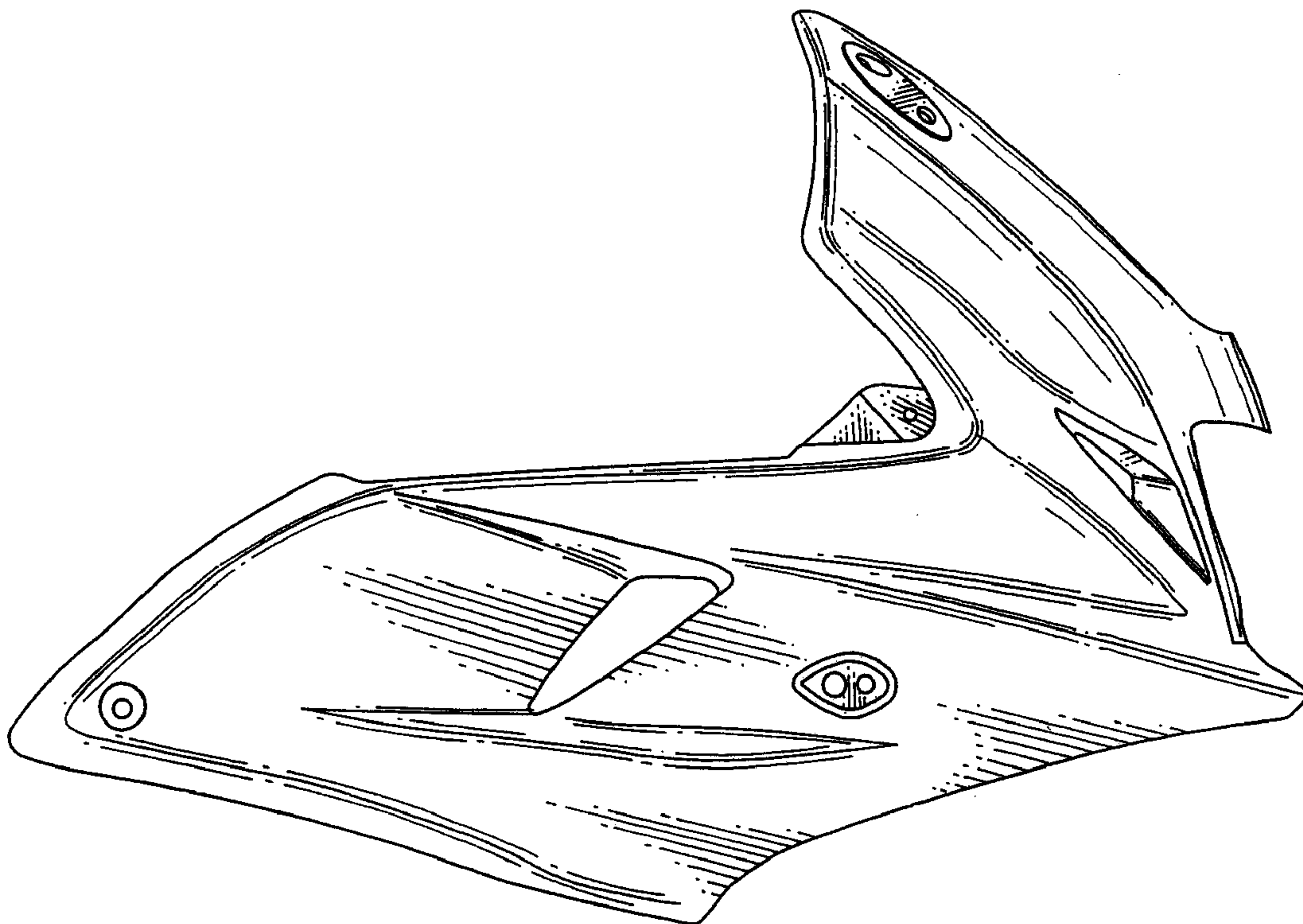

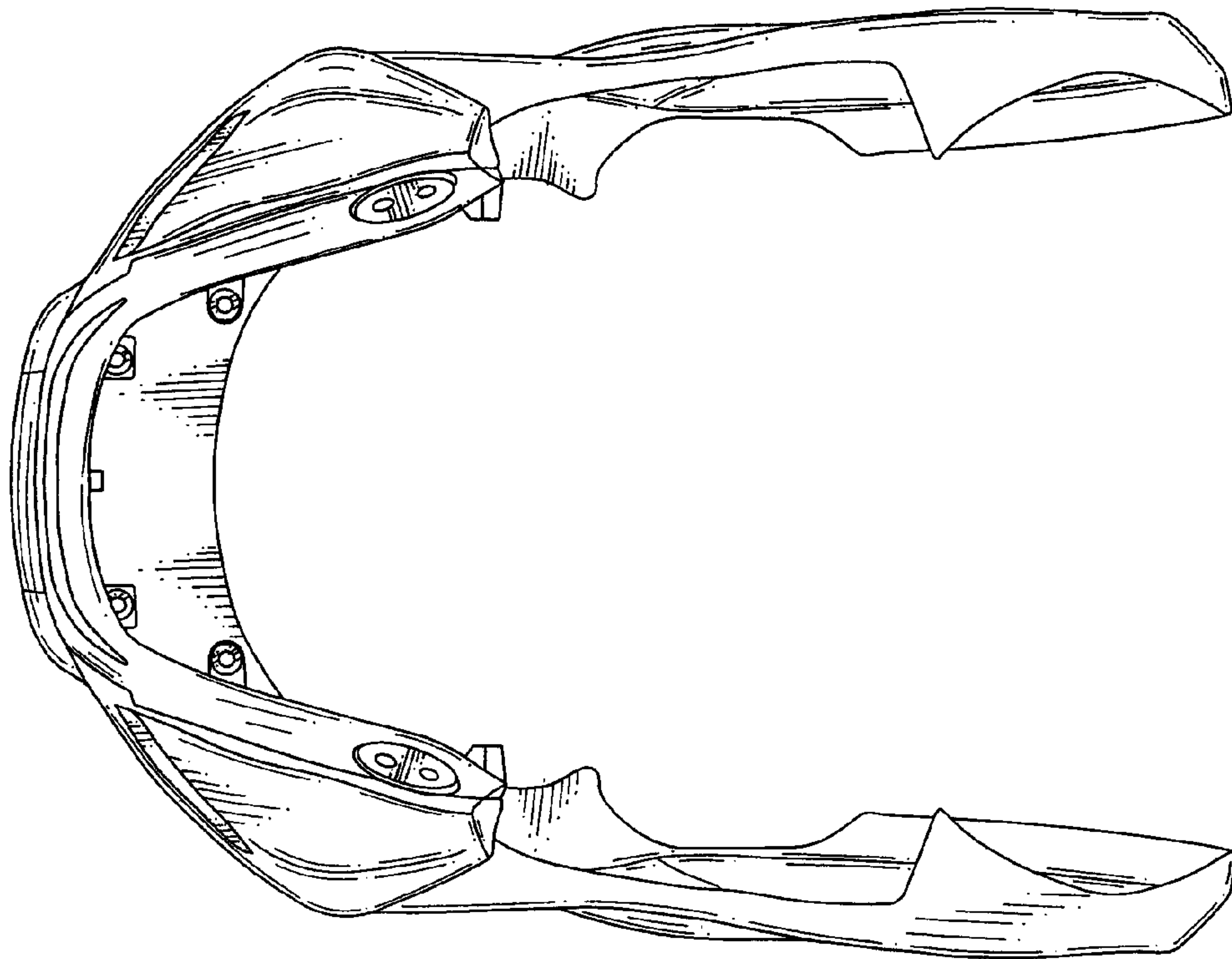

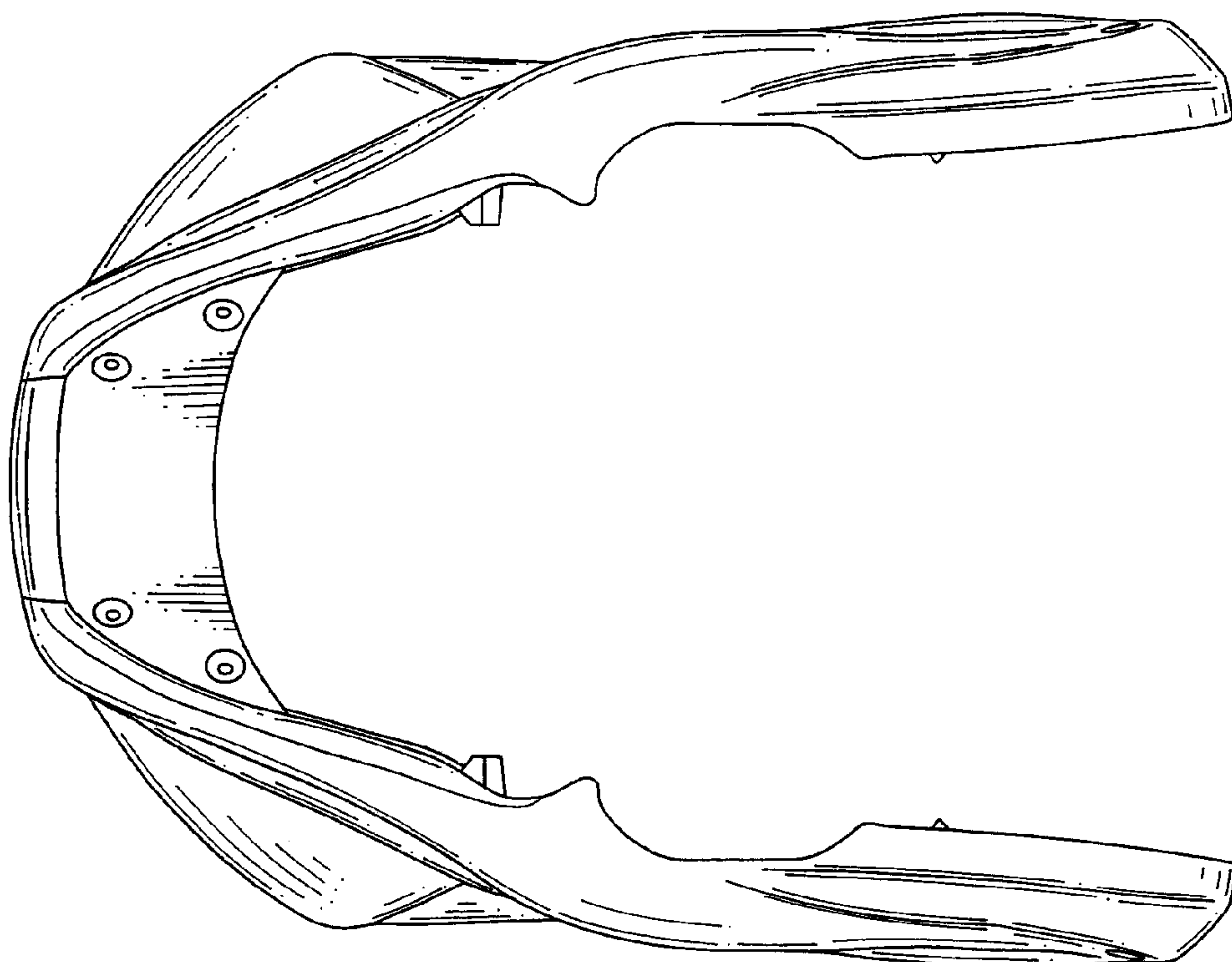

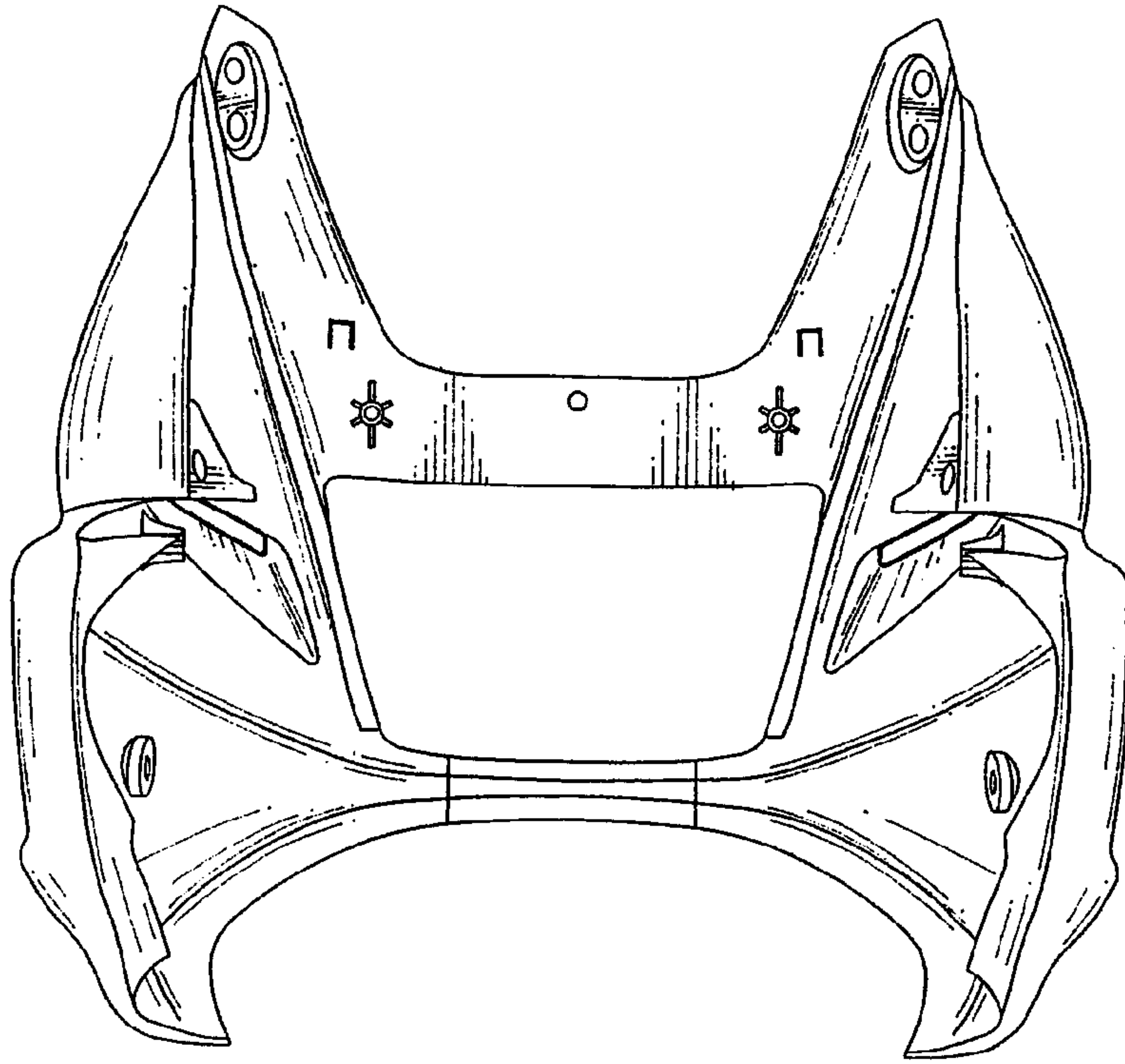

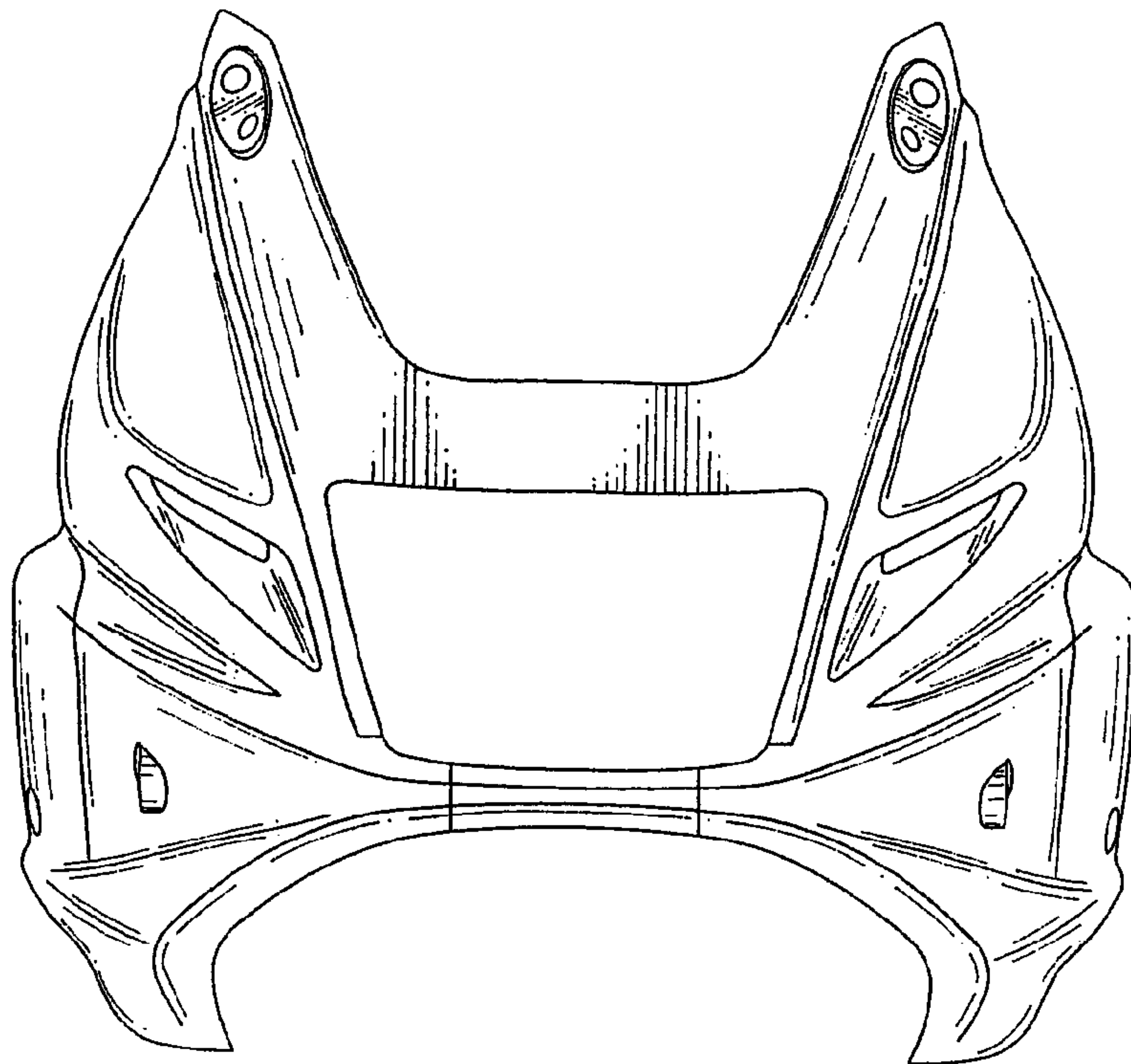

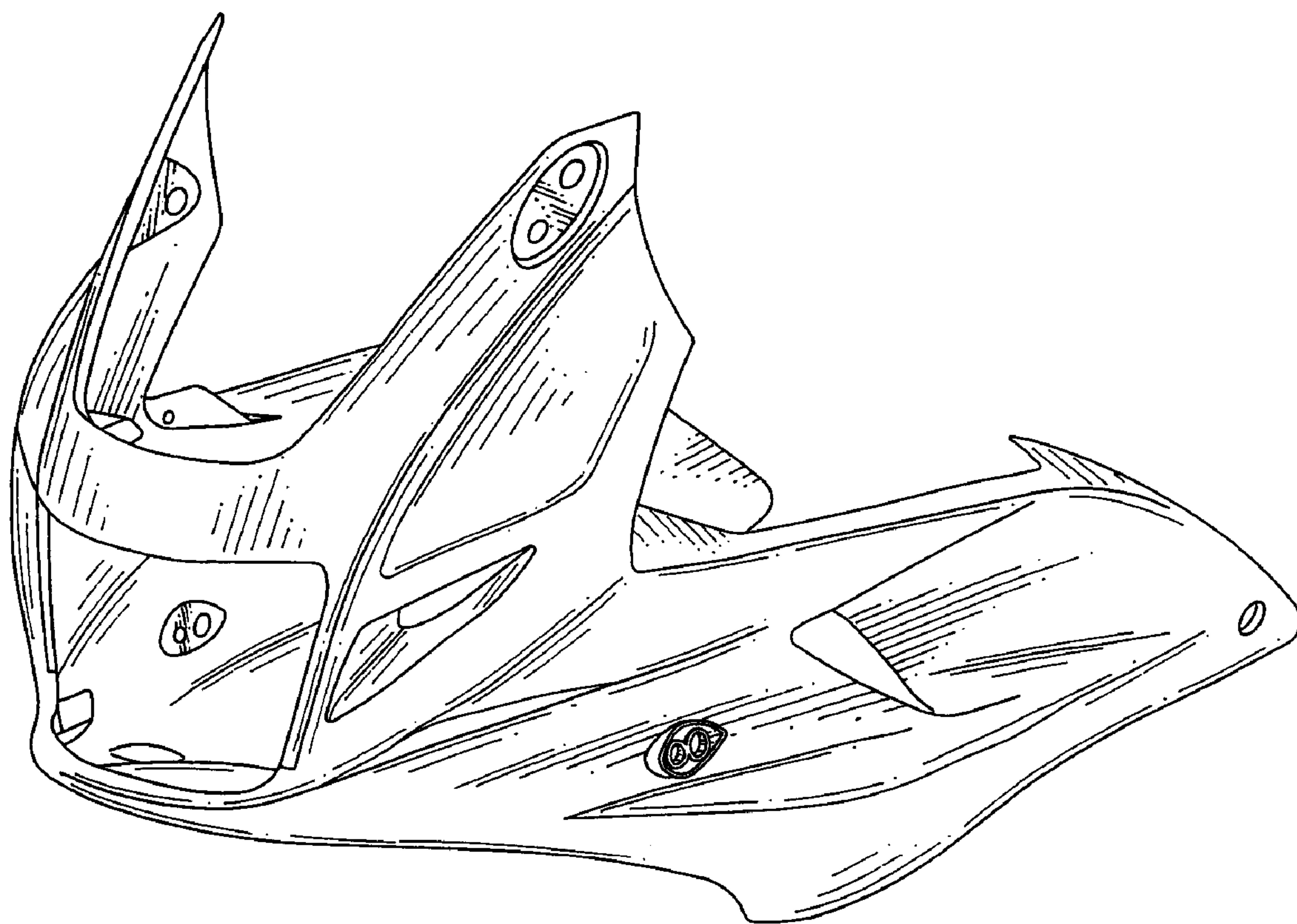
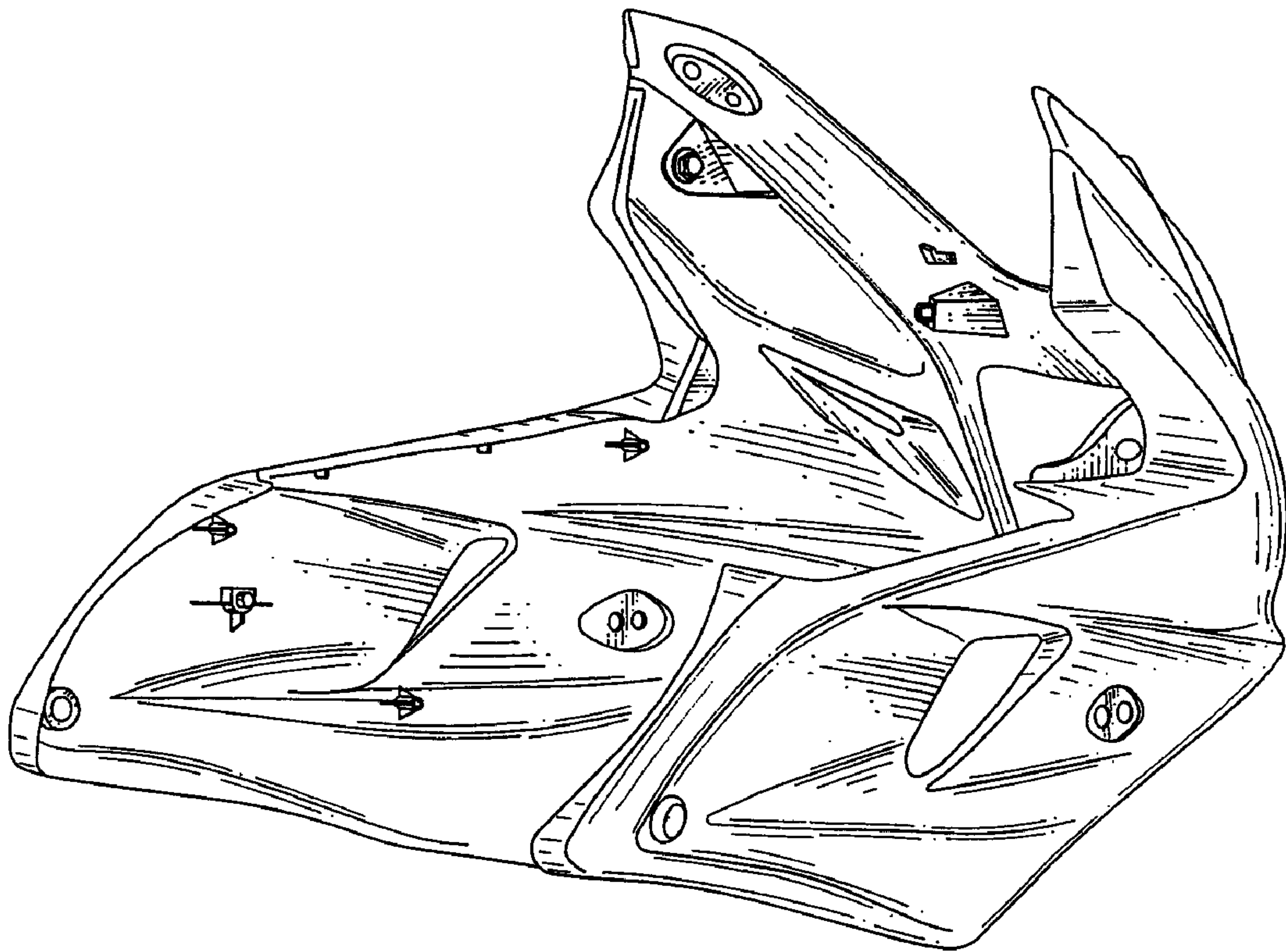
