(57) **CLAIM**

The ornamental design for a key button arrangement for a handset, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a key button arrangement for a handset showing my new design shown in a disclaimed handset environment;

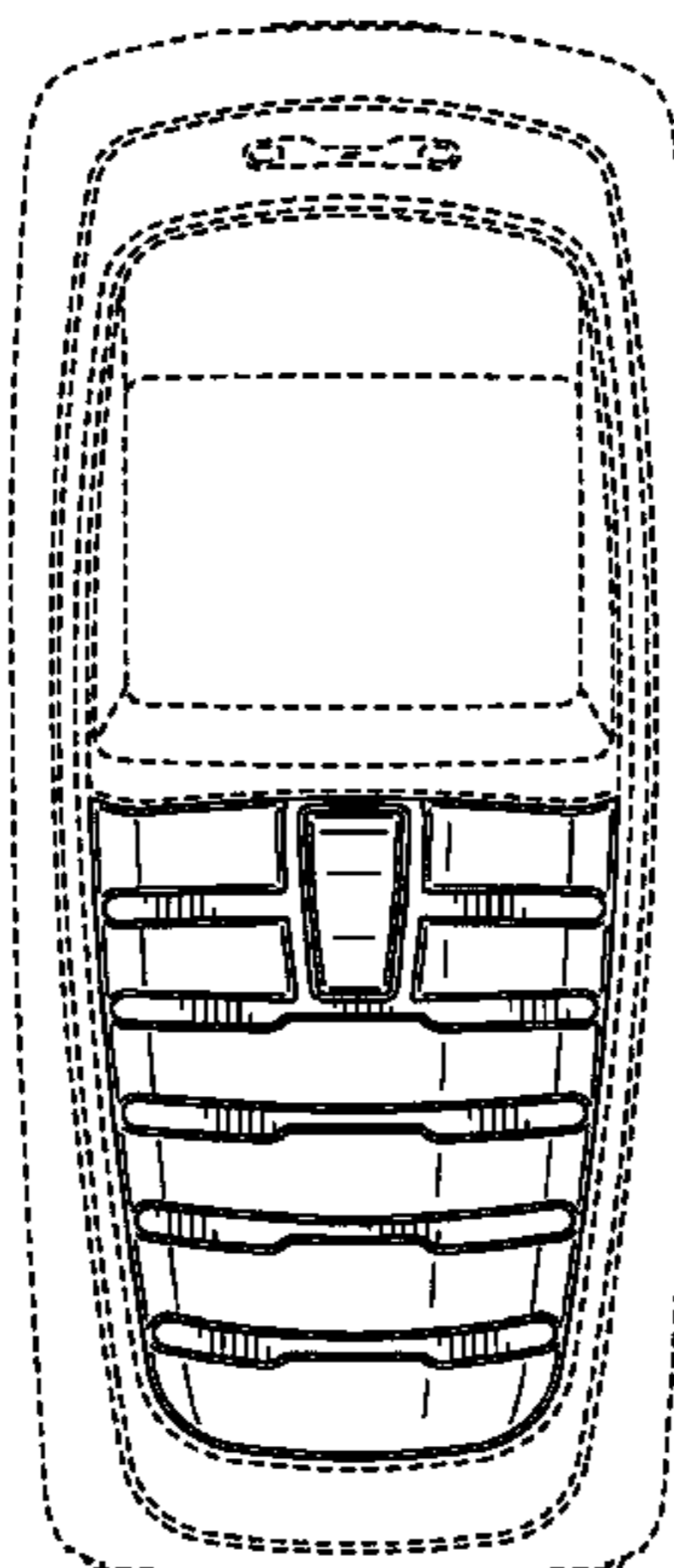
FIG. 2 is a perspective view thereof;

FIG. 3 is a front view of a key button arrangement for a handset shown in a disclaimed keypad environment; and,

FIG. 4 is a perspective view thereof.

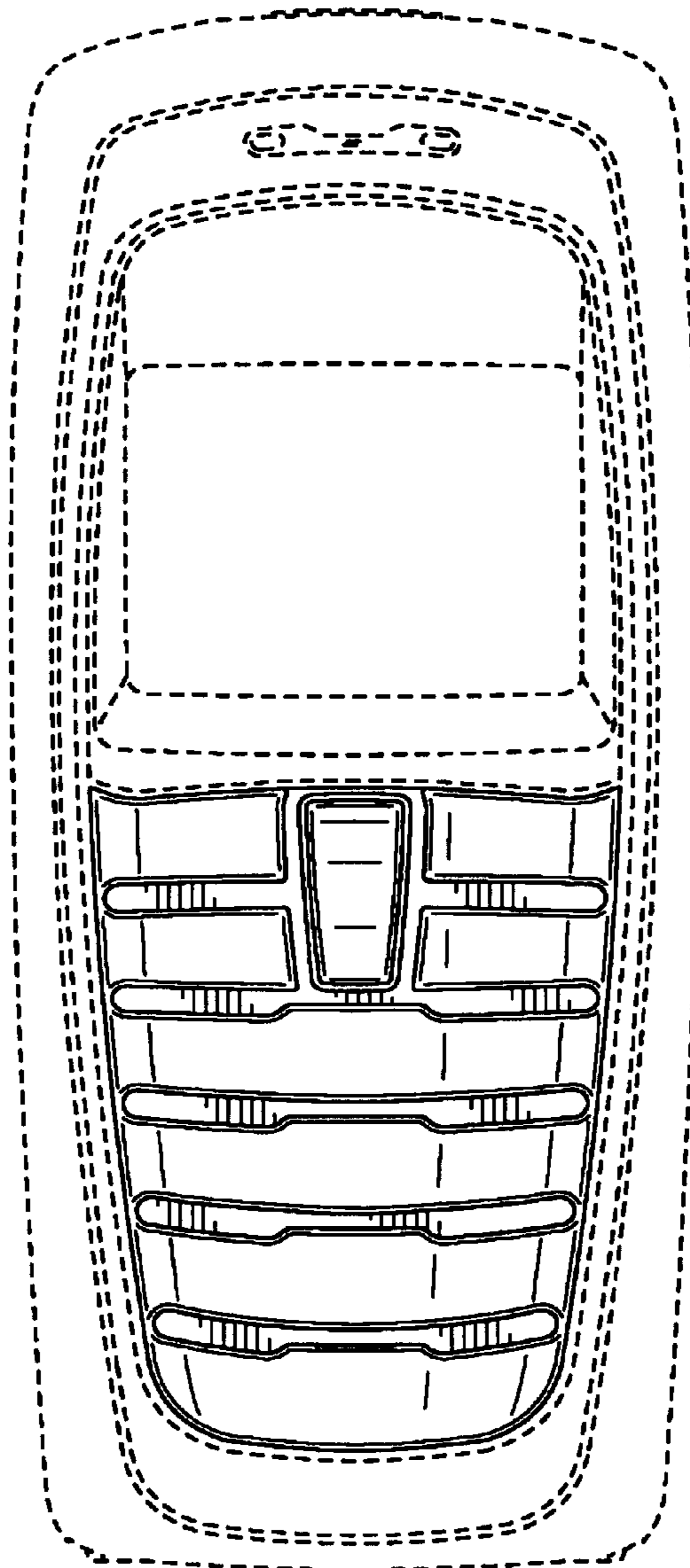

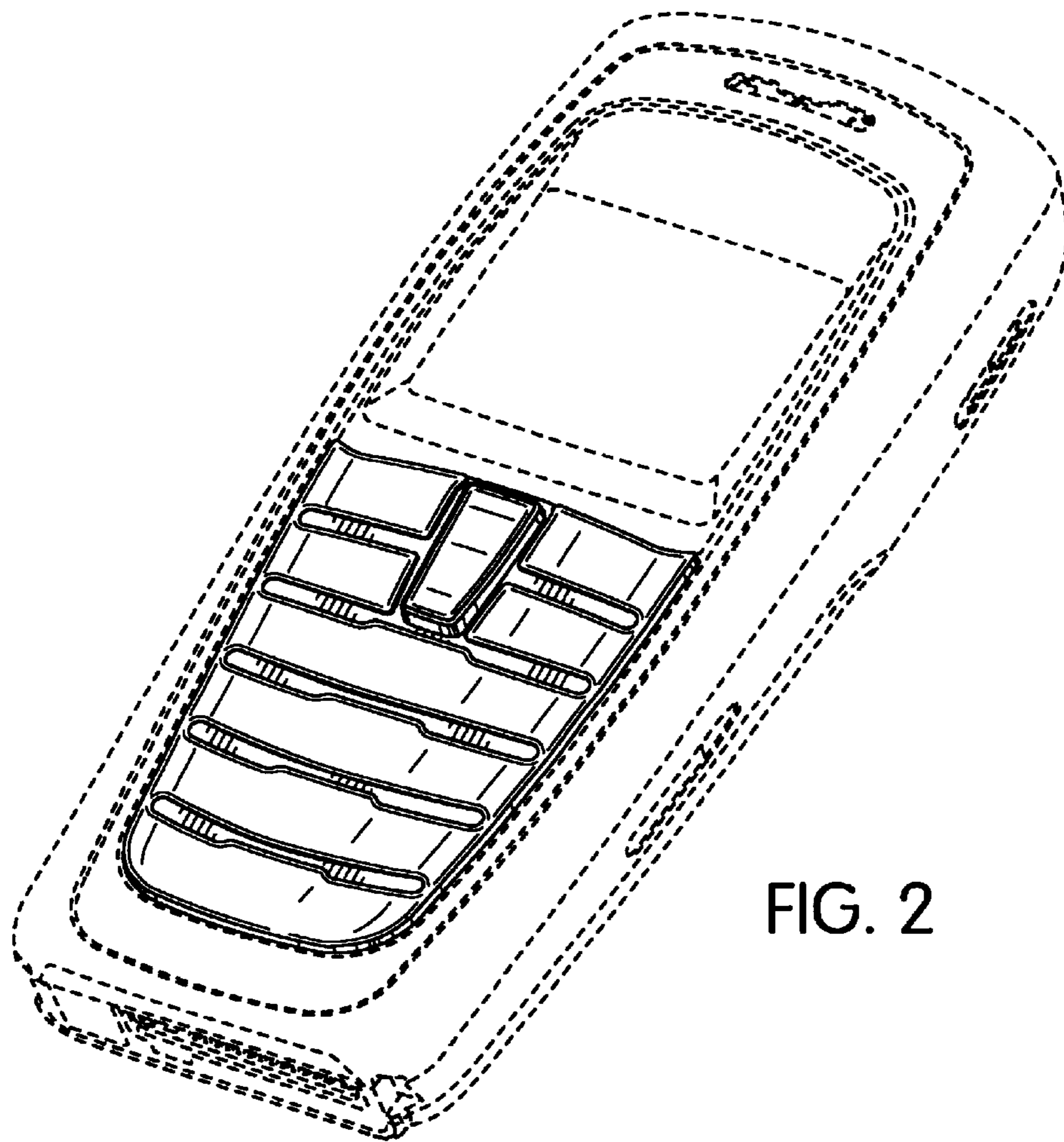

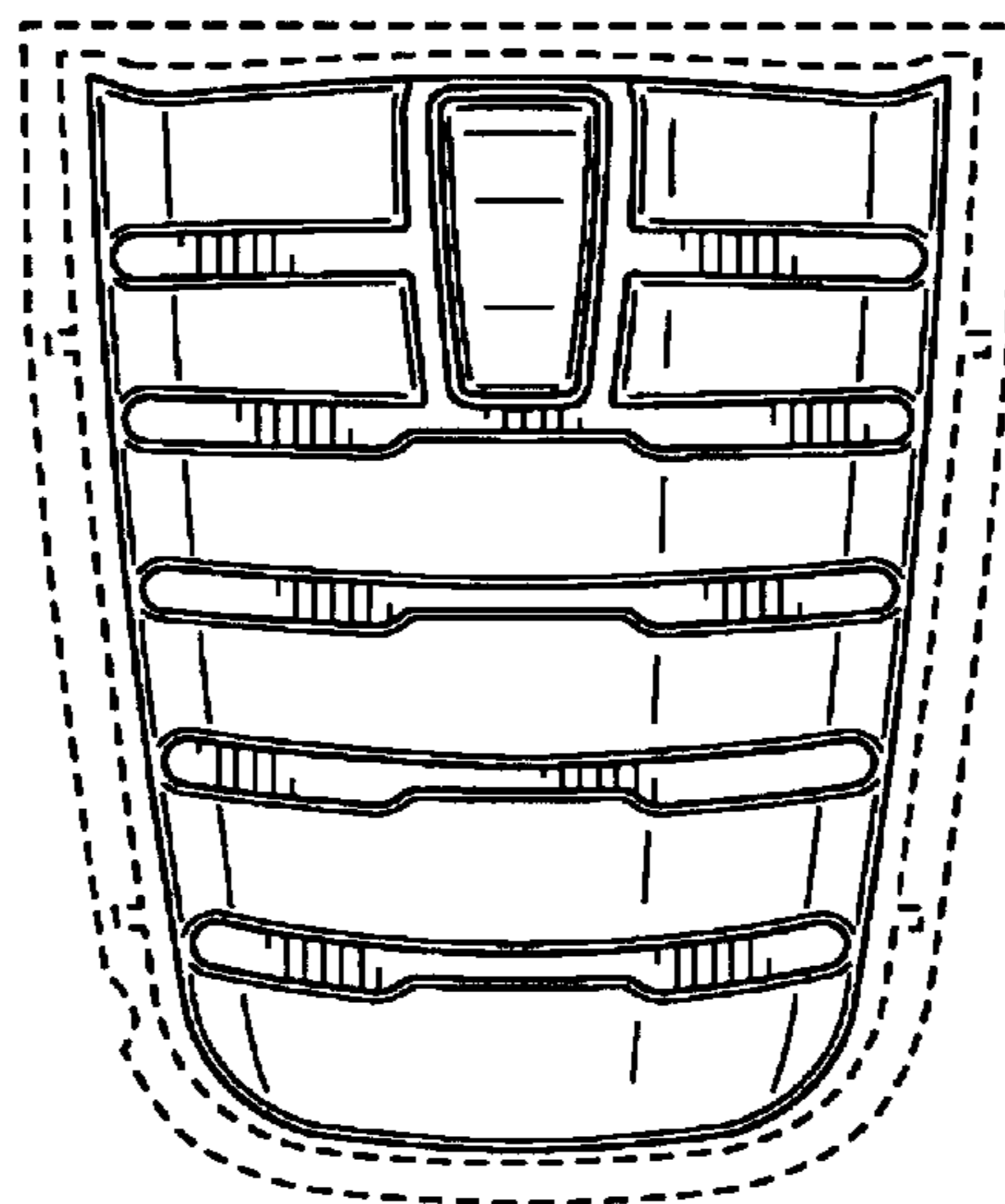

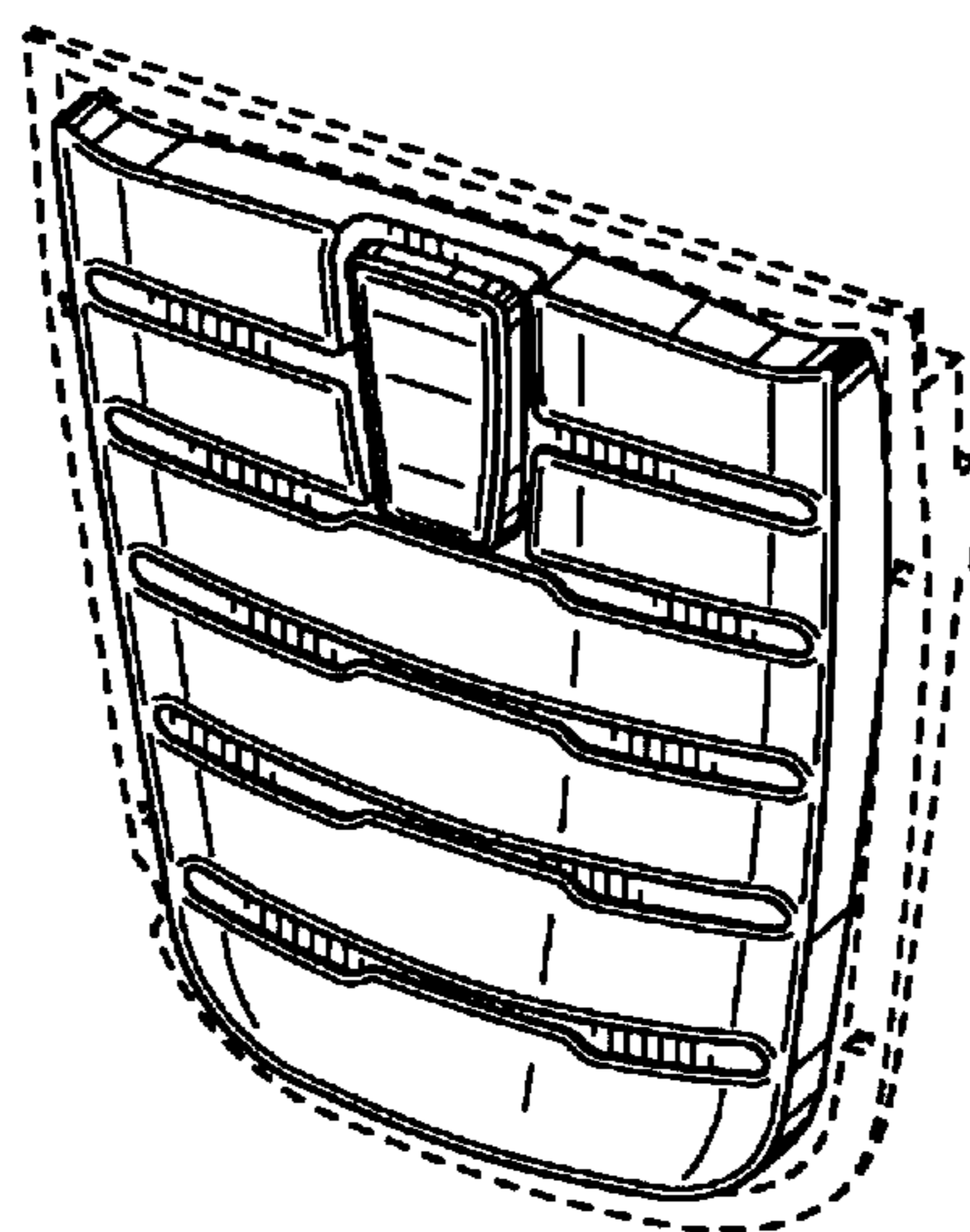
