DESCRIPTION

FIG. 1 is a front elevational view of a an arithmetic and control unit showing our new design;

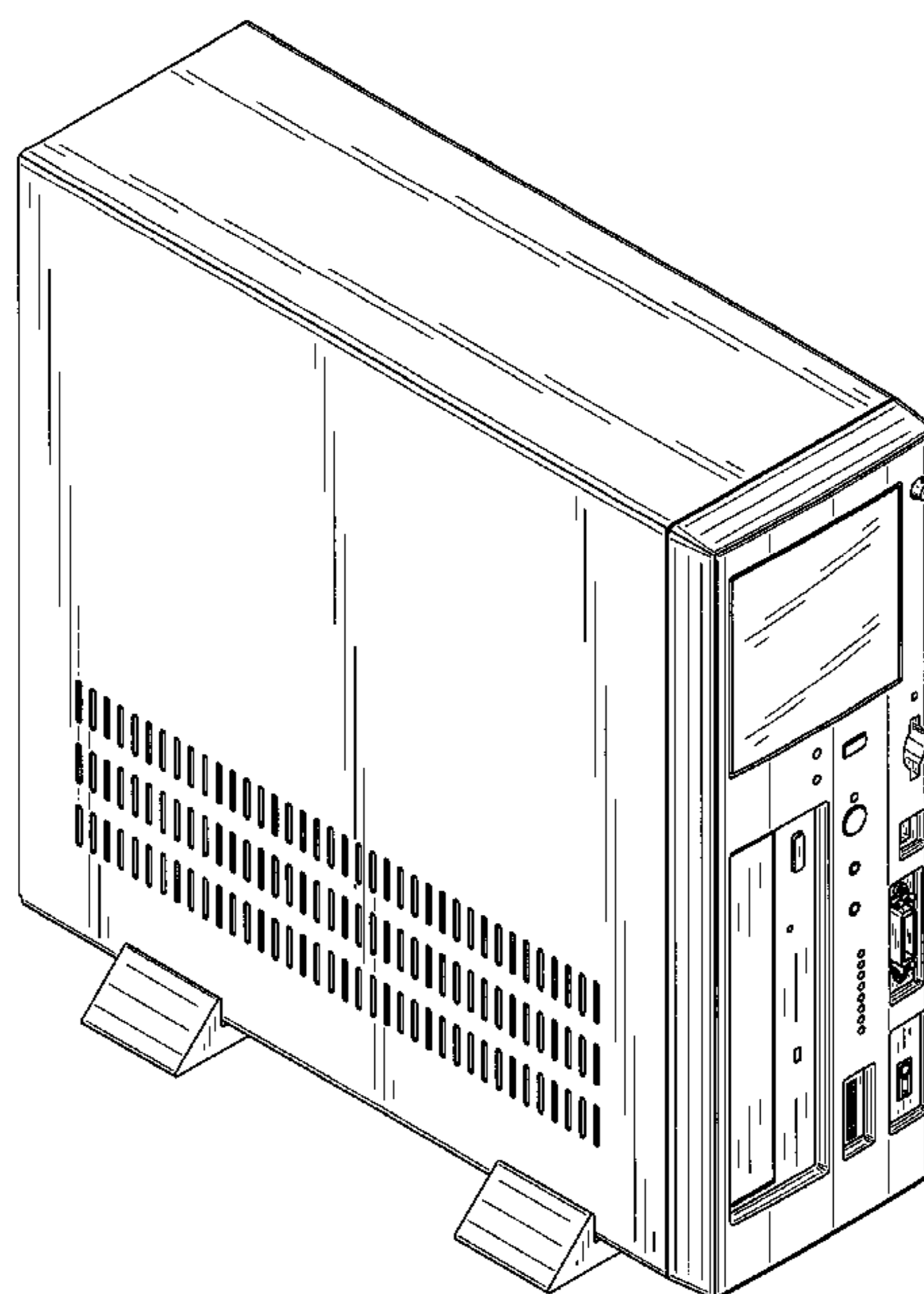

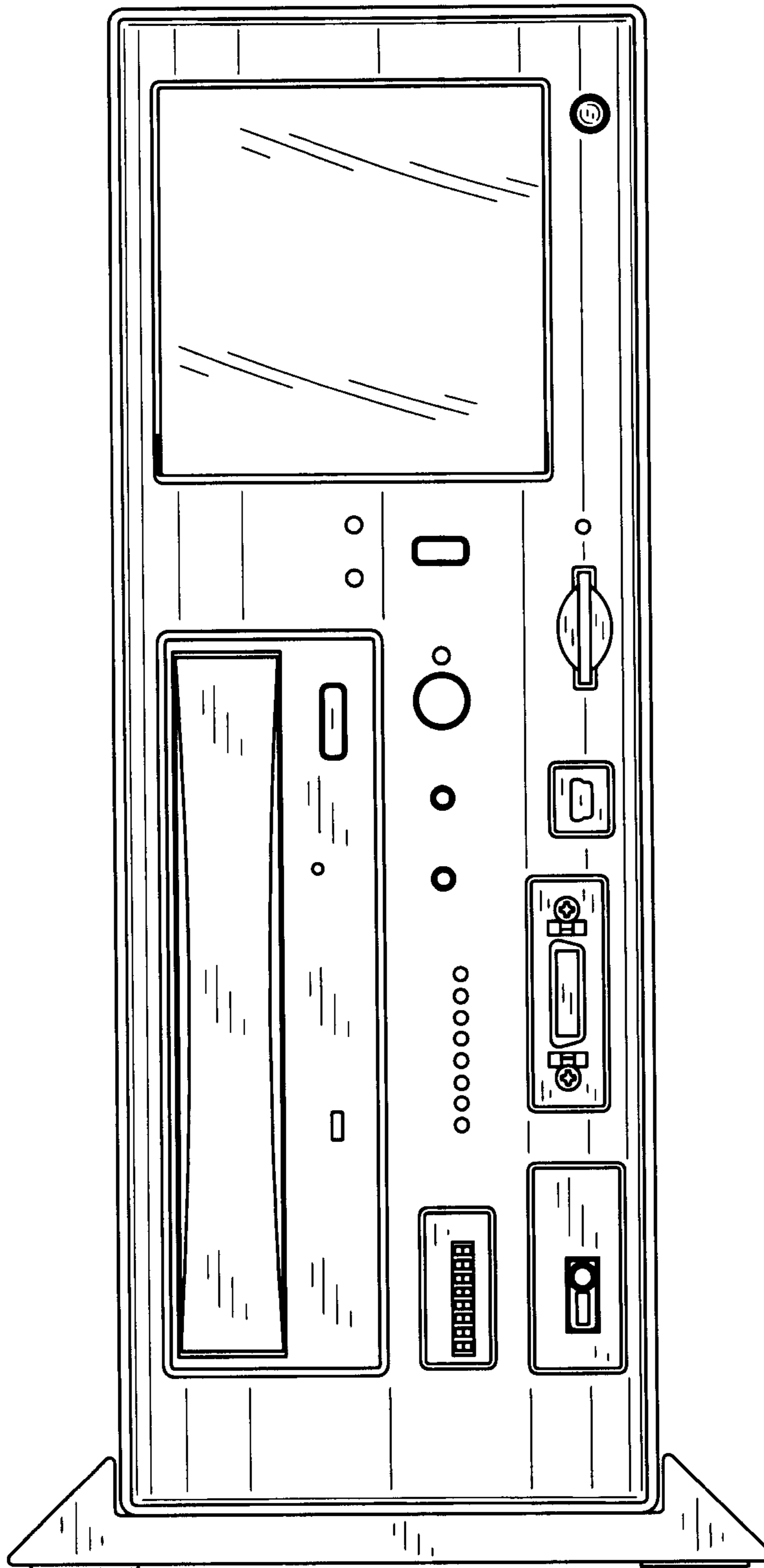
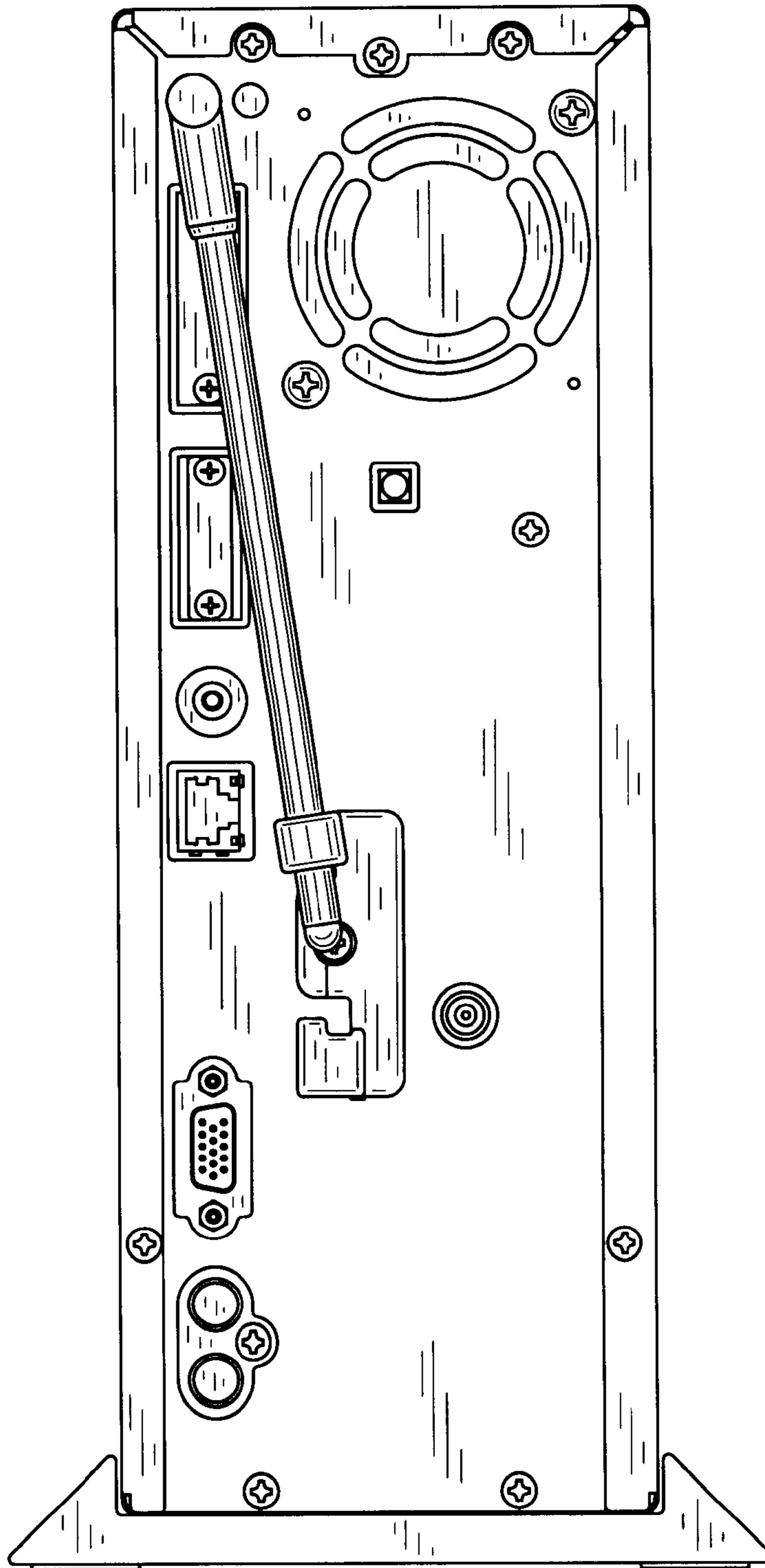

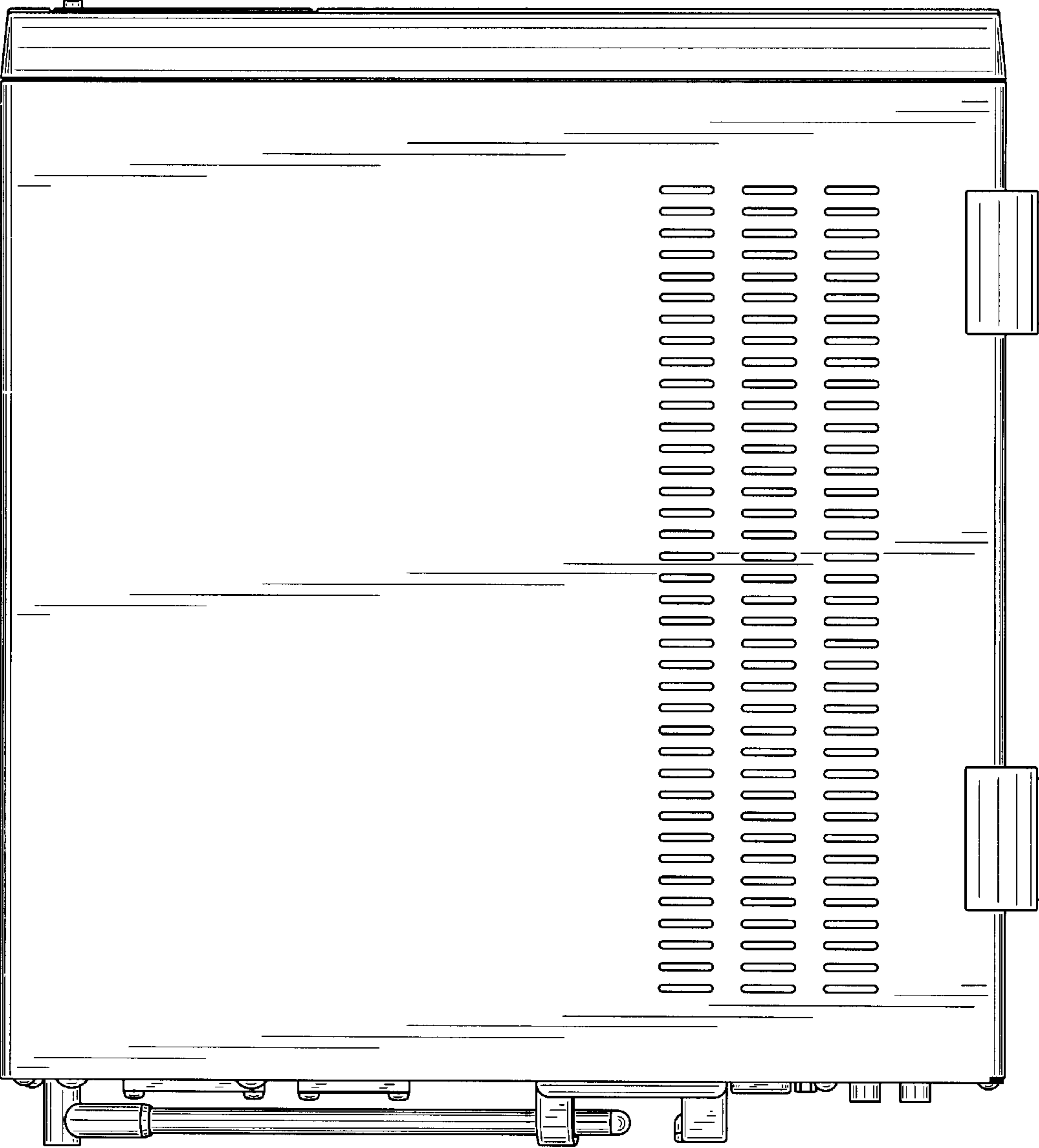

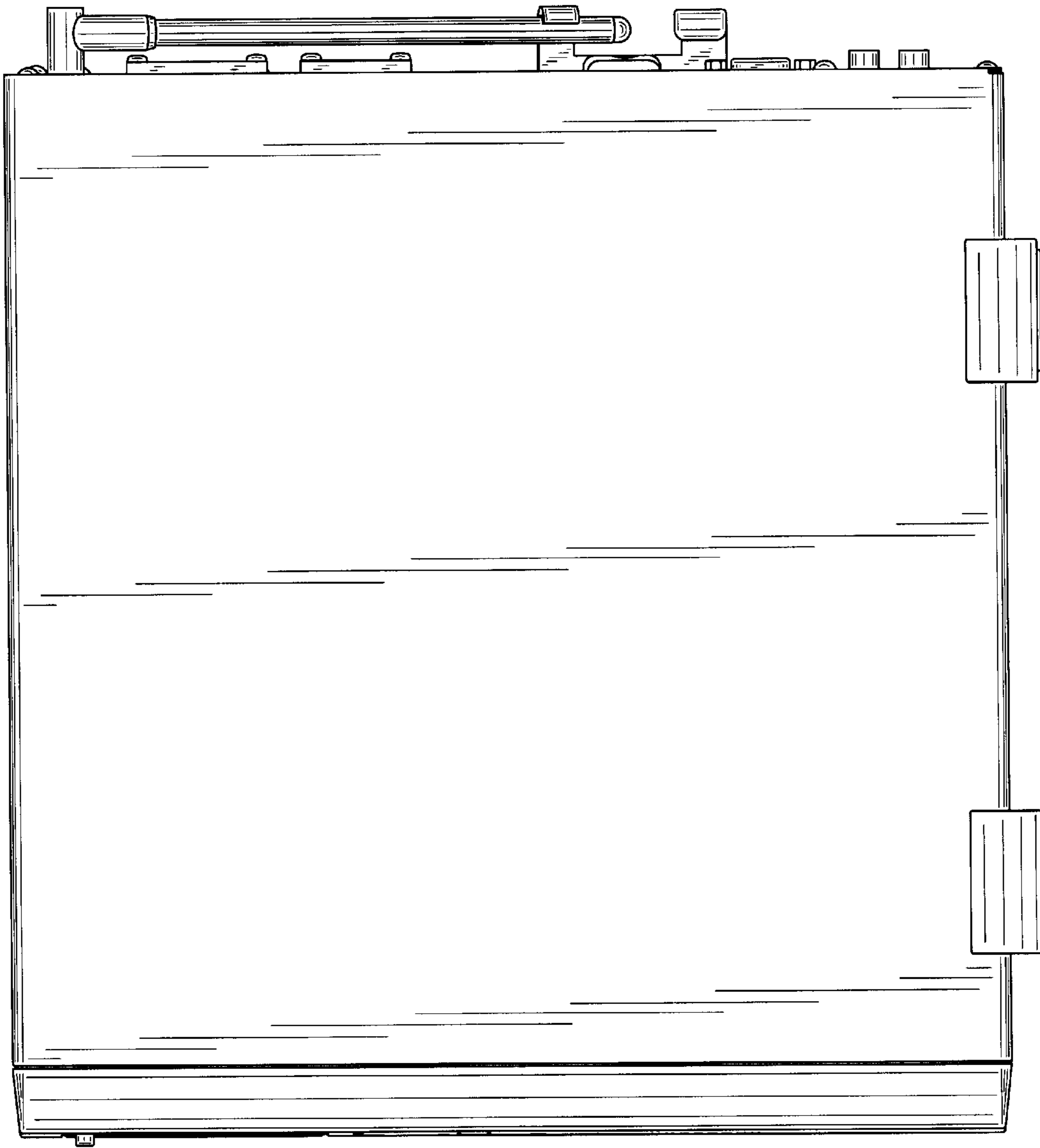

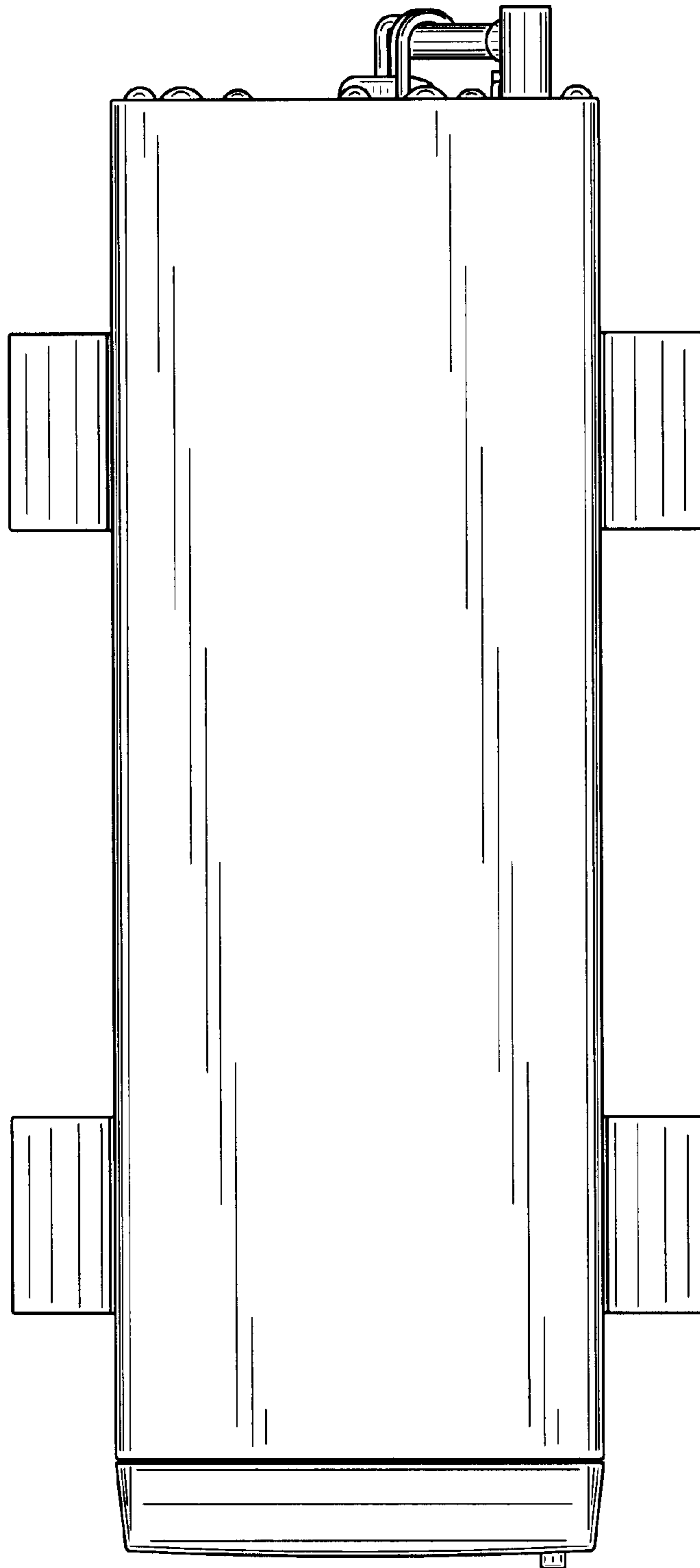

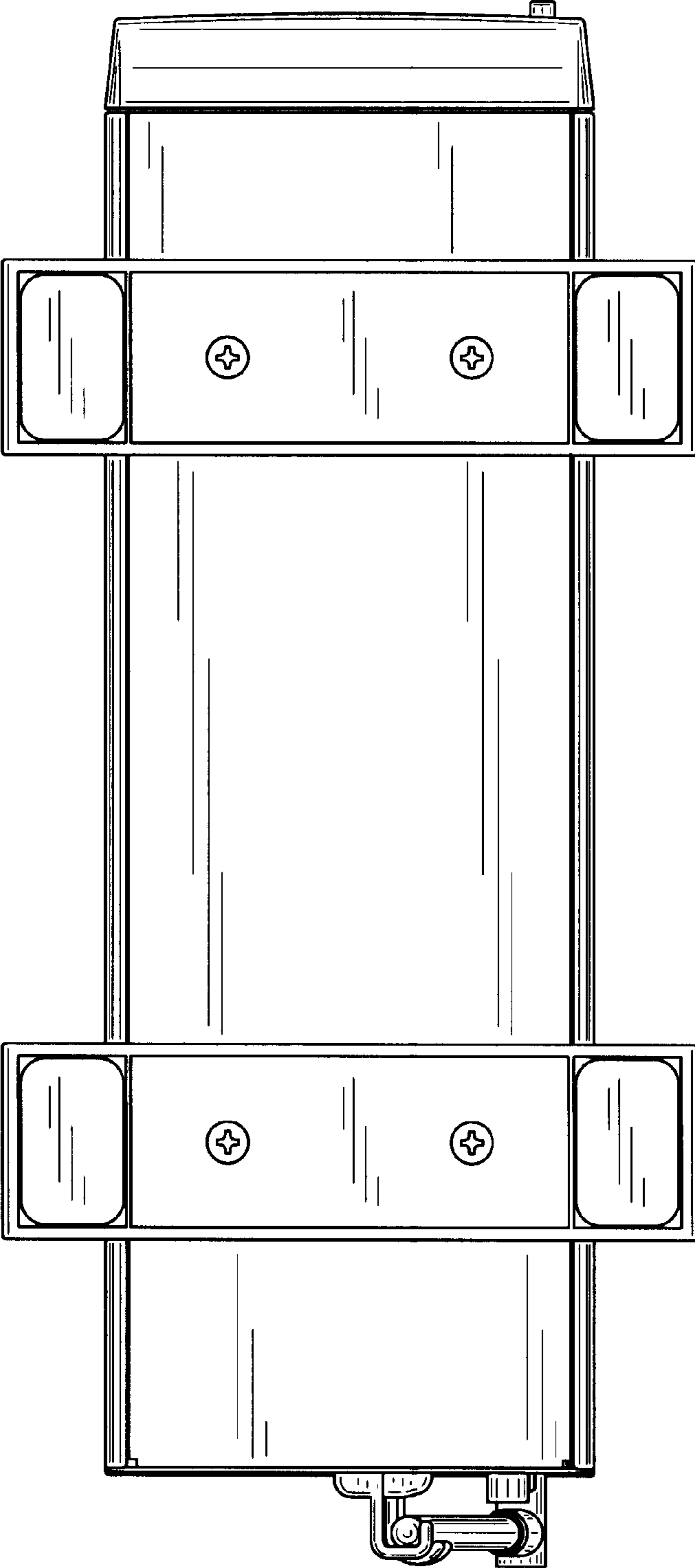

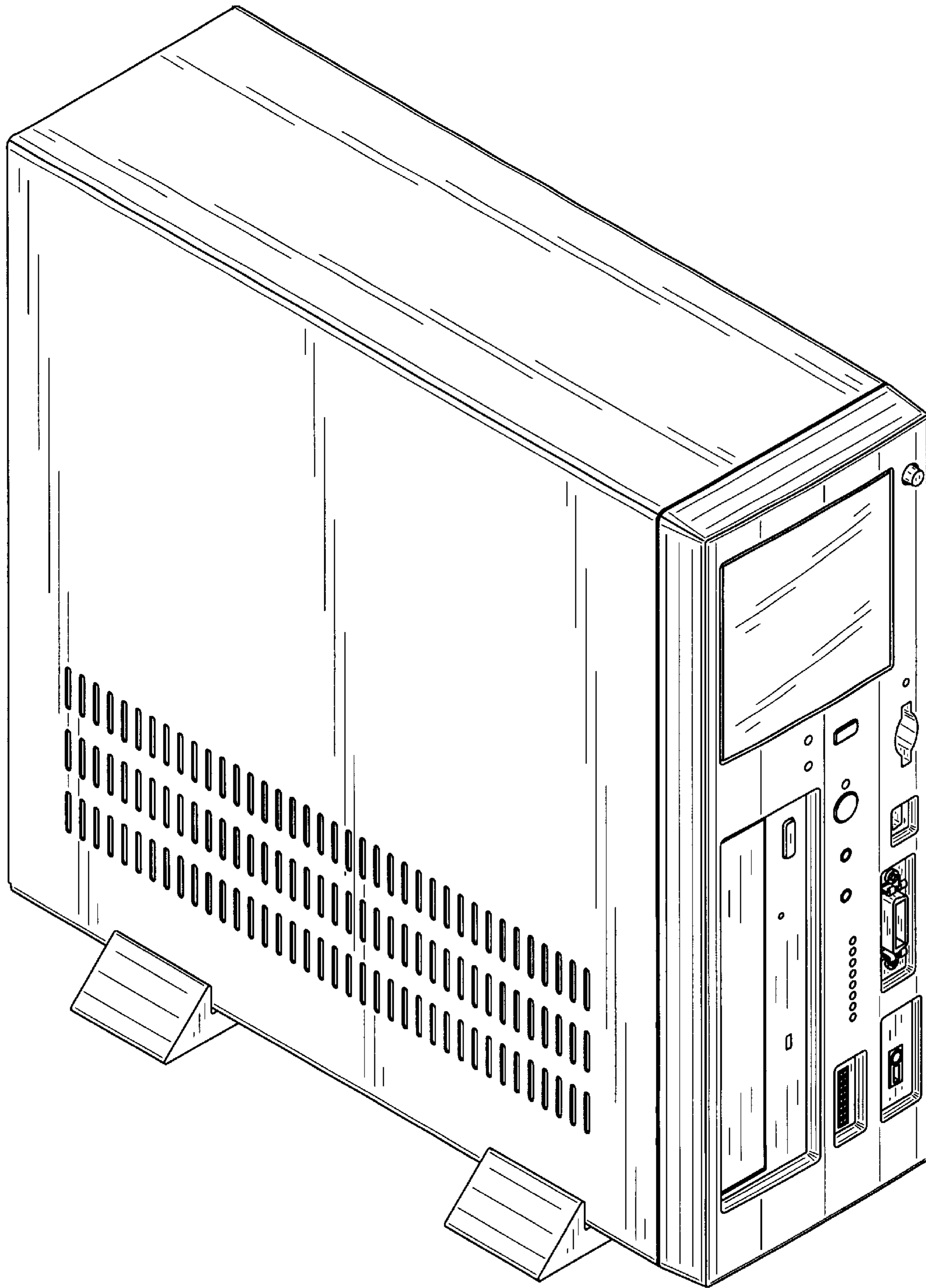
