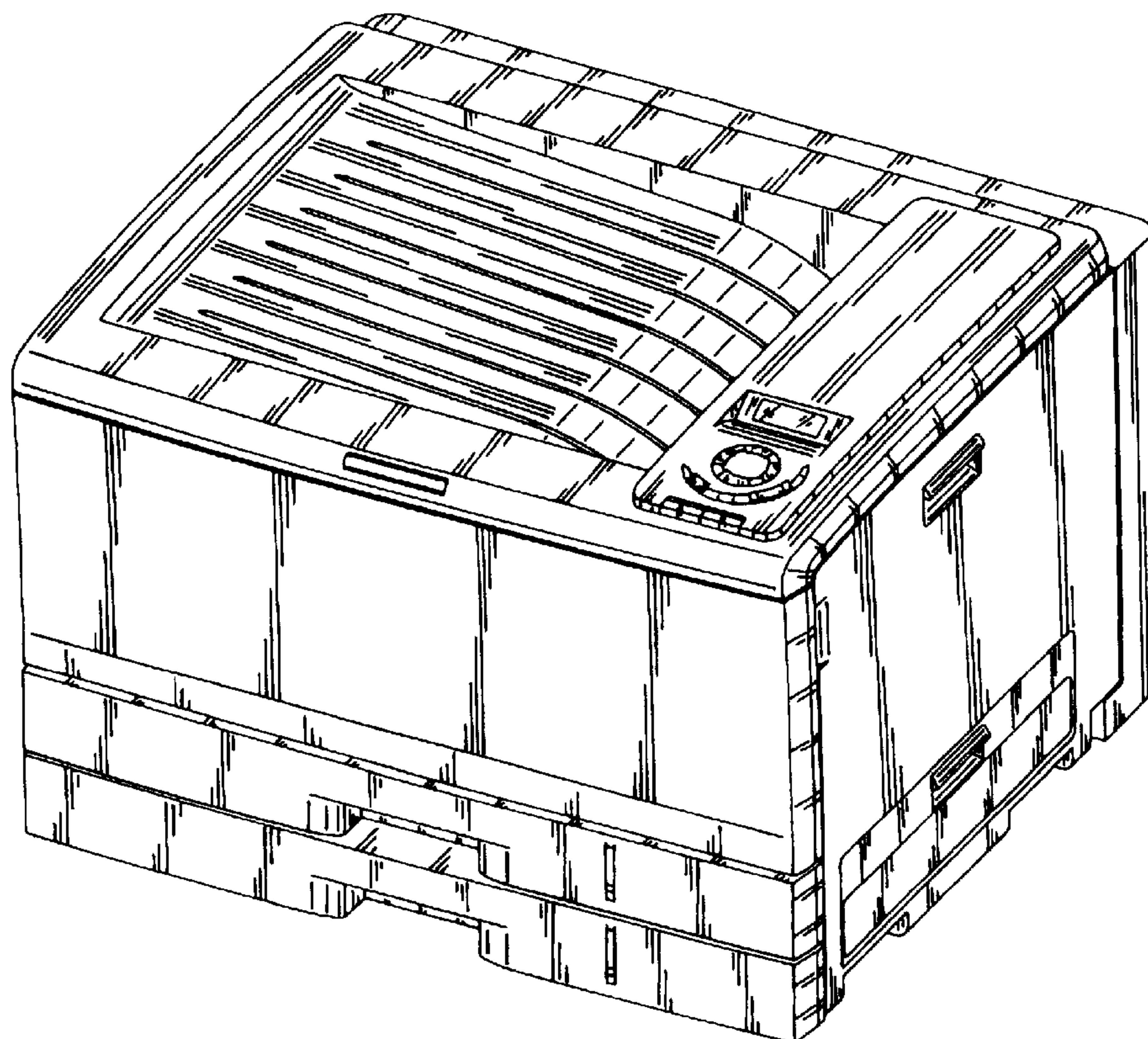
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a reduced scale front, right side, top perspective
view of a printer showing our new design;
FIG. 2 is a front elevational view thereof;

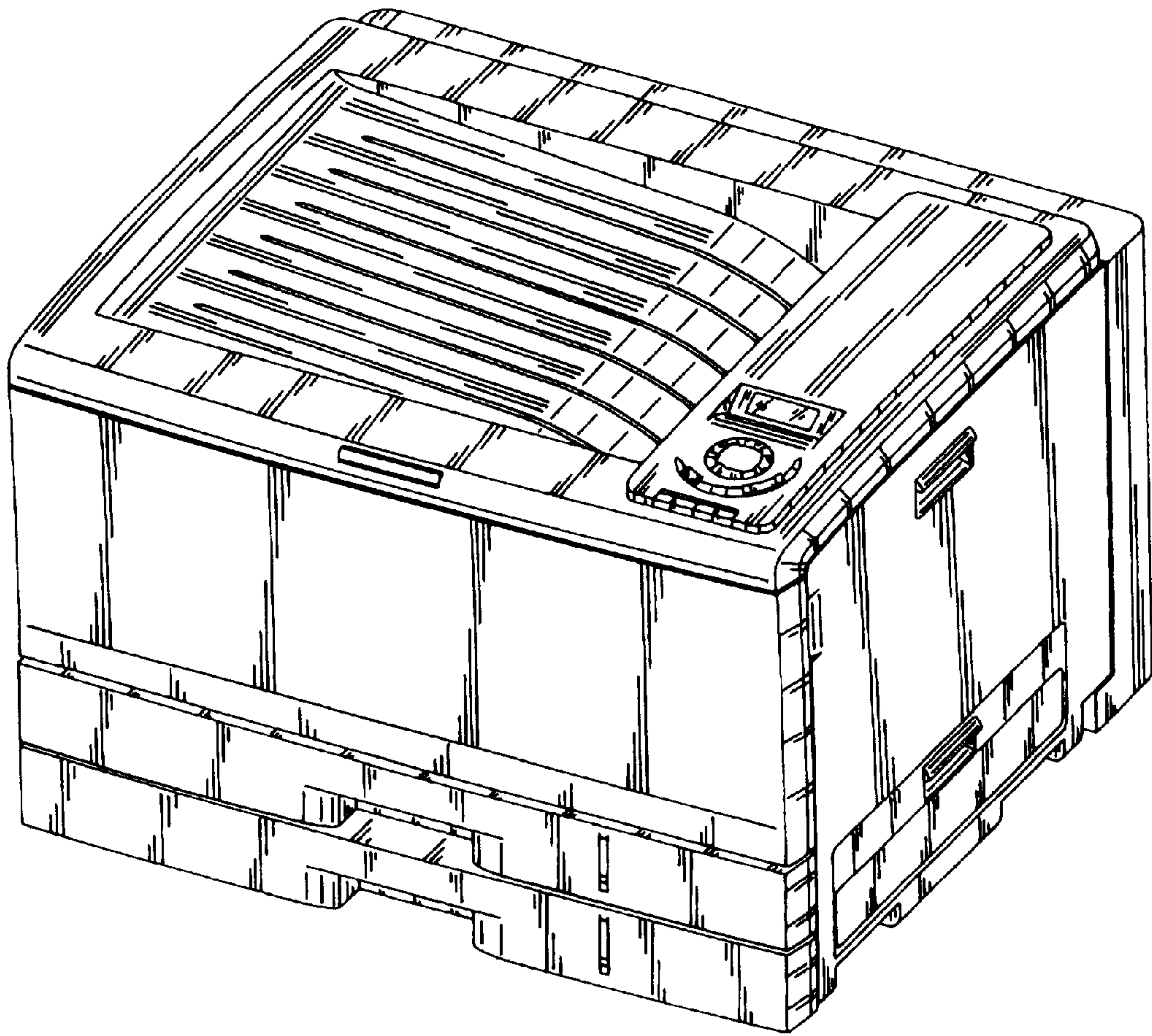

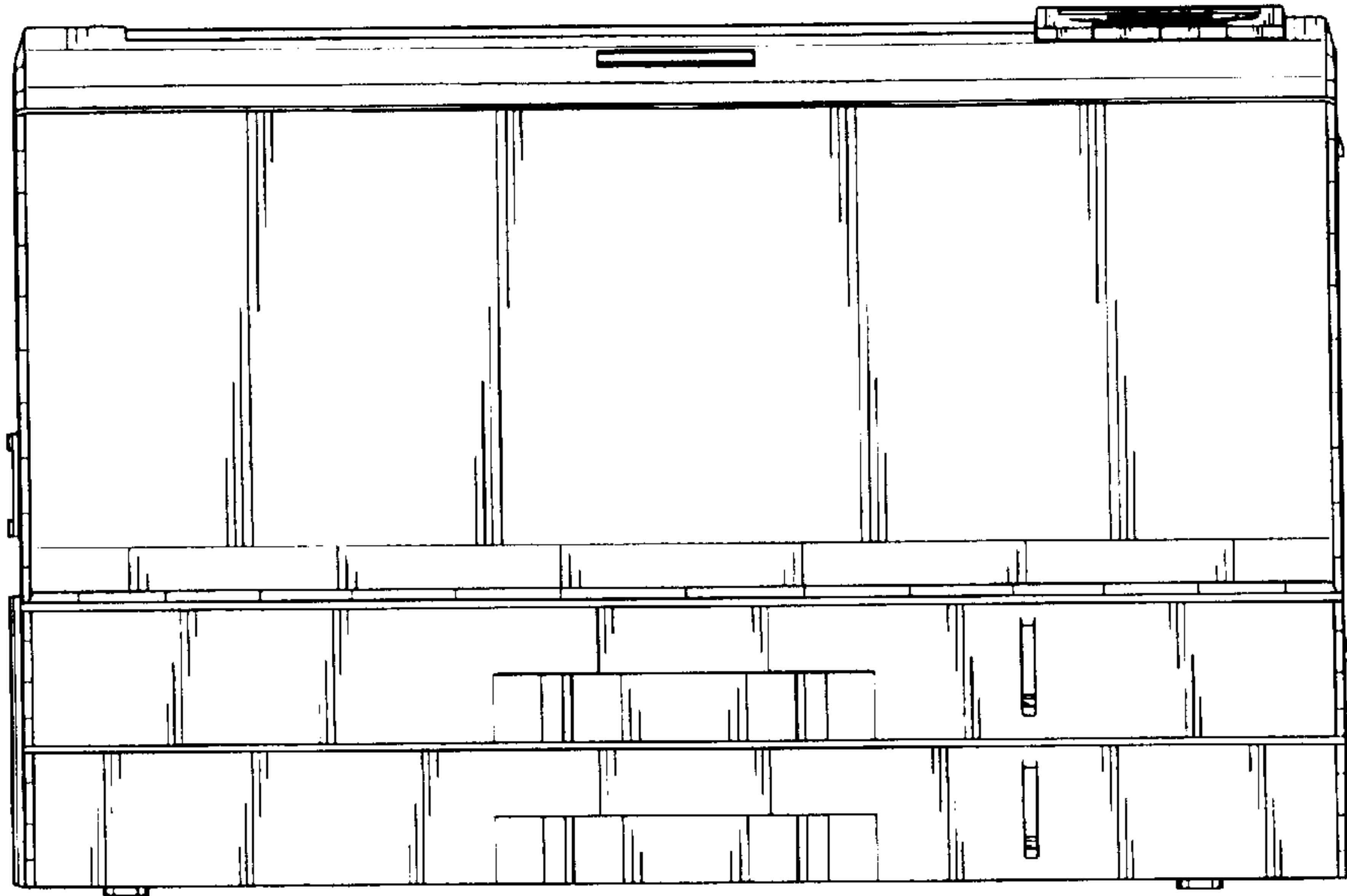

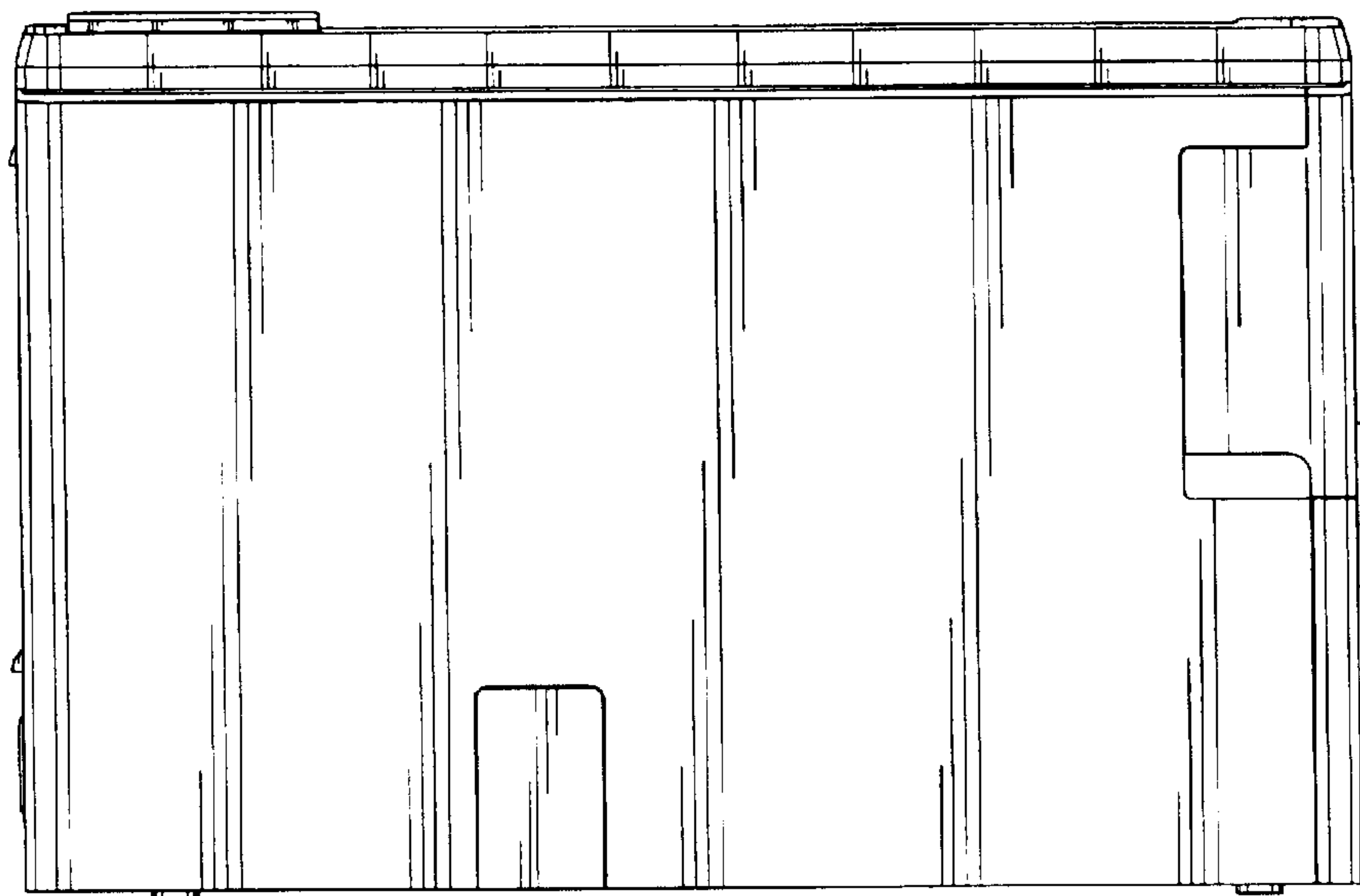

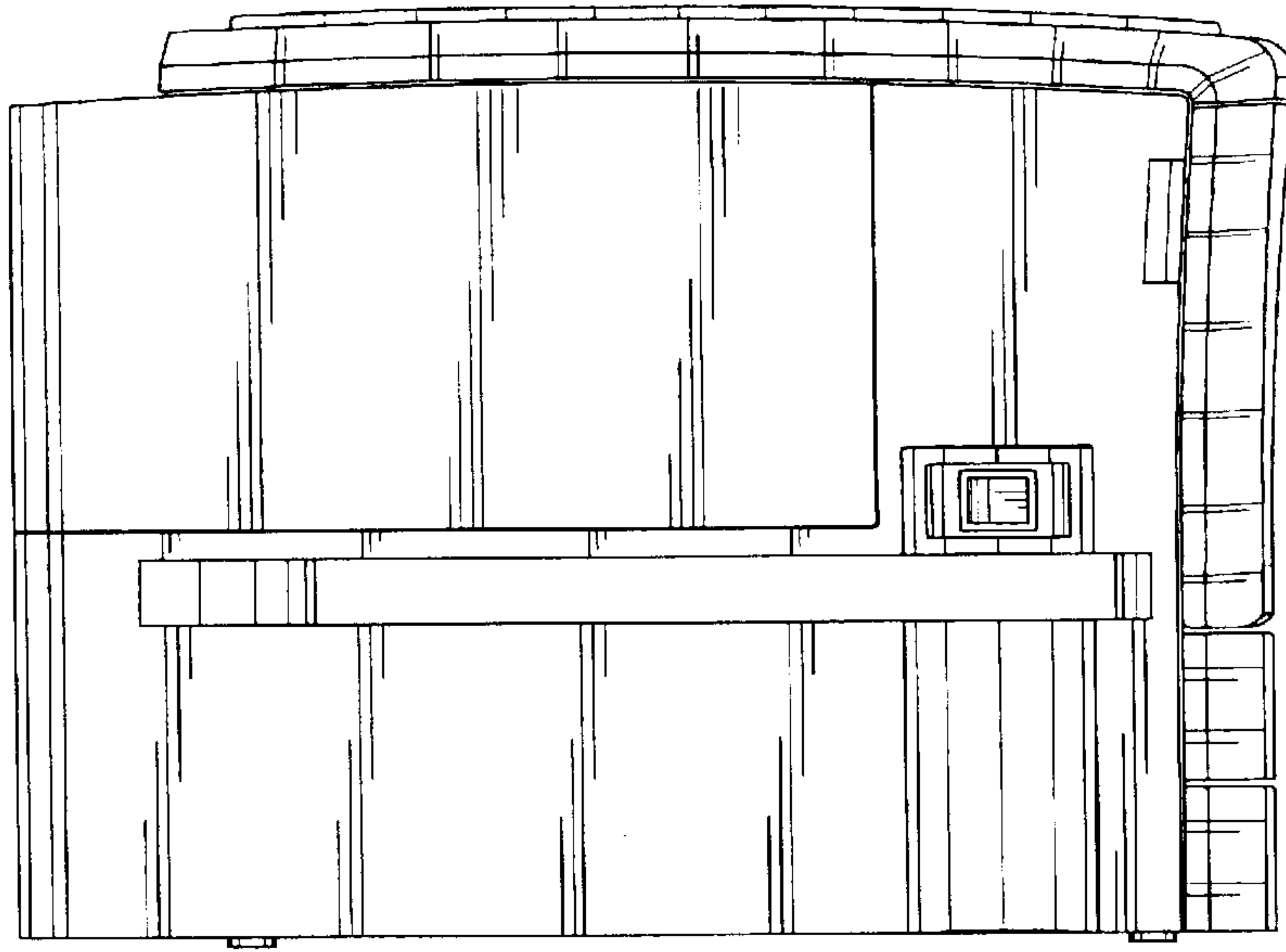

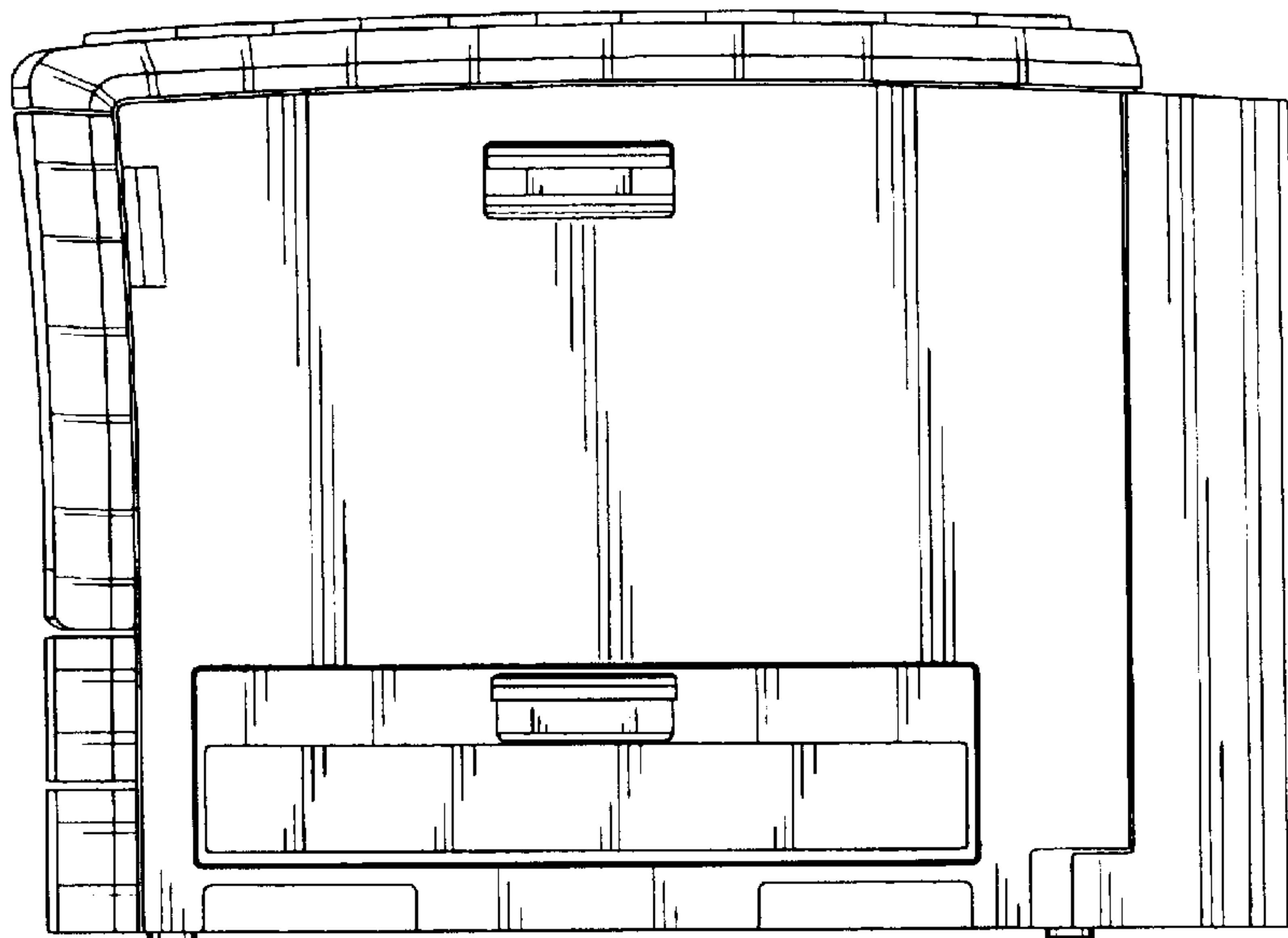

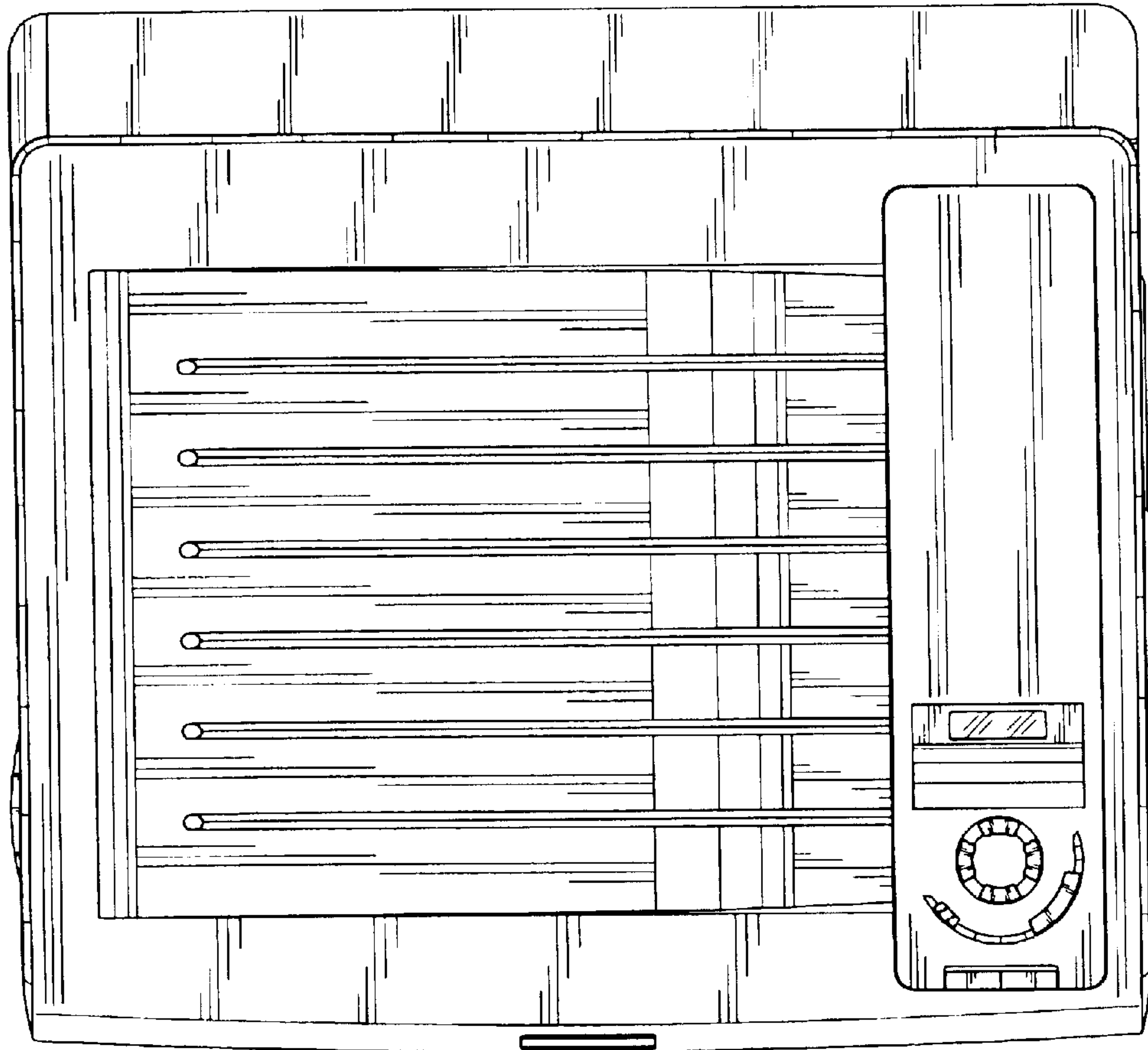

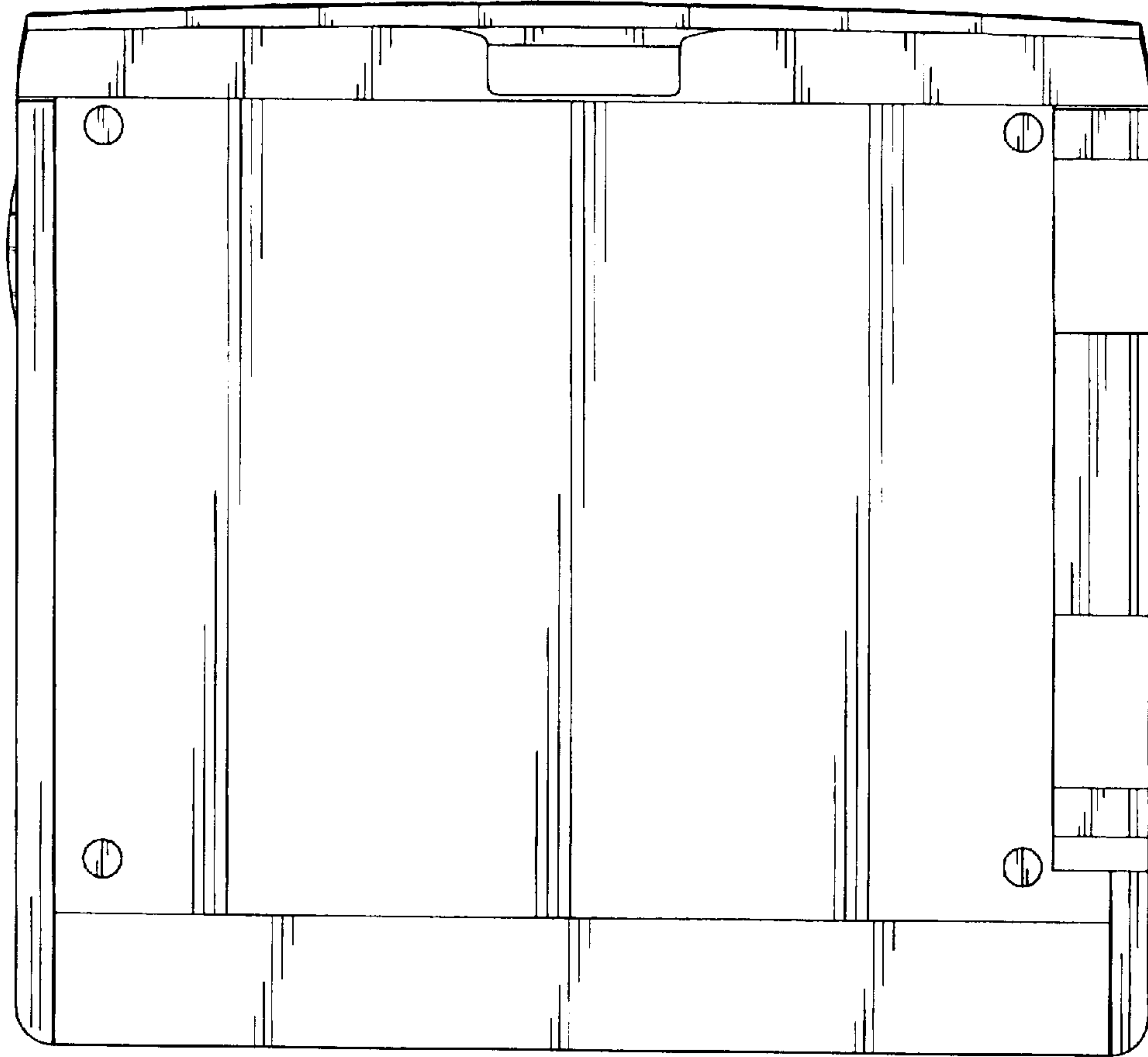
