The ornamental design for a measuring apparatus for an ultrasonic diagnosis apparatus, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top and right side perspective view of a measuring apparatus for an ultrasonic diagnosis apparatus, showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a right side elevational view thereof; and,

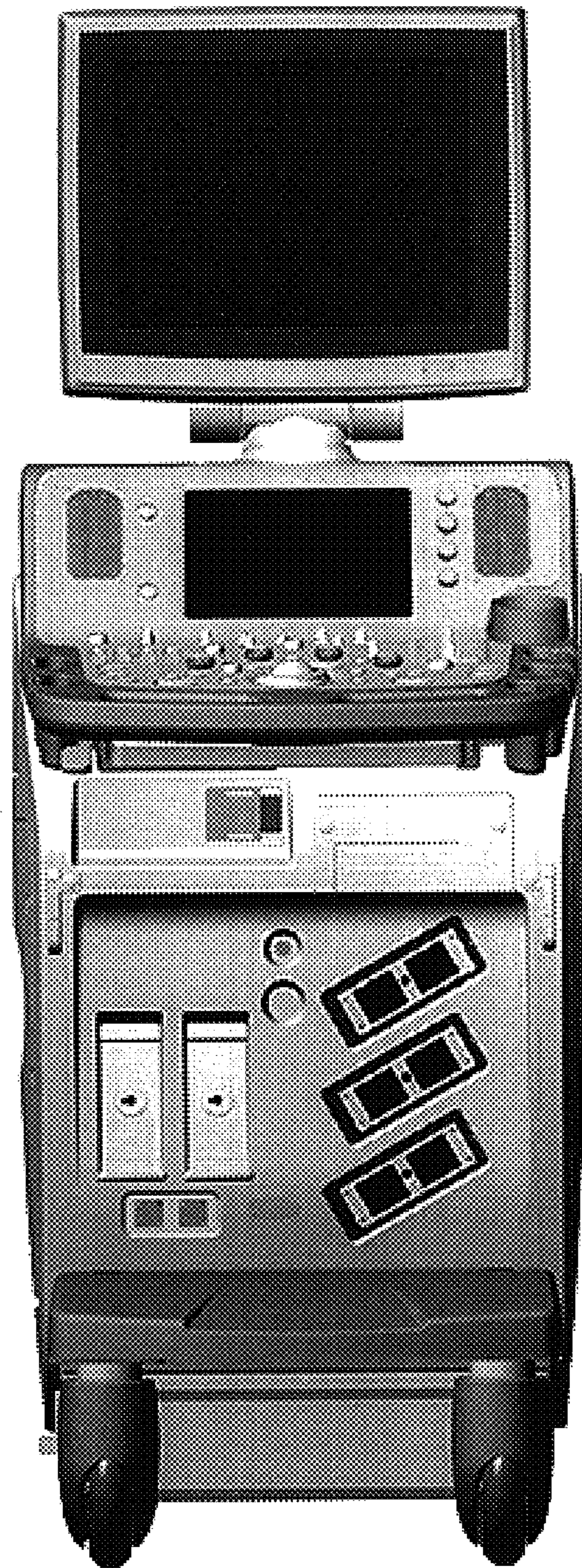

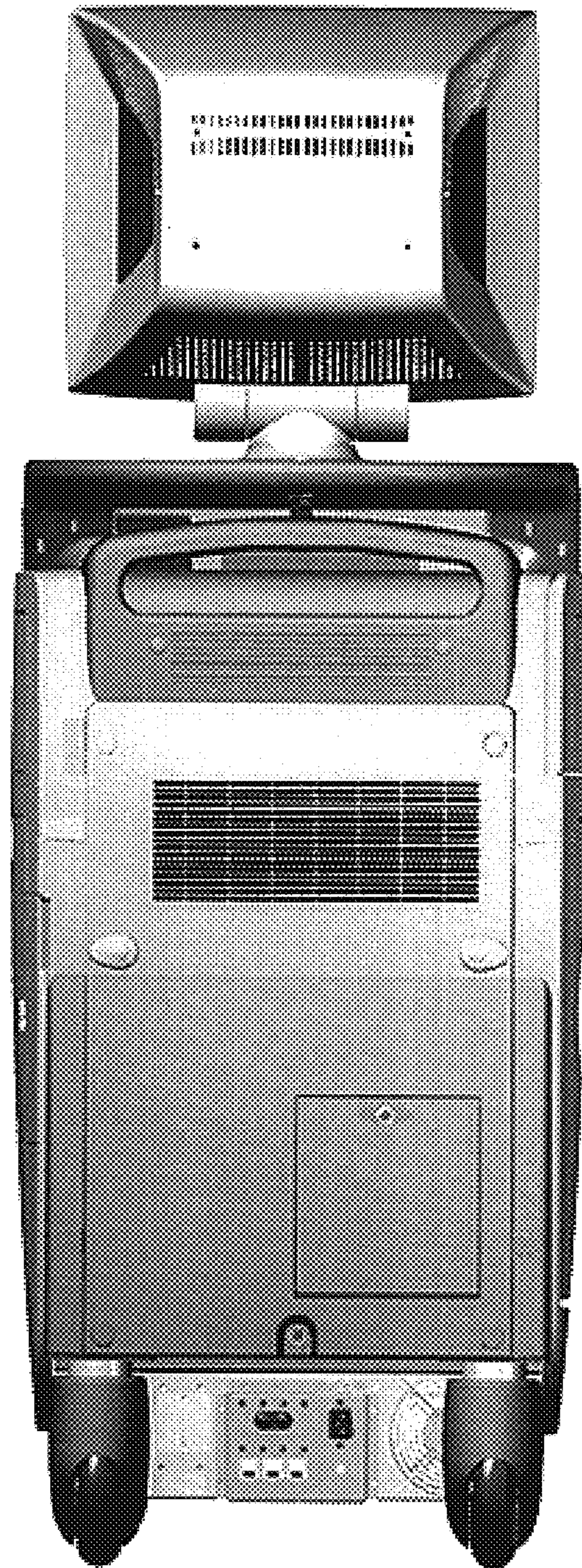

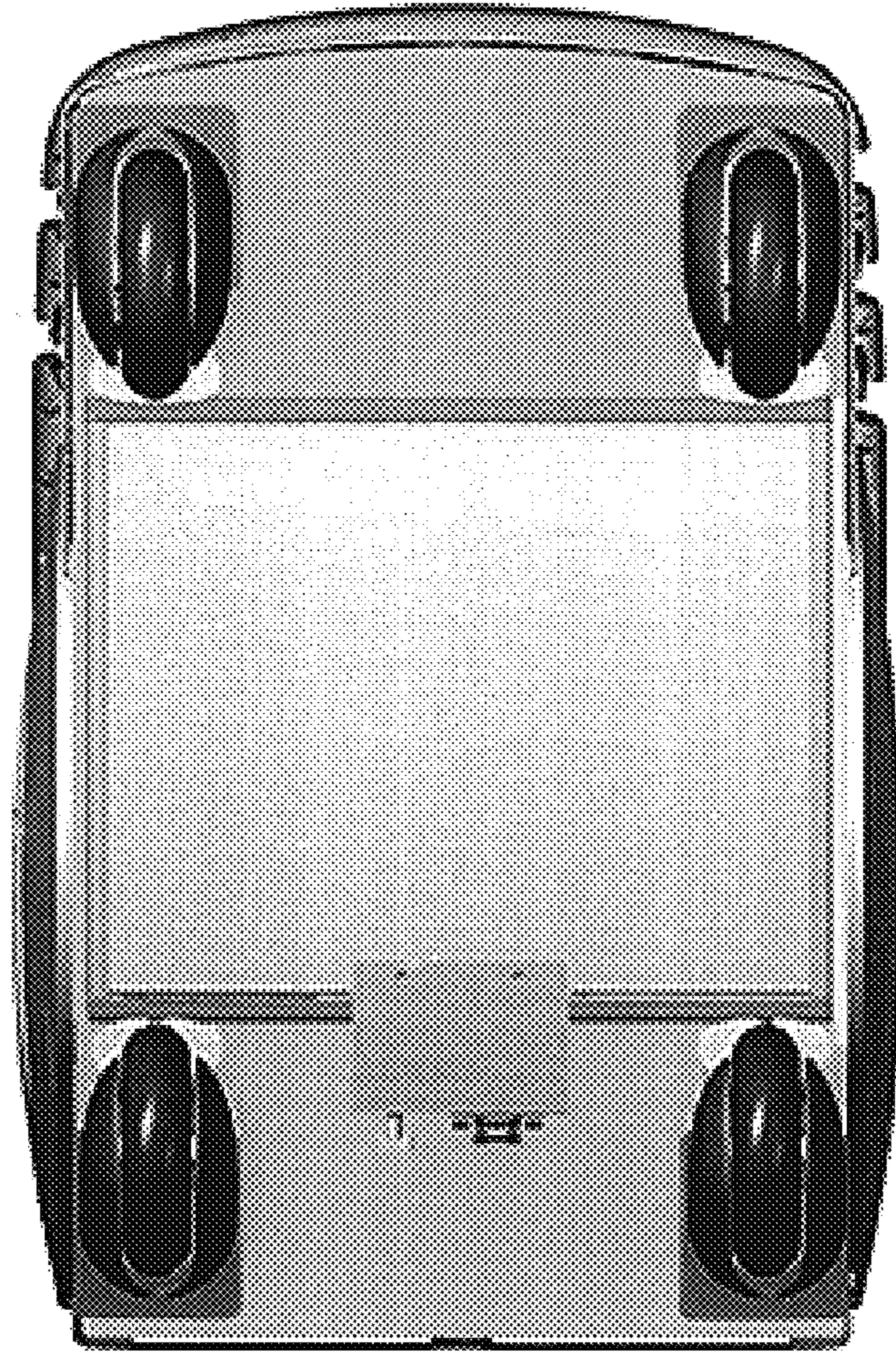

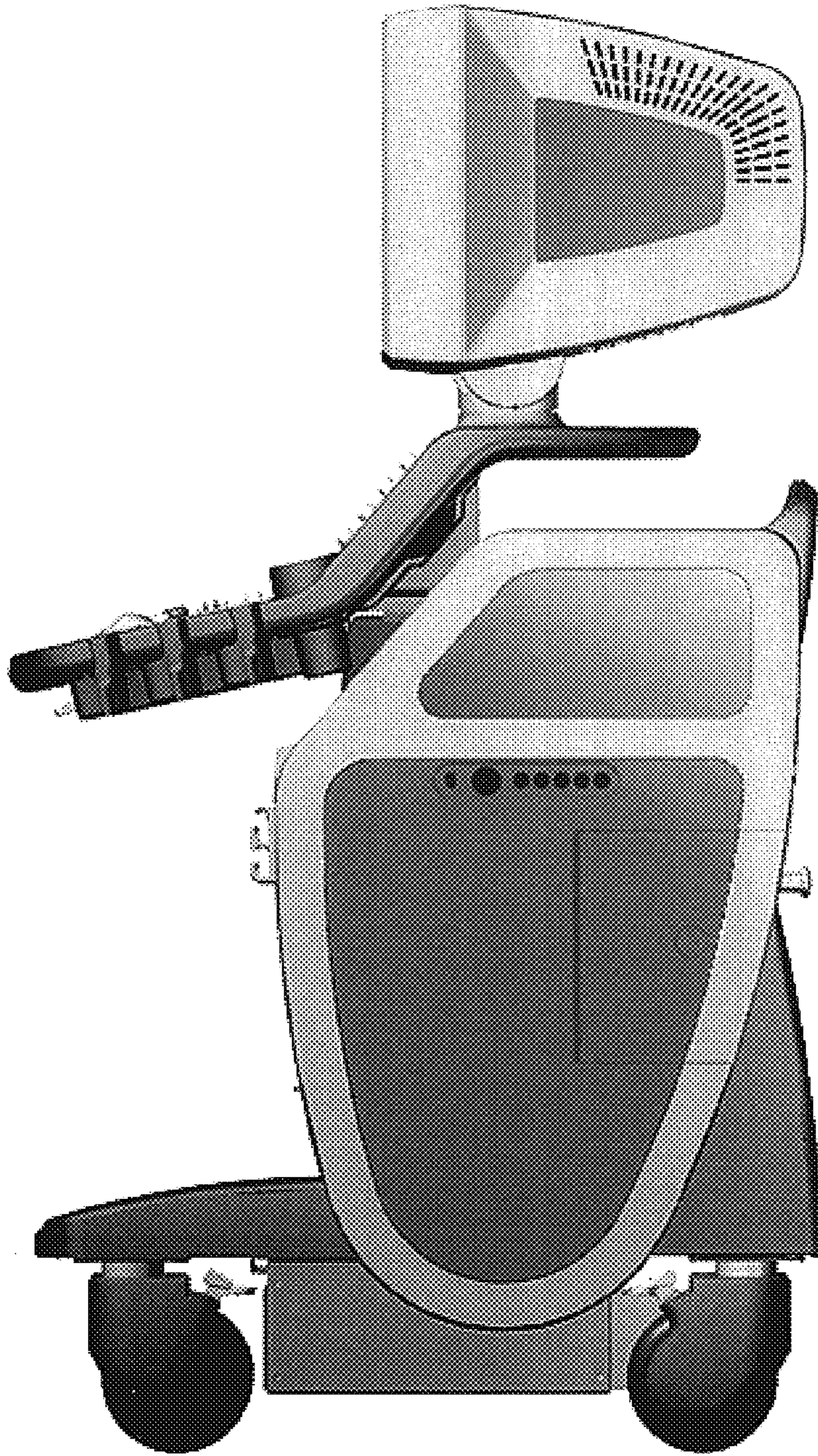

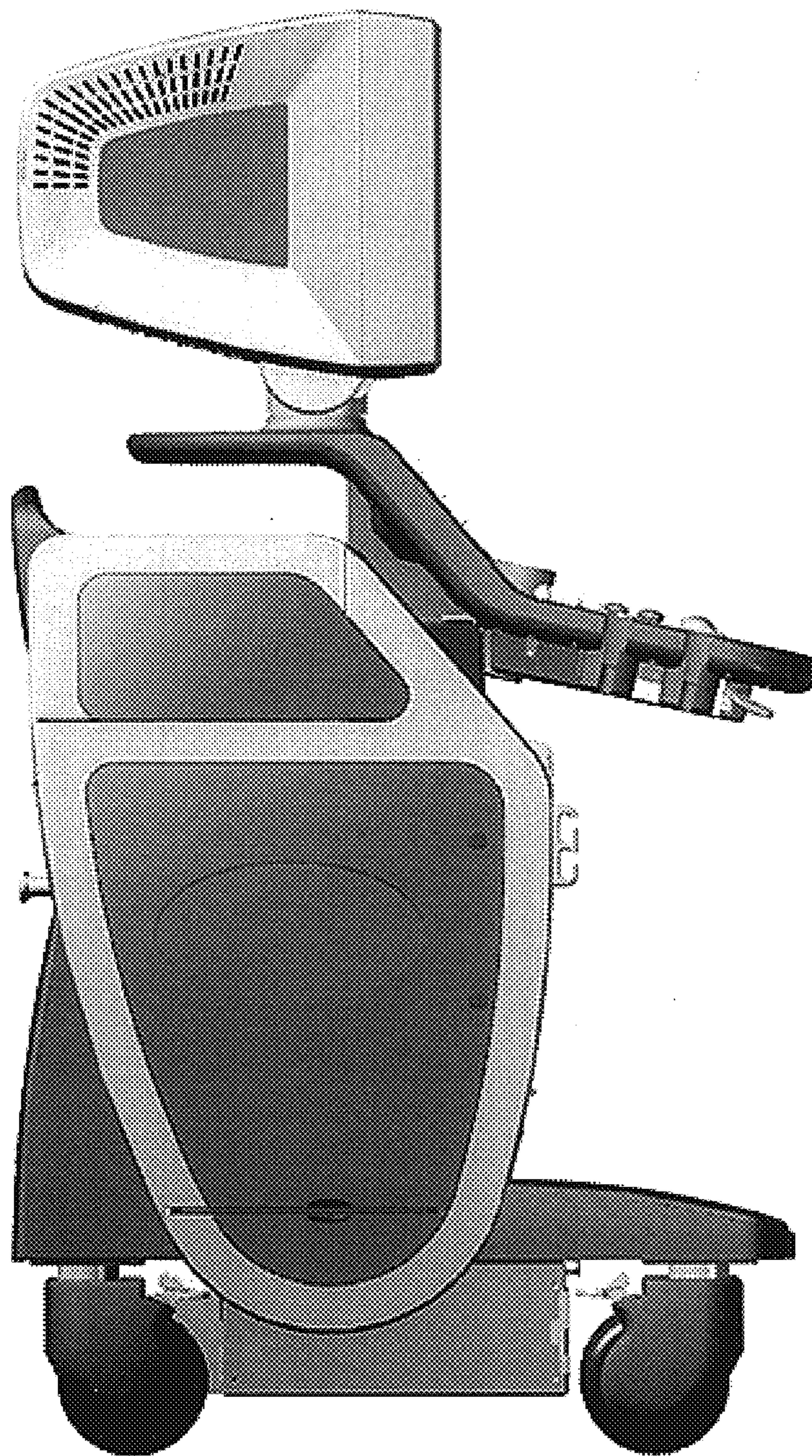
