(57) **CLAIM**

The ornamental design for a lighter, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a preferred embodiment of the lighter according to the present design;

FIG. 2 is a front perspective view of the lighter of FIG. 1, illustrating a cap of the lighter in an open configuration;

FIG. 3 is a right-side elevational view of the lighter of FIG. 1;

FIG. 4 is a left-side elevational view of the lighter of FIG. 1;

FIG. 5 is a front elevational view of the lighter of FIG. 1;

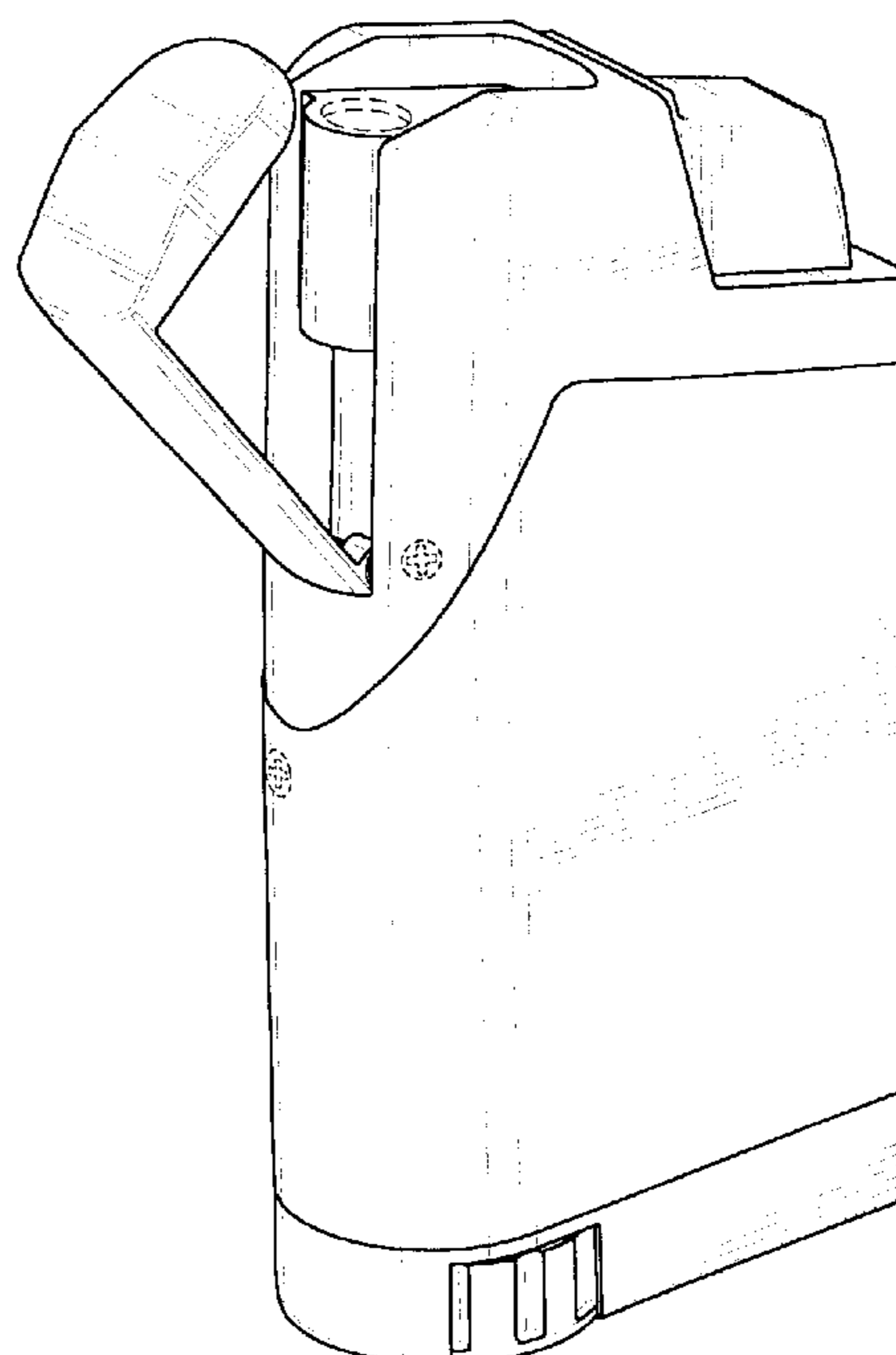
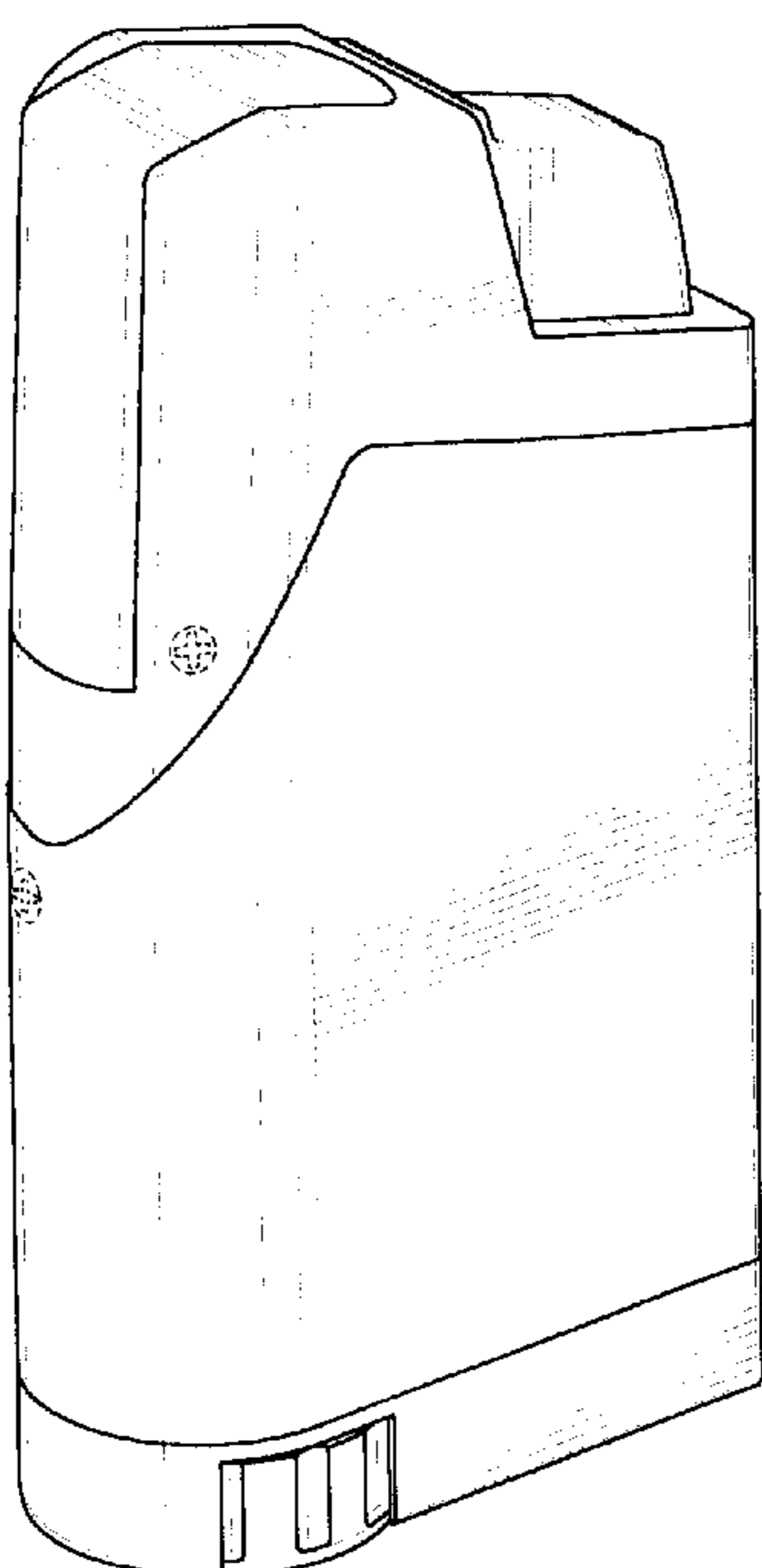
FIG. 6 is a rear elevational view of the lighter of FIG. 1;

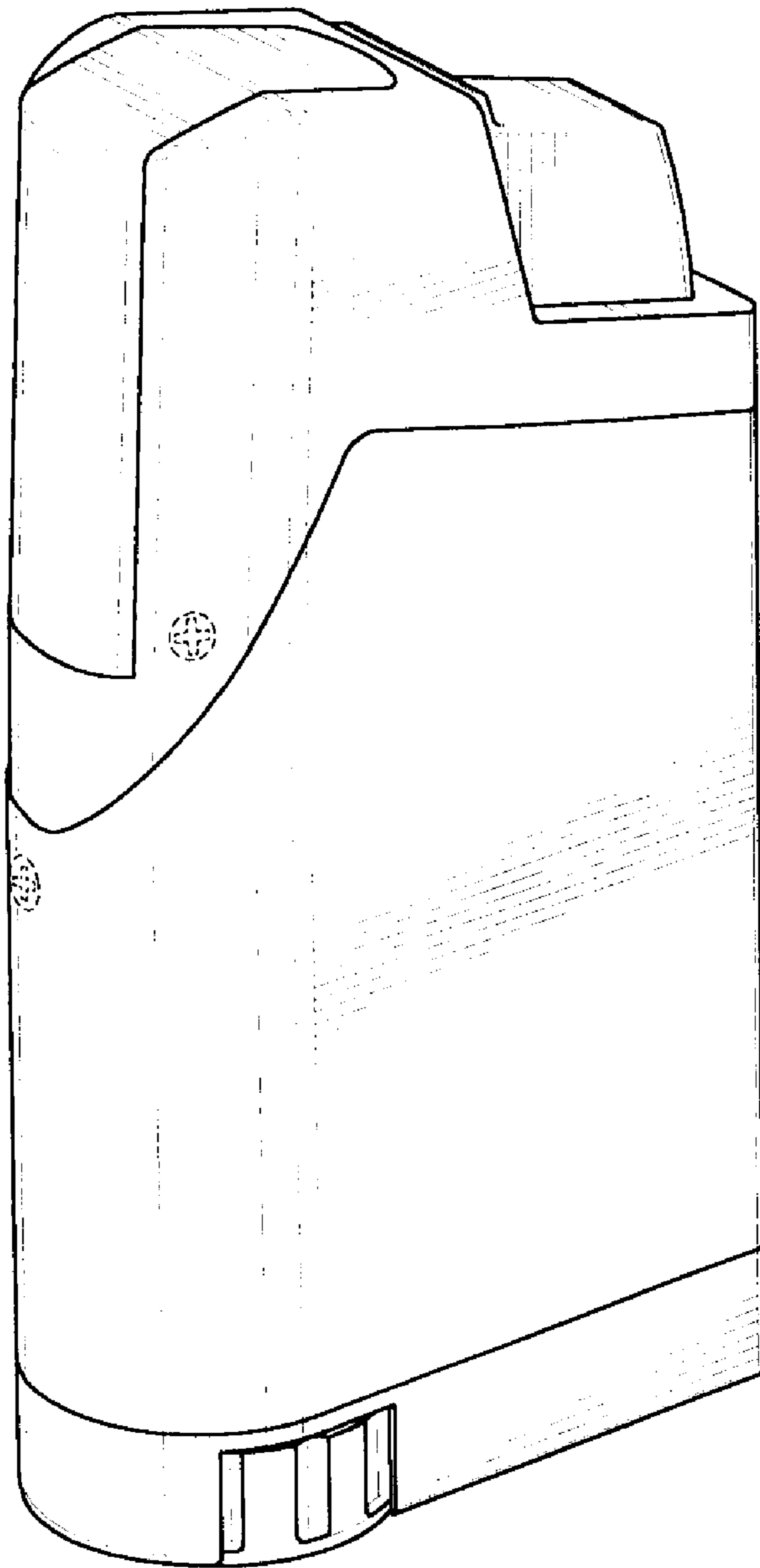

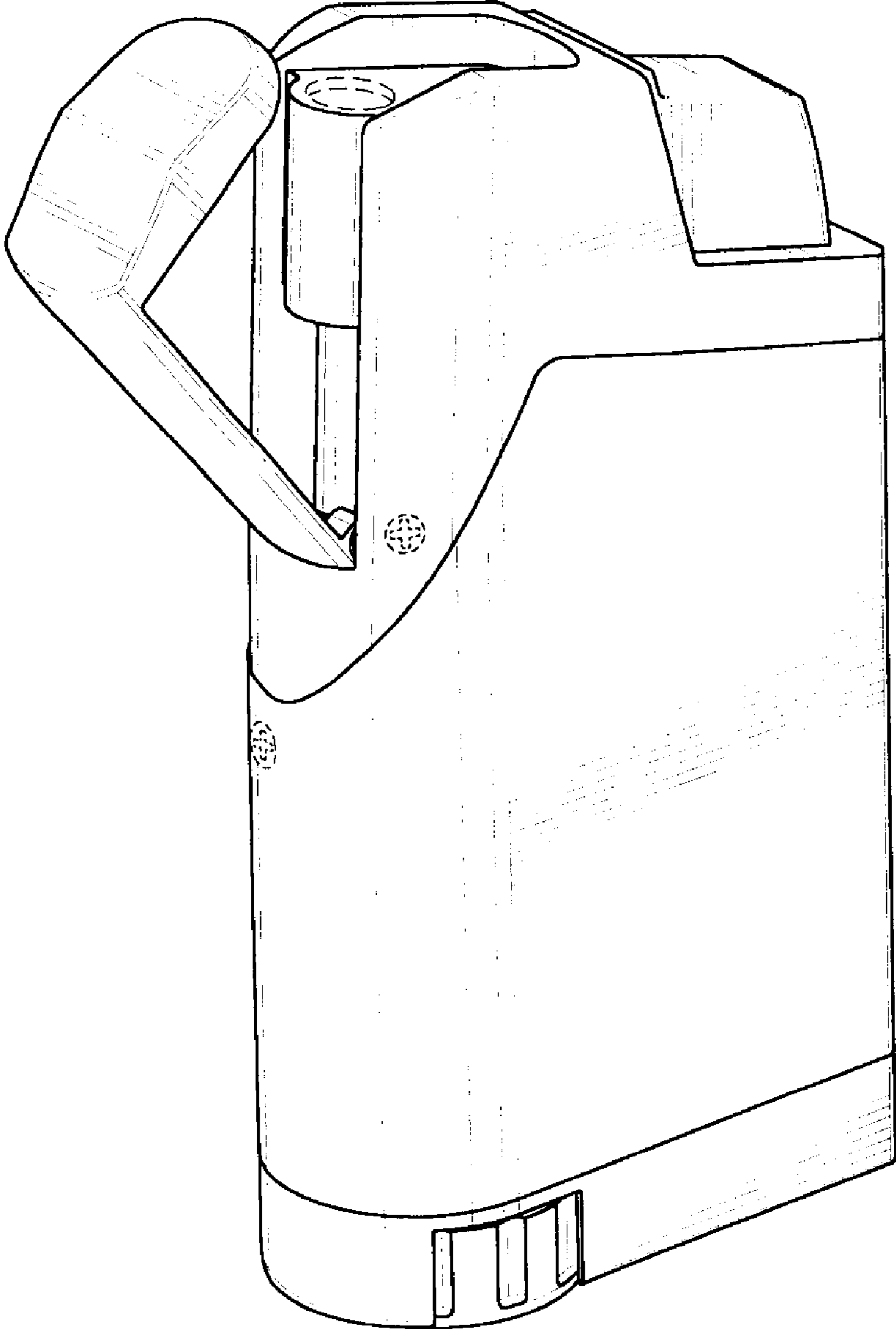

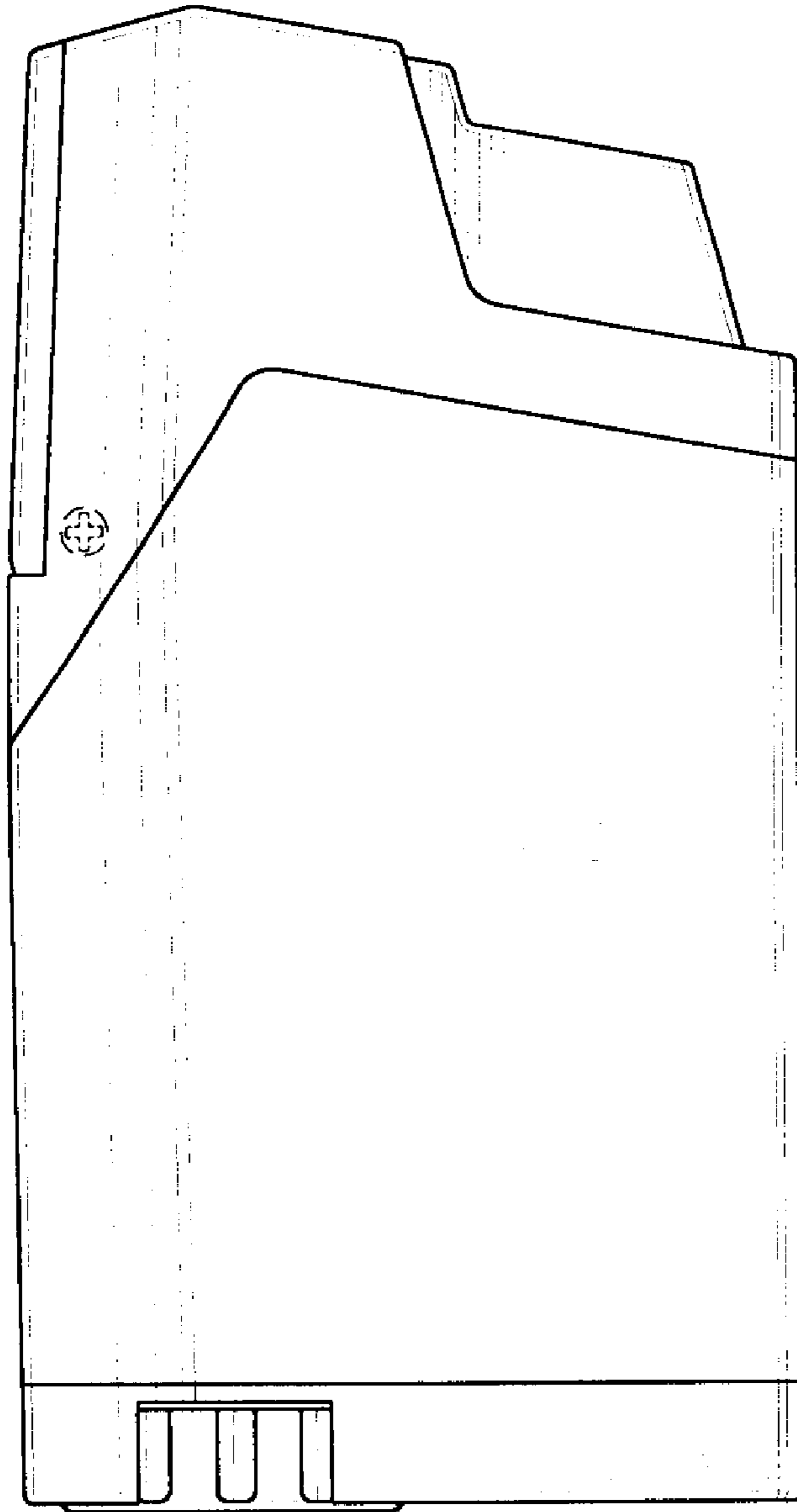

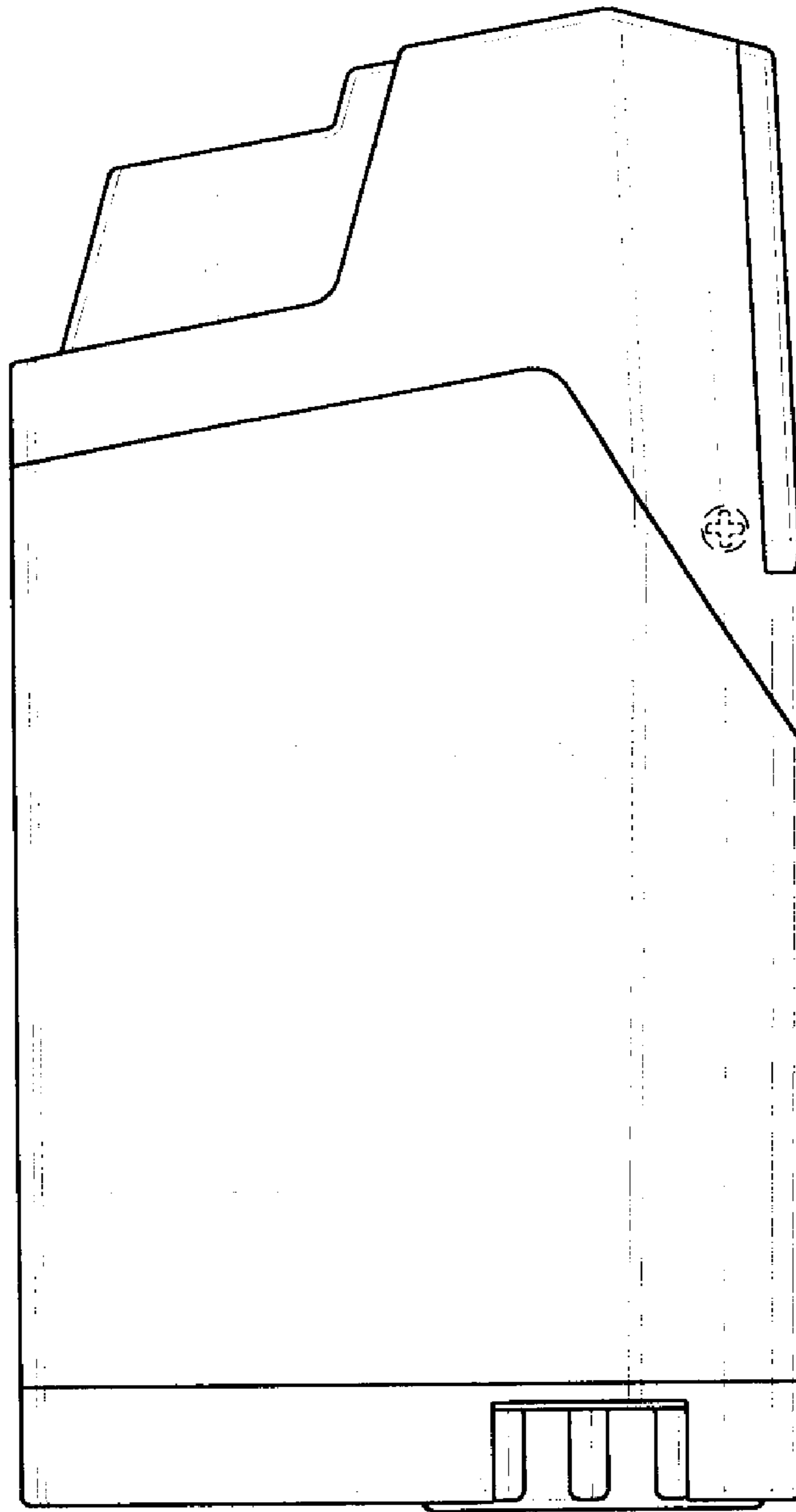
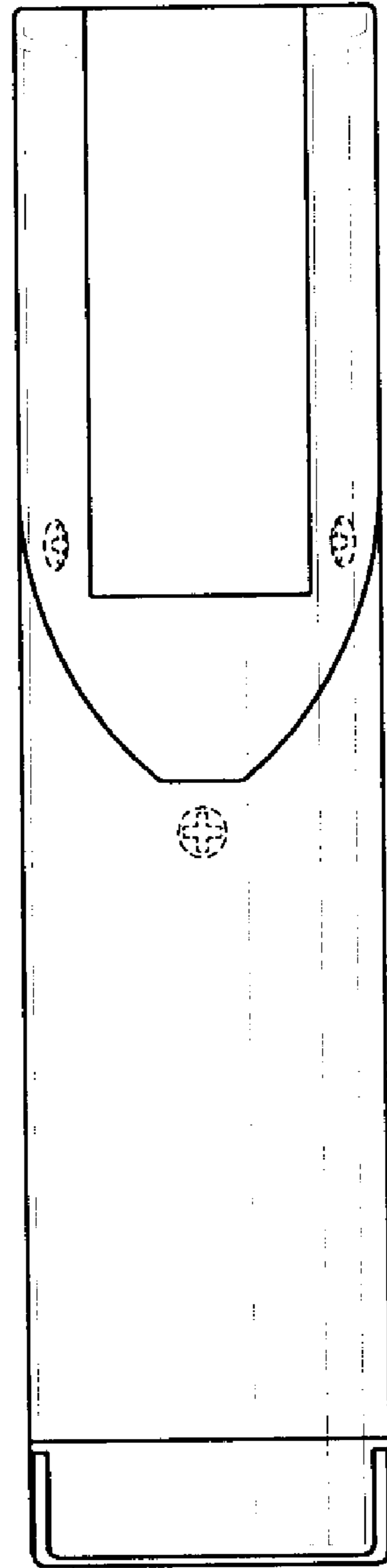
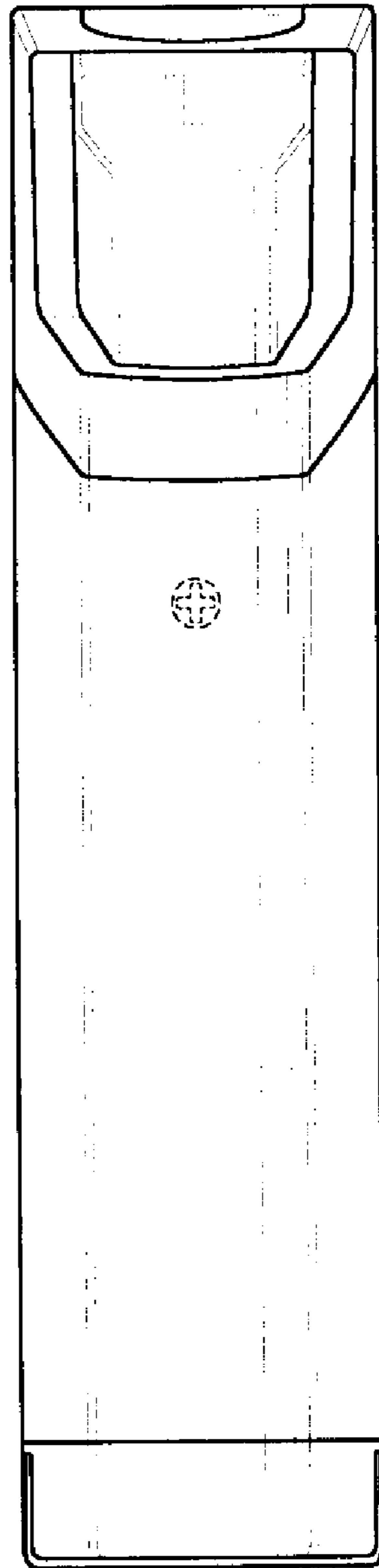

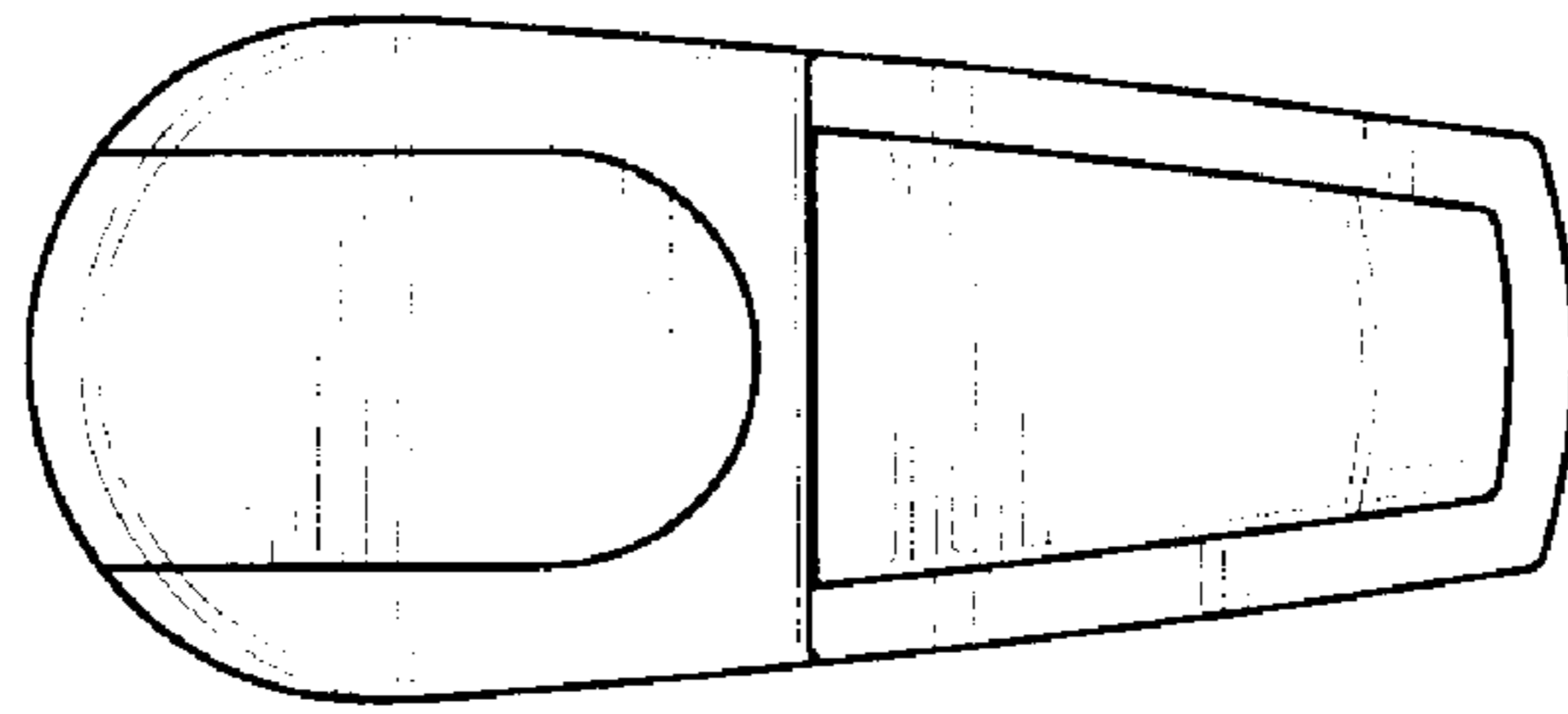

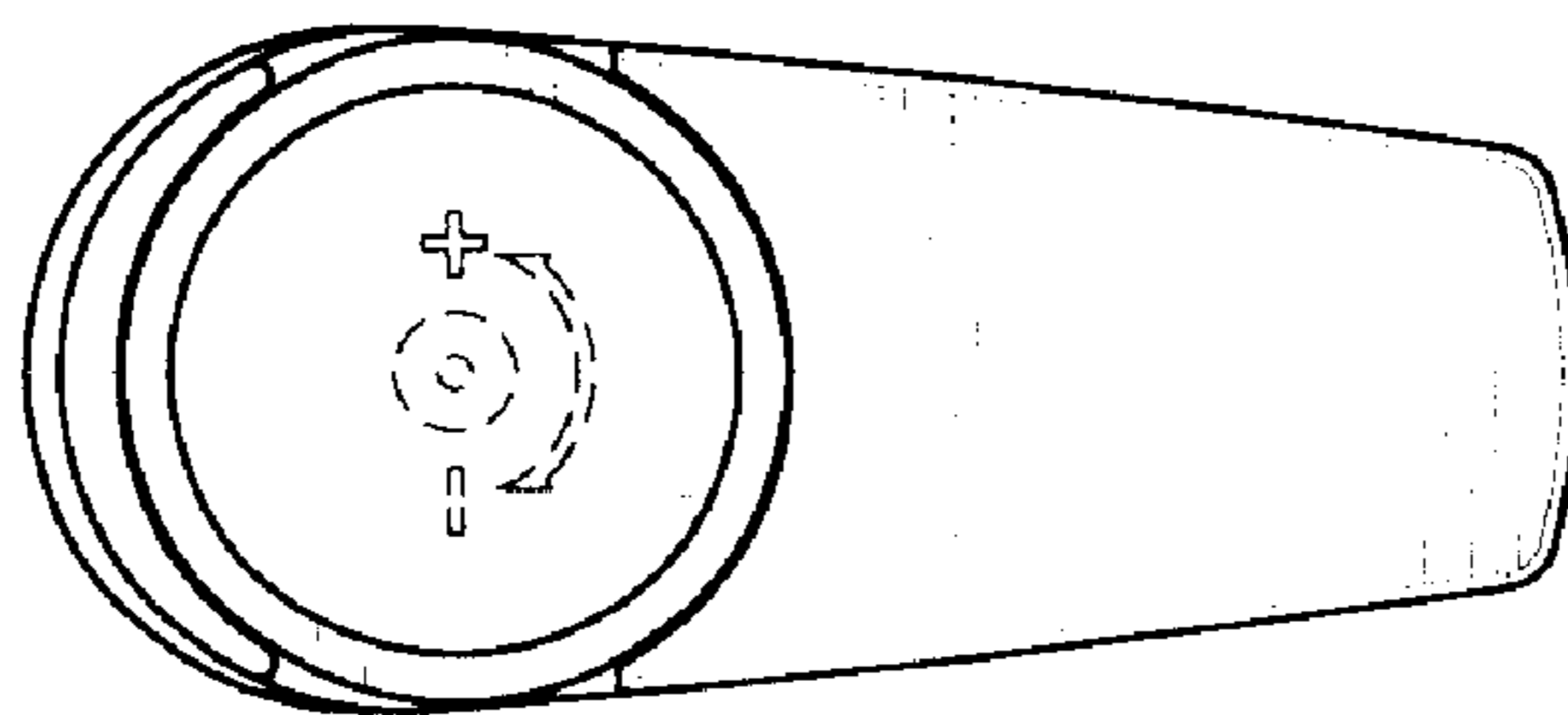
