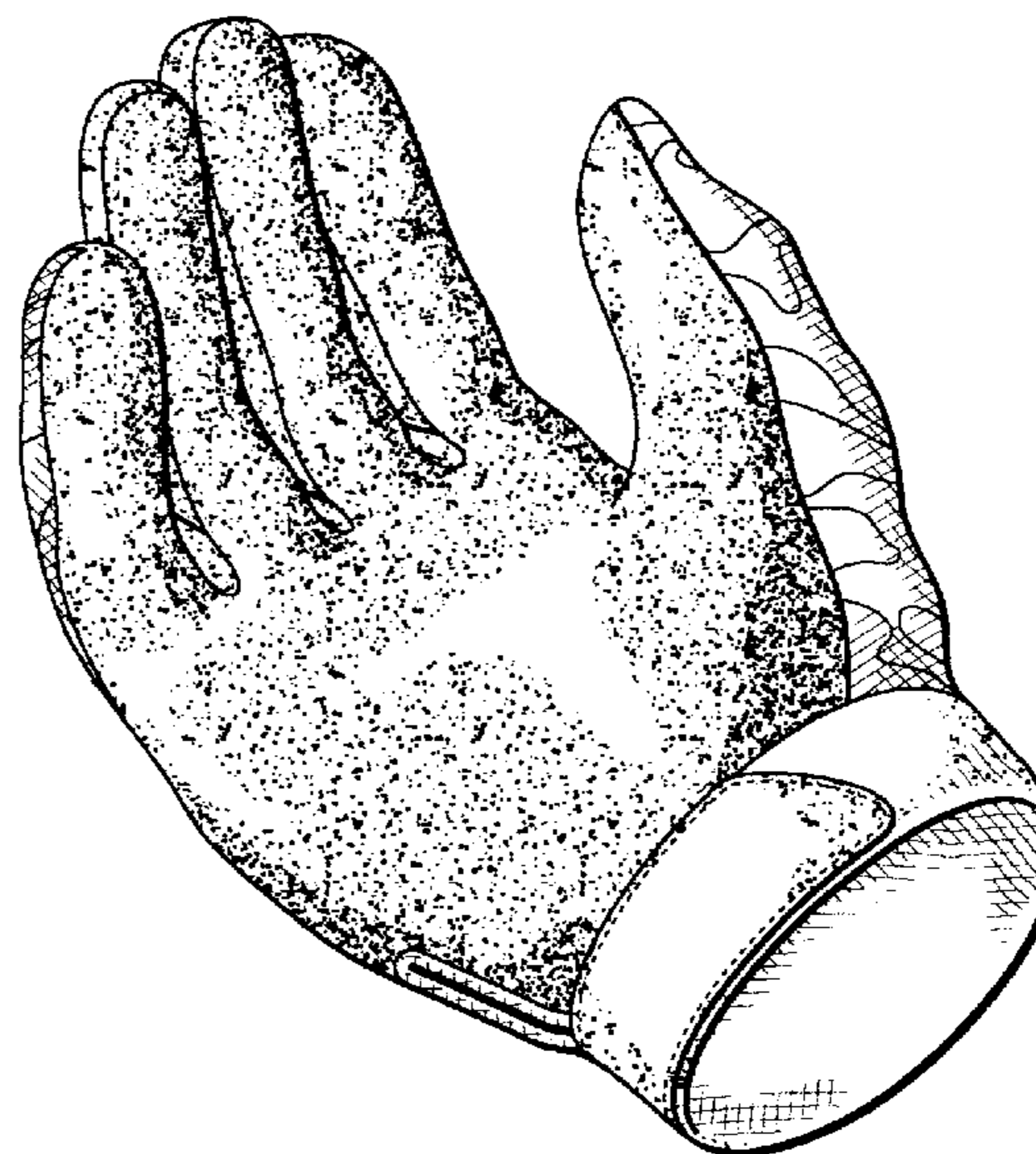
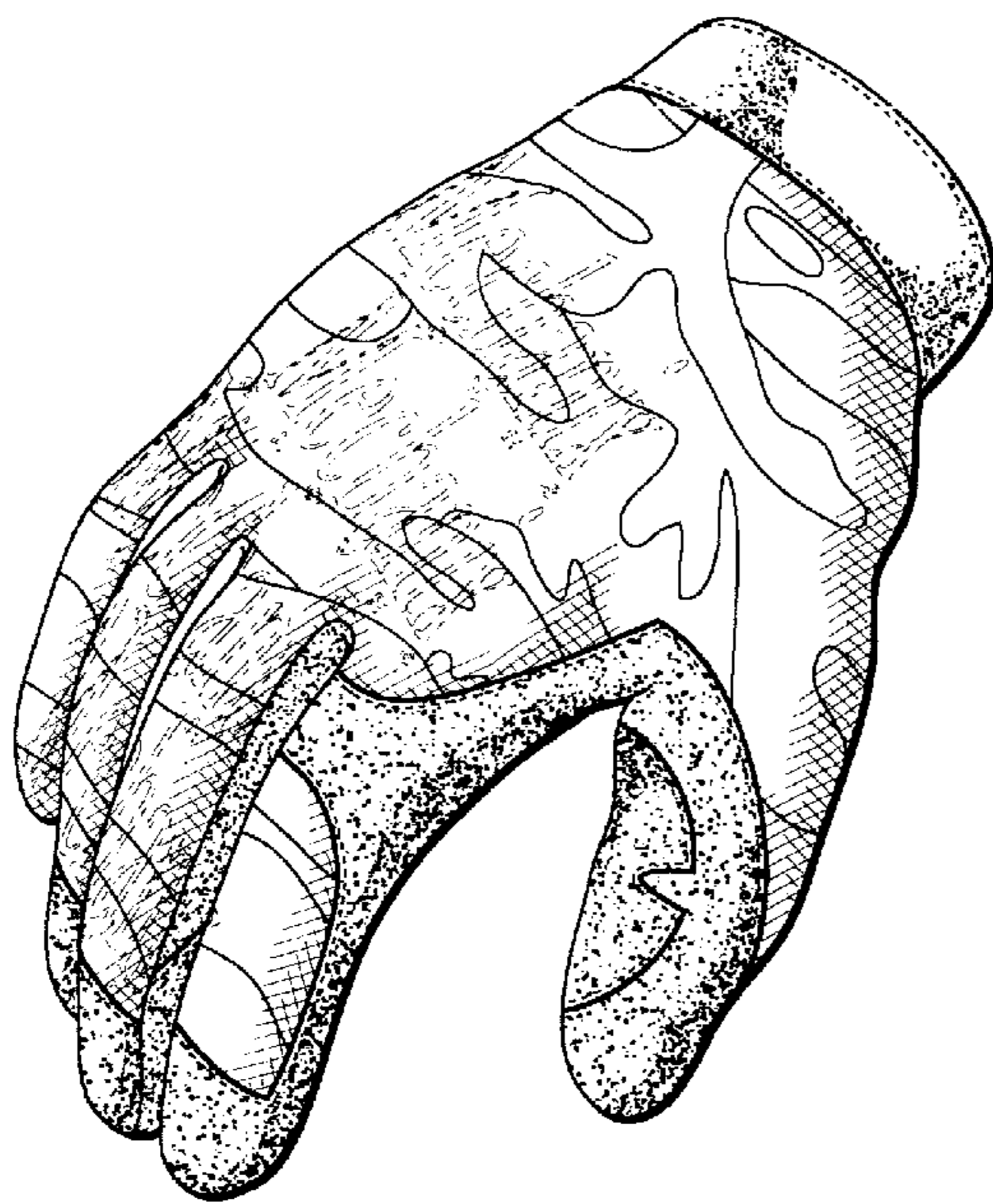
FIG. 1 is a perspective view of one embodiment of a glove showing our new design;

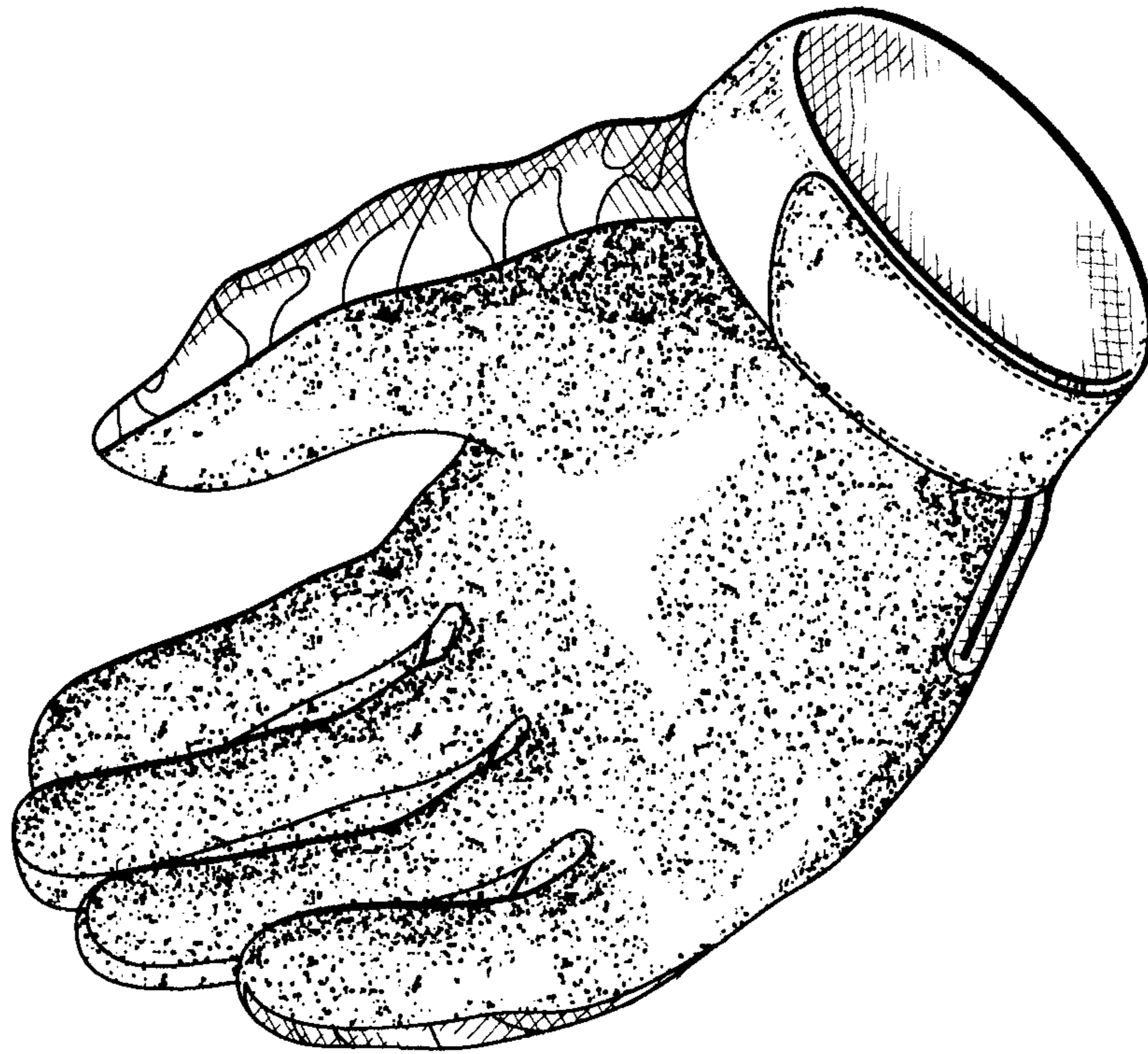

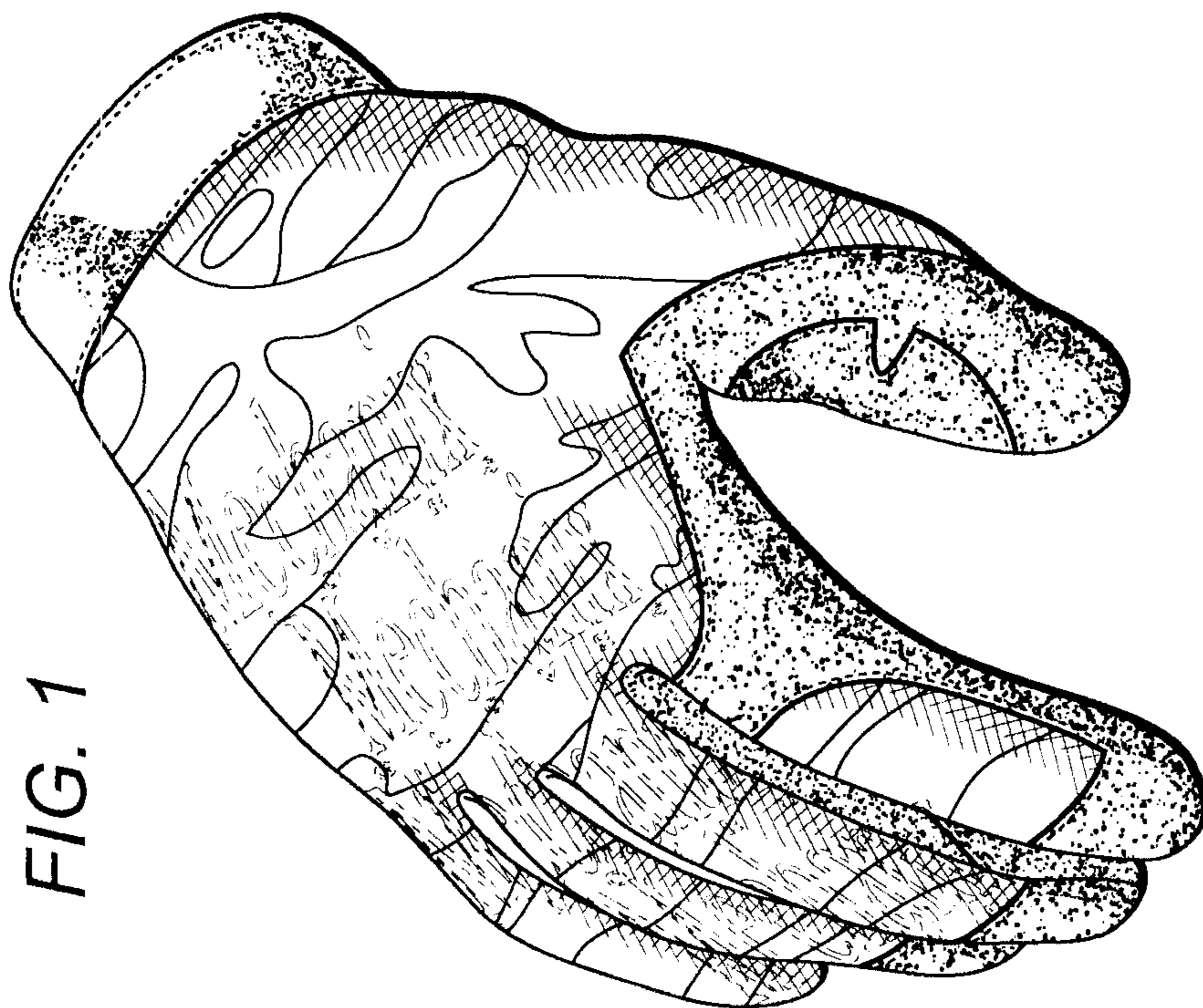

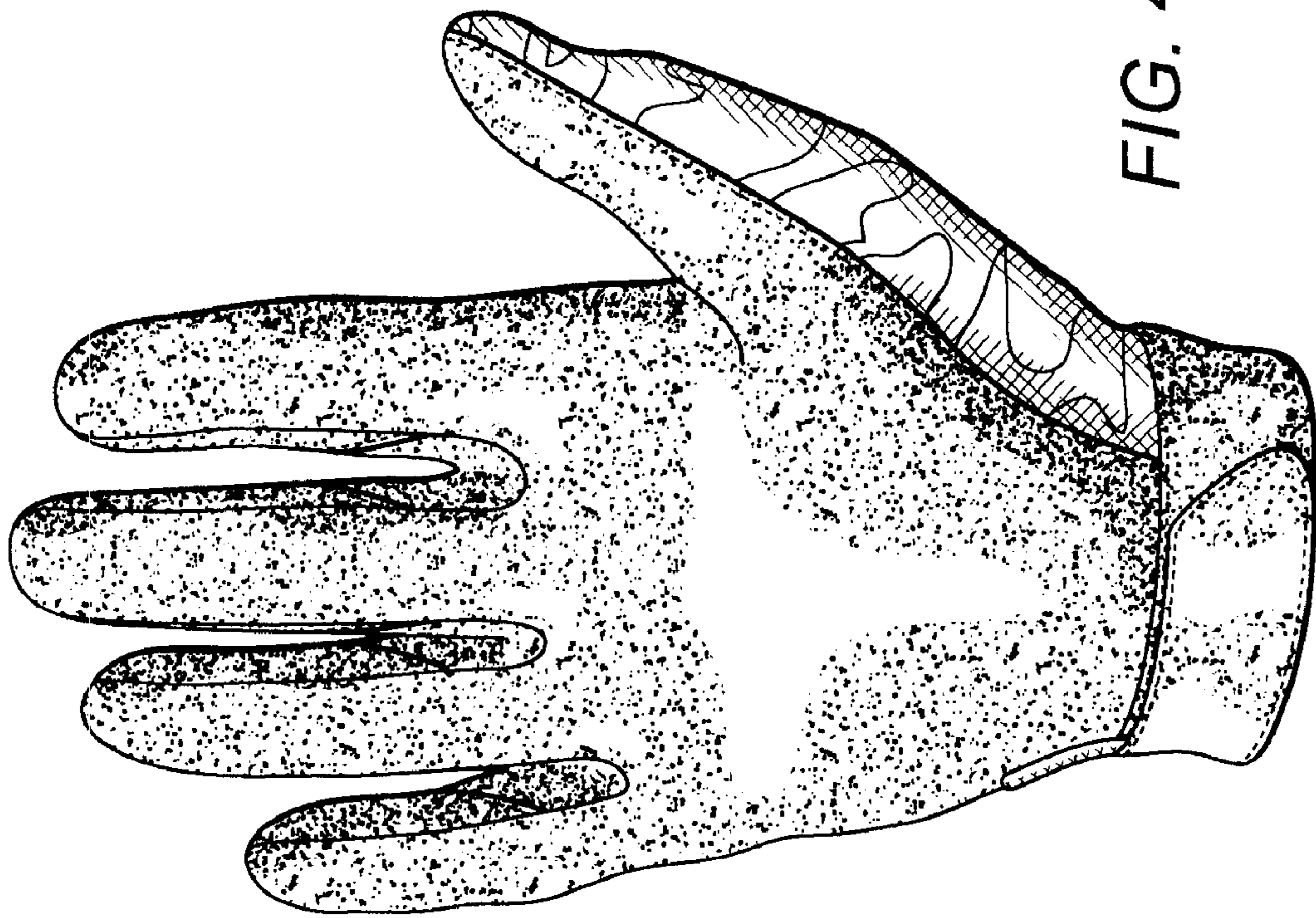

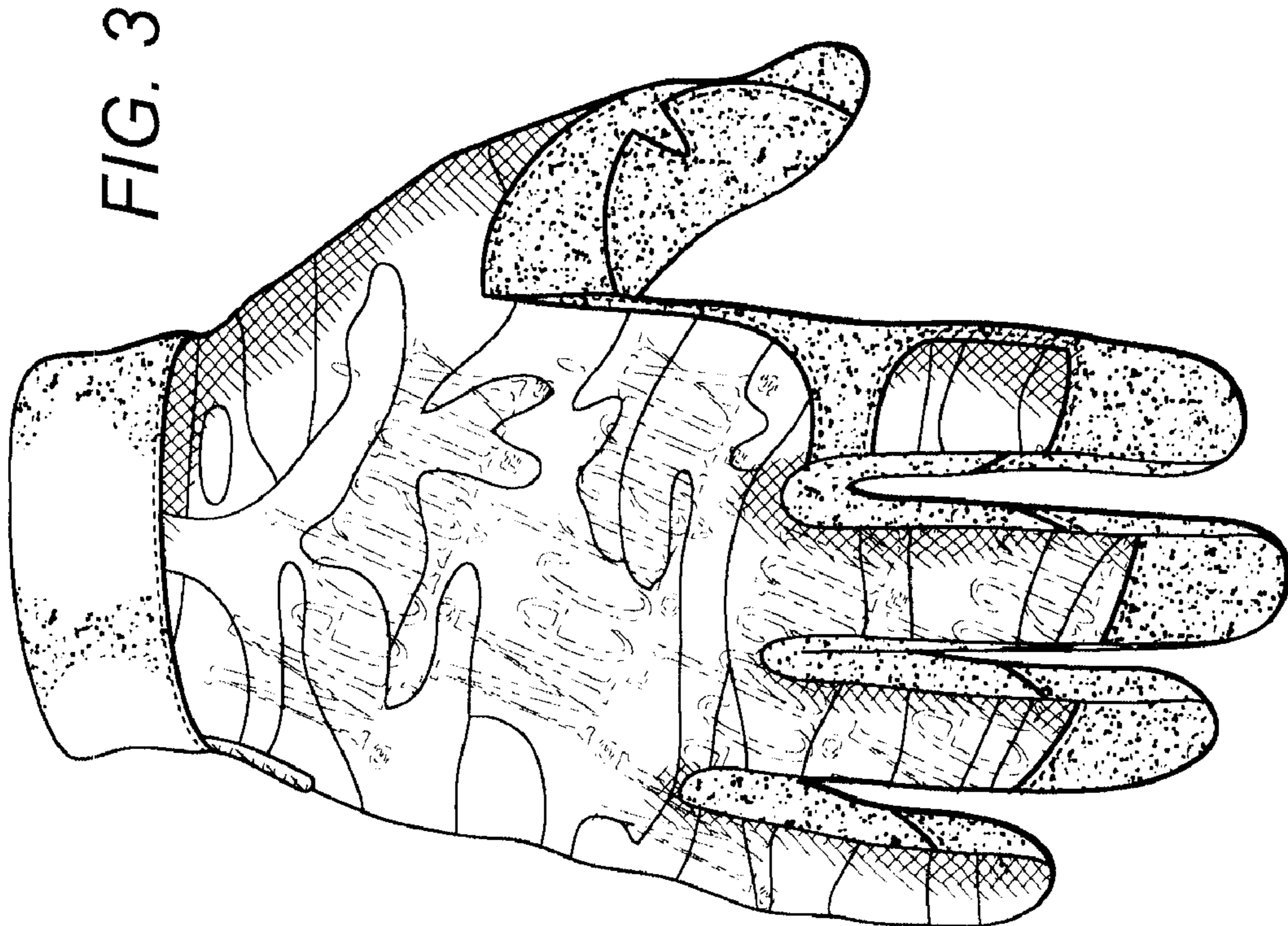
