(57) **CLAIM**

The ornamental design for a cosmetic brush with holding tube, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a cosmetic brush with holding tube showing is new design;

FIG. 2 is a partially exploded, top perspective view thereof;

FIG. 3 is a front elevation view of the brush shown separately for clarity of illustration;

FIG. 4 is an exploded view of FIG. 3;

FIG. 5 is a left side elevation view of FIG. 3, the right side being a mirror image;

FIG. 6 is a perspective view of FIG. 3;

FIG. 7 is an exploded perspective view of FIG. 3;

FIG. 8 is a front elevation view of the holding tube, shown separately for clarity of illustration;

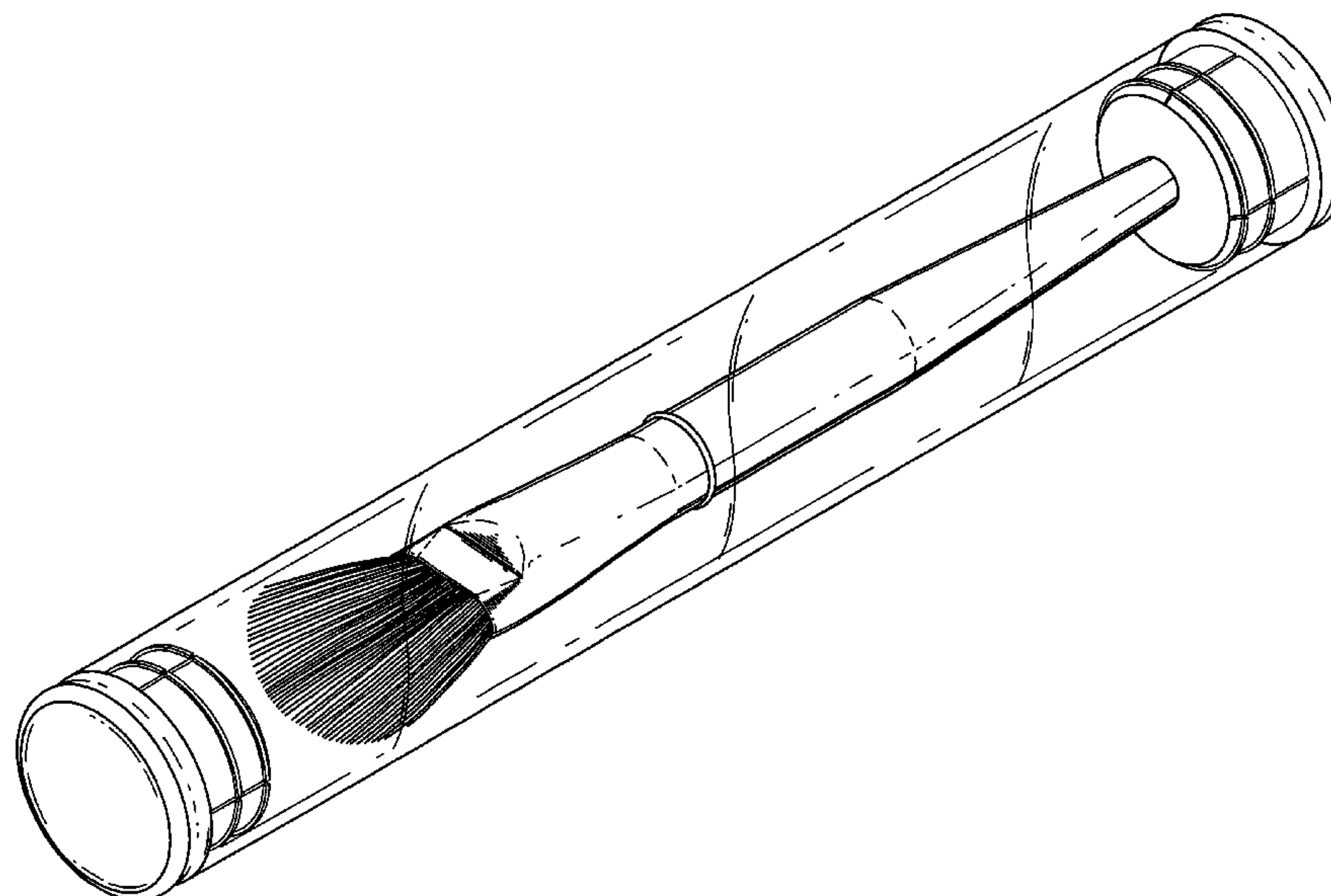
FIG. 9 is a top perspective view of FIG. 8 with an end cap omitted;

FIG. 10 is a top plan view of the cap portion, shown separately for clarity of illustration;

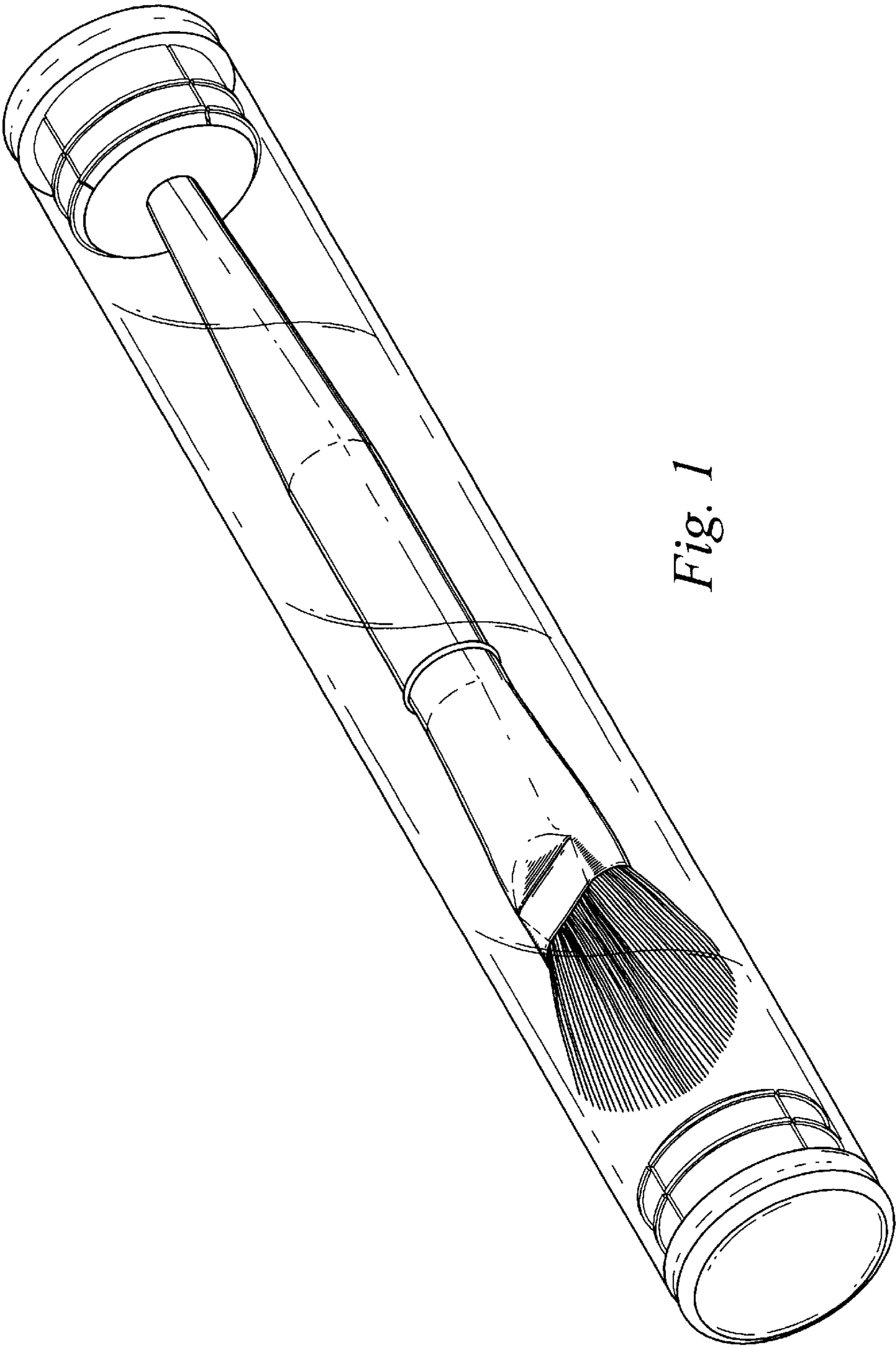

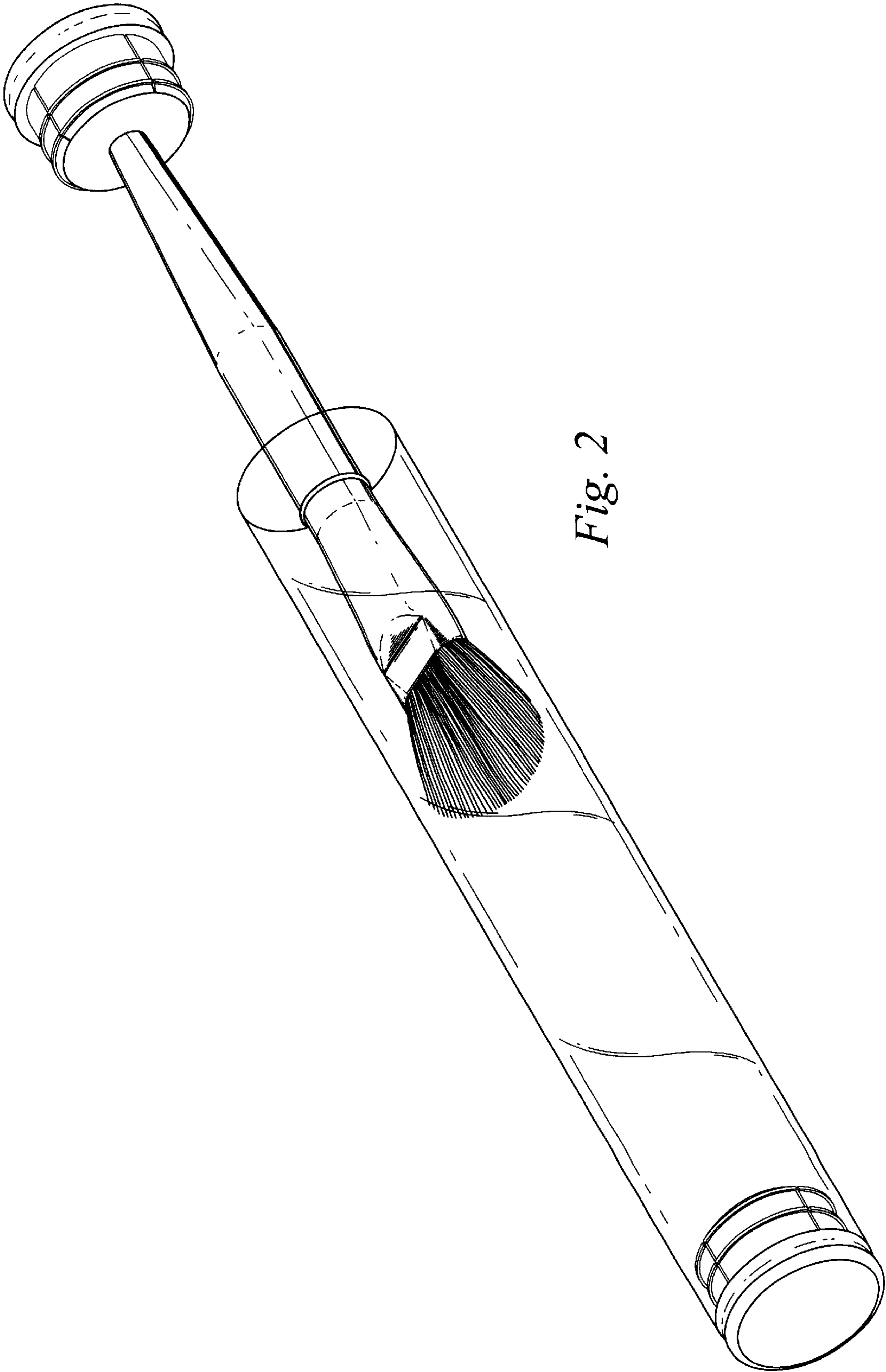

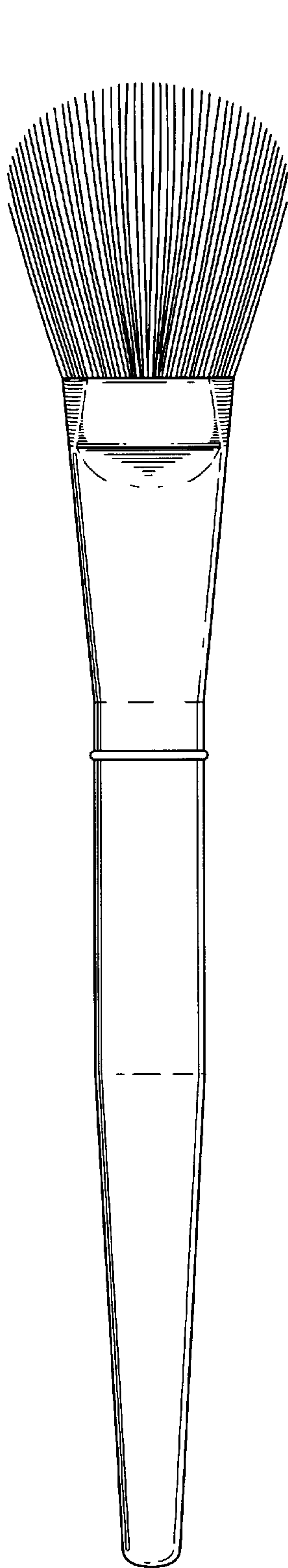

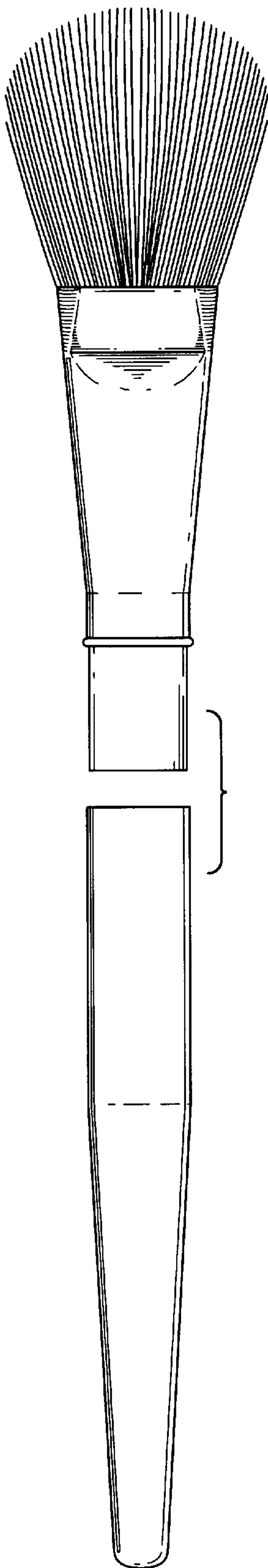

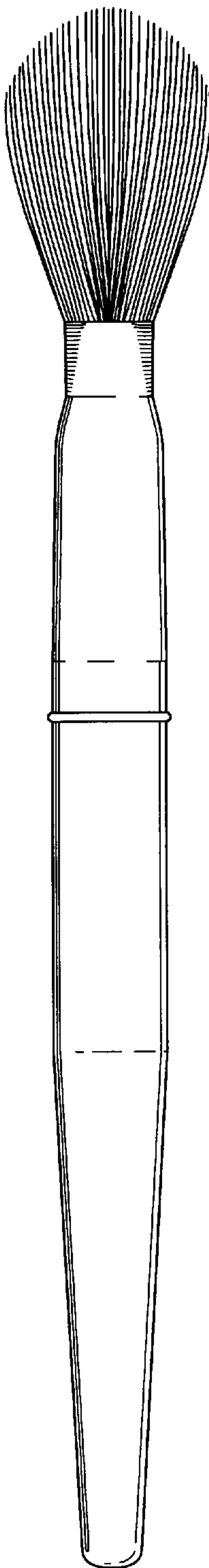

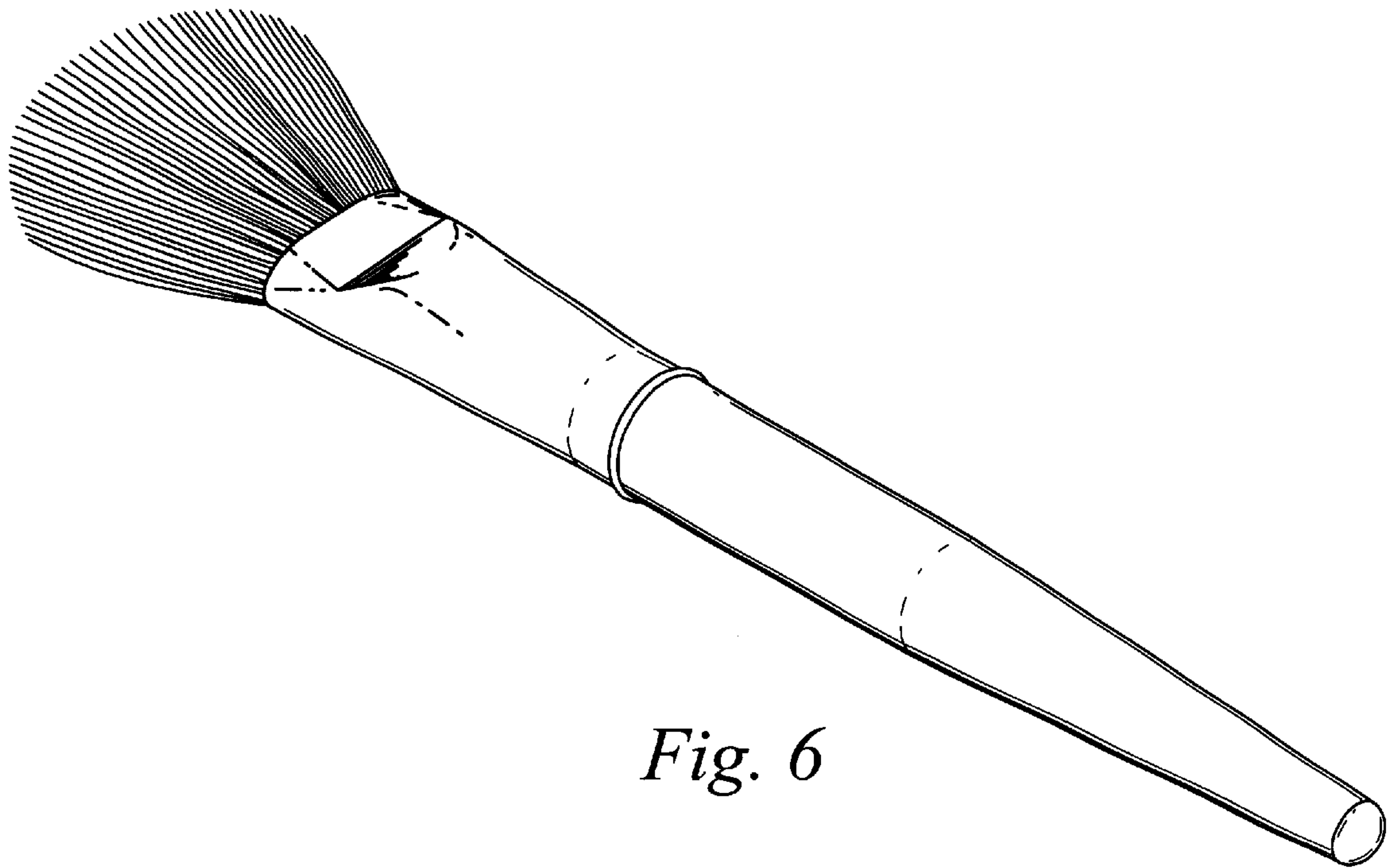

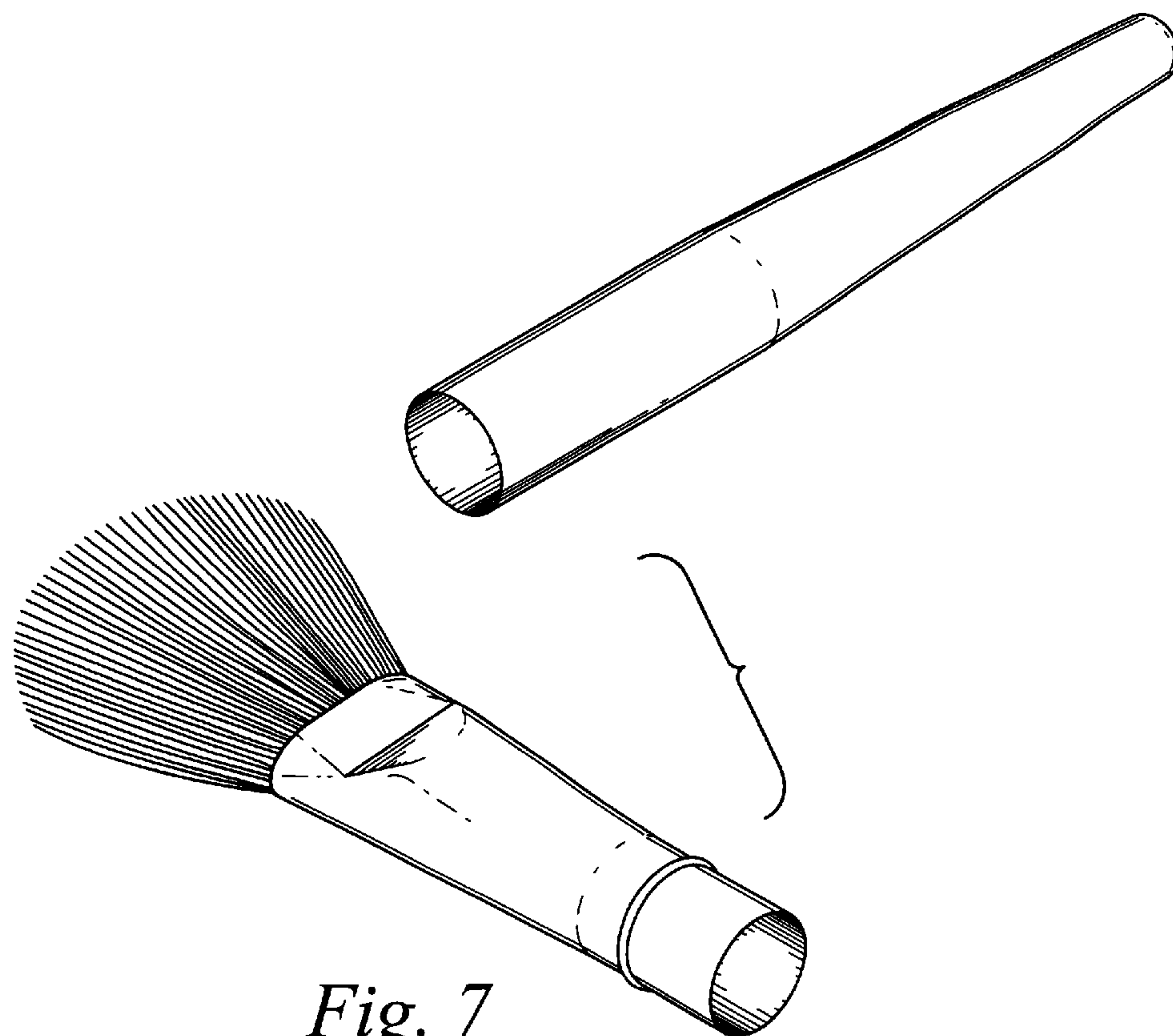

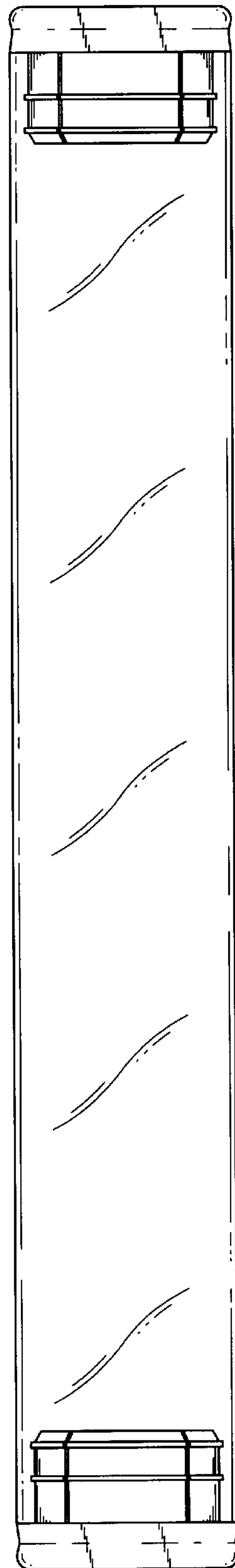

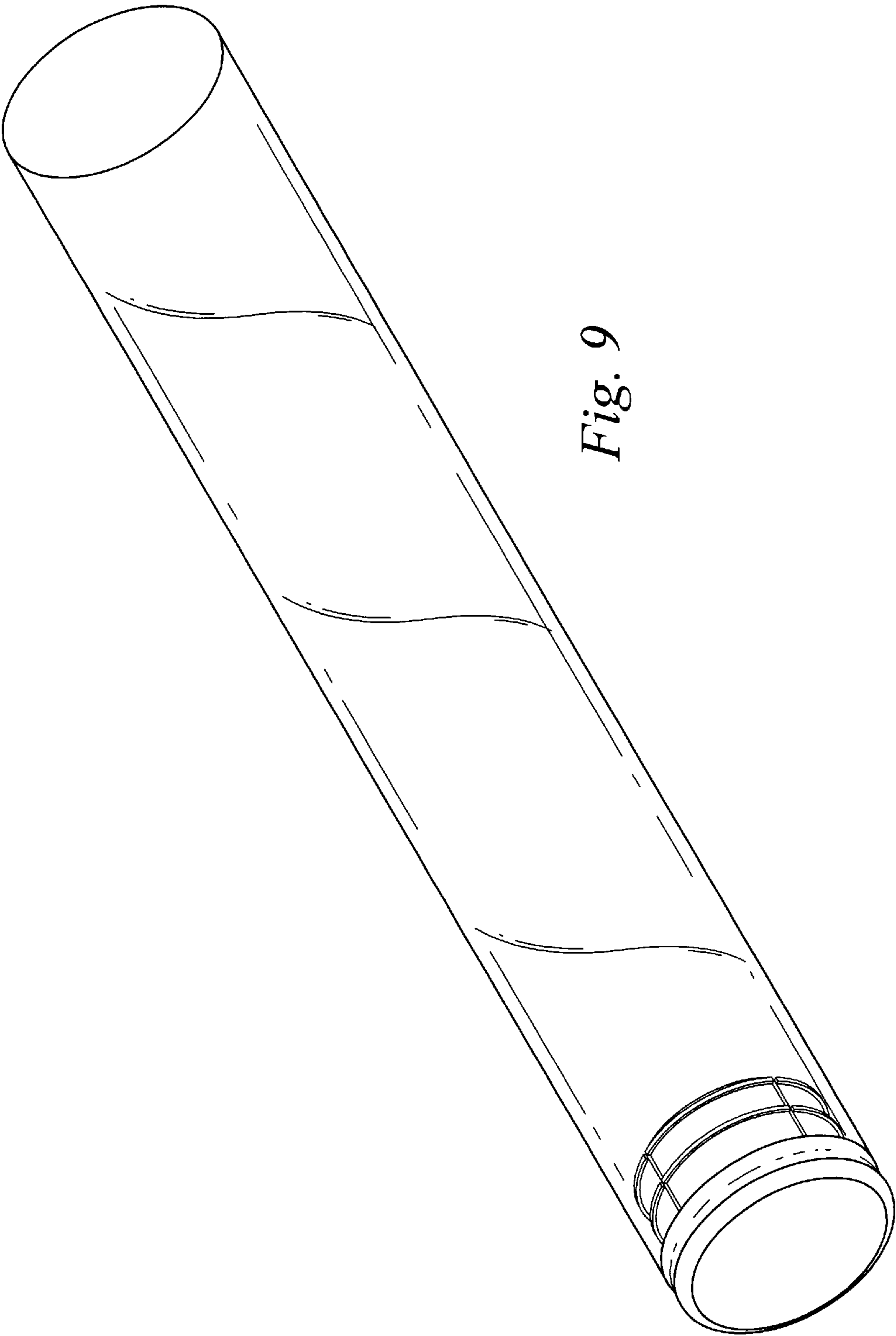

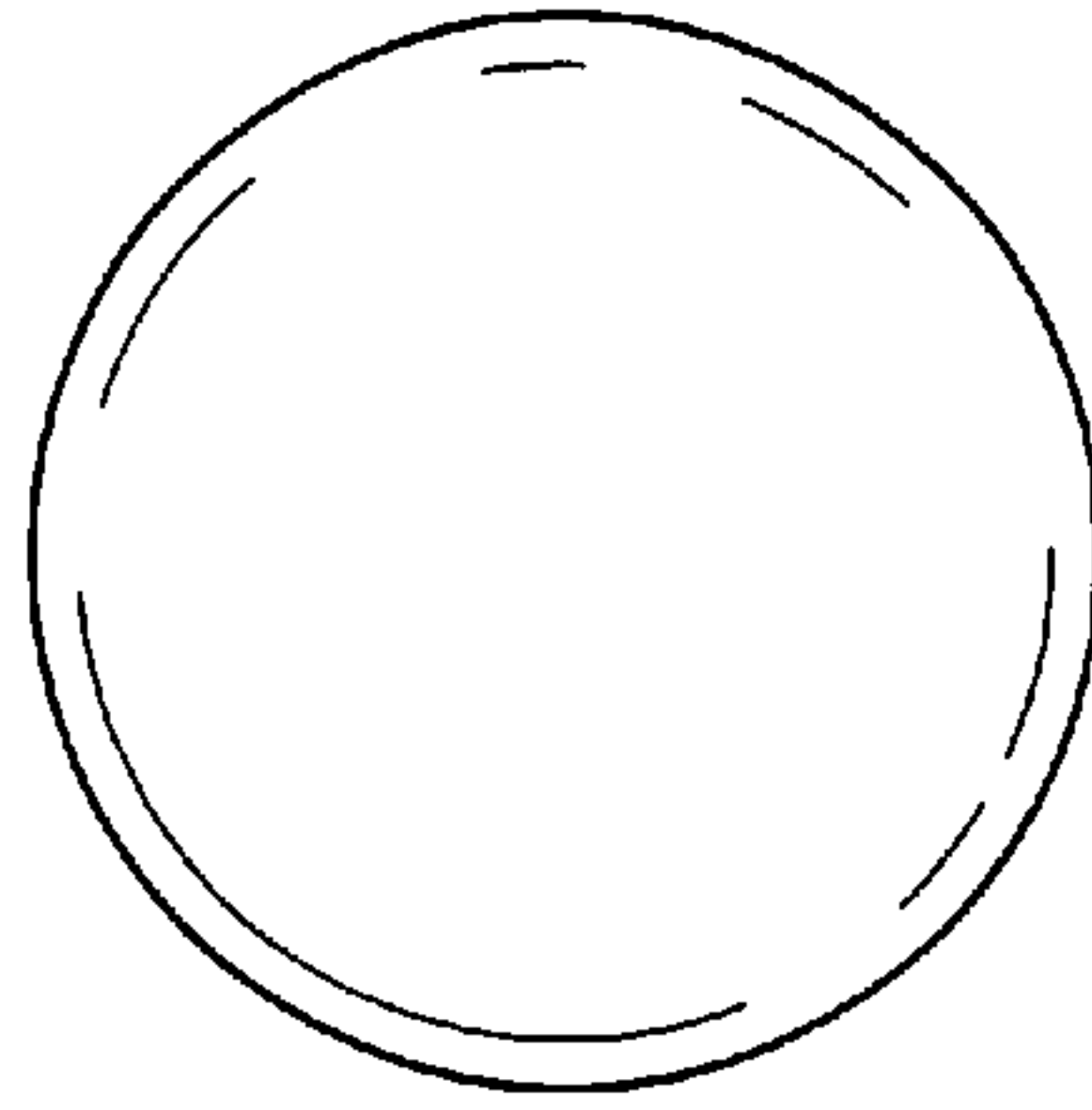

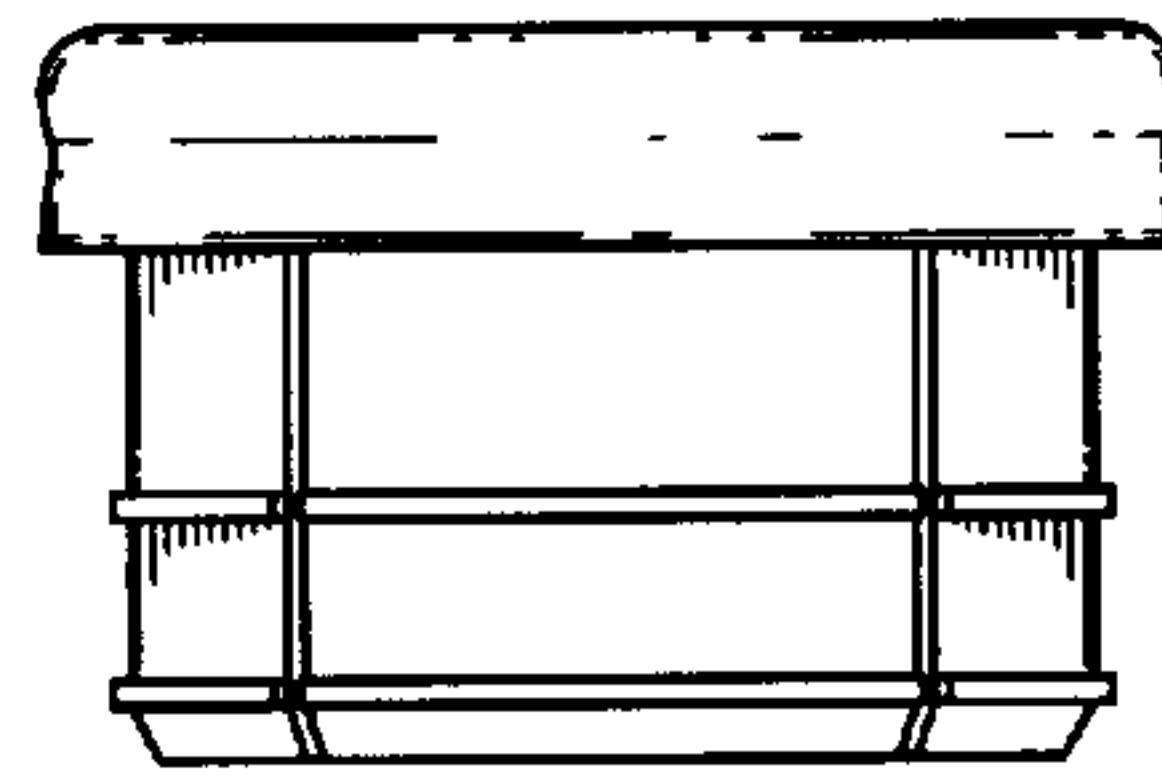

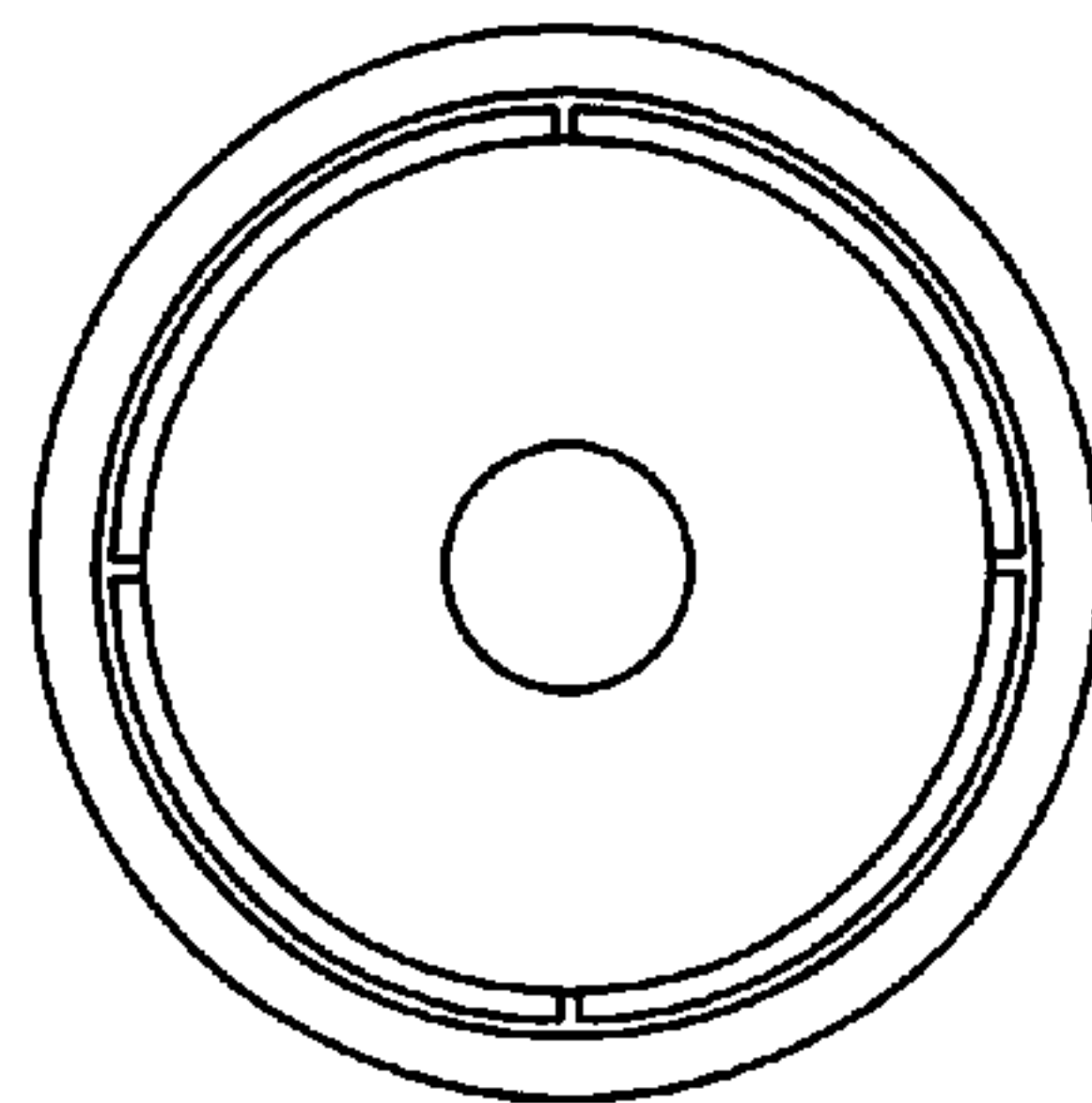
