**DESCRIPTION**

FIG. 1 is a front elevational view of the chair of the present invention;

FIG. 2 is a side elevational view of the chair of FIG. 1;

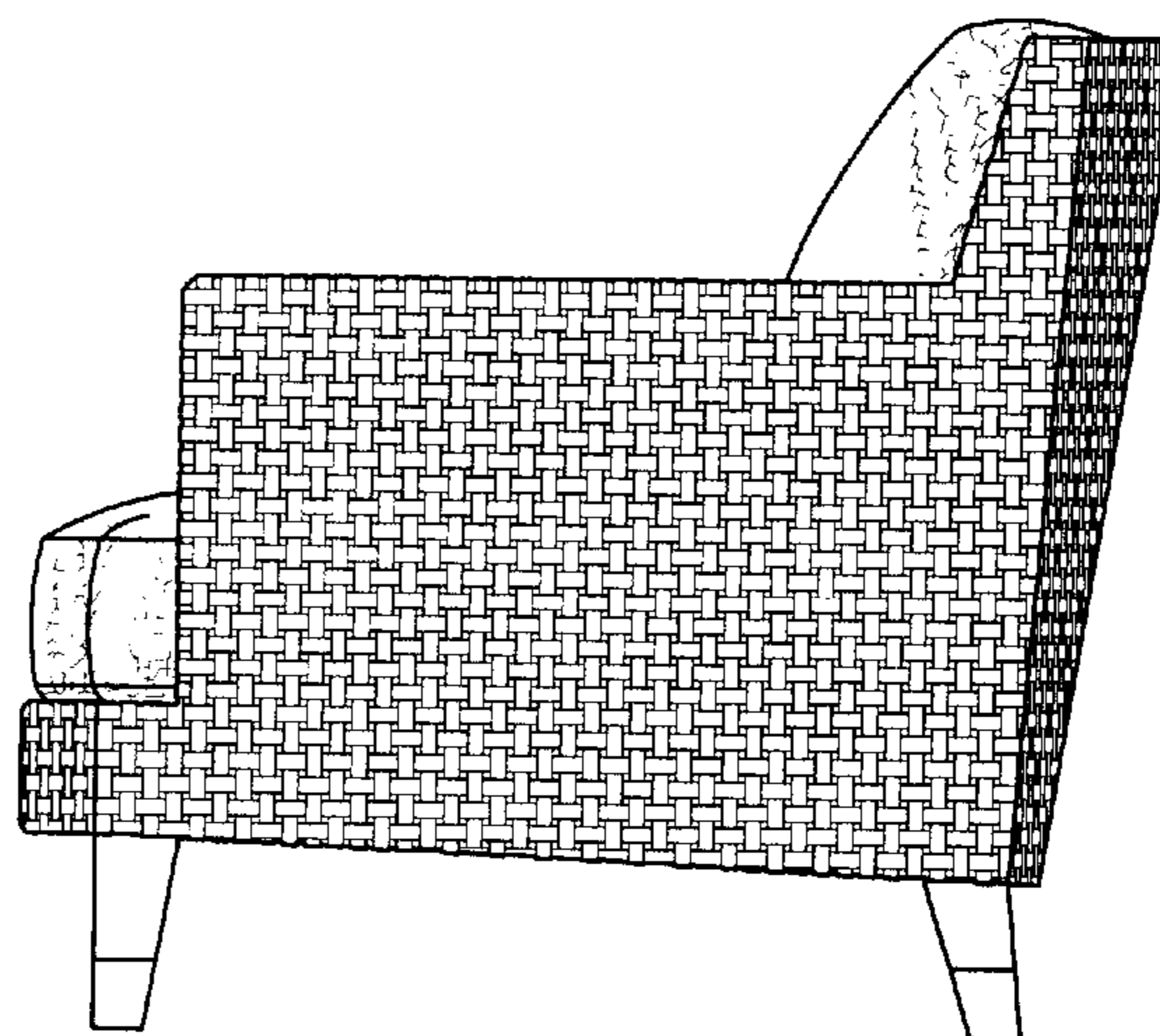
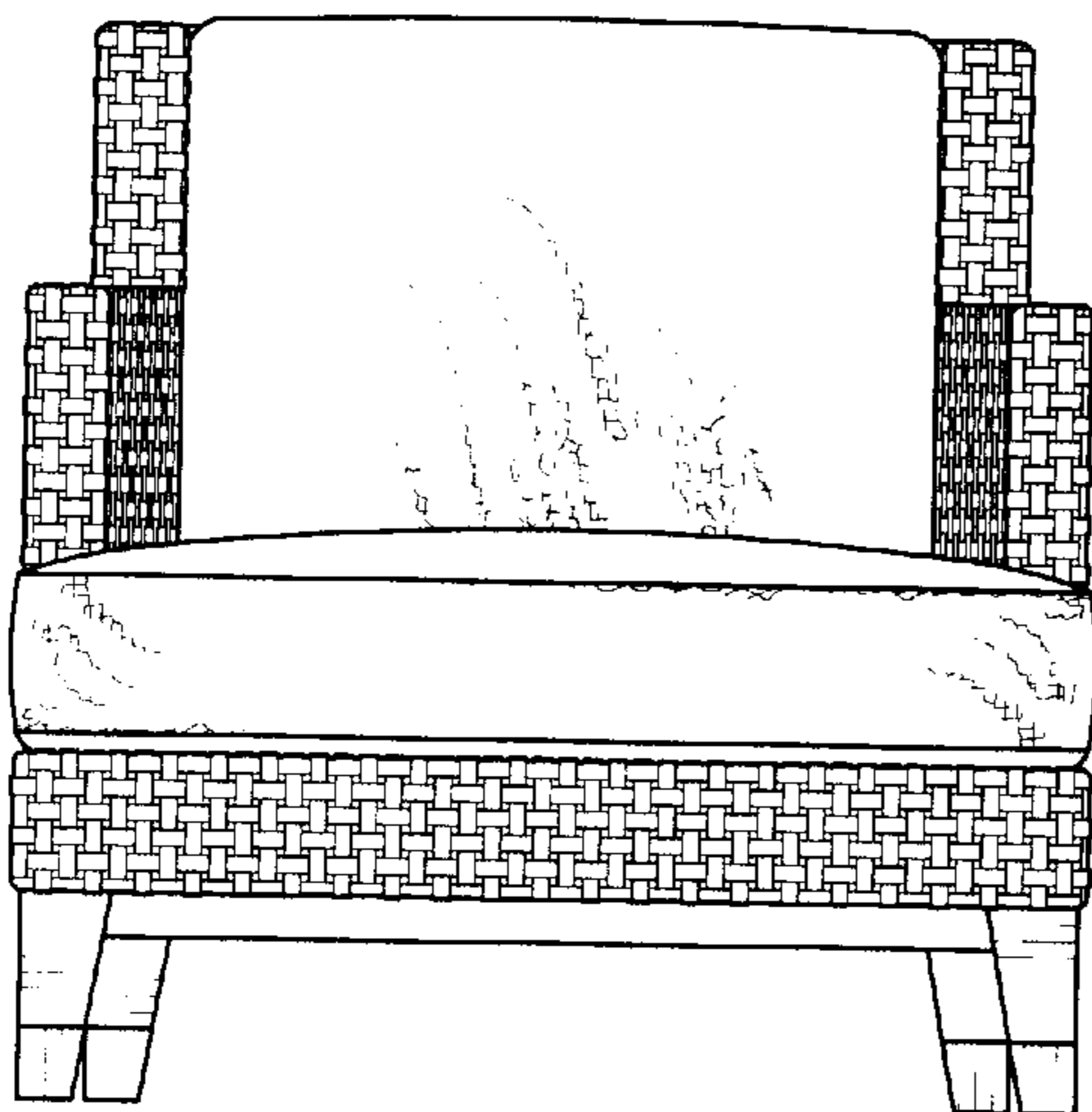
FIG. 3 is a rear elevational view of the chair of FIG. 1;

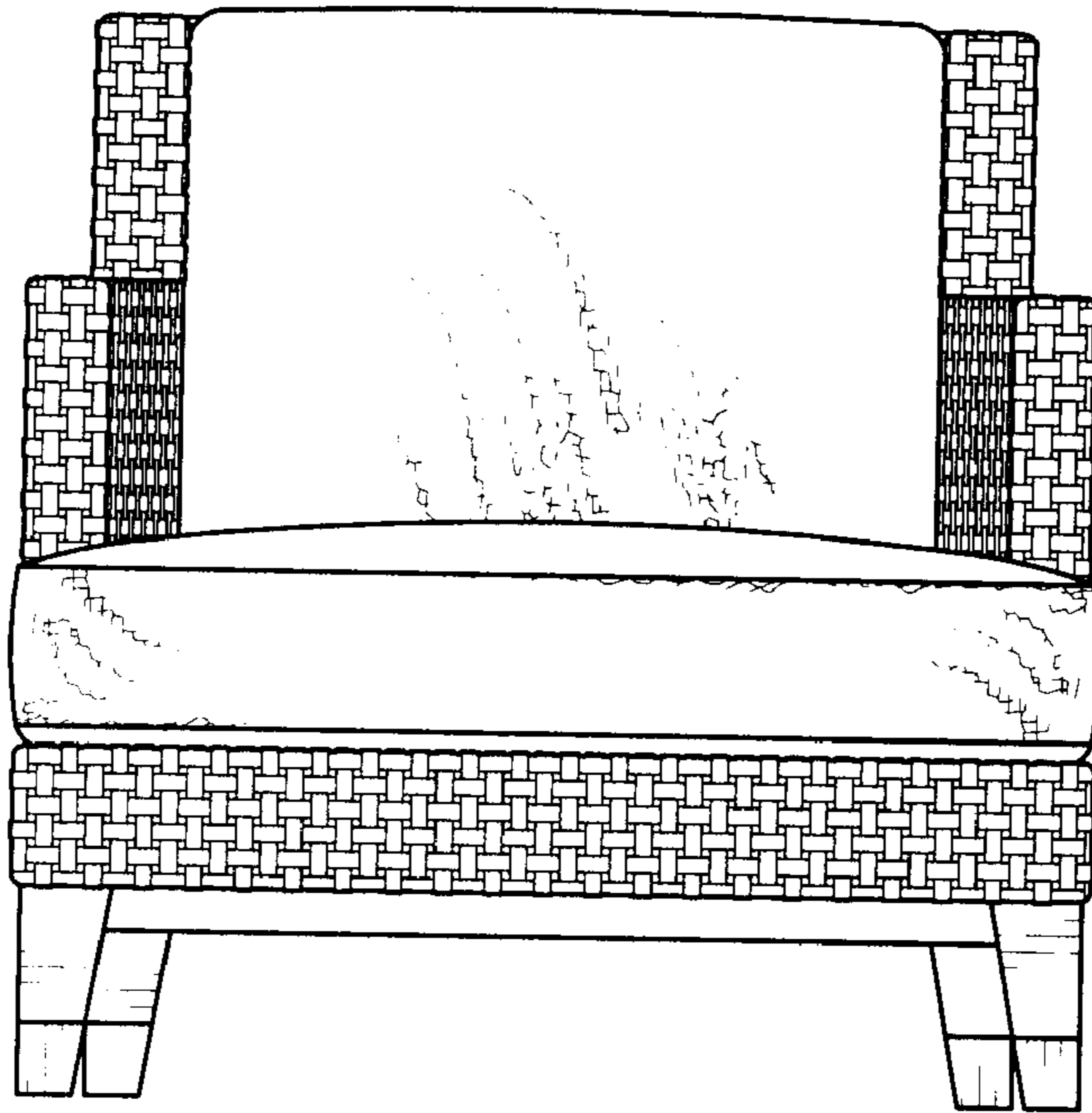

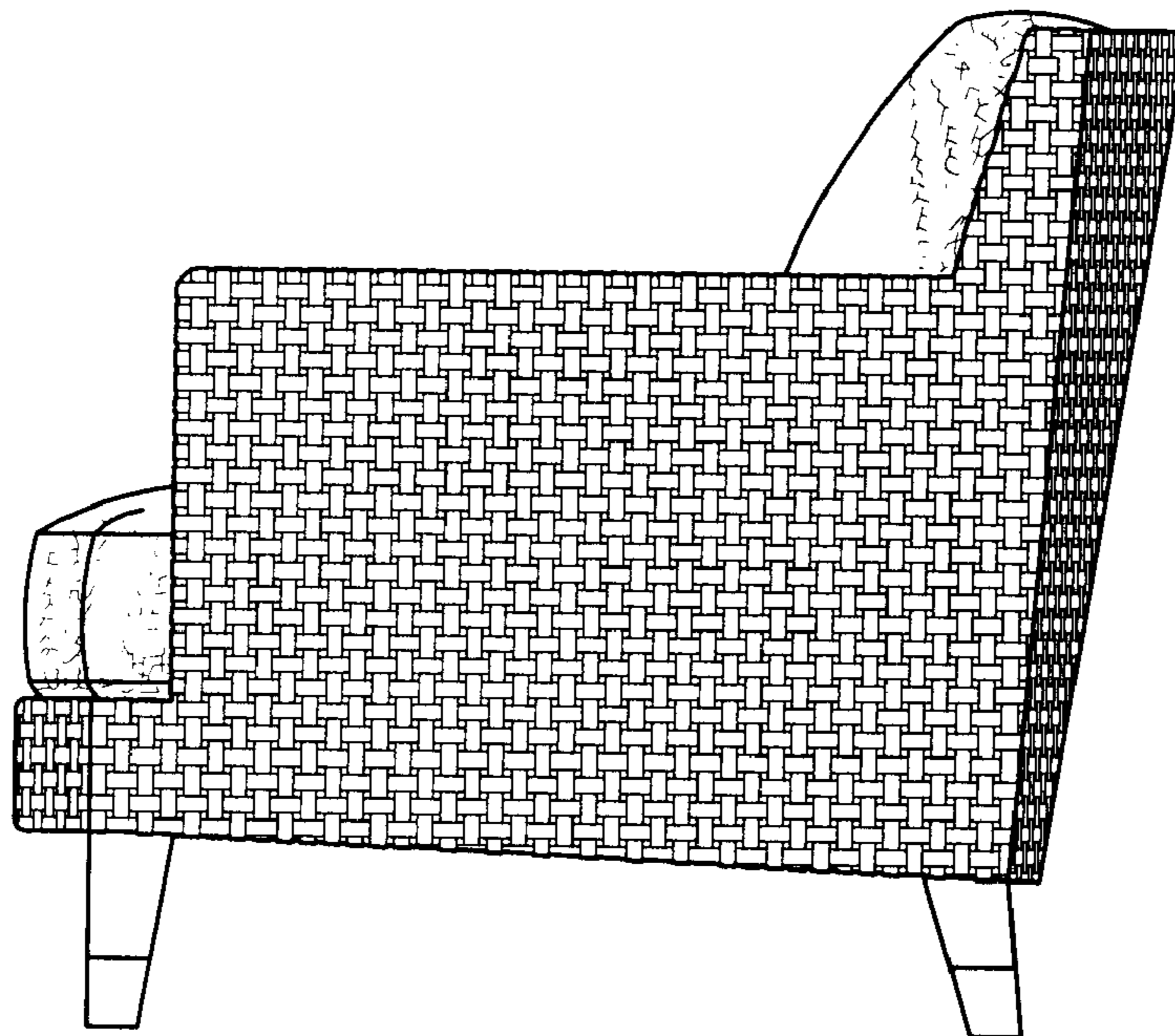

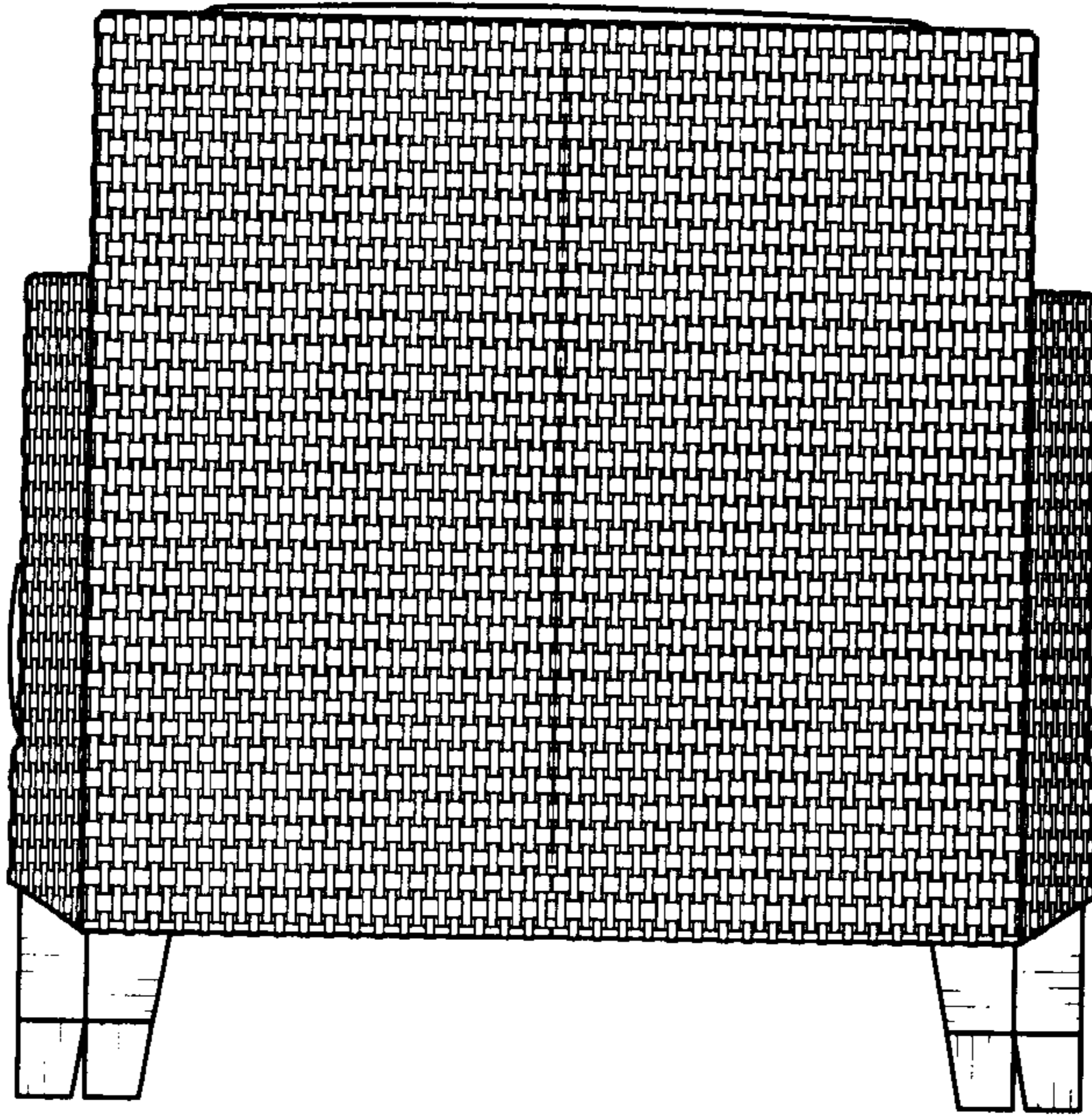

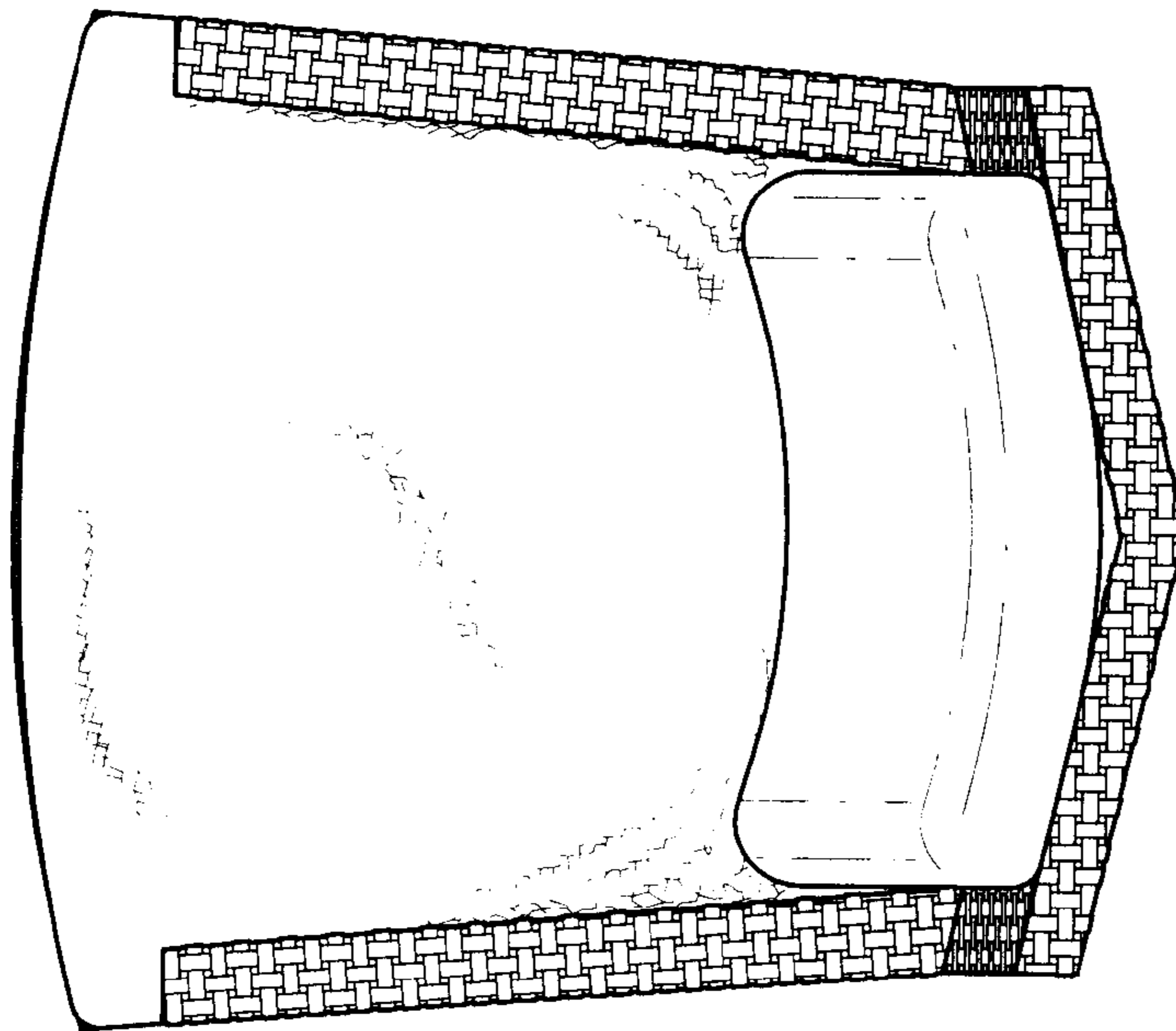

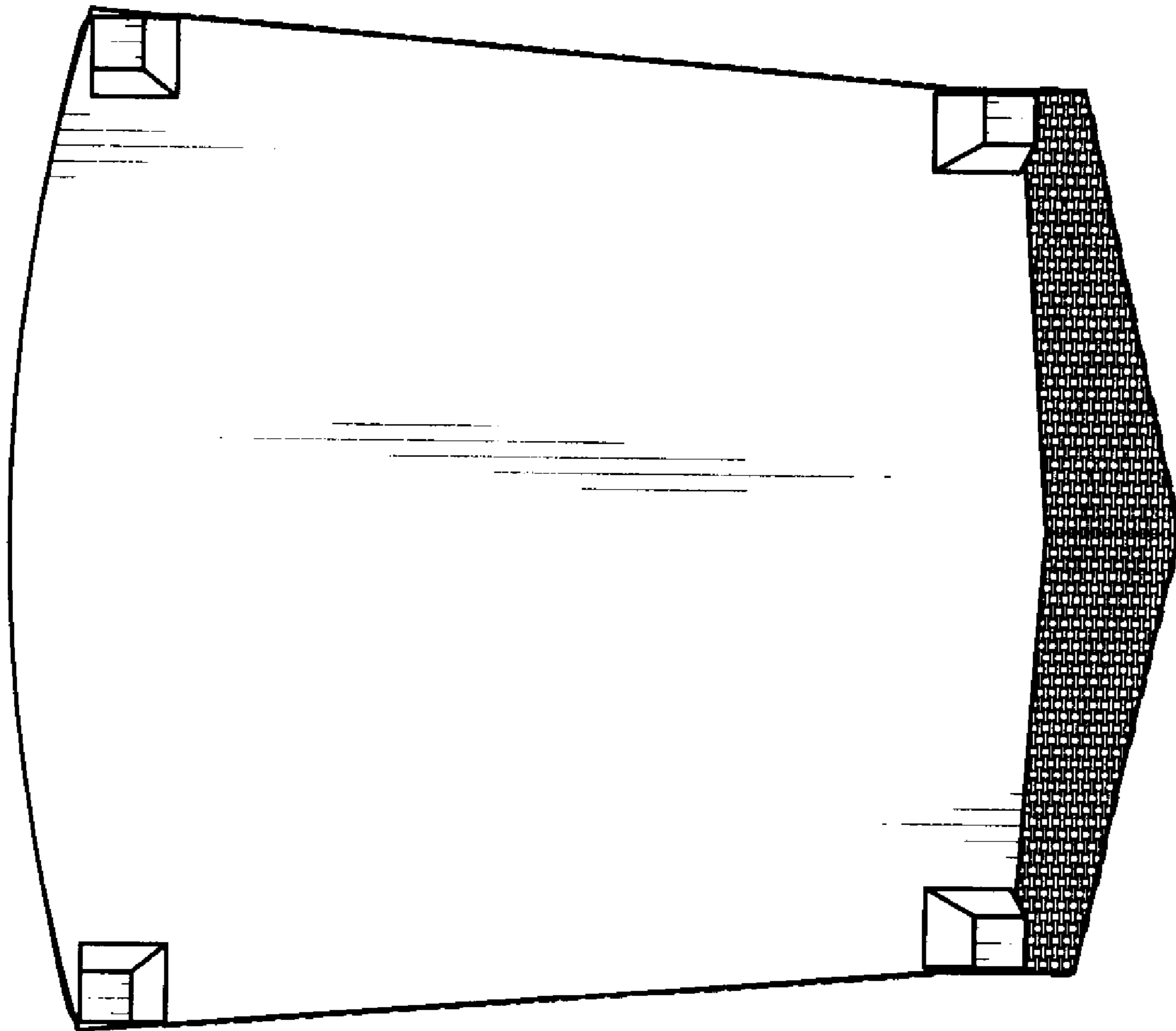
