DESCRIPTION

FIG. 1 is a perspective view of an accessory post of the new design;

FIG. 2 is a left side elevational view of the accessory post of FIG. 1;

FIG. 3 is a front elevational view of the accessory post of FIG. 1;

FIG. 4 is a bottom plan view of the accessory post of FIG. 1;

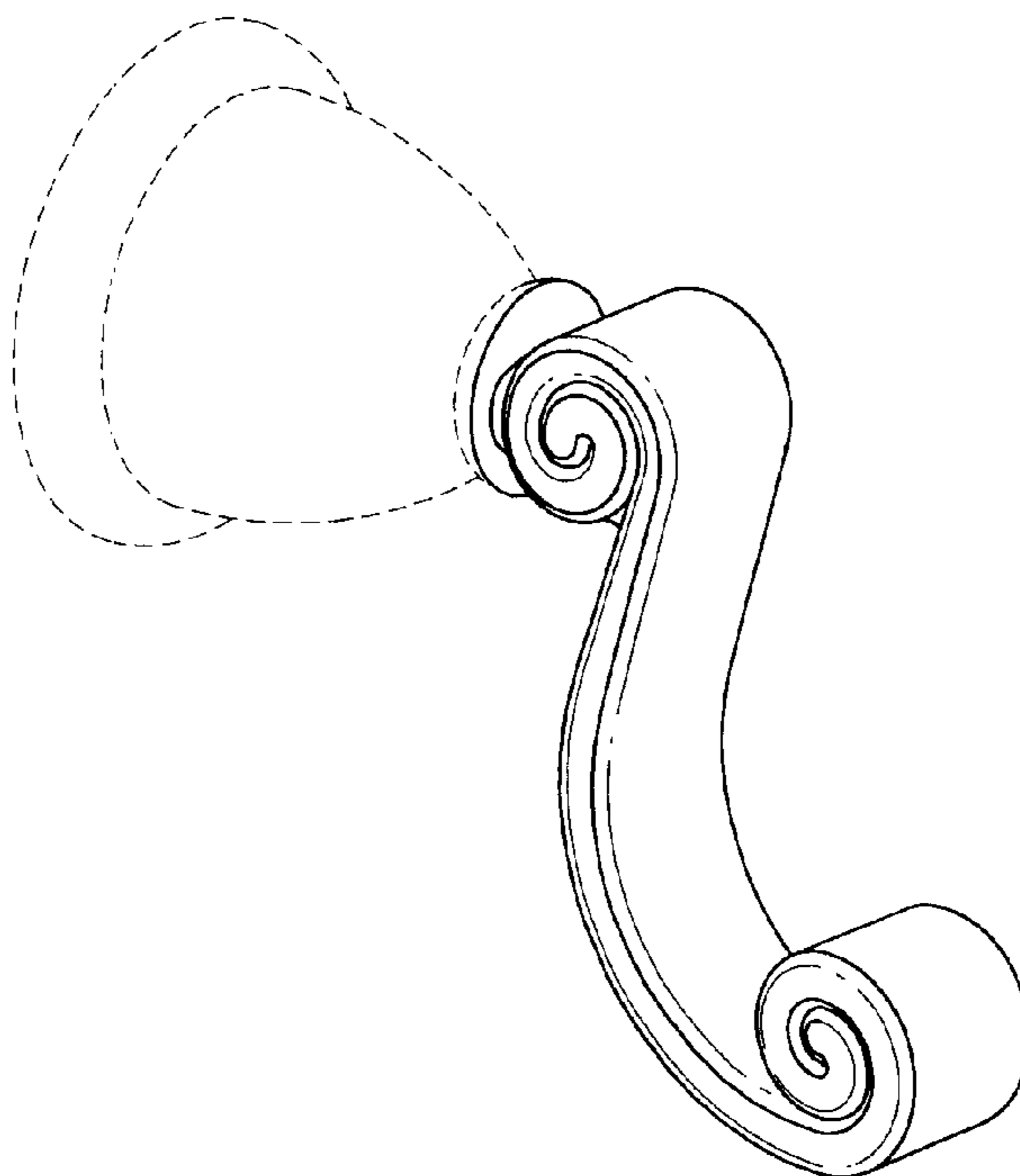
FIG. 5 is a top plan view of the accessory post of FIG. 1;

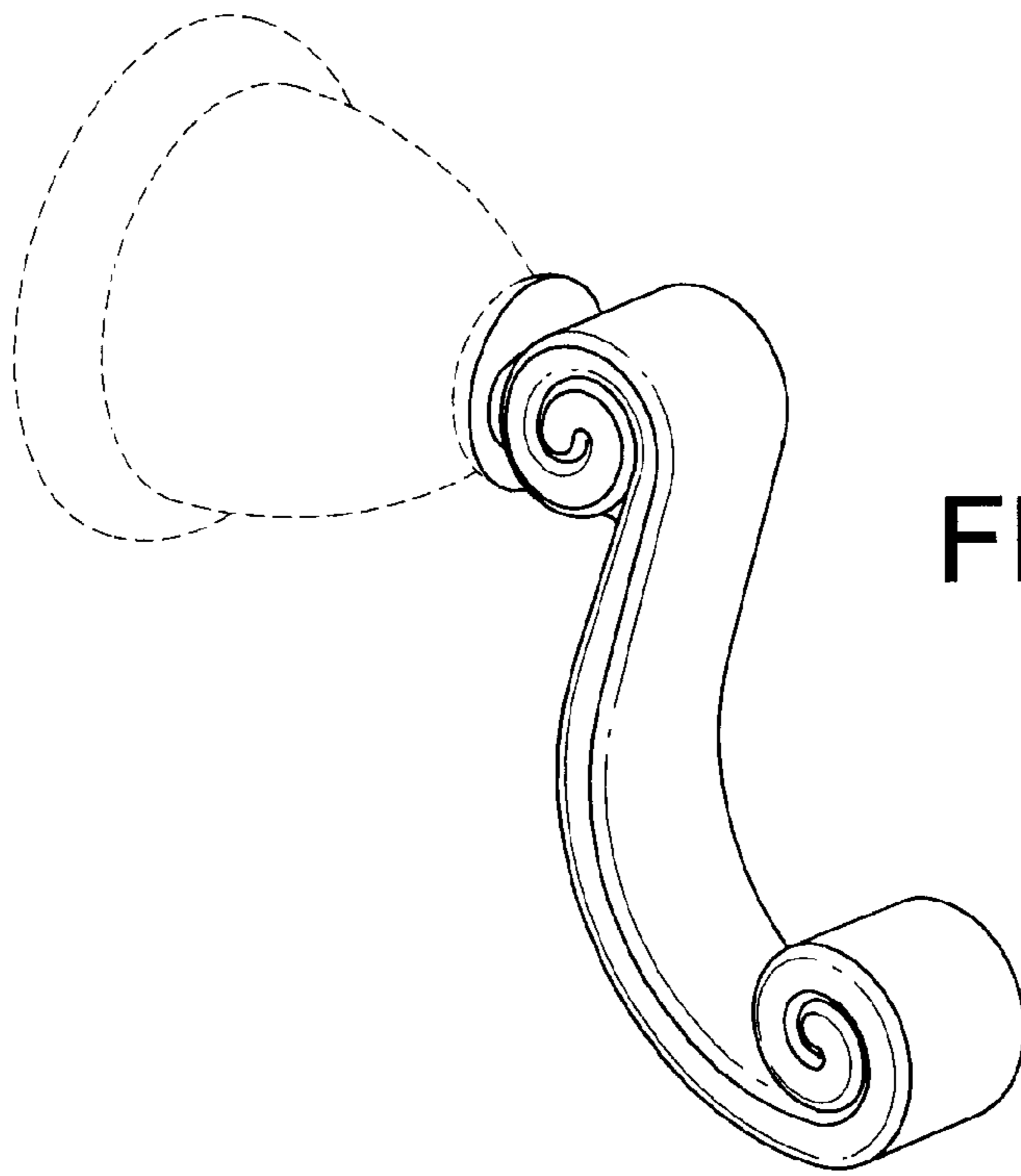

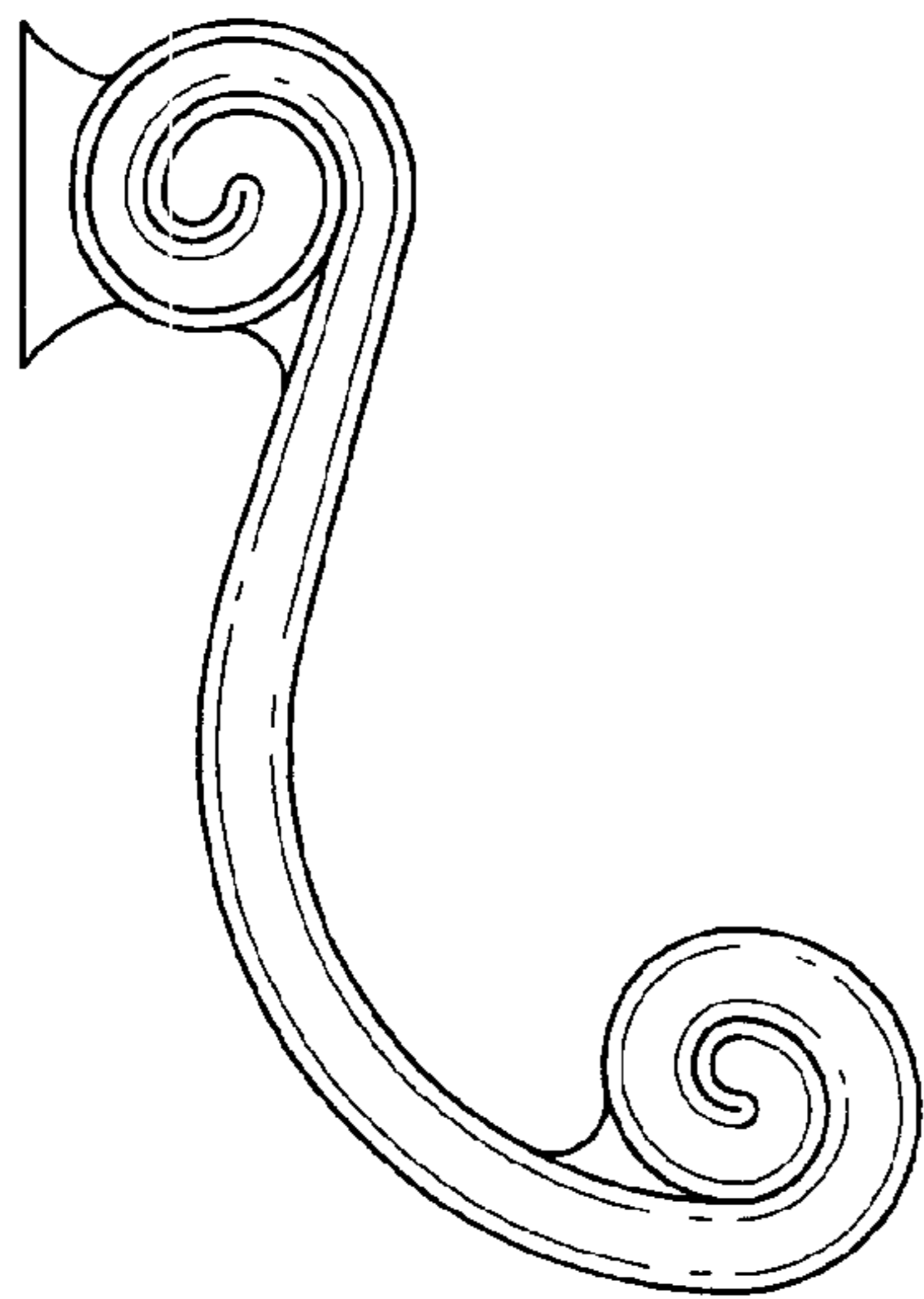

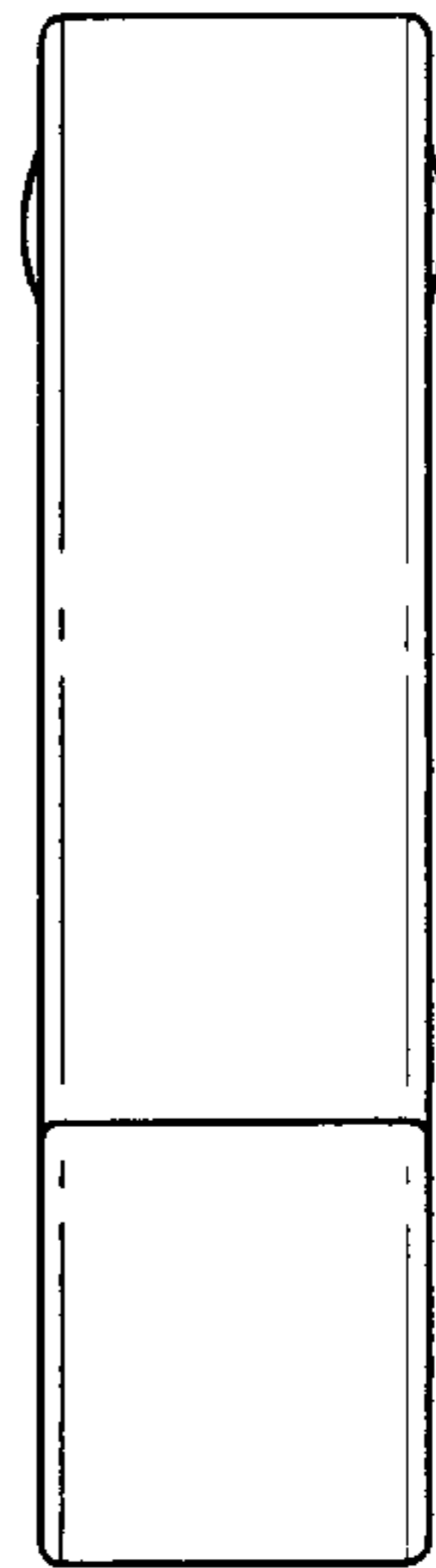

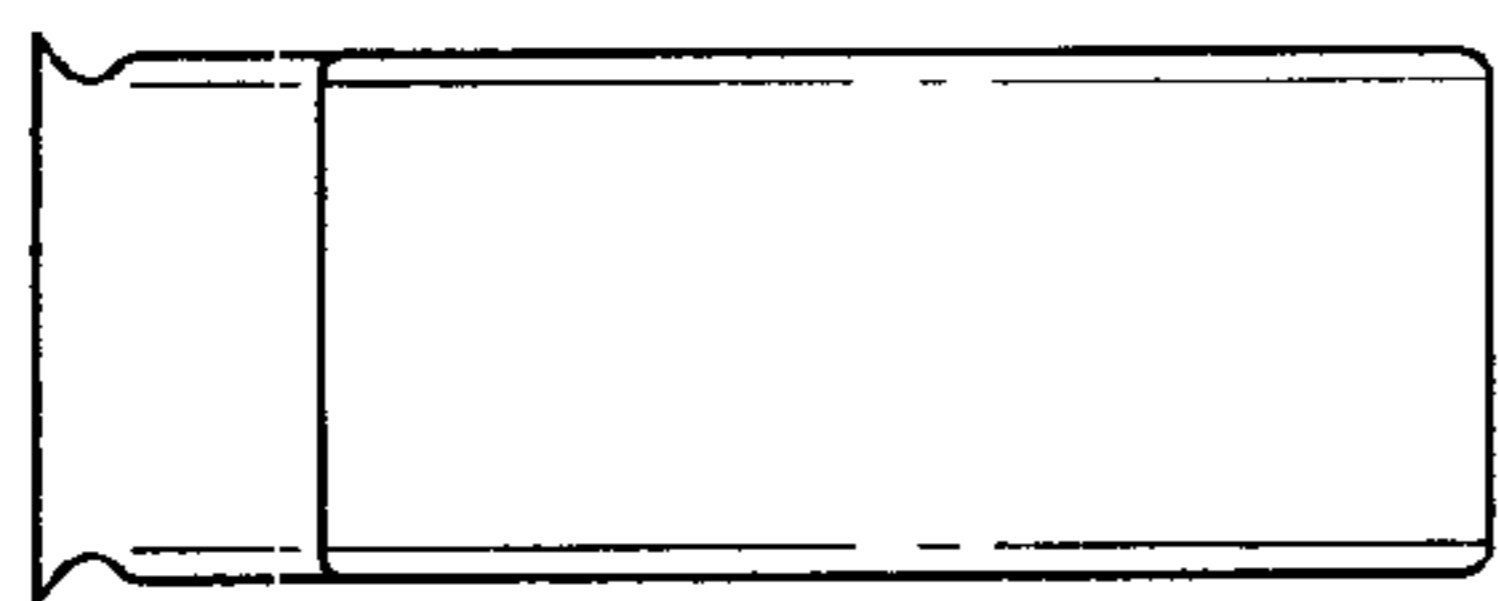

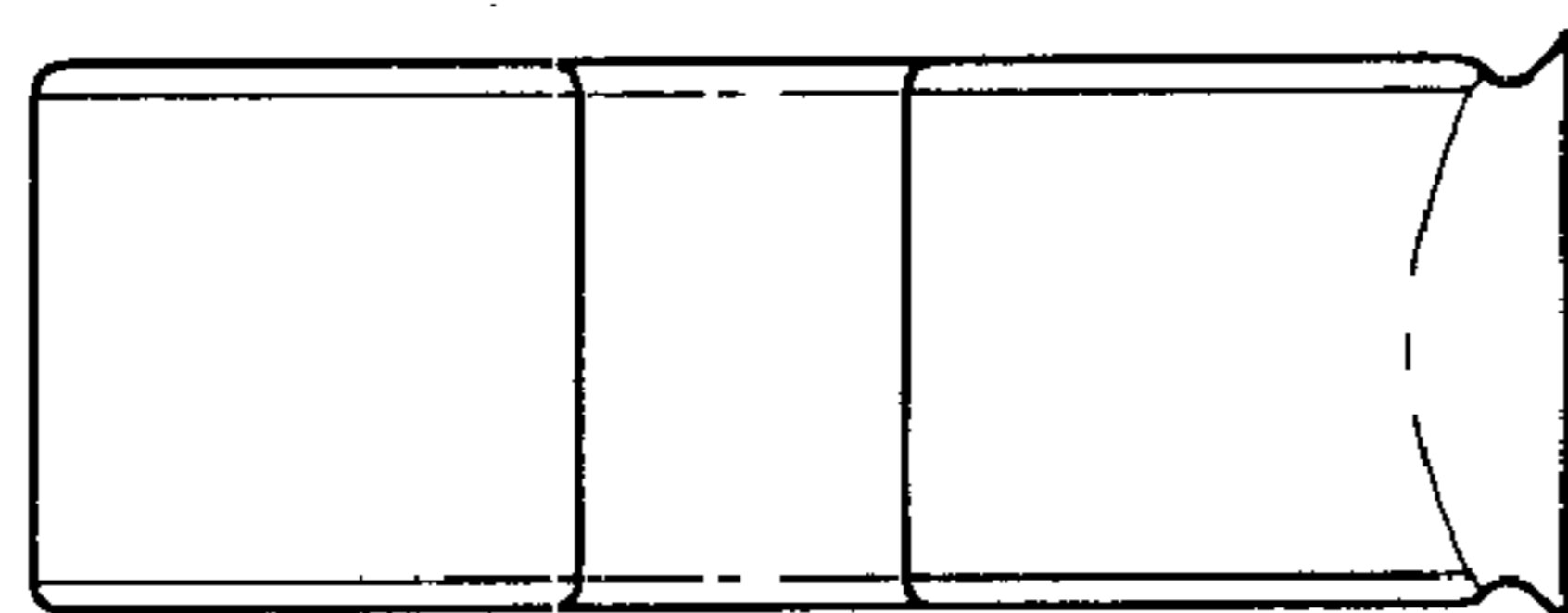

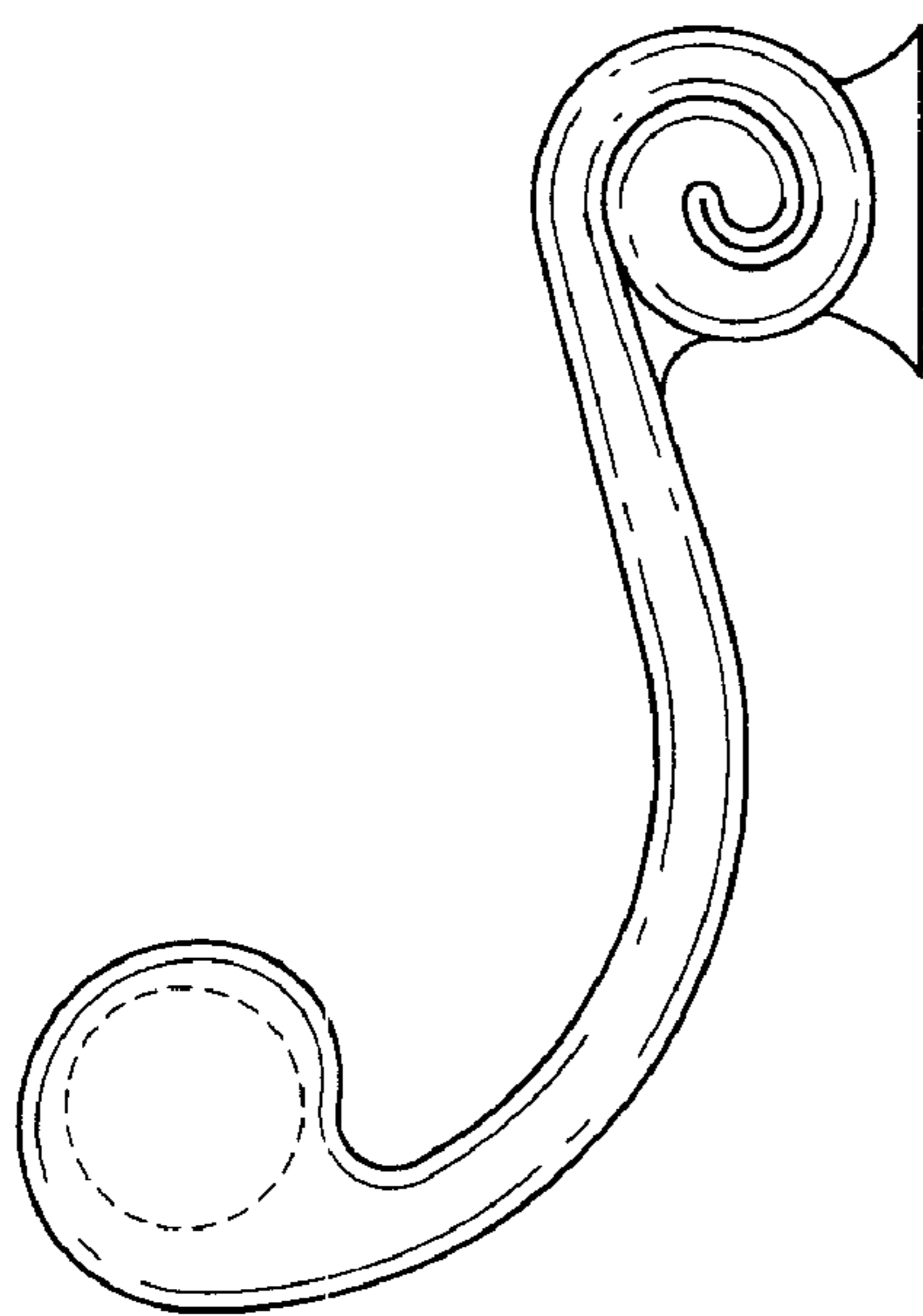

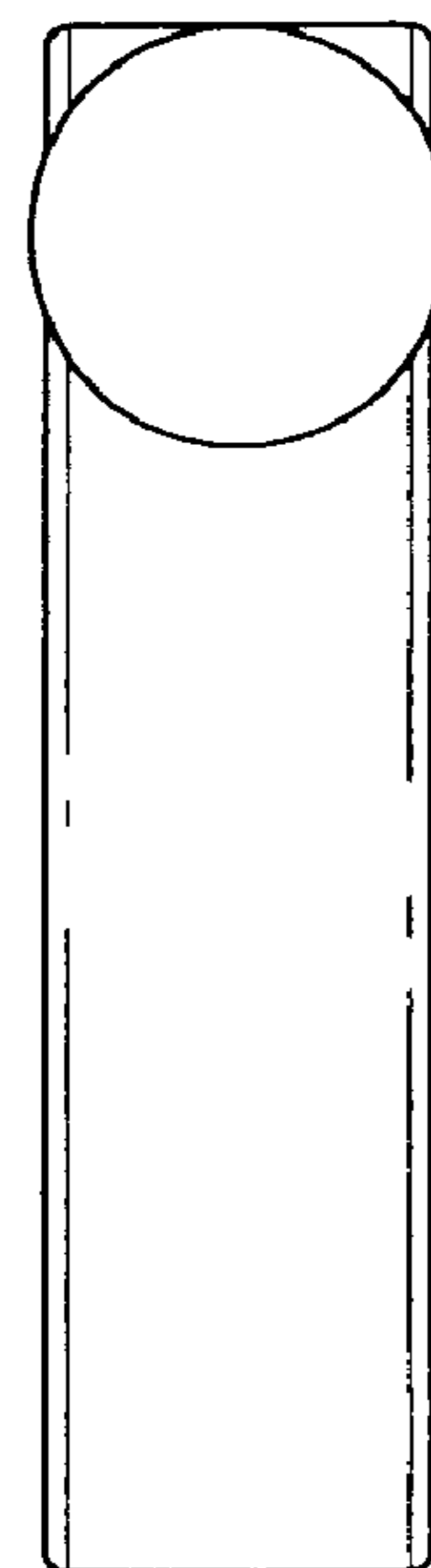
