(57) **CLAIM**

I claim the ornamental design for the combinatory pillow, seat cushion and blanket, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a combinatory pillow, seat cushion and blanket in a compact, folded mode.

FIG. 2 is a rear view of the combinatory pillow, seat cushion and blanket in the compact, folded mode shown in FIG. 1.

FIG. 3 is a top view of the combinatory pillow, seat cushion and blanket in the compact, folded mode shown in FIG. 1.

FIG. 4 is a bottom view of the combinatory pillow, seat cushion and blanket in the compact, folded mode shown in FIG. 1.

FIG. 5 is a right side view of the combinatory pillow, seat cushion and blanket in the compact, folded mode shown in FIG. 1.

FIG. 6 is a left side view of the combinatory pillow, seat cushion and blanket in the compact, folded mode shown in FIG. 1.

FIG. 7 is a front view of a combinatory pillow, seat cushion and blanket in an expanded, unfolded mode.

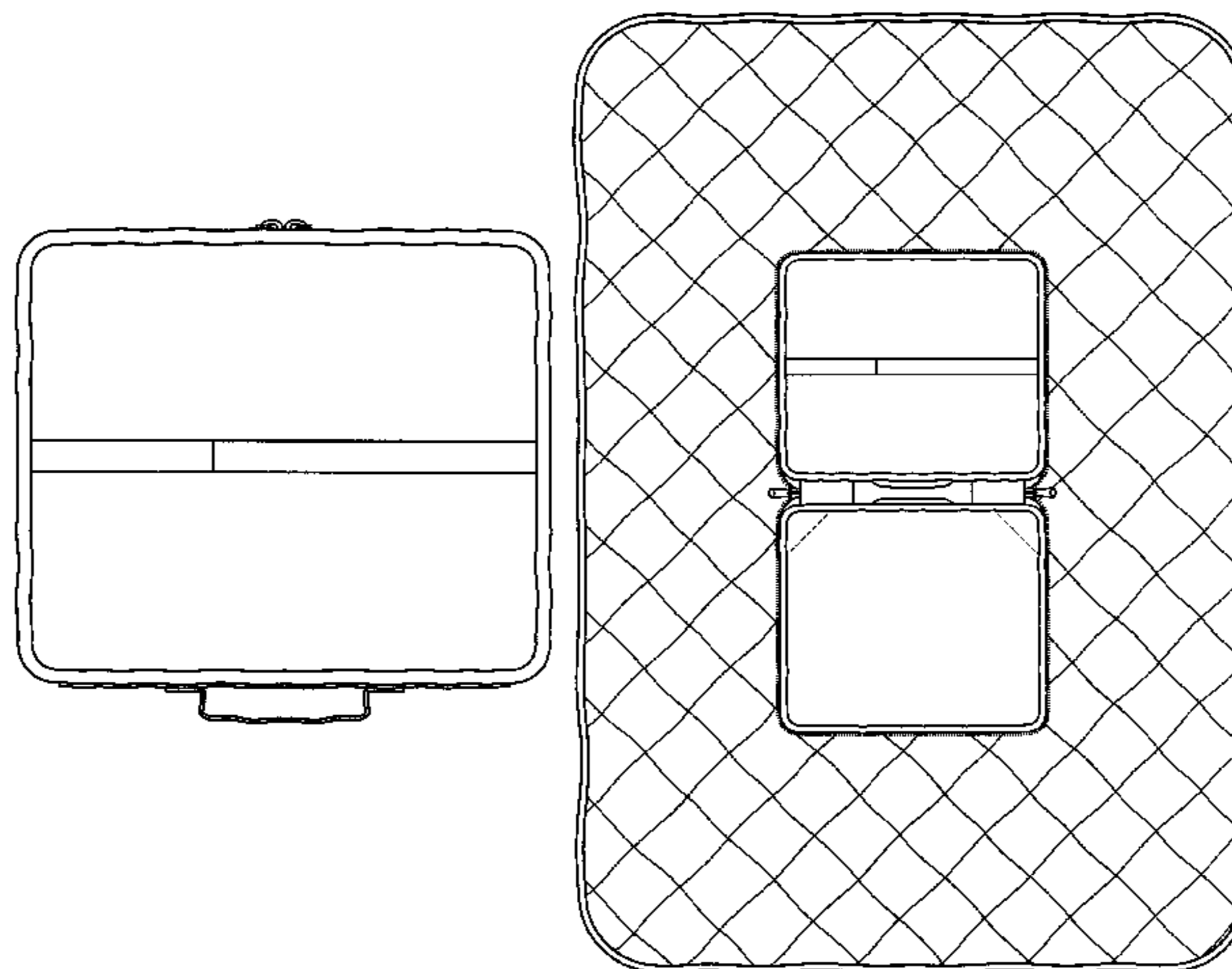
FIG. 8 is a rear view of the combinatory pillow, seat cushion and blanket in an expanded, unfolded mode shown in FIG. 7.

FIG. 9 is a top view of the combinatory pillow, seat cushion and blanket in an expanded, unfolded mode shown in FIG. 7 (the bottom view begin a mirror image of the top view); and,

FIG. 10 is a right side view of the combinatory pillow, seat cushion and blanket in an expanded, unfolded mode shown in FIG. 7 (the left side view being a mirror image of the right side view).

In the drawings, the broken lines represent stitching forming part of the claimed design.

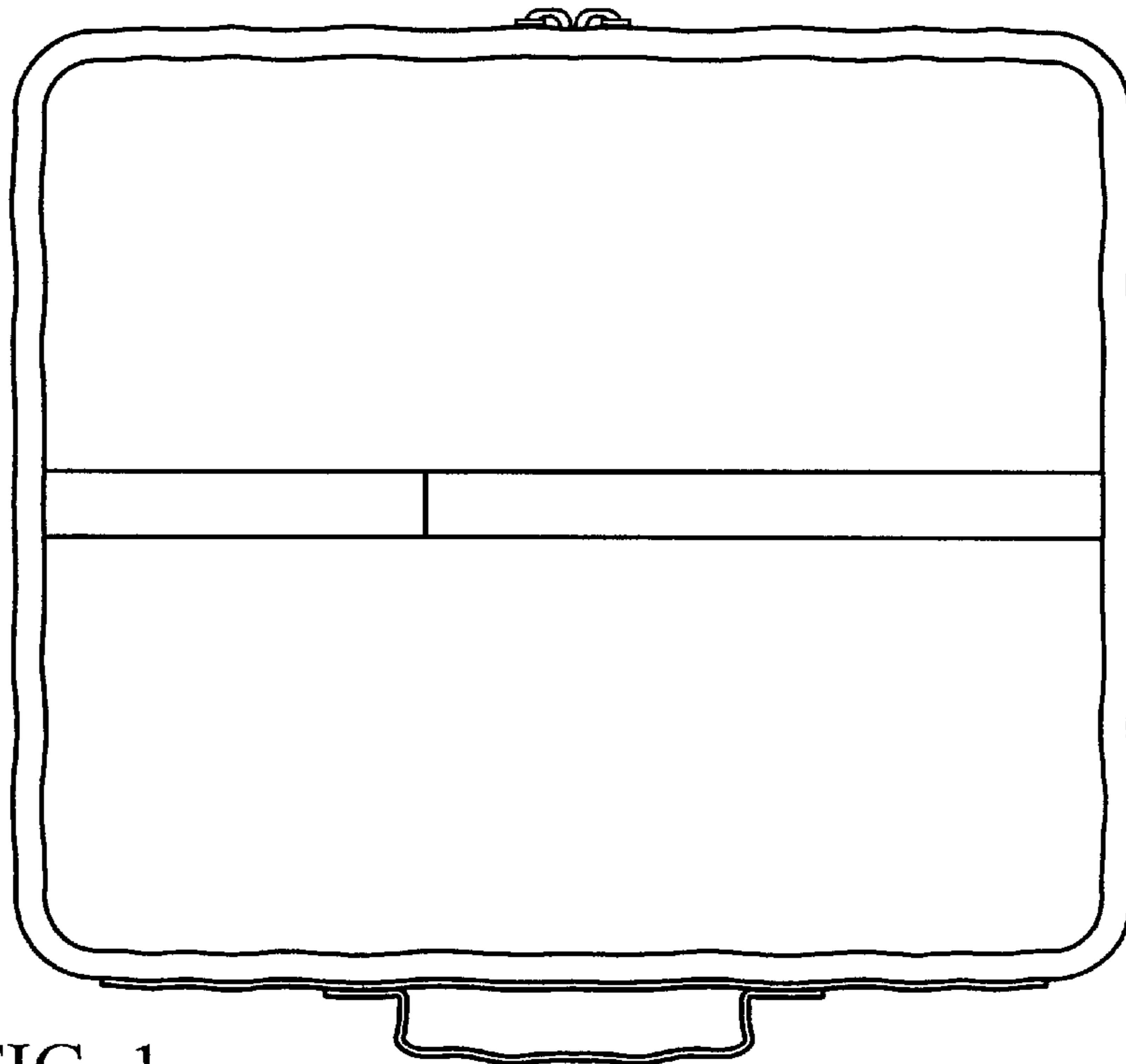

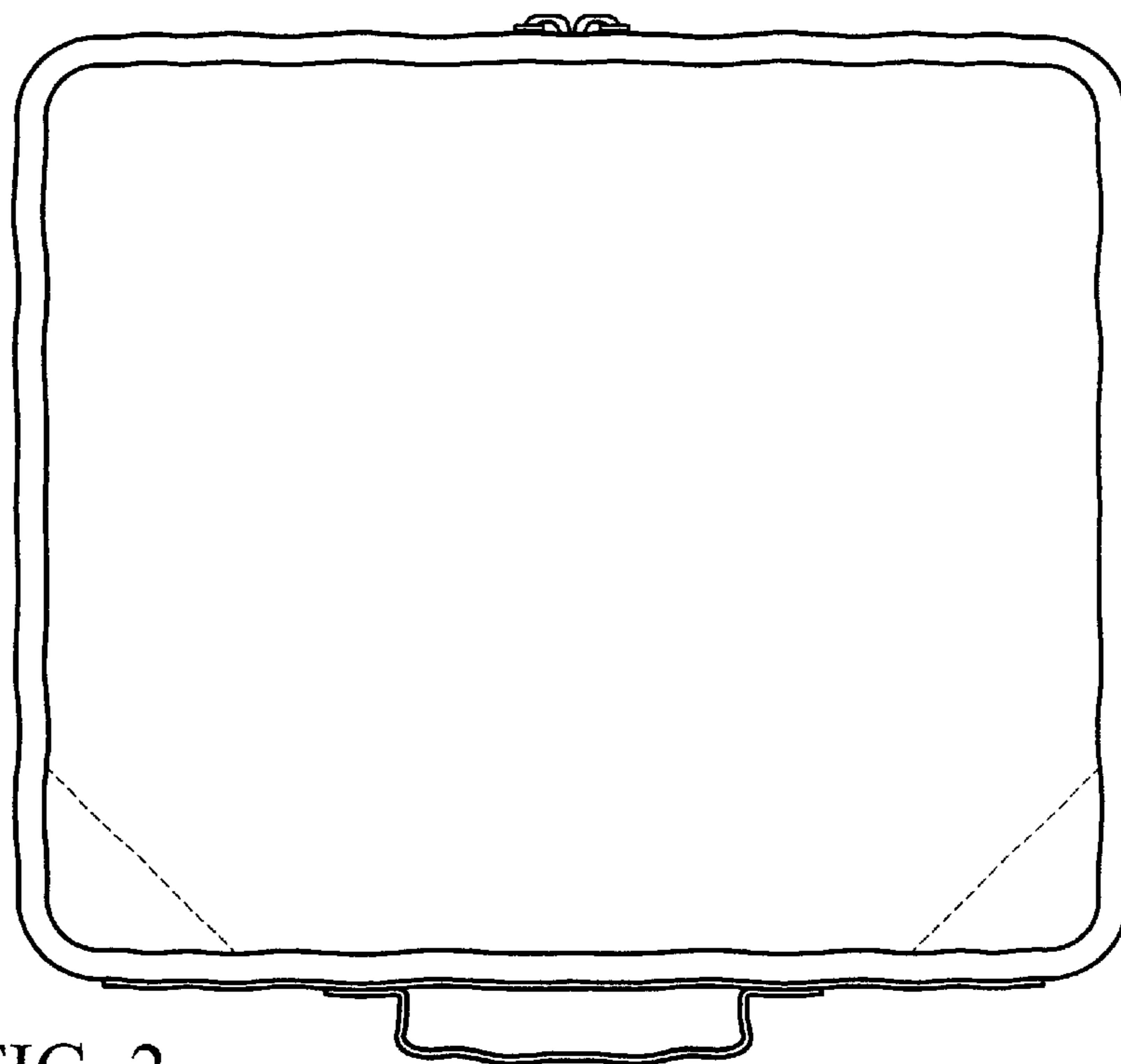

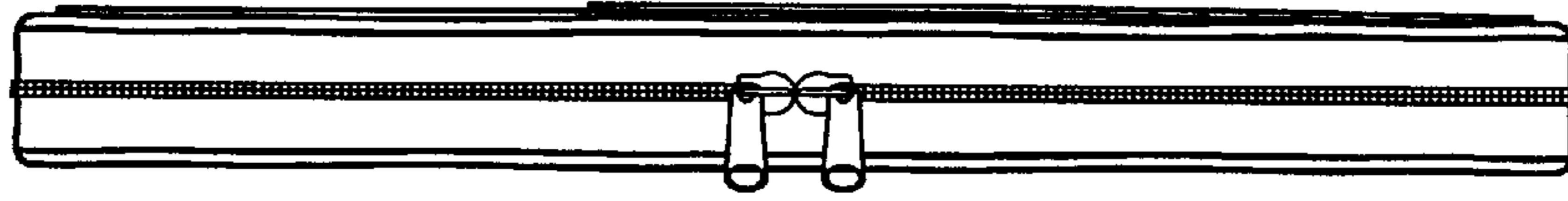

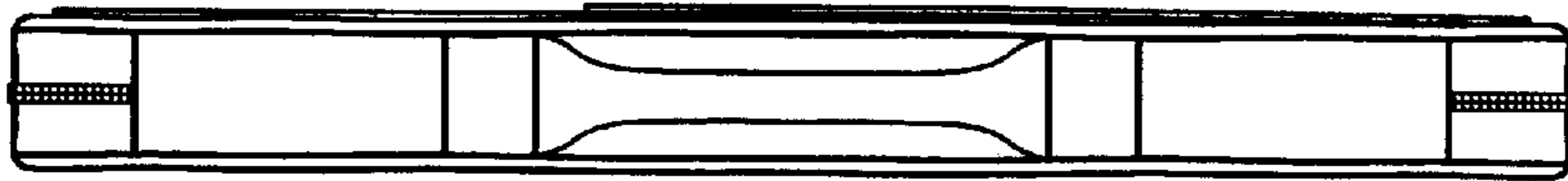

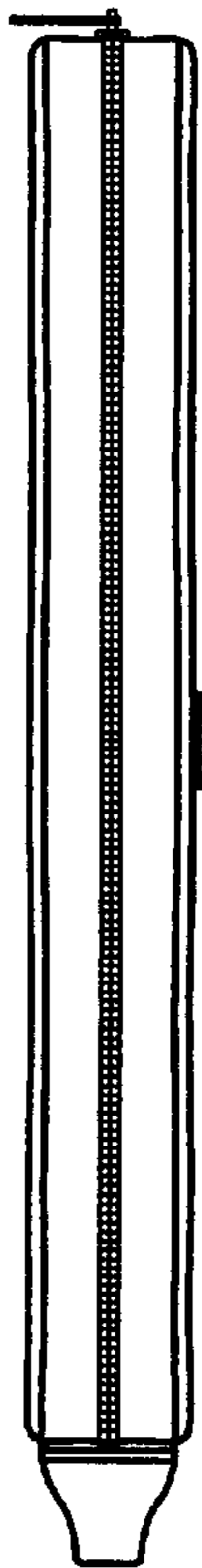

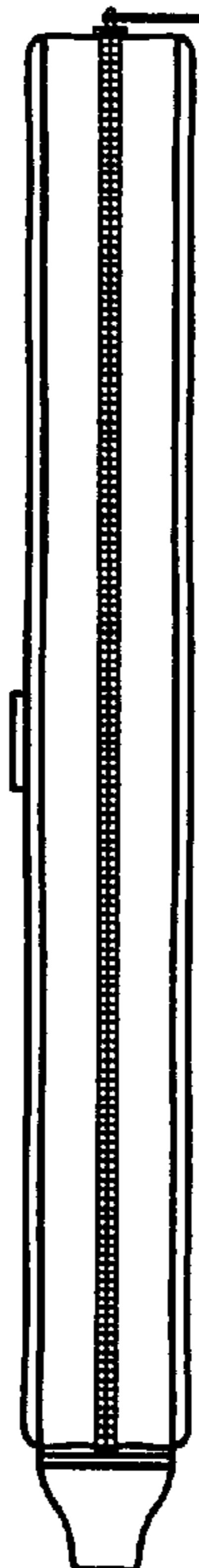

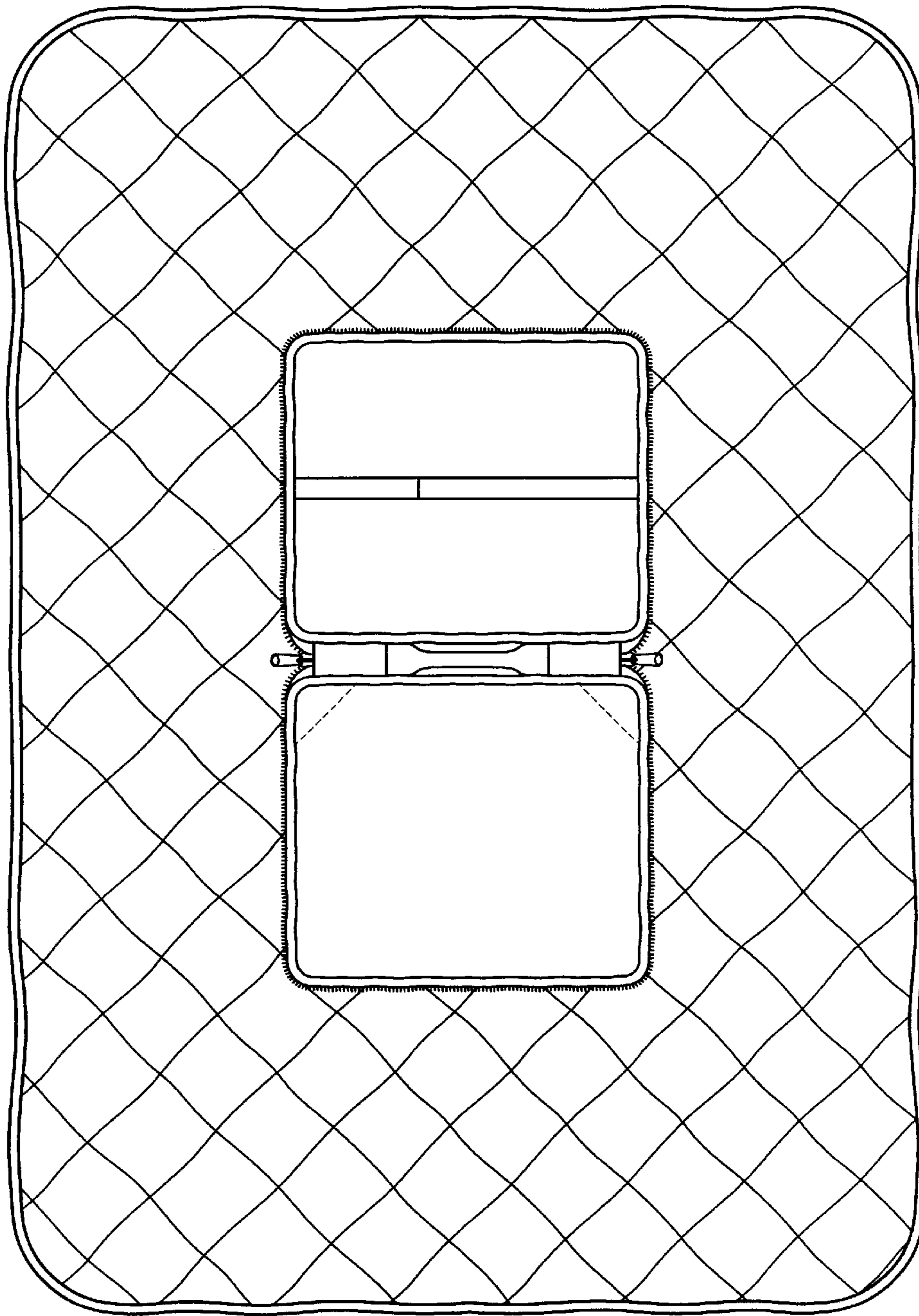

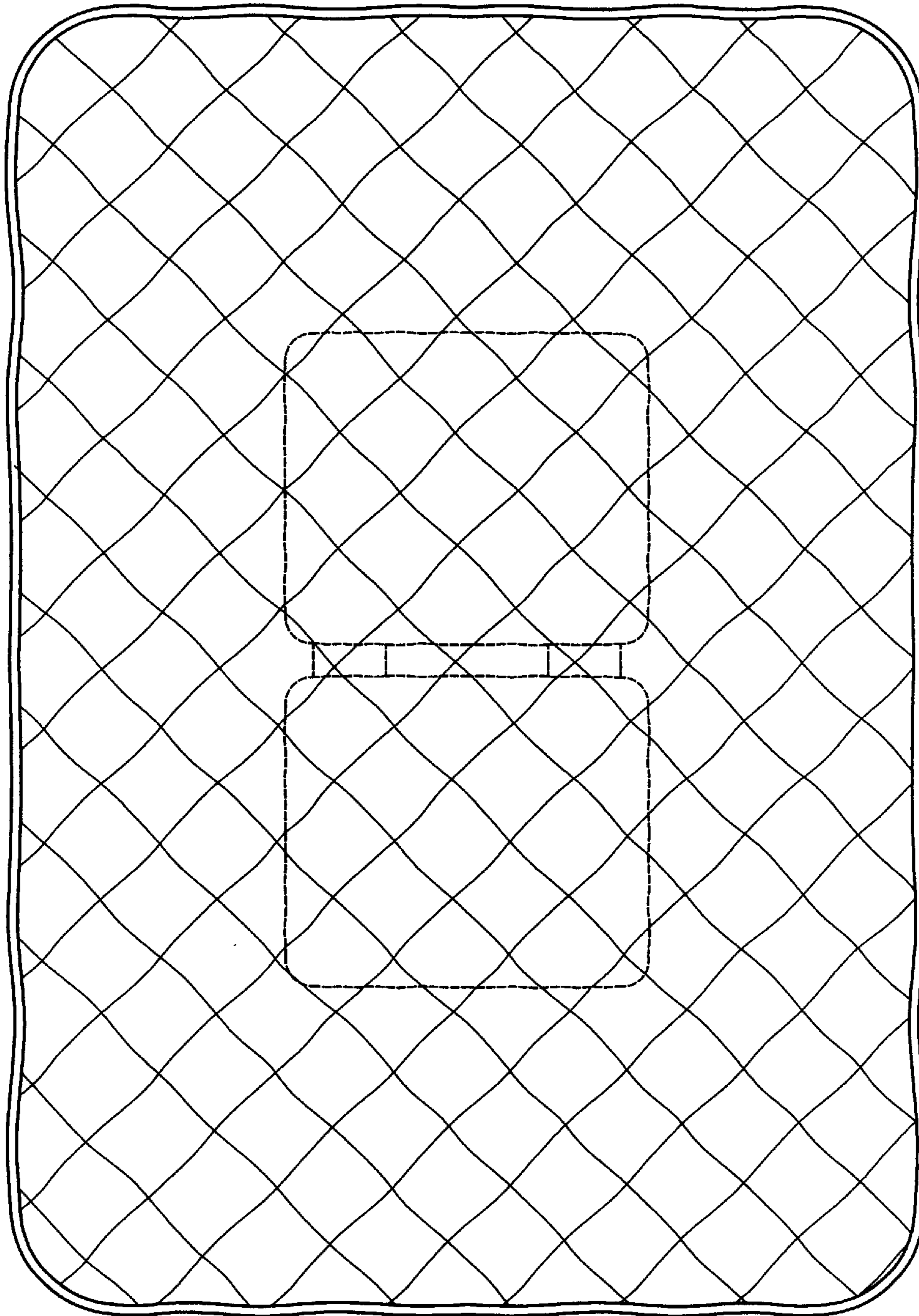
