(57) **CLAIM**

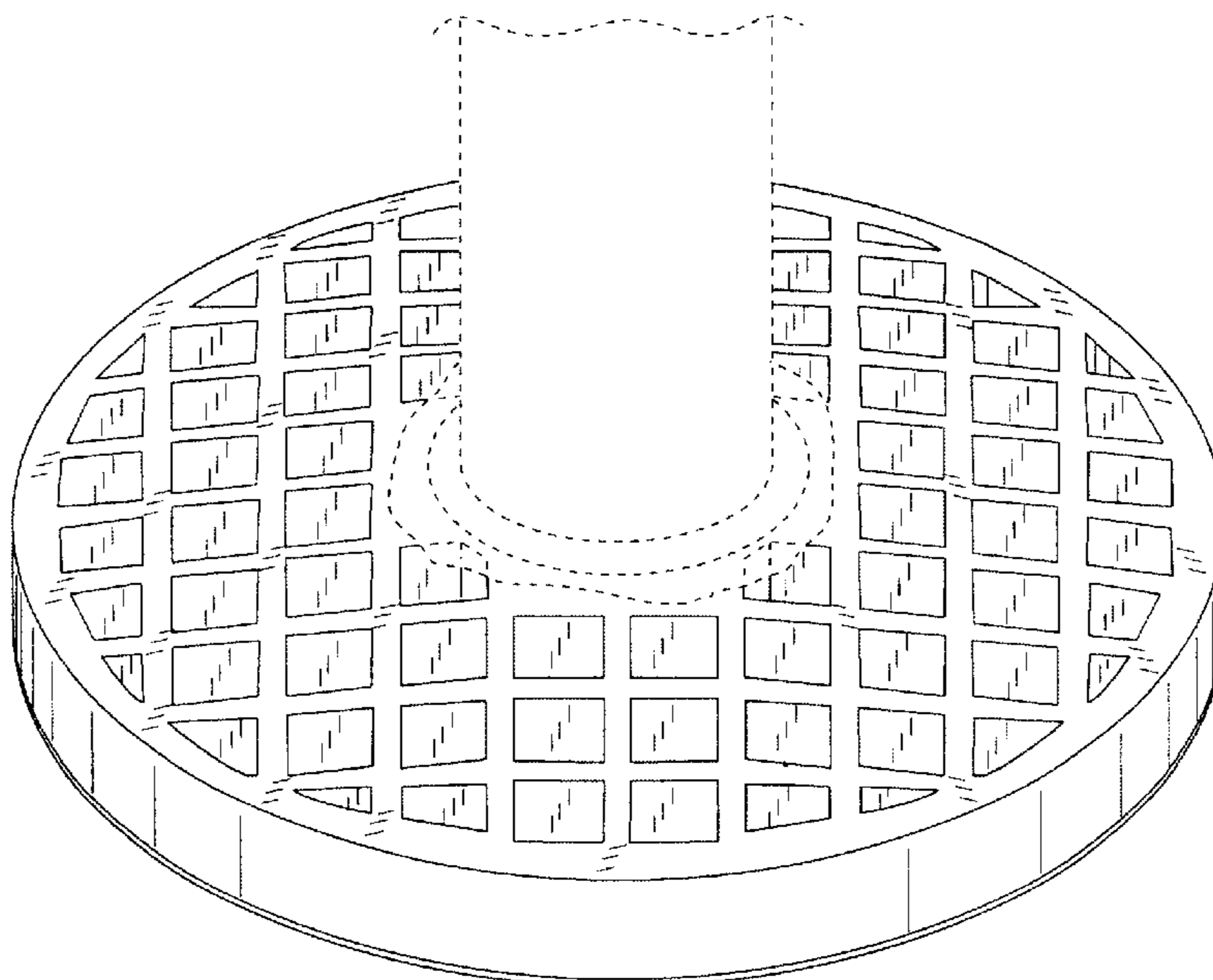
The ornamental design for a mixer head, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, perspective view of a mixer head showing my design;  
FIG. 2 is a bottom, front, perspective view thereof;  
FIG. 3 is a front elevational view thereof; the left, right and back elevational views being a mirror image thereof;  
FIG. 4 is a top plan view thereof; and,  
FIG. 5 is a bottom plan view thereof.

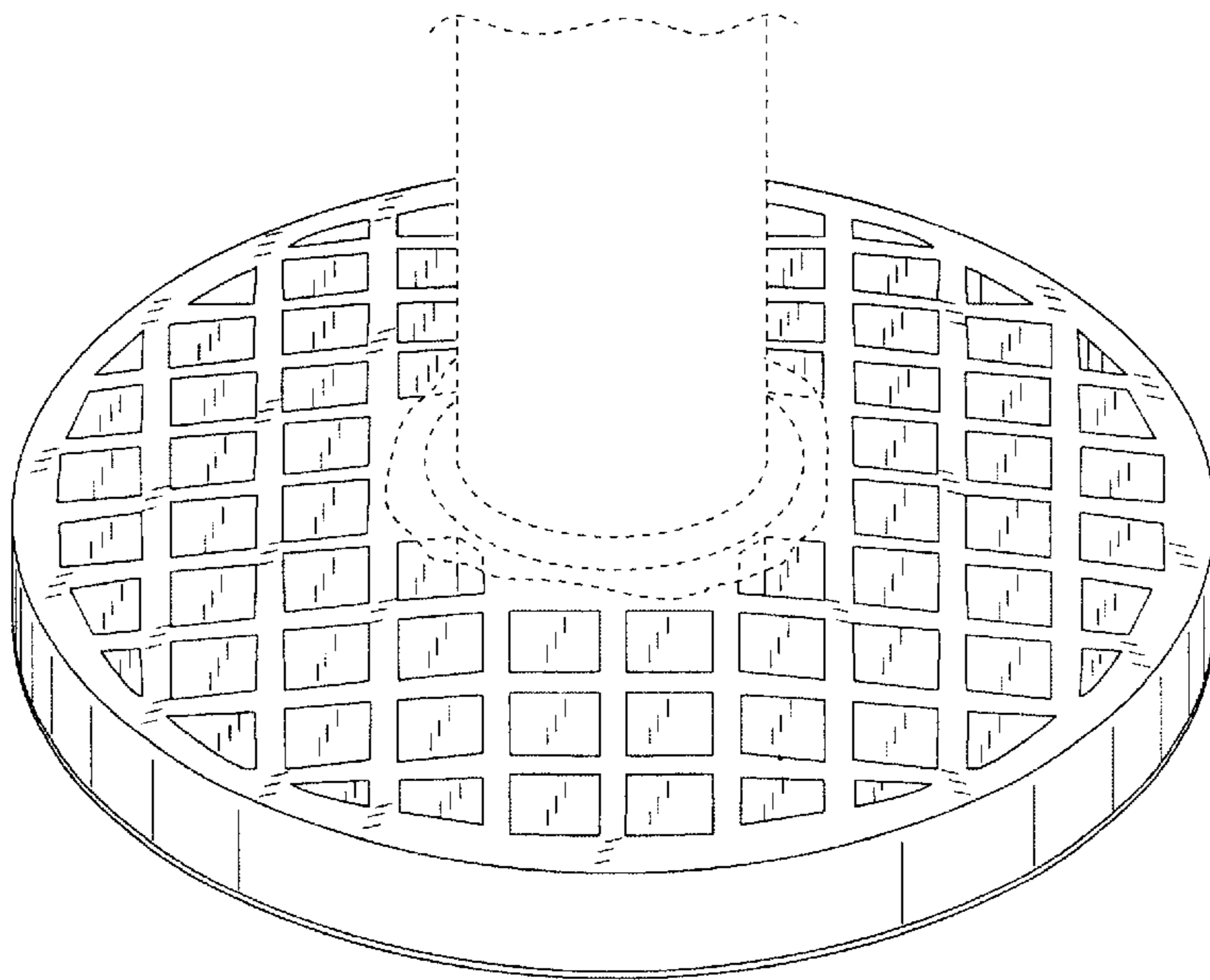

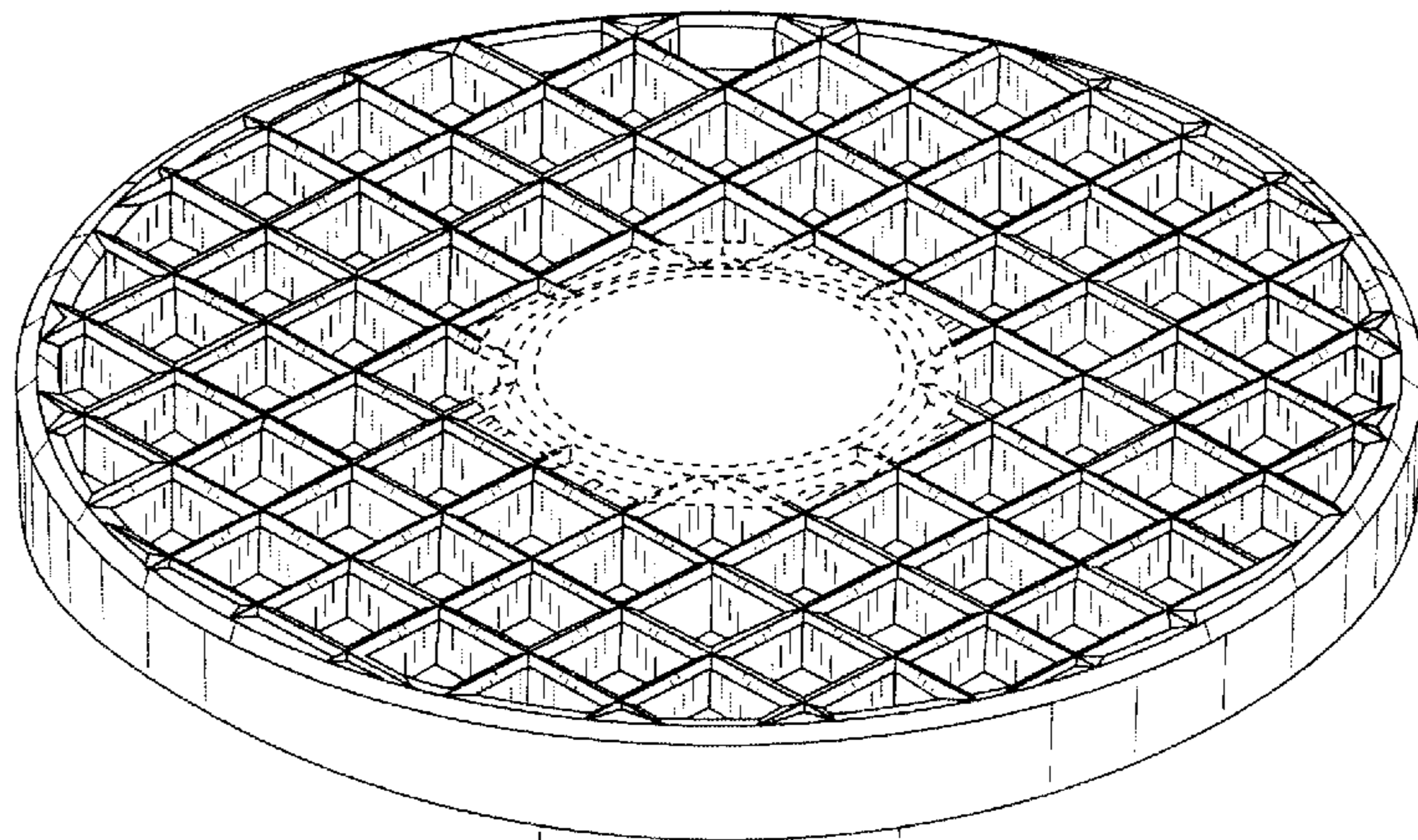

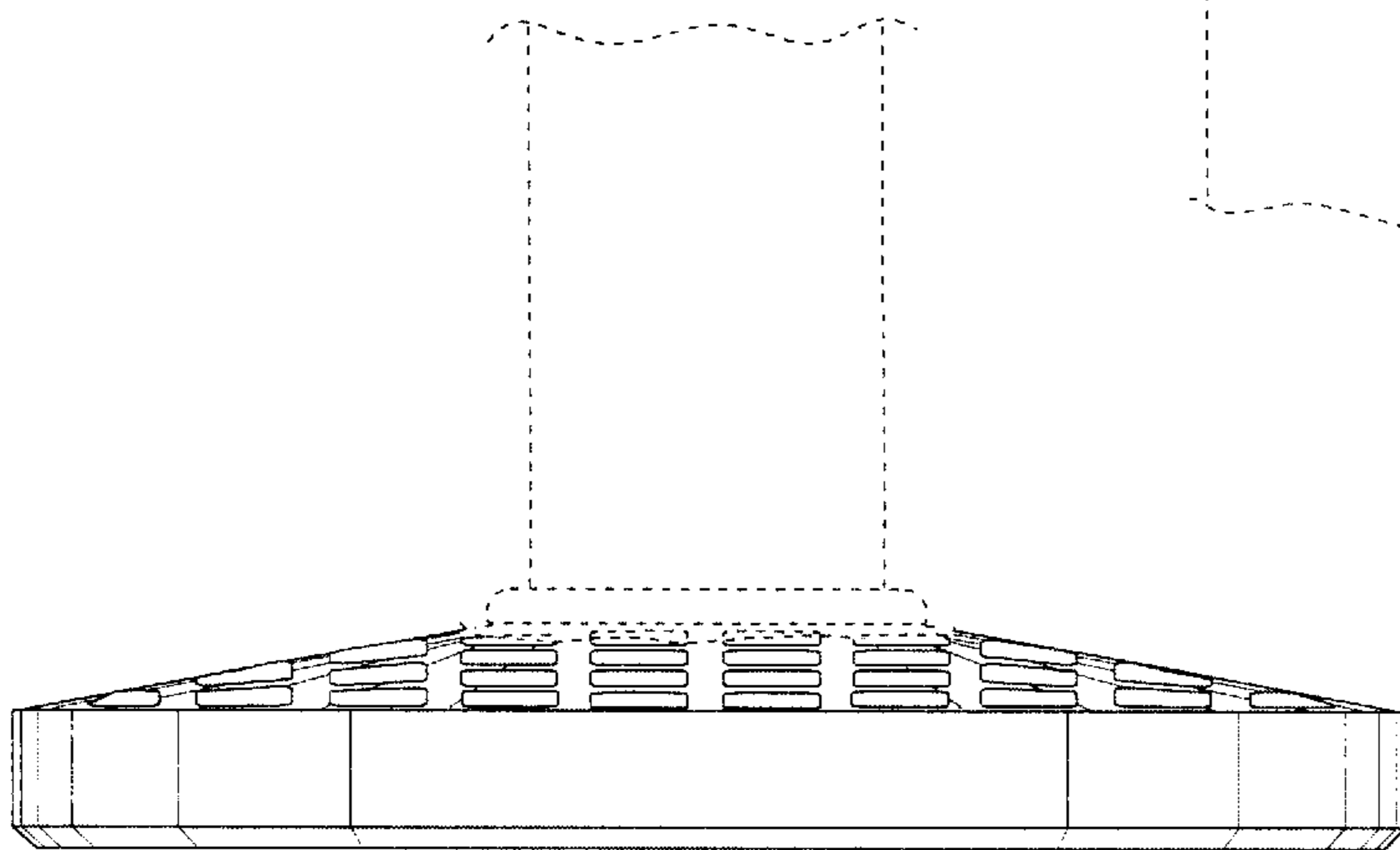

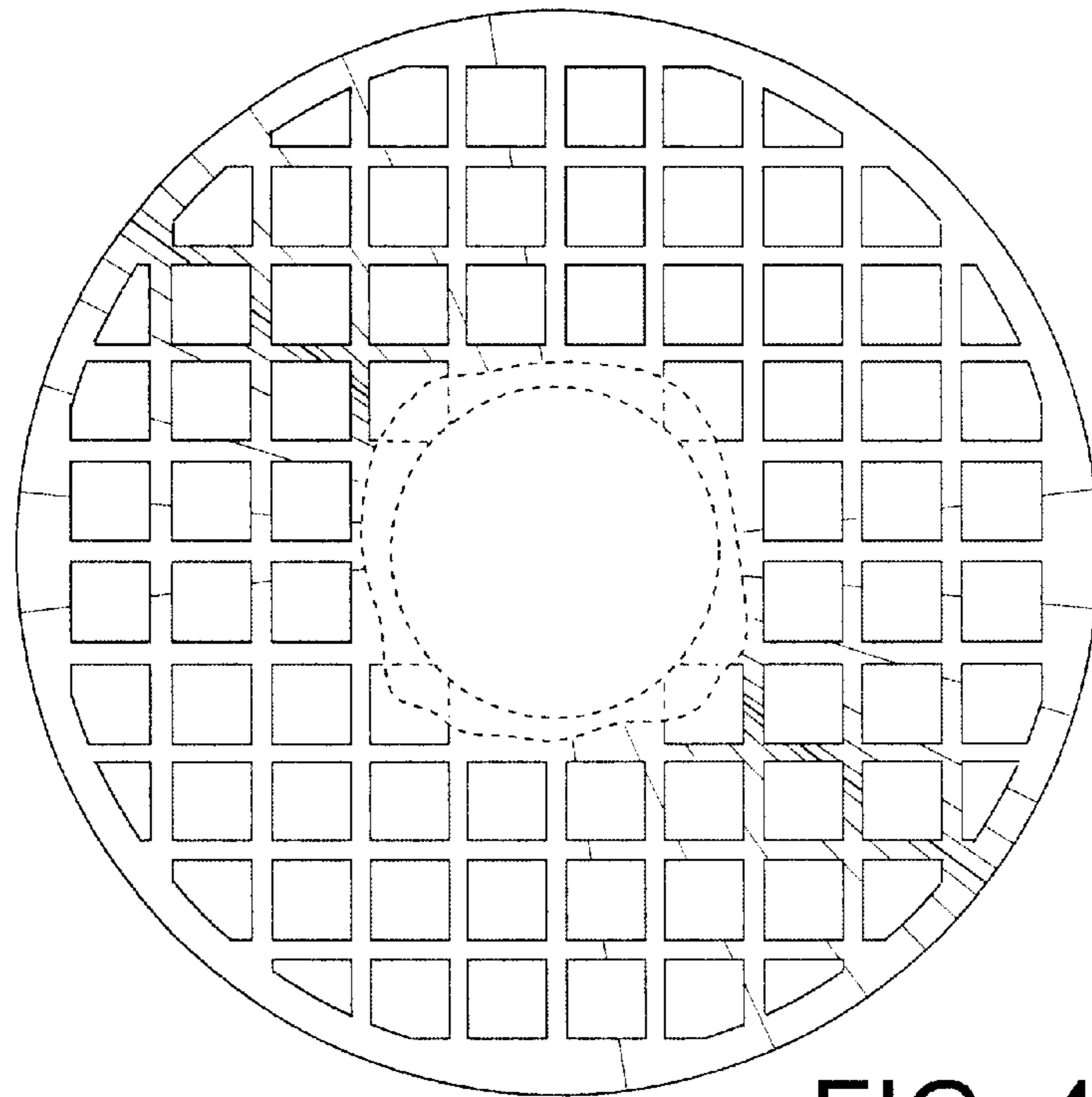

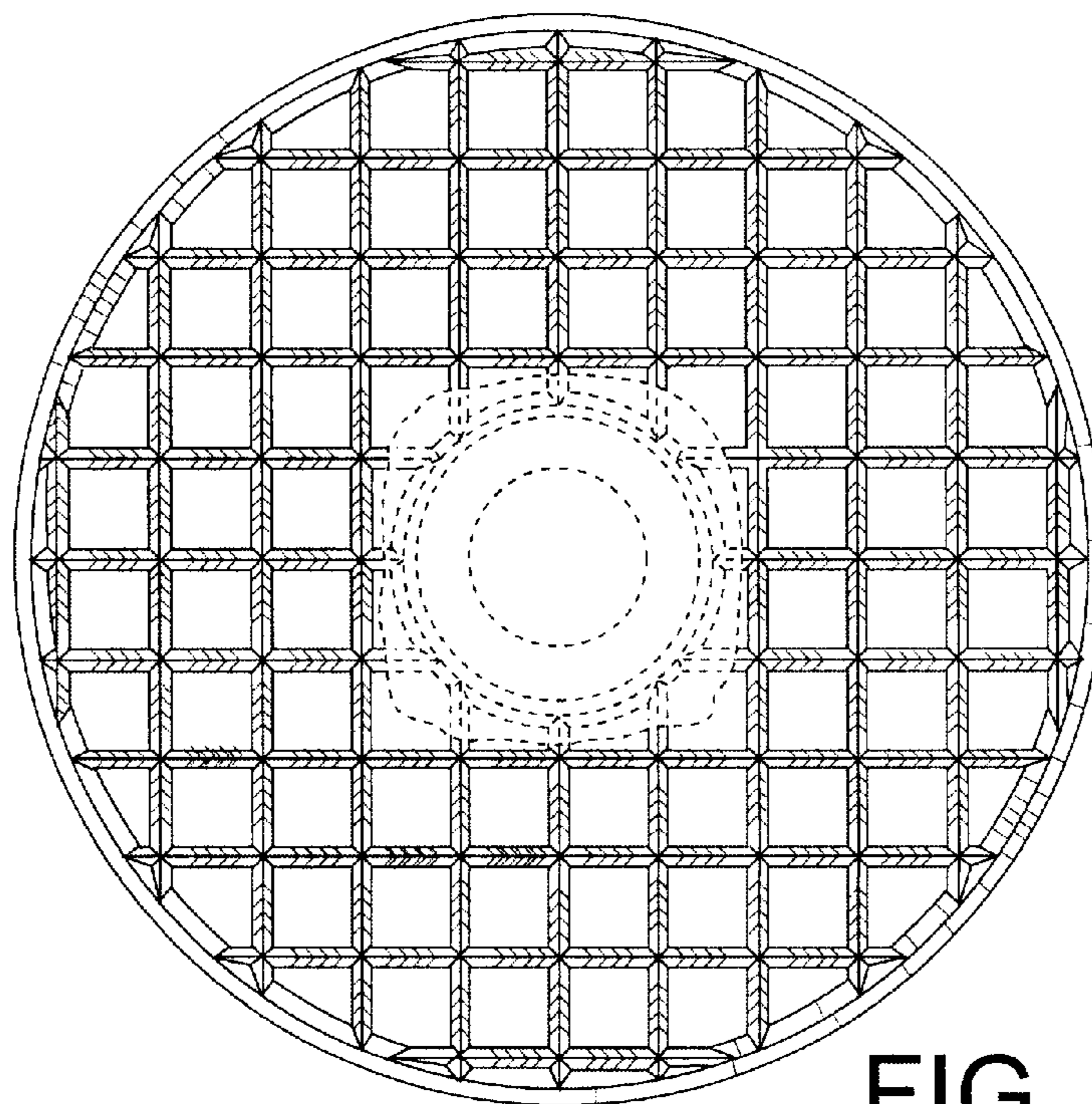
