FIG. 1 is a top perspective view of a beverage tray showing our new design;

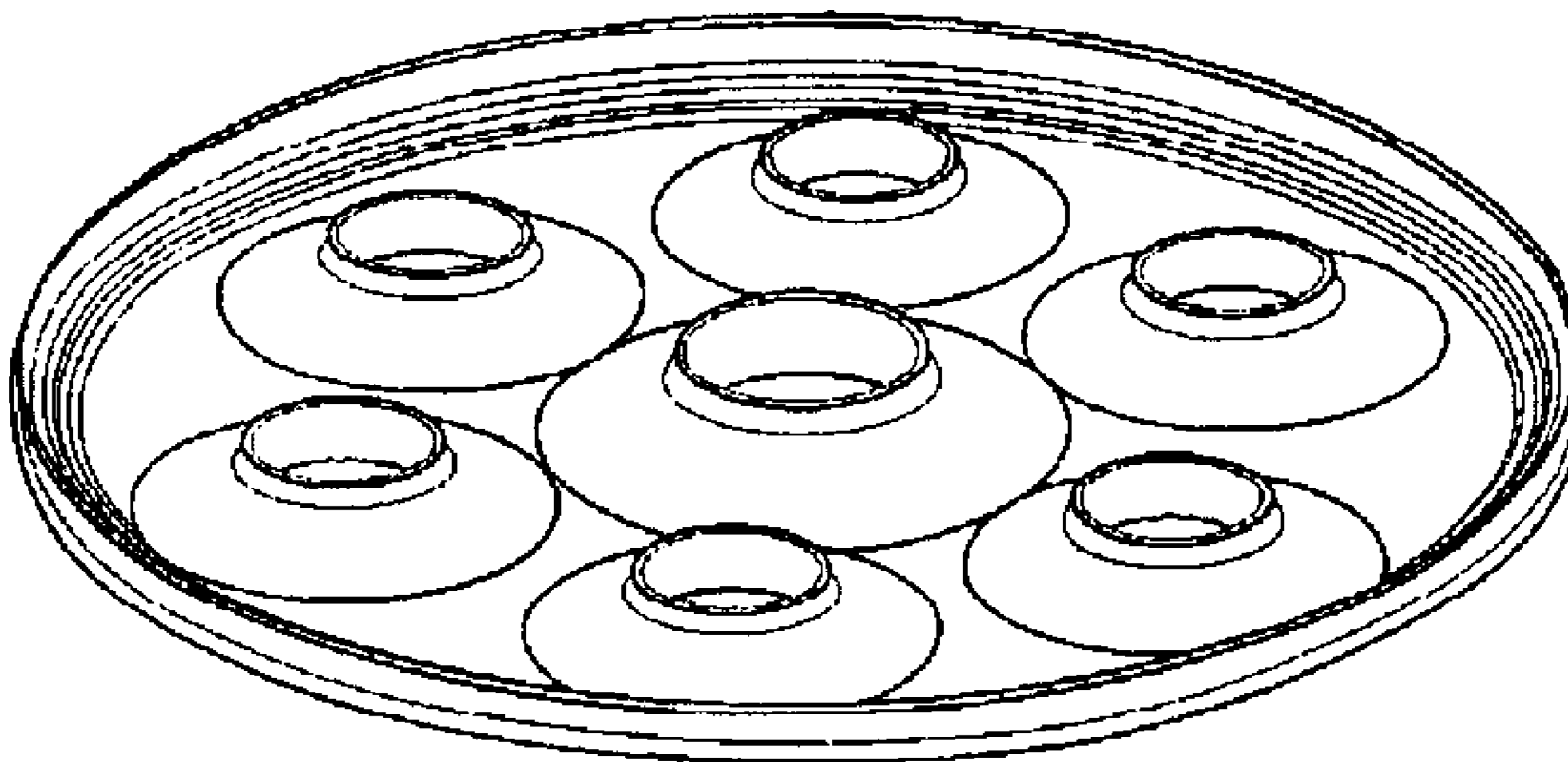
FIG. 2 is a bottom perspective view thereof;

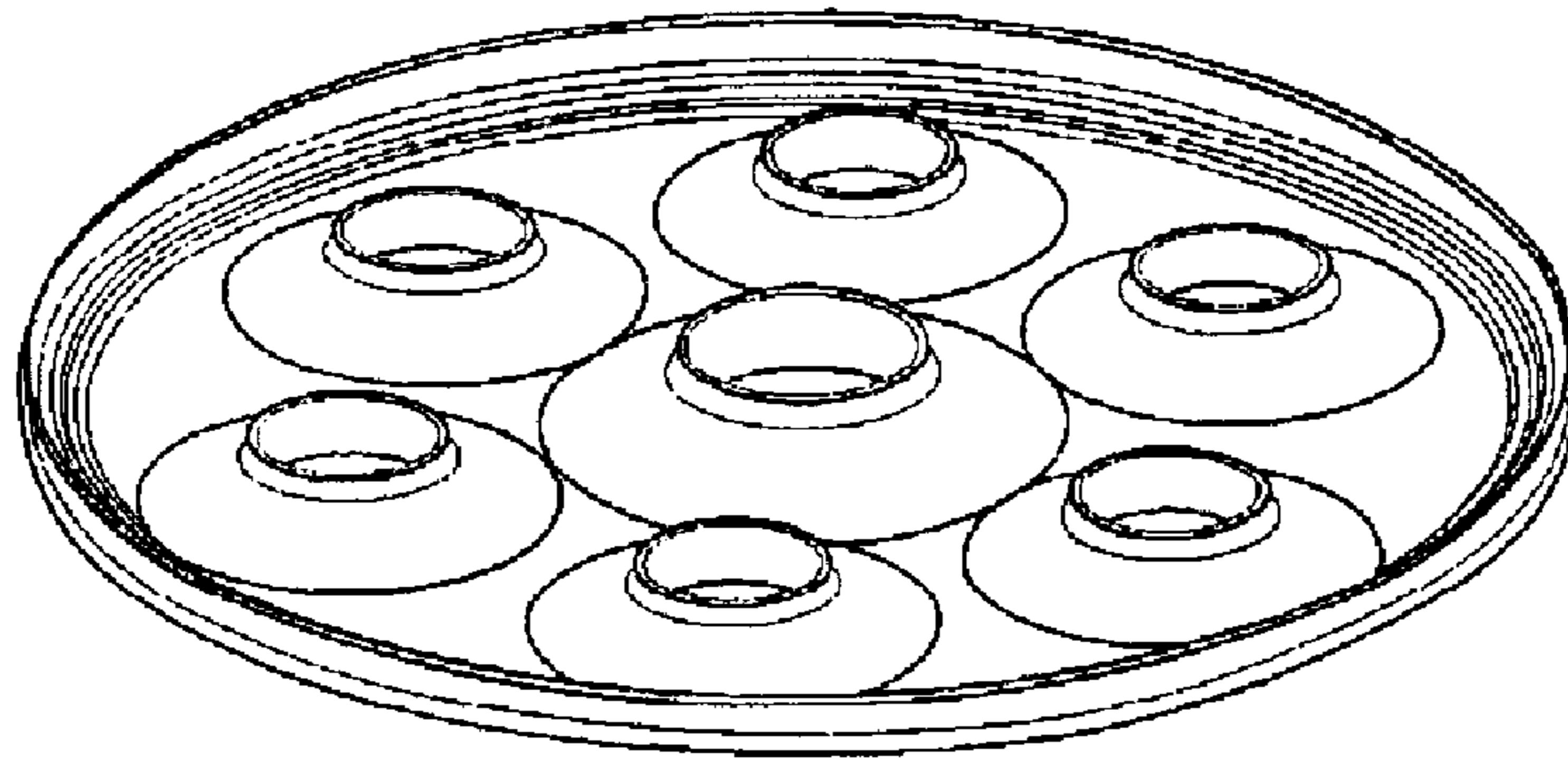

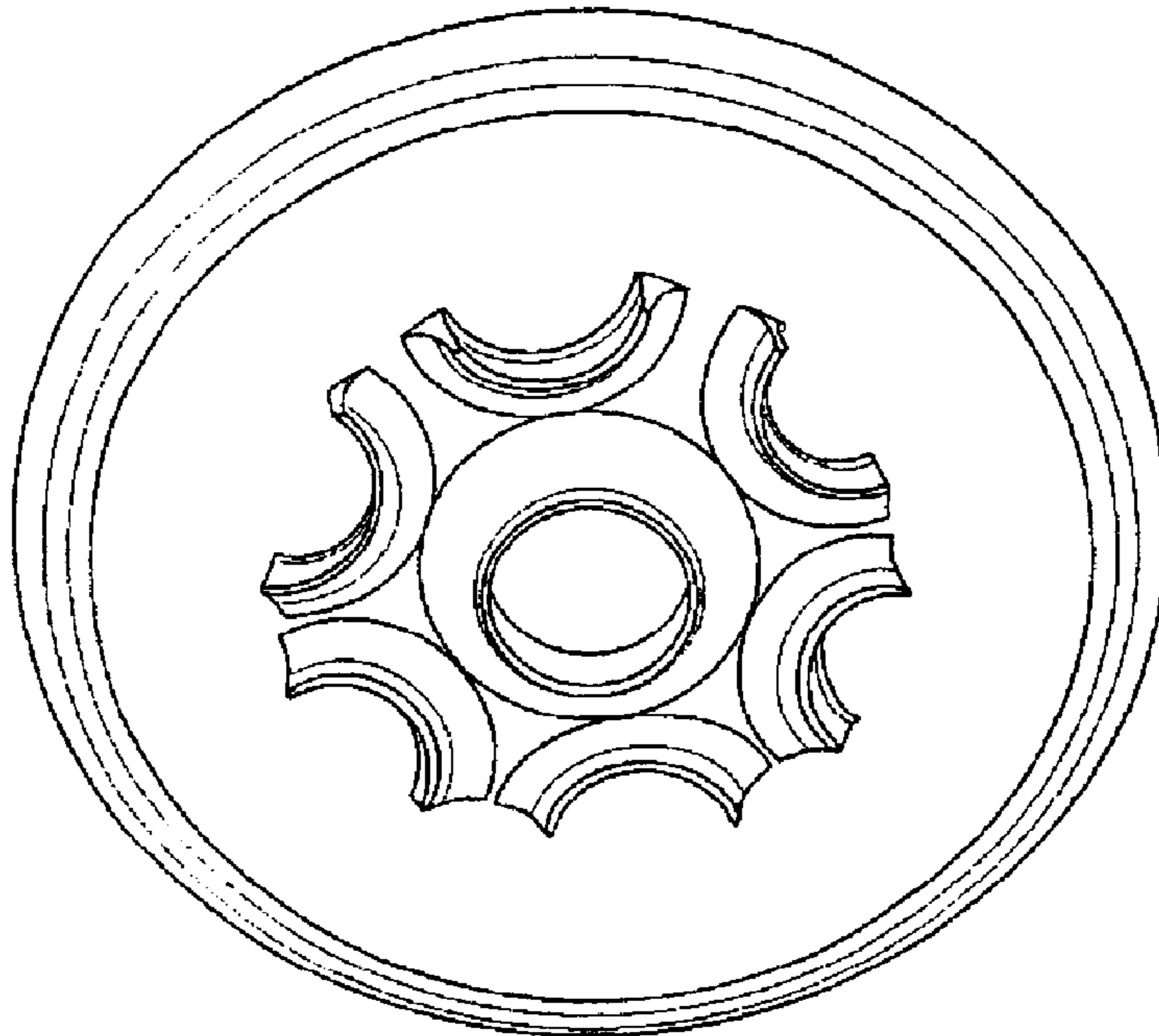

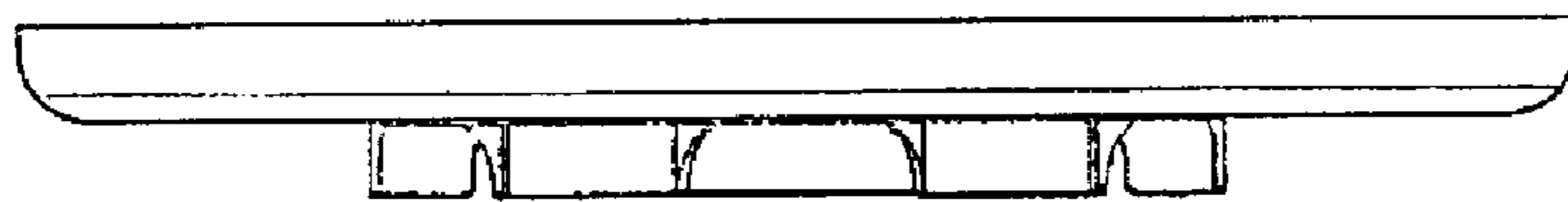

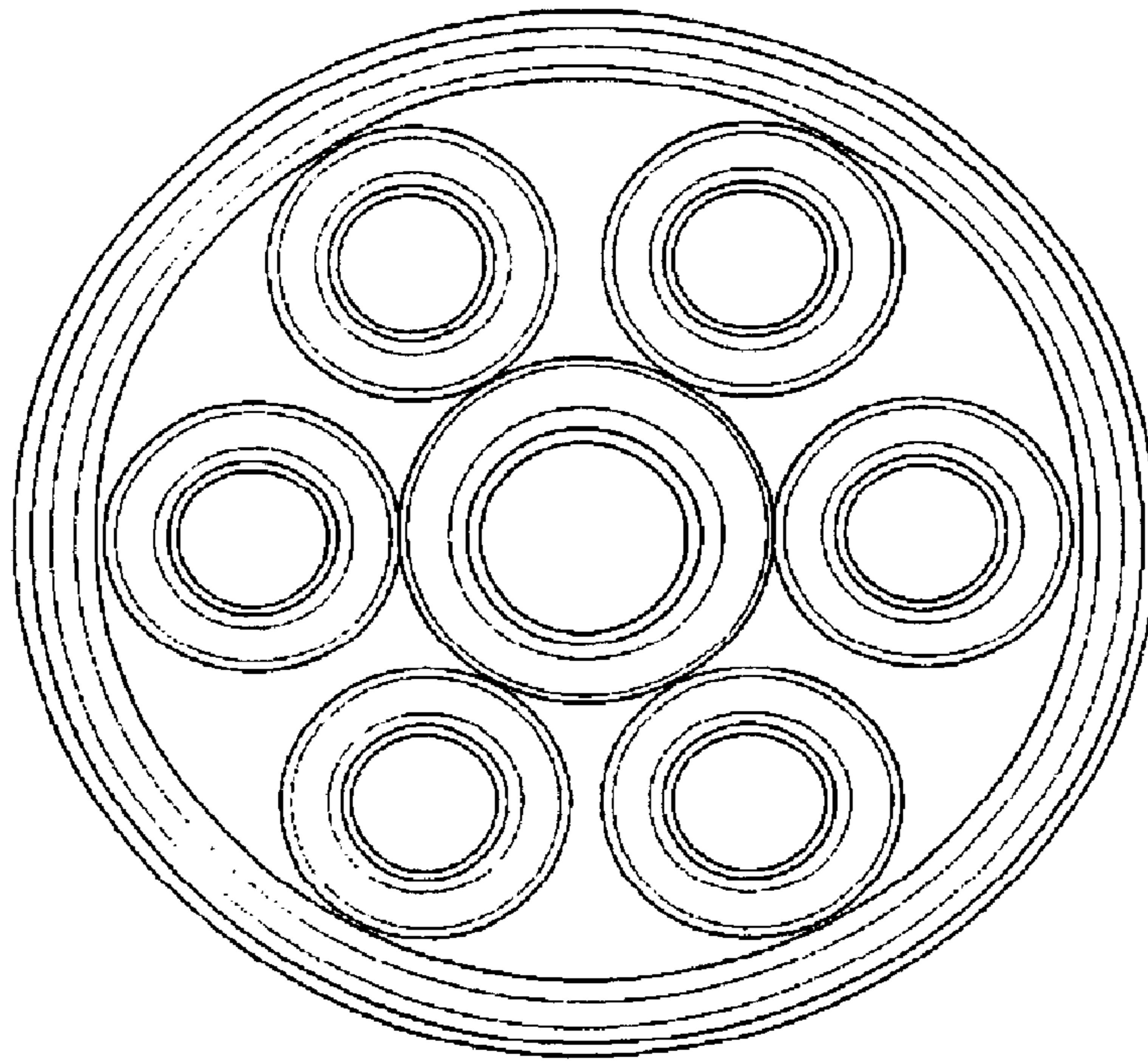

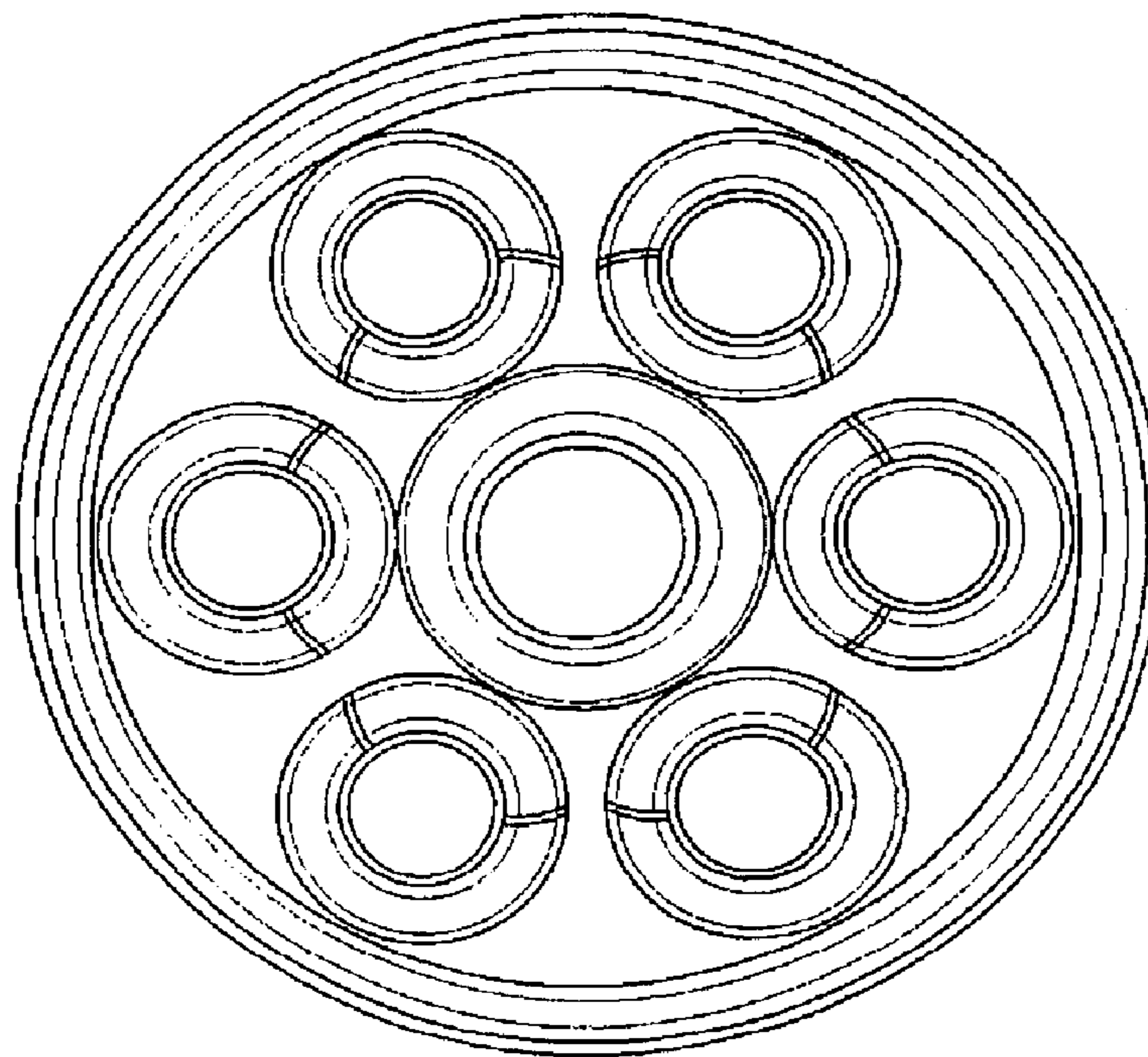
