(57) **CLAIM**

We claim the ornamental design for a nesting handle and housing, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view showing our new design;

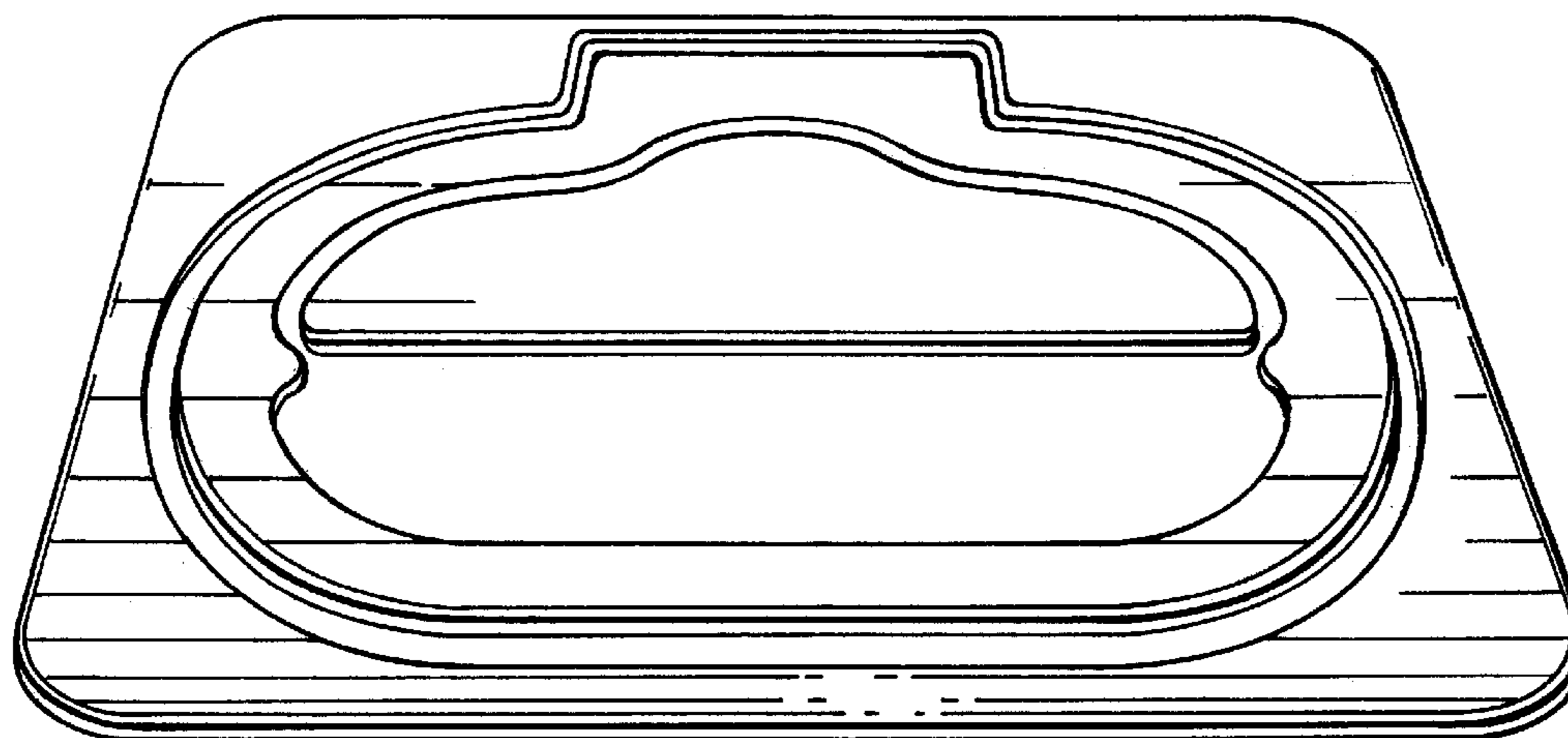
FIG. 2 is a top view thereof;

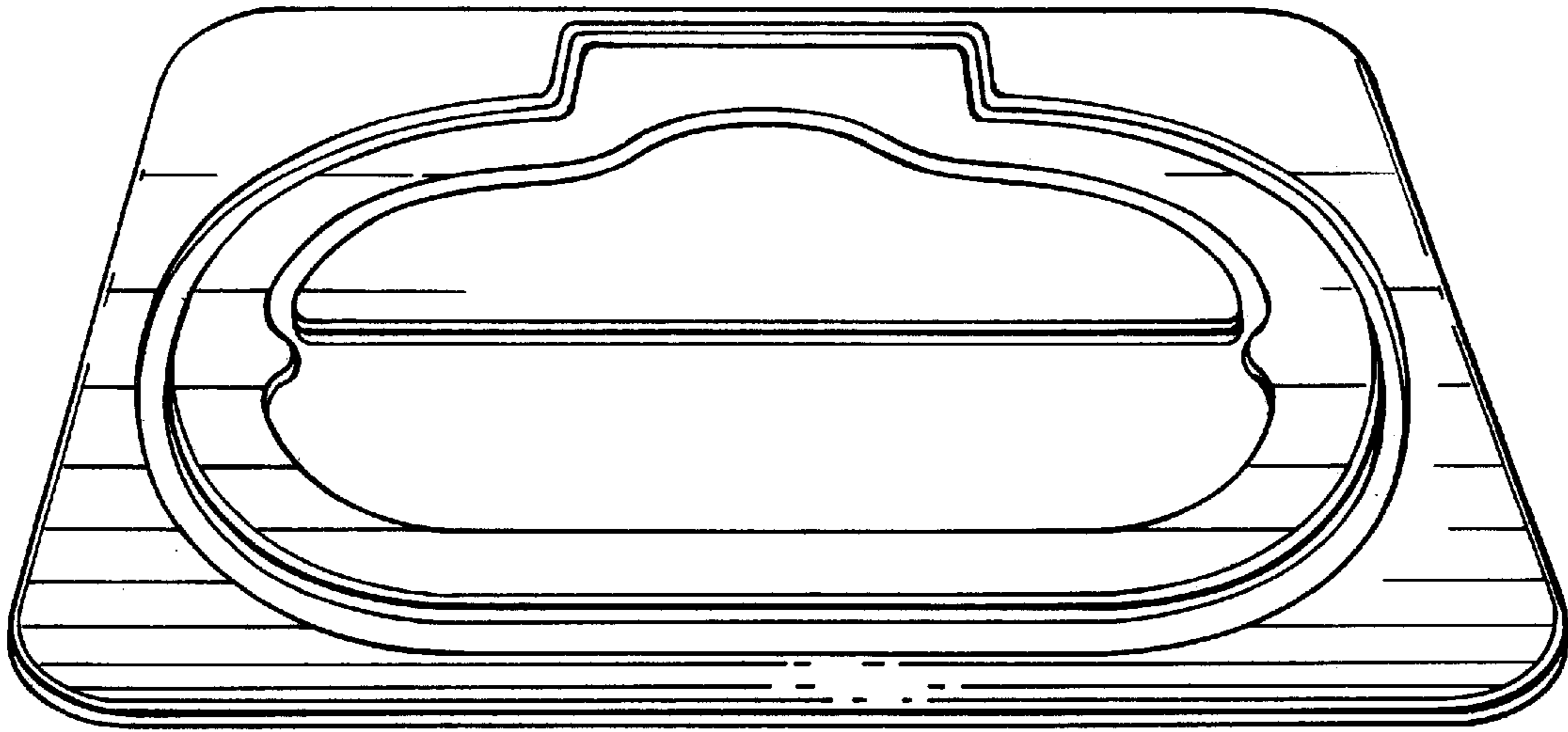

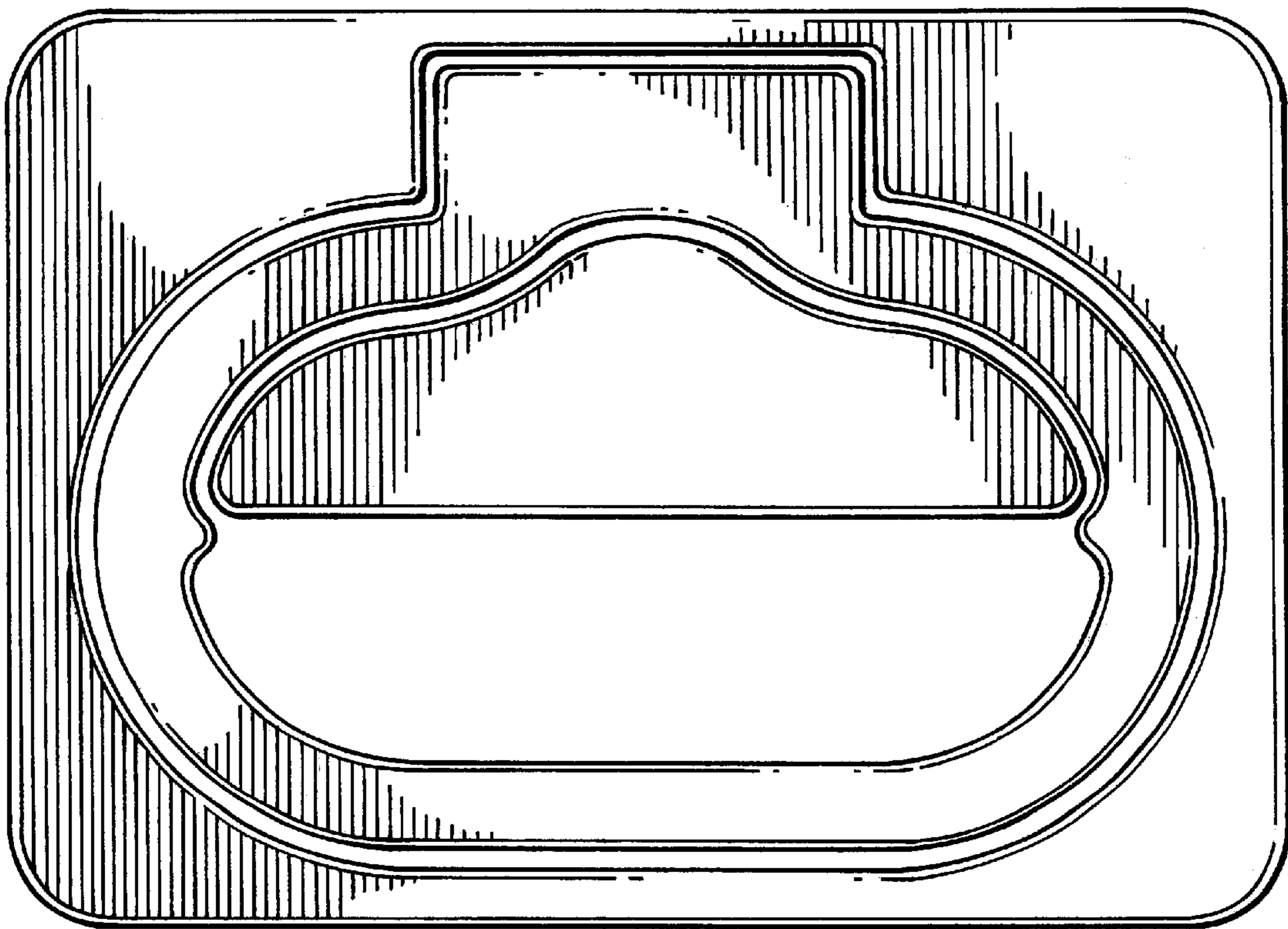

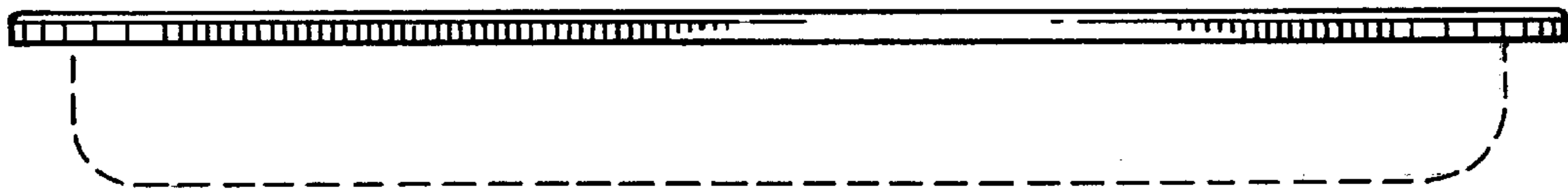

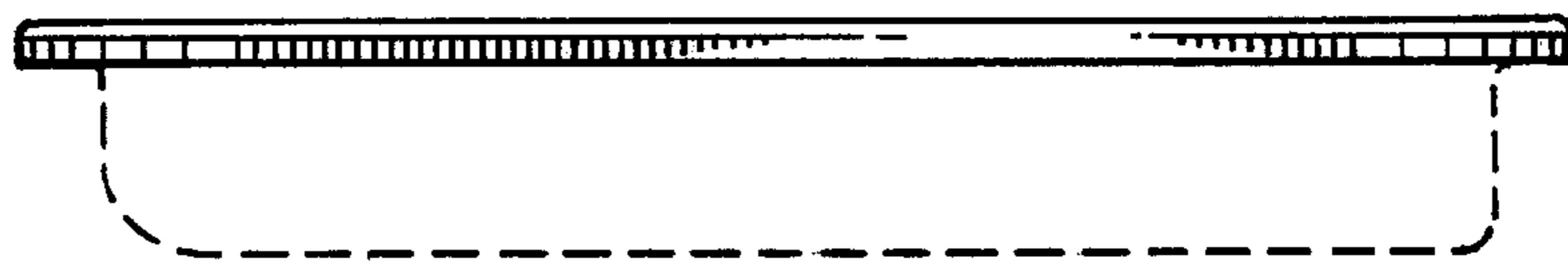
